It said in the petition that the local administration is totally silent about taking any action against the culprits who are illegally and arbitrarily grabbing the homestead of the helpless Sonaichhari ethnic Tripura families with the help of local administration, politically powerful persons and other influential vested quarters.

The aggrieved persons had gone to the offices concerned for several times for making complain, but none of the authorities recorded their case.

Around 75 Tripura families have been residing there, the petition said, adding that they are very poor and belong to minority community. They have no other place to go.

Lawyers ZI Khan Panna, Syeda Nasrin and Md Shahinuzzaman appeared for the petitioner, while Deputy Attorney Generals Arobinda Kumar Roy and Bipul Bagmar represented the state during virtual hearing of the petition.

Quoting Japanese ambassador in Dhaka as saying, Anwarul said a famous Japanese company has shown interest to invest in the automobile industry.

Anwarul further said once the policy is implemented, local automobile industries in cooperation with international brands would be able to manufacture cars at a lower cost.

Yesterday, the cabinet also gave the final approval to the draft of the Delimitation of Constituencies Bill, 2021.

It will replace an ordinance of the military regime, he said, adding that no major change was brought to the draft law.

The cabinet also approved a proposal for accepting the membership of Organization of Islamic Country's (OIC) Women Development Organisation (WDO), its ratification and signing in the WDO Statute.

Anwarul said WDO works in the OIC states to ensure rights and empowerment of women.

ADC Rauf said, "Hamid is the agent, and Mithun is the gang leader."

The group mainly targeted busy areas like EPZ or places with low-income population, as it is easy to get their information, he said.

Police will interrogate the arrestees after taking them into remand, he added.

On September 21 last year, a DU student filed the case with Kotwali Police Station, accusing six persons including Nur of rape, abetting rape and shaming her on social media.

A day before, she filed another case with Lalbagh Police Station, bringing almost similar allegations. Police are investigating the case.

In the first case with Lalbagh Police Station, the complainant mentioned Mamun as the prime accused, alleging that he raped her in his Lalbagh home on January 3.

She also claimed that she was in a relationship with Mamun and that he promised to marry her.

In the second case, Nazmul was made the prime accused. According to the case statement, Nazmul took her to Chandpur on February 9 that year, saying he would patch things up between her and Mamun.

As she did not find Mamun there, she requested him to take her back to Dhaka.

On their way back, Nazmul raped her in the launch, the case statement said.

In both cases, the complainant alleged that Nur and three others -- in the name of arbitration over the matter -- "threatened her of character assassination through posts on social media".

"Recommending for a male person with the excuse of religious reasons also disrespects freedom fighters, by demanding to hand the duty to a lesser important junior official," she added.

In addition, this also neglects women by treating them as a person having no stature and status, which completely goes against everything that the government has taken as its policy towards gender equality, she further said.

Naripokkho founder member Shireen Huq termed the recommendation a "strange demand", and said, "At a time when we're thinking that women should be included in every sector, a group of people having patriarchal mindsets are trying to exclude them using various excuses."

"Even if they consider namaz-e-janaza and guard of honour the same, they cannot make such strange demands, because we have seen many women, including myself, take part in janaza and nobody forbade them."

"I have never imagined that lawmakers, who are educated enough, can make such a recommendation in 2021, and I am really ashamed of their statement," she added.

Manusher Jonno Foundation (MJF) executive director Shaheen Anam expressed a similar concern.

She said, "It is a very discriminatory attitude towards a government officer, and we totally reject this."

"We are fighting for equality, which must be guaranteed as per the constitution. After 50 years of independence, there must be no such recommendation that goes against the spirit of the liberation war, constitution, and women's empowerment," she said.

Bangladesh Mahila Parishad (BMP) also in a written statement expressed their anger over the issue.

It said, "There is no such thing as women UNO in Bangladesh."

"Women are appointed as UNO after passing competitive exams. Creating such division and discrimination is totally unconstitutional," said the statement signed by BMP president Dr Fauzia Moslem and general secretary Maleka Banu.

Leading rights body Ain o Salish Kendra (ASK) in a statement also expressed their shock in reaction to the matter, and asked lawmakers to be more gender-sensitive while taking any actions or making any recommendation.

"Such proposal is contradictory to the article 19 (3), 27 and 28 and the government's position on women empowerment. Besides, it is also not consistent with the government's women development policy and SDG-5 (gender equality)," it said.

Workers Party president and lawmaker Rashed Khan Menon yesterday in parliament also lambasted the recommendation made by the committee, and said such recommendation is tantamount to humiliation of women who sacrificed their lives and were subjected to rape during the Liberation War.

"Such humiliation towards the country's women cannot be accepted," he said while participating in the discussion on the proposed budget for the 2021-2022.

On the other hand, Ekattorer Ghatok Dalal Nirmul Committee in a separate statement also expressed grave concern over the issue and said that the consequences of such recommendation will be dire for the government, the society, and the nation as a whole.

Referring to Pori Moni, Harun said she has been seeking justice for four days following attempted rape and assault. "Media has published news in this regard. Is it false?" questioned the BNP MP.

"The home minister is not in parliament. I want to draw his attention to this. Persons involved in this incident must be brought to justice," Harun said.

Meanwhile yesterday, detectives said they will take immediate steps against Bashundhara Group MD if Gulshan police seek help in a case filed against him on charge of abetting suicide of a young woman.

Harun or Rashid, joint commissioner (North) of Detective Branch of Dhaka Metropolitan Police, said this while replying to a query after arresting five persons from Dhaka's Uttara area, following a case filed by Pori Moni with Savar Police Station.

"Yes, we arrested many, including Mamunul Haque (former Hefajat leader), within shortest possible time. We take immediate steps whenever an investigation officer of a case requests or requisitions us to arrest someone," Harun said.

"We will take steps immediately in the case, if Gulshan Police requisition in the case filed against Anvir," he said replying to a query.
