No 'real Islamic scholar' arrested

Says state minister for religious affairs at parliament

State Minister for Religious Affairs Ministry Faridul Haque Khan yesterday told parliament that no real Islamic scholar was arrested centering Hefajat-e Islam's violent activities in late March in protest of Indian Prime Minister Narandra Modi's visit in Bangladesh.

He said the "so called power hungry" Islamic scholars who were involved in conspiracy against the state and anti-social activities have been brought under the law.

The state minister was responding to BNP MPs Harunur Rashid and Rumeen Farhana, who during discussion on a Bill sharply criticised the government for wholesale arrest of Islamic scholars during the government's ongoing crackdown against Hefajat leaders for their involvement in violent protests from March 25 to March 27.

The state minister said everyone knows what Prime Minister Sheikh Hasina is doing for Islam in this country. He said no real Islamic scholars or alem-ulema have been arrested or prosecuted.

Lockdown leaves students hanging

Thousands of students of Rajshahi University (RU), who were expecting to sit for their final examinations on university campus, are in uncertainty due to the lockdown imposed in Rajshahi.

RU authorities in a virtual meeting on June 3 decided to allow departments to start exams of 2019 from June 20 and of 2020 from July 4 in person. It also decided to keep RU's residential halls closed.

Upon receiving permission, around 10 departments started taking measures. Students also started heading for Rajshahi.

But on June 10, the Rajshahi administration decided to impose a complete lockdown from June 11 to midnight of June 17, as Covid-19 was spreading rapidly in different areas.

After the lockdown was imposed, RU authorities immediately issued a notice to close university offices till June 17.

This set of decisions caused confusion among students and teachers. Sanchita Akter, a student of history department, expressed her frustration in a Facebook post and said, "We've already come to Rajshahi, after hearing the exam dates. But it seems like authorities will reschedule What can we do now?"

A student of finance department said, "We were eagerly waiting to sit for exams. We had even started preparing, after authorities announced the dates. But as the situation worsened, we won't be able to visit Rajshahi."

This correspondent talked to seven department heads, who were preparing to take exams between June 20-25. Some of them said they have already postponed the exams, while others said they did not take any decision yet but have been observing the situation closely.

Brac Survey on Recruitment in Retail Sector

Women, persons with disabilities neglected

Retailers in Bangladesh are reluctant to hire women and persons with disabilities because of safety and security issues, and the perception that women have limited capacity to endure physical strain, found a recent survey.

Only 2 percent of retailers are willing to hire persons with disabilities, it revealed.

Retail employees work for an average of 11 hours a day in a single shift. They mostly can avail annual leaves but are not usually granted maternity or paternity leaves, it

Only half of the workplaces have policies to protect their employees from sexual harassment.

The baseline survey was conducted by Innovision Consulting Ltd, commissioned by Brac's Skills Development Programme to create employable skills and decent work opportunities for the marginalised youth.

The survey's findings were shared yesterday at a webinar titled "The future of

skills and employment in the retail sector" organised by SDP.

The survey also reveals existing skill gaps of salespeople engaged in the sector. For example, 68 percent of employers said their salespeople are unable to meet sales targets; 54 percent stated the salespeople lack communication skills; and 64.6 percent mentioned that their sales staff's knowledge of products is inadequate.

The survey, conducted under SDP's "Progressing the retail sector by improving decent employment (PRIDE)" project and funded by IKEA Foundation and UBS Optimus, interviewed 720 respondents, who were employers and employees in the retail sector in Dhaka, Chattogram, Khulna and Sylhet.

Identifying mindset and social barriers as the most important problems in the sector, Shaheen Khan, chief executive officer of Gemcon Food and Agricultural Products Ltd, said a shift in culture and mindset is required for people to come and

Rajshahi police open free oxygen bank for Covid-19 patients

Rajshahi Metropolitan Police (RMP) yesterday created a "Police Covid Oxygen Bank" to serve Covid-19 patients who require oxygen.

The bank was formally launched at RMP's temporary headquarters at Shah Makhdum police station premises, with a store of 50 oxygen cylinders.

The capacity would be raised gradually, RMP Commissioner Abu Kalam Siddique said while inaugurating the initiative. He said police would provide oxygen cylinders free of cost to patients

"We decided to open the bank, considering those who were unable to collect a cylinder. We will provide oxygen to people who need it," he continued. "We will not only provide cylinders, but also deploy

forces to take them to patients and refill them when necessary," he added.

Anyone can avail the service by calling RMP's control room at 01320063998.

RMP has trained at least 10 of its staffers to handle the cylinders, and police officials said they would increase the number of staffers for conducting activities of the bank.

In his inaugural speech, the RMP commissioner said no other hospital but Rajshahi Medical College Hospital has a central oxygen supply, and it is already facing the pressure

No safety gears for CCC conservancy workers

Around 3,700 cleaners exposed to health risk

Even amid the pandemic, hundreds of conservancy workers in port city take to the streets to clean up the waste produced in the day. However, they continue to collect the waste without using any safety equipment, putting them at risk of being infected by various diseases.

The cleaners alleged that their appointment authority -- Chattogram City Corporation (CCC) -- did not provide them with protective gears. As a result, they were compelled to work this way.

On the other hand, the CCC officials concerned claimed that they did give those to workers but they "do not want"

Waste collection in port city is mostly based on manual labour. The workers collect household waste then carry those to the nearby collection spot, from where the CCC vehicles take those to landfills.

At present, there are 3,700 conservancy workers under CCC. Of those, 1,700 are permanent workers and the rest work on daily wage basis.

According to CCC officials, the city produces around 2,500 tonnes of waste

While visiting different areas yesterday, this correspondent found that almost 90 percent workers were working without any safety equipment such as masks, gloves or shoes.

A few of them were seen wearing masks. Conservancy worker Hridoy was seen

collecting waste at city's Askar Dighir Par. He was dumping household waste in his rickshaw-van for taking those to a nearby collection spot.

Hridoy said the CCC officials did not give him any safety gear.

"I work on daily wage basis. As I'm not a permanent worker, I cannot really demand masks, gloves or shoes from the authority. I know there are health risks, but I am too poor to afford those," he

Meanwhile, Ajoy Das was seen collecting waste in Chawkbazar area. Echoing Hridoy he said he had been suffering from skin diseases for many

"I took treatment at the outdoor of Chattogram Medical College Hospital. The doctors advised me to maintain hygiene but my profession does not allow ne to do so," said Ajoy.

Contacted, Prof Dr Sujat Paul, head of medicine department at CMCH, said conservancy workers were at risk of being infected by various skin and chest diseases if they continue to work without taking any safety measures.

"They may even suffer from diarrhoea, typhoid and jaundice," he said.

Contacted, Dr Mahfuzur Rahman, convener of Public Health Rights Protection Committee, Chattogram, said CCC should modernise the garbage management system, rather than relying on manual process.

War crimes accused former lawmaker MA Hannan dies

Former Jatiya Party lawmaker MA Hannan, who was facing trial for allegedly committing crimes during the Liberation War, died of cancer yesterday. He was



Hannan died at Bangabandhu Sheikh Mujib Medical University yesterday morning, Rezia Sultana Chaman, a prosecutor of International Crimes Tribunal, told The Daily Star.

He was taken to Dhaka Medical College Hospital on June 5 after he fell ill in Kashimpur Central Jail, said Jailer Rabiul Islam, adding that he was admitted to BSMMU the next day.

On June 7, Hannan tested positive for Covid-19, the jailer said. Hannan's body has been kept at DMC morgue for autopsy

Hannan, former lawmaker from Trishal (Mymensingh-7 constituency), his son Sajjad, and six others from Mymensingh were made accused in a case filed for

First Delta variant cases in Ctg found

Researchers have detected Chattogram's first cases of the Covid-19 Delta variant, which was first found in India. According to them, none of the two patients infected

with the Delta variant had a history of visiting India recently and they also did not come into close contact with any symptomatic Covid-19 patients. They have also not ventured outside Chattogram in a

couple of months, said the researchers. They believe this may be a sign that the Delta variant of Covid-19 may have started community transmission in Chattogram. The researchers led by Dr Al Forkan, professor of

Genetic Engineering and Biotechnology Department of Chittagong University went for genome sequencing of 42 samples collected from seven laboratories in Chattogram including CU lab, Chattogram Medical College Hospital lab, Chattogram General Hospital, Imperial Hospital and Chattogram Veterinary and Animal Sciences University in the last week of May. "We have found 33 samples of Beta (South African)

variant, four of Alpha (UK), three of Eta (Nigerian) and two of Delta (Indian) variant," said Dr Forkan.

"It's for the first time that Delta variant has been detected

in Chattogram," he said

"We have contacted both the patients -- a 52-year-old male living in Fatikchhari upazila and a 32-year-old female residing in the port city. They said they did not visit India SEE PAGE 4 COL 3

recruit the six lecturers. Lawyers Aneek R Haque and Syeda Nasrin appeared for the writ petitioners while Deputy Attorney General Arobinda Kumar Roy represented the state and lawyer Cumar Debul Dey argued for JU.

JU authorities issued a circular on February 11 for appointing six lecturers to its philosophy department.

Four teachers of the department -- Prof Dr Mohammad Kamrul Ahsan, Prof Dr ASM Anwarullah Bhuiyan, Prof Md Zakir Hossain and Assistant Prof Abdus Satter -- on June 10 filed the writ petition with the HC, challenging
