mangrove forest, Sundarbans, is expanding and the number of tigers has already increased there. She also said the reserve of carbon in the Sundarbans has increased from 106 million tonnes in 2009 to 139 million tonnes in 2019.

"Actually the Sundarbans is expanding. The number of tigers has risen," she said in a scripted answer.

Hasina, also Leader of the House, mentioned different steps taken by the government to save the Sundarbans and its biodiversity.

She said there were 106 tigers in the Sundarbans, according to the tiger census conducted through camera tracking in 2015. But the number rose at 114 as per the 2018 tiger census, she added.

The premier said the numbers of trees and tigers have increased due to the government's measures and strengthening the forest management.

Considering the shortage of manpower of the forest department, an initiative is being implemented to create some more posts for protection and preservation of the Sundarbans, said Sheikh Hasina.

Tuition fees of students should be waived during the pandemic, he further said.

He added that the government should scrap the decision of imposing 15 percent income tax on private universities and private medical colleges.

On March 17 last year, the government closed all educational institutions to contain the spread of coronavirus. It led to cancellation of exams and left academic calendars in disarray. The government extended the closure to June 30 this year.

be named -- said the dealer instructed them not to sell soybean oil unless customers bought lentils and sugar. He declined to mention the dealer's name, nor did he provide their phone number.

The same situation was observed at Jamal Khan Road and New Market areas. However, OMS trucks were not found in many areas, including Chawkbazar, Anderkilla, Muradpur and Bibirhat yesterday.

Contacted, Jamal Uddin Ahmed, TCB regional head at Chattogram, said although OMS service would stop today, it will resume in the near future.

Asked about customers' allegations, he said all dealers were strictly instructed to not sell packages of multiple goods.

"We instructed dealers to sell any item available in the truck. But I received complaints from customers that in many areas, dealers were selling three items as a package. Many customers are being refused if they want to buy individual items," he said.

"We are looking into the issue."
"If the allegation is found to be true, we will cancel their dealership," he added.

mostly remained closed amid the pandemic, said Shahadat Hossain, a member of the alliance.

At present, about 30,000 to 40,000 migrant workers are waiting for flights to Saudi Arabia, he added.

He said increased ticket price made it difficult for recruiting agencies to bear the cost. Indirectly, the burden falls on the shoulders of migrant workers.

Earlier, the government announced about 1.20 lakh doses of Covid-19 vaccines for migrant workers but those could not be used. One reason was the age limit of above 40, said Fakhrul Islam, another member of the alliance.

Most migrant workers intend to go abroad are aged between 21 and 40, he said, stressing for bringing a change to the age limit for vaccinating migrant workers.

Fakhrul also said Saudi Arabia's requirement does not include Chinese vaccine while Bangladesh has about six lakh doses of such vaccine at its reserve at present.

If necessary, Bangladesh can negotiate the matter with Saudi Arabia, he added.

Jakir Hossain, Maulana Anowar Hossain and Maulana Anisur Rahman.

After hearing, the magistrate took the case into cognisance and recorded the complainant's statements on Tuesday.

The court also directed Police Bureau of Investigation (PBI) to investigate the case and submit a report to it by July 17.

According to case documents, in

October last year, around 250 people, led by 33 of the accused, illegally gathered near Al Madrasatu Mueenul Islam in the capital. At one stage, they stormed into the madrasa and looted cash and valuable documents.

On October 13, the accused attacked teachers of the madrasa and some guardians with iron rods, sticks, sharp weapons and bamboo, and snatched away their money and phones, the complainant said.

"How will lawmakers provide the list? The finance minister is in charge of the Ministry of Finance. He should provide the list of money launderers."

The JP lawmaker said, "Every audit report has the information -- how irregularities and corruption are taking place in different sectors. The finance minister can get information about who is smuggling money from there."

Pointing to media reports, he said, in the 2017-18 fiscal, there was corruption of at least Tk 1,000 crore in purchase of equipment in the health sector.

He called upon the health minister to take actions against corrupt persons involved in the health sector.

"At least let our conscience be awakened during this time of Covid-19. Catch these corrupt people. Ensure treatment of people. We want to ensure Covid-19 vaccination for people," he also said.

Speaking on the proposed budget, BNP MP Mosharof Hosen strongly criticised the government for making an additional secretary OSD (official on special duty) on June 6 for making public the price of vaccine. "Coronavirus vaccines are being purchased with people's money; people have the right to know the price. It is sad that an officer was made OSD for this."

Jatiya Party MP Sayed Abu Hossain Babla also lambasted the health minister for his failure to stop widespread corruption in the health sector.

accounts. Subsequently, Asaduzzaman collected various documents from the workers to open their salary accounts.

Once the accounts and ATM cards were prepared, these were sent to Asaduzzaman for delivery to the account holders. But he didn't give the ATM cards to the customers, but handed over these to Al Amin Babu in exchange of money. Babu credited the collected cards with Tk 20,000, according to DB.

While debiting the money from the ATM, Babu contacted Rony, an IT officer at DBBL. The journal that was created by the ATM booth against the account during the withdrawal was changed by the IT officer before going to the storage server.

Rony disconnected the ATM booths operated through the ESQ ATM monitoring software with the journal storage server just before the withdrawal. Due to the disconnection of the software, the journal generated during the ATM booth withdrawal is not credited to the server.

Following this, Rony converted the 'successful' message into an 'unsuccessful' message, so even if the message later goes to the journal server, it is no longer considered as a successful message. In other words, even after withdrawing money from the booth, the message comes as unsuccessful.

The DB official said that Babu, meanwhile, called the DBBL hotline as planned and complained that he tried to withdraw money from the ATM booth but did not receive the money. Following the complaint, the in-charge of DBBL verified the reliability of the complaint. When the concerned officer saw that the card was inserted in the ATM booth to withdraw money but the journal was 'unsuccessful', the officer adjusted the balance in the account in response to the complaint.

The ring has been embezzling money this way since 2018, the DB official said.

The DB official said they arrested Rony's wife as they found a hefty amount of money in her bank account. Moshir Rahman, vice-president of DBBL, told The Daily Star that Rony joined the bank in 2010 and has been working at its ADC Division. In 2018, they first noticed such type of misappropriation.

Asked, he said Rony came to the office two months ago for the last time.

The DBBL official said that they have filed a case with Motijheel Police Station in this connection.

establishments, but we will need a few more months to demolish all 74," Gulzar told this correspondent.

The structures razed include a five-storied, a three-storied, three two-storied, and four single-floor buildings, eight tin-sheds, and six half-completed structures.

The cadastral survey done in 1924 and the revised survey done in 1973 clearly show the 6.5km-long old channel of the Buriganga split into two flows separating Kamrangirchar and Jhau Char from Dhaka city, BIWTA officials said.

The channel started to disappear after the government built a power substation and a hospital in the 1980s, after which unauthorised structures were built there, said locals.
