





# Business as usual for health ministry

Its development spending crawls despite pandemic



The health ministry's development spending has been low despite the government's emphasis on the sector for the second year running amid the coronavirus pandemic.

The health ministry's development spending was stuck at a disappointing level even after 11 months of the outgoing fiscal year for its failure to accelerate expenditures when the public needed the most.

The health division used Tk 3,759 crore out of Tk 11,971 crore in the 11 months to May, which is only 32 per cent of the allocation made from the annual development programme, data from the Implementation Monitoring and Evaluation Division (IMED) of the planning ministry showed.

Despite the government's emphasis on the sector for the second year running amid the protracted pandemic, the expenses have been low.

"The health ministry has low capacity in utilising project aid. It is, however, okay when it comes to using the government fund," said Pradip Ranjan Chakraborty, secretary of the IMED.

The health services division used up 48 per cent of the fund disbursed from the state coffer during the July-May period. It was 17 per cent when it comes to project assistance.

When the IMED asked the ministry about the low ADP implementation, it replied it was working, and good progress would be visible at the end of the fiscal year, Chakraborty said.

Khondaker Golam Moazzem, research director of the Centre for Policy Dialogue, said the low implementation rate of the division proved that the officials responsible for executing projects were not efficient and did not emphasise implementing the initiatives related to the health sector.

## **GLOBAL COTTON TRADE** Bangladesh among 3 countries leading recovery: USDA

Bangladesh has joined two other countries to lead the global cotton trade recovery as the demand for the commodity has risen sharply thanks to buoyant apparel shipments, according to the United States Department of Agriculture (USDA).

"Record global trade is boosted, led by robust demand in China, Bangladesh, and Turkey," the USDA said in its June report.

Cotton exports are up for the three largest exporters -- India, Brazil, and the United States. The US forecast has higher exports while stocks are projected at their lowest in four years.

The US season-average farm price has lowered by one cent to 67 cents per pound, the USDA said in its report on cotton for 2020-21.

## Look before you book a flat

Sheikh Mehedi Hassan and his wife recently moved into their flat from a rented one in Mirpur-6.

For them, it was a dream come true - ever since their marriage, the couple had been planning to own a flat in the capital city.

In fact, Hassan, a banker, had lived in rented flats since his graduation.

He had some apprehensions before buying the flat, as it was going to be the most expensive purchase of his life.

So, he did his homework and learnt about the entire process from the flat selection to verification of essential documents, which are crucial to this end, before placing the booking order.

He did not hesitate to seek help.

A number of his colleagues from the bank's legal department lent a helping hand to understand the legal procedures and scrutinise and verify documents of the developer and the land records.

"One shouldn't rush to sign a purchase agreement. Since you want to build a permanent address with your hardearned savings, it is best to do thorough research on the seller and show the land deeds and contracts to a lawyer and then book the flat."

"As a result, I faced little troubles during our transition to our own flat from a rented house," the banker said.

There are several things that need to be looked at before buying a flat, plot or piece of land. Otherwise, there is a risk of getting into trouble, he said.

"One shouldn't rush to sign a purchase agreement. Since you want to build a permanent address with your hard-earned savings, it is best to do thorough research on the seller and show the land deeds and contracts to a lawyer and then book the flat."

#### the traditional industry in Rangpur was struggling to survive as demand from home and abroad has diminished amidst the ongoing coronavirus pandemic.

According to local traders, the increasing price of raw materials has made it difficult for producers to continue running operations.

Around 50,000 people of Rangpur are involved in the industry, some 95 per cent of whom are women.

However, traders said the recognition of Shatranji, which comes in the form of rugs, placemats and carpets, would play a helpful role in the growth of the industry at both home and abroad.

Zakia Sultana, secretary to the industries ministry, said through the recognition, the unique identity of the fabric can be presented before the world and this move would strengthen the Shatranji-based economy.

"We have many more products in different districts. The patents of those products have not been collected so far for various reasons. We are working harder on these issues now," she added.

## BSEC removes floor price for all listed firms

The Bangladesh Securities and (BSEC) Exchange Commission yesterday lifted the floor price for all listed companies as it moved to halt its efforts to intervene in share price mechanisms.

Last April, it lifted the floor from 66 companies primarily.

Analysts, merchant bankers and asset managers welcomed the decision.

The capital market is all about price discovery where price floors have absolutely no place in the capital market, said Shahidul Islam, chief executive officer of VIPB Asset Management Company.

Ifad Autos has been allotted 30 acres of land at the Bangabandhu Sheikh Mujib

The company has a plan to establish a manufacturing and assembly plant for motorcycles, a factory for automotive components, and a blending plant for machine lubricants in the complex.

"We have a target to utilise the full land within three to four years and the construction will start just after the current rainy season," said Managing Director Taskeen Ahmed.

"We may establish two other projects here because we are seeing potential of the automotive sector in Bangladesh, he said. There are more than 10 lakh commercial and 16 lakh passenger vehicles in the country which need spare parts, according to Ahmed.

# As Fed taper inches closer, investors prepare for volatility ahead

#### **REUTERS**, New York

As the Federal Reserve takes initial steps toward removing its massively accommodative policy, investors are preparing for the main show ahead.

Fed officials on Wednesday penciled in two potential rate hikes in 2023, sooner than policymakers had previously projected, and Chair Jerome Powell edged closer to unveiling plans to taper the Fed's \$120 billion a month of bond purchases.

Powell went so far as to describe the two-day gathering as the "talking-about talking-about meeting," a glib reference to his protestations earlier this year that he and his colleagues were not even "talking about talking about" tighter policy.

"The Fed is making it clear that they will wait and wade through a noisy summer of data to see a trend before they make a decision about liftoff," said Jason England, global bonds portfolio manager at Janus Henderson.

England expects to see greater market volatility leading bond up to the central bankers' confab in Jackson Hole, Wyoming, in late August and remains focused shorter-duration bonds on in anticipation of a sustained economic recovery.

"The logical response to today's information is that interest rates are going to go higher, and they will probably be going higher faster than people may have thought," said Marcus Moore, assistant portfolio manager at Zeo Capital Advisors.

A more extreme reaction could lay ahead if signs appear of strongerthan-expected inflation and other factors that could push the Fed to taper faster than anticipated, some

said policymakers are not facing a situation where they are "behind the curve.

"We have become more defensive because we don't think the bond market should have so much apathy to inflation," said Thanos Bardas, co-head of global investment grade and senior portfolio manager at Neuberger Berman.

Consumer prices jumped 5 per cent in May, the largest annual jump in 13 years, while supply bottlenecks recently pushed lumber prices to alltime highs before tumbling 40 per cent from their records.

The Fed's projections show inflation exceeding the Fed's 2 per cent target by a wide margin of 3.5 per cent this year.

Todd Thompson, managing director at Reams Asset Management, said wage pressures from a record number of 9.3 million job openings will force the Fed to move more quickly than many in the market anticipate given that real interest rates remain negative.

"With the economy running at a galloping pace, negative real interest rates are a disconnect to reality and that has to be reconciled" through rate hikes, Thompson said.

Ten-year Treasuries, which reflect gains after inflation, trade at a real rate of negative 0.75 per cent.

Duncan, chief Douglas economist at Fannie Mae, said he would have thought there would have been more commentary" on the Fed's monthly purchases of \$40 billion in mortgage-backedsecurities.

## Britain, US reach truce in Airbus-Boeing trade dispute

Britain and United States agreed on Thursday to resolve a long-running trade dispute over Airbus and Boeing and turn their attention to tackling Chinese subsidies, echoing a five-year tariff truce announced by Washington and Brussels.

Together, the deals draw a line under 17 years of battles at the World Trade Organization over aid for the world's largest planemakers and establish a common front against "non-market" funding, in a reference to China's rising aerospace sector.

The dispute had triggered a months-long transatlantic tariff war hitting industries such as Scotch whisky until the punitive measures were suspended earlier this year to ease negotiations.

Tariffs will now be set aside for a further five years while governments pledge to provide any funding on market terms, but the almost identically worded UK-US and EU-US agreements effectively remove for the time being a key source of transatlantic trade tensions. "This will support jobs across the United Kingdom and is great news for Scotch whisky and other exports including aerospace who will no longer face punitive tariffs," British trade minister Liz Truss said on Twitter.

The European Union reached a truce two days ago with Washington in their conflict over aircraft subsidies, suspending for five years one set of Trump-era tariffs that had soured relations. The two sides had been battling since 2004 in parallel cases at the World Trade Organization over subsidies for US planemaker Boeing and European rival Airbus, which each claimed to have been damaged by unfair competition.

Britain has since left the European Union and Thursday's almost identically worded agreement achieves many of the same results as the EU-US deal. In December, Britain and the United States came close to a standalone aerospace deal that could have forced the hand of Brussels in its own talks with Washington, but drew back amid concerns over UK jobs, Reuters reported.

## Low prices dampen spirits of mango farmers

Salauddin sold Tk 2 lakh worth of mangoes from his garden this year, down from Tk 3.5 lakh in 2020. Many farmers who have no direct link with traders in the country's major cities or access to online markets are being compelled to sell their stocks at lower prices fearing losses as the mangoes might remain unsold or rot.

Some farmers say they took mangoes to Dhaka after failing to sell them at local markets at a fair price. However, they still could not make an adequate profit despite paying transportation costs and market fees.

Yusuf Ali, a farmer and wholesaler in Chapainawabganj, said it is tough to send mangoes to Dhaka via the Mango Train, which carries the fruit just once a day, due to its tight schedule and booking procedure.

Kowsar Ali, a mango farmer and trader in Rajshahi, said the Mango Train service is cheaper than other services, but it is very difficult to get a booking due to its inadequate capacity.

"It costs only about Tk 80 to send one maund of mango on the special train, while it costs Tk 640 to send it by couriers," he added.

Ali Hossain, who suffered a loss in his

restaurant business in Binodpur Bazar of Rajshahi amid the pandemic, said he bought mangoes from an orchard for Tk 80,000 but could not make a profit due to lower prices. Alamgir Mia, a farmer in Chapainawabganj, said his six-member family is dependent on selling mangoes

"It will be difficult to manage my expenses this year as the price of mango is around 40 per cent lower than last year," he added.

Citing similar difficulties, many other farmers in the region express concerns over the lower prices despite the good yield.

Md Sorof Uddin, a senior scientific officer at the Horticulture Research Centre of the Bangladesh Agricultural Research Institute (BARI) in Gazipur, said the biggest problem is that buyers from Dhaka, Chattogram and other parts of the country were not able to travel to the region to buy mangoes because of the restrictions.

"So, mango growers are not getting fair prices," he said.

Another problem is that many mangocarrying vehicles face harassment, such as having their tyres punctured when returning after

unloading a shipment.

"So, local administrations should take some steps to encourage the buyers and give them a clear message that no vehicle would be harassed if they come to buy mangoes," Uddin added.

Md Asadullah, director-general of the Department of Agricultural Extension (DAE), said as there were no major natural calamities like last year, mango yield has been good this year. The DAE expects that 24 lakh tonnes of mangoes will be produced across the country this year. Last season, 24.68 lakh tonnes of mangoes were produced on 1.9 lakh hectares of land.

Around 8.52 lakh tonnes of mangoes are expected to be produced on 83,673 hectares of land in Natore, Naogaon, Rajshahi, and Chapainawabganj, according to DAE data. The region's mango production stood at 7.76 lakh tonnes last vear.

Of the roughly 100 varieties of mangoes grown in the country, the top varieties include Gopalbhog, Laxmanbhog, Ranipasand, Himsagar, Langra, Fazli and Amrupali. Besides, the supply of Ashwina and BARI Mango-4 will begin from July 10.

## Ifad Autos gets land to build industrial complex

Knitwear shipments fetched \$15.36 billion, and woven garments brought home \$13.19 billion, clocking 20.55 per cent and 1.80 per cent yearon-year growth, respectively.

The export data shows that the Bangladeshi garment sector is recovering fast with the rise in demand in the western world.

A significant development was the return of woven shipments to the positive territory last month after declining for a year.

The demand for woven items had fallen in the western world as formal events were suspended because of the lockdowns and fears over contracting Covid-19.

Knitwear items maintained 12 per cent growth over the last year because of an increase in demand for more extended stays of people at

"The recovery trend is good, and it will not be short-term this time," said Faruque Hassan, president of the Bangladesh Garment Manufacturers and Exporters Association (BGMEA).

However, it will take long to recoup the imports, and attractive prices for imported industry's losses last year because of the fallouts of the Covid-19, he said.

"We have been receiving a handful of work orders. There has been the reinstatement of previous orders. But many factories are running at losses," Hassan said

Last year, international clothing retailers and brands either suspended or cancelled work orders worth \$3.18 billion, of which 90 per cent have been reinstated so far.

Hassan said the retailers and brands had been paying up, but there were many who had gone bankrupt and were still delaying payment.

The volume of merchandise trade was down 15.5 per cent year-on-year in the second quarter of 2020 when lockdowns in many countries were in full effect. But by the fourth quarter, trade had surpassed the level of the same period in 2019, said the World Trade Organisation on May 28.

On the global cotton trade, the USDA said China's 2020-21 imports were forecast at a seven-year high, driven by the highest projected consumption in three years, robust state reserve

cotton relative to domestic supplies.

Imports are expected to support China's record year-over-year rise in consumption.

China's 2020-21 consumption is expected to recover from the lowest level in 16 years to surpass the previous year by 7 million bales, accounting for half of the gain in global use.

Since Bangladesh is not a major cottonproducing nation, 99 per cent of the requirement or the raw material is met through imports.

Traders, importers and millers may import 8.5 million bales of cotton this year, spending \$3 billion this year, said the BTMA.

Last year, cotton imports fell to 7.5 million bales as production came to a halt in many mills after the government had imposed nationwide restrictions to tame the coronavirus pandemic. (One bale equals 480 pounds.)

Rising bad loans, provision shortfall are the reasons, experts say

The gloomy picture of the banking sector led to a fall in the stock market over the past week amid rising coronavirus cases and deaths.

The DSEX, the benchmark index of the Dhaka Stock Exchange (DSE), dropped 13.89 points to 6,066 compared to the week before.

Among major sectors, banks dropped the most, shedding 2.33 per cent in the week, according to the weekly analysis of LankaBangla Securities.

The main reason for the fall of banking stocks is that the sector's health deteriorated after its payment holiday ended last December, stock market analysts said.

Non-performing loans (NPLs) stood at Tk 95,085 crore in March, up 7.1 per cent from three months earlier and 2.8 per cent year-on-year, data from Bangladesh Bank shows. The payment holiday was introduced in late March last year to help businesses ride out the unprecedented Covid-19 crisis.

Defaulted loans accounted for 8.07 per cent of the outstanding loans of Tk 1,177,658 crore in the banking industry for that month. The ratio was 7.66 per cent in December.

Due to the higher rate of bad loans, the provision base of banks in Bangladesh deteriorated heavily in the first quarter of 2021. The shortfall ballooned more than 42 times to Tk 5,228 crore in March compared to Tk 123 crore three months before that, as per Bangladesh Bank data.

As the banking sector is a large paidup capital-based sector, its impact on the index was higher.

"This is not a surprise for stock investors who saw the deterioration of the banking sector after the loan moratorium ended but it still disheartened them, said Shahidul Islam, CEO of VIPB Asset Management.

About the recent market movement, Islam said the sudden rise in insurance stocks or junk stocks are only because of speculation. "Investors need to be cautious about such companies that move fast," he added.

Investors are following a wait-and-see policy to invest now as the index has soared over 550 points already within two months despite the worsening pandemic situation,

according to another analyst. Sixty-three people have died from Covid-19 in 24 hours till 8:00am yesterday, according to the Directorate General of Health Services.

At least 3,840 new infections were recorded in the meantime and the current positivity rate is 15.44 per cent while the total positivity rate stands at 13.42 per cent.

Mango farmers across the country, particularly in Rajshahi and Chapainawabganj, have been left disappointed by the lower prices for the 'King of Fruits' despite having secured very good yields this season.

Depending on varieties, mango prices are currently around Tk 1,100 to Tk 1,700 per maund (40 kilograms), down by Tk 600 to Tk 800 compared to the same period last year, according to traders and farmers. The ongoing restrictions on public movement could cost the industry about Tk 3,000 crore, they said.

Although vehicles carrying mangoes have been kept out of the purview of the restrictions, traders are reportedly being harassed while trying to transport the fruit, making them afraid of visiting the hubs.

In a bid to facilitate mango transportation, the government launched a special train dubbed the Mango Train from Chapainawabganj via Rajshahi to Dhaka. But the service is not enough to meet the huge demand, traders and farmers said

The livelihoods of 300,000 farmers in the Rajshahi region alone and thousands of others involved in mango trading will be at stake if fair prices cannot be ensured.

As of Thursday, farmers are selling the Himsagar variety for Tk 1,400 to Tk 1,700 per maund.

Langra mangoes are priced at Tk 1,100 to Tk 1,400 per maund, Laxmanbhog at Tk 600, and Guti at Tk 400 to Tk 500 at the local wholesale markets, including Kansat Bazar of

Chapainawabganj and Baneshwar Bazar in Rajshahi.

Local traders sell these mangoes to buyers from other districts at Tk 1,500 to Tk 1,800 per maund. However, these varieties are then sold at the wholesale markets in Dhaka, such as Karwan Bazar, for Tk 1,500 to Tk 2,200 per mound.

The price is Tk 50 to Tk 70 per kg at the retail level

Md Salauddin, a farmer in Bagha upazila of Rajshahi, said after seeing a good yield of mango this season, he had dreamed of making a good profit, but the dream has broken because of the lower prices.

"Farmers are not getting fair prices in this peak season due to the absence of buyers in the local markets," he added.

Apple warns EU law 'risks destroying iPhone security'

## cut import duty on edible oils

India has put on hold a proposal to reduce import duties on edible oils as cooking oil prices started to fall in the world market after hitting record highs, two government and one industry officials told Reuters.

The world's biggest vegetable oil importer was considering reducing duties after domestic soyoil and palm oil prices more than doubled in the past year, hitting consumers already stung by record fuel prices and reduced incomes amid the Covid-19 pandemic.

"We are not cutting import duties now, a more longer term solution has to be found. Cutting duties is not a sustainable solution," said a government official with knowledge of the matter who asked not to be identified.

Yet even after the recent correction of more than 20%, Indian edible oil prices are still around double their levels a year ago

Household consumption is expected to decline the longer prices remain elevated.

Demand from bulk buyers like hotels, restaurants and bakeries had already dropped after authorities imposed local lockdowns in response to a devastating second wave of coronavirus infections over recent months, dealers said.

While India deliberated lowering import duties on vegetable oil, benchmark palm oil prices in Malaysia fell nearly a quarter in the last one month, giving some respite to importing countries.

The EU's proposed new rules to rein in tech giants risk undermining the security of the iPhone, Apple chief Tim Cook warned Wednesday.

The European Union last year unveiled tough draft rules targeting tech giants like Apple, Google, Amazon and Facebook that could shake up the way Big Tech does business.

Cook, speaking at the VivaTech convention for startups in Paris, took aim at some of the rules that target online "gatekeepers" such as Apple which controls which apps can be installed on its phones and tablets.

He said current proposals "would force side loading on the iPhone, and so this will be an alternative way of getting apps onto the iPhone.

"Side loading would allow iPhone users to install apps directly from publishers, something they cannot currently do.

The restriction that iPhone owners may only buy apps from Apple's App Store, where commissions run up to 30 per cent, is at the heart of a lawsuit between the tech

giant and Epic Games, the publisher of the popular Fortnite video game.

The EU also pushed forward with charges against Apple over the App Store, saying the company used it to squeeze out rivals. Apple has countered that restrictions on downloading apps are essentially to protect consumers from dangerous software.

Cook warned Wednesday that the proposed EU rules "would destroy the security of the iPhone, and a lot of privacy initiatives that we've built into the App Store.

## Macron bemoans 'nonsense' innovation

Takes aim at Chinese and US tech bonanza

French President Emmanuel Macron called out on Wednesday what he described as excesses of liquidity in the US and Chinese financial markets, some of which he said could instead foster the growth of tech companies in Europe.

"We can attract a lot of Chinese and American investors because when I look at what they are financing sometimes, some bullshit innovation they finance because you have too much liquidity in the market," Macron told a panel of executives from startups at France's tech show Viva Tech.

Macron did not elaborate on the kind of innovation or specific companies he had in mind. "This place (Paris) now is more and more perceived as first business-friendly and then innovative," he said.

"So the more ... we elaborate and increase the strength of this place the more you will attract investors coming from the United States an China.

Macron is pushing for Europe to create 10 technology giants worth 100 billion euros (\$120 billion) each in valuation by 2030, in a bid to rival US companies that dominate the sector.

But while a growing number of digital companies are lining up to go public via an initial public offering (IPO) or a buyout from a special-purpose acquisition company (SPAC), investments in tech lag those seen in the United States and China.

Macron has since his election in 2017 championed investment in the digital economy as a key to lower unemployment and stimulating economic growth and vowed to turn the country into a "startup nation."

## Egypt souvenir market pins hopes on tourism revival

"The idea is to keep a close

Pyramids, Tutankhamun masks, Nefertiti busts --Egypt's souvenir-makers are pinning their hopes on a new lease of economic life, after tourism was battered by the coronavirus pandemic.

In the shadow of the magnificent Giza Pyramids, Eid Yousri manufactures polyester Pharaonic figurines from a humble workshop erected on the roof of his family home.

"We've lost nearly 70 per cent of our business," he told AFP, lamenting the plunge in visitors to one of the seven wonders of the ancient world.

Before the pandemic, "we had about 15 workers -- compared to five today," he said, noting that even the remaining staff were not full-time

He sells his products from as little as 20 Egyptian pounds (about \$1.30, or one euro) to 200 pounds.

Hundreds of small business owners and artisans have been forced to mothball much of their activity, choked by cancelled flights and movement restrictions around the world.

Yousri hopes that foreign tourists are lured back to Egypt in the latter part of the year, "especially Americans", with some groups from the US expected in September.In 2019, the last full year before the pandemic struck, tourism made up about 12 per cent of Egypt's GDP.

After a long period of political instability dented earnings, revenues from the sector reached \$13 billion that year.

But in 2020, a year when Egypt had initially eyed a further rebound to \$16 billion, takings collapsed to \$4 billion.

In a recent interview with AFP, Tourism Minister Khaled El-Enani welcomed a partial recovery in visitor numbers.

Around 500,000 have flown in monthly since April this year, more than double the number in January and up from an average of just 200,000 tourists per month in 2020.

On the other side of town, in the narrow and labyrinthine alleys of Khan el-Khalili in Islamic Cairo, tourist Caroline Bucher is on the hunt for "locally made" products to bring back home to her native Dominican Republic.

"We're looking for hand made and quality souvenirs, that are about local culture," she told AFP. "It has to be a memory of the trip.

"In a souvenir market that was for many years flooded by cheap Chinese imports, the government is seeking to meet demand for quality products sought out by tourists like Bucher.

On the eastern outskirts of Cairo, a new antique reproduction factory has since March been preparing to capitalise on the much hoped for post-pandemic era.
