THIRD MEETING OF TASKFORCE ON ROAD CRASHES

Old decisions taken afresh

A taskforce aiming to curb road crashes and bring discipline in road transport sector, led by Home Minister Asaduzzaman Khan Kamal, sat for its third meeting yesterday after a six-month hiatus.

Apart from the minister, two lawmakers, several secretaries, inspector general of police, experts and top transport leaders took part the three-hour closed-door meeting.

And finally, they came up with almost similar decisions, which they had taken in the previous meetings, and or in different platforms, and remained unimplemented for a long time.

For example, the home minister after the meeting said they have decided to stop battery-run rickshaw across the country and the ministry concerned will issue necessary directives in this regard soon.

However, the same decision was taken around a decade ago.

The government in May 2011, following an inter-ministerial meeting, banned import and assembly of such vehicles and decided to send off-road those already plying the roads.

Besides, the High Court on July 3, 2014, banned plying of battery-run rickshaws across the country for not running with valid licences as per the law.

Moreover, the taskforce, in its second meeting on December 23, also asked the north and south city corporations and Dhaka Metropolitan Police to take effective measures to stop battery-run rickshaws in

In the second meeting, the taskforce decided that drivers, conductors and helpers of public transports have to be given appointment letters.

After yesterday's meeting, the home minister said they have taken the decision that transport workers have to be given recruitment letter and transport leaders would implement the decision soon.

The minister said they have decided to take stern action so that no motorbiker would be allowed to carry more than one

However, the road transport and bridges ministry on June 6, 2016, following several recent murders committed by bike-riding criminals, issued a circular saying that the government would ensure that no more than two people ride a motorbike.

Five killed, seven hurt in truck-microbus collision

Five passengers of a microbus were killed and seven others injured in Narsingdi on Saturday midnight, as the vehicle collided head-on with a truck.

The accident took place at Bhatpara Sakura intersection on Panchdona-Ghorashal-Tongi road, said Sub-Inspector Zahidul Islam of Madhabdi Police Station.

The deceased were identified as Rubi Akter (33), his daughter Raima Khan (5), and his nephew Sadek Khan (8), their

relatives Rokeya Begum (52), and Mukti Akhter (30), reports our Brahmanbaria correspondent.

The injured have been identified as Shamsunnahar Begum (60), Kazim Uddin (42), Abdur Rashid (40), Razia Akter (40), Sharmin Akhter (38), Saifa (12), and Israt Jahan (6)

SI Zahidul said the victims were first taken to Narsingdi Sadar Hospital, from where four injured were sent to Dhaka. SEE PAGE 4 COL 2

Attain highest professional excellence

PM urges army

Bss, Dhaka

Prime Minister Sheikh Hasina yesterday urged the members of Bangladesh Army to concentrate on attaining the highest professional skills and excellence, keeping pace with the changing world.

"I believe Bangladesh Army, in continuity with the past, will remain ever ready to tackle any disaster alongside protecting the country's sovereignty," she said.

The premier said this at the induction ceremony of Tiger Multiple Launch Rocket Missile System (MLRS) to Bangladesh Army's 51 MLRS Regiment in Savar Cantonment.

The PM joined the event virtually from her official residence Gono Bhaban in Dhaka.

Mentioning that Tiger MLRS at a time could strike accurately and effectively multiple targets in long distance taking less time than other artillery systems, she hoped it would bring new dimension to strengthen army's existing operational efficiency.

"I believe this modern system (MLRS) would strengthen army as well as increase mental strength and confidence of its personnel," she noted.

Repatriation the ultimate solution

Civil society groups at Refugee Day webinar urge int'l community to redouble pressure on Myanmar

Civil society groups have called on the international community to redouble pressure on Myanmar for Rohingya repatriation, which is the ultimate solution to the crisis.

They also urged all stakeholders to ensure human dignity of the Rohingyas and social cohesion until repatriation from Bangladesh, where some one million Rohingyas took shelter fleeing violence in Rakhine State, mostly in 2017.

The call came at a webinar organised by Cox's Bazar CSO-NGO Forum (CCNF), a network of 50 NGOs working in Cox's Bazar, marking World Refugee Day yesterday, at a time when Myanmar is facing political crisis since the military coup in February.

Many are worried that the repatriation SEE PAGE 4 COL 3 | process could now linger even further, and this puts further pressure on Bangladesh, especially due to the pandemic that has pushed millions of people below poverty ine with loss of businesses and jobs.

"International actors should not be only be limited to humanitarian assistance. They should redouble their effort and create pressure on Myanmar for Rohingya repatriation," said CCNF co-chair Abu Murshed Chowdhury.

Myanmar bears the main responsibility for creating conducive conditions in Rakhine state and ensuring sustainable repatriation of Rohingyas, and the international community must hold it accountable for this, he said.

He also suggested that along with the UN and states, there are also scopes for the civil society to engage in track-two diplomacy.

DEATH OF DOCTOR

Prof Dr Mamun Al Mahtab Shwapnil, chairman of Hepatology department at Bangabandhu Sheikh Mujib Medical University (BSMMU), and two other doctors were sued for the death of Dr Mohammad Towfig Enam. The two other doctors are Prof Dr Abdul Wahab

Khan, consultant laparoscopic surgeon of Islami Bank Central Hospital in Kakrail, and Prof Dr Mohammad Ali, hepatobiliary surgeon of BRB Hospital in Kalabagan. Senior physiotherapist Akteruzzaman Mia, father of the victim, filed the case with the court of Dhaka Metropolitan

Magistrate Rajesh Chowdhury yesterday, court sources said. The magistrate took the case into cognisance and recorded the complainant's statement.

The court also directed CID to investigate the case with an assistant superintendent of police (ASP) ranked official and submit a probe report before it by July 19.

In the complaint, Akteruzzaman said the three doctors are responsible for the death of his son Towfiq.

"The accused treated my son wrongly with serious negligence, while he [victim] was taken to them at their respective private chambers. Instead of right treatment, the accused took money from us in name of various tests through fraudulence by breaching the trust," the complainant alleged.

Towfiq died while undergoing treatment at BRB Hospital

The complainant on June 15 went to Kalabagan Police Station to file a case, but police suggested to file a case with the court, the case statement added.

Proposed Budget for 2021-22

Three physicians sued | Allocation for hygiene insufficient: speakers

Insufficient allocation and lack of focus in the budget will hinder the hygiene sub-sector, which remains a key priority for Covid-19 and the SDG Goals, speakers at a post-budget press conference said yesterday. They also stressed the need to reduce the gap in resource allocation for

Water, Sanitation and Hygiene (WASH) in rural and urban areas. The press conference was jointly organised by WaterAid Bangladesh, Unicef, Power and Participation Research Center (PPRC), FANSA-BD, FSM Network, Sanitation and Water for All, WASH Alliance, and MHM

Platform. The analysis presented at the session reflected the proposed national budget (2021-22 fiscal) allocation for WASH, which shows a slight decline in WASH budget allocation, from Tk 122.27 billion last year to Tk 119.55

Following the legacy of previous years, the allocation for hygiene has been overlooked in the 2021-22 fiscal, regardless of the predominance of he pandemic, the speakers claimed. The proposed allocation remains skewed toward urban areas, and that

too mainly on major cities with Wasa services, and substantially ignores the rural and hard-to-reach areas, they said.

Currently, the Covid-19 infection rate is showing a notable upward trend in districts outside the capital, indicating the need to scale up hygiene and WASH facilities to contain further spread of the virus transmission, they said.

'Inoculate us, now' Triple Murder in Capital

Kuwait expat workers stuck at home urge govt to vaccinate them with Gulf country-approved jabs STAFF CORRESPONDENT

Migrant workers, who are stuck at home after coming from Kuwait on holiday, yesterday urged the government to immediately inoculate them with Covid-19 vaccine approved by the Gulf country to make way for their return to workplace. They urged the government to allow them register for

vaccination using data in passport, saying most of them don't have national identity (NID) card required for the registration. They said this at a press conference held under the

banner of "Bangladesh-e Atkeypora Kuwait Probashi Forum" at the capital's Dhaka Reporters Unity, which was aired live on Facebook. The migrant workers said Kuwait's health ministry has

announced that expatriates with valid iqama or residence permit will be able to enter there after taking one of four vaccines approved by the Gulf country from August. The four types of vaccines approved by Kuwait are --

Pfizer/BioNTech, AstraZeneca, Moderna and Johnson and

Migrant worker Saiful Islam said at present about 12,000 to 14,000 of them with valid iqama are stuck in Bangladesh.

Mother forced her to 'anti-social activities'

Accused daughter tells police

Mehjabin Islam Moon killed her parents and sister in Dhaka's Kadamtali area as she was forced into "anti-social activities", police said yesterday, quoting her.

"As her mother forced her into antisocial activities, her father did nothing even after she complained to him about it, and her sister didn't listen to her despite warning, she decided that death is their only punishment," Shah Iftekhar Ahmed, deputy commissioner of Wari Division Police, said.

Mehjabin told police that her mother forced her into "sex work" after she passed SSC, and she was aggrieved over it.

Kadamtali police recovered the bodies of Masud Rana (50), a Saudi expat; his wife Mousumi Islam (45); and their daughter Jannatul Islam from a building on Rajjab Ali Sarder Road around 11:30am after Mehjabin called 999.

Mehjabin's husband Shafiqul Islam (40) and their five-year-old daughter were found unconscious in the flat.

12-YEAR-OLD WRONGFULLY CHARGED OF MURDER

Five lawyers challenge trial COURT CORRESPONDENT

Five Supreme Court lawyers yesterday filed a criminal revision petition with the High Court (HC) challenging the legality of the trial proceedings at the Juvenile Court in Bogura, in connection with a case where an underage boy was accused of murdering his eight-year-old brother.

Advocate Shishir Manir submitted the petition to the HC bench of Justice Jahangir Hossain and Justice Md Atoar Rahman, along with a copy of The Daily Star report on the matter, as well as its video report, as supportive documents.

In the petition, Shishir Manir prayed to the HC bench to summon case documents from the juvenile court and take necessary step to give remedy for the "gross injustice".

The Daily Star on June 11 published a report titled "Bearing the unbearable", and a follow-up video about the ordeal of Mohidul Islam's family.

On August 25, 2015, body of Mohidul's

son Sohag was found in a jute field in Bogura's Katakhali. A day later, Mohidul filed a case with Sariakandi Police Station.

On November 29 that year, local police came to his house and took away Mohidul's other son Sourav, saying they needed him for questioning. Twelve-year-old Sourav was shown arrested in the case for murdering his brother Sohag, and a confessional statement was recorded under section 164.

Sourav later claimed he was forced to give

the statement in face of police torture. Police submitted a charge sheet naming Sourav as the lone accused, but the father filed a no-confidence petition and the court handed over the investigation to Police Bureau of Investigation on July 11, 2017.

After investigating for last four years, PBI found Sourav to be innocent and arrested two persons in connection with the murder.

Police took benefits from the murderers since they are influential people and forced Sourav to confess to the killing of Sohag, Mohidul claimed.

Recruits of former RU VC at it again

This time confine treasurer for 4hrs, besiege admin building

For the second consecutive day, a number of the 137 staffers at Rajshahi University, who were unlawfully recruited by former Vice Chancellor Prof Abdus Sobhan, obstructed campus operations with their demand to allow them to

join their posts. Yesterday, a group of them confined treasurer Prof Akm Mostafizur Rahman Al Arif to his office for four hours.

Around 10am, around 50 of them -- mostly former and current Chhatra League leaders of the campus -- went to RU administrative building to meet acting VC Prof Ananda Kumar Saha. Failing to find him, they proceeded to take position

in front of the treasurer's room and kept him there till Acting proctor Md Leaket Ali said the agitators afterwards

took position at the administrative building and stayed there till this report was filed around 8pm.
