professor, Department of Economics, Jahangirnagar University; and Syeda Rizwana Hasan, chief executive, Bangladesh Environmental Lawvers Association (BELA), are among the 129 individuals who penned the letter.

"The involvement is contrary to President Xi Jinping's speech at the second Belt and Road Forum in 2019 where he said, 'We need to pursue open, green and clean cooperation ... We may launch green infrastructure projects, make green investments and provide green financing to protect the Earth which we all call home," they said in the letter.

"In February 2021, Economic and Commercial Counsellor (ECCO) of China in Bangladesh sent a letter to the Bangladesh's Ministry of Finance stating that 'the Chinese side shall no longer consider projects with high pollution and high energy consumption, such as coal mining and coal-fired power stations," they

Terming the project "A Bloodcoloured BRI project", the personalities and organisations said, "Since the beginning of the project in 2016, 12 people have lost their lives, more than 100 got injured and harassment cases have been filed against over 6,000 workers and villagers in three different incidents around this power plant."

"The project has been marred by lack of transparency, irregularities and rampant human rights violation since its inception. Lead sponsor S Alam group evicted thousands of

local residents and they were not paid a single penny for their land. Those who refused to give up their land were harassed with fake lawsuits. S Alam acquired several times more land than the actual 640 acres of project area using their muscle and mobsters," the

"Banshkhali power plant will be extremely harmful to the public health in the area. According to estimates, the coal power project will emit 192,200 million tonnes of carbon dioxide over its operating lifetime," it added.

They also added, "The project plans to apply very weak emissions standards, which would not be allowed even in China, and the flaws and omissions in the EIA help justify this. The ongoing construction itself creates a permanent waterlogging over a large area of the adjoining villages."

The signatories demand the Chinese minister to get aligned with those Chinese measures for foreign investment, and respond to their following demands:

1. Withdraw all involvement of your institution from the Banshkhali coal power project.

2. Investigate the issues in relation with human rights violation and erroneous Environmental Impact Assessment (EIA).

3. Ensure adequate compensation and rehabilitation of the dead and injured workers and the affected villagers

4. Without exceptions, cancel all ongoing and future investments in fossil fuel including coal, oil and gas.

even though they want to work as a helping hand of the government identifying their errors," he added.

Journalists show a lack of interest in learning new things, said Afsan Chowdhury, a researcher and columnist.

"In our country, reporters do not do the structural analysis on corruption in their reports. Rather, they talk about who is involved with the corruption. We are failing to say why corruption or stealing is going on," he added.

Maintaining ethics is imperative for all kinds of journalism, said Julfikar Ali Manik, planning consultant of Boishakhi Television.

If anyone does journalism violating ethics it means he/she is stigmatising the profession.

"We cannot collect information by force and purchase information from anybody. We cannot take away anything without informing a person from his/her room and these things will violate the ethics of journalism," Manik added.

Doing investigative journalism in Bangladesh is very challenging, said Gitiara Nasreen, a professor at the department of mass communication and journalism of Dhaka University.

The journalists' job is to talk and write, but in the last year they have seen their rights of journalists compromised all over the world, she said.

Talking about fake news in social media, Nasreen said during the pandemic mainstream media also gave wrong information.

Reducing sources of gathering information, torturing journalism physically and mentally and curtailing freedom by enforcing new laws are giving scope to fake news, said Masum Billah, assistant coordinator of outreach and communication division of the TIB.

Fake websites got four times more hits than 10 first-grade newspapers' websites, according to the World Health Organisation and the Centre for Disease Control and Prevention of content got warning signs from Facebook, he said in his keynote

It is claimed that 86 percent of the coronavirus cases in China would have been avoided if there were assurance of freedom of speech and accurate flow of information, he said.

"We are all responsible for the stagnation of current journalism in Bangladesh. This situation has arisen due to the government, the political parties, the administration, the owners of mass media, working journalists, journalist unions, and above all our tendency to accept and adopt and in some cases compel," he said.

In the keynote paper, TIB demanded a policy considering media as an assistant in ensuring the free flow of accurate information during the coronavirus pandemic.

They also demanded a repeal of the controversial sections of the Digital Security Act 2018 and declare the Official Secrecy Act 1923 extinct.

They also demanded bringing the subject of wholesale termination of journalists under the supervision of the government and different journalist organisations will have to take steps in this regard.

TIB also demanded necessary steps by the authorities concerned to ensure the security and health protection of journalists.

The local chapter of the global antigraft watchdog also demanded making the press council more effective than the information ministry.

# Rich nations hoarding Covid shots

Unfortunately, rich countries are hoarding vaccines. They have several times more vaccines than they need. Vaccines are expiring," he said without

naming any country or the conditions. "Those countries promised vaccines but are not supplying these. Before giving [the vaccines], they are asking for this or that in return. Nothing should be tied to vaccines," Momen told reporters at the foreign ministry after his return from a weeklong visit

During his visit, he had attended two UN events -- one on the Myanmar situation and the other on least developed countries (LDCs) -- and held a number of bilateral meetings with senior UN officials.

Bangladesh is desperately seeking vaccines from various countries, including the US, China, Russia, UK, Australia and Canada, following India's halt of vaccine export in February due to Covid surge in the country.

Serum Institute of India supplied only seven million of the 30 million AstraZeneca vaccines contracted with Bangladesh.

Bangladesh then reached out to other countries. China has donated 1.1 million jabs of Sinopharm vaccines, while Bangladesh received 106,000 doses of Pfizer/BioNTech's Covid-19 vaccine. Bangladesh also signed a deal with China for vaccine import and is in the final stages of a deal with Russia.

Some 15 lakh Bangladeshis who had received the first doses of the AstraZeneca vaccine are waiting for the second dose, but unsure of when the country would get more doses of that particular vaccine.

Two weeks ago, the foreign ministry

million 800 shots of AstraZeneca vaccine through Covax, but did not confirm the time of arrival.

Momen said the US Secretary of State Antony Blinken has written a letter to him recently, assuring vaccine supply following requests from the Bangladesh government and the Bangladeshi community for AstraZeneca vaccine.

He said Blinken said they will consider Bangladesh's case, but did not mention the amount and time. The US basically wants to give the vaccine under the Covax facility, but Bangladesh said they can also supply vaccine on a bilateral basis.

"The good news is that the US government is positive about Bangladesh," Momen said after the Biden administration announced the distribution list for 55 million of the 80 million doses of the US's own vaccine supply which the president pledged to allocate by the end of June. Of that, 16 million will come to

Asia, including Bangladesh. Last week, the G7 summit promised distribution of 1 billion doses of

vaccines globally by next year. Momen said the rich countries are making promises, but are not

delivering yet. Referring to his attending the UN event on the Myanmar crisis, Momen said Bangladesh's focus is Rohingya repatriation, but Myanmar has not kept its promise of creating conducive

conditions for Rohingya refugees to


