'Total shutdown' anytime

Says state minister after nat'l advisory panel recommends a 14-day shutdown; number of Covid deaths now 4 times higher outside Dhaka

Runaway Covid infections in every division except Dhaka has prompted health experts to recommend "stricter nationwide lockdowns" rather than focusing on protecting Dhaka.

The National Technical Advisory Committee (NTAC) on Covid-19 yesterday recommended "a complete shutdown" for 14 days. It warned about hospitals being overrun and said lives and livelihoods would be saved by the shutdown.

A state minister also went on the record to say that he agrees with the experts' recommendations and that an announcement for the "complete shutdown" could come any time.

Covid-19 deaths in seven divisions combined was around four times that of Dhaka's this month. Dhaka had always been the worst affected division until the Delta variant started riding this particular

In May, Dhaka recorded 458 deaths and in April 1,494, the highest in a month. The seven other divisions combined reported 651 deaths in May and 754 in April.

No division recorded more than 100 deaths during April and May, apart from Dhaka and Chattogram.

The NTAC in a press release yesterday said, "No matter what preparations are being made, the healthcare facilities will be insufficient if strict measures are not enforced."

It said a high transmission rate was found in more than 50 districts and that the effectiveness of the stopgap measures to curb transmission was being questioned.

'So much air but not a bit for him'

Wails wife of a patient who died of Covid-19; people jostle for ICU bed in Rajshahi as situation turns alarming there

Just four years ago, Papia Sultana donated a kidney to save her husband Aman Vardar. But on Wednesday, when all Aman needed was more oxygen, Papia watched helplessly.

Aman died of Covid-19 at the Rajshahi

Medical College Hospital. Her cries of anguish echoed through a hospital already filled with such grief on a day that saw the highest daily deaths -- 18 -- in the RMCH Covid unit. Eight of them were Covid-19 positive.

The unit is dedicated for the treatment of Covid-19 patients and those displaying coronavirus-like symptoms. "So much air around; I couldn't give

him even a bit of it," Papia wailed. Aman, 35, of Narayanpur village in



Rajshahi's Bagha upazila, was brought to the hospital on June 16 after being diagnosed with Covid-19.

His oxygen saturation level, aided by the hospital's central oxygen supply, was

around 93 percent that day.

Amid growing worries about the coronavirus situation in the country, health authorities logged 6,058 more Covid-19

ases in 24 hours till yesterday from 5,727 the previous day. The positivity rate fell slightly to 19.93 percent from Wednesday's 20.27 percent, according to a handout of the Directorate

General of Health Services (DGHS) Besides, 81 people died of Covid during the 24-hour period, taking the national

death toll to 13,868. The fresh cases pushed up the total caseload to 872,935, the handout added.

However, the mortality rate remained static at 1.59 percent. A total of 794,783 people, including

3,230 in the 24-hour period, have so far recovered from the virus.

Infections keep rising in different parts of the country as people are defying health protocols amid "lax enforcement" of restrictions despite health experts' repeated warnings about severe consequences.

They'll get payment after delivering items

Decides commerce ministry

Online shoppers can now make purchases with confidence after a commerce ministry decision yesterday that stipulated holding the payment of local e-commerce platforms until confirmation of safe delivery of items, adding a layer of consumer protection to the transaction.

At present, the merchants' payment is cleared within moments of the customer making the transaction with bank cards or the mobile financial services platform

Payment will be cleared only after confirmation by the customer, Hafizur Rahman, director-general of the WTO Cell under the commerce ministry, told The Daily Star over the phone. "If the payment gateways can be controlled effectively, no e-commerce

site can cheat or make an unusual delay in delivery of goods as the companies will also need to wait for the payment," he added The commerce ministry will send a letter to the Bangladesh Bank on Sunday to work out the logistics of the decision, including how the

confirmation of receipt of items would come from the customers. The development comes after a recent Bangladesh Bank inspection report

on the e-commerce juggernaut Evaly that sounded off the alarm bells. As of March 14, Evaly, which has assets worth Tk 65.2 crore, had delivery pending on goods worth Tk 213.9 crore and owed about Tk 189.9 crore to

on Wednesday arrested three men, accused in the case filed over the rape, and posted about it on Facebook. In the Facebook post, they uploaded the


photos of the accused and mentioned all the personal details of the 16-year-old victim.

34pc families faced job loss in pandemic

Finds NYU-BRAC-UN Women survey on 6,370 households in April-October 2020

Between April and October last year amid the pandemic, around 34 percent of households surveyed had a family member who became unemployed, finds a new study by New York University, Brac and UN Women Bangladesh.

They conducted the survey on 6,370 households last December across 21 districts, specifically chosen for being migration-prone.

Around 77 percent of the families saw their monthly earnings go down.

The research findings were unveiled at a virtual international dialogue titled "Demographic and socioeconomic changes induced by the Covid-19 pandemic: Challenges of new circumstances" yesterday.

The study found that households with returnee migrants saw a higher rate of unemployment -- 61 percent. Of these families with returnee migrants, 25 percent expressed concern about repaying their outstanding migration loans, which amounted to Tk 76,000 on average, but can go up

Household debt in migrant households increased by 82.4 percent, found the researchers. In addition, households with migrant workers had a larger fall in income when compared to households without migrants.

In spite of this, households with returnee migrants saw a birth rate of 33.4 per thousand population, which is nearly double that of the national birth rate.

5 Bangladeshis rescued

Five more still missing

Five Bangladeshi migrants were rescued after a boat sank in the Caribbean Sea near Puerto Escondido of Colombia.

Five others have been missing since the incident, several Bangladeshis in Colombia told The Daily Star yesterday.

They said the boat carrying 18 people -- 10 Bangladeshis and eight Nepalese -- started from Colombia's Necoclí and was heading towards Capurgana through the Gulf of Urabá, the southern

The boat sank after being hit by a storm.Later, on June 22 night, a group of fishermen and coastguard members rescued four Bangladeshis near Puerto

The next day, another Bangladeshi managed to swim to the shore in the same area, said the Bangladeshi migrants in Colombia.

The coastguard was continuing the rescue operation to trace the missing victims, local media reported.

Of the five rescued, the identities of three were confirmed. They are Sahab Uddin and Omar Faruk of Amishapara of Noakhali's Sonaimuri upazila and Saidur Rahman of Sylhet.

The missing Bangladeshis are Soyeb, Badrul and Rony of Sylhet, Faysal Ahmed of Kashimpur of Noakhali's Begumganj upazila and Sheikh Didar of Amishapara.

The rescued Bangladeshis were in the custody of the Colombian immigration authorities. They are currently in San Jeronimo de Monteria Hospital.

Their condition is stated to be critical as they were in extreme heat and suffered from malnutrition, the local authorities said, adding that one of them was in a

"They were trapped for several hours at the place where they were found. They all have signs of dehydration and one of them is in a critical condition," said the Puerto Escondido mayor.

"It was confirmed by an interpreter that these migrants were of Asian descent, more precisely Bangladeshis, who had left Necoclí for Panama," said RCCO Manuel Vargas, a representative of the municipality of Puerto Escondido.

Captain Luz Pérela Gonzalbez Silva, commander of the Coast Guard station, told the local media that the rescued migrants said their boat had sunk after a crash. However, the matter has not yet been confirmed because their statements about what happened was not very clear.

"The rescued migrants did not have passports or any documents, which made it difficult to learn their full identities," he said.

Nur Islam, elder brother of Sheikh Didar, one of the missing Bangladeshis, told The Daily Star that his brother had left the country a year ago. For a long time, he worked in Suriname, a small country on the Atlantic coast. Didar had arrived in Colombia via Brazil a few days ago. The family last talked with him on Sunday when they came to know that Didar would leave for Panama the next day.

The final destination of this migration route in the Urabá Antioquia region is the United States through the Darien jungle in Panama.

Every year, several thousand migrants, including Bangladeshis, enter the United States through this route.

Some 17,668 people entered the United States through this route in 2019 and some 3,887 in 2020, according to statistics of United Nations (UN).

Between June 1 and yesterday, 948 people died from Covid in seven divisions and during the same time 260 people died in Dhaka division, according to the data of Directorate General of Health Services (DGHS).

On an average, 50 people died of Covid-19 every day so far this month, the second highest average after 80 deaths a day in April.

Rajshahi and Khulna divisions, which have long borders with India, are the hardest hit now. Khulna recorded 295 deaths and Rajshahi 245 this month.

In the previous 14 months since the first cases of Covid were reported, the death toll in Rajshahi was 691 and in Khulna 792.

Yesterday, Chuadanga, a district in Khulna division with a border with India, reported a 100 percent positivity rate as all 41 people tested turned out positive for Covid-19.

Pilot run pushed back to September

Says DSCC mayor; 155 buses were slated to run from April 1 under one company in capital

Originally scheduled for an April 1 launch, the proposed pilot to run buses under a single company on the Kanchpur Bridge-Ghatarchar route has been pushed back to September 7, said Dhaka South City Corporation (DSCC) mayor Sheikh Fazle Noor Taposh yesterday.

The mayor, also chief of the Bus Route Rationalisation (BRR) committee -- formed to bring discipline to the capital's chaotic bus operations -- made the announcement after the 17th meeting of the committee held at the Nagar

Earlier, for the pilot, 155 buses were slated to run from April 1. The mayor said the launching date had to be pushed back due to delays caused by the coronavirus

He said he and DNCC mayor Atiqul Islam has already visited Ghatarchar and selected 12 bighas of land to set up a bus depot

Taposh said they have also taken an initiative to construct a bus-bay and passenger shed in the route.

He said they have already finalised the draft for the contract with the owners who will run the buses and prepared a guideline in this regard. The mayor said they will make the contract on July 29.

20 years in condemned cell!

Death row convict's lawyer requests to move him to normal cell, as HC again adjourns hearing

A death-row convict in Ramna Batamul bomb blasts case, which killed ten people at Pahela Baishakh celebrations in 2001, has been in a condemned cell for the last

The case has been included in the High Court's hearing lists 375 times since 2014, but the benches concerned adjourned the hearing each time following the state's adjournment prayers, said Mohammad Shishir Manir, a defence lawyer for the convict, Moulana Akbar Hossain alias Helaluddin.

Yesterday, Manir prayed to the HC to grant bail to his client or to order the jail authorities to shift him to a normal cell after the HC once again adjourned till October 24 the hearing on the death reference and appeals in the case.

The HC bench led by Justice Krishna Debnath and ASM Abdul Mobin asked lawyer Manir to submit a written application in this regard to this court.

Contacted, Manir told The Daily Star that he will submit the application to the HC next week.

There is no evidence and documents to prove charges brought against the convicted accused of the case, he said, adding that the trial court has delivered an "emotional verdict" in the case.

"My client has been suffering in a condemned cell for around 20 years although there is no evidence against him,"

Meanwhile, the HC bench passed the adjournment order after Deputy Attorney General Shahin Ahmed Khan sought time for hearing the matter.

Project for climatevulnerable people extended by 2yrs

The government and development partners decided to extend the Local Government Initiative on Climate Change (LoGIC) project for two more year at a virtual meeting yesterday for delivering adaptation benefits to the most vulnerable coastal people of Bangladesh.

No headway for a decade in 30yr-old robbery case

Even though a decade has passed, trial of a case filed over the robbery at Bangladesh Agricultural Development Corporation (BADC) 30 years ago has not made any headway.

Only six out of 74 prosecution witnesses have given depositions before court in 10 years after charge framing in the case, according to the prosecution.

Mohsin Bhuiyan, the then Executive Engineer (Parts) of the BADC Central Store, who filed the case in May 1991, passed away on August of 2013 without providing his depositions. Among the remaining 68 witnesses, one has

died, but 67 others have not appeared before court, despite several summons, the prosecution said. Of the 67 prosecution witnesses, 22 are police personnel, while 29 others are employees of BADC, '

said the case documents. The trial of the case is now pending at the Additional Metropolitan Sessions Judge's Court-2 of Dhaka

The court has issued several summons with non-

witnesses, but they did not comply with multiple court orders, a staff of the concerned court said.

"The prosecution's responsibility is to inform the court for issuing summons or non-bailable arrest warrants upon the witnesses to appear before it [court] on the schedule date for depositions. But police will take initiatives to find out whereabouts of the witnesses and produce them before the court," SM Zahid Hossain, additional public prosecutor, told The Daily Star.

"If the police fail to do so, there is nothing for the court or prosecution to do," he said, adding, "Trial proceedings are being delayed as the witnesses are

nowhere to be found." The robbery took place on May 16, 1991. Around 2am, some seven to eight robbers tied up the hands, legs, mouth, and eyes of three nightguards inside the central store of BADC in the capital's Tejgaon area and looted various parts then worth Tk 10-15 lakh, according to case documents.

Research not on DU's mind

Despite repeated complaints raised by different sections on Dhaka University's lack of research work, the university's newest budget still paints a bleak picture for the sector.

The Tk 631.79-crore budget for 2021-2022 fiscal was passed in DU senate yesterday with the highest allocation (31.80 percent) for salary and lowest for research (1.32 percent). The amount allocated

for research is Tk 11 crore. Although the research sector saw a Tk 2 crore increment from last year, senate members have drew attention of the VC while passing the budget, saying it is still insufficient.

The size of this year's budget has also decreased from last year.

DU had prepared a budget of Tk 869.56 crore for 2020-21, which was the largest in the university's history.

The future of supermarkets is here, thanks to Alibaba

More than 200 Freshippo supermarkets are open in China, operating as ultra-hightech supermarkets. In these shops, blue polo clad pickers examine shelves with iPhones, scanning barcodes to find the exact brand of oranges, or spice mixes that match online orders. Items are placed in a bag, attached to the automated conveyor system, and whisked up and out to the back of the store to the delivery motorbikes.

All online orders arrive within 30 minutes of a shopper clicking "buy" within a three-kilometre radius. Conveyor belts for shopping bags, personalised food recommendations, and facial recognition payments make for a unique supermarket shopping experience which many term as 'supermarkets on steroids'.

Alibaba, the e-commerce titan, owns and operates all of them as part of its aim to lead the way in what it calls 'New Retail.' And these Freshippo supermarkets may give a roadmap for how supermarkets in the rest of the world may plan their renovation strategies as they recover from the pandemic's crucial blow on businesses.

Alibaba co-founder Jack Ma created

the term 'New Retail' over five years ago. In 2016, the first Freshippo store debuted in Shanghai. Alibaba had 64 outlets in 14 cities by 2018. Only two years after opening that first store, online grocery sales in China had increased to 32.5 per cent, with each Freshippo store receiving "tens of thousands" of orders every day, according to Guo Xulin, chief of staff at Alibaba's Freshippo Business Group. Over 60 per cent of Freshippo sales come from online.

This concept hasn't simply been tested at supermarkets. According to Xulin, there are now hi-tech convenience stores and breakfast pickup stations scattered all over China that follow the Freshippo model. However, Alibaba's impact on the supermarket industry is undoubtedly the most significant. As a result, several of its rivals are also following suit in transforming the industry for good. By the end of 2021, rival retailer JD plans to have 49 of its own seven fresh supermarkets operating in China with robotic shopping carts and wristbands that scan products as they are added into the basket.

For both Alibaba and JD, the pandemic has proved to be a major boost and pushed the businesses to rethink innovation, charting a course for others in the way. It seems like China and its unique brand of hightech supermarkets might finally have some solutions up their sleeves, and for the time being, the future does not look too bad.

After the meeting, DNCC Mayor Atiqul Islam said 1,646 buses in Dhaka are now running without route permit, one of the main reasons behind traffic congestion in the city.

The initiative to rationalise the city's bus service was first taken by late mayor Annisul Huq. The plan looked to bring all buses in the capital under a few companies, each to be provided with permits for their respective routes and made responsible for proper public transport management and minimising congestion. However, after his death in late 2017, the project lost momentum.

The issue returned to the fore in 2018 when students demonstrated for safe roads following death of two students in a road accident on July 29.

On September 9 that year, a 10-member committee -comprising representatives from government bodies, police, transport owners, workers and transportation experts -- was formed, with then DSCC mayor Sayeed Khokon as convener.

However, the project faltered again since the start of the coronavirus pandemic in 2020, as the committee failed to hold meetings for around six months.

No headway

Mohsin Bhuiyan filed a case with Tejgaon Police Station accusing some unidentified people. After around 19 and half years' probe, IO Magfurul Wadud, inspector of Criminal Investigation Department (CID) of police, submitted the charge sheet to Chief Metropolitan Magistrate's Court in Dhaka against 11 people on October 17, 2010.

Of them, Munjur Rahman Khan, Bipul Chandra Biswas, Khondoker Rofiquzzaman, and Mobarak Hossain were deputy assistant engineers of BADC, while Syed Mosharrof Hossain and Abdur Rahman were also its staffers.

On March 8, 2011, the court framed charges against the eleven accused. Munjur, Shahjahan, Mobarak Bepary, Mobarak Hossain, Mosharrof and Abdul Malek are now on bail, while Bipul, Rofiquzzaman, Ruhul Amin, Abul Hossain, and Abdur Rahman are on the run.

"If the court cannot complete the trial proceedings of a case for want of witnesses' deposition for a long time, it can go for the verdict based on recorded depositions as per provisions of the Code of Criminal Procedure," Supreme Court's senior lawyer Khurshid Alam Khan said.

"The court can issue non-bailable arrest warrants against the absentee witnesses again and again and sent the letter to the authorities concerned to produce them [witnesses] before it," he added.

He told the HC that the state wants to place its arguments in this case in physical presence after ongoing Covid-19 pandemic is over.

THE RAMNA BLASTS

Two bombs went off during Bangla New Year 1408 celebrations on April 14, 2001 organised by Chhayanaut, a leading cultural organisation, at Ramna Batamul in Dhaka. Ten people were killed and dozens injured in the incident.

On June 23, 2014 a Dhaka court handed down the death penalty to eight militants of Harkat-ul-Jihad al-Islami (Huji), including its top leader Mufti Abdul Hannan, for the killings. Six other militants of the banned Islamist outfit were sentenced to life imprisonment for their involvement in the blasts.

The accused who got capital punishment by the trial court are 2004

Nine of the convicted accused are in jail while five -- Tajuddin, younger brother of BNP leader Abdus Salam Pintu, Hafez Jahangir, Moulana Abu Bakar, Mufti Shafiqur, and Mufti Hye are absconding.

Mufti Abdul Hannan, one of the country's most notorious militants involved in plotting and carrying out terror attacks by Harkat-ul-Jihad al-Islami Bangladesh, was executed at Kashimpur High Security Prison on April 13, 2017.

Hannan was executed for carrying out a grenade attack on the then British High Commissioner Anwar Choudhury in Sylhet on May 21,

"Given the scale of threat posed by Covid-19, we need a globally harmonised structure of financial infrastructure,

In his five-point proposal, the minister sought rapid information sharing -- nationally and globally -- through digital means, in a time-sensitive manner; taking globally united and coordinated efforts to combat against the common enemy; stronger and concerted advocacy with the vaccine producing states to strengthen COVAX by WHO; ensuring that no one is left behind; declaring the Covid-19 vaccines a global public good, and implementing its distribution through strong international cooperation.

Although the pandemic has not spared any country from its devastating impacts, the least developed and developing countries are the most affected, he said. "This is happening while the same groups of countries

are already grappling with the adverse ramifications of climate change. The minister said timely sharing of transparent and

correct information at national, regional and global level is of the essence in abating the impacts of Covid-19 crisis.

This calls for fortification of digital infrastructure, both intra and inter-nations, and smooth transmission of critical

data, he said.

Such data sharing would help in augmenting country and region-specific information tools for better policy devising. He said vaccines remain the centrepiece in the effective

fight against the pandemic. "Bangladesh believes that vaccines should be declared a global public good. He said it is encouraging to see countries like China

playing important roles for availability of vaccines. "The COVAX initiative by WHO is highly laudable. Thus, to realise the objectives of such multilateral efforts, we need transitioning to non-linear, big data driven, and prioritised supply chain systems to ensure availability, access, and affordability of vaccines to build back better and stronger socio-economically," he said.

Momen said infrastructure will play a critical role in this regard. "Bangladesh is ready and willing to work with the BRI partners to develop sustainable infrastructures for the benefit of the people in Asia-Pacific."

"At the same time, through our chairmanship of the 48-member Climate Vulnerable Forum (CVF) and V20, we are going the extra mile in ensuring a climate resilient recovery from this pandemic not only for ourselves but also for the whole membership," he said.

BCMCL miners living like prisoners

Claim their families, gather at gate to see their loved ones

Since the coronavirus pandemic hit the country in March last year, the officials, staffers and miners of Barapukuria Coal Mining Company Limited (BCMCL) have been virtually leading a confined life inside company premises to prevent the spread of the highly transmissible contagious viral infection in the mining complex.

The mine is situated in Parbatipur upazila of Dinajpur, a subsidiary of the state-owned Petrobangla.

According to the company's high officials, around 1,000 employees, including officials and staffers of BCMCL, Chinese and Bangladeshi miners of the contracted company CMC-XMC, have been staying at the mine compound since the authority restricted movement on March 24 last year.

Most of the officials are staying with their family members at the residential quarters inside. There is a separate residential quarter for the Chinese miners as well. But, the 450 local miners have been leading an isolated life without their family members, just like

officials under the outsourcing company.

Daily Star wishing not to be the onset of the viral pandemic, he

XMC, the contracted company of BCMCL, does not allow the local miners to go home although they are from surrounded villages of the coal mine.

Every day, family members gather at the mine gate to see their near and dear ones, if the Chinese contracted company allow the miners to meet, far away from the padlocked entrance.

Anjuara, a miner's wife, said she came to the mine gate with her two minor children to see her husband at around 10.00am. After waiting for two hours, she was finally able to see him. The miner said he has been staying inside with other miners for the last seven months. He works around 10 hours under the ground every day. The miners cook meal for them individually.

Rafiza Begum, another miner's wife, said the isolation of the miners inside the coalmine compound for months after months is nothing but torture and violation of human rights. She claimed that GTC, the contracted company of Maddhapara granite mining company, allows the local miners to go home after their everyday work. "Why are they so harsh?" she questioned.

She also brought some cooked food with her. Rafiza alleged that her husband needs to cook a meal every day.

Besides, there are at least 30 officials and staffers inside the coalmine suffering from fever. So, the coalmine authority has decided to conduct a test for them to be sure whether they test covid-19 positive or not.

They deliver hope on bike

Chulkathi Oxygen Bank stands beside serious Covid patients

Time and again, the youths rose to the occasion when the country needed them the most. This time around, when the Coronavirus pandemic has been sweeping through the bordering districts, eight youths from Chulkathi area of Bagerhat Sadar upazila have come to the rescue of affected locals.

On May 1, they launched a 24-hour service named 'Chulkathi Oxygen Bank' to stand by critical Covid patients who cannot afford to buy oxygen-filled cylinders due to its skyrocketing prices.

Soon after getting a distress call on their hotline (01711309483) or a message on their Facebook page, two of their volunteers hop on a motorbike with an oxygen cylinder and rush out to the home of the patient.

Aside from providing the free service to patients in Bagerhat Sadar, the volunteers so far served patients in Morrelganj, Fakirhat and Mongla upazilas in Bagerhat, and Rupsa upazila in neighbouring district of Khulna.

Out of the eight volunteers, Shakib Hasan Johnny, Kazi Rezwan and Choyon Debnath already contracted Covid-19. But the disease could not deter them from their will to serve the less fortunate and they resumed their voluntary work soon after they tested negative.

Arif Dhali, one of the founders of the oxygen bank, said several of his friends decided to provide free oxygen support to Covid patients as finding affordable oxygen supply was getting difficult due to its rising

They first got training from doctors on how to handle oxygen cylinders and necessary apparatus and gathered Tk 34 thousand to buy two sets of oxygen dispensing units along with cylinders.

With the third set of cylinder they received a from a well-wisher recently, they have been working day and night to save every possible human life, Arif said, adding that they refill the three cylinders at a time, for Tk 150 each, from Khulna and they pay Tk 1,000 for the round trip transport of the cylinders.

Covid survivor Shakil, an employee of Local Government Engineering Department in Rampal upazila, said he was thankful to the Creator for sending the volunteers of Chulkathi Oxygen Bank with the crucial oxygen support that saved his life.

Lalima Ahsan, a relative of Covid patient Shipon, from Morrelganj upazila, said they called Chulkathi Oxygen Bank when Shipon was in dire need of oxygen.

"We are grateful to Chulkathi Oxygen Bank" and its volunteers for promptly delivering the oxygen, which ultimately saved his life, she also said.

Jakaria Hossain Shawan, another of the founders and the coordinator of the oxygen bank, said thanks to the courage displayed by their volunteers and the contributions made by a few kind-hearted souls, they have so far been able to continue the invaluable service for people in the region.

If more people from the affluent section of the society joined their cause, they would be able to reach out to a larger number of critical patients, he added.

Stalemate continues over firing of tea worker

For the third consecutive day, the workers of Luhaiuni Tea Garden, in Kulaura upazila of Moulvibazar, staged demonstrations on Thursday, to press home their 11-point demands that include job reinstatement of a fellow worker. The tea workers have been holding agitations as the authorities closed the garden indefinitely since Wednesday morning.

Worker Shyamal Pachi said on May 20, without issuing any prior notice or warning, Assistant Manager Nazrul and Gatekeeper Sadhu cut down a tree that he had planted inside the garden.

Referring to Section 26 (Ka) of the Bangladesh Labour Act, they terminated his job on May 22, as he protested their chopping down his tree the other day, he claimed.

Under Section 26 (Ka), job of any worker can be terminated without showing any reason.

The job termination of Shyamal Pachi on May 22 sparked a workers' unrest at the garden and the workers have been gathering there to press home their 11-point demands that include reinstatement of his job.

Ajit Kairi, president of the tea garden Panchayat committee, said on June 22 morning, when the workers took position in front of the

Translating 8th Five Year Plan into Fiscal Year Budget 2021-22: Youth Perspective

The Daily Star and ActionAid Bangladesh jointly organised an online discussion titled "Translating Eighth Five Year Plan into Fiscal Year Budget 2021-22: Youth Perspective" on May 31, 2021. The primary objective of the roundtable was to have a conversation with important stakeholders and experts to determine how the upcoming national budget can accommodate the needs of the youth. Here we publish a summary of the discussion.

Farah Kabir, Country Director, ActionAid Bangladesh

As we approach the announcement of the upcoming budget, the most important question that we should keep in mind is how the National Budget can accommodate the Eighth Five Year Plan on the issue of young people. After 2026, the proportion of the young population is going to gradually decrease. Thus, it is high time to invest in the youth. We have to ensure adequate provisions are kept in the budget for the youth constituency so that they can realise their potential.

We started with a concern regarding the feasibility of the rollout of the Eighth Five Year Plan in the middle of a pandemic. Before developing the 2021-2022 budget, it was imperative to keep the COVID-19 situation in mind. Our response should not only be about creating more hospital beds and facilities but also focusings on health, education, farming and employment issues through a holistic approach.

We have seen a reverse migration during this pandemic. People have migrated back to villages from Dhaka. Healthcare systems are very poor at the rural level. We need to ensure necessary health care services are available at the rural level as the pandemic is not restricted to just the urban areas. Recently it has spiked in the border areas.

We should conduct a survey to identify the demand of the youth, the transgender community and marginalised people, and then create a shadow budget. This will enable youth to undertake advocacy and lobbying effectively. Iqbal Hossain, Deputy Manager- QAPS,

ActionAid Bangladesh It is time to Integrate young people into political, economic, and social aspects of society and enable them to share in the benefits of development. This will involve guaranteeing quality education, providing decent work opportunities and addressing the myriad of other challenges young people face. 

YOUNG ACHIEVER

Reigning over the chessboard

18 year-old Mohammad Fahad Rahman is the youngest chess player in Bangladesh to earn the lifelong titles of International Master (2019) and FIDE Master (2013). The self-taught genius relies mainly on books to practice and perfect his moves across the chessboard. He is an SSC candidate from Little Jewels International School.

Fahad was only five years old when he first got to know about chess, and instantly fell in love with the game. "I was fascinated by everything in chess, and began learning the rules. After two months of practicing, I won a competition organised by my school," he shares.

What began as a fun hobby soon cultivated into a serious pursuit for Fahad, who went on to participated in a tournament organised by Bangladesh Shishu Academy in 2008, qualifying amongst participants across 8 divisions. Just after two years, he became an age group champion for the National School Chess Tournament, organised by the Bangladesh Chess Federation. Soon after, he joined the national team.

"By 2011, we moved to Dhaka from Faridpur, as the federation was nearby. I began preparing for more competitive tournaments," says Fahad, who participated and won the National Sub-Junior and National Junior titles from 2014 to 2017, and 2014, 2016, 2017, and 2018 respectively. His streak of brilliant performances in the nationals opened the doors to many international championships for him.

He played in the Asia Championship held in India, clinching a gold medal under both Standard and Blitz categories, and one bronze medal in the Rapid Chess category. He also participated in 14th Dubai Juniors Chess Tournament and ASEAN Age-Group (U-10) Chess Championship of Thailand.

"I also participated in the 43rd World Chess Olympiad held in Georgia in 2018, which helped me earn an international rating to become an International Master," adds Fahad. The same year, he won the Asian Zonal Championship which led him to FIDE World Cup 2019, held in Russia.

"I got the chance to play alongside my idols, some of the best chess players in the world. I enjoyed their performances, witnessing their moves and learning about their strategies," Fahad says about his experience in the world cup.

The pandemic made it quite challenging for him to participate in many important international tournaments that would have assisted him in becoming a Grandmaster, the highest title a chess player can attain, apart from World Champion. Yet, Fahad has not remained idle. "I have played opposite the leading Grandmasters in our country. No matter what, I have always put up a strong fight. I aspire to keep working hard to become the youngest Grandmaster in Bangladesh," he concludes.

Jibon is a non-profit organisation based in Rangamati, which provides blood to the needy, free of cost. It was established in November 2011 as a Blood Donor Association, and gained the trust of the Chittagong Hill Tract (CHT) localities swiftly.

Sazid Bin Zahid, with six of his friends from Rangamati Govt High School, started the organisation when they experienced the lack of proper blood donation and blood management in Rangamati. The Co-founders are Meher Niger, Gayatri Chakraborty, Tasnima Hoque Zarin, Yeah Hakim Pias, Ashfaq Hossain, Sabyasachi Chakma.

Inspired by Anwarul Kabir, the current President of Jibon, the team follows a simple rule: the right blood supply at the right time can save a life. However, finding the right resources in a short time can be

a challenge. Recipient of the Joy Bangla Youth Award 2018, Jibon aims to create a safe space for willing blood donors, as well as governmental hospitals, blood banks, and volunteers.

The organisation does not take direct blood donations from people. Rather, it works as a medium. Jibon's team has a list with the blood groups, locations, and phone numbers of willing donors.

Those who need blood urgently, can post on the Facebook Group of Jibon. All posts must mention the health issues, exact blood groups, number of blood bags required, names, addresses, hospital cabin or ward numbers of patients, and relevant contact numbers. Currently, Jibon is operating with over 7,500 willing blood donors.

The organisation also launched workshops and mask distribution programmes in Rangamati to raise awareness about the severity of the Covid-19 pandemic.

Jibon operates widely in the CHT areas. The organisation's team has also expanded their work at Khagrachari, Bandarban, Cumilla, and Dhaka.

Currently, Jibon is working on multiple projects, along with blood donation.

"We are focusing on 'Hello Campus', a campaign that aims to help students through leadership and motivational training, debate sessions, sports, ccultural programmes, and general knowledge competitions. So far, this campaign has covered over 10 educational institutions in Rangamati," says Sazid.

Moreover, 'Skill Drops' is an initiative of Jibon for skill development programmes such as basic computer training, graphic design courses, and handicraft training.

EU divided over Russia summit plan

Members urge caution as France, Germany say direct contact with Putin needed for Europe's stability

France and Germany yesterday called for a European Union summit with Russian President Vladimir Putin but met firm resistance from Poland and Baltic countries who distrust the Kremlin.

French President Emmanuel Macron said the first EU summit with Putin since January 2014 would be a chance for dialogue and won support from Austria's chancellor as EU leaders arrived for their regular summer meeting in Brussels to discuss a new strategy to improve ties with Moscow.

"We need a dialogue to defend our interests... it is a dialogue necessary for the stability of the European continent," Macron

"We cannot remain in a purely reactive logic when it comes to Russia,' he said. "I hope that we can, with real European unity and coordination, have this ...dialogue.'

"We as the European Union must also seek direct contact with Russia and the Russian president. It is not enough for the US president to talk to the Russian president," Germany's Chancellor Angela Merkel said ahead of the summit.

EU leaders are also set to ask the European Commission and the EU's top diplomat Josep Borrell for "options for additional restrictive measures, including economic sanctions" against Russia, according to a draft of the summit statement seen by

After Nato warnings that Russia is trying to divide Western democracies through disinformation and covert attacks, many EU countries said talk of summits was premature. Lithuanian President Gitanas Nauseda said the idea was like "trying to engage the bear to keep a pot of honey safe".

The Kremlin welcomed the idea of a summit, saying both Brussels and Moscow needed dialogue.

On opposing sides in standoffs in Ukraine and Belarus, and at odds over human rights, the EU and

Russia accuse each other of meddling in elections, disinformation and threatening security and stability from the Baltics to the Black Sea.

The EU yesterday imposed economic sanctions on Belarus, an ally of Russia that the Kremlin sees as a buffer state between Russia and Nato. The new package looks to hit key

sources of revenue for the authorities in Minsk by restricting trade in potash fertiliser, petroleum and tobacco products, a statement said. It limits access for Belarus to the EU's capital markets and bans providing insurance to government and public bodies.

There is also a prohibition on the sale of technology to Belarus that could be used to intercept phone or internet communications and "dual-use" military equipment that could be used to crack down on demonstrators

Pandemic fallout to be felt 'for years'

Warns UN drug agency

The coronavirus pandemic is pushing more people into drug use, while illicit cultivation could also get a boost, the UN said Thursday, warning that the crisis's fallout was likely to be felt "for years to come". The Vienna-based United Nations Office on Drugs and

Crime (UNODC), which each year pulls together data from its wide network of member countries in its annual report, said it also feared illicit opium poppy and coca leaf cultivation could rise as the economic crisis caused by the pandemic led to joblessness and other problems around the globe.

"The new report shows that drug markets have swiftly resumed operations after the initial disruption at the onset of the pandemic" last year, a statement by agency said.

Top opium producer Afghanistan reported a 37 percent jump in the amount of land used for illicit poppy cultivation during 2020 compared with the previous year,

Inequality, poverty and mental health conditions -known factors that push people into drug use -- are also on the rise globally, it said in a chapter entitled "Covid-19 fallout likely to be felt in drug markets for years to come".

Most countries have reported a rise in the use of cannabis during the pandemic, it said, noting generally people decreasingly saw risks in its use.

The crisis has also seen an increase in the non-medical use of pharmaceutical drugs, while consumption of drugs that are "typically used in social settings", such as cocaine,

In a positive development seen by UNODC the area percent in 2019.

This was largely driven by the first significant fall in cultivation in six years in Colombia though the South American country continued to be by far the largest source of cocaine globally.

EU MPs pass climate law

The European Parliament on Thursday approved a landmark law to make the European Union's greenhouse gas emissions targets legally binding, paving the way for a policy overhaul to cut planet-warming pollution faster. Negotiators from Parliament and the EU's 27 member countries reached a deal in April on the climate law, which puts tougher emissionscutting targets at the heart of EU policymaking. The bill sets targets to reduce net EU emissions by 55% by 2030, from 1990 levels, and eliminate net emissions by 2050.



Philippines' ex-president **Aquino dies**

Former Philippine president Benigno "Noynoy" Aquino, the reserved 61-year-old bachelor from one of Asia's most famous political families, died yesterday, the country's foreign minister and several officials said. Aquino, who ruled the archipelago nation from 2010 to 2016, was the only son of the late former president Corazon Aquino and her assassinated husband, senator Benigno "Ninoy" Aquino. Aquino died in a Manila hospital of renal failure as a result of diabetes, his family said.

Trudeau survives vote of no confidence

The minority government of Canadian Prime Minister Justin Trudeau survived a parliamentary vote of no confidence Wednesday in a face-off over the proposed budget, eliminating the possibility of early elections this summer. The House of Commons voted 211 to 121 in favor of approving the budget, which was proposed in April and contains a plan to spend CAN\$101.4 billion over three years. The conservative opposition voted together against Trudeau, who was able to hang on thanks to the support of three other smaller blocs in the lower chamber.



World's highest hotel opens

The world's highest luxury hotel, boasting a restaurant on the 120th floor and 24hour personal butler service, has opened in Shanghai to guests with deep pockets and a head for heights. Elevators whizz guests up the intimidating spiral-like skyscraper at earpopping speeds of 18 metres per second to the J Hotel's 165 opulent rooms. The hotel occupies the top floors of the 632-metre Shanghai Tower in the city's financial district, the second-

tallest building in the world after Dubai's Burj Khalifa. Its opening was delayed partly by the coronavirus pandemic but the hotel has now started receiving guests at any hour.

A 'victim of tyranny'

Says Apple Daily as Hong Kongers snap up final edition

Hong Kong's pro-democracy Apple Daily tabloid said it was a "victim of tyranny in a defiant final edition yesterday after it was forced to close under a new national security law, ending a 26-year run of taking on China's authoritarian leaders.

The sudden death of the popular newspaper is the latest blow to Hong Kong's freedoms, deepening unease over whether the international finance centre can remain a media hub as China seeks to stamp out dissent.

Queues formed across Hong Kong yesterday as residents raced to snap up one of the one million copies Apple Daily said it planned to print. Many vendors sold out within minutes and were awaiting fresh deliveries.

The swansong front page featured the paper's own journalists waving goodbye to crowds outside its headquarters.

"Apple Daily is dead," deputy chief editor Chan Pui-man, who was arrested last week on a national security charge, wrote in a farewell letter to readers.

"Press freedom became the victim of tyranny."

In the working-class district of Mongkok, hundreds queued through the early hours of the morning to get their hands on the final edition, some chanting

"Apple Daily we will meet again!" It's very shocking," a 30-year-old woman, who was in the queue and gave her first name as Candy, told AFP.

"Within two weeks, authorities could use this national security law to dismantle a listed company." Hong Kong's most popular tabloid

had long been a thorn in Beijing's side, with unapologetic support for the city's pro-democracy movement and caustic criticism of China's authoritarian leaders.

Those same leaders used a new security law to bring about its rapid demise.

Owner Jimmy Lai, currently in jail for attending democracy protests, was among the first to be charged under the law after its imposition last year. But the final chapter was written over the

last week when authorities deployed the security law to raid the newsroom, arrest senior executives and freeze its assets. That last move crippled the paper's ability to conduct business or pay staff

and the news group decided yesterday's newspaper would be its last. Overnight it took down its website, Twitter and Facebook accounts.

Its edition in Taiwan will continue to operate. But some 1,000 people, including 700 journalists, are now out of work.

"Hong Kongers lost a media organisation that dared to speak up and insist on defending the truth," eight local journalist associations said in a joint statement.

China imposed its security law on Hong Kong last year after the city was convulsed by huge and often violent democracy protests in 2019.

AIRSTRIKE ON TIGRAY MARKET

At least 64 killed; 180 injured

UN calls for urgent investigation AFP, Addis Ababa

UN demanded an urgent investigation as an Ethiopian air strike on a market in the war-torn Tigray region killed at least 64 people and injured 180, an official of the rebel territory said.

"The air strike was in the market area, so many, many people were injured," Mulu Atsbaha, an advisor to the Tigray regional administration on maternal and child health said yesterday.


The strike on Tuesday in Togoga town also left 180 injured, Mulu added.

He said the toll had been gathered from residents of Togoga town, 30 kilometres (18 miles) north-west of the regional capital Mekele, and "confirmed with local leaders". Ethiopia's army spokesman yesterday said that the military carried out the attack on Togoga, but said rebel fighters were the target.

But survivors and health workers described aerial explosions striking a busy market at the peak of trading, killing and injuring dozens, including children.

The attack came as vote counting was underway following Monday's national elections in Ethiopia. However, the conflict in Tigray meant no vote was held there, and the region has seen an upsurge in fighting in

Prime Minister Abiy Ahmed sent troops to Tigray in November to oust the dissident regional leadership, promising a swift victory. But nearly eight months later, fighting continues, which has triggered a humanitarian crisis with the UN warning 350,000 people are on the brink of famine.



FLORIDA APARTMENT BLOCK COLLAPSE

1 killed, '51 missing'

A 12-story oceanfront apartment block in Florida partially collapsed early yesterday, killing at least one person and leaving dozens unaccounted for as rescuers combed the rubble for possible victims.

Video footage posted online showed a large portion of the building in the town of Surfside -- just north of Miami Beach - reduced to rubble, with the apartments'

interiors exposed. It was unclear what caused the building to collapse, nor how many people were inside at the time, since it was occupied by a mix of full-time and seasonal residents and renters according to Miami-Dade County

Commissioner Sally Heyman. "It's hard to get a count on it," Heyman

told CNN. "It is 51 people who were supposedly, supposedly, residing there at the time (and) have not either called out or had people call in to reach them.'

Local media said records showed the block was built in 1981 and had more than 130 units inside.

Around 55 apartments were affected by the collapse, according to Miami-Dade Fire Rescue Assistant Chief Ray Jadallah. 35 people have been rescued from the building. Some 14 survivors had been recovered from the rubble.

At least four Argentinians were among those unaccounted for, according to reports.

230,000 displaced in Myanmar in 2021: UN

The United Nations humanitarian agency yesterday said an estimated 230,000 people have been displaced by fighting and violence in Myanmar this year and are in need of assistance. The United Nations Office for the Coordination of Humanitarian Affairs (OCHA), in an update on the situation in Myanmar, said operations were ongoing but were being hindered by the insecurity in the country.

Indonesia jails hardline cleric over virus lies

Indonesian police fired tear gas and water cannon at supporters of a hardline Muslim cleric jailed yesterday for spreading false information about Covid-19 after he held rallies that drew thousands. Rizieq Shihab, 55, was handed a four-year jail term for claiming in a viral video that he was healthy, despite knowing that test results showed he may have been infected with the virus. Thursday's ruling comes after the same court in May sentenced Shihab to eight months' jail for holding sermons and other gatherings that drew tens of thousands of followers, breaking virus restrictions in one of Asia's worst-hit nations.

Sri Lanka pardons 16 **Tamil Tigers**

Sri Lanka's president pardoned 16 men linked to the Tamil Tiger rebels yesterday, as the country faced renewed pressure from the UN over detentions without charge under an anti-terrorism law. The men were convicted under the Prevention of Terrorism Act (PTA) that gives security forces sweeping powers to arrest and detain suspects. The UN Human Rights Council and other international rights groups have called for it to be repealed. The men had been behind bars for at least a decade. Government officials said the release was the first phase of a plan to free all 78 people held or charged under the PTA.

Couples must use same surnames

Rules Japan SC AFP, Tokyo

Japan's top court on Wednesday ruled a law requiring married couples to have the same family name is constitutional, rejecting plaintiffs who sought the right to keep separate surnames, local media said.

The plaintiffs -- three couples -- submitted marriage registration documents with different surnames for wives and husbands in 2018. But municipal governments refused to accept the documents, the Mainichi Shimbun reported.

The plaintiffs argued requiring married couples to choose a single name "is against equality under the law and freedom of marriage, which are guaranteed by the constitution."

The ruling is in line with a 2015 Supreme Court decision that also found the law constitutional but urged MPs to discuss a bill addressing growing calls for flexibility on the issue.





When the DAG catches the bribe-takers

Land-related offices need thorough spring-cleaning!

T was by a fluke that the victim of extortion for a routine public service happened to be a Deputy Attorney General (DAG), for which reason the crime was made public. According to our report, two employees of Kushtia Sub-Registrar's Office demanded Tk 30,000 to prepare the deeds of his family land. Even after knowing his identity, the duo persisted and offered a Tk 5,000 concession... so brazen were they about asking for the bribe. Their audacity comes from an entrenched system of rent-seeking and irregularities that has characterised most offices related to land issues. A report by the Transparency International Bangladesh (TIB) has found massive corruption at the district registrar and sub-registrar offices, with people paying bribes from Tk 500 to Tk 5 lakh at every step of the process of getting land-related services.

Digitisation of the entire land administration and management has been suggested by many as a way to curb the corruption. The idea is that all land transactions and land records will be maintained in the digital platform. However, while digitisation can ease some of the problems, experts have warned that it is more important to remove existing anomalies that have been created and sustained for many years. An op-ed in this paper by researchers of BRAC Institute of Governance and Development (BIGD) has pointed out the discrepancies in our land survey records which make digitisation quite challenging. With constantly changing land use and demarcation, regular updating is necessary. And with four different land surveys—none of which were completed-complications are bound to arise with demarcations of land being contested all the time (as different surveys can give different information

According to the law, the Revisional Survey record takes precedence but disputes are informally resolved through local arbitrators or land officers. Therefore, there are many loopholes that leave leeway for corruption. So before taking any digitisation initiative, records have to be verified, illegal possession and fake documents have to be done away with, and discrepancies among various documents have to be resolved and made consistent. Otherwise, many errors and fraudulent documents will remain in the system and people will have very little recourse to get them corrected.

In this particular case, it was after the DAG narrated the incident on a Facebook post that the officials of the sub-registrar's office and deed writers called him up to applogise.

Is an apology sufficient to absolve these individuals from this crime? An office assistant has been suspended but it is quite certain that he is way down the ladder in this "unofficial fee structure". This particular incident, where a public official became a victim of the corrupt system leading him to make it public, should be a trigger for the government to get the land office in order. In the long run, all the records and documents have to be verified for authenticity and disputes resolved fairly after proper investigation and then the government can think about digitising, of course, with security measures in place to prevent tampering or hacking into the system. In the short run, however, the government must clamp down on corrupt employees and ensure that people who seek their service are not harassed or made to suffer.

Dengue surge looming amidst Covid-19 surge

Proper initiatives from all stakeholders needed to stamp it out

T'S disturbing enough that Covid-19 infections continue to rage across the country, but now another life-threatening disease has presented itself following the arrival of monsoon: dengue. Between June 1 and 23, 147 dengue infections were detected in the country, which account for 59.5 percent of all dengue cases recorded in the current year. Aedes mosquitoes, which are carriers of the dengue and chikungunya viruses, find the wet monsoon months to be ideal for breeding, and they breed anywhere there is clean or stagnant water.

The alarming increase in the number of dengue cases in June is especially a cause for concern due to hospitals and healthcare resources already being strained under the country's Covid-19 extended second wave. It goes without saying that if the danger of a dengue surge is allowed to fester, health systems across the country will find it extremely difficult to accommodate and treat all incoming patients. And, as experts have opined, the situation will be particularly critical if a patient is infected with both dengue and Covid-19—a real possibility, given the circumstances.

We believe it is crucial to not only prepare hospitals and healthcare personnel to handle this double threat, but also to make people aware about how easily Aedes larvae can breed all around them and how they can protect themselves from dengue by making sure there are no places or receptacles holding water for too long. We commend the DNCC for "issuing letters to all government, semi-government, autonomous, private organisations and educational institutions to take necessary steps so that Aedes larvae do not get any suitable place to breed" since April—and also for asking, via text messages, 1,700 house owners (where Aedes larvae were detected last year) to destroy the breeding sources of mosquitoes or face stern action. We would urge the two city corporations of Dhaka to step up their anti-mosquito drives, road shows, and "routine spraying of larvicide and adulticide"

At the same time, we urge the health authorities to raise awareness of this growing menace and equip all hospitals in the country accordingly, instead of focusing all their efforts and attention on the capital only. After all, the numbers of dengue patients recorded this year originate from all over the country, and no disease discriminates between districts or divisions.

A lot has changed since the start of the pandemic. For many of us, it has come to instantiate the kind of epoch-making events that upend not just life but also perspectives, leaving a profound mark on the civilisation. As a writer and thinker, what has it altered or reinforced about your view of our society?

When the world was reeling under the onslaught of Covid-19 pandemic around this time last year, I was quite heartened to see the beginning of a global conversation about healing humanity and nature. There was strong optimism that nations would reflect on their failure to address inequality, violence and rights abuses, and would put all their efforts in righting the wrongs. From medical scientists to politicians, all pledged their support to ensure the efforts deliver results. We were told that collaborations are the future. For a time, I believed that we too would have some soul-searching and the post-pandemic Bangladesh would see a more caring and compassionate society, although altruism had never been one of our strong points. Nevertheless, I was hoping for a change in our mindsets and in the way we had connected with the less fortunate.

But when I saw inequities and violence against women and children rising and stories emerging of relief goods being sold and Covid-19 test certificates being forged, among many other instances of injustice and corruption aggravating the fallout from the pandemic, I realised that nothing substantial was going to change. Not in the way I, and perhaps many others, had hoped. So I resigned to the sad wisdom of the idiom I first learnt in school: a leopard never changes its spots.

On the brighter side though, the optimist in me found solace in the selfless service and sacrifice of the frontline Covid fighters, in the kindness of people providing food to the hungry and helping Covid patients find hospital beds or get decent burials.

Sadly, the pandemic hasn't changed my worldview for the better.

What's your favourite pandemic quote?

An old one—from *The Plague* by Albert Camus—that sums up humanity's predicament in times of pestilence: "We tell ourselves that pestilence is a mere bogy of the mind, a bad dream that will pass away. But it doesn't always pass away and, from one bad dream to another, it is men who pass away."

But isn't tragedy also a time that brings people closer? I ask this because I look around and all I see is the opposite, with deepening polarisation marked by sharply contrasting positions in the ideological architectures of our society. What does this polarisation bode for us and how do we get over it?

To be frank, ours has always been a polarised society, with the rich and the poor, landowners and peasants, factory owners and workers, the urban privileged class and the rural subalterns occupying the two ends of our social and economic spectrum. With capitalism becoming rampant, inequalities between these groups have widened.

In post-independence Bangladesh, there was a realisation that economic and social polarisation should end, but the political and social forces, the main drivers of change, preferred to take the old, beaten track. In the absence

of system overhauls (in governance, judiciary, education, policy planning), the instruments and institutions that would ensure the end of polarisation failed to emerge. And with time, society and politics splintered into opposing and clashing interest groups. The polarisation that resulted was led by the two main political parties which, over time, became rigid, uncompromising and confrontational.

Today, political polarisation has morphed into tribalism which is undermining our democracy, judiciary and governance, and affecting the media environment, academia, workplaces, and even social relations. What is worse is that the traditional providers of checks and balances on the conduct of the government and political parties—such as civil society and the media—have become increasingly partisan. The social media, which has emerged as an alternative platform of public dialogue, has become something like an echo chamber, amplifying the divisiveness, hatred and intolerance that mark our political and social landscapes. Amidst the resulting

So I sadly agree with you that this may be a new normal we have to live with.

Fifteen years ago, no one would have imagined there would be a new frontier in social inequality called "digital divide". Today, it is as ubiquitous and quite as impactful as lack of food, housing, etc. As a teacher who witnessed first-hand how it's been affecting students, what's your take on this?

I see it as an injustice, a denial of the right to education—since online teaching depends on equal access to digital technology and related electronic

chaos and panic, we tend to forget that a polarised nation is a paralysed one, and we're dangerously headed in that direction.

There is no easy solution for this, but as a teacher I believe education and culture can open the door to a less polarised and more tolerant, just, humane and equitable world. But without a sea change in the way we teach our children and view the role of culture, that door will remain shut.

In a recent interview, you talked about how politicisation of universities has had a dreadful effect on the students, teachers and even vice-chancellors. Let's hear your thoughts on the last group—the VCs—many of whom have made headlines for allegations of corruption and irregularities recently. Is it just a few rotten apples, or are we going to have to accept it as a new normal?

The society expects exemplary behaviour and guiding roles from thought leaders, intellectuals and educators, including the vice-chancellors. Historically, they have met these expectations and played their part in enlightening and leading the society. But in post-independence Bangladesh, especially in the last few decades, there has been a slide in both the performance of these actors and in society's expectations about them. With the politicisation of academia and the rise of partisanism, many academics began to

devices—and lastly, as a failure of the society and the state in imagining and addressing this vital issue. Digital divide, which has been described as the new face of inequality, threatens to become unbridgeable because of the widening geographical (urban-rural) and economic divides. The authorities will have to address this issue on a priority basis, as the use of computers will increase exponentially in the years to come, and going online in every field of activity—from education to domestic travel—will become the norm.

How would you respond to worries about the apparent "degeneration" of today's youth—a term increasingly used in reference to modern lifestyle problems like drug/TikTok addiction, etc.?

When our culture first took a visual turn, I was worried that the youth, without any media literacy, would be lured into a world of make-believe where, in addition to viewing pleasure, they would encounter violence, sexuality and drugs. The arrival of the Internet and social media and the ready availability of drugs have, unfortunately, proved me right. As our economy developed, money flowed, corruption surged, and education became just a key to enter the job market, the safeguards of ethics, good conduct and culture that had largely protected earlier generations from corrupting influences

crumbled. We cannot protect young people from Internet predators and cyberbullying as we are unable to protect our banking system from hackers. And it does not need the genius of a Steve Jobs to realise how the mix of drugs and temptations of the TikTok kind can be so dangerous, and how heavy a price we have to pay for the youth's daily exposure to violence and communalism and their disconnect from culture.

Banning any media or putting all the burden on gatekeepers would never work, however. I would rather go back to solutions that our education and culture offer. Bring back purpose and pleasure in education, make culture a means of meaningful self-expression and peer bonding, and revive the forgotten role of the family in walking a child through to adolescence and beyond. Difficult, yes, but not impossible. All it needs is a political will, supported by all stakeholders and the society at large. This is not a choice we have, but an obligation.

What's your thought on how Bangladesh has managed the Covid situation so far?

When the Covid pandemic began to spread, the government reacted with some degree of urgency, shutting down the country and limiting people's movement. These and other measures worked for a while, and I should say, the government did well to contain the first wave of the pandemic. But once the country descended into Covid chaos, things began to unravel. The government succumbed to the pressure of maintaining a fine balance between life and livelihood, and even allowed superspreader events to take place.

It is now clear that there was no longterm plan to manage the Covid crisis, no well-laid pandemic policy response (which has exposed our vulnerability in the face of new, more infectious variants of the virus), and no roadmap for efficient procurement of equipment and vaccination (for the latter, we put all our eggs in the basket of one supplier). We still don't have enough ICU beds and intubation facilities, and have a shortage of specialist doctors in district hospitals. The problems have been compounded by corruption in the health sector which the health ministry consistently denies. We could have done better.

Despite our numerous achievements postindependence, especially on the economic front, why do you think we have failed to build a fair and inclusive society even after 50 years?

Our achievements indeed are numerous and the government deserves praise for consolidating growth. But we have failed to build a fair and inclusive society because we have not created equitable opportunities for all the stakeholders. We have allowed genderbased inequities to grow, and failed to allocate resources to the extreme poor. We have allowed communal forces to dominate our politics and pose a threat to the minorities. We have not respected the rights of ethnic minorities who, consequently, feel alienated and ignored. We have not been kind to people with disabilities and children who are employed in our labour force. Above all, we have not invested enough in areas that promote inclusive growth—education, culture, healthcare and social welfare.

Mohiuddin Ahmed: An institution in himself

7O the average reader, Mohiuddin Ahmed is better known as the founder of University Press Limited, a reputed publishing

house in the country. However, that describes only a part of his identity, an incomplete one. Limiting his identity to the founding of the UPL ignores his contributions to the world of publishing in Bangladesh and his impacts on Bangladesh studies. It is an understatement that Mohiuddin Ahmed was a pioneer in the publishing scene of Bangladesh, because he was much more than that.

The news of Mohiuddin Ahmed's passing is still hard to believe. He breathed his last early Tuesday, at the age of 77. He fought his long-term illness with remarkable courage and fortitude. Neither old age nor illness of one can prepare us for their departure. This is truer in the case of a personality like Mohiuddin Ahmed. His passing is an irreplaceable loss for us all.


The news of the demise of people who have, through their work, greatly changed an entire domain not only fills us with sorrow and pain but also reminds us, with greater clarity, how profoundly they impacted the lives of others. The absence of those whose endeavour has opened the door for the creative work and research of others reminds us of their importance in this world, and how badly we need them

now and always.

To me, Mohiuddin Ahmed was a person dedicated to bringing the global standard of research, particularly in social sciences, at home. Throughout his life, he has tirelessly worked to introduce research works on Bangladesh, produced in Bangladesh, to the outside world—as well as to familiarise local readers with the research on Bangladesh being done internationally. The impact of his work can be grasped by looking at the books published by the UPL, the breadth of the topics covered, and how it has encouraged new researchers to engage in perceptive works. This is how he has enriched Bangladesh studies, both at home and abroad. For more than 40 years, that is what he has done wholeheartedly, without any respite. His driving forces were neither material success nor any expectation of recognition, but rather his love for his work and a profound sense of duty.

He was a soft-spoken person

who preferred to remain behind the scenes. But the history of the publishing industry and its endeavour for quality—both in content and production—cannot be written without his name in it. He is the principal protagonist of the publishing history of the country and he will remain at the centre of it.

His talent and labour propelled him to this position. But above all, he has paved the way for his successors. Those associated with the publishing world in Bangladesh must acknowledge that the lion's share of the credit for Bangladesh's recognition in the

international publishing industry belongs to him. That the books published in Bangladesh now draw the attention of the international community is largely because of his efforts and his attention to the quality of published content. This is where he is unique, and he has carved a space for himself.

His life began with journalism. He was invited to step into the academic world permanently when he was offered admission into a PhD programme at Stanford University. He previously taught in the journalism department of Punjab University

in Pakistan. Therefore, it was not surprising that he had considered an academic trajectory. However, publishing and editing for the Oxford University Press (OUP) attracted him more. This happened in 1969, and became the turning point of his life.

When Mohiuddin Ahmed told me about this episode of his life in London in 1997/98, my spontaneous response was: "Thankfully, you joined the OUP instead of doing a PhD!" With his characteristic smile, he said, "I think so too." Then we talked more about how UPL was founded in 1975 and its journey in becoming the premier publishing house in Bangladesh. No wonder that under his leadership, UPL has won the National Book Centre Award a total of 16 times since 1981.

I often wondered, could anyone else have set the trend of publishing research-based English books in Bangladesh with such commitment? I think not.

The way he built the UPL and devoted himself to the world of publishing was only possible through patience, dedication, and love. In a country where such organisations do not have a history of surviving long, where their untimely demise is considered inevitable, Mohiuddin Ahmed built an institution that Bangladesh can be proud of. In the process of building this institution, he became an institution in himself.

The G7 Vaccine Charade

N a recent essay on Samantha Power, President Joe Biden's new administrator of the United States Agency for International Development, Michelle

Goldberg of The New York Times writes, correctly, that Power's "first big test... lies in what America does to help vaccinate the rest of the world against Covid-19." And Power herself is quoted as saying that, "It's about a very, very tangible, results-

oriented agenda. Results seemed to follow. At the G7 summit, Goldberg duly reports Biden announced that the US would contribute 500 million vaccine doses for use in "low- and middle-income countries." According to Goldberg, this "spurred other countries to step up their contributions," ensuring "a billion doses by 2022."

Except that it didn't. According to the World Health Organization, the actual new commitment was for 870 million additional doses, not a billion, "with the aim to deliver at least half by the end of 2021." In other words, the "aim" would be to get "at least" 435 million additional vaccine doses to the COVAX facility (the international mechanism established to ensure vaccine access in poorer countries) "by 2022." Even if all billion come in over the course of 2022, Agnès Callamard, the Secretary-General of Amnesty International, has called it a "drop in the ocean," made of "paltry half-measures and insufficient gestures." As Gavin Yamey of Duke University summed up the outcome for a Lancet working group, the "rich countries behaved worse than anyone's worst nightmares."

And there is a further problem: the G7 commitments are only promises,

and the G7's track record on meeting its Progressive International. Meanwhile, promises is not especially good. Here the language of the G7 communiqué is telling: "aim to deliver." Even if one believes that those words were chosen in good faith, they are not exactly precise or categorical.

Today, Africa and India have vaccinated barely 3 percent of their combined populations of about 2.5 billion people. Why is that? The US alone is reputed to have the capacity to produce 4.7 billion doses by the end of 2021—four billion more than America needs. Again, according to Amnesty

difficulties, it could resume exports and start supplying doses to the rest of Asia and to Africa, while meeting its own requirements by the end of this year. And enough doses could be produced to end the pandemic, for practical purposes, by the end of 2022.

In early May, the Biden administration announced its support for a proposal, advanced by India and South Africa, to waive Trade-Related Aspects of Intellectual Property Rights (TRIPS) enforcement on Covid-19 supplies, including vaccines. But what does this amount to? So far, just support for negotiations. With whom? Over what?

It was government, not the big drug companies, that underwrote the basic research used to invent these vaccines. The companies have patents only because they were granted as an 'incentive" to produce the vaccines. The claim that otherwise they would not do so is absurd: the US government has the power of compulsion under the Defense Production Act, which it has already used to get vaccine production ramped up, including in a way that briefly disrupted Indian production.

Meanwhile, there's China, and at a smaller scale, Russia. China currently is vaccinating more than ten million people per day—an accelerating pace that will cover their entire population this year. In 2022, China could produce

up to five billion doses for the world enough for India and Africa combined. Meanwhile, Chinese producers are determined to build production sites worldwide, beginning recently in Egypt. And Russia has plans to produce over 850 million doses of Sputnik V in India alone this year. That's just about the same as the entire G7 commitment, and it will happen sooner.

Not everything we read on these matters is necessarily reliable. Not every projection will work out. It may be true, as reported, that the Chinese vaccines are less effective than those produced by Pfizer-BioNTech, Moderna, AstraZeneca, Johnson & Johnson, and Sputnik V.

But for now, where this is heading is obvious. The US and Europe are offering crumbs, protecting their billionaires, their pharmaceutical lobbies, and their politicians' campaign contributions. Meanwhile, China and Russia have other ideas, and the capacity to realise them. So, before too long, when the back of this pandemic is finally broken, the world will have fresh evidence about who is reliable and who





On the other hand, the BBA proposed a toll of Tk 30 for autoickshaw, Tk 50 for car, Tk 150 for minibus, Tk 250 for bus, Tk 200 for small truck and Tk 600 for large truck for using Mukterpur Bridge. It, however, proposed keeping the toll for bikes unchanged.

An official, who was aware of the meeting, said the BBA board discussed the toll issue elaborately and the road transport minister suggested reducing some rates.

Quader also said the revised rate should not be introduced before October this year, the official told The Daily Star wishing not to be named. WHAT TRANSPORT OWNERS SAY

Khondaker Enayet Ullah, secretary general of Bangladesh Road Transport Owners Association, said they were not aware of any move regarding hiking of the toll rate.

"Our business has already taken a hit from the pandemic. Amid such a situation, raising the toll rate without holding talks with us is not appropriate at all," he told this newspaper yesterday.

Rustam Ali Khan, general secretary of Bangladesh Truck-Covered-Van Owners Association, said if the operational costs of vehicles go up, the fares of truck and covered van will rise as well.

their vast force, would simply devour everything that came close to it, the accretion of material releases huge amounts of radiation, releasing heat and light.

Scientists put together this image using a composite of light from different parts of the spectrum, which revealed a "fascinat Using Hubble's Wide Field Camera 3 (WFC3), scientists can capture our universe in ultraviolet, visible, and near-infrared light.

This galactic phenomenon is relatively uncommon, though, as Seyfert galaxies only account for ten percent of all galaxies in the known universe.

Hubble's space telescope is not without its own drama, however. Recently. Nasa had to restart the spacecraft after a computer glitch put it, and all its scientific instruments, into safe mode.

The main computer stopped receiving the "keep-alive" signal, a standard "handshake" (a way of establishing a connection) between the payload and the spacecraft's main computers. It is set to be soon replaced by the James Webb Space Telescope, which Nasa will send into orbit on 31 October aboard an Ariane 5 rocket.

This will give scientists the opportunity to look back 150 million to 1 billion years after time began something that has been previously inaccessible to them with Hubble.

Philippines grounds Black Hawk fleet after deadly crash

The Philippines grounded its entire fleet of Black Hawk helicopters yesterday after one of the new aircraft crashed during a night-time training flight, killing all six on board.

Three pilots and three airmen died when their S70-i went down near the Crow Valley training range north of Manila on Wednesday, Defence Secretary Delfin Lorenzana said.

"The entire Black Hawk fleet are grounded while the incident is being investigated," Lorenzana said.

The country ordered 16 of the multi-role aircraft from a Polish firm that made them under licence from the Sikorsky division of US defence manufacturer Lockheed Martin.

Brazil continued their winning romp through the Copa America Wednesday, eking out a controversial 2-1 victory against Colombia after struggling most of the match to answer a magnificent bicycle-kick goal by Luis Diaz.

The 11th-hour win gave the "Selecao" a perfect nine points from three matches in the South American championships, and extended their current winning streak to 11 matches.

However, the victory was steeped in controversy: Brazil's second-half equalizer, a Roberto Firmino header, was preceded by a Neymar pass that glanced off Argentine referee Nestor Pitana.

Colombia heatedly argued afterward that play should have been stopped, but Pitana ruled neither side was hindered and allowed the match to continue.

Disgruntled Colombia fans on social media turned the referee's name into a viral hashtag, joking he had played as

Cristiano Ronaldo scored his 109th goal for Portugal in Wednesday's Euro 2020 game against France to equal former Iran striker Ali Daei's all-time international record.

The 36-year-old Ronaldo, the leading scorer in European Championship history, converted his second penalty of the game in Budapest to match the record in his 178th international appearance.

Ronaldo has already broken a few records playing at the Euro 2020. He became the only player to have played

at five Euros and has also scored in every Euro he has taken part in, making him the only player to score in five different Euros. Ronaldo was tied with Michel Platini on nine Euro goals as the highest goalscorer in the tournament. He took that record for himself, having scored five goals already in three games. He now has 14 goals to his name and is well clear of Platini.

At 36 years, 130 days, Ronaldo also became the oldest player to score for Portugal at a major tournament, breaking the record set by Pepe at World Cup 2018 (35 years, 124 days), when he scored against Hungary.

"Congratulations to @cristiano who is now one goal away from breaking the men's international goal scoring record. I am honoured that this remarkable achievement will belong to Ronaldo great champion of football and caring humanist who inspires and impacts lives throughout the world."

But that's not the end. The superstar is in line to create a few more records during the course of the tournament, with Portugal expected to go deep into the competition.

It is highly probable that Ronaldo will surpass Iran's Ali Daei and become the player with most international goals. Having already equalled Daei's record of 109 international goals, Ronaldo could overtake him when Portugal face Belgium next in the last 16 of Euro on June 28.

The prolific scorer could also become the player with most assists in Euros. Currently, the record for the most assists made in Euros belongs to Karel Poborsky who is on eight assists. However, Ronaldo is only one away with seven assists.

In terms of caps, Sergio Ramos has 180 caps for Spain and is the highest-capped European international. Ronaldo has 178 caps after the France match and if Portugal progress to the semifinal, he will have broken Ramos' record.

Thursday after the Black Caps claimed the inaugural World Test Championship (WTC) by beating

Kane Williamson's team became Test cricket's first official world champions after prevailing by eight wickets in Southampton on Wednesday, the reserve day of a match plagued by bad weather.

"The Black Caps have made New Zealand proud. This was a masterful performance from a team at the top of their game and on top of the world," Ardern said in a statement.

New Zealand have been to the semi-final of the 50-over World Cup eight times and lost the last two finals, in heartbreaking fashion to England on the boundary countback rule after the 2019 decider was tied.

Throughout those setbacks, New Zealand have continued to play in a spirit sometimes derided as "nice guy" cricket.

More importantly, they have won all but one match, a draw,

in four Test series since a 3-0 drubbing in Australia around the turn of 2020.

"Over the past two years, the Black Caps performances in the Test arena have been outstanding with Test match and series wins at home and abroad," the 69-yearold Hadlee said in a statement.

"The whole team has shown a high degree of professionalism. Their skill sets have complemented each other to make them a complete playing unit. "It's fair to say that this current group of players is the best in our history.

Kiwis dominated global headlines and Indian media outlets also praised the Black

Caps as worthy champions. Former England international Mike Atherton described them as a "humble, hardworking and outstanding Test team - worthy champions", while former Kiwi cricketer Scott Styris tweeted it was a "sensational performance".

The Telegraph commended New Zealand's discipline and dominance and it also pointed out the rise of Kyle Jamieson.

Indian cricket icon Sachin Tendulkar said New Zealand deserved their victory. "Congrats @BLACKCAPS on winning the #WTC21. You were the superior team," Tendulkar wrote on Twitter.

Bangabandhu Bridge

Toll to go up around 17pc

Bridge authority also hikes toll of Mukterpur bridge to meet maintenance cost, repay loans

Bangladesh Bridge Authority (BBA) has decided to raise the toll rate of Bangabandhu Bridge by around 17 percent aiming to boost its income for covering maintenance costs and repaying loans.

The authority has also decided to increase the toll rate of Mukterpur Bridge in Munshiganj for the first time since it inauguration in 2008. The BBA board, chaired by Road Transport and Bridges

Minister Obaidul Quader, made the decisions at its 110th meeting yesterday, officials said.

However, the revised toll rate has to be approved by the prime minister before being implemented. Once approved, the new rate may be introduced from October, they added.

The move comes at a time when the country is witnessing a second wave of Covid-19 and the fare of buses has already been increased by 60 percent to run those at half their capacity.

The fresh initiative may further increase fares of transport which would use the two bridges.

Meanwhile, the BBA board did not approve a toll rate proposal for the under-construction Padma Bridge as the project work has not been completed yet.

The meeting decided to fix the rate three or four months before the opening of the bridge to traffic, likely in June

Complainants have to provide proof of identity

HC issues five directives in full text of its order

The High Court in a full text of an order has issued five directives to ensure that the identities of informants and complainants of criminal cases are recorded.

The informants and complainants must submit photocopies of their national identity cards, or passports and theirnumbers to the police stations or courts concerned when they file cases so that police can find them during investigation.

If any informant or complaint doesn't have national identity cards, the photocopy of the ID card of the person, who identifies the informant or complaint, must be submitted to the police station or court concerned during filing of the case, the HC bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman said in the full text of the order.

The bench released the two-page order on Wednesday.

Hubble Telescope spots distant galaxy with 'fascinating secret'

The Hubble Space Telescope has captured an image of a spiral galaxy that is hiding a supermassive black hole at its centre.

Galaxy NGC 3254 is a "Seyfert galaxy", a collection of planets and stars defined by their extremely active centres, located approximately 118 million light-years from Earth.

The black hole at its core, with its huge gravitational power, can pull gas, dust, stars and planets, around in space – captured by Hubble using both visible and infrared light.

Slipping back to uncertainty

Houses given as PM's gift to nine homeless people inundated after moderate rain

A homeless freedom fighter and eight others, who have been blessed with a cluster of houses in Shajahanpur, Bogura, have found that even moderate rains can leave their new houses completely flooded.

Thanks to the rains last week, even the front and back yards of the houses, given to the homeless people as a gift from the prime minister, are still under water, causing unbearable suffering to the residents.

The houses were built under the Ashrayon Prokolpo-2 at a cost of Tk 15.39 lakh by the Department of Disaster Management in 2020. The nine individuals, including six widows, moved in six months ago.

Locals said it was no surprise that the houses have been flooded, because the low-laying piece of land, on which these have been built, always got flooded during monsoon. Some said they pointed this out to the officials at the outset, but the latter didn't pay heed to their

"We are suffering a lot. There is water inside. Our toilets, and tube wells have been inundated. We have to wade through knee-deep water if we want to leave the neighbourhood," said 68-year-old freedom fighter Hujur Ali. . "We are homeless, the

prime minister gifted us the houses, but they made these on a piece of land where nobody can live in monsoon. Where will we go now?" he asked.

Brazil sets record as 3rd wave breaks

Russia's daily infections, deaths hit six-month highs

Brazil set a new record for Covid-19 infections with 115,228 new cases identified within 24 hours, the health ministry said on Wednesday, confirming the arrival of a third wave of the pandemic.

During the same period 2,392 new deaths were recorded, bringing the total to 507,109.

Brazil is the second worst-hit in the world in absolute numbers of fatalities, behind the United States which has suffered more than 600,000 deaths.

The largest country in Latin America, with 212 million inhabitants, Brazil has a total of 18,169,881 confirmed Covid cases, according to official figures, which many specialists considered an underestimate.

The number of daily infections has been rising steadily for more than a month and the average death rate has been around 2,000 per day since last week.

With this continual acceleration in the number of cases, we are already in the third wave," said Carlos Lula, president of the National Council of Health Secretaries (Conass), which brings together health authorities from the countries various states, told the daily O Globo.

The country has been slow to roll out vaccines with only 12% of Brazilians fully immunized, according to the ministry data. Efforts have accelerated recently, with certain


