

Endangered by engines

Animals dying as road, rails run thru' Lawachhara forest; LGED project to build alternative road still waiting for Ecnec approval

Deaths of rare and endangered species of wildlife under the wheels of vehicles and on train tracks are rampant in Moulvibazar's Lawachhara forest.

A 6.5-kilometre road connecting Sreemangal and Kamalganj and a five-kilometre portion of the Dhaka-Sylhet rail route goes through the forest.

On average, three wild animals die every day on these roads and rail tracks, found wildlife research body Creative Conservation Alliance in a survey conducted last year.

Wildlife frequently end up roadkill when trying to cross

Trial of Suu Kyi to run longer

A Myanmar junta trial of Aung San Suu Kyi will run longer than scheduled, her lawyers said yesterday, with the prosecution still to call nearly two dozen witnesses.

The coup-ousted leader, who is under house arrest, faces an eclectic raft of charges in a trial her legal team had expected would be wrapped up by the end of July.

But with 23 witnesses still to go, "even the close of the prosecution side won't be possible" by then, said her lawyer Khin

Maung Zaw. Suu Kyi was deposed by the military in February, sparking a mass uprising and a brutal crackdown. More than 880 civilians have been killed by the junta's forces, according to

a local monitoring group. Cut off from the outside world except for brief meetings with her legal team and her court appearances, Suu Kyi appeared at the specially set up tribunal in the capital

Wrong Man Jailed

HC gives him bail, seeks answers

The High Court yesterday granted six months' ad-interim bail to a Manik Hawlader, an innocent man who had been serving the jail sentence handed down to actual convict Manik Miah, of Shariatpur's Bhedarganj upazila, in connection with a drug related case.

At the same time, the HC ordered convicted Manik Miah to surrender before the trial court concerned in Shariatpur immediately.

the bench of Justice JBM Hassan and Justice Md Khairul Alam also ordered the district and sessions judge of Shariatpur to send all the relevant case documents to this court in 30 days.

The chief judicial magistrate of Shariatpur was also asked to record statements of the investigation officers of the case about implicating Manik Hawlader and to send the statements to the HC in 30 days, Tushar Kanti Roy, deputy attorney general, told The Daily Star.

Bangladeshis will not accept hoax: Bhashani

BHASHANI REJECTS 'POLITICAL SETTLEMENT' The people of Bangladesh would not accept any political settlement short of independence, said Maulana

Abdul Hamid Khan Bhashani. "The people of Bangladesh will not accept a hoax in the name of a political settlement when they have lost their possessions, when the honour of women has been violated, when so many people have shed their blood, and when millions have been ejected out of their own homes," said the Maulana.

He made it quite clear that there could be no compromise on the matter. "It is independence or death," he said.

He warned the quislings who might be tempted to strengthen

the hands of President Yahya Khan of dire consequences. Any party which ignores the demand for full independence and joins hands with Yahya will be hated more than the anti-people Muslim League. Their political death is inevitable, he predicted.

Bhashani indicted USA and China for giving aid in the shape of arms and money to Pakistan and thereby supporting and sustaining Islamabad's war of extermination on the people of Bangladesh. HOSSAIN ALI'S PLEA FOR RECOGNITION

Man held for raping blind woman

A court in Dinajpur yesterday sent a youth to jail for raping a visually impaired woman, while three others were arrested in Gazipur and Noakhali in rape cases.

The accused of Dinajpur Md Shuvo Islam, 25, is a resident of the upazila's Mirpur village.

Quoting the victim's family members, police said the 27-year-old victim was alone at home on June 12 afternoon when Dafirul Islam, 32, Jahrul Islam, 42 and Shuvo entered the house and gang-raped her.

As she started screaming, neighbours rushed there and rescued the women. However, the rapists managed to flee.

On June 27, the victim's brother filed a case against the trio. Of them, Shuvo was arrested Sunday night, said Mahmudul Hasan, officer-in-charge (OC) of Phulbari Police station.

US Covid cases raising again

Country says Delta variant accounts for 35.6 percent of new cases

After declining fast for two months, the rate of Covid infections in the United States has leveled off since mid-June thanks to localized spikes in under-vaccinated regions of the country, data showed yesterday.

It comes as the highly contagious Delta variant continues to gain traction, now accounting for 35.6 percent of sequenced cases in the past two weeks, according to the covSpectrum tracker. Authorities have said it is poised to soon become the country's dominant strain.

The seven-day-average of new daily cases has hovered at around 11,500 since June 16, according to the Centers for Disease Control and Prevention, or about 3.5 per 100,000 people.
