The project, which started in June 2017, was supposed to be completed in June 2018, said sources. Meanwhile, the builders gave Zakir Enterprise sub-contract of the project.

Contacted, Abdus Sattar Roni, general secretary of South Chattogram Passengers' Welfare Association, said thousands of people must cross the canal by boat due to delays in constructing the bridge. Emergency patients, pregnant women and students who appear for public examination are the worst sufferers.

"The authorities should pay attention to complete the work of the very important bridge immediately," he said.

Mohsin-ul-Islam, manager of Zakir Enterprise, could not be contacted as he did not receive phone calls despite repeated attempts. At one stage, the phone was found switched off.

No officials of Rana Builders or Hasan Builders could be contacted.

However, Suman Singha, executive engineer of Roads and Highways Department (Dohazari circle), claimed

However, the two main contractors were given show-cause notices, he said.

"Four of the five girders were already set up. When the last guarder was being installed by hydraulic jack, a pipe of the jack broke down, which displaced the girder and hit the next one, and that hit the one next to it. In that way, three girders got displaced suddenly and fell into the canal," he explained.

"It's our bad luck. We were supposed to complete the project by June 30, but the accident damaged a lot of the bridge," he said. "It would delay project for at least six months. As the rainy season has already started, we could not go for piling in the canal. We will have to wait for dry season."

Suman claimed that only one worker sustained minor injuries in the accident, who received primary treatment.

Regarding a one-year project being delayed for four years, he said he took over office two years ago and from then on work of the project gained pace.

"We warned the contractors over the delay and strictly instructed them to that the incident on Friday was merely an complete it as soon as possible," he added.

HC summons

The father and his family have been compelled to leave their home, he said.

On June 11, The Daily Star published a report titled "Bearing the unbearable", and a video about the ordeal of the family.

On August 25, 2015, the body of eight-year-old was found in a jute field in Bogura's Katakhali. A day later, the father filed a case with Sariakandi Police Station.

Liberation Minister AKM Mozammel Haque held a meeting on June 24 on this issue, but the resolution of the meeting's decision was yet to be finalised, he said, adding that he will submit the resolution to the court when he receives it.

Lawyer Syeda Rizwana Hasan appeared for the writ petitioners during the virtual hearing of the petition.

Earlier on May 20 this year, the HC bench expressed hope that the problems regarding Suhrawardy Udyan's tree-felling will be resolved amicably, through discussions between the government and environmentalists.

Rights organisations Bangladesh Environmental Lawyers Association (Bela), Association for Land Reforms and Development (ALRD), Nijera Kori, Bangladesh Legal Aid and Services Trust (BLAST), Bangladesh Paribesh Andolon (Bapa) and Ain O Salish Kendra (ASK), and architect Mubasshir Hossain collectively filed the writ petition with the HC on May 9 this year.

In the petition, they sought its directive on the government not to cut trees and not to damage environment and natural characteristics at Suhrawardy

Following another writ petition, the HC on July 7, 2009 directed the government to identify and preserve all the important historic places related to the Liberation War and to set up memorial monuments at the historic places at Suhrawardy Udyan maintaining international standard, so that people from home and abroad can pay homage to martyred freedom fighters.

The HC had ordered the government to take steps to protect and maintain the historic places at Suhrawardy Udyan -- where Bangabandhu Sheikh Mujibur Rahman delivered his historic speech on March 7 in 1971 and where the Pakistani army surrendered on December 16,

Suhrawardy Udyan also include places where Bangabandhu gave his speech on January 10, 1972, after his return to the country from exile, and where Indira Gandhi, then prime minister of India, greeted Bangabandhu on March 17, 1972.

WB to provide

Police detained them from Nishindara area of Bogura Sadar upazila around 1am.

The video, which went viral, showed a team of Bogura district lawenforcers illegally smashing battery-run auto-rickshaws and vans with hammers. and later, bulldozing them. Police said the incident took place in 2017, but during the current lockdown, the arrestees publicised it as a recent incident.

According to a police press release, the accused were spreading the video inside a Facebook group.

During preliminary interrogation, the accused admitted that they had used the opportunity to tarnish the image of law enforcement during the ongoing strict lockdown, police said.

Bogura Superintendent of Police Ali Ashraf Bhuiyan told The Daily Star, "The accused are inciting public discontent and anger against the government by releasing an old video and saying the footage is of current drives of law enforcers during the ongoing lockdown.
