# MOGHBAZAR BLAST Caretaker's body found 2 days later

Probe body blames methane; cops file case

#### STAFF CORRESPONDENT

Two days after an explosion in a building in the capital's Moghbazar, another body was recovered from the debris yesterday, raising the death toll to eight.

The victim, Harun-or-Rashid, 71, was the caretaker of the three-storey building.

Debashis Bardhan, deputy director (operations and maintenance) of Fire Service and Civil Defence, said Harun had been missing since the blast on Sunday evening. Firefighters found his body around 3:30pm while inspecting the debris on the ground floor.

"We will hand over the body to police ," he said

Meanwhile, police yesterday filed a case with Ramna Police Station against unidentified people for causing deaths by negligence.

Harun Or Rashid, additional deputy

commissioner of Ramna division of Dhaka Metropolitan Police, told journalists that they were investigating whether there was any negligence from the owner, caretakers and traders in the building.

It will also be probed whether there is any negligence in the storage or management of goods by the traders in the building, he added.

#### METHANE GAS BLAMED

Md Asaduzzaman, who leads the sevenmember committee formed by police to investigate the cause of the explosion, yesterday said Moghbazar blast took place in presence of methane gas.

He said 12-13 percent methane gas was found at the spot by testing with a gas detector machine.

"Initially, I guess that the accumulated gas came in contact with air and formed an explosive mixture which caused a huge SEE PAGE 10 COL 3

# Lawyers should have 10pc pro bono cases

Says CJ

Chief Justice Syed Mahmud Hossain yesterday said law profession has now become a business.

Lawyers in the past would not charge extra other than fixed fees, he said, adding that lawyers should have at least 10 percent pro bono cases, as practicing law is a service profession.

The chief justice made the remark while presiding over a six-member full bench of the Supreme Court's Appellate Division for virtually dealing with several jail appeals filed by poor convicts.

Chief Justice Syed Mahmud Hossain told senior lawyer and criminal law expert Md Munsurul Hoque Chowdhury that senior lawyers like him should move pro bono cases.

around the world, they were able to quell the previous month's cholera epidemic, which took more than 5,000 lives.

## Militants have no capacity to attack now STAFF CORRESPONDENT

Militants are not capable of carrying out any major subversive attack in the country at this moment, Rab Director General Chowdhury Abdullah Al Mamun has said.

"We are one step ahead of militants and that's why there is no violence by militants in the country now. We are taking actions before any major incident could occur," he said.

The chief of Rapid Action Battalion was speaking to reporters at the Rab headquarters yesterday about the current law and order in the country.

He said the Rab were monitoring militant activities in the cyber world and whenever they get information through this monitoring, they arrest militants and bring them to book.

Since the Holey Artisan Bakery attack in the capital's Gulshan on July 1 2016, the Rab has arrested around 1,500 militants in last five years. Besides, 16 militants were rehabilitated after their surrender, said Mamun.

At least 20 local and foreign nationals were killed in the militant attack in 2016. Two police officials were also killed SEE PAGE 10 COL 3


