Weeklong Lockdown

First day was indeed strict

Rural areas, alleyways see crowds

On the first day of the weeklong nationwide "strict lockdown", most roads, including that of Dhaka, were eerily quiet with law enforcers going tough on people out without a valid

Yesterday, the country recorded 143 deaths from Covid-19, the highest in a single day since the first cases were reported in March last year. Several teams of the army, BGB, Rab, and

police, accompanied by executive magistrates, set up check points at various locations in Dhaka and elsewhere in the country and asked

people why they were out. People who were unable to give satisfactory answers were detained or fined.

Most Dhaka dwellers stayed home, respecting the government's order. The intermittent showers throughout the day also

Dhaka Metropolitan Police (DMP) yesterday detained 550 people in Ramna, Lalbagh, Motijheel, Wari, Tejgaon, Mirpur, Gulshan, Uttara and other places in the capital, according to a list issued by the DMP.

It said the detainees failed to provide acceptable reasons for defying the stay-at-home order. The cops also fined 212 people.

At least 274 cars were fined Tk 4.63 lakh and 26 shops Tk 45,557, according to the list.

Record 143 deaths in a single day

8,301 new Covid cases

Health officials yesterday reported 143 deaths, the highest in a day since the first cases of Covid-19 were detected in the

The deaths were recorded in the 24 hours preceding 8:00am yesterday, according to a press release from the Directorate General of Health Services (DGHS)

The number of deaths have been over 100 for the last five day.

The number of total reported deaths from Covid-19 reached 14,646 yesterday.

Of them, 7,087 died this year. The first cases of coronavirus were detected in Bangladesh on March 8, 2020.

Officials also reported 8,301 new cases yesterday and the positivity rate was 26 percent. The rate has been rising since June 1. The highest, 32 percent, was recorded on August 3, last year.

Of those reported dead yesterday, 90 were male and 53 female. Nine died at home and the rest in hospitals.

Forty-six of them died in Khulna, 35 in Dhaka, 19 in Rajshahi, 15 in Chattogram, 10 in Rangpur, eight in Barishal, seven in Sylhet and three in Mymensingh divisions.

Khulna and Rajshahi divisions have been the hotspots of new cases of Covid-19 as the Delta variant spread across the country.

Vaccination gathers steam

45 lakh doses of Sinopharm, Moderna arrive by tomorrow

The arrival of around 45 lakh doses of Covid-19 vaccine over two days is set to boost the country's vaccination

Bangladesh will receive 25 lakh doses of Moderna's Covid vaccine in two shipments today and tomorrow under the Covax facility.

The country is also going to receive around 20 lakh doses it procured from China's Sinopharm in the two days, said Health Minister Zahid Maleque.

"A total of 12 lakh doses will reach Hazrat Shahjalal International Airport around 11:20pm on Friday and the rest will arrive on Saturday at the same time. Around 11 lakh doses of Chinese Sinopharm vaccine will arrive at 12:30pm [on Saturday]," the minister said.

Zahid said after getting the vaccines, the country's vaccination campaign will gain pace as more people will be vaccinated.

He also said the registration process for people to get the vaccine is likely to be reopened.

Hassles outweigh remedy they give

Courts take 10 times the time they are legally allowed to come up with judgments: BLAST study

On average, labour courts take ten times more time to pass a judgment than they are legally allowed.

This astonishing figure came up in a study done Bangladesh Legal Aid and Services Trust (BLAST), which analysed 80 compensation cases, all

related to workplace injuries and deaths, litigated by the organisation.

It took, on average, 601 days for labour courts to pass a judgment on cases of workplace injury or death, even though the legal time-limit is 60 days, found the report titled "'Tire them out': Challenges

Employers take a further 475 days on average to pay compensation

Average distance covered between worker and court was 201 km

of litigating compensation claims under Bangladesh Labour Act 2006". The labour court of

Chattogram took the longest -- 1,280 days on average -- to dispose of cases, the study found.

Such excruciatingly long waits also often come to no fruition because employers routinely defy court orders,

and the workers have to then file criminal cases to obtain what is rightfully theirs -- and so, the legal process starts all over again.

Five die as oxygen supply 'interrupted'

At least five Covid-19 patients died in Satkhira Medical College Hospital aftei disruption to their oxygen supply on Wednesday night.

Hospital employees said the vendor failed to deliver the oxygen on time, causing a dip in gas pressure in the evening.

An official of the vendor, Spectra Oxygen Ltd, said the delay was caused at Benapole Port through which his company imports oxygen to Bangladesh from India.

Contacted, Milton Hossain, Jashore depot manager of Spectra Oxygen Ltd, said, "We were informed [that oxygen was needed] at 10:00am. We thought we would be able to deliver oxygen by noon. But, we could not. There was a delay at the port while releasing the oxygen imported from India."

The Daily Star could not contact the port authorities.

Free Covid tests at all govt labs this month

The government has decided to make all Covid-19 tests free of charge in all government-run laboratories this month.

"With the massive surge of infections across the country, the necessity of Covid-19 tests has increased. [But] paying for several members of a family for the test is becoming tough for poor people. In this regard, it has been asked to take necessary measures to do Covid-19 tests for free for only July 2021," an official order signed by Bilkis Begum, deputy secretary of the health ministry's health service division, said yesterday.

Currently, Tk 100 is charged for each Covid-19 test at the designated sample collection booths, while Tk 300 is taken for collecting samples from home.

The home service is limited inside Dhaka city only.

UN RESOLUTION ON MYANMAR

Dhaka treads on razor edge

Bangladesh's abstention from voting on the UN General Assembly resolution on Myanmar, which condemned the country's February 1 military coup and called for restoring democracy and preventing arms flow, has raised questions whether Bangladesh supports the Myanmar military

It is also being speculated whether Bangladesh is in the group of Russia and China, who, despite their powers at the UN Security Council (UNSC), has done little to protect the Rohingyas from the genocidal acts, especially following the 2017 military crackdown that led to an influx of 750,000 Rohingyas into Bangladesh.

The Western countries, including the US, EU, UK, and Canada, initiated the resolution and finalised it in consultation with the members of the Association of

Southeast Asian Nations. It was adopted on June 18. A total of 119 countries voted in favour and Belarus voted against it.

As many as 36 countries, including UN Security Council Permanent Members China and Russia, and Bangladesh's closest friend India, and ASEAN countries Brunei, Cambodia, Thailand and Laos, abstained from voting.

Rabab Fatima, Bangladesh's Permanent Representative to the UN in New York, explained the abstention.

She said Bangladesh shares borders with Myanmar and hosts over a million of their people. Therefore, stability in Myanmar is critically important for Bangladesh in finding
