Man dies of injuries in Dinajpur

One arrested

A man, who was injured during a clash over a cricket match in Phulbari upazila of Dinajpur on Thursday, died at a hospital in Dinajpur early yesterday.

Police arrested a man in connection with the incident.

The deceased, Mintu Islam, 35, was son of late Nur Islam of Ghatpara village under Phulbari upazila.

The arrestee, Shafiqul Islam, 35, is son of Foyzar Rahman of the same village.

During the match, the players and supporters locked in an altercation. Later, they attacked each other, leaving four people injured.

A case was filed over the incident with Phulbari Police Station.

According to the case, local youths of Ghatpara village organised a cricket match at the playground of Adarsha College on Thursday. During the match, the players and supporters locked in an altercation. Later, they attacked each other, leaving four people injured. Of them, Mintu Islam was injured critically.

Locals rushed him to Phulbari Upazila Health Complex. But the doctors there referred him to M Abdur Rahim Medical College Hospital in Dinajpur. Mintu succumbed to his injuries there.

Police sent his body to the morgue of the hospital for autopsy.

Hasan Mahmud, officer-in-charge of Phulbari Police Station, said Jahrul Islam, a villager, filed a case with the police station on Saturday, accusing 12 people.

A court in Dinajpur sent the arrestee to jail custody, said the OC.

Another accused of the case went into hiding after the case was filed, he added.

21 FLOODED HOUSES OF ASHRYAN PROJECT

Sarishabari upazila administration in Jamalpur has started to construct 21 new houses for 21 landless families whose houses, built in the middle of Karbari Beel under government housing project of Ashrayan, were flooded last month following incessant rain.

The houses, built at a cost of Tk 35.7 lakh, were handed over to the homeless families earlier this year.

The original site of the houses was in a low-lying area of the beel, under Mahadan union of the upazila, which remains under water for nearly half of the year, said locals.

The steps to build 21 more new houses for the 21 displaced families came after news reports were published in The Daily Star and various other newspapers and media outlets regarding the inundation of their houses in Karbari Beel.

Shihab Uddin Ahmed, upazila nirbahi officer (UNO) of Sarishabari, said this time they were constructing houses for the 21 families on higher ground in Raghunathpur area of Mahadan union.

The residents of the new houses would not feel insecure as the new site is in a 'flood-free' area and construction of the houses will be completed within the shortest possible time.

Currently they arranged shelter for the 21 displaced families at Hirannabari Madrasa building, which is being used as a flood shelter for locals.

Asked how a low-lying area was selected originally for the housing project under Ashrayan, the UNO said most of the upazila fall under low-lying areas and the Ashrayan Taskforce Implementation Committee in the upazila had selected the khas (government) land in Karbari area as the site of the project.

Since June 23, each of the 21 displaced families of Ashrayan already received relief materials -- including 10 kilograms of rice, potato and soybean oil -- in two phases, the UNO added.

Sarishabari Upazila Project Implementation Officer, Humayun Kabir, however, could not be reached for comments over the situation of the Ashrayan project despite repeated calls on his cell phone.

While speaking with this correspondent, Mahadan Union Parishad Chairman Anisur Rahman said before the construction started, he had raised objection to the selection of the original Ashrayan site in the low-lying area of the beel.

He confirmed that earth filling work at the new site in Raghunathpur area has started already and he hoped that the landless families would not have to wait for too long

to be rehabilitated and move in to their new houses.

Abdur Rahman, a 60-year-old ailing member of one of the displaced families, said he and his four other family members did not go to the flood shelter and they were temporarily staying at a house in Karbari area.

A member of another displaced family, Jorina Begum, said she and her three children were also staying with another family in Banshabari area.

Expressing contentment at the news of the commencement of fresh construction of houses for them, many of the displaced family members said they hope that their new houses would be on higher ground and of permanent nature this time.

They also thanked the upazila administration for taking care of them by sending food relief at the most critical time.

Villagers kill Nilgai in Thakurgaon

A Nilgai, the largest antelope in Asia, died after locals chased it at Muktarbasti village in Thakurgaon's Ranishankoil upazila yesterday afternoon.

Upazila Livestock Officer Madan Kumar Roy confirmed the news to The Daily Star.

Locals said the animal crossed the border from India a few days ago and was seen around the village.

Spotting the animal in a crop field at the village, villagers began to chase it, locals said.

At one stage, the antelope took shelter in an under construction house of one Hamidur Rahman, they said, adding that as people were about to catch it there, the animal jumped through the window and fell unconscious.

On information, a local Livestock Service Provider (LSP) rushed to the spot and provided primary treatment to it but it died within an hour.

Being informed, acting Upazila Nirbahi Officer Pritom Saha along with the upazila livestock officer visited the place.

3 held for gang-rape of minor in Chattogram

Police arrested three men yesterday for their alleged involvement in the gang-rape of a minor girl in Chattogram.

The trio -- Mohammad Alauddin, 19, Shakil Ahmed, 21, and Shafiqul Islam, 21 -- were arrested from the port city's Khulshi area, police sources said.

Aftab Hossain, inspector (investigation) of Khulshi Police Station, said the three youths used to hang out near the victim's house.

"Around 7:30pm on Thursday, they tactically took the victim out of her home and forcibly took her to a nearby hill," he told The Daily Star.

There, they raped the 13-year-old girl, he added.

According to the police officer, a local named Masud caught the trio red-handed but they threatened him with dire consequences. Later, Masud returned home and told everybody around.

In the meantime, the victim returned to her house in critical condition. Her family members rushed her to the One-Stop Crisis Centre (OCC) of Chattogram Medical College Hospital (CMCH), the inspector said.

The victim's mother later filed the case against the three youths.

"During primary interrogation, the trio admitted their involvement in the crime," the police officer said.

Meanwhile, an indigenous girl was gang-raped in Sadar upazila of Khagrachhari early yesterday.

The minor victim hailed from the Marma community and was a student of grade five at a local school, said Mohammad Rashid,

officer-in-charge of Khagrachhari Sadar Police Station.

The alleged rapists -- Mohammad Kamal, 30, and Rafiqul Islam, 24 -- were arrested, said the OC.

After having a feud with her mother, the victim went out of her home at night and reached the bus terminal in the upazila.

The duo then picked her up in a bus and raped her, the police official said, adding, the duo confessed that they raped the minor girl.

Ripon Bappi, resident medical officer of Khagrachhari Sadar Hospital, said the victim was receiving treatment at the hospital.

In another development, police recovered the body of a 10-year-old girl from a jute field in Kishoreganj's Katiadi upazila.

On Friday, the victim went for early morning fishing with her father Chunnun Mia, a fisherman by profession.

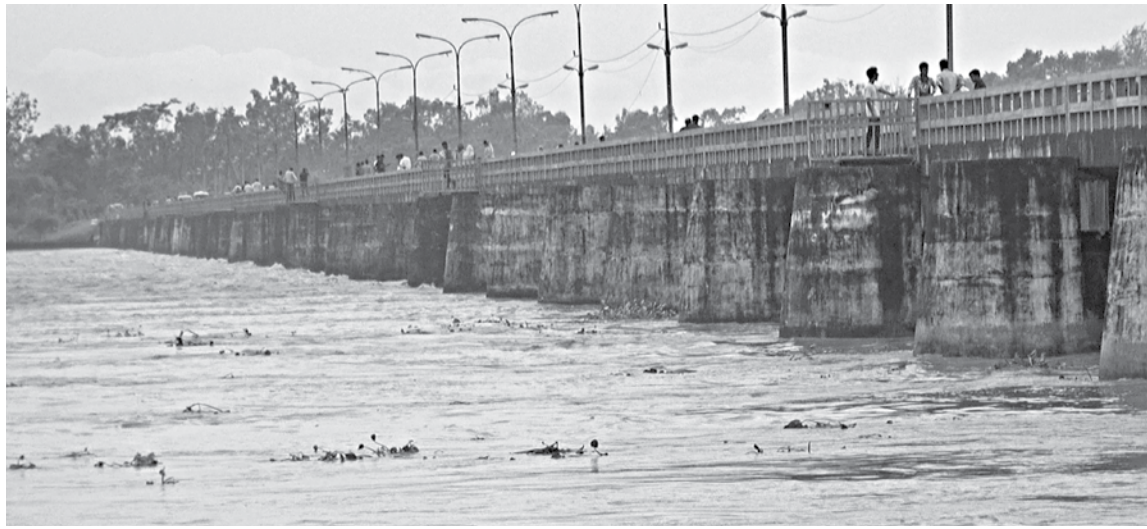
SM Shahadat Hossain, officer-in-charge of Katiadi Police Station, said Chunnun asked her daughter to return home as the rain started. The girl, however, did not return home.

Later, locals found her body around 10:00am on the same day. A scarf was wrapped around her neck and her hands and legs were tied, he added.

Police primarily suspected that the girl was raped before being murdered.

The body was sent to Kishoreganj General Hospital morgue for autopsy.

A case was filed against unknown people on Friday night in this regard but police could arrest nobody in connection with the case.

Man hacked dead by neighbours

A man was hacked dead yesterday around noon, allegedly by his neighbours in Dokkhin Ramchandrapur village of Pabna Sadar upazila.

Angry locals later set fire to the residence of the suspected attackers.

The deceased was identified as Sumon Pramanik, 37, son of Baki Pramanik from the same village in the upazila.

According to locals, Sumon had a longstanding hostility with twin brothers Titu and Mithu.

Around noon yesterday, when Sumon was returning home, the two brothers attacked him with sharp weapons and left him for dead on the spot.
