Vaccine lowers risks for Covid-infected patients

Finds CVASU study

Researchers in Chattogram have found that Covid-19 patients who received Oxford-Astrazeneca vaccine had a minimum risk of being critically ill and hospitalised compared to those who were not vaccinated.

Experts at Chattogram Veterinary and Animal Sciences University (CVASU) conducted the research on 1,095 Covid-19 patients from different districts in the division from April 22 to June 22.

CVASU VC Prof Dr Goutam Buddha Das led the eight-member research team.

One of the researchers, Dr Sharmin Chaudhury, professor of Department of Pathology and Parasitology, told The Daily Star that of the 1,095 patients, 968 (88.4 percent) did not receive any vaccine.

The rest 127 received vaccine, she said, adding that of them, 63 (5.75 percent) received a single dose of Oxford-Astrazeneca vaccine and 64 (5.84 percent) took both

Among the affected, a total of 137 patients who did not receive vaccine were hospitalised whereas only seven who received the first dose and three who took the both were hospitalised, she said.

That means, of the unvaccinated, 14.15 publishing.

percent needed hospitalisation whereas of the single dose vaccinated patients, 11 percent needed hospitalisation and of those who received both doses, only 4.68 percent were hospitalised.

That means, the study revealed that vaccination not only lessens the risk of being affected but also lessens the risk of being hospitalised, said Dr Sharmin. Full dose vaccination is more effective than that of single dose, she said.


Contacted, Dr Goutam Buddha Das said of the hospitalised patients, a total of 83 suffered from breathing problem and none of them were vaccinated.

On the other hand, the vaccinated patients did not require oxygen support, he The oxygen saturation decreased as low

as 70 percent among the patients who did not receive vaccine whereas it was 96.7 percent on an average among the vaccinated patients, he said.

A total of seven patients required ICU support and none of them were vaccinated, said the VC, adding that10 patients died and none of them were vaccinated.

Dr Sharmin said the study would be submitted to an international journal for

Oxyjet, which reduces costs and is capable of supplying 60 litres of oxygen per minute.

The device's design and evaluation were based on UK-MHRA guidelines for Rapidly Manufactured CPAP System.

But Buet did not get permission from Directorate General of Drug Administration (DGDA) for its production based on the grounds that it was not developed by a company, the lawyer added.

The HC bench said it is worth questioning whether Buet can produce the device for business purposes, as there are some rules and regulations in production and purchase.

Aneek told The Daily Star that he just informed the HC about Oxyjet.

"I did not move any petition before the HC bench for an order. The court advised me to inform the principal secretary at PMO and attorney general."

accomplices of TikTok Ridoy who was arrested in India on charges of human trafficking. Anik used to supply drugs to Ridoy's TikTok group,' Commander Khandaker Al Moin, Rab's legal and media wing director, told a press briefing yesterday.

The other detainees are -- Shahidul Islam alias Ampul (34), accused in six cases; Abir Ahmed Rakib (22), accused in two cases; Sohag Hossain Arid (36), accused in three cases; and Hira (22), accused in one case.

Rab seized a foreign-made pistol, two rounds of bullets, five sharp weapons and 300 pieces of yaba pills from their possession.

"The gang has 20-25 members. They are involved in crimes in Hatirjheel and Moghbazar areas, including extorting money from people who visit Hatirjheel," the Rab official said.

About Anik, Rab said he got involved with criminal activities since he was a teenager. In 2016, Anik was first accused in Arif murder case. Gradually, he formed his gang and established supremacy in Moghbazar, Madhubag, Mirbagh, Peyarabagh, Chairman Goli, Aambagan and Hatirjheel areas, said Rab.

"Anik used to control a drug syndicate in the area. In this lockdown, the gang used to supply drugs through home delivery services," the Rab official said.

At a briefing on Sunday, he said some drug peddlers were trying to sell narcotics in guise of emergency services. Rab had foiled two such attempts in Chattogram and Rangpur.

Asked, the Rab official said that they were investigating whether Anik has any involvement with Ridoy's trafficking racket.

Tackle land

"It is key to adopt a modern system of garbage management and build awareness among people, and if necessary, apply laws concerned so people do not throw garbage into waterbodies," he continued.

While coming to Farmgate from Dhanmondi via Saatmasjid road, Panthapath, and Karwan Bazar, no police check posts were seen. However, in some areas, police were seen

stopping and questioning cars going past active check posts, such as at Kakrail and Paltan.

Meanwhile, police presence at alleyways was almost nil, which enabled shops to operate vithout fear, many with their shutters half-open. According to government's orders, only shops

and groceries selling daily essentials are allowed

o open during the lockdown. However, all sorts of stores were seen raising their shutters yesterday. In some areas, shop staffers were seen playing hide and seek" with law enforcers. They shut the shutters whenever patrol vehicles would appear,

out opened once police were gone. Stores selling furniture, bedding, sanitary goods, electronics, and clothing were seen open at areas including Rampura, Azimpur, Mohammadpur, Adabor and parts of Mirpur.

Besides, most people didn't bother to follow health protocols, while many traders' masks were seen hanging off their necks at different kitchen markets and grocery shops.

Amid all this, Dhaka North City Corporation

Mayor Md Atiqul Islam warned that shops that remained open defying government directives could get their trade licenses cancelled.

"We will cancel their trade licences and take legal action," he said while visiting Bijoy Sarani


