Hospitals stretched to breaking point

With coronavirus patients rushing in, facilities running out of beds fast; ICU occupancy rate doubles in a month

As the Delta variant continues to spread and the number of critical coronavirus patients keeps rising in hospitals, the country faces the bleak prospect of running out of Covid-dedicated beds, especially those in ICUs. hospitals Major

already become overburdened due to the rush of Covid patients, with around 81.65 percent out of 1,471 ICU beds, designated for treating the disease countrywide, remaining occupied

as of yesterday noon. The ICU occupancy rate has doubled in one month since June 14, according to the Covid-19 Dynamic Dashboard of the

Health officials said ICU beds are filling up thick and fast as around 50 percent of the Covid patients are coming to the hospital in critical condition.

The government considers allowing garment factories to be open so that the biggest export-earning sector can continue production and keep their commitment with international buyers.

Commerce Minister Tipu Munshi yesterday talked about the plan amid concerns among garment owners that shipment will suffer seriously if they have to suspend operations during the 14-day lockdown beginning from

July 23. Entrepreneurs said the July-August period is the prime season for apparel manufacturers since sales rise at that time in the

Jubo League man 'tortured in custody'

His family sniffs communalism over FB post on Mamunul

Police in Sunamganj arrested two people, including a Jubo League leader, on Tuesday in a case filed over assaulting a sub-inspector of Shalla Police Station.

However, family members of the Jubo League leader have alleged that the arrest was part of a communal agenda connected to his sharing an audio recording of former Hefajat-e-Islam leader Mamunul Haque on Facebook in April.

The family also alleged that the Jubo League leader has been tortured in custody.

The arrested Jubo League leader is Arindam Chowdhury Apu, 38, the former convener of Shalla Úpazila unit Chhatra League and a resident of Ninda village of the upazila. The other arrestee is Ratan Roy, 28, a resident of Ghungiargaon village.

According to the statement of the case filed by Shalla Police Station Sub-inspector Shah Ali, the SI had visited Shahid Ali High School in the upazila soon after

Covid may now spread even faster

Fear health officials citing easing of lockdown; deaths surpass 17,000-mark

Health officials have warned of a possible rise in Covid-19 transmission as the "strict lockdown" has been withdrawn for a week from today.

"We think there is a chance

The warning came at a time when the country saw 210 deaths from Covid-19 in 24 hours ending at 8:00am yesterday.

China vaccine at 'lower price'

Proposal for purchasing 15m doses okayed

The government would purchase 1.5 crore doses of Sinopharm vaccine from China at a lower price than the one mentioned in the previous agreement.

According to a finance ministry statement, the Cabinet Committee, chaired by Finance Minister AHM Mustafa Kamal, yesterday approved a proposal regarding government procurement.

The minister said that a total of 15 million doses of Sinopharm vaccine -- 13 million of the previous agreement and two million newly proposed -- would be purchased at a lower price.

"We got a lower price than the previous price," he said.

Buy 20m doses of Sputnik V

Gonoshasthya urges govt, claims it's now the local distributor of the Russian vaccine

Gonoshasthaya Kendra (GSK) has asked the government to buy 20 million doses of Russia's Sputnik V Covid-19 vaccine and said that the Gonoshasthaya Nagar Hospital has been appointed the vaccine manufacturer's sole distributor in Bangladesh.

Each dose will cost \$8, according to a proposal submitted to Foreign Minister AK Abdul Momen during a meeting on June 6. Health Secretary Lokman Hossain Miah and DGHS Director General Prof ABM Khurshid Alam were also present in the meeting, said GSK sources.

On June 9, GSK wrote to the minister informing him about getting the distributorship of Sputnik V. Getting no response, it sent another letter to the Prime Minister's Office on June 15. It also sent a letter to Prime Minister's Principal Secretary Ahmad Kaikaus on June 24, the sources said. Contacted, GSK founder and trustee Zafrullah Chowdhury said, "I don't

have anything to tell you about this. We have informed the government in details in our letters. However, we did not get any response," he said. Asked, he said, "We have given our proposal on purchasing the vaccine

Methane caused Moghbazar blast

Finds a probe by Fire Service; gas accumulated from pipe lines and sewers

The massive explosion that claimed 11 lives in the capital's Moghbazar late last month resulted from the accumulation of a huge amount of methane gas from a leaked gas pipeline and sewerage line inside the building, says a probe report of the fire service.

The accumulated gas came in contact with a spark either from an electric switch or an electric insect killer or a mobile phone, according to Bangladesh Fire Service and Civil Defence (BFSCD).

Over 9k held in 14-day lockdown

'Strict lockdown' withdrawn for a week from today

More than 9,000 people were arrested in Dhaka in the 14-days "strict lockdown" as the government is relaxing the restrictions for eight days from today for the Eid-ul-Azha.

Besides, mobile courts fined 2,999 individuals and business establishments Tk 39.11 lakh while 8,139 vehicles were fined over Tk 1.83 crore for violating lockdown, according to Dhaka Metropolitan

However, such action affected little as Dhaka and elsewhere were seeing a rise in public and vehicular movement every day with the spike in Covid-19 infections and deaths throughout the

There is a chance that Covid-19 transmissions will rise since the ongoing lockdown has been withdrawn for a week, health officials said yesterday.

Yesterday, traffic, crowds swelled up on Dhaka streets on the final day of lockdown. Large numbers of people and vehicles like private cars, motorbikes and rickshaws were seen

There were gridlocks at different intersections including Panthapath, Karwan Bazar, Bijoy Sarani, Mouchak, Kakrail and Mohakhali areas in the

Private cars, motorbikes and rickshaws dominated the city thoroughfares. The traffic police were

Like other days, kitchen markets also drew public gatherings, and vendors were seen roaming around the streets while many shops stayed open. Shopping malls, markets and big outlets were preparing to open their businesses from today ahead of Eid.

Laundry services, salons were also found open in some areas nearly after two weeks of closure.

"We reopened the laundry shop after 12 days as many people will need the services ahead of Eid," said a laundry service provider in the Shymoli area.

Meanwhile, DMP's mobile courts yesterday fined 105 persons over Tk 1.32 lakh and 744 vehicles over Tk 15.79 lakh for violating lockdown. Some 462 people were arrested on similar charges.

Outside Dhaka, gridlock was created in Brahmanbaria part of Cumilla-Sylhet highway due to repairing works on Langalbandh Bridge in Narayanganj.

Thousands of goods-carrying vehicles crowded the highway, making it almost impassable. Drivers and passengers were in distress, reports our Brahmanbaria correspondent.

Hospitals stretched to breaking point

11,000 in the last week and the positivity rate around 30 percent, experts fear healthcare facilities across the country including those in Dhaka may face a bigger crisis than it experienced in April this year if runaway infections are not reined in.

They say transmission has not come down as expected during the ongoing lockdown that started from the first day of July.

The Delta variant, far more transmissible than all other strains, has brought the healthcare system in India to its knees. And since its first detection in Bangladesh on May 8, this variant caused health disasters across Khulna and Rajshahi regions before reaching other parts of the

On Saturday, there were at least 11 patients -- five of them from outside Dhaka -- waiting to be admitted at the DNCC Covid-19 Dedicated Hospital in the capital between 3:15pm and 4:10pm.

Mongla Bishwas, 45, was one of them, having been brought to the country's biggest Covid facility with his oxygen saturation level at 75 percent. The on-duty nurse at the triage area said the patient needed high-flow oxygen therapy.

"However, not a single bed with high-flow nasal cannula was vacant. We will admit the patient anyway," the nurse said, preferring not to be

There were around 70 ICU beds officially vacant at the hospital at that time. Multiple staffers, however, said no high-flow nasal cannula (HFNC), meaning no critical patient needing high-flow oxygen therapy can be treated in these ICU beds.

For the past week, the DNCC hospital has been receiving around 80 patients daily on an average, according to the officials.

As of yesterday noon, the hospital was treating 501 Covid patients, 481 of them in critical condition.

The patients were occupying 167 out of 212 ICU beds, all of the 288 HDU beds, and all of the 12 beds with HFNC. Only 40 patients were receiving treatment in general beds, numbering 500 at the hospital.

"Around 40 percent are coming at a critical point of their illnesses. But we cannot provide high-flow oxygen therapy at once to all of them as all HFNC beds have been remaining occupied for more than a week," an on-duty doctor at the hospital told The Daily Star seeking anonymity.

Due to several official embargos, including Thursday's one, imposed by the Dhaka Civil Surgeon office, none of the public healthcare staff are interested in being quoted in the

Contacted, Brig Gen AKM Nasir Uddin, director of the hospital, told

this newspaper that the rush for some 11 patients died in the past two patients has increased in the past "We still have vacant ICU beds as

well as general beds. But our capacity will be exceeded soon if such a rush continues," Brig Gen AKM Nasir Uddin said. While the DNCC hospital had many general beds vacant, Dhaka Medical College Hospital was close to

surpassing its capacity as 92 percent of its 827 general beds were occupied on Sunday, according to the Covid dashboard data updated till July 11. All the 20 ICU beds for Covid in Dhaka Medical College Hospital

(DMCH) were occupied yesterday, according to the DGHS press release, while 55 out of 65 HFNC beds and 29 out of 37 HDU beds were engaged till Sunday.

DMCH Director Brigadier General Nazmul Haque told this newspaper on Sunday, "The rush of Covid patients has increased recently. But we are still capable of treating them with the resources we have.

Except for the DNCC hospital, there are 15 other public hospitals treating Covid patients in Dhaka city where the ICU bed occupancy rate was around 86 percent against a total 183

beds yesterday. Besides, all 300 beds in Kurmitola General Hospital have been occupied for more than a week while the bed occupancy rate was 91 percent of 195 beds in Kuwait-Bangladesh Friendship Hospital, and 78 percent of 384 beds in Mugda General Hospital.

While official data shows more than 18 percent of ICU beds were vacant across the country, the reality, however, indicates a number of those are not fully equipped to treat critical patients or have remained dysfunctional, according to healthcare professionals treating Covid patients.

For instance, two out of total 10 ICU beds have remained dysfunctional for the last two weeks in the Covid unit of Rangpur Medical College Hospital while four out of 20 ICU beds in Sylhet's Shahid Shamsuddin Ahmed Hospital remained dysfunctional for several days, reports our district correspondents concerned.

The surge in patients has also put the oxygen supply chain under immense pressure as the daily demand has increased to 220 tonnes from 100 tonnes of the normal time, according to Dr Farid Hossain Miah, director of hospitals and clinics at the DGHS.

"As the number of patients is increasing, the demand for oxygen is also rising by three percent daily. We are trying our best to tackle the situation with what we have," Dr Farid told The Daily Star yesterday.

Due to the delay in filling up central oxygen tanks in at least three hospitals of Satkhira, Faridpur and Dhaka,

in Covid hospitals has more than doubled in all divisions in the past one month from June 14, according to the dashboard data of the Management Information System (MIS) unit of the health directorate.

In over one month till yesterday, Mymensingh division recorded the highest increase in overall bed occupancy rate -- from 22 percent to 111 percent -- followed by Rajshahi -from 71 percent to 89 percent.

Meanwhile, Dhaka division saw a rise from 26 to 74 percent, Barishal from 26 to 67 percent, Khulna from 55 to 85 percent, Chattogram from 37 to 68 percent, Rangpur from 41 to 49 percent, and Sylhet from 28 to 65 The overall bed occupancy curve has

been showing an upward trend in the past several days in Sylhet, Rajshahi, Khulna, and Dhaka divisions while in other divisions, it is very high despite a bit of a downward trend.

The curves for ICU, HDU and HFNC beds, however, have been showing an upward trend in all divisions meanwhile.

As of yesterday noon, at least 16 Covid-dedicated hospitals were treating extra patients against their capacity, according to DGHS data. WHAT EXPERTS SAY

Experts said this trend may continue till the end of this month.

Prof Ridwanur Rahman, an infectious disease specialist, told this newspaper Tuesday, "The situation is grimmer than what it was in April. If there was easy transportation, the remaining high care hospital beds would have been occupied already. As the lockdown has been eased ahead of the Eid, the situation will deteriorate further.'

He suggested imposing curfewlike restrictions as the hospital bed occupancy has surpassed 70 percent. 'Otherwise, the health care system will break down soon."

Dr Mushtuq Hussain, consultant of the Institute of Epidemiology, Disease Control and Research (IEDCR), told The Daily Star on Sunday, "Despite the ongoing lockdown, the transmission has not decreased yet. So the pressure on the hospitals will also increase."

He feared that the transmission will intensify in the cities when people will travel to their home districts for Eid-ul-Azha, which will be celebrated on July 21.

unnamed persons.

Md Nur Alam, officer-in-charge (OC) of the station, said, "We've arrested two, including the prime accused, in connection with the attack. We're investigating the matter."

The OC said that SI Shah Ali was still at hospital as of yesterday.

Meanwhile, Arindam's brother, lawyer Amitabh Chowdhury Rahul, claimed that the arrest was a vindictive act of the sub-inspector centring a communal incident.

Maulana Mamunul Haque, who was the joint general secretary of the Hefajat committee dissolved in May, went to a resort in Narayanganj on April 3 with someone he claimed to be his second wife.

An audio recording of a conversation with the woman was leaked on Ekattor TV the following day, and Arindam shared the audio on his Facebook account, Amitabh said.

In the ensuing days, locals had threatened attacks on their village and on Arindam unless he publicly apologised for sharing the recording, Amitabh said.

On April 10, Amitabh filed a general diary (GD) with the Shalla Police Station, mentioning the names of 13 people who had issued the threats.

These threats came within a month of the communal attack in Noagaon of the same upazila on March 17, over a Facebook post criticising Hefajat.

Talking to The Daily Star on Tuesday, Amitabh said, "After we filed the GD, the police put pressure on my brother instead of taking action against the intimidators. SI Shah Ali told my brother that it was not right to share such a post and that he should have thought about the arrest of Jhumon Das Äpon in Noagaon.

"SI Shah Ali then spoke of deleting the post and removing the name of Hefajat-e-Islam and issues related to communal attacks the GD.

According to Amitabh, his family then lodged a complaint with the office of Sunamganj Superintendent of Police (SP) Mizanur Rahman about the pressure by Shah Ali.

The circle additional superintendent of police (ASP) investigated the matter, Amitabh said, adding that the family came to know that Shah Ali was served a show-cause notice.

"Shah Ali was furious with my brother when we lodged the complaint with the SP ... we have reasons to believe that this is the main reason behind the arrest of my brother by framing the false charge of assaulting the sub-inspector," he added.

He also alleged that Arindam was tortured in police custody after his

arrest.
"We will file a complaint in court after he is produced before it today.'

Contacted, Sunamganj SP Mizanui Rahman said, "The general diary and the subsequent complaint against the SI [Shah Ali] was settled as we instructed the SI not to pressurise the plaintiff to change the general diary, and to investigate properly and send a report in this matter.

The SI later investigated the matter and informed that the accused were staying outside the country. The matter remains in that place," the SP said. 'Most of the time the plaintiff doesn't

feel happy about the police's work. "However, it cannot be said with certainty that he is now being charged in connection with the attack. The matter is subject to investigation and

we will take it seriously," he said. Regarding torture of Arindam in custody, the SP said, "If torture has aken place in police custody, it is definitely a serious crime. 

Bangladesh Railway (BR) signed an agreement with United Enterprise and Company Limited for a PPP project worth Tk 400 crore on March 18, 2020, under which the latter would build a medical college, a 500bed hospital and a nursing institute, said sources in BR, east zone.

Although protesters said the project would have an adverse impact on the environment due to felling a number of century-old trees, BR officials said the environment will not be affected, claiming that none of the trees would have to be cut down

HC slams business orgs' nonchalance

The High Court yesterday came down hard on business organisations, including the Federation of Bangladesh Chamber of Commerce and Industries, for not playing an effective role over the fire at a food processing factory in Narayanganj's Rupganj, that killed 52 people and

"A number of workers have been burnt to death and sustained injuries. But, business organisations including FBCCI have not even expressed any condolence. Any statement of their expressing shock was not found as if they have no responsibility. No representative from the business organisations was found to visit the spot and victims. They are found busy collecting stimulus facilities and bank loan remissions from the government," the HC bench of Justice M Enayetur Rahim said.

The bench said this while hearing an application filed by four rights organisations seeking its order on the authorities concerned to pay due salaries and Eid-ul-Azha bonus to workers of Hashem Food and Beverage factory at Narayanganj's Rupganj that was ravaged by a fire on July 8.

Justice Enayetur Rahim said, "I personally try to follow newspapers regularly. But unfortunately, I did not find business organisations playing their due roles in connection with the incident of fire. They need to oversee the weakness and deficiencies of the factories.

"A change has been brought in the readymade garments sector under the pressure from foreigners. Their positive role is not found until pressure is created on them."

"It should be looked into whether the supervising agencies carry out their responsibilities properly. I saw in a newspaper that factory inspectors go to inspect factories and come back with envelops. Human rights organisations have scope to work in these places," the HC judge

Fake pesticide, fertiliser worth Tk 150cr seized from Keraniganj factory

It used packaging of top brands to dupe farmers AKLAKUR RAHMAN AKASH, Savar _____ authorities decided to conduct a mobile

In a two-day mobile court drive, court drive. authorities unearthed a fake fertiliser and pesticide factory at Dhaka's Keraniganj upazila, and seized counterfeit products worth Tk 150 crore.

A joint team of local administration, Department of Agricultural Extension and Bangladesh Crop Protection Association conducted the drive at Meghna Fertilizers Co Ltd.

Huge quantities of fertilisers and pesticides, with packaging emulating top brands, were destroyed after being seized.

The drive -- led by Iqbal Hasan, executive magistrate and assistant commissioner (land) in Keraniganj -- began on Tuesday morning and continued till yesterday evening at the factory set up on around 2.5 acres of land in Alipur area.

Iqbal yesterday told The Daily Star that acting on a tip-off that the factory has been producing substandard products,

"When we came to the factory on Tuesday morning, we found it locked from outside. Later, we entered by breaking the lock and found huge quantities of fertilisers and pesticides with packaging of top brands in the factory's five warehouses," he said.

The factory produced such products using soil and kerosene oil, and sold them in the market using packaging of companies like BADC and Syngenta, said the executive magistrate.

"We did not find any factory authorities during the drive, but we came to know that the owner's name is Saidur Rahman Khan. He set up the factory and has been making fake products like this since 2017," said Iqbal.

Outgoing migrants to get Moderna jabs

Stock of Pfizer vaccine being held back for second shot; workers protest at inoculation centre in capital

Several hundred expatriate migrant workers -- mostly from Saudi Arabia -- yesterday demonstrated for a few hours at the vaccination centre at Shaheed Suhrawardy Medical College Hospital (SSMCH), demanding they be adminstered the Pfizer vaccine.

The expatriates who went to the centre yesterday morning started chanting slogans when authorities stopped providing the Pfizer vaccine.

Though the authorities offered them to take Moderna vaccine, they refused it, saying they were registered for the Pfizer

vaccine and Saudi Arabian authorities will not allow them into the country with other vaccines, said some expatriates.

However, they again started taking the Moderna vaccine after around two hours, when authorities showed them documents from the Bangladesh consulate in Saudi Arabia. The documents said expatriates with four vaccines -- Pfizer, Oxford-AstraZeneca, Moderna, and Johnson &

The letter also read as per the direction of Saudi General Authority of Civil Aviation (GACA), anyone who has not taken one of

Johnson are eligible to enter Saudi Arabia.

It said police stopped a motorcycle carrying three people at a check-post in the area on Friday. As Foysol failed to show his driving licence and bike registration documents, police seized the vehicle and lodged a case against him for not having the licence and documents, carrying two pillion passengers and riding the bike without wearing a helmet.

After an argument with the traffic sergeant, Foysol went live on Facebook and said police were harassing an "on-duty journalist". On July 11, a case was filed, accusing Foysol.

Earlier on July 11, the four rights organisations moved a writ petition before the HC bench of Justice Enayetur Rahim seeking necessary directives on the authorities concerned to give each deceased's family Tk 1 crore and injured victim Tk 35 lakh as compensation.

They also prayed to the court for an order for conducting inquiry into the incident and to prosecute and punish those who are responsible for the fire. The organisations are -- Ain o Salish Kendra, Bangladesh Legal Aid and Services Trust, Bangladesh Environmental Lawyers Association, and Safety and Rights Society.

On that day, the bench refused to pass any order over the compensation as the victims' bodies could not be identified. The court, however, ordered the authorities concerned to publish a list of the injured to ensure their proper treatment.

BNWLA President advocate Salma Ali expressed concerns over the death of women and child workers in Hashem Food's Rupganj factory and urged the government to safeguard children from

"It is impossible to ensure the protection of children without strict enforcement and monitoring of the law," she said.

"A good number of Public Interest Litigations (PIL) were filed for similar incidences before, but none of them have received any verdict," she added.

Foundation Bangladesh Labour general secretary ZM Kamrun Anam also joined the conference, and talked about the irregularities that were found in the Rupganj factory. "Officials from the Department of

Inspection for Factories and Establishments must be included in the case, because if they had inspected the factory thoroughly and reported accordingly the deaths could have been prevented," he said.

ZM Kamrul Anam also demanded compensation for the workers in accordance with the ILO convention c121 (Employment Injury Benefits Convention,

In her speech, BNWLA general secretary advocate Jobaida Parveen said it requires approval from 27 departments to establish a factory. How the Rupganj factory managed to get the approvals despite having safety flaws is a matter of concern, she said.

AKM Masud Ali, executive director of INCIDIN Bangladesh said eliminating child labour is not the responsibility of the Ministry of Labour and Employment alone. It also requires the co-ordination of other ministries, such as the Ministry of Social Welfare, Ministry of Women and Children Affairs.

Lima Ferdous, president of Street Women and Children Care emphasised that a group of unscrupulous factory owners have been appointing children into hazardous labour, taking advantage of their poverty and helplessness to make

She asked for special attention to miscreants who provide fake age certificates to work-seeking children and asked the government to bring them under the purview of law and give exemplary punishment.

The committee will look into possible causes of the fire and will prepare a list of dead and injured workers including those missing after the fire. It will also assess structural flaws of the building and working environment of the factory, the press release further said.

The committee will also analyse whether factory authorities abided by the labour law requirements, including recruitment working hours, working days, and payment of wages, as well as the liability of factory owners and authorities so that key figures behind the incident could be identified and held accountable.

Sayeduzzaman, chairperson of Bangladesh Crop Protection Association, who was present during the drive, told The Daily Star that for a long time, they were getting complaints of products of top brands not working properly. "We started monitoring the market, conducted an investigation, tracked the factory's location, and informed higher authorities of Department of Agricultural Extension as well as the local administration."

Fertilisers and pesticides are in high demand in the market, so the fake products caused extensive damage to the country's farmers, said Sayeduzzaman, adding that strict action must be taken against the factory's owners.

Mizanur Rahman Khan, vice president of Bangladesh Crop Protection Association, claimed that the owner of the factory's land was a Deputy Inspector General-ranked police official, and Saidur used to run the establishment under his patronage.

He also claimed that two such drives were earlier conducted at the factory and legal steps were taken against Saidur, but he evaded the law.

This correspondent also talked to several locals, but they were reluctant to speak about the factory. They, however, assured that the land owner is a high-ranking police official.

The Daily Star, however, could not independently verify the claims. Contacted about it over phone last

evening, Keranigani Model Police Station officer-in-charge refused to discuss it over phone and asked this correspondent to visit the police station.

Anwar Hossain, chairman of Hazratpur Union Parishad under which the land falls, also said the high-ranked police official was the owner of the land, and that the factory owner did not take any trade license from him, as they were supposed to. "People like them do not need such documents," he said in a resigned tone when contacted.

This newspaper could not reach Saidur despite several phone calls.

Usually, the local agriculture office is supposed to monitor such factories, but the establishment has been running for four years right under the office's nose.

Shahidul Amin, upazila agriculture officer of Keraniganj, who was present at the spot, said, "We had come to visit the factory a month back but found it empty. During lockdown, the factory produced huge quantities of fake fertilisers and

He said no one should come to the vaccination centres without a confirmation SMS.

Expatriate workers started receiving Pfizer and Sinopharm vaccines from July 8.

The government has been administering Covid-19 vaccines to migrant workers at seven centres in Dhaka as well as districts and upazilas across the country on a priority basis.

Senior Assistant Secretary of ministry of Expatriates' Welfare and Overseas Employment Sarwoer Alam said expatriates will have to go to the Saudi Arabia completing two doses of the vaccine.

Archaeological site harmed to make homes

Wall of king Dharmapal's fort damaged

EAM ASADUZZAMAN, Nilphamari

It was once part of the capital of the powerful Pala dynasty which ruled Bengal up till the 12th century. The earthen wall protecting the fort from invaders still stands in presentday Dharmapalagarh village of Nilphamari's Jaldhaka upazila.

The top of this wall has now been leveled and the land used to build multiple government housing projects for the poor over the years, despite the land being declared a reserved archaeological site 35 years ago.

The houses stand on the partially leveled wall and the raised land, so high that the jute fields beside them look quite short in comparison.

During a recent visit to the area, this correspondent observed that residents of the housing projects are also indiscriminately digging on the raised land to plant crops, posing further threat to the wall, raising concern among historians and villagers.

schoolteacher prominent local 75-year-old Khitish Chandra Roy said, "There was a 50-60 feet tall earthen wall stretching several kilometres surrounding the Pala-era capital. It was difficult even

for vigorous youths to climb."

Several other villagers expressed frustration saying that the site brought honour to their village and its damage

Dharmapalagarh, declared reserved by the Department of Archaeology in 1987, is one of 524 such sites in the

In an excavation drive in Dharmapalagarh in 2016, the archaeology department unearthed a Buddhist temple along with other structures believed to be built in the 12th century -- only 50 metres away from the historical wall where the housing projects are situated.

Dharmapalagarh Union Parishad Chairman Zaminur Rahman said, "Two housing projects under Guchhagram and Ashrayan comprising a total 110 houses meant for the poor were built at Dharmapalagarh in 2019 and 2020." These were both implemented during his term as chairman.

The Ashrayan-2 project was started by the Prime Minister's Office to provide free housing to homeless and landless people across the country on the occasion of Mujib Borsho last year.

The Guchhagram-2 phase project,

started by the land ministry in 2015, Academy, Zahangir Alam Sarkar said, aims to rehabilitate landless poor affected by climate change, river erosion, and other natural disasters.

Before these, an earlier housing project of 40 houses had been implemented there in 2003, informed the UP chairman.

Historian and author of "History of Nilphamari" published by Bangla

"It is an act of utter callousness as the authorities, instead of protecting the reserved archaeological site, damaged it.

"I urge the department concerned to repair the damage and protect the remaining part [of the wall]."

However, far from taking measures, the authorities concerned seem to have no idea of the state of the reserved

archaeological site.

Nahid Sultana, regional director of the archaeology department, said, "I've asked the custodian of the Rangpur museum to visit the reserved site at Dharmapalagarh and submit a report mentioning the present situation as it is difficult to conduct monitoring during

Nilphamari Deputy Commissioner

Hafizur Rahman Chowdhury said the department was yet to bring the matter to his knowledge.

"The site is now under the authority of the archaeology department and whenever they seek cooperation, we will render it," he said.

With regard to the historical and archaeological significance of the land, past Member of Parliament from the Nilphamari-3 constituency Golam Mostofa, said, "In the 10th Jatiya Sangsad session, I had requested the government to launch an extensive drive to find out the glorious past of the Pala dynasty at Dharmapalagarh.'

They should work to protect the site, he added.

Assistant custodian of Rangpur Museum SM Hasanat quoted from widely accepted history book, Bangladesher Protno Sampad' (archaeological assets of Bangladesh) to put emphasis on the archaeological importance of the area.

He said king Dharmapal, son of Horshopal of Kamrup empire, conquered a good part of northern Bengal and built a fort at Gar Dharmapal village, named after him 900 years ago.

Man to be free after 17 years in jail

overturning the High Court judgement that confirmed his death sentence.

The apex court bench did not disclose the names of the judges who did not want him to be acquitted. Nargis' father Ibrahim Dewan filed the murder case with Kaliganj Police Station but he did not mention any name in the case.

He filed an appeal with the High Court challenging the trial court's verdict. After hearing his appeal and examining the death reference (trial court documents), the HC on February 25, 2018, upheld the death penalty of Awal.

Biden decries Republicans' attacks on voting rights

President Joe Biden on Tuesday called it a "national imperative" to pass sweeping voting rights legislation that has stalled in Congress and attacked Republicans for their opposition. At least 17 states this year have enacted laws that restrict voting access, with more being considered. Critics say these restrictions are aimed at Black, Hispanic and younger voters. Many Republicans have justified new restrictions as a means to combat voter fraud. In a passionate speech in a city, Biden slammed the widespread voting fraud claims by Donald Trump and some Republicans. Republicans must "stand up, for God's sake," and oppose voting restrictions, Biden said, adding a challenge: "Have you no shame?"

Malaysia cabinet backs PM

Malaysian cabinet ministers yesterday unanimously pledged their support for Muhyiddin Yassin to continue as prime minister, amid a new round of political uncertainty after the premier lost the backing of the country's biggest party. The United Malays National Organisation (UMNO), a key ally in the ruling coalition, withdrew support for Muhyiddin last week and called on him to resign for failing to manage the country's Covid-19 crisis. Parliament is scheduled to hold a five-day special meeting from July 26. Muhyiddin has a slim two-seat parliamentary majority, with UMNO comprising 37 of its 113 lawmakers.

Cuba calm after protests

Cuba has restricted access to social media and messaging platforms including Facebook and WhatsApp, global internet monitoring firm NetBlocks said on Tuesday, in the wake of the biggest anti-government protests in decades. Thousands of Cubans joined demonstrations throughout the Communist-run country on Sunday to protest against a deep economic crisis that has seen shortages of basic goods and power outages. The protests, rare in a country where public dissent is tightly controlled, had largely ended by Sunday evening, as security forces took control of the situation. Activists say at least one person died and more than 100 people have been arrested.

China furious as blast kills 9 workers in Pakistan

Beijing said nine Chinese workers were among 12 people killed yesterday morning by a bomb attack on a bus in northwestern Pakistan and called for severe punishment, but Islamabad blamed the explosion on a "gas leak". The bus was carrying around 40 Chinese engineers, surveyors and mechanical staff to a hydropower dam construction site in Khyber Pakhtunkhwa province. China's foreign ministry spokesman Zhao Lijian urged Pakistan to "severely punish" those responsible and "earnestly protect" Chinese nationals and projects. Around 28 people were also injured. Pakistan authorities said an investigation was under way.

Taliban back to old ways

Fears grow as insurgents impose harsh Sharia law in newly acquired territories

Days after the Taliban captured a remote district in Afghanistan's north, they issued their first orders in the form of a letter to the local imam.

"It said women can't go to the bazaar without a male companion, and men should not shave their beards,' said Sefatullah, 25, a resident of Kalafgan district.

The Taliban are making huge advances across the country as they capitalise on the final withdrawal of foreign troops -- capturing districts, seizing key border crossings, and encircling provincial capitals.

Taliban claim control of key border crossing with Pakistan UK says may work with Taliban if they join Afghan govt Russia tells Kabul to negotiate with Taliban

Yesterday, the Taliban said they had captured the strategic border crossing of Spin Boldak on the frontier

with Pakistan. The border crossing is one of the most strategically valuable for the Taliban. Kabul claimed the crossing

remained under its control. It provides direct access to Pakistan's Balochistan province -- where the insurgents' top leadership has been based for decades -- along with an unknown number of reserve fighters who regularly enter Afghanistan to help



The crossing also gives the Taliban the opportunity to access Pakistan's commercial capital Karachi and its sprawling port on the Arabian Sea, which is considered a linchpin for Afghanistan's billion-dollar heroin trade that has provided a crucial source of revenue for the Taliban's war chest over the years.

In some areas they are again introducing the harsh interpretation of Islamic rule that earned them notoriety until being overthrown by the US-led invasion that followed the September 11 attacks. Last month they took Shir Khan Bandar, a northern

customs post that connected the country to Tajikistan over a US-funded bridge that spanned the Panj river.

"After Shir Khan Bandar fell, the Taliban ordered women not to step out of their homes," said Sajeda, who told AFP she worked in a local factory at the time.

"There were many women and young girls doing embroidery, tailoring and shoe-making... The Taliban's order has now terrified us," she told AFP by phone.

Afghanistan is deeply conservative and some rural pockets of the country adhere to similar rules even without Taliban oversight -- but the insurgents have tried to impose these edicts even in more modern centres.

A statement purporting to come from the Taliban circulated on social media this week ordered villagers to marry off their daughters and widows to the movement's foot soldiers.

Taliban said they didn't issue such notice. But people in areas insist there is truth to the social media buzz. They also said Taliban have ordered all girls above sixth grades to stop going to schools.

In another sign Western governments were rapidly reassessing their Afghanistan policies,

British Defence Secretary Ben Wallace said the United Kingdom was prepared to work with the Taliban if it enters into a power-sharing government.

"Whatever the government of the day is, provided adheres to certain international norms, the UK Government will engage with it," he told the Daily

Meanwhile, Zamir Kabulov, President Vladimir Putin's special representative on Afghanistan, yesterday accused the Afghan government of hypocrisy and said it needed to start proper negotiations with the Taliban about the country's future before it was too late.

Rohingyas skeptical

A shadow government is breaking taboos in Buddhist-majority Myanmar by welcoming Rohingya into its antijunta coalition, but many in the longpersecuted Muslim minority are wary after living through decades of discrimination and deadly violence. Myanmar has been in turmoil since

US urges Asean

About 100 opponents of military rule in Myanmar marched through the centre of its biggest city of Yangon yesterday, as the United States called on Southeast Asian nations to take action to restore democracy and end violence in their neighbour.

Myanmar has been in turmoil since the military overthrew the elected government of Aung San Suu Kyi on Feb. 1, but street protests have become rarer after they were suppressed by the army with the killing hundreds of people.

During a virtual meeting with members of the Association of Southeast Asian Nations (Asean), US Secretary of State Antony Blinken urged its members to take joint action to help end violence, restore a democratic transition and release those "unjustly detained" in Myanmar, State Department spokesperson Ned Price

Blinken also urged Asean, which includes Myanmar, to hold the military accountable on what Asean called a fivepoint peace consensus, agreed in April, with Myanmar's military ruler.

Myanmar's security forces have killed more than 900 people since the coup and detained thousands, according to the Assistance Association for Political Prisoners, an activist group. The junta has previously disputed the death toll and said the army had also suffered casualties.

BOOK REVIEW: POETRY

A perennial philosophy: Amitav Ghosh's 'Jungle Nama'


Amitav Ghosh's passionate engagement with the Sundarbans has brought out his best as a socially conscious fashioner of narrative in The Hungry Tide (HarperCollins, 2004) and Gun Island (John Murray, 2019); enriched his intervention in the discourse on ecology, The Great Derangement: Climate Change and the Unthinkable (Penguin, 2016); and perhaps most felicitously, has brought to light the poet hiding behind his voluminous prose.

Ghosh's Jungle Nama (HarperCollins India, 2021) is a verse retelling of the core story of the central cultic folk narrative of the Sundarbans, the Bon Bibi Johuranama, available in two late 19th century versions, one by Munshi Muhammad Khatir, the other by Abdur Rahim Sahib. It is intertextually related to the 17th century Raymangal of Krishnaram. Raymangal introduces the tiger god Dokkhin Rai (King of the South), who is defeated by and makes peace with Gazi Khan and Gazi Kalu, agreeing to share human homage with them. This syncretism is incorporated into the Bon Bibi cult, a unique example amidst clashing fundamentalisms of interfaith solidarity in a shared, inhospitable environment.

Ghosh picks up the narrative at the point where Bon Bibi and her twin brother Shah Jongoli arrive in the forest and are challenged by Dokkhin Rai. They easily subdue their rival, set strict limits to his forest constituency, and assume guardianship of those who have to venture into it for their livelihood. Hence the practice among woodcutters, honey collectors, and fisherfolk of seeking Bon Bibi's blessings before entering the forest.

The stage is now set for a moving drama. Dhona, etymologically "the Rich One", is greedy for more wealth, unlike his brother Mona ("mon", significantly, means heart), who refuses to accompany him with a fleet of seven ships to ransack forest resources. The crew is one short, and Dhona cajoles a poor relation, Dukhey (literally "the Sad-Lad"), a widow's only child, to sign up. Having entered Dokkhin Rai's realm without going through propitiatory rites, they are utterly in his power, subject to fantasmagoric experiences, until Dhona strikes a deal with the tiger god: for shiploads of valuable wax he must leave Dukhev behind to be devoured.

Just in time Dukhey recalls his mother's advice to appeal to Bon Bibi in the verse form of the Johur Nama, for meter and rhyme lend magical power to words. Once more Dokkhin Rai is humbled by Bon Bibi and Shah Jongoli, and is forced to yield enormous riches to his intended victim. Dukhey returns home to find his mother prostrated by grief. Calling her in the magical verse form revives her, and the joy of reunited mother and son is followed by his



happy wedding.

In an Afterword, Ghosh underscores the significance of the tale in the age of climate change. Bon Bibi propagates a perennial philosophy that humankind would do well to

The most remarkable achievement of Ghosh's narrative is the verse he has fashioned as the equivalent of the quantitative meter of the original, the "poyar", defined as rhyming couplets with 14 units in each line, and a marked caesura after the eighth unit. These units ("matra") aren't simply syllables, for an "open" syllable like "Rai" will count as one unit; a "closed" syllable like "Bon" as two.

Ghosh has couplets of 12-syllable lines that do not conform to any of the accentual meters of English verse. In fact, read with "normal" English intonation, they sound like rhymed prose-quite dull-but belted out like rap, they work beautifully.

This prosodic innovation is characteristic of the "New Englishes", whose speakers outnumber native speakers five to one. David Crystal in his Youtube video "The Future of Englishes", explains that English has traditionally used "stress-timed rhythm", as in iambic verse, while the "New Englishes" follow "syllable-timed rhythm", as in rap. These syllabic rhythms are akin to the Bangla poyar. I recall the great Bengali folk singer Shah Abdul Karim declaring in an interview that rap or hip hop was nothing new, and was akin to our folk poetry, which he recited by way of illustration.

A discussion of this attractively produced book will be incomplete without an admiring mention of the artist Salman Toor, whose expressionistic black-and-white pictures have truly illuminated the text.

Revisiting the lost Jewish communities of Baghdad


BOOK REVIEW: GRAPHIC NOVEL

Iraq once boasted one of the world's oldest Jewish communities, encompassing 2,600 years of rich cultural history punctuated with moments of benign tolerance, blatant discrimination, and outright intolerance and persecution. As the cradle of civilisation and a melting pot of different ethnicities and religions, one-third of Baghdad is said to have been Jewish, numbering 150,000 Jews, as recently as the 1950s. Yet there are four Jews remaining in modern day Iraq today. The Iraqi-Jewish diaspora, meanwhile, has gifted us luminaries such as the world renowned advertising executives, the Saatchi brothers; one of Singapore's founding fathers, David Marshall; as well as JFR Jacob, the Indian war hero of Bangladesh's Liberation War who authored Surrender at Dacca: Birth of a Nation (UPL, 1997), descended from Baghdadi-Jewish stock.

testimonials attest to the changing of times from good to bad to worst. The imagery reaches across time periods, but the peculiar and perhaps most engaging aspect of the narrative is that it has no dialogue. Carol Isaacs's masterful graphic novel, The Wolf of Baghdad: Memoir of a Lost Homeland (Myriad, 2020), takes us back to a time in the 20th century when Jews were an intrinsic part of Iraqi society. Its title is based on an Iraqi-Jewish tale that believes in the power of wolves to protect from demons. In fact, as was tradition, the cribs of children had amulets made of wolf teeth fixed to them to sway away

Isaacs taps into the memories of her family and friends who passed on their memories to her. The novel showcases the changes in 20th century Iraq, and with those changes, the Jewish community evolved from tradition to modernity, all the while placing strong emphasis on being both Jewish and Iraqi—two identities which have sadly been appropriated for chauvinistic nationalism. Isaacs recovers this history under the disguise of a black abaya, as was worn by her ancestors, walking in the narrow alleyways of Old Baghdad while evoking a strong sense of nostalgia and deep-rootedness with the land. The market places, mosques, synagogues, and buildings are all shown in thought provoking detail in

The pages are permeated by miniature portraits of the Isaacs and other Jewish families whose that Carol Isaacs is the personification of, was systematically purged of its Jewish composers. Contrary to popular belief, it was the venom of European anti-semitism tinged with narrow-minded Arab nationalism that ended the vibrancy of Jewish life

A British author of Jewish Iraqi descent, Isaacs works as a cartoonist for The New Yorker under the name of The Surreal McCoy, and is an accomplished musician in her own right. She has never been to Iraq and like many refugees, the memories of her homeland linger in the music and stories passed down to her by the generation of yesteryears, the generation which saw the flourishing and destruction of one of the most conspicuously prosperous communities in the Middle East.

As history has always shown, hatred with one minority does not end with one; it amplifies and explodes. As Iraqi Christians and Yazidis flee and the Iraqi Sunni-Shia proxy war continues, the story of the Jews in Iraq remains a vital and important story of remembrance, of the reconciliation of memory and belonging.

Fresh round of relief for pandemichit groups

Authorities must ensure quick and effective disbursement

E applaud the government decision to introduce relief packages worth Tk 3,200 crore to segments of the population who have been dealt a fresh blow by the latest round of lockdown to contain the current wave of Covid-19 in Bangladesh. Of this, Tk 450 crore will specifically target day labourers, transport workers, small traders and shipping workers with cash assistance; Tk 1,500 crore will be used to finance job creation activities in rural areas; and Tk 1,000 crore will provide low-interest loans for paying salaries to workers in the tourism sector. The government has also allocated Tk 100 crore for providing food assistance through the 333 hotline, and Tk 150 crore for operating 813 special open market sale (OMS) centres across the country.

While these are all commendable steps, quick and efficient disbursement is key to ensuring they are actually effective. And in order for them to be effective, there is an obvious need for these initiatives to be informed by data. However, last month, the finance minister dismissed the estimates of all non-government organisations regarding the new poor, and announced that the government will only accept poverty data from the BBS. So where exactly is this data? The Bangladesh Poverty Database has not been completed in more than seven years, and the data collected for it has already been rendered useless. As such, there still exist serious concerns about whether the government packages will actually reach those most affected by the pandemic. We have already seen previous attempts at cash disbursement go awry because of incomplete and incorrect lists of beneficiaries. What steps are the authorities taking to ensure this is not

Similarly, while there is clearly goodwill behind the initiative to ensure food assistance to those calling 333, we have previously witnessed how vulnerable citizens, made newly poor by the pandemic, have been punished for seeking help. The authorities must ensure that this does not happen again and take steps against government representatives engaging in this sort of abuse of power.

While experts have commended the latest round of relief packages, especially in terms of the OMS and a separate initiative to extend assistance to those with vulnerable group feeding cards, they have generally expressed concerns about effective targeting and duplication in beneficiary lists. The authorities must listen to their concerns, and take their recommendations on board if they truly want to help those most affected by the pandemic and the recent lockdowns.

Capital's cattle markets swarmed way ahead of opening date

So why should the govt's enforcement of health guidelines wait?

T is quite disappointing that cattle markets around the capital—which are not set to open before July 17—are already seeing throngs of sellers and potential buyers, most of them not wearing masks, let alone practicing social distancing. Visiting reporters also noted the absence of hand-washing facilities, hand sanitisers, and thermal scanners to check visitors' body temperature prior to entry. If this is to be the scenario in all 20 cattle markets (between the two city corporations) until Eid—and the scenario may well be the same in other cattle markets across the country—we must prepare ourselves for an even grimmer Covid-19 situation after the holidays. Already, the daily death rate is in triple digits, while the number of positive cases crossed 12,000 between Monday and Tuesday.

Meanwhile, sales seem to be going on full swing in these markets, with one trader at the Gabtali market (quoted in our report) having already sold three cows. This market was observed to be at the worst in terms of crowding, with buyers and visitors from outside Dhaka swarming it. Regarding the delay in setting up necessary health facilities, a leaseholder at this market—most likely unfamiliar with the rules of supply-and-demand and citizens' general tendency to not follow health guidelines unless strictly enforced—said they had not expected "people in droves would start to come to the market, for which we could not ensure those". On the other hand, the DNCC mayor and the DSCC chief estate officer said that immediate action (including closing down the market) would be taken if health guidelines are violated, and that the 10 cattle markets under DNCC will each have a monitoring team. One can only guess that these "immediate actions" will be applicable after the official opening date of the cattle markets, since violations are still taking place freely as of now.

We understand the government's desire to appease religious sentiments as well as ensure the livelihood of cattle traders, but if such essential health guidelines are ignored when the markets become even more crowded in the coming days (thanks to the easing of lockdown till July 23), we will have to pay a steep price. Since there seems to be no stopping the buyers, visitors or traders, the least our two city corporations can do is immediately install hand-washing facilities and begin enforcing health guidelines. As mentioned before, buyers and visitors do not just belong to the capital, but those from outside are also coming to these markets to purchase and resell cattle in their own districts. Given our current sky-high rates of daily Covid-19 deaths and infections, our already exhausted health system and still-uncertain vaccine supply, we simply cannot afford such mishandling. It's high time the authorities took stern actions to prevent further spread of the virus.

Why are we seeing so many deaths in the third wave?

HE third wave of the Covid-19 pandemic with the Delta variant has started almost simultaneously in Bangladesh and in the UK. The infection rate is similar in both countries. The viral reproduction rate in the UK is currently 1.43, and in Bangladesh it is 1.42. Although the rate of transmission is similar, there is a stark difference in the number of fatalities. Bangladesh is witnessing a record high number of deaths in the third wave of the pandemic

In the UK, since the beginning of the third wave, five lakh and sixty thousand people have been infected; of them, around six hundred died with the lowest death rate of 0.10 percent. In Bangladesh, in that time, one lakh and eighty-seven thousand people have been infected; of them, three thousand and one hundred people died with a death rate of 1.7 percent. As such, the death rate in Bangladesh is currently 17 times higher than in the UK.

Before the beginning of its mass vaccination programme in December, the Covid mortality rate in the UK was 3 percent. To date, 67 percent of the population of the country have got one shot of vaccine and 50 percent got two shots. Some 85 percent of the country's adult population have now developed antibodies against coronavirus through natural infections and vaccines. Consequently, the death rate has dropped dramatically from 3 percent to 0.10 percent, meaning that vaccination has reduced fatality by 30 times.

The pandemic scenario of Bangladesh is quite the opposite. Both infections and deaths are increasing rapidly. To date, 3.5 percent of the country's population have received one dose of vaccine and only 2.7 percent got two doses. Currently, the government has 56 lakh shots in its stock, which are sufficient for 28 lakh people. But Bangladesh needs 20 crores of additional shots to fully inoculate the country's 70 percent of population.

A little over one crore shots have been delivered across the country in the last four months. If the vaccination programme continues at this pace, it will take six and a half years to reach the target! Apparently, the speed of vaccination must be increased manifold. If 5 lakh shots are delivered every day, it will take until December next year to reach the goal of national Covid-19 immunisation set by the government.

India, meanwhile, is eight and a half times larger than Bangladesh in terms of

population. But the country managed to vaccinate 22 percent of its population with one dose and 5 percent with two full doses within a short time. When Bangladesh is giving only a few thousand doses every day, India is giving 30 to 35 lakh doses daily. To date, India delivered 37 crores of vaccine shots.

A recent country-wide serosurveillance conducted by the World Health Organization revealed that 67 percent of adults in India developed antibodies against coronavirus. Amongst them, 79 percent people were from urban areas, and 63 percent from rural areas. They also found that the vaccinated people had 80 percent less chance of hospitalisation. It is a relief for India that a large portion of its population has developed immunity against Covid. This mass immunity will reduce mortality in the forthcoming pandemic wave in India which is going to occur in a few months.

What is the seroprevalence status of our country? Do we know how many people in the urban and rural areas have developed immunity against Covid? An accurate answer is absent as there hasn't been any nation-wide serosurveillance conducted in our country to date. A vital piece of information is missing—one that is required for successful immunisation.

Vaccines save lives. In fact, mass vaccination has saved an estimated 27 thousand lives in England so far. If the elderly and those in the high-risk group in Bangladesh had been vaccinated on a priority basis in the last four months, the death toll from the third wave could have been greatly reduced.

Bangladesh must procure enough vaccines and speed up its mass vaccination drive. Currently, our vaccination drive is going on at a snail's pace. Vaccination at a slower rate reduces its ability to control the epidemic. If India can jab 35 lakh people every day, why can't we give at least 5 lakh doses daily?

The lack of essential healthcare services can also be attributed to higher deaths in the third wave. The last two waves were mainly Dhaka-centric. But the current wave

is affecting mostly the border districts, where lack of high-flow nasal cannula, oxygen supply and ICU facilities are evident. If the necessary actions were taken promptly, many lives could have been

Moving forward, the government must take the following actions immediately to reduce further deaths from the forthcoming waves: (1) Accelerate the mass vaccination programme and inoculate 3-5 lakh people per day (vaccine should be offered first on a priority basis to all people in their sixties and high-risk groups; (2) Covid treatment facilities across the country must be increased by three folds; and (3) Countrywide serosurveillance should be conducted to assess the immunity status of the nation.

It is unfair to compare Bangladesh with a country like the UK. But isn't it true that we are also way behind India—with which we share many socioeconomic similarities—in terms of the above three points in managing the pandemic?

Only 'We, the People' can unleash the full potential of RTI law

ANGLADESH has long been known for the political activism of its citizens, ready to fight for their rights and defend their freedom. The creation of the country in 1971 is a testimony to that. Now—in an age when institutions of representative governance are in fast decline both globally and locally—is the time for us to seize what the Right to Information (RTI) Act 2009 offers as an alternative to continue that tradition.

Our first job is to convince the upper echelons of our society, who have largely ignored the law so far, that without their participation its full potential will remain untapped. Since its adoption 12 years ago, the law has been kept alive mainly by ordinary citizens. With the help of RTI enthusiasts and some committed NGOs, they have demonstrated, however sparsely, the power of the law to initiate positive change in governance. To go beyond and make higher gains, we need the participation and leadership of people who are more knowledgeable about the inner workings of the government and better equipped to understand the intricacies of the law and its use.

RTI law is globally acknowledged as the most effective instrument to promote participatory democracy, where people feel that they are no longer the "ruled" but the "rulers". While it takes time to dismantle a deep-rooted culture of secretive and opaque governance, experience of other countries shows that it can be done. Hurdles faced in implementing the law can be ironed out over time.

To speed our progress, "We, the people" must rally together and spread the message about the power and promise of RTI law more vigorously. Here is how.

First, remember that the RTI Act is fundamentally different from all other laws because only citizens can initiate its use, not the government. While the government is the executor of other laws—which citizens must abide by—in case of the RTI law, citizens are the executor and the government the responder. The roles have reversed. This point cannot be overemphasised.

Next: RTI law is aimed at empowering citizens vis-à-vis public authorities. Its primary objective is to promote participatory democracy. People participate in the governance of the country by seeking relevant information from public authorities, thereby reminding them that their work is being monitored. Their requests help to instil in the minds of

public servants that people are the real owners of state power. The law is well-titled as a *right* to know, not a *need* to know. Citizens do not have to justify their requests to public authorities. There should be no fear, therefore, for the people to use the law. The RTI Act not only recognises their right but also underscores a concurrent responsibility.

The RTI Act states clearly that people's right to information contributes to better governance by promoting transparency and accountability in the work of public authorities, increasing their efficiency, mitigating corruption and advancing good governance. People do so by obtaining relevant information on the work of

records and take certified copies.

A great deal of confusion exists on the definition of public authorities. As a general rule of thumb, the law permits citizens to seek information from all government and other public offices, including NGOs and private entities who benefit from public funds. Even those entities who use no public fund but have a reporting responsibility to the government under any regulatory law are covered indirectly. Private companies are, however, normally outside the purview of the law; but if we ensure strong use of the Act as it is now, there could be a basis for us to seek increase of its scope.

Another important area which

public authorities which provide a basis to assess their work. They can then use the information to seek corrective measures from the government, if necessary.

Through RTI requests, citizens also help to improve the capacity of public officials to deal with their requests, to change their bureaucratic mindset and attitudes, and bring them closer to the people.

As to what kind of information people can seek from the authorities:

any information available with public.

deserves particular care from RTI users is the exemption clause of the RTI Act, which blocks citizens' access to certain types of information. These include information which may prejudicially affect the sovereignty, integrity, security, strategic, scientific or economic interests of the state, its relationship with foreign countries, or incite offence. Some other types of information, including personal information of citizens, are also exempted from disclosure. As many RTI requests are rejected on these grounds, citizens must comprehend the scope of different subsections of Section 7 of the RTI Act and be ready to challenge their misuse.

The law requires RTI requests to be submitted in forms specifically designed for this purpose and available from the

website of the Information Commission. Requests have to be addressed to the Designated Officer (DO) of the authority concerned, whose particulars should be available directly from the authority or its website. To avoid rejections, citizens must address their request to the right person and describe their requests precisely. Requests are often rejected on procedural grounds. Citizens must remain alert to any abuses and lobby for their mitigation.

RTI requests often go unanswered. The law requires applicants to appeal within 15 days after the expiry of a maximum of 30 working days within which the request should have been answered. If the appeal process is not complied with properly, the request simply "dies". The public servant who did not reply to the original request is let off the hook. So, it is up to citizens to ensure that they follow the requirements of the law diligently.

The Information Commission plays the most critical role in the implementation of RTI in the country, inter alia, by resolving disputes between information-seeking citizens and information-providing public officials. The commission's decisions can either encourage or discourage users. Its decisions on whether or not to penalise derelict public officials for not abiding by the law can have a lasting impact on people's faith in it. Its decisions create precedence with long-lasting effects. Many users are dissatisfied with the commission's decisions but cannot afford to have their legality checked by the High Court through writ petitions. It is imperative for citizens' groups to bear these facts in mind if they want to see an effective RTI regime in the country.

The government too can reap important benefits from the RTI law. It is in the government's interest, therefore, to facilitate its operation. Among other things, it can reassure the Information Commission about its neutral and independent role, ensure impartial selection process of the Commissioners, and equally importantly, encourage public officials to abide by the provisions of the law without fear.

However, even if the government maintains a positive attitude towards the law, it is the people who must be its main custodian. They must remember that no government in the world likes to be controlled by their citizens. It is rare for them to go out of the way to boost RTI. Only people can do that.

Meanwhile, sales seem to be going on full swing in these markets, with one trader at the Gabtali market (quoted in our report) having already sold three cows. This market was observed to be at the worst in terms of crowding, with buyers and visitors from outside Dhaka swarming it. Regarding the delay in setting up necessary health facilities, a leaseholder at this market—most likely unfamiliar with the rules of supply-and-demand and citizens' general tendency to not follow health guidelines unless strictly enforced—said they had not expected "people in droves would start to come to the market, for which we could not ensure those". On the other hand, the DNCC mayor and the DSCC chief estate officer said that immediate action (including closing down the market) would be taken if health guidelines are violated, and that the 10 cattle markets under DNCC will each have a monitoring team. One can only guess that these "immediate actions" will be applicable after the official opening date of the cattle markets, since violations are still taking place freely as of now.

We understand the government's desire to appease religious sentiments as well as ensure the livelihood of cattle traders, but if such essential health guidelines are ignored when the markets become even more crowded in the coming days (thanks to the easing of lockdown till July 23), we will have to pay a steep price. Since there seems to be no stopping the buyers, visitors or traders, the least our two city corporations can do is immediately install hand-washing facilities and begin enforcing health guidelines. As mentioned before, buyers and visitors do not just belong to the capital, but those from outside are also coming to these markets to purchase and resell cattle in their own districts. Given our current sky-high rates of daily Covid-19 deaths and infections, our already exhausted health system and still-uncertain vaccine supply, we simply cannot afford such mishandling. It's high time the authorities took stern actions to prevent further spread of the virus.

Why are we seeing so many deaths in the third wave?

THE third wave of the Covid-19 pandemic with the Delta variant has started almost simultaneously in Bangladesh and in the UK. The infection rate is similar in both countries. The viral reproduction rate in the UK is currently 1.43, and in Bangladesh it is 1.42. Although the rate of transmission is similar, there is a stark difference in the number of fatalities. Bangladesh is witnessing a record high number of deaths in the third wave of the pandemic.

In the UK, since the beginning of the third wave, five lakh and sixty thousand people have been infected; of them, around six hundred died with the lowest death rate of 0.10 percent. In Bangladesh, in that time, one lakh and eighty-seven thousand people have been infected; of them, three thousand and one hundred people died with a death rate of 1.7 percent. As such, the death rate in Bangladesh is currently 17 times higher than in the UK.

Before the beginning of its mass vaccination programme in December, the Covid mortality rate in the UK was 3 percent. To date, 67 percent of the population of the country have got one shot of vaccine and 50 percent got two shots. Some 85 percent of the country's adult population have now developed antibodies against coronavirus through natural infections and vaccines. Consequently, the death rate has dropped dramatically from 3 percent to 0.10 percent, meaning that vaccination has reduced fatality by 30 times.

The pandemic scenario of Bangladesh is quite the opposite. Both infections and deaths are increasing rapidly. To date, 3.5 percent of the country's population have received one dose of vaccine and only 2.7 percent got two doses. Currently, the government has 56 lakh shots in its stock, which are sufficient for 28 lakh people. But Bangladesh needs 20 crores of additional shots to fully inoculate the country's 70 percent of population.

A little over one crore shots have been delivered across the country in the last four months. If the vaccination programme continues at this pace, it will take six and a half years to reach the target! Apparently, the speed of vaccination must be increased manifold. If 5 lakh shots are delivered every day, it will take until December next year to reach the goal of national Covid-19 immunisation set by the government.

India, meanwhile, is eight and a half times larger than Bangladesh in terms of

population. But the country managed to vaccinate 22 percent of its population with one dose and 5 percent with two full doses within a short time. When Bangladesh is giving only a few thousand doses every day, India is giving 30 to 35 lakh doses daily. To date, India delivered 37 crores of vaccine shots

A recent country-wide serosurveillance conducted by the World Health Organization revealed that 67 percent of adults in India developed antibodies against coronavirus. Amongst them, 79 percent people were from urban areas, and 63 percent from rural areas. They also found that the vaccinated people had 80 percent less chance of hospitalisation. It is a relief for India that a large portion of its population has developed immunity against Covid. This mass immunity will reduce mortality in the forthcoming pandemic wave in India which is going to occur in a few months.

What is the seroprevalence status of our country? Do we know how many people in the urban and rural areas have developed immunity against Covid? An accurate answer is absent as there hasn't been any nation-wide serosurveillance conducted in our country to date. A vital piece of information is missing—one that is required for successful immunisation.

Vaccines save lives. In fact, mass vaccination has saved an estimated 27 thousand lives in England so far. If the elderly and those in the high-risk group in Bangladesh had been vaccinated on a priority basis in the last four months, the death toll from the third wave could have been greatly reduced.

Bangladesh must procure enough vaccines and speed up its mass vaccination drive. Currently, our vaccination drive is going on at a snail's pace. Vaccination at a slower rate reduces its ability to control the epidemic. If India can jab 35 lakh people every day, why can't we give at least 5 lakh doses daily?

The lack of essential healthcare services can also be attributed to higher deaths in the third wave. The last two waves were mainly Dhaka-centric. But the current wave

is affecting mostly the border districts, where lack of high-flow nasal cannula, oxygen supply and ICU facilities are evident. If the necessary actions were taken promptly, many lives could have been

Moving forward, the government must take the following actions immediately to reduce further deaths from the forthcoming waves: (1) Accelerate the mass vaccination programme and inoculate 3-5 lakh people per day (vaccine should be offered first on a priority basis to all people in their sixties and high-risk groups; (2) Covid treatment facilities across the country must be increased by three folds; and (3) Countrywide serosurveillance should be conducted to assess the immunity status of the nation.

It is unfair to compare Bangladesh with a country like the UK. But isn't it true that we are also way behind India—with which we share many socioeconomic similarities—in terms of the above three points in managing the pandemic?

Only 'We, the People' can unleash the full potential of RTI law

ANGLADESH has long been known for the political activism of its citizens, ready to fight for their rights and defend their freedom. The creation of the country in 1971 is a testimony to that. Now—in an age when institutions of representative governance are in fast decline both globally and locally—is the time for us to seize what the Right to Information (RTI) Act 2009 offers as an alternative to continue that tradition.

Our first job is to convince the upper echelons of our society, who have largely ignored the law so far, that without their participation its full potential will remain untapped. Since its adoption 12 years ago, the law has been kept alive mainly by ordinary citizens. With the help of RTI enthusiasts and some committed NGOs, they have demonstrated, however sparsely, the power of the law to initiate positive change in governance. To go beyond and make higher gains, we need the participation and leadership of people who are more knowledgeable about the inner workings of the government and better equipped to understand the intricacies of the law and its use.

RTI law is globally acknowledged as the most effective instrument to promote participatory democracy, where people feel that they are no longer the "ruled" but the "rulers". While it takes time to dismantle a deep-rooted culture of secretive and opaque governance, experience of other countries shows that it can be done. Hurdles faced in implementing the law can be ironed out over time.

To speed our progress, "We, the people" must rally together and spread the message about the power and promise of RTI law more vigorously. Here is how.

First, remember that the RTI Act is *fundamentally* different from all other laws because only citizens can initiate its use, not the government. While the government is the executor of other laws—which citizens must abide by—in case of the RTI law, citizens are the executor and the government the responder. The roles have reversed. This point cannot be overemphasised.

Next: RTI law is aimed at empowering citizens vis-à-vis public authorities. Its primary objective is to promote participatory democracy. People participate in the governance of the country by seeking relevant information from public authorities, thereby reminding them that their work is being monitored. Their requests help to instil in the minds of

public servants that people are the real owners of state power. The law is well-titled as a *right* to know, not a *need* to know. Citizens do not have to justify their requests to public authorities. There should be no fear, therefore, for the people to use the law. The RTI Act not only recognises their right but also underscores a concurrent responsibility.

The RTI Act states clearly that people's right to information contributes to better governance by promoting transparency and accountability in the work of public authorities, increasing their efficiency, mitigating corruption and advancing good governance. People do so by obtaining relevant information on the work of

documents, memos, e-mails, opinions,

advice, press releases, circulars, orders,

samples, models, data material held in any

electronic form, etc. They are also entitled

to ask for inspection of work, documents,

logbooks, contracts, reports, papers,

records and take certified copies.

A great deal of confusion exists on the definition of public authorities. As a general rule of thumb, the law permits citizens to seek information from all government and other public offices, including NGOs and private entities who benefit from public funds. Even those entities who use no public fund but have a reporting responsibility to the government under any regulatory law are covered indirectly. Private companies are, however, normally outside the purview of the law; but if we ensure strong use of the Act as it is now, there could be a basis for us to seek increase of its scope.

Requests have to be addressed to the Designated Officer (DO) of the authority concerned, whose particulars should be available directly from the authority or its website. To avoid rejections, citizens must address their request to the right person and describe their requests precisely. Requests are often rejected on procedural grounds. Citizens must remain alert to any abuses and lobby for their mitigation.

RTI requests often go unanswered. The law requires applicants to appeal within 15 days after the expiry of a maximum of 30 working days within which the request should have been answered. If the appeal process is not complied with properly, the request simply "dies". The public servant who did not reply to the original request is let off the hook. So, it is up to citizens to ensure that they follow the requirements of the law diligently.

The Information Commission plays the most critical role in the implementation of RTI in the country, inter alia, by resolving disputes between information-seeking citizens and information-providing public officials. The commission's decisions can either encourage or discourage users. Its decisions on whether or not to penalise derelict public officials for not abiding by the law can have a lasting impact on people's faith in it. Its decisions create precedence with long-lasting effects. Many users are dissatisfied with the commission's decisions but cannot afford to have their legality checked by the High Court through writ petitions. It is imperative for citizens' groups to bear these facts in mind if they want to see an effective RTI regime in the country.

The government too can reap important benefits from the RTI law. It is in the government's interest, therefore, to facilitate its operation. Among other things, it can reassure the Information Commission about its neutral and independent role, ensure impartial selection process of the Commissioners, and equally importantly, encourage public officials to abide by the provisions of the law without fear.

However, even if the government maintains a positive attitude towards the law, it is the people who must be its main custodian. They must remember that no government in the world likes to be controlled by their citizens. It is rare for them to go out of the way to boost RTI. Only people can do that.

BSF shoots

Sources at Jamiat told The Daily Star that the party was under pressure from the government to quit the 20-party alliance following the recent government crackdown on Hefajat-e Islam leaders, many of whom are from Jamiat. Quitting the alliance was set as a pre-condition by the government for the release of Jamiat

leaders and activists. Yesterday, Jamiat also demanded the government withdraw all cases filed against its leaders and activists following the countrywide violent protests over Indian Prime Minister Narendra Modi's visit to Bangladesh on March 25.

Meanwhile, BNP standing committee member Nazrul İslam Khan yesterday alleged that Jamiat was forced to quit the 20-party combine following its recent meeting with Home Minister Asaduzzaman Khan.

After holding a meeting with the minister on July 5, top Hefajat leaders demanded the government release its "innocent" leaders and activists arrested across the country since March 25.

The government took a tough stance against Hefajat following its three-day violent activities from March 25 over Modi's trip to Bangladesh. The violence left at least 17 people dead and many injured.

Hefajat, a Qawmi madrasabased platform of different Islamist organisations, has been under huge pressure from the government to restructure its central committee since the March violence, sources said.

At least 154 cases were filed against Hefajat men and around 1,230 people, including more than 50 top Hefajat leaders, were arrested following the violence, according to Police Headquarters data.

After the recent crackdown on Hefajat, some of its leaders started trying to reach an understanding with the government to avoiding "arrest and harassment".

Hefajat's previous central committee was disbanded on April 25.

A number of joint ventures have already been operational here for a long time. We're trying to expand the maritime industry in Bangladesh and seeking similar joint ventures with Bangladeshi entities. Some of our companies are eyeing government contracts for dredging and ship-building.

DS: What challenges do you see from Dutch companies' perspectives?

Harry: Honestly, people don't know much about this country. My motto on our bilateral relationship was: expand, brand and stand! Branding Bangladesh in Europe was what I considered one of my major roles. Regretfully, Bangladesh is in the lower strata of the 190 countries in the World Bank's Ease of Doing Business Index, so low that you almost cannot believe it. If you come in as a foreign company, it takes, a long time to register your company. It can be difficult to repatriate profits. I don't have answers, but I do observe that the government is working hard to change these conditions. Institutions and agencies need to work faster and be more accommodating to foreign trade and investment. I'm happy that branding Bangladesh is being taken up more professionally. With swift reforms to the business climate, better branding will help improve Bangladesh's position in the indexes. inland waterways. Medical tests of the victim were completed yesterday, said Mahfuzur Rahman, officer-in-charge of Gaibandha Sadar Police Station, adding that they were trying to arrest the accused.

S'pore unveils

The prosperous financial hub has turned to setting up plants off its coasts and in reservoirs, and aims to quadruple solar energy production by 2025.

The new farm can produce up to 60 megawatts of electricity, and will lead to carbon emissions reductions equivalent to removing 7,000 cars from roads, according to Sembcorp Industries and national water agency PUB.

Sembcorp built the project, which covers about 45 hectares (110 acres), with backing from the agency.

"Solar energy is plentiful, clean and green, and is key to reducing PUB's and also Singapore's carbon footprint," said the water agency's chief executive Ng Joo Hee.

Singapore has also built a solar farm in the Johor Strait, which separates the island state from Malaysia, as well as plants on land.

The government in February unveiled a "green plan" that included steps such as planting trees, reducing waste sent to landfills and building more charging points to encourage electric car use.

Singapore has pledged to achieve net-zero emissions "as soon as viable" in the second half of the century.

utterly shocked and frustrated hearing this, as we, being the frontliners in Biman, worked relentlessly during the pandemic amidst fear of being infected and infecting our family members ... ," reads the letter.

The Bapa president said in the last one year, 25 pilots were infected. Several pilots are still in hospitals with Covid. Entire families of eight pilots contracted coronavirus.

The Biman administration on Tuesday withdrew the decision to reduce (by 10 percent) the salaries of all officers and employees of Biman, which will come into effect from July.

But cockpit crew (pilots) with 5 years or less in service would get 15 percent pay cut. Those five-10 years in the job would 20 percent cut and those above 10 years a 40 percent pay

Several pilots told The Daily Star that there are examples in Biman that salaries of some officials have increased during the pandemic.

"This is injustice, discriminatory and humiliating," said a senior pilot. The pilots said the authorities did not even bother to discuss before making such a decision.

Asked, Abu Saleh Mostafa Kamal, managing director and CEO of Biman, said the Bapa was yet to inform them about their decision.

A top official in Biman said Bapa cannot make any such decisions as their service has been declared emergency. Wishing anonymity, he added

Madrid president Real Florentino Perez called Ronaldo an Cristiano "imbecile" and Mourinho "abnormal" while

he also said the two had "huge egos" in two audio recordings from 2012 that were leaked on Wednesday.

Both Portuguese stars were at Madrid during Perez's second tenure as club president. Audios of Perez attacking former players Iker Casillas and Raul Gonzalez as the "biggest frauds" in the club's history in an audio recording from 2006 had been leaked 24 hours earlier.

"He is mad," Perez had said of Ronaldo in one of the audios released by El Confidencial. "This chap is an imbecile,

"Do you think this chap is normal? He is not normal, otherwise he wouldn't do the things he does. The last foolish thing he did, everyone around the world saw it.

"Why do you think he does that foolish thing?" It is unclear what Perez was referring to regarding the "foolish thing."

Perez also attacked super agent Jorge Mendes, who represents Mourinho and Ronaldo. "Mendes does not order him, nor does he order Mourinho whatsoever," Perez said. "Zero. Not even for the interviews. These are guys with huge egos, both of them spoiled.

"He and the coach don't see the reality because the two could earn a lot more following a reported rift with Perez over a money if they were different. They are new contract.

for decades to impart bad luck on the opposition. Responding to a question from ESPN, Chiellini responded in Italian: "Hello Christian, I confirm everything! Kiricocho!"

veteran defender shouting the word just prior to Donnarumma's title-winning save on Saka.


Juan Carlos 'Kiricocho', or Quiricocho according to some versions of the story, was a hardcore supporter of Argentinian club Estudiantes de la Plata during the 1980s. The fan even attended some of the club's training sessions, but Estudiantes head coach Carlos Bilardo began to notice that his players mysteriously seemed to get injured whenever Kiricocho was present.

Bilardo, as the legend goes, told Kiricocho to attend training sessions of Estudiantes' rivals, hoping to utilise his powers to help, rather than hurt his side.

"Kiricocho was a kid from La Plata who was always with us, and since that year we were champions [in 1982], we adopted him as our mascot," Bilardo once remarked.

"He was a good kid but then I didn't see him again. The last time I was coaching Estudiantes [in 2003-04] I asked after him and nobody knew anything."

The legend of Kiricocho has since spread throughout the footballing world, with players now routinely using the word when they want to put a curse on their opponents.

'Olympics journey with a new dream'

Participating in the Olympic Games has always been a token one for Bangladesh since its maiden appearance in the Los Angeles Olympic Games in 1984

but the Bangladesh officials this time, are thinking differently ahead of 2020 Tokyo Olympics by tagging a slogan -- Olympics journey with a new dream.

Yet to win any medal from the Olympics so far, Bangladesh had previously participated in all nine editions of Olympics till Rio Olympics with all wild cards entry except one for golfer Siddikur Rahman, who was the first athlete to represent Bangladesh in Olympics with his own capability. And this time around, archer Ruman Sana became the second Bangladeshi athlete to achieve the same feat.

The Bangladesh Olympic Association (BOA) yesterday had a media briefing as three out of six athletes will leave here for Japan tomorrow and BOA is dreaming on the back of those three athletes – shooter Abdullah Hel Baki, archers Ruman and Diya Siddique while swimmers Ariful Islam, Junayna Ahmed and sprinter Jahir Rayhan are scheduled to leave from their respective places on July 19 and 25.

'We are dreamers. Yes, Ruman made all of us dream after qualifying directly for the Olympics. That's what we wrote about the new dream. It is a big dream alright, but we believe in it, even though dreams often doesn't come true," said chef de mission of Bangladesh's 18-member continent and BOA vice president Sheikh Bashar Ahmed at a city hotel yesterday where ITO Naoki, ambassador of Japan in Bangladesh, was present along with other BOA officials.

This time the Olympic Games will be different due to the Covid-19 situation and there will be a lot of restrictions for both athletes and the officials but I guarantee you that we will hold a safe and secured Games with the athletes and officials travelling to Japan without any worries," said Naoki.

Referring to the discussion with Prime Minister Sheikh Hasina, BOA secretary general Syed Shahed Reza said, "Honourable Prime Minister ensured us in providing all types of support for the betterment of the country's sports. She also instructed us to focus on direct participation in the Olympics in future and arrange better training for the



SALARY CUT IN BIMAN

Pilots say they won't do any extra work

Pilots of Biman Bangladesh Airlines have threatened that they would refrain from operating extra flights if the authorities do not withdraw the decision of cutting their salaries by July 30.

"Biman pilots will only 'fly by the book' if their demand is not met by July 30, meaning that they will not do any additional duty to operate flights," Capt Mahbubur Rahman, president of Bapa, told The Daily Star.

"... We are scheduled to fly 75 hours in a month. But many pilots are flying beyond their flying hours to keep Biman afloat,"

If the pilots do not operate aircraft, flights of the airline's most popular destinations, including Abu Dhabi, Doha, Dammam, and Dubai, might have to be cancelled, said sources in Biman.

"We will be forced to stop operation of aircraft if our demand is not realised finally," Capt Mahbubur warned.

"The Executive Committee of Bangladesh Airlines Pilots' Association (Bapa), today [yesterday] decided that if the Biman authorities do not solve the

Military victory the only solution: Tajuddin

ALL-OUT WAR TILL VICTORY The Prime Minister of Bangladesh Tajuddin Ahmed declared today that "military victory is the only solution to the situation in Bangladesh",

reported The People, a pro-AL English-language weekly. It also reported that Awami League members of the National and Provincial Assemblies at a meeting had taken an "oath of all-out

war till victory". The report said 110 members of the National Assembly and 200 members of the Provincial Assembly had attended the meeting, which was held somewhere in Bangladesh.

The oath read: "The enemy shall be engaged not only on land, but also in the air and on the sea if need be, and shall be defeated once and for all to safeguard the independence of the people of Bangladesh."

The meeting decided to rename the Mukti Fauj (liberation army) as "Mukti Bahini" (liberation forces) signifying the "advent of the air force and the navy".

The Mukti Fauj now has over 1,20,000 men, comprising about 40,000 troops of the East Bengal Regiment, East Pakistan Rifles and about 80,000 volunteers. The Fauj was led by a large number of Bangalee officers of the Pakistan army who had defected and joined the freedom fighters.

Rohingya man beaten to death

A Rohingya man was beaten to death at Noyapara refugee camp in Teknaf upazila early yesterday over longstanding enmity with his rivals.

The dead, Mohammad Shaker, 45, was a resident of the refugee camp.

Sources at the camp said Shaker, who was educated in a madrasa, used to work as a police source at the cami He had a dispute with robber Jakir, who was killed in a "gunfight" with law enforcers a few months ago. He lived outside the camp for about one and a half years due to threat on his life.

Shaker returned to the camp after Jakir's death and started a small grocery store. Early yesterday, associates of Jakir swooped on Shaker at the store and beat him to death, the sources told The Daily Star.

Death toll in S Africa now 72

Citizens arm themselves as crowds rampage; over 1,200 arrested

South African President Cyril Ramaphosa said yesterday he might order more troops onto the streets as the army and police struggled to quell days of looting and violence that has claimed 72 lives.

Some citizens armed themselves to protect their property and businesses from the rampage, the worst in South Africa for years. Food and fuel supplies are running Triggered by the jailing of ex-president Jacob Zuma last

week after he failed to appear at a corruption inquiry, its has widened into an orgy of looting and an outpouring of anger over the hardship and inequality that persist in South Africa 27 years after the end of apartheid. Shopping malls and warehouses have been ransacked

or set ablaze in several cities, mostly in Zuma's home in KwaZulu-Natal province, especially the Indian Ocean port city of Durban, and the financial and economic centre Johannesburg and surrounding Gauteng province. Soldiers have been deployed to help outnumbered

police contain the unrest. Security forces say they have arrested more than 1,200 rioters, but the government has held back from imposing a state of emergency.

Ramaphosa met with leaders of political yesterday to discuss ways to address the unrest.

"President Ramaphosa welcomed proposals made by political leaders and said expanded deployment of the South African National Defence Force was being addressed," a government statement said.
