# Irregularities widespread in 3 hospitals

## Finds DGHS probe body in Uttara

### STAFF CORRESPONDENT

The health directorate inspected three hospitals in the capital's Uttara and found widespread irregularities, including treating Covid-19 patients without permission and that too with insufficient equipment and shortage of trained doctors and nurses.

The hospitals inspected on Saturday by a committee of the Directorate General of Health Services (DGHS) are Shin Shin Japan Hospital, Uttara Al-Ashraf General Hospital and Radical Hospital.

The five-member committee submitted its report to the director general of DGHS on Sunday.

Shin Shin Japan Hospital came under the scanner after the death of Sabuj Peris, 35, and his family's allegation that he was beaten indiscriminately and left without treatment at the hospital for hours

Sabuj had been admitted to the facility on July 18 with breathing difficulties. He died on July 26 while undergoing treatment at United Hospital, where he was transferred following the incident three days earlier.

The DGHS committee investigated the three hospitals after the incident came to light.

The three hospitals were overcharging patients for Covid-19 treatment despite insufficient central oxygen supply, ventilators, high-flow nasal cannulas and shortage of trained doctors and nurses, the report said.

During treatment, many Covid patients died at the SEE PAGE 10 COL 3

## Muhith still has breathing difficulties

Former finance minister AMA Muhith has breathing problems, seven days after being diagnosed with Covid-19.

"He [Muhith] lost weight and does not want to eat. He still has difficulty breathing," Foreign Minister AK Abdul Momen, younger brother of Muhith, told reporters at the State Guesthouse Padma yesterday.

He said on Sunday night Muhith, 87, slept well unlike the previous night when had not eaten or slept well and thus became weak.

Muhith is undergoing treatment at the Combined Military Hospital in the city where he was admitted last week. All his family members, including his wife, son and two house helps, were also infected.

Most of the time he is made to sleep with medication. "We are hopeful he will recover," he SEE PAGE 10 COL 6

# TALIBAN OFFENSIVES 'Abrupt' US pullout to blame

Says Afghan president; Commandos deployed

President Ashraf Ghani yesterday blamed Afghanistan's fast-deteriorating security situation on a "sudden" decision by the United States to withdraw its troops, but said his government had a plan to bring conditions under control within six months.

Taliban insurgents have moved in on three provincial capitals in the last few days, amid rapid advances nationwide since Washington said it planned a complete withdrawal of troops by September.

"The current situation is due to a sudden decision on the withdrawal of the international troops," Ghani told the Afghan parliament in a speech.

"We have had an unexpected situation in the last three months.

However, the Afghan government had a security plan to bring the situation under control within six months, he added, and the United States supported the plan.

The Taliban would not move towards peace unless the worsening security situation was curbed, Ghani said.

Peace talks between the Afghan government and Taliban negotiators started last year in the Qatari capital of Doha, but have not made any substantive progress despite a few rounds, reports Reuters.

The two sides committed to speeding up the talks, however, at a recent meeting in Doha between a high-level Afghan political delegation and the Taliban.

Ghani said the militants had not severed ties with terrorist groups, and had stepped up attacks on women SEE PAGE 10 COL 1
