CAAB writes to India to resume flights STAFF CORRESPONDENT

Civil Aviation Authority of Bangladesh (CAAB) yesterday wrote a letter to Indian authorities concerned, proposing to resume flights with India on various conditions, including Covid-19 vaccination of air passengers.

CAAB sent the letter to its Indian counterpart, sources said.

CAAB Chairperson Air Vice Marshal M Mafidur Rahman said, "India has already shown interest to resume flights with us. We are discussing whether flights can be started through an Air Bubble Agreement between the two countries.

Bangladesh suspended all international flights to and from the country on April 14, after the start of the second wave of the pandemic.

After being suspended for 16 days, operation of international flights resumed from May 1, except for 12 countries including India.

Earlier in the day, in a rare precedent, lawyer Shishir Manir forwarded the letter to the HC bench of Justice M Enayetur Rahim through email, saying that an executive magistrate cannot hold trial of minors through a mobile court as per a judgement delivered by the HC in 2019.

Earlier on Sunday, Sultana Razia, assistant commissioner (land) and executive magistrate of Atpara upazila in Netrakona, conducted a mobile court and sentenced two 15-year-olds to one month's imprisonment for getting married, according to a report published in the Daily Prothom Alo yesterday.

The executive magistrate conducted the mobile court at her office and ordered police to send the detained minors to the Child Development Centre in Gazipur, according to the newspaper report.

Lawyer Shishir Manir told The Daily Star that he sent the letter to the HC as an officer of the court under the relevant provisions of the High Court rules.

On March 11, 2019, an HC bench of Justice Sheikh Hassan Arif and Justice Md Mahmud Hasan Talukder scrapped the convictions and jail sentences handed down by executive magistrate-run-mobile courts to juveniles across the country.

In the full text of the judgement, the bench has observed that the mobile court law has not empowered executive magistrates to conduct trial of children.

We have not found anything in the Mobile Court Act, 2009 that empowers executive magistrates to conduct trial of an accused minor."

"Rather, the Children Act, 2013 being the subsequent special law, the provisions of the same law will override in case of any conflict of it with the Mobile Court Act, 2009," the HC bench said in the full text of the verdict.

needed to be remanded to find out the people who assisted the accused in posting the altered pictures, the IO added.

The defence, however, submitted a petition seeking bail and cancellation of the remand prayer, saying that Monir was implicated in the case as part of conspiracy.

Upon hearing both the sides, the magistrate rejected the bail petition and placed him on remand.

Earlier on Sunday night, a DB team arrested Monir from his Kamrangirchar residence on the charge of defaming AL leaders posting several pictures on Facebook.

Moreover, Monir allegedly became owner of vast wealth through land brokerage and lobbying. He also collected AL nomination papers for Dhaka-2 constituency comprising parts of Keraniganj and Savar in the 2018 elections. Meanwhile, another Dhaka court yesterday placed two associates of

businessperson-turned-politician Helena Jahangir on a three-day remand each in a fraud case filed with Pallabi Police Station. The accused are Hajera Khatun (40), general manager of Helena Jahangir's

IPTV JoyJatra Television; and Sanaullah Noori (48), its co-ordinator.

Dhaka Metropolitan Magistrate Debdash Chandra Adhikary passed the order after Sub-Inspector Md Al Helal, IO of the case, produced them before the court with a seven-day remand prayer.

The defence submitted a petition seeking bail and cancelling the remand prayer. But, the magistrate rejected the petition.

Earlier on August 3, Helena was remanded for four days in the same case. Rab arrested Hajera and Sanaullah in Gabtoli on Monday.

In the case, Helena was accused of taking Tk 54,000 from one Abdur Rahman from Bhola for appointing him as a local correspondent of JoyJatra.

As a correspondent, Rahman worked for several months but he was not paid. On the other hand, the TV authority took Tk 3,000 per month from him.

On August 2, Abdur Rahman filed the case against Helena, Hajera and Sanaullah. The law enforcers arrested Helena at her Gulshan residence on Thursday night.

workers between the ages of 18 and 24 go to factories? How will transport workers of this age go out to work? Or how will the shopkeepers of this age open their shops?"

Quader also said the health ministry issued a statement on Tuesday disagreeing with Liberation War Affairs Minister's comment on not allowing unvaccinated people on the streets.

"Such incidents are happening repeatedly due to the unplanned and short-sighted decisions and for lack of coordination," he said.

On Tuesday, Liberation War Affairs Minister AKM Mozammel Haque said it has been made mandatory to take Covid jabs for public movement from August 11.

"Any movement by people aged 18 or above without being vaccinated would be considered a punishable offence.

However, the minister withdrew his statement by issuing a media release vesterdav.

"All citizens above the age of 18 will be vaccinated in phases. But Liberation War Affairs Minister AKM Mozammel Haque is withdrawing the part of his statement that anyone above 18 years will not be allowed to go outside after August 11," the release said.

From 1971-1973, he was one of hundreds of Bengali army officers imprisoned in prison camps in West Pakistan, released only after the 1973 Simla Accord. For service in the Liberation War, he received the Joy Padak and Constitution Medal.

At CMH, he introduced laparoscopic surgery, advanced neurosurgery, endoscopic joint surgery, advanced microscopic methods of ENT surgery, and phaco surgery for cataracts. He retired in 1995 as Consultant Surgeon General at Mai Gen rank.

After retirement, he taught surgery at Jahurul Islam Medical College, Bajitpur (1996-2010), and Armed Forces Medical College, Dhaka (2010-2020).

He is survived by his wife of 55 years, teacher Nilufar Begum Mohaiemen, and his two sons Naeem Mohaiemen and Zaed Mohaiemen.
