Fire guts electronics warehouse in Savar

It was used by Singer as temporary storage facility

A fire broke out at a warehouse used by Singer Bangladesh in Savar yesterday morning where electronic appliances were stored. Though the cause and extent of damage is yet to be ascertained, eyewitnesses said the total damage could be hefty.

The fire originated at the tin-roofed warehouse in Raz Fulbari area around 8:20am, some 600-700m away from Singer's factory at Jorpul, Ershad Hossain, duty officer of Fire Service and Civil Defense control room, told The Daily Star.

On information, eight firefighting units rushed to the spot and brought the fire under control after two-and-a-half hours of effort, he added.

Md Manikuzzaman, assistant director of Fire Service and Civil Defence Headquarter in Dhaka, told the media that they brought the fire under control around 10:50am.

Cause and the extent of damage of the fire will be known after investigations, he added. No casualty was reported.

However, Nazrul Islam, security guard of a nearby factory, said the fire was started by an explosion in the electric transformer close to the 32,000-square feet warehouse. Once it got going, the fire spread rapidly, the evewitness said.

Ekramul Haque, Upazila Project Implementation officer, told The Daily Star that they came to know the warehouse was used to keep ACs, refrigerators, and televisions from Singer's factory. Singer authority occupied the warehouse on a rented basis, he said.

Rakib Ahmed, owner of the warehouse, said to reporters his premise is equipped with proper fire safety measures and reiterated that the fire originated from the electric transformer explosion.

Meanwhile, as the warehouse is located next to the highway, traffic movement remained halted for three hours. Fire service also had to keep the road obstructed, as they needed to use water from the opposite side of the road.

Later in the day, Singer released an official statement where it said the warehouse was only used as a temporary storage facility and emphasised that it was not Singer-owned.

The Daily Star tried to contact Singer



Musleha Islam was a freedom fighter in her own right and made her house at Dhanmondi road-4 a hub of the famous Freedom Fighters' group, "Crack Platoon".

She collected clothes, money, and medicine for the Mukti Bahini and sent them to the camps across the border. On occasion, arms and ammunition were stored in dug-out storage in her garden.

Her eldest son Wasif Islam, now ameer of Tabligh Jamaat, joined the War and along with his companions closely worked with sector commander Khaled Musharraf.

Her only daughter Shaheen Anam -- now executive director of Manusher Jonno Foundation -- was also a freedom fighter, helping Crack Platoon and freedom fighters in every way.

Her two other sons, Sheraz Bin Faruk and Rizwan Bin Farouq, both established professionals, were too young to join the war, but helped their mother and sister in serving freedom fighters.

Her son-in-law Mahfuz Anam is the editor and publisher of The Daily Star. Her eldest granddaughter Tahmima Anam is an internationally-famed novelist.

Musleha is survived by her three sons, daughter, eight grandchildren, and six great-grandchildren.
