vaccination drive, aimed at inoculating 35 lakh people in six days. The vaccine jabs are being administered simultaneously in 4,600 unions, 1,054 municipality areas, and 433 wards of the city corporations.
Fakhrul said their standing committee meeting highlighted the issue of vaccine production in the country to provide people with vaccines within the shortest possible time while maintaining international standards.
The BNP leader said the contradictory remarks by a minister on not allowing unvaccinated people on the streets have clearly exposed the government's lack of coordination and irresponsibility.
He also voiced concern over the slowdown in the country's economic growth, increase in poverty, and hike in the price of essential commodities amid the pandemic.
Fakhrul said the number of poor and unemployed people has increased due to lack of proper steps taken by the government to handle the Covid situation. "The ruling party members have established a reign of plunder and corruption," he alleged.
He urged the government to consult with the country's leading economists immediately, and take realistic and effective steps to keep the economy afloat.

Arindam's family, however, alleged that the arrest was part of a communal agenda connected to his sharing of an audio clip of former Hefajat-e-Islam leader Mamunul Haque on Facebook in April.
They also alleged that the Jubo League leader was tortured in police custody. But, they withdrew the allegation later.
Afterwards, Jubo League, Swachchasebak League and Chhatra League leaders and activists of Sunamganj and Sylhet protested the arrest and filed repeated complaints with the administration and police.
Following an internal investigation, Sub-Inspector Shah Ali was withdrawn from the police station on July 30.
On allegation of the assault, SI Shah Ali filed a case with the police station accusing Arindam, Bishwajit Roy, Polish Sarkar Paltu, Ratan Roy, Chandan Roy, and three or four unnamed individuals.

Mizan approached the corner of the cornice and grabbed him. In the meantime, other firefighters rushed in and rescued him.
A video of the incident was soon posted on social media and has gone viral.
"We were worried he might jump off anytime. That's why we came up with the trick to save him," said Md Shahabuddin, senior station officer of Mirpur Fire Station.
"He said his name was Rakib and he is from Faridganj upazila in Chandpur. But we're not sure if that is his real identity as he didn't speak with clarity," he said.
Fire fighters suspect the teenager may not be mentally stable.
The house owner said Rakib climbed the sewerage pipe to reach the risky side of the cornice in the morning. It took firefighters nearly two hours to rescue him.
As Rakib was rescued he was still laughing, and by then, so were the people witnessing the drive, but out of relief.

"e-voucher" from the arrestees.
He said Shwapno conducts all business activities including sales monitoring, inventory and staff management, financial transaction, and digital voucher management at 186 outlets across the country through their website.
The arrestees breached the security system, generated digital vouchers worth Tk 18 lakh and sold those online at discounted prices, the CTC chief said, adding that they used to deposit the money in their cryptocurrency-based accounts.
Asked how much money the hacker group swindled from different sites, Asaduzzaman said they have found a transaction of around Tk 20 lakh in cryptocurrency in primary investigation.
"We need time to verify and check the actual figure," he said, adding, "We are conducting drives to arrest other members of the group."
"They have also hacked a foreign website called freelancer.com, which has around five crore followers..." he said.
A case was filed against the arrestees under the Digital Security Act with Tejgaon Industrial Area Police Station.
Present at yesterday's briefing, Sabbir Hasan Nasir, executive director of Shwapno, said a criminal gang was trying to tarnish their reputation.
"Digital vouchers have also been spread on social media with fake offers in the name of Shwapno. We lodged a complaint and filed a case in this regard," he said.
When they sought cooperation of the cybercrime team, they took cognisance of it and arrested the criminals, said Nasir.

Police Station in Bagerhat on charge of killing his wife Sheuly Begum (20) on November 28, 2007 as the medical and chemical reports said the death of Sheuly was caused due to poisoning, which was suicidal in nature.
On July 5, 2015, the HC confirmed his death penalty given by a Bagerhat court on June 10, 2010 in the case, he added.
Shirin Afroz, a state-appointed defense lawyer for Al Amin, told this correspondent Al Amin was arrested on December 8, 2010 in the case filed for abducting and killing 12-year old third-grader Parvez.
Parvez's slaughtered body was recovered from a paddy field on November 15, 2020.
His mother Josna Begum filed the case with Debidwar Police Station against Al Amin the same day.
The trial court concerned of Cumilla on January 31, 2012 convicted and sentenced Parvez to death and the HC on January 29, 2017 confirmed his death sentence, the lawyer said.
Shirin Afroz said the SC commuted death penalty of Al Amin considering her arguments that the accused Al Amin was young and he had no source of income during the occurrence.
Attorney General AM Amin Uddin and Deputy Attorney General Bishwajit Debnath represented the state during the virtual hearing of the appeals.

The mayor made the comment while addressing an awareness programme at Beraid as the chief guest.
He said effective steps have to be taken so that every area remains Aedes mosquito-free.
The mayor also called on residents to clean their houses and destroy the Aedes mosquito larvae or the breeding sources. He said the anti-mosquito activities will have to be sped up and everyone will have to take part in that.
The mayor also reiterated his announcement of monetary rewards for residents for cleaning coconut shells, unused toilet fittings, plastic bags and discarded tyres.
"We will give Tk 5 for unused commode and discarded tyres and will give Tk 5 for each coconut shell, pots and chips packets. Anyone can collect the money by submitting it to the councillor office or zonal offices," he said.
He said everyone will have to be careful so that water cannot remain stagnant for more than three days at different pots, flower tubs, rooftops, or any other containers. He also urged people to dump solid waste in a designated place.
The mayor said due to the awareness of people, the number of dengue patients is still less in DNCC areas. He also urged people to wear masks and follow health guidelines to stop the spread of coronavirus.
