# Probe finds govt body's negligence

The government's factory inspection department has been negligent in monitoring safety measures, found a government probe body formed after the devastating Hashem Food and Beverage factory fire in Narayanganj. The probe body also blamed the

factory owner. incident, three After the

government bodies -- Narayanganj district administration, Fire Service and Civil Defence authority, and the Department of Inspection for Factories and Establishments -- formed three probe committees.

The district administration's probe body submitted its 44-page report to the deputy commissioner on August 5 after almost a month-long probe. Yesterday, Narayanganj DC Mostain Billah shared the findings with The

The Department of Inspection for Factories and Establishments is responsible for monitoring safety measures in factories. The probe report has found that the department lacked sound monitoring in this case,

The fire originated from an electric short-circuit on the ground flood. As there were huge flammable substances stored, the fire spread fast, the DC added, quoting the probe report.

The owner did not have approval from the upazila administration and the Department of Environment (DoE) for setting up the factory, the probe found.

The owner did not comply with the government's directives to ensure safety at the factory. All these factors contributed to the fire, he said.

Contacted yesterday, probe body member and Deputy Inspector General Soumen Barua of Department of Inspection for Factories and Establishments in Narayanganj said, "The owner could not show any documents of approval from the Department of Environment (DoE) or local upazila administration for setting up the factory."

Asked about negligence on the part of his department, he said the DC would talk about it and hung up the

The probe body placed a 20-point recommendation.

The recommendations include increasing manpower in the Department of Inspection for Factories and Establishments to strengthen monitoring of safety measures in factories, keeping sufficient fireextinguishers in factories, keeping a team of firefighters in each factory, and training the workers to fight fire in emergencies.

It also recommended paying Tk 2 lakh to families of each deceased workers and Tk 2.5 lakh to each of the injured workers as compensation.

The factory, located in Kornogop area of Rupganj, caught fire on July 8, claiming at least 51 lives.

The fire caused huge outrage among workers and common people. Two days after the accident, a police officer on July 10 filed a case with Rupganj Police Station, alleging negligence against eight persons, including factory owner Abul Hashem.

All eight were arrested hours after the case was filed.

Of them, five persons, including Hashem, later got bail.

A group of people tied and trapped a freshwater crocodile in a water body, and brought it onto land in a village of Faridpur's Sadar upazila yesterday afternoon. # Grim picture painted for Bangladesh

greenhouse gas emissions decline dramatically.

It said heatwaves and humid heat stress will be more intense and frequent during the 21st century over South Asia. Heat extremes have increased while

cold extremes have decreased, and these trends will continue over the coming decades over Asia, the report said. This the first time IPCC has released regional factsheets. The Asia projection maps indicate annual mean

temperatures will increase by 1-2°C relative to 1850-1900 period in case of 1.5°C to 2°C global warming. There are likely to be 90 to 120 days in a year with maximum temperatures above 35°C in case of 1.5 to 2°C warming and over

180 days in case of 4°C warming.
"Strong and sustained reductions

in emissions of carbon dioxide (CO2) and other greenhouse gases would limit climate change," the report said. The report provides new estimates

of the chances of crossing the global warming level of 1.5°C in the next decades, and finds that unless there are immediate, rapid and largescale reductions in greenhouse gas emissions, limiting warming to close to 1.5°C or even 2°C will be beyond achievable.

The report shows that emissions of greenhouse gases from human activities are responsible for approximately 1.1°C of warming since 1850-1900, and finds that averaged over the next 20

years, global temperature is expected to reach or exceed 1.5°C of warming.

This assessment is based on improved observational datasets to assess historical warming, as well progress in scientific understanding of the response of the climate system to human-caused greenhouse gas

The report projects that in the coming decades, climate changes will increase in all regions. For 1.5 °C of global warming, there will be increasing heat waves, longer warm seasons and shorter cold seasons. At 2°C of global warming, heat extremes would more often reach critical tolerance thresholds for agriculture and health, the report said.

special campaign," Haque said.

A source in the Director General of Health Services (DGHS) said the special campaign might launch later this month if there are adequate doses in stock.

# Tigers wrap up series with thumping win FROM PAGE 1 Looking to forget the series as quickly as and too close to pull. The resulting shot

The Tigers dedicated their maiden T20I series win over Australia to the Father of the Nation Bangabandhu Sheikh Mujibur Rahman and his family members who embraced martyrdom this month in 1975.

Having arrived on the back of a 4-1 T20I series defeat to West Indies, the visiting Australia side managed to scrape a single win against the Tigers in the fourth T20I, largely succumbing to the slow wicket and Mustafizur Rahman's cutters making the difference between the two sides.

But having once again restricted the home side to a manageable target yesterday, the Aussie reply this time was

again set the tone early. Nasum Ahmed removed Dan Christian, sent to open the innings, out bowled in the second over. A crucial blow followed in the left-arm spinner's next over, the fourth of the innings, when in-form Mitchell Marsh looked to go across the line, only to be trapped leg-before and unable to overturn the decision.

Skipper Matthew Wade had two powerful sixes off Mahedi Hasan as he looked to dominate but Shakib cleaned up his castle in the seventh over with a delivery that rushed through and under Wade's pull-shot. With the skipper gone after a run-a-ball 22, the Australia innings would crumble to a heap thanks largely to Shakib's four-wicket haul.

During a turbulent phase of bowling and in the space of 40 deliveries, Australia lost eight wickets, adding just 24 runs, falling to their lowest ever T20 score – 17 runs short of their previous worst of 79 all out against England in 2005. The Aussies, who left Dhaka for home later in the night, would be

In his first match of the series, Mohammad Saifuddin picked up three wickets with Alex Carey and Moises Henriques departing in the 11th over to scores of three.

Ashton Turner gave Shakib his second wicket of the match, providing a dolly of a catch to mid-off as the ace all-rounder notched the unique record of becoming the first ever player to take 100 wickets and score 1,000 runs in T20Is. Shakib, playing in his 84th T20I, has already scored 1,718 runs in the

Defending a modest score of 122 his last over -- the 14th of the innings for three after 10 overs. for eight, the Bangladesh spinners once -- removing Nathan Ellis and Adam Zampa to finish with four for nine as Australia were bowled out for 62.

Earlier, Bangladesh's batting continued to flounder after the hosts won the toss, only managing 122 for eight.

Australia picking four spinners in the line-up, including leg-spinners Zampa and Mitchell Swepson, should have worked in the visitors' favour but early on in the innings it had the opposite effect as the Tigers got off to their best start of the series.

Hasan and his friend Mobarak Ali, 31, were arrested yesterday, said Abu Bakar Siddique, additional deputy commissioner (north zone) of Chattogram Metropolitan Police, adding that Mobarak works at a private bank while Hasan is a businessman. 'The vaccine was taken in Mobarak's

house, who is a friend of Hasan's," he said, adding, "During primary interrogation, Mobarak said he also managed a vaccine at home for his "During primary interrogation, we

The health directorate reported 245 deaths and 11,463 cases of Covid-19 in

24 hours ending at 8:00am yesterday. With this, the total number of fatalities reached at 22,897 which is 1.68 percent of all confirmed cases so far in the country.

Yesterday, the positivity rate was 24.28 percent against a total of 47,207 The total number confirmed cases

reached 13,65,158. Of the deceased yesterday, 117 were

A total of 234 of the 245 died in hospitals while 11 died in their homes.

The number of Covid-19 deaths in homes has increased notably after community transmission of the Delta variant began. Of the yesterday's deceased, the highest 83 was in Dhaka divisions

followed by 71 in Chattogram, 25 in Khulna, 19 in Rangpur, 18 in Sylhet, 13 in Mymensingh, 10 in Rajshahi, and six

With the detection of new patients every day, hospitals have been struggling to treat patients.

As of yesterday noon, the ICU bed occupancy was 88 percent while the occupancy for the beds in the high dependency units was 86 percent across the country

The general bed occupancy, however, declined a bit compared to the previous day. Yesterday, the general bed occupancy rate was 58 percent while it was 59 percent the previous day.

health experts are being ignored, and non-technical persons are making without any impact decisions assessment.

Terming the government decision an illogical one, he said restrictions can be lifted if the infection rate drops below 5 percent. But it is still above 20 percent.

"We should follow scientific approach. Otherwise, we may have to pay a high price," observed Be-Nazir. At yesterday's press briefing, the cabinet secretary said restrictions on

public gatherings and recreation centres will remain in force. Replying to a question, he said, "Public gatherings and operation of recreational centres are still not

permitted. Meanwhile, Road Transport and Bridges Minister Obaidul Quader said the strict lockdown has been relaxed for the sake of people's lives and livelihoods, but it may be re-imposed if

the Covid situation worsens. He also said both passengers and transport workers must wear facemasks
