LIMITED COURT FUNCTIONS Lawyers, litigants left distressed

The Supreme Court buildings, most of which were constructed in the beginning of the 20th century, stand still with an eerie calm hanging all over the premises.

The flurry of activity that used to reverberate through the Renaissance architectural style buildings is absent now: no crowd of lawyers, litigants, clerks, and staff at the court compound.

This has been the scene at the country's highest judicial institution since the Covid-19 outbreak in March last year brought the regular functions of all the courts across the country to a halt, badly hampering the justice delivery system.

Court activities, however, have gone virtual, albeit at a limited scale.

As a result, the rates of case filing and disposal fell drastically, leading to increased backlog of pending cases and sufferings of the justice seekers. Neither the government nor the SC administration have devised any major plan of action to recover the damage caused by the pandemic.

According to the latest decisions of the chief justice, all the benches of the Appellate and High Court Divisions of the Supreme Court will run judicial functions virtually from tomorrow, read two notices of SC administrations.

Since Covid-19 struck the country, all benches have remained operational together only for half this period --

Gas field found in Zakiganj

Bapex says it'll last 12 yrs

Bangladesh announced the discovery of its 28th gas field in Sylhet's Zakiganj yesterday on the occasion of the National Energy Security Day.

The state-owned Bangladesh Petroleum Exploration and Production Company (Bapex) made the discovery in June, but did not declare it formally as they were assessing the prospects of recovering gas from the drilled well in Ananadapur village of Zakiganj.

In a webinar, State Minister for Power, Energy and Mineral Resources Nasrul Hamid said they estimated that the field has 68 billion cubic feet of gas reserves.

"If we use 10 million cubic feet per day gas from this field, it will be extractable in next 12-13 years," he added.

"The value of the entire reserve at the new gas field

THANT'S WARNING

UN Secretary General U Thant warned today that the trial of Bangladeshi leader Bangabandhu Sheikh Mujibur Rahman would "inevitably have repercussions outside the borders of Pakistan".

He added that he had been receiving expressions of concern about Bangabandhu from many governments every day.

U Thant further said there was a general feeling that the hope of restoring peace and normality in the region was "remote unless some kind of accommodation is reached".

Meanwhile, 11 American senators urged today that the United States government convey to Pakistan their "profound hope" that

KOTALIPARA BOMB PLOT Attempt on PM's life disgraceful chapter for nation

Says HC in full text of verdict

The attempt of perpetrators to kill Awami League President and Prime Minister Sheikh Hasina by detonating bombs in Gopalganj in 2000 is an ignominious chapter for the nation, the HC said in the full text of the verdict on the Kotalipara bomb plot case.

On February 17 this year, the HC delivered the short verdict on the death reference and appeals in connection with the case filed over the attempt to kill Prime Minister Sheikh Hasina.

In the full text of the 86-page verdict released yesterday, the bench observed that the conspiring accused had in fact planned to kill the person who was in office as the head of the legitimate government.

The court said it has been found after reviewing confessional statements of the accused that their mindsets had been created from an unreal and illusive concept.

"It has also been found that some of the conspirators had joined different militant organisations in Pakistan and Afghanistan and received training on militant activities," the HC judges said in the full text.

The HC also said the convicted accused's beliefs that "a female leader in the country is not allowed in Islam and [so] they would resist the system" are not supported by Islam in any manner because it is a religion of peace.

The convicted accused are reluctant to abide by the existing laws of the country

9th grader held in DSA case in Rangpur

A Rangpur court yesterday sent a 9th grader to jail after police arrested him in a case filed under the Digital Security Act over a Facebook post.

Police said the 17-year-old boy was arrested in Pirganj on Sunday after he posted a distorted photo of Bangabandhu Sheikh Mujibur Rahman on Facebook.

Sub-inspector Monirul Rahman of Pirganj Police Station filed the case against the boy, student of a local madrasa.

Sorosh Chandra, officer-in-charge of Pirganj Police Station, said the accused was sent to Rangpur jail.

Since the post was defamatory and could deteriorate law and order,

SURGE IN COVID CASES Sri Lanka holds mass cremations

China reports more cases

Sri Lanka has begun mass cremations to clear a backlog of dead bodies from Covid-19 as cases surge across the island, officials said yesterday.

Daily virus infections in the country have doubled in a month to more than 2,500 with nearly 100 deaths, putting huge strain on hospitals.

On Sunday evening Colombo Municipality began mass cremations, disposing of 15 corpses at the Colombo General Cemetery after the island's main hospital said it had no more freezer space.

It was the first mass cremation since December when the government overruled religious objections and cremated 15 members of the Muslim minority, including
