# Passport delivery **STUMBLES**

Thousands of migrants left in uncertainty as DIP fails to act in time

The passport authorities sat on upgrading the MRP server that had crossed the 30-million limit in early June, causing delay in reissuing passports to tens of thousands of Bangladeshis, mostly migrants in the Gulf and Southeast Asian countries.

It has left the migrants at risk of becoming undocumented or delayed their process to become regular, migrant workers and activists have said.

The issue came to the fore in the last couple of weeks as the migrants made numerous complaints about it -- at a time when they are facing joblessness and uncertainty over life and livelihood abroad amid the coronavirus pandemic.

The Department of Immigration and Passport (DIP) Director General Major



General Mohammad Ayub Chowdhury said the system for machine readable passports (MRPs) requires upgrades from time to time.

Steps have already been taken to upgrade the server and we will extend the contract with the Malaysian company concerned," he told The Daily Star on Sunday.

Passports against pending applications will be printed and delivered once the system is upgraded, he said, without giving any timeframe.

DIP Director Shihab Uddin Khan said they had a target of introducing e-passports within 2020, but their officials could not go to the Bangladesh missions abroad to put the e-passport systems in place due to the coronavirus pandemic.

"That's why the pressure on the MRP server increased and its limit of three crore applications crossed," he said on Monday.

### No first dose of Moderna from tomorrow

The government has decided to suspend administering the first dose of Moderna Covid vaccine from tomorrow

Issuing a circular yesterday, the Directorate General of Health Services (DGHS) instructed those vaccination centres, which still have Moderna jabs in stock for first dose, to administer those soon and make preparations for administering the second

It also said the administering of the second dose of Sinopharm vaccine will start all over the country on August 14.

The Chinese vaccine jabs will be dispatched to different parts of the country on the basis of demand, mentioned the circular.

Record-equaling 264 deaths in 24 hrs

With most of the restrictions on movement of people and public transports lifted today, health experts warn of a further a surge in Covid deaths and infections.

Yesterday, the country logged 264 deaths, which matched a previous daily record on August 5, taking the virus death toll to 23,161

The number of deaths in the first 10 days of this month was high -- more than 247 a day on average -- because of higher infection rates, according to the Directorate General of Health Services (DGHS).

In the preceding 10 days, 218 Covid deaths were logged a day on average.

Experts fear that the lifting of the restrictions will lead to a further rise in virus transmission across the country.

Yesterday, 11,164 out of 53,462 samples tested positive for Covid, raising the total number of cases to 13,76,322.

The Covid positivity rate stood at 23.54

The World health Organization last year advised governments to consider reopening only when the positivity rate remains below

5 percent for two weeks at a stretch. "With the lifting of the restrictions, more

people will now go outside and get infected with the novel coronavirus. We will see more pressure on hospitals and a further rise in deaths in the days to come," Prof Ridwanur Rahman, an infectious disease specialist, told

this newspaper yesterday. "Despite the weak enforcement of restrictions, many people did not go outside. ine suspension of inter-district dus services had a positive impact and helped check virus transmission," he observed.

Talking to this correspondent, Dr Mushtuq Hussain, consultant at the Institute of Epidemiology, Disease Control and Research (IEDCR), said, "When social gatherings will increase, virus transmission will rise too. This may drive up infections.'

Both the experts said the infection rate was in decline since August 2 as a result of imposition of the Covid restrictions by the government. These restrictions should have been in force for at least two more weeks.

DGHS data shows that the Covid positivity rate on August 2 was 29.91 percent, which continued to fall till yesterday.

# Heavy vehicles banned on ferry

In order to avert the risks of ferries ramming into pillars of the underconstruction Padma bridge, the authorities yesterday decided that

ferries will not carry heavy vehicles, like buses and trucks, there is strong current in the river.

The decision came a day after a ferry rammed into pillar no. 10, damaging its pile cap, which was the third such incident in 20 days.

Khalid Mahmud Chowdhury, state minister for shipping, made the announcement after a meeting with senior officials from the Bangladesh Inland Water Transport Corporation (BIWTC) and Bangladesh Inland Water Transport Authority (BIWTA) to discuss the recommendations of an enquiry committee formed after previous incidents.

"We are embarrassed and sadden by the incident of [ferries] hitting the pillars of Padma bridge. This is a matter of concern for us. Hit on Padma bridge is tantamount to hit on our heart. We don't want our heart get hurt again and again," the state minister said.

Only cars, microbuses, ambulances and other lighter vehicles will be carried across the river via this route. SEE PAGE 2 COL 1

Say Prof Yunus, 5 others

A temporary waiver of intellectual property rights for Covid-19 vaccines is vital to increase supply, achieve global herd immunity, and advance global health equity, Nobel Peace Prize winner Muhammad Yunus and five others have said in an article published in the BMJ (formerly British

Medical Journal). By late June 2021, 46 percent of people in highincome countries had received at least one dose of the Covid-19 vaccine compared with 20 percent in middle-income countries and only 0.9 percent in low-income countries, said the article.

# OxyJet: the long road to approval

From the drawing board to the approval stamp, it's been a long exhilarating process for OxyJet. But it isn't over yet.

A type of CPAP (continuous positive airway pressure) device, OxyJet can supply pure oxygen at the rate of up to 60 litres per minute without any electricity, and shows a similar clinical outcome as high-flow nasal cannula (HFNC) treatment.

On the upside, the whole set-up of OxyJet costs only Tk 20,000-25,000, whereas a high-flow nasal cannula costs Tk

The idea began on the whiteboards of the biomedical engineering department of Buet last year and was led by Dr Taufiq Hasan, associate professor of the department.

Taufiq said, "My wife and many of my friends are doctors who shared horrific stories of deaths due to the shortage of high-flow oxygen supply. I spoke to doctors of several hospitals in Dhaka and learnt how Covid-19 patients were suffering due to a shortage of resources.

# Dengue, Covid **Double Blow**

DGHS starts training docs tomorrow

As a person's chance of being infected with both dengue and Covid-19 is rising, the health directorate has taken an initiative to train doctors involved in dengue treatment across the country

"We are going to hold an online training programme on August 12 for the doctors of public and private hospitals who are providing treatment to dengue patients. They will be trained on what to do when a person contracts both dengue and coronavirus," said Afsana Alamgir Khan, deputy programme manager (malaria and Aedes transmitted diseases) of the Directorate General of Health Services

Bangladesh Society of Medicine will conduct the training. In the event, doctors will be guided on what they should do when a patient carries both the viruses and remain in normal and critical conditions, she said.

"We don't have any data about the cases of carrying both the viruses, but we are informed by Bangladesh Society of Medicine that there are some cases like this. For this, we are going to hold the training," said Afsana.

According to the DGHS data, 226 people with dengue fever were hospitalised in the country in 24 hours ending at 8:00am yesterday. Of them, 15 are from outside Dhaka.

With them, 4,979 patients have so far been diagnosed with dengue this year, of which only 214 are from outside

Among 4,979 infected, 2,321 were detected in the current month, while 2,286 were hospitalised in July, 272 in June and 43 were infected in May, according to the DGHS data.

There is a national guideline on dengue treatment, updated in 2021, which all the doctors and nurses of public and private hospitals follow. But there is no guideline about the treatment for a patient carrying both the viruses, said Afsana.

Health and Family Welfare Minister Zahid Maleque is expected to inaugurate the training at Hotel InterContinental Dhaka around 11:00am tomorrow, she

Doctors from 137 public and private medical college hospitals, over 100 Sadar hospitals and 492 upazila health complexes will join the training from their institutes virtually, she said.

Afsana said they will make the link of the programme available in the DGHS website and Facebook page and if anyone wants to join the training, he or she can.

"We will also record the programme and upload it in DGĤS website and anyone can watch it from there anytime," she said.

Experts opined that the recovery battle for patients infected with both the diseases -- considered life threatening --

Abdul Rahim, consultant of department of medicine of DNCC Covid-19 dedicated hospital, said he got two patients suffering from both the diseases in the hospital during Eidul-Azha. The number of this type of patients are now increasing, he added.

Patients suffering from fever and pain have Covid or dengue test. If they are diagnosed with any of the disease, they do not usually go for the test of the other disease. But the patients should undergo both tests, he added.

HM Nazmul Ahsan, associate professor at Shaheed Suhrawardy Medical College and Hospital, said doctors will struggle to handle patients infected with both dengue and Covid-19

"A dengue patient faces bleeding while a coronavirus patient faces blood clotting. We use an injection of anticoagulation for coronavirus patients when it is needed to prevent blood clots. But we cannot do it when the same patient also carries dengue virus and his platelet counts remain under one lakh," he explained. **DENGUE CORNER** 

Afsana said dengue corner has already been opened in all public hospitals.

"We are providing free NS1 testing at the dengue corner in all public hospitals and health complexes across the country and a patient will get proper advice after the test. They will be advised where to go for their admission or will be referred to go home with necessary prescription," she said.

Afsana said the government has already started their treatment in six hospitals dedicated for dengue patients and the service has started last week.

The hospitals are: Mitford Hospital, Lalkuthi Maternity Hospital in Mirpur, Kamalapur Railway General Hospital, Kamrangirchar 31-bed hospital, Aminbazar 20-bed hospital and Shaheed Ahsan Ullah Master General Hospital in Tongi.

# Passport delivery stumbles

Shihab said the DIP has already signed a new contract with the Malaysian company, IRIS Corporation, for an additional 60 lakh passports and the

server will be upgraded at the soonest. Sources in the home ministry and DIP, meanwhile, said the capacity of the server exhausted in early June but neither IRIS nor the DIP took initiatives to address it in time.

"No passports were printed in the last four weeks," a source said on Saturday.

The Bangladesh high commissions in Malaysia, Singapore, Maldives, and Lebanon even issued circulars saying there was a shortage of passport supply due to a technical issue in the MRP server.

On July 30, the Bangladesh High Commission in Singapore issued a notice on its Facebook page, saying the renewed passports of those who had applied after June 8, had not reached the southeast country. It requested the passport seekers to wait until further

The Bangladesh High Commission in Malaysia on August 7 in a circular said a huge number of applications were in the pipeline as "the capacity of the server at the Department of Immigration and Passport has died out."

The high commission said this was beyond its jurisdiction and that the home ministry and the DIP were

A Bangladesh embassy official in Riyadh told The Daily Star that they wrote to the DG of DIP several months back, detailing the problems the migrants were facing for the delay in passport delivery and requesting a quick supply of passports, but there was no solution. 'MONTHS' DELAY'

Against this backdrop, Bangladeshi migrants have expressed sheer frustration and anger.

They said more than one crore Bangladeshi migrants send home annually \$18 billion remittance, keeping the country's economy vibrant, but their concerns are not being addressed by the authorities on an urgent basis.

Waheed Nizam from Malaysia said it was taking four to six months to get passports while the migrants were passing days in uncertainty and in fear of detention by Malaysian police.

"With no timely passport delivery, many of us are not able to apply for work permit renewals. Some are even not being able to apply for the recalibration programme [amnesty] meant for the undocumented ones, he told The Daily Star by phone.

Rashidul Islam, a Bangladeshi in Singapore, said it was a matter of huge concern that they were not getting passports even three to four months after submitting applications.

A Bangladeshi migrant in Saudi Arabia said they were not able to have their iqamas (residency permits) renewed due to long delays in getting passports from the embassy.

Apart from the pressure on the MRP server and delays due to the pandemic, some officials of the Bangladesh missions said, another factor could be that passport brokers or the migrants might not have filed online applications properly.

Mohammad Harun Al Rashid, a migrant rights activist in Malaysia, said it was beyond imagination why the DIP was not able to identify the fact that the three-crore limit of the server had crossed and why it did not take actions beforehand. "Now, lots of problems have arisen.

Migrants could be detained because many of them could not renew work permits. If they are arrested or they lose their jobs, who will compensate Usually, Bangladeshi migrants face

various forms of abuse by the brokers, agents and are often denied state services. This time, it is the DIP whose negligence is directly affecting the migrants, he said.

They have a right to know actually what created the mess in passport reissuance, Harun further said and demanded those affected be compensated and those responsible be brought under investigation.

# RMP ASI closed for sexually harassing woman

An assistant sub-inspector of Rajshahi Metropolitan Police (RMP) was closed on Monday on charges of sexually harassing a woman at a police outpost.

Nibaran Chandra Barman, officerin-charge of Boalia Model Police Station, confirmed the information to The Daily Star.

According to sources, on Friday, a woman called the police emergency service number 999 and sought help, informing that she was abused by her husband.

Quoting the victim's family, OC Nibaran said, ASI Shamim of Bospara Model Police Outpost, met the woman at her house right after the call.

Listening to her allegations, he asked her to meet him at the police outpost for further procedure.

On Sunday, the woman went to the outpost with her mother. At that time, ASI Shamim allegedly told the woman's mother to go out of the room and sexually harassed the woman.

Hearing the incident, the woman's family filed a written complaint with Boalia Police Station on that day.

Later at night, local Ward Councillor Arman Ali called the girl's family and ASI Shamim to settle the matter.

However, the victim's family denied settling the matter and met the police commissioner in Rajshahi to report about the incident on Monday.

According to the OC, once nformed, he shared the incident with the senior officers.

"The police commissioner then withdrew the accused. We have already started an investigation. The accused was withdrawn so that he could not influence the investigation," he said. Police would take further steps

after investigation, he added.

Realising that we need a higher flow of oxygen, we took up a plan to develop a CPAP using a Venturi-mechanism [which speeds up flow of a fluid] for the treatment of Covid-19 patients.

"Using this technique, the device can generate high-flow oxygenated air at a normal hospital bed with central oxygen supply and without any electricity."

Usually, general hospital beds are equipped with one oxygen flow metre which can supply only up to 15 litres

With Oxylet, two flow metres can be used simultaneously -- one that gives 15 litres per minute while the other delivers 50 litres per minute. OxyJet is also fitted with a peep valve to regulate the CPAP pressure as required by the patient, Dr Taufiq said.

Besides, viral filters in the inlet and outlet of OxyJet prevent infection and contamination, he added. Once the design phase was done, it

# Informal workers in dire straits: speakers

Negligence of authorities blamed

STAFF CORRESPONDENT

Workers of the country, especially informal ones, are facing serious deprivation and negligence by the authorities during the coronavirus lockdown, which has pushed them into dire situation because of joblessness or low wages, said labour leaders, activists and academics

At a webinar on labour rights organised by civic body Nagorik, they said 86 percent of the country's labour force is in the informal sector, and they have no job contracts and thereby a lot of them were arbitrarily terminated from jobs.

After Eid holidays, garment factories were declared open but the government had no announcement on public transport -- a situation that forced the workers from their homes to take whatever means they had to travel from their homes to workplaces in Dhaka or Chattogram, they said.

"The state had thought little of how the workers will follow health rules during the lockdown. Moreover, there is no minimum protection of their jobs during this time," said Jahangirnagar University professor Anu

Samajtantrik Sramik Front Central Committee Chairman Razekuzzaman Ratan said a good portion of the country's GDP comes from the tourism sector, but the hotel and tourism sector workers' situation is dire during

They neither have any wage board or framework nor are they recognised by the labour law. With the pandemic beginning last year, lakhs of hotel workers were jobless and went home. They are still jobless and are passing hard days, he said.

# Punish those who vandalised temples

Demand eminent citizens after Khulna incident

Eminent citizens yesterday issued a statement, demanding arrest and trial of those responsible for vandalising and ransacking several houses, shops and temples of the Hindu community in Khulna's Rupsha upazila on Saturday.

"This is not an isolated incident. It's a shameful example of repression of minorities during the pandemic," they said in a joint statement signed by Shamsul Huda, executive director of Association for Land Reform and Development.

"In recent years, repression of minority communities has increased. We have seen such incidents in Cox's Bazar's Ramu (2012), Pabna's Santhia (2013), Brahmanbaria's Nasirnagar (2016), Bhola's Manpura (2020), and in Sunamganj's Shalla (2021),"

"We have repeatedly urged authorities concerned to take necessary measures to avoid such incidents and demanded trial of the responsible persons," they continued.

"But still, investigations into the incidents have not been completed and the real criminals were never put on trial.

"Despite the local administration being aware of the chaotic situation in Rupsha, they did not take any action to stop untoward incidents, nor take any measure to ensure security of the minority community."

"We strongly protest such incidents of torture, harassment and human rights violation of members of the minority community at Shiyali village in Khulna's Rupsha upazila," they said.

We demand the arrest and punishment of the criminals who were behind the incident," they further said in the statement.

"We also demand the government take steps to engage general people in preventing such incidents," they added

# LGRD ministry allocates Tk 10cr for 61 districts

The Ministry of Local Government, Rural Development and Co-operatives (LGRD) has allocated about Tk 10 crore for procuring oxygen cylinders, high-flow nasal canula and health safety materials for 61 districts of the country.

The ministry yesterday in a letter to the chief accounts and finance officer of Local Government Division (LGD), controller general of accounts, asked to release the first installment from zila parishad development assistance.

In the letter signed by LGD deputy secretary Mohammed Tanvir Azam Siddique, directives are given to the chief executive officers of the upazila parishads for spending the money for the said purpose only.

The letters shows Tk 15.5 lakh each was allocated to 10 districts; Tk 16.5 lakh to 49 districts and Tk 17 lakh for Dhaka and Tk 18 lakh for Cumilla.

"The money should be spent for distributing health safety equipment including masks, hand sanitisers, highflow nasal canula, oxygen cylinders and relief among the poor in the zila parishad areas," reads the letter.

The parishads must follow Public Procurement Rules-2008 and the respective authorities will be responsible for any irregularities.

Says HC on language used by Vigarunnisa principal in leaked phone conversation

# Writ petition seeks steps | 'Relocate hospital to stop eavesdropping

Ten Supreme Court lawyers yesterday filed a writ petition with the High Court, seeking its directive on the government to take necessary steps to prevent incidents of eavesdropping and recording of private phone

In the petition, they also sought a directive from the HC on the government to inform what necessary steps have been taken to prevent such incidents and to ensure right to privacy of telecommunication.

The lawyers said in recent years, they have come across numerous incidents of eavesdropping and recording of private telephone conversations from various reports published in national dailies, including

As per its constitutional statute, Bangladesh Telecommunication and Regulatory Commission (BTRC) is delegated with the responsibility of ensuring privacy of telecommunication and upholding the sanctity of Article 43 of the Constitution.

However, the newspaper reports demonstrate the continued failure of the BTRC in carrying out its constitutional duties. Such regular incidents of eavesdropping and recording of private telephone conversation show that BTRC is failing to take any necessary actions or preventive measures or carry out investigation to prevent such breach of privacy of telecommunication, the petition said.

The officials who have been mentioned as respondents in the petition are secretaries to ministry of posts, telecommunications and information technology, post and telecommunication division, information and communication technology division, and chairman of BTRC.

# Man arrested over abduction, murder of five-year-old

Three days after a five-year-old was abducted from the capital's Khilgaon area, police yesterday recovered the child's decomposed body from an under-construction building in

Analysing CCTV footage, police arrested Md Selim (32), a rickshaw-puller, over the abduction and murder, on the

Abdul Ahad, deputy commissioner of Motijheel Division police, confirmed the development to The Daily Star. Ahad said Selim's wife was suffering from kidney disease,

and he needed money for her treatment. Selim then asked for financial support from his former landlord's family. But they refused to help him. So, Selim

planned to blackmail the family, said the official. On Friday, he abducted a random child, Jisanul Islam Akayed, from the street and took him to the building belonging to the former landlord, Babul. The place was empty, and he knew about it, as he worked for the landlord

Then, he killed the child, left the body there and fled. He thought the landlord would get scared seeing the body and call Selim to dispose of it. At that time, Selim would blackmail him for money, said police, quoting Selim.

Without increasing existing rates or imposing any new tax, Barishal City Corporation has announced a budget of around Tk 416 crore for the year 2021-22.

Mayor Serniabat Sadik Abdullah announced the budget from a virtual session yesterday afternoon.

BCC CEO Syed Faruk Ahmed said around 33 percent of the budget will come from the annual development Programme; 11 percent from government allocations -- bulk and special; while 21 percent will come from government and foreign aid projects. The city corporation plans to raise the other 35 percent on its own.

Among others, the budget has allocated Tk 264.21 crore for developing infrastructure -- including roads, bridges, and other constructions -- Tk 36 crore for waste management, Tk 41 crore for administrative and office management, and Tk 9.79 crore for health services.

Notable among these are the Tk 43 crore plan to construct and renovate city roads, Tk 10 crore to update the waste management system, and constructing children's parks for 30 wards.

Syed Faruk said though Tk 280 crore was allocated through government and foreign aid projects in last year's budget, only Tk 17.91 crore was received, which is six per cent of the total proposal. This made it difficult to complete planned development activities of the city.

He told The Daily Star that though no new taxes have been imposed this time, it is possible to raise enough revenues through a cutting-edge and corruption-free system.

He mentioned that the city corporation raised Tk 77 crore last year and plans to raise Tk 113 crore this year.

"The government is pushing the city corporation to become self-sufficient, and we have successfully completed 17 percent of our development work from our own coffers," Faruk said. "I think we'll be able to do most of our development activities this way in the near future.

Mayor Serniabat said if the city corporation gets enough fund from the government, they can achieve the calendar year's targets.

"We have planned to increase revenue income by maximising tax realisation from a variety of existing sources," he said.





# Residents plagued by problems

OUR CORRESPONDENT, Mymensingh

About one thousand residents of Ashrayan project on Dulalbarir Char, a river island eight kilometres away from Mymensingh city, have been suffering from numerous problems since they were given free houses there by the government last year.

Most members of the low-income families, 240 in total, need to commute to and from the city every day to make a living. But a bamboo bridge made for them over Suti Khal, under the Ashrayan scheme, has become wobbly and hazardous within a few months.

Manik Mia, a grocer and a resident of the project, said many of the wooden planks on the rickety bridge broke down and made it extremely dangerous, especially for children, women, the elderly and people with disabilities.

The Ashrayan residents suffer the most when they need to cross the bridge in a hurry with a critically-ill patient, he also

The bridge is crucial for their livelihoods as their work is mostly in Mymensingh city, said Mohammad Giasuddin, another resident of Dulalbarir Char Ashrayan.

The Ashrayan residents do not have the financial solvency to raise necessary funds for the repair of the dilapidated bridge, he

Resident Chand Mia drives autorickshaw in the city. He said that over one hundred of the residents' children risk their lives while crossing the unsafe bridge on their own when their schools are open.

Third grader Rifat Mia and several other students of nearby Kalyanpur Government Primary School said they get scared every time they have to cross the broken bridge. The second biggest difficulty the

residents of Dulalbarir Char Ashrayan have been facing is the unavailability of adequate number of tube wells for its thousand residents.

Abdur Rahman, another resident, said there are only 24 tube wells available for all the residents, aside from the six new tube wells installed by a non-governmental

An island in the Old Brahmaputra river, Dulalbarir Char, under Mymensingh Sadar upazila, is cut off from the mainland by Suti canal. The island therefore is floodprone and embankments are necessary to protect its inhabitants and their property, said many of the inhabitants.

Waterlogging in the project area after even a moderate rainfall is another setback that is making their lives miserable, said Jomila Begum of the project.

Many residents alleged that the houses in the project did not have finished floors when those were handed over to them, while others complained of frequent power outages that sometimes last for several days.

Ever since they moved to their new address, their cost of commute rose by Tk 60 to 100 each day, said many residents.

Dolly Islam, a mother of two, said she used to work at a tailor's shop in the city, but the long distance from the city has forced her to quit the job and rely on meagre income of her husband, who is a restaurant worker.

Maharani Chowdhury, 75, said she used to work as a day labourer in the city's old Gudaraghat area, but she now has to depend on financial support from her

Asked about the waterlogging problem at the Dulalbarir Char Ashrayan, Mymensingh Sadar Upazila Nirbahi Officer (UNO) Sinful Islam claimed that a proper drainage system, capable of dispersing water accumulated from moderate to heavy rainfall, was made under the project.

On the issue of the dilapidated bamboo bridge, the UNO said a proposal for a bridge, made by the Local Government Engineering Department, was sent to the higher authorities for approval.

Abul Kalam, a traffic policeman at Rajarhat town, said that Sona Ullah plays a very helpful role in reducing traffic congestion. He always cooperates with the work of traffic police.

"We support him personally," he added.

Trucker Nur Jamal, 45, said that they give Sona Ullah a tip of Tk 5-10 as he assists the truck drivers

Local businessman Bikash Chandra Roy Tarun told the correspondent that even at the age of 73, Sona Ullah is keeping himself busy with work which is phenomenal.

Pedestrians are also getting volunteering work, he added.

Rajarhat Upazila Parishad Chairman Enamul Haque said that preparations have been made to pay old age allowance to Sona Ullah and his wife Nurjahan Begum.

Sona Ullah's voluntary work is phenomenal and he has never come to me for seeking any relief, the chairman added.

#### Myanmar junta says had 'nothing to do' with UN envoy plot

Myanmar's junta had "nothing to do" with an alleged plot to attack the country's ambassador to the UN Kyaw Moe Tun, who has defied the military and backed the pro-democracy movement, state-backed Global New Light of Myanmar newspaper said yesterday. Last week United States prosecutors said they had charged two Myanmar citizens over an alleged plot to hire hitmen who would force him to resign or, if he refused, kill him. Suspects Phyo Hein Htut, 28, and Ye Hein Zaw, 20, are being charged in a federal court on counts for which they could be sentenced to up to five years in prison. Prosecutors said Phyo Hein Htut had been in touch with an arms dealer in Thailand who had dealings with the military in Myanmar. The arms dealer spoke to Phyo Hein Htut about hiring assailants for the plot, which involved sabotaging the ambassador's car to force it

#### US to review classified 9/11 docs for possible publication

to crash, the criminal complaint said.

US officials vowed Monday to review classified documents related to the September 11, 2001 terror attacks to see which could be made public -- a recurring demand of some victims' relatives. The FBI said in a letter to the US attorney for the southern district of New York that it "has decided to review" its prior privilege to not disclose certain sensitive documents and will "identify additional information appropriate for disclosure." Agents with the Federal Bureau of Investigation "will disclose such information on a rolling basis as expeditiously as possible," the letter read. The FBI's committment is part of a legal battle waged by relatives of September 11 victims against Saudi Arabia and other nations they believe were accomplices. During the legal wrangling, successive US administrations have invoked state secrecy in order not to publish some documents.

#### First West African case of Marburg virus detected: WHO

Guinea confirmed a case of Marburg disease, the World Health Organization said on Monday, the first recorded in West Africa of the lethal virus that's related to Ebola and, like Covid-19, passed from animal hosts to humans. The virus, which is carried by bats and has a fatality rate of up to 88 percent, was found in samples taken from a patient who died on August 2 in southern Gueckedou prefecture, the WHO said. "The potential for the Marburg virus to spread far and wide means we need to stop it in its tracks," said Dr Matshidiso Moeti, WHO Regional Director for Africa. In Geneva, the WHO said it considered the threat "high" at the national and regional level, but "low" globally.



#### **Prince Andrew sued in NY** court for alleged sex abuse

Oueen Elizabeth II's second son, Prince Andrew, was sued in a New York court on Monday for alleged sexual abuse of a woman who says she was "lent out" for underage sex by late US financier Jeffrey Epstein. The filing at the US district court in Manhattan said Virginia Giuffre was the plaintiff in the case against the defendant, named as "Prince Andrew, Duke of York." Giuffre alleged in the filing that she "was regularly abused by Epstein and was lent out by Epstein to other powerful men for sexual purposes. According to the complaint, Giuffre said Andrew sexually abused her at the London home of socialite Ghislaine Maxwell more than 20 years ago, when she was under 18. Andrew, 61, has vehemently denied claims he had sex with Giuffre, and said he has no recollection of meeting her, but the allegations threaten to damage the British royal family. Andrew, a divorced father of two and former Royal Navy helicopter pilot was forced to step back from frontline royal duties in late 2019. Epstein, who befriended celebrities including former president Bill Clinton and Bill Gates, killed himself in jail in 2019 while awaiting

Save 'our very future'
Climate-vulnerable island nations call on world after damning climate report; China, Australia refuse to put forward more ambitious emissions targets

Dozens of small island states most vulnerable to the effects of climate change have called on the world to save "our very future" after a landmark UN report said accelerating global warming and rising sea levels threaten their existence.

The call to action comes after the climate report warned that catastrophic global warming is occurring far more quickly than previously forecast, an assessment met with horror and hopefulness by

world leaders and green groups.
"We have to turn this around," Diann Black-Layne, lead climate negotiator for the Alliance of Small Island States (AOSIS) and ambassador of Antigua and Barbuda, said in a statement late Monday.

"The stark fact is that if we keep warming to 1.5C we are still facing half a metre of sea level rise. But if we stop warming from reaching 2C, we can avoid a long term three metres of sea level rise. That is our very future, right there."

The group comprises 39 states including Cuba, Jamaica, Papua New Guinea and the Maldives, the world's lowest-lying country.

It said the report confirmed that governments around the world must take critical action to cap warming to the 1.5C temperature goal of the 2015 Paris Agreement. The UN's Intergovernmental Panel on Climate

Change report, published on Monday, said the world is on course to reach that level around 2030, a decade earlier than predicted just three years ago. That level of global warming will have devastating

impacts on humanity, including more extreme weather events such as fires, typhoons, droughts and floods. In its first major scientific assessment since 2014,

the IPCC said by mid-century, the 1.5C threshold will



have been breached across the board, by a tenth of a degree along the most ambitious pathway, and by nearly a full degree at the opposite extreme.

Many world leaders reacted to the report by calling for immediate action to curtail the rise of the world's temperature.

But Australia's conservative prime minister rejected growing calls yesterday to adopt more ambitious emissions targets, while China insisted it was implementing its climate commitments and signalled no new policies despite the report's findings.
"Australia is doing its part," Prime Minister Scott

Morrison said. "I won't be signing a blank cheque on behalf of Australians to targets without plans.

Australia has one of the highest rates of emissions per capita in the rich world and is among the world's irgest exporters of coal and natural gas

Australia has suggested it will achieve netzero carbon emissions "as soon as possible", and preferably by 2050, but has not made any commitments to do so.

Meanwhile, China yesterday insisted it was implementing its climate commitments, while signalling no new policies following the release of UN report. The Chinese government has set a target of reaching peak carbon emissions by 2030, and becoming carbon neutral by 2060.

### 207 arrested in latest Saudi anti-graft purge

Saudi Arabia announced the arrest of 207 employees across about a dozen government ministries in the latest sweep by an anti-corruption body empowered by Crown Prince Mohammed bin Salman.

The kingdom's National Anti-Corruption Commission, known as "Nazaha", announced the arrests late on Monday. Those detained were not named and it was unclear when the arrests were made.

The crown prince's anticorruption purge began in late 2017. It has helped him consolidate power and netted the government \$106bn in assets.

Saudi nationals have long complained of rampant corruption in government and of public funds being squandered or misused by those in power.

The commission said more than 460 people were investigated in this latest round, and that as a result, 207 Saudi citizens and residents were detained on allegations of corruption, abuse of authority and fraud.

# **Brazil indigenous group sues** Bolsonaro at ICC for 'genocide'

A Brazilian indigenous organization asked the International Criminal Court (ICC) Monday to investigate President Jair Bolsonaro for "genocide" and "ecocide," accusing him of persecuting native peoples and destroying their homelands. The Association of Indigenous Peoples of Brazil (APIB) alleged in a case filed with the Hague-based court that the far-right president has led "an explicit, systematic and intentional anti-indigenous policy" since taking office in 2019. "We believe there are acts in progress in Brazil that constitute crimes against humanity, genocide and ecocide. Given the inability of the justice system in Brazil to investigate, prosecute and judge these (crimes), we

denounce them to the international community," the group's legal coordinator, Eloy Terena, said in a statement. Bolsonaro, 66, has presided over a surge of destruction in the Amazon rainforest, slashed environmental protection programs and pushed to open indigenous reservations and other protected lands to agribusiness and mining. Indigenous rights activists also accuse him of exacerbating the devastation that Covid-19 has wrought on their communities with his anti-stayat-home policies. Brazil's estimated 900,000 indigenous inhabitants are particularly vulnerable to outside diseases, including Covid-19, which has killed at least 1,166 of them, according to APIB. It is not the first time indigenous leaders have accused Bolsonaro of attacking their people and homelands. In January, iconic indigenous chief Raoni Metuktire filed a separate case to the ICC asking the court to investigate Bolsonaro for crimes against humanity, saying the "destruction" of the Amazonian forest has accelerated without measure" under his government. The ICC's chief prosecutor must now decide whether to pursue the cases.

# Kim Jong Un's sister condemns 'perfidious' Seoul over drills with US

The influential sister of North Korean leader Kim Jong Un yesterday called Seoul authorities "perfidious" over the South's joint military exercises with the United States, and demanded Washington withdraw its forces from the peninsula. Kim Yo Jong's latest remarks come despite a surprise thaw on the Korean peninsula, prompted by a series of personal letters between her brother and South Korean President Moon Jae-in. The two sides last month restored cross-border communications that were severed more than a year ago, announcing their leaders had agreed to work on improving ties. But Kim Yo Jong -- a key adviser to

her brother -- condemned South Korea for holding "dangerous" joint military drills with the United States this month, which the North has long considered rehearsals for invasion. She expressed her "deep regret at the perfidious behaviour of the south Korean authorities" in a statement released by Pyongyang's official KCNA news agency. "For peace to settle on the peninsula, it is imperative for the US to withdraw its aggression troops and war hardware deployed in south Korea," she said. Kim Yo Jong had accused Washington of hypocrisy, he added, but she had "no right to say that as North Korea refuses to even be contacted by the US". Kim's comments came as the US and South Korean militaries began their preliminary training Tuesday in the run-up to next week's yearly summertime exercise. Seoul and Washington are treaty allies, with around 28,500 American troops stationed in South Korea to defend it against its nucleararmed neighbour. Seoul's defence ministry said the North did not answer the daily calls made between the two Koreas on their military hotline yesterday afternoon. SOURCE: AFP

# Turning sewage into ultra-clean water

Giant pumps whir deep underground at a plant in Singapore that helps transform sewage into water so clean it is fit for human consumption while reducing ocean pollution.

The tiny island nation has little in the way of natural water sources and has long had to rely principally on supplies from neighbouring Malaysia.

To boost self-sufficiency, the government has developed an advanced system for treating sewage involving a network of tunnels and high-tech

Recycled wastewater can now meet 40 percent of Singapore's water demand -- a figure that is expected to rise to 55 percent by 2060, according to the country's water agency. While most is used for industrial purposes, some of it is added to drinking

water supplies in reservoirs in the city-state of 5.7 million people. And the system helps reduce maritime pollution, as only a small amount

of the treated water is discharged into the sea.

This is a contrast to most other countries -- 80 percent of the world's wastewater flows back into the ecosystem without being treated or reused, according to UN estimates.

"Singapore lacks natural resources and it is limited in space, which is why we are always looking for ways to explore water sources and stretch our water supply," Low Pei Chin, chief engineer of the Public Utilities Board's water reclamation department, told AFP.

One key strategy is to "collect every drop" and "reuse endlessly", she added.

# 'Hours on a footnote'

Scientists felt joy, frustration in making UN climate report

After spending hundreds of hours in virtual meetings to complete this week's major UN climate report, scientists Piers Forster and Joeri Rogelj celebrated in a way their peers could not: by hugging.

Britain-based Forster had been

weary of the isolation during the COVID-19 pandemic and invited his co-author to work alongside him in his Harrogate kitchen as they worked with other scientists around the world to thrash out the final version of the report by the Intergovernmental Panel on Climate Change.

Being together for the last stretch of a three-year effort "made it more fun," said Forster, a climate physicist at the University of Leeds.

Specialist scientists, all 234 of them working for free, reviewed more than 14,000 scientific studies published since 2013 to draft the latest version of what has now become the established science on climate change, before coming together – virtually – for two weeks of final checks and negotiations.

Despite travel restrictions and national lockdowns that delayed the report's completion for several months, organisers say they pulled off



the effort with no notable technical glitches to meet their revised deadline.

For many of the scientists, the effort came with a personal cost. "You put a lot of yourself in it," said ETH Zurich climate scientist Sonia Seneviratne, who had to skip a family holiday to help finish the report.

Completing the politically sensitive "Summary for Policymakers" section, which 195 governments must approve by consensus, presented a particular challenge. Each word of each sentence

needed to be scrutinized and debated "We spent sometimes hours on a footnote," said co-chair Valerie Masson-Delmotte, a climate scientist at the University of Paris-Saclay who described work on the report as a "marathon."

But Masson-Delmotte also said the chance to work on pioneering climate research with so many scientists around the world was "one of the biggest joys of my professional life."

Redoan Rony noted filmmaker and CEO of Chorki, along with director Giasuddin Selim, Amitabh Reza Chowdhury, Shihab Shaheen, and Robiul Alam Robi, sat for an interview with Rafi Hossain. In this interview, the directors shared their thoughts on Chorki.





#### **REDOAN RONY**

Chorki is a Bangladeshi video streaming platform, and its journey began recently from July 12, 2021. It serves as a one-stop platform for passionate directors who want to bring forward their best works, stories of Bangladesh, and Bangladeshi originals and cater to avid movie or series lovers all over the world. I am also a director, and I always felt the need for a platform where I could regularly work. Even the directors before me and the rising directors who have the passion to present good stories required a platform to connect and represent their stories globally. And from this thought and requirement, Chorki was created. We were concerned about whether or not the Bangladeshi audience will subscribe and pay to watch content. To our surprise, the projection or target we predicted for a month came in within three days of launch. We were amazed to observe that audiences are subscribing, paying to watch Bangladeshi content, sharing on social media platforms, and even leaving feedback for us regarding the contents or any technical difficulties. The



expected profit ratio from the Bangladeshi audience is already covered. However, I did not expect that the platform would also receive subscriptions with dollars and foreign currencies in such a short time. It is a great achievement that Chorki and its contents are recognized not only

in Bangladesh but around the world. The process of commissioning occurs through two stages of pitching. The primary pitch is presented to our content team, who finalizes the stories from a pool of submissions. We follow a format for the pitch, which includes, story ideas, treatment plan, director's philosophy, budget plan, and so on. The pitch format aims to provide a basic idea to our team to understand the director's vision. The second pitch is presented to our commissioning committee. The committee members are a combination of employees of Chorki, film enthusiasts, young professionals and so on. In this final pitch, when the committee agrees to create the project, it is handed over to the purchase committee. Then the purchasing committee finalizes the commercials and commissioning. Even I will be going through this process if I want to release anything on Chorki. Just because I am the CEO does not mean I will be treated differently. We are trying to improve the standard of this process, and in the future, we believe we can take it to an international level.

**AMITABH REZA CHOWDHURY** When it comes to OTT platforms, content curation is crucial. It is like exquisitely arranging a shelf because there are so many different genres of films and series. When you are providing your audience with such an overwhelming number of choices, they all have to be up to a certain standard. Many other platforms do not have such strict curation. Rony is one of the biggest assets they have. He has been in the industry for a long time, and I know that he will act responsibly when it comes to picking the projects out of a diverse pool. I also think many OTT platforms do not value their content creators as much as they should. The creators and filmmakers along with their work must be respected for these platforms to thrive in the market. Chorki has these creators at the forefront, and I think that is amazing. As for whether televisions will stay relevant,

I would say they definitely will. I agree with Selim bhai. Owners of entertainment channels need to have a unique vision. They need to stand out. Instead, in our country, these channels have more political agendas. It will not work when their primary goal is to provide entertaining content to the masses. Similarly, I believe for a filmmaker it is important to know the main platform for their works. Of course, they can have it on multiple ones. However, the production process would be quite different for each. If it was to be released in cinemas, for example, it would be designed for

> a huge screen with appropriate sound design. Shows primarily released on OTT platforms try to be more engaging and dialogue-focused. Before signing off, I would like to thank all the fans and supporters of OTT platforms in our country. As long as we can provide a decent story made with heart, they are always very appreciative.



### **SHIHAB SHAHEEN**

Our country was missing a full-fledged Bangladeshi OTT platform, and Chorki fulfils that void. With the help of Rony's communication, this platform gives importance to directors and help them achieve recognition in the industry. From my experiences working for both local and international OTT platforms, I never found any of them so well-planned and orderly as Chorki from the very beginning. Now talking about the relevance of television, I feel the industry will remain prominent. Cable television and content released on television is easily accessible to the mass public in Bangladesh. It is mass media which is why I feel it will remain relevant for the coming years. On the other hand, OTT or web platforms viewership is still a niche market in Bangladesh. Finally, I would request our audiences to subscribe and support our projects by streaming rather than downloading through torrents. I am hopeful for Chorki; they have an amazing line-up of projects to be released.



### **ROBIUL ALAM ROBI**

A platform creates identity through its programming and curation, and Chorki is wellorganized in this part. As Rony is a filmmaker and has prominence in the cultural industry, Chorki is organized and maintained properly. My experience working with Chorki for my series was wonderful. As a filmmaker, I had creative freedom and the space to share my ideas. My ideas were appreciated and valued by Rony and Chorki's content team. I got positive vibes and good energy from them. The OTT platforms booming in the market has many contents released, and Chorki being a brand new podium has limited web series or films released right

now and still has time to grow. I feel at this stage, Chorki is still new to be evaluated and compared with other platforms. As for the relevance of television, I also feel there is no reason for the market to fall. Currently, cinema and drama are merging into OTT platforms as web films and series. Before, movies were watched in cinema halls and dramas on television. Now, OTT platforms have made it possible for audiences to enjoy a different type of content in one place. So, I feel television is not losing its value, rather the contents are merged into web platforms. My final thoughts for this discussion ends on a positive note. I hope Chorki will continue to be a platform to not only audiences but also filmmakers like us.

### **GIASUDDIN SELIM**

I believe Chorki stands out because it was thoroughly developed with great care over a long period of time. OTT platforms must appeal to the right audiences. In Bangladesh, it is usually telecom companies that run such platforms with their agendas. The groups behind Chorki consist of passionate individuals who want to bring forth something new. As someone who knows a few of them, I would say they are very transparent and honest businesspeople. They are experienced and well renowned in the entertainment field as well. Needless to say, they would have done quite well even if they worked with television platforms. Then again, this is the age of OTT platforms. Especially with the ongoing pandemic, it is a great time to introduce Chorki, and I believe it will be successful. Adding to it, I want to talk about is the language of our content. For many OTT platforms, it becomes tough to promote films that are not in English. Usually, the dubbing process takes up a long time. However, Chorki's primary target is Bengali audiences. They can put their focus on local shows and do not have to allocate too much time for foreign content. There is always the question of whether these platforms will replace television. I do not think so. The reason television channels in our country are declining in popularity is because their owners lack vision. Television platforms in India and other Western countries are thriving because they have better adapted to modern times. OTT platforms also affect the way shows are produced. I have experience with most contemporary entertainment platforms. So, I know that it is not just the production style that changes with the platform it will be released on primarily. For example, when I am producing a television show, it would also depend on what channel will broadcast it. All in all, I hope Chorki finds success in our country because I have seen the effort put into it. It will greatly support independent filmmakers who have good stories to tell. That is why I encourage everyone to support them and other platforms that strive to bring quality entertainment to your screens!

# Disaster lies at humanity's doorstep

Urgent measures have to be taken to address global climate change

new Intergovernmental Panel on Climate Change (IPCC) report titled "Climate Change 2021: The Physical Science Basis" released on August 9, shows dire consequences for the planet unless we act now. According to it, the Earth's average surface temperature is estimated to hit 1.5 or 1.6 degrees Celsius above preindustrial levels around 2030 in all five of the greenhouse gas emissions scenarios—ranging from highly optimistic to reckless. Just three years ago, the IPCC had predicted that such a scenario would arise nearly a decade later. But the new report projects that humans have less time to act than earlier thought.

One of the reasons for this changed projection is the degradation of natural carbon sinks such as forests, soil and oceans that had absorbed around 56 percent of all the carbon dioxide (CO2) that humanity has chucked into the atmosphere since 1960. But these natural allies of ours are showing signs of becoming saturated, which means they might soak up less carbon from the atmosphere in the coming decades.

The estimates are particularly grim for Bangladesh, as the report predicts that the country is likely to face more frequent and intense heavy rainfalls, flooding, and cyclones due to global climate change in future. Moreover, the frequency of category 4 and category 5 cyclones may increase, which could badly affect coastal areas. Last year, Bangladesh suffered its longest and second-worst flood since 1998, and the IPCC report suggests that the likelihood of such a scenario persisting is quite high. The increased frequency and intensity of rainfall that the report forecasts could also pose a massive danger for agriculture and food security in the long run.

According to environmentalists, the frequency of flood and cyclones has already increased in Bangladesh in recent years. And unfortunately, according to the IPCC, most of these impacts are irreversible, and hence cannot be remediated even if greenhouse gas emissions decline dramatically. Along with that, it also said heatwaves and humid heat stress over South Asia in general will increase and be more severe during the 21st century. This illustrates how this issue extends beyond borders and ultimately concerns everyone.

Even though, collectively, humans may not be able to reverse some of the damage that has already been done, the majority of what is to come can still be prevented. But for that, as the report suggests, humanity must act sooner rather than later. Global leaders, as a result of the pressure that has been exerted upon them by people from all continents, have often made lofty promises to address climate change. However, all too often, we have seen them failing to act accordingly. This is where people must stay relentless. Only the general public's persistent pressure can make global leaders stick to their words and address this grave danger that is now at humanity's doorsteps. If our civilisation is to survive, we must not shy away from this great responsibility of protecting our planet and our species—we must face it head-on.

# Justice must be served for Narayangani fire victims

Probe body finds negligence of DIFE and factory owner

NE of the probe bodies formed after the devastating Hashem Food and Beverage factory fire in Narayangani last month has finally finished their job and submitted their findings, putting the blame on the government's factory inspection department as well as the factory owner for their negligence and lack of compliance with safety rules respectively. The result was, 57 innocent lives were lost, including that of several children. We were loath to call it an accident then, and wouldn't sanctify the killing by labelling it a mishap. The probe report has validated our opinion. In several editorials following the gruesome incident, we had averred that government agencies responsible for exercising oversight must share the blame for the fire and the deaths.

It is because of their acts of omission and commission that factories like the Hashem Food and Beverage in Narayanganj manage to cut corners in matters of safety and wellbeing of the workers. Eventually, the lacunae are exposed but at the cost of precious lives of the workers, as has happened in this instance, and in many other similar instances before.

We had particularly pointed our fingers at the line agency responsible for monitoring safety measures in workplaces, i.e. the Department of Inspection for Factories and Establishments (DIFE). It is shocking and utterly unacceptable that the DIFE had visited the factory, according to our report, a month before the fire, but did not check its safety measures. What they did do was see whether the workers were following Covid-19 safety guidelines. If they had taken the trouble to spend a few minutes there, they would have discovered that nothing inside the factory was going right as far as the safety of workers was concerned. This cannot be explained away as happenstance. Every single rule was being violated, including the fact that the factory was operating illegally, without the clearance of the DoE and the UNO. How could such glaring truths escape their attention?

It is shameful that most of the violations are done in connivance with those that are entrusted to check these violations. We have been crying hoarse about manpower shortages in the DIFE. But even the few personnel the department has do not do their jobs properly. They turn a blind eye to the shortcomings, but not for nothing though. Meanwhile, tragedies keep happening. It is time for the authorities to stop giving lip service to workers' safety and do something substantive about it. Apart from beefing up the operation of DIFE with proper manpower, we believe the errant officials should face severe punishment for their failure to do their duty. The only thing that would be more reprehensible than their criminal negligence is if they, as well as the factory management, escape justice, and if proper checks are not instituted to ensure no such violations take place in the future.

# Should Bangladesh be worried about Vietnam's apparel performance?



outperformed Bangladesh and emerged as the second-most important exporter of apparel in the global market in 2020. Should Bangladesh be

concerned by this? What signals does this transmit for the medium-term prospects of Bangladesh's export-oriented apparel sector?

The recently published WTO Trade Statistical Review 2021 revealed that Vietnam ranked second in terms of export earnings from apparel in 2020, pushing Bangladesh to the third position. Bangladesh's share in the global apparel market has come down to 6.3 percent in 2020 from 6.8 percent in 2019, whilst that of Vietnam has gone up from 6.2 percent to 6.4 percent over the corresponding period.

However, this should not come as a surprise. Since 2010, Vietnam has been in 2020 dipped by eight percent compared to 2019, with global apparel exports coming down by about nine percent. Both Bangladesh and Vietnam experienced falls in export earnings, by 15 percent and seven percent respectively. A large number of enterprises in Bangladesh had to suffer frequent stoppages in production during April to June, 2020. Orders were cancelled, leading to loss of potential export earnings, and significant discounts were asked for, resulting in lower export earnings. Some of the orders that required relatively short lead time were shifted to enterprises in Vietnam, since during this time, enterprises there were operating in full swing. It took some months for Bangladesh's RMG sector to revert back to pre-pandemic levels of production.

As Bangladesh started to recover from the worst impacts of the first wave of the pandemic, towards the end of 2020, the situation gradually got better and orders started to pick up. Over the past few months of 2021, enterprises in Bangladesh have been receiving more orders from major brands and buyers. The situation has indeed been reversed—because of the

that of about seven percent for Bangladesh. Thus, the recent performance of Vietnam did not emerge out of the blue; success was built over the years, by creating and expanding on a number of advantages. Almost three-fourths of Vietnam's apparel destined for the global market is produced by foreign companies, with close ties with foreign buyers, brands and markets. This has allowed the enterprises to be more tuned in to the shifting demand structure

of the global apparel market. One example of this is the structural change in the supply capacity of non-cotton-based apparel. Vietnam's apparel exports are increasingly being dominated by manmade fibre-based items, export of which is experiencing a relatively faster rise in the global market. Vietnam is also gradually moving into fashion and design-based components of the market where prices are higher and domestic value addition is larger. Its emphasis on development of backwardlinkage textile sector, complemented by connectivity with foreign direct investment (FDI) driven forward linkages, provides its apparel sector an added advantage. One issue that is not given due attention, but should merit consideration, concerns net domestic value addition from the export of apparel. Strong backward and forward linkages have meant that domestic value addition in Vietnam has been on the rise in recent years.

What is also to be noted in this connection is that over the past years, Vietnam has been quite aggressively pursuing bilateral and regional trade agreements. These will provide the country preferential market access in the EU thanks to the Vietnam-EU Free Trade Agreement, in the Canadian market by taking advantage of the Comprehensive and Progressive Trans-Pacific Partnership (CPTPP), and in the markets of Japan, Australia and China on account of being a member of the recently concluded Regional Comprehensive Economic Partnership (RCEP). All these will provide Vietnam with a significant competitive edge over Bangladesh, particularly in view of Bangladesh losing preferential market access as a result of its graduation from the LDC group in 2026 (the EU preferential access will continue till 2029).

However, Bangladesh has the potential capacity to compete with Vietnam from a position of strength if the required homework is carried out in full measure during the run-up to LDC graduation over the next five years. Over the past years, Bangladesh's apparel entrepreneurs and workers have demonstrated their capacity to learn and grow in the highly competitive global apparel market. This is owed no less to the policy and financial support provided by successive governments. For many brands and buyers, when they say "China plus one", they consider Bangladesh as the "plus one" country for purposes of sourcing. However, in order to take advantage of this, a renewed effort must be made to improve Bangladesh's performance in several areas.

Bangladesh will need to build industrial parks and RMG clusters with common services and required infrastructure. Policies must be geared to encourage changes at the enterprise level, in such areas as technological upgradation and adoption of advanced technologies, improvements in managerial and management capacities, skills enhancement and raising of productivity. Since many services are embedded in merchandise trade, quality of services, including financial services and digital platform-based services, ought to also be significantly improved as part of raising overall competitiveness of the apparel sector. A time-bound structural shift to cater to the fast growing noncotton segment of the market must be taken through appropriate changes in the incentive structure and with assistance from

While one of the key strengths of

Bangladesh's export-oriented apparel sector is that it has been overwhelmingly a domestic entrepreneurship-driven sector, going forward, Bangladesh should take necessary steps to attract more FDI. A number of initiatives are being taken now in this respect, including establishment of special economic zones. These need to be significantly fast-tracked. To note, FDI flow to Bangladesh was USD 3.6 billion and USD 1.6 billion in the pre-pandemic years of 2018 and 2019 respectively, compared to USD 16.1 billion and USD 15.5 billion for Vietnam. Keeping in mind the upcoming LDC graduation, with consequent loss of preferences for exports, including for apparel, Bangladesh should, as has been the case with Vietnam, aggressively pursue the goal of signing FTAs and Closer Economic Partnership Agreements (CEPAs) with important trading partners. There should be a focus on developing production networks and value chains with regional partners, and with important trading partners such as Canada, Japan and others bilaterally, and also possibly with RCEP, to ensure preferential market access. These will enable Bangladesh to opt for both product diversification and market diversification in RMG. However, this will call for careful preparation, domestic policy reforms, and formidable negotiating skills since, unlike the case for LDCs, such partnerships will entail significant measures of reciprocity and exchange of both offer and request lists.

Bangladesh does have the capacity to face the growing competitive pressure and emerging challenges in the global apparel market, from Vietnam and others, if the past performance of our exportoriented apparel sector is anything to go by. However, at the same time, one should also concede that the future is not going to be a mere progression of the past. It will be what we make of it.

moving strategically to consolidate its position in the global apparel market. Key elements of this strategy included moving up the value chain, and product and market diversification, implemented through targeted policy interventions and actions—and the country has achieved impressive success in pursuing this over the past decade. Vietnam's emphasis on productivity and skills enhancement, and on intra-and extra-apparel diversification, has meant that it has been able to reduce its dependence on apparel while also significantly raising its earnings from apparel exports. The apparel sector in 2020 accounted for about one-fourth of the country's total export earnings of USD 281.4 billion, whereas in Bangladesh, apparel counted for more than four-fifths of total exports of USD 42 billion. Higher productivity and better prices have also allowed the country to pass some of the benefits from entrepreneurs to workers in the form of higher wages. Average wage in Vietnam's apparel sector is about 1.5 times more than that of Bangladesh.

The above should nonetheless be considered with a caveat-2020 was no normal year. The world merchandise trade

resurgence of Covid-19 in Vietnam and its adverse impacts on the economy, some of its orders are being shifted to Bangladesh. Consequently, it is highly plausible that Bangladesh will be able to supersede Vietnam in 2021 and regain its ranking as the second largest exporter of apparel in the global market, a position that it had held for more than a decade. The question is, should Bangladesh be in 2021? In the context of the above mentioned fluctuating fortunes of the

complacent in view of this likely outcome apparel sector, the issue that merits serious assessment is whether Bangladesh will be able to sustain the momentum of the past years over the medium-term future, and whether it will be able to consolidate its position as the second largest exporter of apparel by withstanding the increasing competitive pressure from Vietnam, as well as other challengers like India, Cambodia and Turkey, which are competing in some of the same market segments.

Vietnam's global export market share in 2010 was about 2.9 percent, when the same for Bangladesh was about 4.2 percent. Since then, Vietnam has been able to post an average growth of 11 percent as against

# Latest IPCC climate report shows time is running out to save the planet



of climate change is assessed every six or so years under the aegis of the Intergovernmental Panel on Climate Change (IPCC), which was set up several decades ago by the United

Nations Environment Programme (UNEP) and the World Meteorological Organisation (WMO)—and it consists of

the governments of all UN member states. The IPCC does this assessment by inviting leading scientists from around the world to study scientific literature and assess the latest developments in the science of climate change. It is important to note that the IPCC does not do new research itself, but rather assesses the existing body of scientific research and gives its assessment to the governments, who have the responsibility of approving the final Summary for Policy Makers (SPM) based on the underlying scientific

It is also important to explain that the IPCC is divided into three Working Groups of which the first (WG1) assesses the status of climate science, the second (WG2) assesses the status of impacts, vulnerability and adaptation, while the third (WG3) assesses the status of actions to tackle climate change by mitigation as well as adaptation.

The IPCC is currently reporting its sixth assessment report and, last Monday, the final report of WG1 was released with much fanfare. I had the privilege of being a lead author of the IPCC's third, fourth and fifth assessment reports and have been closely associated in contributing to the IPCC'S WG2 for many years. As

such, I am sharing my take on the major outcomes of the recently released WG1 report of the IPCC'S Sixth Assessment

Report (AR6). The first message is the clear and unequivocal statement that humaninduced climate change, due to the emissions of greenhouse gases over nearly 200 years, has now definitely raised global mean temperature by over one degree

change. These scientists are now able to make these attributions more quickly, as was demonstrated in the last couple of weeks with the heatwave in north-west US and Canada, as well as the wildfires in Greece and Turkey and floods in Germany and China.

In fact, it is probably correct to say that from now on, every record-breaking extreme weather event can be reasonably attributed to having been exacerbated by

many extreme weather events such as heatwaves, wildfires, floods and cyclones that are much more severe than they otherwise would have been.

This is a significant breakthrough in the attribution science for severe weather events, which in the past took a lot of time after the event was over for the scientists to give their verdict on whether they were indeed made more severe because of human-induced climate

human-induced climate change. This is in effect ushering in a new era of loss and damage from human-induced climate change for the foreseeable future for all of humanity

The second major finding of the AR6 is that the global temperature goal of staying below 1.5 degrees Celsius is slipping away rapidly, and unless drastic actions are taken immediately, we may cross that key threshold within a decade. This means

we must enhance the urgency of action in moving away from fossil fuels like coal, petroleum and natural gas as quickly as possible to renewable energy in every country. This means that the Nationally Determined Contribution (NDC), which all countries have submitted or are still about to submit, needs to be truly ambitious to ensure that the 1.5 degree Celsius threshold is not crossed.

The third and perhaps most important message is the possibility of irreversible changes in the physics of the global atmosphere, such as the complete destruction of the Atlantic conveyor system or the release of methane from below permafrost regions like Siberia. These will be such game-changing shifts that the results are completely unpredictable.

The above messages are part of the SPM, while the 4,000-page underlying report has more details of what are the possible climate change related impacts in every region of the world, including in South Asia and Bangladesh. One of the innovations introduced in this sixth assessment report is that location specific impacts data are now available for scientists in each country, including Bangladesh, to delve into. The impacts for the Ganges Brahmaputra river delta show the likelihood of more intense precipitation in the monsoon season, leading to more severe floods, while there could be less precipitation during the dry

season, leading to more severe droughts. The bottom line from the IPCC AR6 is that time is running out and actions have to be stepped up urgently by everyone, especially the governments who will be meeting at COP26 in Glasgow in November this year. There is not a

# Citizens' participation in formulating health policies can be a game changer



days, in the city best known as a democratic city-state, where, arguably, the concepts of citizenship and democracy emerged, there was something called Ecclesia. Here, eligible citizens would gather to have the final say

on legislation and the right to call magistrates to account after their year of office. Unlike a parliament, the Ecclesia's members were not elected, but attended by right when they chose. Although these assemblies weren't always inclusive (i.e. of women, rural people or the poor), I suppose it is a reasonable assumption that at least in certain matters, such as public health, the participation on these platforms would be meaningful.

The healthcare system in Bangladesh is presently battling what Al Jazeera recently referred to as "a double blow", with a sharp spike in dengue cases coupled with the worsening coronavirus crisis in the country. In addition, it was recently reported that mental illness is taking a silent toll on healthcare workers. However, while we are all battling the same storm, we are not all in the same boat. In 2015, the Asia Pacific Observatory on Health Systems and Policies published a report that identified inequitable access to health services between urban and rural areas, including variable health financing mechanisms, as a key challenge. One wonders if the response, or at least part of the response, to this challenge might involve greater citizen participation in policymaking.

While ancient Athenians would probably readily agree, we could, maybe, start with asking three questions. Firstly, would a more participatory process help the healthcare system in Bangladesh, especially in the time of this global health crisis? And secondly, how doable is it? And thirdly, if it eases the burden and is feasible, how much of an active effort exists to ensure that the health policymaking in the country is participatory?

To attempt to answer the first question, we have to clarify what we mean by citizen participation. Citizen participation implies the concept of citizen responsibility, right and governance, making full use of intelligence, knowledge and information in formulating policy. It can ensure that the policy represents the views that are shared by the majority.

Now, to answer the question, does a participatory process help the healthcare system in Bangladesh? Theoretically, the

Now, to answer if it is doable, citizens' participation doesn't necessarily mean that people have to gather in assemblies to give their opinion on policies. Participation is not

the country is participatory. Policymaking in Bangladesh is virtually in the domain of the bureaucracy. In a report published by the Bangladesh Health Watch, Dr M Atiqul Haque, Associate Professor at the Department of Public Health and Informatics of Bangabandhu Sheikh Mujib Medical University (BSMMU), examined citizen participation to identify principal actors and factors based on views of representatives from states, health service providers and the citizens.

The findings of the study were that although stakeholder engagement and communication are theoretically cited as important for ensuring transparency, accountability and effectiveness of public health policies and events, there is very little practical action being taken to ensure that there is active public consultation in the decision-making process. Government officials take it as their responsibility to develop policies and so they do it, but only half-heartedly, by making incremental improvements over something that already exists.

So, the participation of civil society or citizens in policymaking is controlled by bureaucrats and is often challenged by the

unwillingness and ignorance of government stakeholders. The citizen stakeholders, therefore, are purely ceremonial, and not truly valued for their engaged, constructive participation. Without clarity, or even a definition of which citizens are engaged in stakeholder consultations, citizens are only engaged to tick off boxes.

Now that we have discovered that there is room for improvement in terms of engaging citizens more effectively in policymaking, let's ask a fourth question. How do we ensure a more participatory process in decisionmaking? Looking to others might help. In Thailand, for example, the National Health Assembly (NHA) was first convened in 2008 after which until 2019, 85 resolutions from 12 assemblies have been implemented, including resolutions on Thailand's Global Health Strategies antibacterial resistance, illegal advertisement of drugs and health products, daily cycling, waste management, health, and housing, to name a few. Despite learning and adopting from the World Health Assembly, the exemplary Thailand National Health Assembly is often cited for its inclusive participation from the government, academia, professions and people throughout the process.

But like any relationship, the relationship between the state and its citizens is a twoway process. What can we do as citizens? Maybe we can start with asking questions. Questions like, how effectively has civil society organised itself over the years? How familiar are those who have the privilege of literacy and knowledge, with the policies that currently exist in Bangladesh? And if there was such a thing as an Ecclesia in Dhaka, Khulna or Rajshahi, how many of us would be able to make meaningful contributions to policies that have direct bearings on our lives? And if we were making meaningful contributions, how prepared is the state to listen to us and take on board citizens' voices? And until the state and the citizens find an equilibrium where they are both ready to listen to each other, how will things improve?

answer would be yes. Experts agree that effective engagement and a comprehensive pledge from relevant key stakeholders from the very onset are crucial to ensure the development and implementation of effective national policies and strategies. Without the participation of citizens, facilitation and the execution of policy might prove difficult, and multi-sectoral stakeholder involvement is proven to accelerate the process of any political commitment. 
infectious diseases from animals to humans at least as early as the 1800s. The 14th century bubonic plague, the 1918 influenza pandemic, malaria, dengue, HIV/AIDS and Ebola are other examples of public health emergencies originating from animals. The Covid-19 pandemic is also suspected to have emerged from our nonhuman neighbours.

When these health emergencies strike, traditional healthcare systems are swamped and overwhelmed, unable to cope with the sheer numbers of patients. Scientists have showed that ending the destruction of the natural environment can stop pandemics more cheaply and effectively than scrambling to cope with their implications.

Economic aspirations push industries and human dwellings to take over habitats of other species. Thomas Gillespie, associate professor of Emory University, has been studying how shrinking natural habitats cause viruses to jump from animals to humans. Coronavirus, he says, is the tip of the iceberg.

"We cut the trees; we kill the animals or cage them and send them to markets," writes David Quammen, author of Spillover: Animal Infections and the Next Pandemic. "We disrupt ecosystems, and we shake viruses loose from their natural hosts. When that happens, they need a new host. Often, we are it.

Covid-19 has also shown us that unless all countries of the world have adequate healthcare systems, none of us are safe. Even one unaddressed person can spread the disease, bringing economic and health disasters. Today, decent healthcare is concentrated in a few privileged populations.

Only 0.3 percent of Covid-19 vaccines administered to date have gone to people in low-income countries. But unless all of us are safe, none of us are safe. It is the same for our ecosystem. If animals and environment are not given their space with respect, this misbalance may continue in our world.

The need for healthcare that addresses all living beings, regardless of economic disparities, and gives space and respect to every living being we share our world with, is what brought together the likeminded individuals who began the One Sustainable Health (OSH) Forum. OSH is a global,

multidisciplinary effort to address human health in unison with environmental and animal health, led by Secretary General Benoît Miribel; the French doctor, diplomat and historian Jean-Christophe Rufin, who first chaired the Council of Strategic Orientation; and myself, with others who truly believed in this concept.

The forum is supported by the World Health Summit in Berlin, the Geneva Health Forum, and the One Sustainable Health for All Foundation in Lyon. In July 2021 we launched six international working groups to help develop an integrated approach without

These actions and recommendations will be closely linked to changes in the economic, social, energy and ecological paths that will take effect to achieve the 2030 Sustainable Development goals.



## China demands recall of Lithuanian envoy over Taiwan recognition

China yesterday demanded Lithuania recall its envoy to Beijing, after Vilnius allowed Taiwan to set up an office under its own name in a move seen as provocative by the Chinese government.

The self-ruled island, which China considers part of its territory, last month said it was setting up a representative office in Vilnius under the name "Taiwan" as opposed to "Taipei", an act interpreted by Beijing

as a diplomatic insult. An outraged Chinese foreign ministry yesterday said it had "demanded the Lithuanian Government recall its Ambassador to China" and would also withdraw the Chinese envoy to Lithuania.

The decision by Vilnius to allow a Taiwanese Representative Office "severely undermines China's sovereignty and territorial integrity' and "brazenly violates" the ground rules of diplomatic relations between China and Lithuania, the ministry said in a statement.

Beijing claims Taiwan as its own and has vowed to one day retake it -by force if needed.

China tries to keep Taipei isolated on the world stage and refutes any official use of the word "Taiwan" in case it lends the island a sense of international legitimacy.

The Chinese foreign ministry yesterday urged Lithuania to "immediately rectify its wrong decision" and "not to move further

down the wrong path". Lithuania's foreign ministry responded by saying it "regrets this

move by China". "While respecting the principle of one China, (Lithuania) is determined to develop mutually beneficial relations with Taiwan," the ministry said in a statement.

The opening of the Vilnius office is the latest sign that some Baltic and central European countries are seeking closer relations with Taiwan, even if that angers China.

In May, Lithuania announced it was quitting China's 17+1 cooperation forum with central and eastern European states, calling it

"divisive". It has since pledged to donate 20,000 coronavirus vaccine doses to Taiwan.

And in 2019, Prague cancelled a sister-city agreement with Beijing and signed one with Taipei, while a high-profile visit to Taiwan last year by Czech senate leader Milos Vystrcil infuriated China.

China cut official contact with Taiwan and ramped up diplomatic pressure after the 2016 election of

President Tsai Ing-wen. Tsai, who won re-election by a landslide last year, rejects Beijing's stance that the island is part of "one China" and instead views Taiwan as a de facto sovereign state.

# Haiti chooses judge to probe president's assassination

AFP, Port-Au-Prince

After weeks of struggling to fill the job, a senior magistrate in Haiti on Monday announced that a judge has been named to lead the probe into the assassination of president Jovenel Moise.

The dean of the Court of First Instance in Port-au-Prince, Bernard Saint-Vil, said that Judge Mathieu Chanlatte was chosen for the job.

Chanlatte "will not be intimidated," said Jean Wilner Morin, president of the National Association of Haitian Magistrates.

"It is an investigation that will take time. We also hope that the authorities will put all the necessary resources at the disposal of magistrate Chanlatte and will also ensure his safety," Morin said.

A hit team burst into the presidential residence on July 7 and shot Moise dead. His wife Martine was wounded but survived.

Human rights defender Pierre Esperance said he hoped that Chanlatte would treat the case "with the law as a compass, without falling

into political persecution." Minister of Justice and Public Security Rockefeller Vincent said that his ministry would take all measures necessary to guarantee the safety of judges as well as courtroom evidence.

Police say they have arrested 44 people in connection with the killing, including 12 Haitian police officers, 18 Colombians who were allegedly part of the commando team, and two Americans of Haitian descent.

The head of Moise's security detail is among those detained in connection with the plot allegedly organized by a group of Haitians with foreign ties.

Moise had been ruling the impoverished and disaster-plagued nation by decree, as gang violence spiked and Covid-19 spread.

# Indira calls upon nations

INDIA, RUSSIA WANT POLITICAL **SOLUTION** 

The Soviet Union and India today called for a political solution of the Bangladesh issue. In a joint statement issued after four days of discussion, both countries demanded that the following actions should be taken to resolve the crisis: 1) stoppage of military atrocities by Pakistani troops, 2) stopping of the exodus of people from East Bengal to India, and 3) creation of conditions for safe return of refugees from India.

Secretary General Thant appealed today for more money to help send relief to East Pakistan. A statement issued by his office said also that the first United Nations aid personnel had reached East Pakistan, with the main object of seeing "that all supplies, reach their destination, the people of East Pakistan". The statement today indicated that the United Nations cash receipts were less than a tenth of the amount estimated as necessary for the first phase of relief work.

# Navalny allies face fresh criminal charges in Russia

Two exiled aides of jailed Kremlin critic Alexei Navalny were slapped with new criminal charges for helping to finance organisations that have recently been labelled "extremist", Russian investigators said yesterday.

Navalny's movement is facing unprecedented pressure in Russia as his Volkov and Zhdanov announced main groups have been de-facto banned in the country, while the opposition leader is serving two and a half years in prison on old fraud charges. President Vladimir Putin's most vocal

domestic critic was sent to jail in February after returning to Russia from Germany following a near-fatal poisoning attack that he blames on the Kremlin.

Russia's Investigative Committee said on yesterday that it had launched a criminal case against Navalny allies Leonid Volkov and Ivan Zhdanov over the "collection of funds and provision of financial services deliberately intended to finance an extremist organisation".

The charges carry a maximum penalty of eight years in jail.

Volkov, 40, was in charge of Navalny's disbanded network of

regional offices. Zhdanov, 32, headed the Anti-Corruption Foundation (FBK) that publishes investigations into the wealth of Russia's elites. The organisations were labelled

"extremist" in June for allegedly plotting an uprising with support from the West. "Knowing that these organisations

were recognised as extremist, the continuation of their illega activities and organised a fundraiser, investigators said in a statement. Both Volkov and Zhdanov reside

outside Russia and are wanted by Moscow on other criminal charges.

"I've already lost count of the number of criminal cases that have been launched against me," Zhdanov wrote on his Instagram yesterday.

Navalny's close allies still in Russia are under close law enforcement supervision, some under house arrest.

Last week, Navalny's brother Oleg was handed a one-year suspended sentence for breaching coronavirus rules by calling on Russians to attend an unsanctioned rally. Key ally Lyubov Sobol was sentenced to a year and a half of restricted movement in the same case.

"Most plants develop a leaf, and that's it," says Andrew Leitch, a plant geneticist at Queen Mary University of London. "This plant can live thousands of years, and it never stops growing. When it does stop growing, it's dead."

Some of the largest plants are believed to be more than 3,000 years old, with two leaves steadily growing since the beginning of the Iron Age, when the Phoenician alphabet was invented and David was crowned King of

By some accounts, Welwitschia is not much to look at. Its two fibrous leaves, buffeted by dry desert winds and fed on by thirsty animals, become shredded and curled over time, giving Welwitschia a distinctly octopus-like look. One 19th-century director of Kew Gardens remarked, "It is out of the question the most wonderful plant ever brought to this country and one of the ugliest."

The agreement to sign the 34-year-old Argentine is a major coup for wealthy PSG. Wearing a T-shirt that read "This is Paris," Messi beamed and waved at scores of fans who had come to greet him at Le Bourget airport on the outskirts of the French capital after his flight from Barcelona. Chanting "Messi, Messi, Messi," the fans cheered and let off firecrackers. "It's going to be mad. After all, it's a legend who is arriving," said Florent Chauveau, a PSG fan. Reuters





# **PSG** reunite Messi and Neymar

The prospect of seeing Lionel Messi team up again with Neymar will have many football fans around the world salivating.

A team, PSG, that missed out on the Ligue 1 title last season but who in the last two campaigns reached a Champions League final and semi-final, now appear well set to land a first European Cup.

The model is the Barcelona team of 2014/15 which won the treble with Messi scoring 58 goals and Neymar 39. The third man, then, was Luis Suarez who added 25

Now the third man is Mbappe. It is over to Pochettino, Messi's compatriot, to accommodate them all, and Angel di Maria, and find the right balance to make a team of champions as well as a modern-footballing version of the Harlem Globetrotters

Not all of fans will rejoice. Many will struggle to come to terms with Messi leaving Barcelona. Others would have preferred to see him go to a club where he really could have a transformative impact, like Diego Maradona at Napoli.

But modern football is now dominated by a narrow elite financed by mega-rich owners, state wealth in the case of Qatar-backed Paris Saint-Germain and Abu Dhabi's Manchester

Add in Roman Abramovich's Champions League winners Chelsea and even the likes of Barcelona and Real Madrid can't keep up. It is another bitter blow for Barca, who in 2017 were powerless to stop Neymar going to Paris for a world record 222 million euros (\$264m), setting off the chain of events that led to Messi heading the same way.

Barca ruined themselves in the transfer

market trying to replace Neymar to the extent they could not keep their greatest ever player due to La Liga's financial fair play rules.

PSG are not immune from the financial difficulties caused by the pandemic, but they are better placed to survive the economic downturn. PSG lost 124.9 million euros before tax in the 2019/20 season which was curtailed by the pandemic. Last season's figures are likely to be far worse, reportedly



around 230 million euros, with PSG almost entirely deprived of gate receipts as games were played behind closed doors while French TV revenue went off a cliff after the collapse of a record deal with Mediapro.

Yet they have splashed out in the transfer market, spending 60 million euros (\$71 million) on Inter Milan right-back Achraf Hakimi and signing several big-name players who were out of contract in Sergio Ramos, Georginio Wijnaldum and Gianluigi Donnarumma. Wijnaldum was snatched from under the noses of...Barcelona.

PSG can do it because their Qatari owners are there to cover the losses and because, for now at least, French league rules do not stop clubs having a wages to income ratio of almost 100 percent, as it was in 2019/20.

# What direction do Tigers take now?

The historic 4-1 series win against Australia was the most significant series win in the T20 format, considered to be Bangladesh's Achilles heel. It will be a

massive confidence boost ahead of the T20 World Cup, especially for a side missing a few key players, but in terms of preparations with two months to go until the tournament, how the latest series win adds up remains to be seen. And with the New Zealand series on the horizon, what should be Bangladesh's intention going forward?

The Tigers found lots of value as a number of young players displayed the character, attitude and confidence required

in international cricket. Facing Australia's skill with the ball, there

The balls kept low, the new batsmen from both sides found going tough and even after spending time at the crease, failed to play

Bangladesh's batsmen, used to such surfaces, consistently fell 10-15 runs short when batting first and that should be concerning as the rub of the green -- a very literal one in this case -- will not favour the Tigers' away from home, where the batsman will again have to adjust.

"The team winning is the most important, although o this slow, low, turning wicket, batsmen will probably not score many runs," ace all-rounder Shakib said after the

The question now is whether the thinktank will think about another series win on low, turning tracks against New Zealand or give some much-needed focus on the

were many intense scenarios that played out in this series. Handling pressure situations has always been a worry for the Tigers and in that regard the just concluded series will breed necessary belief.

In essence, Bangladesh arguably gambled that the team would succeed in executing its plans. The team think-tank was reliant on the fact that Bangladesh bowling would fare better than their counterparts and although four of the five T20Is were close contests, it was largely the bowlers that made the difference, using the conditions to their fullest potential in tight situations.

Ultimately, discussions around those conditions are a different issue altogether. In terms of winning the series, there would not have not been better conditions anywhere else to pull off a feat of the magnitude. The Bangladesh Cricket Board (BCB) had insisted on playing matches in different venues and not just Mirpur but Australia, keeping the pandemic in mind, opted for just one venue.

On these wickets, neither team's scores exceeded the 131 runs that Bangladesh posted in the first T20I. In their 144-year history, Australia produced their shortest innings in any format, plummeting to 62 all out in the final T20I. It was also their lowestbatsmen's room for improvement.

With Bangladesh not scheduled to play any more T20Is after the New Zealand series, the focus ideally should be to play on pitches that resemble conditions in UAE, where the World Cup will be played. Shakib will probably get an opportunity to play in the IPL leading up to the tournament and can use that opportunity to adapt to the wickets, but the same cannot be said of the

Australia skipper Matthew Wade said that the pitches in the West Indies were better suited to gauging their performances, reiterating that conditions in ICC tournaments would not be similar to those in Bangladesh. In fact, the conditions in Bangladesh were extreme, especially for the

Ahead of the 2015 World Cup, the Tigers, went to Australia under coach Chandika Hathurusingha early to prepare and acclimatise to conditions. They lost warmup matches to Ireland and Pakistan, but those defeats did not hinder the experience gathered from such matches. Even at the expense of losing the upcoming series, should the Tigers prepare better tracks against the Kiwis to properly gauge themselves and prepare for the tournament?

Nurul's urgency for home comforts

cannot be downplayed as it has been a long time since the cricketers have had a respite. The harsh realities of the Covid-19 pandemic forced the cricketers to leave one bio-secure bubble only to enter another, compelling them to stay away from their families even when living in the same city. Prior to the series against Australia was a

tour of Zimbabwe for a full series, starting from July 7. But instead of going back home after returning from Harare on July 29, the Tigers entered a bio-secure bubble at the Hotel InterContinental straight from the airport for the Australia series.

However, in spite of all the obstacles, Nurul said the cricketers had one objective in mind and never strayed from it.

"When we went to Zimbabwe, we knew it would be a long tour. We had been talking about the Australia series even when we were in Zimbabwe. We were mentally prepared to focus on the Zimbabwe series and give our best in the series against Australia as well," Nurul said.

"We had to stay at the hotel [to quarantine]

even after arriving in Dhaka from Harare. But we had that mental preparation and we had one objective -- to stay focused till we complete the mission. That's what happened and we were very lucky that we played well," he added, also mentioning that his family had been enduring a bit of a crisis due to his wife's being unwell and that he was relieved to finally be back home.

Even before the month-long tour of Zimbabwe, the cricketers had been engaged in the Bangabandhu Dhaka Premier League, for which they had to quarantine for about a month. Prior to that, touring Sri Lanka for two Tests followed by the Lankans' visit for three ODIs kept the Tigers busy and away from their loved ones. With the stress of maintaining health protocols and undergoing numerous Covid tests, the Tigers had to soldier through long stretches of time away from family with just a few visits in between and their yearning to return home was not only understandable but natural.

With that said, Bangladesh's future assignment is already set. Mahmudullah Riyad's men are scheduled to host New Zealand for a five-match T20I series from September 1 to 10. The BCB also mentioned it was contemplating putting players in quarantine for the series from August 24, the same day the Kiwis are set to arrive in Dhaka.

The Tigers may now be deservedly enjoying a brief period away from cricket, but they certainly know what they need to do when they resume. At least Shakib, according to Nurul, made sure during his speech in the dressing room after Australia series win that the Tigers understand the need to 'keep up this momentum' when they face New Zealand next month.

# **DGHS** orders closure of 7 pvt facilities

All hospitals, diagnostic centres, blood bank located in single building in Mohammadpur

The health directorate yesterday ordered seven private hospitals, diagnostic centres, and a blood bank in the capital to close down all activities after it found widespread anomalies in those establishments during a recent

The seven establishments are Prime Orthopedic General Hospital and Digital Diagnostic Centre, Dhaka Healthcare Hospital, Remedy Care Limited, Life Care General Hospital, Jamuna General Hospital, Royal Multi-Care Specialty Hospital, Diagnostic Centre, and Rajdhani Blood Bank and Transfusion Centre.

All seven institutions, located at the Muktijoddha Tower in Mohammadpur, were inspected by a DGHS team on July 28, according to the order.

The Directorate General of Health Services (DGHS) also issued show-cause notice as to why licences of those institutions would not be cancelled.

DGHS Assistant Director Mohammad Habib Ismail Bhuiyan and Medical Officer Mahmud Ullah signed the order with approval from the director general.

We appeal to you to exercise your influence with President Yahya Khan to take a realistic view in the larger interest of the peace and stability of this region."

# Plant that 'can't die' reveals its genetic secrets

The longest-lived leaves in the plant kingdom can be found only in the harsh, hyperarid desert that crosses the boundary between southern Angola and northern Namibia.

A desert is not, of course, the most hospitable place for living things to grow, let alone leafy greens, but the Namib Desert — the world's oldest, with parts receiving less than 2 inches of precipitation a year — is where Welwitschia calls home.

In Afrikaans, the plant is named "tweeblaarkanniedood," which means "two leaves

# Thousands flee homes in north

UN warns of possible war crimes as another city falls to Taliban

The Taliban seized another Afghan provincial capital yesterday -- the seventh in less than a week -- as tens of thousands of people fled their homes in the north for the relative safety of Kabul and other centres.
