# Hope revives in Jaldhaka, Dimla

In a positive development amid the ongoing drought-like situation in the North, the Buri Teesta irrigation project has resumed operations in Jaldhaka upazila after it had remained inoperative for a decade.

Bangladesh Water Development Board (BWDB) hopes to bring around four thousand acres of croplands in Jaldhaka and Dimla upazilas under the coverage of the irrigation network initially.

BWDB officials said that after recording only 824 millimetres of rainfall in April-July, as opposed to 1,881 millimetres during the same period last year, they decided to expedite the restoration work of the decades-old project with the help of local farmers in order to save droughtstricken Aman paddy fields in the region.

The farmers voluntarily joined hands with the BWDB to repair breaches in the banks of canals, dig earthen channels and level out uneven or raised canal beds.

Despite unavailability of funds for the project's rehabilitation work and limited work force, the BWDB made a wholehearted effort in reviving the much-needed irrigation scheme in the area.

Implemented in 1968 at Kaliganj village, the irrigation scheme has a 91-meter-long barrage, a water reservoir on 1,200 acres of land and a 30-kilometre-long network of canals to irrigate 5,500 acres of cropland.

The project, however, got sidetracked in 1998 when the Teesta irrigation project, the largest of its kind in the country, was launched in Dimla upazila.

Eventually, pieces of land belonging to the Buri Teesta irrigation project started to go in the possession of land grabbers. The final blow to the project came in 2010 when the then BWDB authorities leased out its reservoir to fish farmers.

Locals took the matter to the High Court, which issued a stay order on fish

farming or irrigation operations in the project area.

After ten long years, in 2020, the High Court cancelled the lease and lifted the stay order. But the irrigation project by this time became almost non-functional.

SR Shafik Sadik, president of Buri Teesta irrigation management committee of farmers, said, "We demanded water for irrigation so that poor rainfall cannot hamper Aman cultivation amid Covid-19 situation. We assured the BWDB that we would repair the canals by ourselves and despite their limitations, the BWDB extended their cooperation."

BWDB Sub-divisional Engineer Abdul Hannan Prodhan said, "We started discharging irrigation water from 28 July, although most of the project's infrastructure was vulnerable and [we had] no fund available."

The BWDB arranged money for major repair work from its general maintenance

fund and the farmers built channels to bring water to about four thousand acres of cropland.

The coverage area is increasing gradually, he added.

Birendranath Roy, a farmer from Rashidpur village, said, "We made earthen channels, repaired breaches in the banks [of canals] on our own to bring water in to our land."

The production cost will now go down and proper irrigation will ultimately result in better yield of crops, hoped Ashraful Islam, another farmer from Taluk Golna village.

Abdullah Al Mamun, executive engineer of BWDB in Nilphamari, said, "In Covid-19 times, it was a challenge to ensure irrigation through a project that had been inoperative for ten years. But we have succeeded." "We are likely to expand it in future as a

new project is underway," he added.

## Man held for raping 6yr-old in Rangpur

Rapid Action Battalion (Rab) on Tuesday arrested a young man from Gaibandha in connection with a case for raping a minor girl in Rangpur's Pirgachha upazila.

The arrestee, Tushar Imran, a resident of Norsingha village in Pirgachha upazila, was produced before a court yesterday that sent him to jail.

Rab officials said father of the six-year-old victim filed a case with Pirgachha Police Station accusing Tushar on August 8, but the culprit went into hiding since the incident occurred on July 28, Commander of Rab-13 in Rangpur Reza Ahmed Ferdous said at a press conference held at Rab-13 Headquarters in Rangpur yesterday.

Based on secret information, a team of Rab-13 arrested Tushar from one of his relatives' house in Gaibandha Sadar upazila on Tuesday afternoon, the official said, adding that the arrestee was handed over to Pirgachha Police Station.

According to the case statements, the minor victim was playing nearby her house on July 28 afternoon.

At one stage, neighbouring Tushar suddenly appeared on the scene, lured the girl to his house and raped her there.

When the victim cried for help, people nearby rushed to the spot, rescued her and rushed her to Pirgachha Upazila Health Complex, from where she was later shifted to Rangpur Medical College Hospital for better treatment.

Manzill Murshid also said the officials concerned, including the DG of DGDA, are not taking any steps against Indo-Bangla Pharmaceuticals, which is disrespectful to the HC directives and also contempt of court, and a punishable offence.

The countries are China, Thailand, Indonesia, Vietnam, Philippines, Mongolia, Cambodia, Pakistan, Bangladesh, Nepal, Myanmar, Uzbekistan, Sri Lanka, Timor-Leste, Kyrgyzstan and Laos, says EPS' official website.

BOESL, owned by the government, is the lone agency sending workers from Bangladesh to South Korea under EPS.

Billal Hossain, BOESL's managing director, on Monday said the visa embargo put by South Korea on new EPS workers is still in place.

However, following negotiations, the Bangladesh government was able to resume re-entry of some old workers, he told this newspaper over the phone. He said they held a meeting with

the director of the Human Resources Department of South Korea recently to get the visa embargo lifted. Besides, they were negotiating through the Bangladesh foreign ministry.

If necessary, the BOESL MD said, they are ready to intensify any measures including accommodation and food for workers, it a quarantine facility, which is already in place.

The overall visa embargo that South Korea put on Bangladesh was due to the Covid-19 situation while BOESL's concern

is regarding the migrant workers under the EPS, he further said.

Mokima Begum, first secretary at the labour wing of the Bangladesh Embassy in Seoul, recently said they have kept all sorts of efforts ongoing to have the visa embargo lifted.

She said the embassy has already sent a note verbale to the South Korean authorities concerned for withdrawal of the embargo.

As workers are unable to get jobs due to the visa embargo at present, this has left many of them in frustration, Mokima told this newspaper via WhatsApp.

According to BOESL's 2019-2020 annual report, Bangladesh signed a memorandum of understanding with South Korea in 2007 for the recruitment of Bangladeshi workers under EPS and started sending workers through BOESL the next year.

The age range for workers wanting to migrate under EPS is 18-39 years while the total migration cost is \$1,115 including airfare, states the report. Such workers usually earn about Tk

2 lakh a month, including overtime. Sometimes, employers provide free also states.

Abdullah, known as Lion of Kashmir, joined the chorus of appeals to save Bangabandhu's life. He sent a telegram to Pakistan President Yahya Khan today asking the latter to withdraw prosecution of Bangabandhu and enter into fruitful negotiations with him to identify a political settlement.

Sheikh Abdullah, who had broken his long silence over the development in Bangladesh, said in his telegram: "The unfortunate developments in East Pakistan constitute basically a human and not a law and order problem. A broadminded liberal policy is therefore called for to bring about a lasting solution."
