Taliban close in on Kabul

Capture Ghazni, Herat; Afghan govt offers to share power with insurgents, say media reports

Agencies

The Afghanistan government has made a power-sharing proposal to the Taliban in exchange for a halt in the escalating violence in the country, media reports said yesterday, as the insurgents seized the strategic cities of Ghazni, just 150 kilometres from Kabul, and Herat, the country's third-largest city.

A senior security source from Herat told AFP that government forces and administration officials had retreated to an army barracks outside the city.

"We had to leave the city in order to prevent further destruction," he said.

A Taliban spokesman, however, tweeted "soldiers laid down their arms and joined the Mujahideen"

Herat -- about 150 kilometres from the Iranian border -- is home to veteran warlord Ismail Khan, who for weeks has been rallying his forces to make a stand against the Taliban.

The Taliban also appeared close to capturing Kandahar, the second largest city and the spiritual home of the Taliban, which now control about two-thirds of Afghanistan.

Earlier, the interior ministry confirmed the fall of Ghazni, which lies along the major Kabul-Kandahar highway and serves as a gateway between the capital and militant strongholds in the south.

The capture of Ghazni is their most important strategic gain in a lightning offensive that has seen them overrun 10 provincial capitals in a week. SEE PAGE 2 COL 3



The government is lifting most of the coronavirus restrictions from August 19, even as the number of deaths reported daily from Covid-19 continues to be over 200.

Social gatherings will be allowed and tourist destinations will reopen on the condition that they operate at half their capacities.

The Cabinet Division in a circular yesterday said all public transport will be allowed to operate on the roads, railways and waterways maintaining health guidelines from August 19.

Transport companies are currently allowed to operate 50 percent of the buses on the roads.

From August 19, community centres, tourist attractions and recreational facilities will reopen and operate at half of their capacities.

However, the authorities have not specified how crowds will be controlled at places like sea beaches.

The decision was based on discussions at an inter-ministerial meeting on Covid-19 on August 3 and the overall situation of the country, the circular said.

It said everyone must wear a mask and follow the other health rules. If any of the conditions are violated, the authorities concerned will be

held responsible, it added.

vaccination drive expected

The drive's duration will depend on the availability of the shots, said health officials, adding that only Sinopharm jabs would be administered as first dose during the campaign, which has been planned mainly to vaccinate the elderly and those living in rural areas.

The plan was outlined as a six-day special vaccination piloting ended yesterday. Around 48 lakh people received their first shot during the drive, said officials.

The government had targeted to vaccinate 32 lakh people in the piloting, launched on August 7 on the sidelines of the regular vaccination campaign. It had to raise the number in the face of huge demand and massive response from people across the country.

"We are planning to launch a similar drive on August 17. The length of the drive will depend on the availability of vaccines. If we get a small number of vaccines, the drive may run for even a single day," Prof Abul Bashar Mohammad Khurshid Alam, director general of the DGHS, told The Daily Star yesterday.

Earlier, the government had planned to launch a special drive on August 14-19 but backtracked due to vaccine shortages. Sources in the Directorate General of Health Services (DGHS) said they have

a plan in place to start a countrywide campaign with fresh consignments of vaccine doses arriving in the country. SEE PAGE 2 COL 1

ATTACK ON 2 BANKERS Dhaka court clears Sikder brothers of charges

A Dhaka court yesterday cleared Ron Haque Sikder, managing director of Sikder Group, and his brother, of the charges of abducting, torturing, and opening fire on two Exim Bank officials.

Dhaka Metropolitan Magistrate Rajesh Chowdhury passed the order after complainant of the case Exim Bank Director Lt Col (retd) Serajul Islam told the court that he had no objection if the court accepted a police final report.

During the hearing on the probe report, Ron was present in the court. He had obtained bail.

His brother Dipu Haque Sikder, now abroad, was shown as absconding.

On July 29, investigation officer Md Ripon Uddin, a sub-inspector of the Detective Branch of police, submitted the report to Chief Metropolitan Magistrate's court of Dhaka mentioning that an out-ofcourt settlement had been reached. SEE PAGE 2 COL 6

MACHINE-READABLE PASSPORTS No explanations yet on 1.5 lakh pending requests

When over 1.5 lakh applications for machine-readable passports are pending for some two months, the authorities have yet to come up with any official explanations about what led to this situation and when and how it is going to be addressed.

Bangladesh missions from different countries over the last months wrote to the Department of Immigration and Passports (DIP), describing the problems they were facing as passport processing was either delayed or not delivered to Bangladeshi migrants.

Migrants said they were becoming undocumented or failing to apply for renewal of work permits due to the delay in getting passports. They also said they were facing trouble accessing healthcare at a time when the pandemic is causing havoc to the migrants through joblessness and infections

Some officials also said it might lead to a security breach that so many passport applications have been pending for so long. They questioned why the DIP did not take actions to upgrade the software system well ahead of the time when the 30-million limit of the MRPs was crossed in early June.

Rohingyas in Bangladesh Canada to provide CA\$ 288m as humanitarian aid

Canada has earmarked 288 million Canadian dollars (around Tk 1,951 crore) to provide humanitarian assistance to Rohingya refugees in Bangladesh for the next three years.

Besides, 45 million CAD (around Tk 305 crore) has been allocated for the marginalised people over the next five years.

It has also assured Bangladesh of its support in areas of vaccination, climate change, and LDC issues.

The announcements came from Karina Gould, Canada's Minister for International Development, separately in two virtual meetings -one with Bangladesh Foreign Minister AK Abdul Momen on Tuesday and the other with Brac Executive Director Asif Saleh yesterday.

During the meeting with Momen, Gould said the Rohingya issue remains a foreign policy priority for Canada. She urged Bangladesh to facilitate education for Rohingya children.

Gould said Canada will consider financial support for the Rohingya genocide case at the International Court of Justice.

Momen urged Canada to take a leadership role in the Rohingya repatriation process, saying investments in education, health and pathway to citizenship for the Rohingyas in Rakhine would encourage displaced Rohingyas in Bangladesh to return to their homeland.

The foreign minister also requested the Canadian government to extend preferential trade access for graduating LDCs, including Bangladesh, till 2030 in order to help address the postpandemic scenario.

To Momen's request for vaccine, Gould said Canada has so far contributed 545 million dollars and 30 million surplus doses to the COVAX and ensured that Canada would give due consideration to the

As security forces retreated across the country, Kabul handed a proposal to Taliban negotiators in Qatar offering the power-sharing deal, according to a member of the government's team in Doha who asked not to be named.

A second negotiator, Ghulam Farooq Majroh, said the Taliban had been given an offer about a "government of peace" without providing more specifics,

The proposal has also been reported by Afghanistan's local media and Al Jazeera yesterday.

Despite the ongoing Doha talks, US State Department spokesman Ned Price yesterday acknowledged that "all indications" point to the Taliban seeking a "battlefield victory."

The White House on Wednesday confirmed that, despite the Taliban's military gains, the United States would complete its troops withdrawal by end of August.

Signaling the worsening situation on the ground, US Embassy in Kabul yesterday urged US citizens to leave immediately using Afghanistan available commercial flight options.

The Pentagon later said that it was deploying around 3,000 troops to Afghanistan immediately to evacuate US embassy employees securely as the threat grows from the Taliban insurgency.

The UK government also said it was sending troops to help its embassy staff leave Afghanistan.

In the report, the IO said both the complainant and the accused signed an agreement on July 8. The case had "factual error" as the ballistics report said the shots were not fired from the firearm concerned, it added.

Another 242 hospitalised with dengue

At least 242 people with dengue fever have been admitted to hospitals in the country during 24 hours, till 8am yesterday. Of them, 21 are from outside Dhaka.

With them, a total of 5,434 patients have been diagnosed with dengue this year, according to the Directorate General of Health Services (DGHS).

Of the total infected, 260 are from outside Dhaka.

Among the total infected, 2,776 were diagnosed during the current month.

At least 2,286 people were hospitalised across the country in July and 272 in June. In May, 43 people were infected with dengue.

Though most of the patients who were hospitalised have so far been released, 896 are still undergoing treatment at hospitals across the country, the DGHS data shows. Meanwhile, ABM Khurshid Alam,

JS body opposes WB proposal of integrating Rohingyas into Bangladesh **R**ASHIDUL HASAN

A parliamentary body yesterday strongly opposed the World Bank's reform proposals, including the inclusion of Rohingya refugees in the host country

The parliamentary standing committee on foreign affairs ministry has asked the ministry concerned to be vigilant in this regard, citing the proposal as an intention to allow Myanmar's displaced Rohingyas to settle permanently in Bangladesh.

The meeting was held in the Jatiya Sangsad Bhaban.

Muhammad Faruk Khan, chief of the parliamentary body, said, "We have told the ministry that the World Bank wants to make permanent arrangements for the Rohingyas by making such proposals. All these proposals for the settlement of Rohingyas cannot be accepted. We have clearly opposed it. We have said very strongly that we should not fall into the trap of the World Bank."

"We have also told the foreign ministry that statement in this regard will be clear that we have given them temporary shelter. You [World Bank] should make arrangements for their return to Myanmar. We will not accept such proposals to construct buildings for them and giving them opportunities for work and to buy land," he added.

Faruk Khan, also a ruling Awami League MP, said they have told the foreign ministry that their first agenda while discussion with the World Bank will be how to send Rohingyas back to Myanmar.

The Supreme Court yesterday upheld the High Court orders that stayed the government decision for cancelling freedom fighter status of 196 retired members of army, Border Guard Bangladesh (BGB) and Bangladesh Air Force (BAF), and also directed the government to give them benefits as freedom fighters.

A five-member bench of the SC's Appellate Division headed by Chief Justice Syed Mahmud Hossain dismissed five appeals filed by the government, challenging the HC orders

Lawyers Ahsanul Karim, Sabrina Jerin and Abdul Qaium appeared for the freedom fighters while Additional Attorney General SK Md Morshed represented the state during the virtual hearing.

Following the five petitions, the HC on September 21 last year stayed the government decision of cancelling the freedom fighter status of 196 retired members of Army, BGB and BAF, and also directed the government to give them benefits as freedom fighters.

On June 7 last year, the Liberation War affairs ministry issued two gazette notification cancelling freedom fighter status of 1,134 retired BGB personnel and 47 retired BAF personnel, including the 196 petitioners, on charge of obtaining the status by placing forged documents.

RAPE, MURDER OF UNIV STUDENT Apex court stays bail of accused

The Supreme Court yesterday stayed a High Court order that granted six weeks' bail to Mortuza Raihan Chowdhury, an accused in a case filed over the rape and murder of a private university student in the capital, in January this year Justice Obaidul Hassan of the Appellate Division passed the order following a petition filed by the state seeking a stay on the HC order.

The ferries were taking extra time to cross the river, resulting in fewer trips. Consequently, a long queue of vehicles waiting to board ferries was noticed at the terminals.

The routes are Paturia-Daulatdia and Shimulia-Banglabazar. Paturia is located in Manikganj, while Daulatdia is in Rajbari. Shimulia is in Munshiganj and Banglabazar in Madaripur. The two routes are considered gateways to 21 southern districts of the country.

At Paturia terminal, over 500 goodscarrying trucks, and 70 long-distance and 80 small buses were seen stuck yesterday evening, as ferries were moving slowly.

Normally, a ferry takes around 30 minutes to cross the river, but now it requires around 45 minutes, said ferry operators.

Traffic flow increased in the last two days, after withdrawal of the lockdown, but ferry trips were fewer. That is why congestion was created, said Md Zillur Rahman, deputy general manager (commerce) at Manikganj's Aricha zone office of BIWTC.

A similar situation was noticed in Simulia terminal

Normally, it takes around one hour and 20 minutes to cross the river on the route. But each of the ferries took over two hours to cross the river yesterday, said BIWTC officials.

Around 600 vehicles were seen waiting at both Shimulia and Banglabazar terminals.

Passenger vehicles had to wait five to seven hours to board ferries, while cargoladen vehicles had to wait more, said Md Faysal, BIWTC's manager at Shimulia terminal

The victim later fell sick and died on January 31 while undergoing treatment at a city hospital.

Samsung teams up with Google to challenge Apple Watch

While the rate of development in phones appears to be slowing lately, the rate of development in wearables has the potential to accelerate. In the wearables arena, nothing in the Android ecosystem compares to the Apple Watch in terms of quality and utility. So without a viable alternative for Android users, Apple is increasingly likely to continue gaining users.

But finally, Samsung appears to be ready to make a serious attempt to re-enter the wearables market, teaming up with Google. Samsung is expected to unveil two new smartwatches on August 11th: the Galaxy Watch 4 and Galaxy Watch 4 Classic, both of which have been widely rumored. And with this new release, the wearables war between Samsung, Google and Apple takes a new shape as the company that stands to gain the most from the success of these watches is Google, not Samsung.

Despite its purchase of Fitbit and rumors that Google is working on a Pixel watch, Samsung will be the first to release Wear OS 3 smartwatches. They'll be based on Google and Samsung's collaboration, which was announced at Google IO earlier this year.

In other words, Samsung is abandoning its own Tizen watch OS in favor of contributing parts of it to a resurrected version of Google's dormant Wear OS. Both companies claim to have improved battery life, software experiences, and third-party app support.

Making a smartwatch that is better than the current Wear OS watch options, on the other hand, is embarrassingly simple. For years, Samsung has been doing it with its Tizen watches, which only work with Samsung devices and have been hampered by poor third-party app support.

It's not just a matter of raising the bar for Wear OS or Tizen. For Android users, there are low bars everywhere. OnePlus, RealMe, Oppo, Fitbit, and others have turned to proprietary, simplified platforms that lack the features you'd expect in a smartwatch today as Wear OS has stagnated.

As a result, the pressure is on both Samsung and Google to deliver a pair of smartwatches that are good enough to keep Android users who want a smartwatch from feeling left out. It's unlikely, however, that Samsung's first round of Wear OS 3 watches will be able to match the Apple Watch's ecosystem or integration.

Samsung, like Apple, will surely be attempting to develop an entire ecosystem of Android-related products and services. We don't know how tightly these watches will be tied to Samsung's ecosystem just yet, but it's possible that non-Samsung Android users will be turned off.

Indigenous People's Forum, said, "It has been proven that protection of land rights of indigenous peoples is not possible with the existing land laws of the country. Syeda Rizwana Hasan, chief executive of Bangladesh Environmental Lawyers' Association, said, "There is a political goal behind such land grabbing and eviction. The government does not recognise them as indigenous communities and even ordered NGOs not to use the word 'indigenous'."

"We need to focus on this political motive and build a political discourse of our own to protect land rights of these groups," she added.

Fazle Hossain Badsha, lawmaker and secretary general of Bangladesh Workers' Party, said, "It is really alarming that oppression of indigenous people is continuing even in this pandemic. National Human Rights Commission is supposed to submit a report on the protection of their land rights this month."

"We shall then take this report to the parliament and emphasise mobilising and empowering the CHT land commission, which is currently non-functional. We should also form a separate ministry for indigenous peoples of the plains, otherwise they will always remain excluded from the national budget," he said.

Foreign Minister AK Abdul Momen recently said the government had rejected the WB proposal in which it called for giving refugees all kinds of legal rights, including birth and death registration, working, buying land, education, employment and engaging in business.

Meanwhile, a report issued by the foreign ministry said improving the living standards of Rohingyas would encourage them to settle in the country permanently. The report, which was also placed in the

parliamentary committee, said bypassing the issue of Rohingya repatriation, western countries and relevant UN agencies have long been interested in taking up long-term projects to improve the living standards of Rohingyas in the camps.

The international community is becoming more active in increasing the quality of life and facilities for the camps, providing Rohingyas with formal education, technical training, job creation through social business and various development projects.

Such activities, especially the continuous improvement of the quality of life in the camps, could encourage the Rohingyas to settle permanently in Bangladesh and severely hamper the repatriation process, the foreign ministry said in its report.

In this regard, the prime minister has approved the proposal of the foreign ministry to take a policy decision to keep the living standards and facilities of the Rohingya camps at a reasonable and limited level in the interest of repatriation.

Among others, committee members Foreign Minister AK Abdul Momen; State Minister for Foreign Affairs Shahriar Alam; and lawmakers Nurul Islam Nahid, Golam Farooq Khandaker Prince, Abdul Majid Khan and Habibe Millat took part.

Meanwhile, the World Bank has clarified that the proposals made in its Refugee Policy Review Framework is a global document, not Bangladesh-specific, meant to assess the effectiveness of the refugeerelated projects funded by the global lender. It also said it was not in a position to negotiate the policy issues.

Memorial plaque of historical 'Jahajmara battle' remains in a sorry state

OUR CORRESPONDENT, Tangail

The Liberation War memorial reminiscing the glorious victory in the 'Jahajmara battle' at Sirajkandi in Bhuapur upazila under the district has remained uncared for seven years since its construction.

The Public Works Department (PWD) constructed the memorial beside the Jamuna River, four kilometres to the north of the Bangabandhu Bridge east end, and eight kilometres to the south-west of Bhuapur upazila headquarters, at a cost of Tk 1 crore 64 lakh in 2013. Later, they handed over it to the Ministry of Liberation War Affairs.

On August 10 in 1971, valiant freedom fighters belonging to 'Kaderia Bahini' in Tangail attacked two arms, ammunition and fuel-laden ships of the Pakistan occupation army -- ST Razan and SU Engineers LC-3-- on the confluence of the Jamuna and Dhaleswari rivers at Sirajkandi.

Defeating the enemy, they captured huge number of modern arms and ammunition worth around Tk 21 crore (at that time) from the ships and burnt those up, causing a blow to the supply chain of the Pakistani army to the northern region.

Locals started calling the place Jahajmara (destroyer of ships) and commander of the daring operation Habibur Rahman Bir Protik (now late) became famous as 'Jahajmara Habib'.

Visiting the memorial recently, this correspondent saw the plaque has already been covered with algae and weeds. The lightings of the memorial have also gone out of order.

Local people said the memorial was constructed on a filled-up pond of Bangladesh Bridge Authorities and regular

plying of sand-laden trucks to and from local dockyard is causing damage to the structure.

"Jahajmara battle is a glorious event in the history of our Liberation War and the new generation should be made aware of it. But the memorial has remained uncared since its construction," said Motahar Hossain, one of the FFs who took part in the historical War. "We are disappointed to see the dilapidated state of the glorious war memorial installation. We want proper preservation of the place," he added. "The next generation will be deprived of knowing the history of the sacrifices and glory of the Liberation War if the place of the glorious confrontation with the Pakistani army and the actual history of the liberation war are not properly preserved," he added.

Contacted, Al Amin Mohammad Nurul Islam, executive engineer of PWD in Tangail, told The Daily Star that after constructing the memorial plaque in 2013, the department handed over it to the authorities concerned for taking its care. "As per the procedure, the care taking authorities should inform the PWD in written for holding anything about its developments or other works.

However, none of the authorities or concerned others informed the department about the state of the memorial plaque so far," he said. "We shall take necessary steps about the memorial plaque after getting the letter," he said

Dr Ataul Gani, deputy commissioner in Tangail, while giving interview to a private television channel in this regard told that necessary steps will be taken to preserve the memorial plaque of the historical battle of the Liberation War.

You always have to be strategic to become successful in the farming sector. Success in farming depends on how skilled a farmer is. It's not just about investing money and time, it's about investing talent, thoughts as well as using modern technology in the work process. Over the past few years, there has been a great deal of interest and enthusiasm among the youth for fish farming using the biofloc method. While some biofloc projects have been successful, there have been reports of failures also. However, the initiatives haven't stopped.

In December last year, Mohammad Abdullah Jaber, managing director of Noman Group of Industries, called me and said he had seen my reports on biofloc on YouTube and had taken up the initiative of fish farming on a portion at his factory premises in Gazipur's Sreepur upazila. I was very curious about the matter because I was glad to know that industrialists are also giving spaces for farming enterprises, which I have dreamt of for long.

I know Jaber for a long time. He is a man, full of passion for agriculture and has been engaged with farming since his childhood. As a child, when everyone at his home liked to watch cartoons and entertainment programmes on television, he liked my agricultural TV shows.

Shykh Seraj is Bangladesh's pioneer development journalist. He received country's two highest civilian honours, Swadhinata Puroshkar and Ekushey Padak, respectively. He is a BIDS, Ashoka

and Bangla Academy Fellow. He also received highest award for agricultural journalism from the United Nations, FAO A.H. Boerma Award, Gusi Peace Prize (Philippines) and many other prestigious accolades at home and abroad. At Channel i, he's the Founder Director and Head of News. He's also Director and Host of Channel i's popular agro-documentary, Hridoye Mati O Manush.

He also cultivates vegetables and raises poultry beside his factory. I went to his factory to see his biofloc method and harvest. Jaber has done different species of fishes, including shing, gulsha and shoal in 5,33,000 litres of water. Indoor fish farms have become an attractive venture for young entrepreneurs. A biofloc shed, 182-feet long and 65-feet wide, next to Noman Group's huge factory. Eleven tanks made of rod cages and Korean PVC-coated plastic on the top. The height of the tanks are about four to four and a half feet with a capacity of 10,000 to 1,00,000 litres. There are aerators, oxygen bubbles installed in the tank. Each tank has different varieties of fishes. Jaber said the sheds and tanks were made of unused iron sheet, rods and old materials. As a result, the cost was not too high. Jaber released

only a gram of fingerlings in these tanks back in December, 2020. Like fabric production, fish production is going on in other sheds of the textile mill.

Jaber's biofloc factory is a smaller version of the fish factory I had seen in China. Water was cleared from two tanks from where Jaber would harvest fish. Shing fish in one tank, tengra in the other. I was amazed to see lots of fishes in a small place, a 10-feet by 10-feet tank, containing 10,000 litres of water which produced fish that might have required 0.40 acres of pond in reality.

First I went in front of the shing tank. Arif, who is in charge here, said fingerling quality, is a big issue in biofloc fish farming. If the fingerlings are not good, it is difficult to harvest the desired size. It takes four months to produce shing fish in biofloc method. Jaber is very optimistic about the purity of the fish produced in this way. He said, the colour and taste of this fish is like river fish or you may call it freshwater fish. Even I had not seen such bright shing fishes for a long time. The colour of gulsha and tengra was also shiny. The other nine tanks were cultivating Vietnamese shoil, monosex tilapia, Vietnamese koi and pabda fish. Jaber and his colleagues are very happy with the success they achieved from the experimental production in the first couple of months. Jaber dreams of distributing fish he produced from biofloc to his staff. Through this, he can see there is a good market and demand for biofloc fish. He is very much optimistic that Bangladesh will soon export a lot of fish produced, using the biofloc method. And I was really pleased by seeing an industry owner getting more interested in farming and a factory is leaving space for fish cultivation, in other words, for farming. I believe the revolution in the agricultural industry will be accomplished

only a gram of fingerlings in these tanks back through entrepreneurs like Mohammad in December, 2020. Like fabric production, fish Abdullah Jaber.

Traditional farming is now rapidly shifting to commercial arena. Commercial entrepreneurs are leaning towards production systems which can be financially profitable in a short time. To accelerate this system, various technologies, Internet of Things (IoT), artificial intelligence have been added to agriculture sector. Consequently, production has increased scientifically and has become dynamic. If there is no mechanical disorder, there is no risk of loss in production. Therefore, people from unemployed youth to the largest financial entrepreneurs are getting involved in agriculture through farm enterprises. Both sides want quick financial return. Many are also reaching success by following proper management. But some are lagging behind in management just to focus on money. Over the last few years, biofloc has become a very attractive investment sector for new entrepreneurs. But keep in mind that 'biofloc' is a completely scientific method for fish farming. There is a lot of competition going on around the world for this system. There is RAS method, Bottom Clean Raceway and also IPRS (In-Pond Raceway System) method. Again, several methods are being practiced for fish farming in intensive and semi-intensive approaches. In fact, it is a matter of paying close attention. It is a matter of following scientific management. There is no chance to do anything outside the formula here. If an entrepreneur does not fully apprehend the issue, it will be fatal. I wish success to all the entrepreneurs. With that, I hope you will put more emphasis on systematic tactics that will give you a productive commercial agricultural enterprise.

OCCUPIED WEST BANK Israel to okay 2,000 new settler homes AFP, Jerusalem

Israel is to approve 2,000 new homes for Jewish settlers in the occupied West Bank, defence sources said yesterday, despite opposition from dovish members of the governing coalition.

The Palestinians swiftly condemned the latest settlement expansion plans, the first of Prime Minister Naftali Bennett's administration.

A security source told AFP the permits for Jewish settlements would come alongside approvals for hundreds of Palestinian homes in the large swathe of the West Bank known as Area C, where Israel exercises military and planning control. "There is an expectation to approve about 1,000 housing units for Palestinians in Area C next week and 2,000 housing units in the Jewish communities," the source told AFP on condition of anonymity.

The office of Palestinian president Mahmud Abbas expressed its "strong rejection and condemnation" of the new settler homes, saying they contradicted "the clear American position" President Joe Biden expressed in a call with Abbas. Biden is reportedly to meet with Bennett in the near future, though his office did not specify a date.

Bennett, a former director of the Yesha Council settler lobby, faced criticism from dovish partners in his coalition, as well as from Israeli settler advocates in the opposition.

Israel seized the West Bank and east Jerusalem from Jordan in 1967. Since then, nearly 700,000 Israelis have moved into settlements that most of the international community regards as illegal. Palestinians hope the territories will become part of a future state.

US finds Pakistan useful only to clean up 'mess': Imran Khan AFP, Washington

Pakistani Prime Minister Imran Khan has accused the United States of seeing his country as useful only in the context of the "mess" it is leaving behind in Afghanistan after 20 years of fighting.

Washington has been pressing Pakistan to use its influence over the Taliban to broker an elusive peace deal as negotiations between the fighters and the Afghan government have stalled, and violence in Afghanistan has escalated sharply.

"Pakistan is just considered only to be useful in the context of somehow settling this mess which has been left behind after 20 years of trying to find a military solution when there was not one," Khan told foreign journalists at his home in Islamabad on Wednesday.

The US will pull out its military by August 31, 20 years after toppling the Taliban government in 2001. But as the US leaves, the Taliban today controls more territory than at any point since minimal diplomatic relations.

Paramilitary police officers evacuate residents stranded by floodwaters with a boat following heavy rainfall in Hedian town of Suizhou, Hubei province, China yesterday. Several cities in the province were severely hit by heavy rainfall and floods with some initiating a high level emergency response for flood.

Kabul and several Western governments say Pakistan's support for the armed group allowed it to weather the war.

The charge of supporting the Taliban despite being a US ally has long been a sore point between Washington and Islamabad. Pakistan denies supporting the Taliban.

Khan said Islamabad was not taking sides in Afghanistan.

"I think that the Americans have decided that India is their strategic partner now, and I think that's why there's a different way of treating Pakistan now," Khan said.

Pakistan and India are arch-rivals and have fought three wars. The two share frosty ties and currently have

A political settlement in Afghanistan was looking difficult under current conditions, Khan added.

He said he tried to persuade Taliban leaders when they were visiting Pakistan to reach a settlement. "The condition is that as long as Ashraf Ghani is there, we (Taliban) are not going to talk to the Afghan government," Khan said, quoting the Taliban leaders as telling him.

Also on Wednesday, the Pakistani military in a statement said all stakeholders should play their part 'positively for enduring peace" in Afghanistan, calling it a "collective responsibility". Misperceptions and scapegoating must be avoided to counter designs of spoilers, it quoted military chief General Qamar Javed

Bajwa as saying. Peace talks between the Taliban and team of Kabul-nominated Afghan а negotiators started last September but

have made no substantive progress.

Shiv Sena leader Sanjay Raut said the opposition did not get a chance to present their views in Parliament and spoke against

French rescue 108 migrants in Channel

French authorities rescued more than 100 migrants Wednesday seeking to sail to England in four separate boats that officials said got into trouble in the Channel. Last week the British government said a record of at least 482 migrants crossed from France to England in a single day, putting annual figures way above last year's numbers, reports AFP. Maritime officials in France said on Wednesday that a navy patrol boat rescued seven people aboard a vessel "in difficulty" off the coast of Sangatte and took them to the port of Dunkirk, where they were looked after by local officials.

Indian rocket fails to launch satellite

An Indian rocket carrying a powerful earth observation satellite failed to fire fully yesterday, the state-run space agency said, in a setback for the country's space programme, reports Reuters. The satellite, meant for quick monitoring of natural disasters such as cyclones, cloudbursts and thunderstorms, was launched on a geosynchronous satellite launch vehicle (GSLV) at 0013 GMT, from the Satish Dhawan Space Centre in southern India. But while the liftoff was smooth, the rocket failed in its final phase, the Indian Space Research Organisation said.



Libel case against Maria Ressa dismissed

A Philippine court has dismissed a libel case against Maria Ressa, a lawyer said yesterday, one of several lawsuits filed against the journalist who says she has been targeted because of her news site's critical reports on President Rodrigo Duterte. The plight of Ressa, who was named Time Magazine Person of the Year in 2018 for fighting media intimidation, has raised international concern about the harassment of journalists in the Philippines, a country once seen as a standard bearer for press freedom in Asia. The cyber-libel case was filed by a college professor against Ressa wand a reporter at her site, Rappler, in October.

PEGASUS SPYWARE SCANDAL UN experts urge moratorium on sales of surveillance tech

UN experts yesterday called for an international moratorium on the sale of surveillance technology until regulations are implemented to protect human rights following an Israeli spyware scandal.

An international media investigation reported last month that several governments used the Pegasus malware, created by Israeli firm NSO Group, to spy on activists, journalists and politicians.

Pegasus can switch on a phone's camera or microphone and harvest its data.

"It is highly dangerous and irresponsible to allow the surveillance technology and trade sector to operate as a human rights-free zone," the United Nations human rights experts said in a statement.

The statement is signed by three special rapporteurs on rights and a working group on the issue of human rights and transnational corporations and other businesses.


"We urge the international community to develop a robust regulatory framework to prevent, mitigate and redress the negative human rights impact of surveillance technology and pending that, to adopt a moratorium on its sale and transfer," they said.

The experts urged Israel to "disclose fully what measures it took to review NSO export transactions in light of its own human rights obligations". Israel's defence establishment has set up a committee to review NSO's business, including the process through which export licences are granted.

Pegasus's list of alleged targets includes at least 600 politicians, 180 journalists, 85 human rights activists and 65 business leaders.

my relevant study field. I left the job after two months, and started Cramstack in April 2016 with my childhood friend, Hasib Mamun.

What makes Cramstack stand out? The idea behind Cramstack is to build a search platform that allows users to search enterprise data sources as easily as a Google search. It also offers tools to extract and process data from portable document format (PDF) files and images.

Hasib Mamun and I came up with the idea to work with natural language query. We developed a natural language enterprise database while participating in Grameenphone Accelerator in 2019.

Currently, we have clients in the Ministry of Power in Bangladesh, a number of renowned banks and RMG exporters, as well as international firms such as Boston Consulting Group.

How is Cramstack tackling challenges during the pandemic?

Owing to the pandemic, we had to face obstacles, like most other businesses. Our bills got delayed, but we did not lay off employees or cut off salaries. Even if we went broke, we wanted to make sure our employees had full support from our side. We also provided government data from healthcare workers and immigration officials to help track and curb the spread of the coronavirus. We raised over \$1 million from Rockstart (Netherlands), Grameenphone (unit of Telenor) and angel investors.

CUET students shine at Concrete Projects Competition 2021

American Concrete Institute (ACI), a Michigan-based international professional organisation, recently hosted the Concrete Projects Competition, an annual event for undergraduate students from all across the world. This year, it was organised virtually.

Three teams from Chittagong University of Engineering and Technology (CUET) secured the first, second, and third positions at the competition. Each team consisted of two students, and all six winners were recent graduates of CUET. They worked on the projects for their final-year theses.

Mahfuzul Islam and Imtiaz Ibney Gias were the champions. Their project, 'A critical review on the performance of microbial concrete developed using E. coli bacteria', was supervised by Professor Moinul Islam. The project intends to manufacture a concrete which is stronger and more durable than the conventional one. "For this purpose, we incorporated E. coli bacteria strain into concrete as a partial replacement of water. The bacteria would help in healing the micro cracks developed at an early stage," Imtiaz explained.

Syed Maruf-Ul Hassan and Ezaz Ahmed secured the second position. Their project, 'Effect of compaction on the properties of eco-friendly building blocks produced from industrial by-products', explored ways to generate value for waste materials. "Wastes produced from coal power plants and steel manufacturing industries require safe disposal. Our research introduces an alternative solution for the traditional clay burnt brick, using

industrial by-products. Subsequently, the produced brick is more cost-effective, and eco-friendlier," Maruf shared.

The third position was achieved by Jannatul Ferdous and Tabassima Faria. Their project, 'Ternary combination of industrial wastes for sustainable geopolymer mortars', attempts to utilise wastes generated from different industries as binder materials to prepare eco-friendly geopolymer mortars. "Cement emits a large amount of carbon dioxide. Additionally, the proper disposal of waste is a problem encountered by different industries. Our project intends to minimise carbon emission, discard waste effectively, and prepare sustainable construction materials," Jannatul said.

The participants submitted two electronic copies of their reports. The first copy included the students' contact information and ACI member numbers, as well as the ACI member numbers of their faculty advisors. On the other hand, the second copy had no identification information of the students or the universities, in order to ensure fair results.

There was no virtual ceremony for the winners. However, the organisers have invited them to the Concrete Convention, which will be held at Orlando, USA, in March next year. The winners extended their gratitude to their faculty advisor, Prof Dr G M Sadiqul Islam, who also supervised the teams that achieved the second and third positions.

Address migrant workers' wage theft claims


Authorities must ensure migrant workers receive their due

T E express our strong support for the demand put forward by experts at a recent webinar, who urged the government to address migrant workers' wage theft claims at regional forums during bilateral meetings with host countries, and via international and UN agencies working on migration. According to the findings of a survey conducted by the Bangladesh Civil Society for Migrants (BCSM), 1,160 Bangladeshi migrant workers who returned home from six Gulf countries after February 2020 had lost, on an average, about Tk 1.8 lakh in wages and other entitlements amid the pandemic. Of the returnees, 67.7 percent said they did not receive due wages regularly after February 2020.

Ever since the pandemic first swept across the globe, we witnessed how it disproportionately affected migrant workers, especially from countries like Bangladesh, Nepal, Pakistan, etc. The mistreatment of migrant workers in host countries ranged from mass unemployment and hunger to imprisonment in quarantine facilities lacking basic amenities and forced deportation. It is worth noting that the same Gulf countries that expelled migrant workers during the pandemic are now denying them entry without Covid-19 vaccines, and have washed their hands of any responsibility towards them, despite the fact that many major sectors in their economies are dependent on them. In this context, it is almost criminal that after being denied some of the basic rights that every worker is entitled to, they are also being denied their due wages and entitlements

The injustice of it all becomes more obvious when considering the current situation of returnee migrant workers. According to a survey conducted by Brac, UN Women Bangladesh and the Center on International Cooperation at New York University, many of these workers have amassed an average of Tk 76,000, and a maximum of Tk 7 lakh, in migration loans. How will they manage to survive if, on top of that, their employers take away an average of Tk 1.8 lakh in wages from them? Let us not forget that this wage theft is not just detrimental to migrant workers and their dependants, but also to the country as a whole, since valuable foreign currency that would have been part of our remittances is being withheld.

Experts have suggested that wage theft claims can be addressed at different platforms such as the Colombo Process or Abu Dhabi Dialogue, or they can be placed before host countries through a "commission" or UN organisations such as the ILO. There have also been demands of a continued campaign against wage theft in collaboration with regional platforms such as the MFA, as well as the involvement of concerned foreign missions in Bangladesh in creating more dialogue on the issue. We request the government to take these recommendations on board and collaborate with civil society and rights groups to urgently address the issue. In the long run, we must continue to exert pressure on all actors involved in order to dismantle the unjust global labour markets that allow foreign employers to take advantage of migrant workers, especially those employed in low-wage, precarious jobs.



dealing with the overall management of the Covid situation continuously flip-flops on its decisions, then doesn't the image of the government MAHFUZ ANAM suffer? If what

one day is changed on the next, doesn't it lead to people losing confidence in government decisions? When a course of action is decided upon without any implementation plan, then doesn't it erode the credibility of the government? Can the government expect full compliance when decisions are taken without any thoughts given to their impact on the people?

On July 13, the cabinet division in a gazette notification (one cannot get more official than that) announced that "strict lockdown" would be imposed from July 23 to August 5, extending the work stoppage from Eid leave. The home minister on July 27 added that the government had turned down pleas from the business community, including garment factory owners, for keeping factories open during lockdown. Then on Friday, July 30, to everybody's surprise, the same cabinet division announced that all export oriented industries will be out of the purview of the lockdown from next Sunday, giving practically little more than a day for the workers to join their factories on the pain of losing their jobs or being financially punished for late appearance.

Whether or not it was correct to open the factories in the midst of the lockdown or how it will impact the spread of the highly infectious Delta variant is not what we are asking at the moment. Our focus is, in deciding to open the factories on such short notice, how much attention was given to the convenience of the workers and whether it was at all practical for the government to expect RMG workers to report for work, especially when all means of transport was closed, again, by the order of the government.

The decision forced thousands of workers, mostly female, to undergo untold sufferings to travel to Dhaka, Gazipur and Narayanganj, where most of their factories are located, to join work.

After a full day of chaotic, hazardous, life-risking and Covid-spreading travelling, on Saturday (July 31) at 8pm, the authorities, perhaps realising the injudiciousness of giving such a short notice, ended up doing something more foolish. They decided to re-open public transport for 16 hours to "facilitate" workers joining their work.

Opening public transport for 16 hours? Was the practicability of such an order at all thought of? Was it the view

Investing in global vaccine equity

On Tuesday before last (August 3), an inter-ministerial meeting was held to assess the lockdown situation and finalise the vaccine rollout plan. It was attended, in-person or virtually, by 12 ministers and state ministers, the PM's principal secretary, cabinet secretary, 16 secretaries of different ministries, chiefs of law enforcement and intelligence agencies. The purpose was to spell out the details of the massive rollout plan aiming at vaccinating roughly 1 crore people. What followed after the meeting was

quite unbelievable. As ministerial meetings go, it was of

a very high level. It lasted for over three hours, at the end of which a joint press briefing was held by the Minister for Liberation War Affairs, AKM Mozammel Haque, who presided over the meeting, along with the Minister of Health and Family Welfare, Zahid Malegue. In his 30 minutes briefing, among other things, he ministry distancing itself from minister Mozammel's statement. This was followed by a press release at mid-day next. An hour later, the presiding minister withdrew his statement.

Why was such a farce made of a press briefing? What is the protocol of press briefings, especially after official highlevel meetings? Didn't the two ministers feel any need for an exchange of points or thoughts before going before the press? Why was it taken so lightly? Given the subject, the main briefing should have come from the health minister and not from the minister in charge of Liberation War Affairs just because he presided over the meeting.

As of last Wednesday, all forms of restrictions have been lifted, except for tourism, political and religious gatherings, etc. In deciding to lift practically all restrictions on transport, public movement, factories, offices, restaurants,

Needless to say, the decision has baffled experts, especially when the infection rate is nowhere near the prescribed level given by WHO, and when the Covid situation is far from under control

The livelihood argument overwhelmed the government, as the captains of the industry are known to have irrepressible clout over our decision-makers. While experts will continue to debate as to the judiciousness of lifting the lockdown, once again, as before, we want to focus on how implementable and well-thought-out the decisions were, whether adequate time was given to the government machinery down the line to implement them, and whether any thought was given on how those decisions were likely to impact the citizens?

While lifting all restrictions on transportation, the government directed that only half the fleet of buses will be allowed to ply on the roads with 100 percent capacity. How and who will ensure that only half of each owner's fleet of buses will be allowed to operate? How will the owners who have only one bus implement this decision? What happens to social distancing when buses are allowed to take their full load? The chaos that followed-and the sufferings that people had to go through—speaks for itself.

The importance of the government as a functioning institution cannot be overemphasised. It is at the epicentre of literally everything. All policies, planning, directives, projects, future ideas, and much more emanate from it. A huge amount of taxpayers' money is spent to nurture and facilitate the advancement of our government employees. The credibility of this institution is an important element of effective implementation of all its policies and plans.

The three instances we cited above speak of unthinking policymaking, unprepared decision-making, and an uncaring attitude towards the people that they are paid to serve. This must stop if we are to effectively defeat the pandemic and emerge on top.

We cannot continue to have such confusion and chaos in the decisionmaking and implementing processes within the government.

Make factories pay for polluting the environment

Punishment is necessary, and so are effluent treatment plants

OMING hard on the heels of a new Intergovernmental Panel on Climate Change (IPCC) report that made dire predictions about the occurrence of more frequent rainfalls, floods, and cyclones in Bangladesh, a report in this daily shows how ill-prepared we still are to face this challenge. It describes how 48 units (out of a total of 185) under the Bangladesh Small and Cottage Industries Corporation (BSCIC) are operating without effluent treatment plants (ETP). To put it simply, across four divisions (Dhaka, Chattogram, Rajshahi, Khulna) of the country, there are 48 industrial factories that are dumping their untreated chemical waste right into open drains, allowing filthy and discoloured water to flow into rivers and even into people's homes during the monsoon season when flooding happens.

One such area is Pagar Alerteg, adjacent to the Tongi Industrial Zone of the BSCIC. Here, rain brings knee-deep floods of black, filthy, foul-smelling water that residents have to wade through during monsoon. It has reached a point that residents now refuse to move there, making the area nearly uninhabitable.

One may wonder how such an issue is allowed to fester in four divisions, or how as many as 48 factories are allowed to dump chemical waste irresponsibly and improperly. The fact is, they are not allowed to operate without the ETPs, but neither the BSCIC nor the Department of Environment (DoE) seems aware of the magnitude of this problem.

Although it is mandatory to set up ETPs for factories that generate chemical waste, as per BSCIC guidelines, the corporation is strangely enough not allowed to penalise factories flouting this guideline. One such factory in Gazipur has begun the process of setting up an ETP after facing pressure from the BSCIC and DoE, but it will take at least three more months for this effort to reach fruition. Others either do not have enough land or necessary financial resources to set up their own ETPs. The BSCIC's plan from two years ago to set up a central ETP in Konabari, Gazipur has also not been implemented yet.

Meanwhile, representatives of the DoE told our reporters that they were not "aware" that so many factories under the BSCIC were operating without proper ETPs, and that they would communicate with the corporation soon regarding this matter. We hope this does happen, and soon, as there can be no excuse to pollute the homes and rivers of the country with harmful chemical waste. Although punishment for offending factory owners is desired, there needs to be a long-term solution to this issue that is hugely impacting the natural environment. We earnestly hope that the DoE and BSCIC will prioritise the building of ETPs at every factory (or central ETPs in each industrial city), instead of exchanging blame while the problem gets worse and worse.

vaccines in record time highlights the power of vaccines to bring us closer to our loved ones and to a more prosperous,

equitable world in which everyone has the chance to achieve their full potential. Vaccines are among modern medicine's greatest innovations, allowing billions of people to lead healthy lives. But stopping outbreaks of vaccine-preventable disease-and not only Covid-19-depends on achieving critical mass with immunisation campaigns.

Consider polio. The shuttering of classrooms to protect children from Covid-19 outbreaks might seem unprecedented, but a 1937 polio outbreak in the United States inspired school-byradio programmes-an early innovation in remote learning. In those days, polio was thought to afflict only industrialised countries, until a major outbreak in South Africa in 1948 led to the establishment of the first African foundation for polio research and catalysed greater awareness of the disease's global burden. In the 1950s, polio paralysed an average of 600,000 people each year.

Fortunately, scientists developed the first polio vaccines later that decade. And since the launch of the Global Polio Eradication Initiative in 1988, vaccines have reduced the global incidence of wild polio cases by more than 99 percent, from hundreds of thousands annually to a handful of endemic cases in just two remaining countries: Afghanistan and Pakistan. In 2020, Africa was certified as being free of wild polio,

giving the continent a much-needed glimmer of hope amid the Covid-19 pandemic. Strong vaccine coverage has made it possible to believe that polio could become the second disease-after smallpox-to be eradicated through vaccination.

But the polio clock has not stopped ticking: back in 2014, the World Health Organization sounded the alarm when it designated the disease as a Public Health Emergency of International Concern. In particular, areas with low immunisation rates, and thus low levels of protection, are also vulnerable to rare but increasingly frequent outbreaks of circulating vaccinederived poliovirus (cVDPV), which occur when the weakened pathogen originally contained in oral polio vaccines eventually regains virulence.

Today, cVDPV outbreaks outnumber wild polio cases. Although we are closing in on the virus, we are struggling to maintain the strong vaccine coverage needed to stop these outbreaks before they start, owing to a lack of resources, conflict or civil unrest, and pandemicrelated disruptions to immunisation drives.

The Covid-19 crisis has so far caused the postponement of 57 lifesaving mass vaccination campaigns in 66 countries, affecting hundreds of millions of people, mostly African children. In November 2020, the WHO and UNICEF called for emergency action to avert a secondary crisis of measles and polio outbreaks caused by disrupted vaccine access.

Even as we rally together against Covid-19, PATH and other partners continue to call upon national governments and donors to double down on immunisation against polio and other vaccine-preventable diseases. The newly launched Immunisation Agenda 2030 global framework has a crucial role to play both to make up for lost time and to boost our collective resilience. As the

pandemic has shown, cross-border spread of infectious disease is an ever-present threat. All therefore have a strong interest in international immunisation coverage.

Investing in disease prevention through vaccine development and delivery protects us all and will pay dividends for years to come. We should thus feel heartened by the stunning speed with which the scientific community-helped by many previous years of research into other coronaviruses-came together to develop

When it comes to highly infectious diseases such as Covid-19 and polio, our fates are bound up together; what affects one part of the world affects us all. Investing in tools for a single country does little to control or eliminate such global health threats. Instead, we must keep global vaccine access at the centre of our efforts. Strong national commitments and financing for the Immunisation Agenda 2030 framework can help get us

Using technologies is key to speeding up ADP execution

HE implementation of the Annual Development Programme (ADP) in Bangladesh has been severely affected by the impact of the Covid-19 pandemic in the last 17 months. As the country entered the new financial year on July 1, now is an appropriate time to review last year's ADP execution, learn from the challenges faced, and take stringent measures to improve the rate of implementation this year.

up of project-related procurements, delay in release of imported goods from the ports and late recruitment of project staff and consultants. Thirdly, inadequate monitoring and supervision of field activities to ensure quality implementation due to extended lockdowns and closure of offices. That the health ministry performed poorly in executing last year's budget is well known, but there are other ministries whose execution levels were also less than 50 percent.



The current and last two years' ADP have had the same Covid-19 related challenges that the implementing ministries should take into account and tackle from the early part of this fiscal year. These are, first of all, the challenge of mobilising the projected revenue from internal sources, borrowing from financial institutions and securing the expected foreign loans and grants. Secondly, slow pick-

The current year's budget (2021-2022) is the 50th budget of Bangladesh. The total amount of ADP proposed in the budget is Tk 225,324 crore, which is 6.5 percent of GDP. The five sectors which received the highest ADP allocation are: transportation and communication, power and fuel, housing and community facilities, education, and health. The first two sectors have been allocated 48 percent of total ADP allocation. These five

sectors have a total number of 743 projects out of a total of 1,426 projects included in the ADP. A huge amount of construction work is included in the top five sectoral projects requiring procurement and physical work. As many as 141 projects have foreign grants and loan components in them, with a total amount of USD 41.6 billion. Due to various reasons, 24.1 percent of the projects included in the ADP have been revised from one to three times already.

Those ministries which didn't achieve up to 50 percent implementation level last year should undertake a planned approach to the implementation of their projects from the beginning of this year. They should start floating the tenders, followed by assessment of the bids and complete the procurement formalities in good time. In case of construction projects, the government should allow professionals like the engineers and workers to work in the same spirit as the health sector professionals who are considered as essential staff, provided they follow the Covid-19 health regulations and get vaccinated. Instead of keeping the offices closed, the government staff should work remotely during the lockdown period and continue their operations.

Many countries have experimented and devised good remote working

mechanisms to continue their project execution in both public and private sectors. In Bangladesh, the banking sector showed remarkable resilience and their capital adequacy, asset quality, profitability and liquidity have been praiseworthy during the last two years. The NGOs have also been maintaining their critical operations at a satisfactory level. They have been building awareness of infection prevention measures among the communities, distributed personal hygiene products to the poor households and supplied personal protective equipment to staff who work on the frontline. We can learn from their experiences and adopt the good practices.

One major constraint during this pandemic, especially during the lockdown, is the inability to be physically present in the projectsites by government engineers and supervisors. To overcome this challenge, some government departments on a sample basis have started using remote devices such as mobile phone, computer and camera for real-time monitoring of project-work using WhatsApp. Many projects have also started disbursing funds through government's digital platform, which should be made universal as quickly as possible. Many private companies, banks and NGOs have started doing the same and in addition, they have regularised video conferencing, on-line training, performance analysis and reporting, by using IT equipment and software. These new communication tools have been widely used in the developed countries in the last one year and they are thinking of continuing their use in future since they have cut costs significantly by adopting these technologies and skills. The projects included in the ADP should use these technologies and enhance their implementation rate.Bangladesh needs to address the infrastructure gaps in all sectors through increased public investment, and ADP is the main

channel to fill this gap. However, the government needs to prioritise only the good projects. The ministries should be strict about screening and appraisal of projects so that the most important ones are included in the ADP and they are adequately funded. There is a critical need to enhance technical capacity in the government ministries in these areas. Timely implementation of good projects can help increase the growth rate. We need to enhance ADP implementation which will contribute to achieving pre-Covid GDP growth rate.

The total stimulus packages given during this pandemic by the government so far amount to Tk 128,441 crore (4.59 percent of GDP) from which Tk 940 billion (73 percent) is for the private investors, and the rest for the poorest and disadvantaged people and families. This shows that a significant amount of public resources have been made available to the private sector. The developed countries that have made good progress on vaccination and contained the rate of Covid-19 transmission have resumed their normal economic activities, and our export opportunities to those countries have reopened now. We need to give a boost to public sector projects, to enhance employment opportunities and effective demand, and increase export. The government has made a policy move towards supply side push by incentivising the business sector through such measures as reducing corporate taxes, lowering bank interest rates and allowing delayed repayment of bank loans, in addition to giving a number of stimulus packages. In order to match these incentives, demand side measures should be strengthened as well, by enhancing project implementation, for an early recovery of the economy.

Grin and bear it: How economics won Kipchoge an Olympic gold



Sunday August 8, like many running enthusiasts, I watched in awe as Eliud

Nobel Prize winning economist Daniel Kahneman describes in his book Thinking Fast and Slow. We all understand that our emotional state can affect our facial expressions: when we are sad we frown, and when we are happy we smile. But experiments have

allowing such negativity to take hold is likely to have adverse psychological and physiological consequences, to the detriment of athletic performance.

What is more, knowledge of these insights can help all of us to rise to challenging circumstances, just like Kipchoge.

Keen observers will have noticed a peculiar smile cross Kipchoge's face in the latter stages of the race. Peculiar, because it was clearly a conscious affectation rather than a spontaneous expression of joy as a smile usually is. Commentators such as Paula Radcliffe (herself a marathoning record-breaker) have observed that the smile has become something of a Kipchoge signature that usually emerges late in the marathon when he starts to fatigue and works especially hard. So why does the world's greatest marathoner pretend to smile when he is under pressure and is there a lesson there for the rest of us?

The answer lies in a force that

found that the reverse is also true: the facial expressions we adopt can alter our emotional, psychological and even physiological state. Stimulating the facial muscles associated with smiling such as by holding a pencil sideways in one's mouth can elevate measures of mood and subjective wellbeing. The opposite is also true so that simulating a frown by holding a pencil protruding from a pout can make people feel unhappy.

Athletes had many reasons to frown during the Tokyo men's marathon. It was far hotter than is optimal for marathoning. The course was very tight in parts with turns and twists that can break a runner's rhythm. The fierce competition led to overcrowded drink-stations with runners elbowing and running into one another. On three separate occasions, overcrowding prevented Kipchoge from getting the drinks that he needed to fuel his race. Expressing frustration might have been a natural reaction to these impediments, especially during a marathon which by its nature leaves athletes dehydrated with depleted blood sugar and so less in control of their emotions. Evidence from experimental economics suggests that

But something as simple as pretending to smile can set us on the right path. After all, if putting on a smile can help Kipchoge defend his gold medal, imagine what it could do for the rest of us!



An asteroid known as Bennu will pass within half the distance of the Earth to the Moon in the year 2135 but the probability of an impact with our planet in the coming centuries is very slight, scientists said Wednesday.

OSIRIS-REx, a NASA spacecraft, spent two years near Bennu, an asteroid that is about 1,650 feet (500 meters) wide, observing its size, shape, mass and composition and monitoring its orbital trajectory

Earth's gravity and a phenomenon known as the Yarkovsky effect will affect its future trajectory and the potential for an impact on a subsequent orbit.

"The OSIRIS-REx data give us so much more precise information, we can test the limits of our models and calculate the future trajectory of Bennu to a very high degree of certainty through 2135," said Davide Farnocchia, a scientist with the Center for Near Earth Object Studies at Nasa's Jet Propulsion Laboratory in California.

"We have already held meetings with chemical suppliers so that chloroform is not available in the black market ... he said.

Islam Selim, former Nazrul president of Bangladesh Scientific Instrument Dealers Association, told The Daily Star that chloroform is mainly used by pharmaceutical companies in the country. Besides, the authorities concerned of the education sector buy the chemical, he said.

We do not sell chloroform without documents. We are now more aware and check every record even though chloroform alone cannot be harmful. Someone needs to add something to the chemical [to make it lethal], Selim claimed.

CTTC officials claimed that since getting hold chloroform was difficult, Furkan, with instructions from Jon, was trying get a job in a chemical factory to siphon out the knockout drug.

locomotives in Bangladesh, the BR commissioning committee found that the technical specifications of four key components -- engines, alternators, compressors and traction motors -of the supplied locomotives did not match the specifications mentioned in the agreement.

Subsequently, the project authority halted 65 percent of the payment for the locomotives and the railways minister in October last year ordered an investigation into the matter.

In March this year, the technical committee was formed to determine whether the 10 locomotives can be commissioned. It has now recommended receiving those.

Asked whether the contract-related issues have to be placed before the Cabinet Committee on Government Purchase again, Mazumder said, "No. Only the approval of the railways ministry is needed.'

Mohammad Hassan Mansur, the project director, told this newspaper vesterday that the committee suggested receiving the locomotives as the BR is operating trains with locomotives of similar configuration.

The next steps regarding the locomotives would be taken based on the report of the technical committee, he said.

Though the committee led by Borhan Uddin, chief mechanical engineer (east) of the BR, submitted its report recently, it is yet to be accepted

The engines, traction motors, compressors and other equipment can be used as they are.

Hyundai sought six months to check whether the alternators can be replaced, he added.

"Consequently, our measurements demonstrate that the AM-III material is comparable in strength to diamond and superior to the other known strongest materials," the scientists noted in the study.

According to the scientists, AM-III has tunable energy absorption properties comparable to semiconductors commonly used in solar cells such as hydrogenated amorphous silicon films.

While in diamond crystals, the organised internal structure of its atoms and molecules contribute to their immense strength and hardness, in AM-III the researchers found that a combination of order and disorder of its molecules give rise to its strange properties.

materials made of hollow footballlike arrangements of carbon atoms, the researchers produced different types of glassy materials with varying molecular organisation among which AM-III had the highest order of atoms and molecules.

To achieve this order of molecules, the scientists crushed and blended the fullerenes together, gradually applying intense heat and pressure of about 25 GPa and 1,200 degrees Celsius in an experimental chamber for about 12 hours, spending an equal amount of time cooling the material.

Increasing the order further, the scientists observed, could potentially kill the semiconductivity and other properties that required the atoms and molecules to be chaotic.

"The emergence of this type of ultrahard, ultrastrong, semiconducting amorphous material offers excellent candidates to [the] most demanding practical applications," the researchers wrote in the study.

Ecstasy already peaked in Paris, where fans flocked to the airport upon hearing news that a certain Lionel Messi was on his way to sign for Paris Saint Germain after spending 21 years at his childhood club, Barcelona.

As the Argentine looks forward to taking on a new challenge with a new team, his new coach, Mauricio Pochettino, with the faced



addition of Romelu Lukaku will be the final piece of the puzzle in challenging Pep Guardiola's Manchester City, the reigning champions, for the Premier League title. A new day is also dawning at Real Madrid, where Carlo Ancelotti begins his second reign this season after Zinedine Zidane's departure from the managerial hotseat. The mastermind behind La Decima -- Real Madrid's 10th European cup in 2014 -- has to now manage a squad that finished trophyless last season and has seen their captain, Ramos, leave for greener pastures.

The addition of David Alaba may add some value to defence, but Madrid's long search for attackers may prove to be fruitless as signing either Kylian Mbappe or Erling Haaland looks very unlikely. Defending La Liga champions Atletico Madrid will also be in no mood to relinquish their crown. covered one of their biggest weaknesses from the past season. Manchester United have also made significant strides, adding Jadon Sancho and Raphael Varane, but a lack of depth means a title challenge could still be a way off.

In Serie A, Massimiliano Allegri returned as Juventus manager with the aim of banishing the memories from a disappointing season under Andrea Pirlo. His job has certainly been made easier by Inter Milan having to sell off the key cogs of last season's title-winning team due to their owner's financial situation and no other club quite at the level of the Old Lady, although Atalanta and AC Milan will harbor some hope. Similar to Ligue 1, Bundesliga may also be a one-horse race. There seems to be little opposition to Bayern Munich, who will fight for their tenth consecutive league title. The Bavarians have recruited Julian Nagelsmann, a young, energetic coach who has created huge hype around Europe in his short managerial career. Nagelsmann takes over a squad that won every title available to them just two years ago and the biggest task for the 34-year-old will be to earn the trust and respect of his players as soon as possible, including captain Manuel Neuer, who happens to be a year older than his new manager. As a new season dawns against the backdrop of big changes at major clubs, it will be quite interesting to see what unfolds. But the return of fans to the stands, chanting, screaming and cheering their hearts out for their club, the outburst of joy with every goal scored and every tear shed for every defeat, with banners, flares and fireworks, football will get back its lifeblood, the fans.

As Messi himself opined in his first press conference for PSG, one may not achieve the highest success even with the best of teams and if things go south at the Parc de Princes, the first fingers will be raised towards Pochettino.

Although the Argentine coach has had success in the past with Tottenham, taking them the Champions League final with limited resources, Pochettino's managerial credibility will be tested to the limits this season.

While those in Paris are certainly enjoying the high life, Messi's previous club has no choice but to start afresh in La Liga. For years, Barcelona could rely on the Argentine's heroics whenever they were in dire situations. Now, coach Ronald Koeman's biggest responsibility now is to fill the void. The Dutch has options in the

Pep Guardiola's City have won the league three times in the past five seasons and the inclusion of Jack Grealish plus the possible signing of English striker Harry Kane will add even more depth to City's already formidable squad.

The German coaches, Chelsea's Thomas Tuchel and Liverpool's Jurgen Klopp, have opted not to tinker too much with their squads, although the addition of Romelu Lukaku means that the former have

Although, during the last edition of the AFC Cup, Kings in their debut season had made quite an impression -- by thumping a 5-1 defeat to TC Sports of Maldives in Dhaka -- before the tournament was cancelled due to the outbreak of the novel coronavirus. the back-to-back However, League Bangladesh Premier

champions, placed in Group D, are now geared up to take another shot at the AFC Cup as their matches are scheduled to take place in Maldives from August 18 to 24. Kings were set to depart for Maldives during early hours at 3:30 am (local time) today.

Bashundhara Kings' Spanish coach Oscar Bruzon believes that the upcoming tournament is going to be

a challenge for all the participating teams, as this edition of the AFC Cup features big names of the subcontinent clubs, the likes of Maziya SR&C, Eagles Club of Maldives, and ATK Mohun Bagan, JSW Bengaluru FC from India.

"Every team will find it challenging as there is no clear favourite," Oscar told The Daily Star yesterday.



"Upon analyzing our rivals, we are anticipating tight games which would be decided on small details. For us, it'll be important to start with a victory and keep our qualifying chances alive till the last game against Mohun Bagan [August 24]," said the 44-year-old coach, whose charges will kick-off the campaign against Maziya on August 18 before facing the winner between Bengaluru and Eagles on August 21.

"Our opponents have a variety of game plans but they all regularly deliver good results. Maziya is a very sharp dynamic team, and especially good on transitions, whereas Mohun Bagan is cohesive as a unit and difficult to beat. And Eagles have signed the senior players of Maldives national team for this tournament while Bengaluru under their new coach are implementing a high-line pressing game to prevent opponents from building up [from the back] comfortably. We also have our own playing style. Every game will require different adjustments but we will be loyal to our objective of being the dominant side on the pitch.

The charges of Bruzon have been consistent throughout the season to win two titles this season, courtesy of the four quality foreign recruits they possess, along with some talented national players boosted by the addition of Nigerian-born Bangladeshi Eleta Kingsly who however, is waiting for the final green signal from the AFC. One major advantage for Kings is that they would play in their peak form in Maldives, after having been in action in the domestic league of late.

CONTRACT BREACH OVER 10 LOCOMOTIVES Technical body recommends accepting those

A technical committee has recommended taking delivery of the 10 locomotives that South Korean Hyundai Rotem Company supplied to Bangladesh Railway without meeting some of the specifications agreed in the contract, said BR officials

The locomotives, which cost about Tk 330 crore, were left unused for eight months since they arrived in Bangladesh in September last year. The Railway authorities began trial run of the locomotives in late April this year, but the issue of receiving those formally is yet to be settled.

According to the technical committee, the locomotives can be accepted in their present format, said Dhirendra Nath Mazumder, director-general of the BR.

The locomotives, procured under a Tk 733.6 croreproject taken up in 2015, were supposed to be of TA12-CA9 alternator model, as per the contract signed with Hyundai. But the South Korean company provided the locomotives of TA9-12CA9SE alternator model.

The two models are different in terms of power output, said BR officials

Besides, as per a government plan, all rail lines in Bangladesh would be converted into dual gauge within a few years. The BR was instructed to purchase locomotives that could be used on both metre-gauge and broad-gauge by changing the undercarriages.

But with the TA9-12CA9SE alternator, the locomotives will not run on broad-gauge, according to BR officials.


