After months of stalling, Directorate General of Health Services (DGHS) yesterday finally announced that 25 people died of dengue at different hospitals across the country this year.

Among the deaths, five are at Dhaka Shishu Hospital, six at Square Hospital, four at Ibn Sina Hospital, three at Bangladesh

Specialized Hospital, two at Hospital, United one at Green Life Medical Hospital, and four outside Dhaka.

All of them died in July and August. An official of

control **DGHS** said room they have decided not to review the death as it is taking time. From now they will give the data collecting directly from hospital.

Earlier, authorities had said a review is required to confirm deaths due to dengue. Now, they will publish the numbers based on hospital records. They were reviewing the 25 cases but until yesterday were yet to confirm that they died of dengue.

Earlier, DGHS Director General Prof ABM Khurshid Alam had said, "In any epidemic, you have to verify the deaths officially, otherwise you cannot announce it."

When asked why it was taking two months to verify the data, he said, "As the same doctors are treating both Covid, dengue and non-Covid patients, the process is taking time."

Some experts had raised questions about the delay in the announcement. They said a death certificate should be enough in this case. Besides, a former high official of DGHS had said that there is no need to review any dengue-related deaths.

"A review is necessary when the government has to give compensation to a victim's family. Otherwise, there is no need for review before announcing the number of deaths," he argued.

"Once a hospital confirms that a patient has died of dengue, there is no need for a verbal autopsy, as the hospital authorities' statement is enough to determine how the patient died," he added.

"Verbal autopsy" is a method of interviewing one or more people who know about the symptoms and circumstances of the deceased.

In many countries, they carry out an

autopsy hospital after the death of a patient to improve hospital services, but there is no such provision in this country, he said.

Asked, Shirin, Tahmina head of the death review committee of the government and director of Institute of Epidemiology, Disease Control and Research, told The Daily Star last week that those involved with the committee

do not come to the IEDCR in-person due to the pandemic situation.

To carry out a death review, physical presence of the committee members is a must, for which they failed to start the process, she added.

Manzur Chowdhury, entomologist and former president of Zoological Society of Bangladesh, said area-based report on deaths, dengue infection and its mapping is necessary, and it should be published to make people aware. Mentionable, during the dengue epidemic in the country in 2019, there was confusion over the death toll, after major government hospitals stopped providing information to journalists.

Prof Meerjady Sabrina Flora, who led the DGHS death review committee in 2019, told The Daily Star at that time, to release the numbers the committee members assessed medical documents and treatment records of a deceased. And several months later, they conducted a verbal autopsy.

As per DGHS data, 179 dengue patients had died in 2019, and 276 death cases were

221 more hospitalised in a day

At least 221 people with dengue fever were admitted to hospitals in the country during 24 hours till 8am yesterday, of which only 22 are from outside Dhaka.

With them, a total of 6,321 patients have been diagnosed with dengue this year, according to Directorate General of Health Services (DGHS).

Of the total infected, only 330 are from outside Dhaka.

A total of 3,663 people were diagnosed during the running month till yesterday morning, which indicates the fastrising trend of the disease.

At least 2,286 people were infected in July, 272 in June, while 43 were infected in May. Although most of

the patients who were hospitalised have so far been released, 1,032 are still undergoing treatment at hospitals in Dhaka, and 70 outside the capital, DGHS data shows.

As the capital's public hospitals are overwhelmed with Covid-19 patients, those with dengue were finding it hard to get admission.

DGHS spokesperson Dr Md Nazmul Islam recently said the dengue situation could turn alarming again, but the issue can be tackled, if necessary measures are taken immediately.

Certain areas within the jurisdiction of the city corporation require intensive care when it comes to Aedes mosquitoes. They need to be cleaned, fogged, and sprayed regularly -- something the city authorities have failed to do. Some experts say this is the prime reason behind the rise in this year's dengue cases.

Most of these areas are outdoors, meaning they're beyond the scope of citizens' intervention. But rather than taking responsibility, the city corporations are shifting the blame on to the people, they added.

"Instead of going for early prevention, we wait until the eggs are hatched. There's no point in trying to kill mosquitoes only after dengue cases start rising," urban planner and architect Mobassher Hossain told The

"The outdoor fogging and spraying they do is mostly eyewash. Instead

and larvae, they are pushed to the roadside, and even into people's homes. Fogging should reach inside the houses," he added.

"There needs to be synergy. The city authorities need to adopt long-term plans to deal with dengue. For their part, the citizens' need to clean their toilets, air conditioners, flower vases etc. too. Only then we can contain the threat," he argued.

Entomologist Touhid Uddin Ahmed opined that often government offices themselves are breeding grounds for mosquitoes.

'If Aedes larvae are found in policeseized vehicles and inside government offices, only a city corporation can do anything about it. If they had managed to keep those places clean throughout the year, the rate of dengue infections would be much less," he said.

"For example, if you ask the city corporations, they'll tell you the police stations should control the larvae

of actually killing off the adults breeding inside their premises and adjacent areas. But where will they get the insecticide and the machinery?" Ahmed asked.

"This is nothing but a blatant 'blame game'.'

Ahmed also said, "If we want to stop the rising rate of infections, we will need to kill adult mosquitoes immediately, which requires effective fogging. And nobody but the city corporations have the means to do it.'

"But instead of doing that, they are only focusing on the larvae, while threatening and imposing fines on people (as a way to shift the blame). This is a waste of people's time and money," Ahmed opined.

Entomologist Dr Chowdhury, former president of Zoological Society of Bangladesh, spoke of more such areas under the sole jurisdiction of the city corporations. "There's nurseries, graveyards, parks, car garages, and more," he said,

"Several charter flight companies initially offered us to evacuate around 45,000 people from Afghanistan. In the last 15 days, we had talks with them several times on this issue," a top official of Biman told The Daily Star

Biman Managing Director and CEO Dr Abu Saleh Mostafa Kamal said they are observing the overall situation in Afghanistan and will decide soon.

Before deciding, we will have to know whether Kabul airport has the ground handling facilities, and who will carry out passengers' immigration formalities," said the Biman MD Moreover, the Biman boss said, "We have also informed

the insurance companies concerned, seeking their opinion on operating evacuation flights in Kabul at this time.

The court issued a rule asking the authorities concerned of the government to show causes in four weeks why their inaction to stop earth filling in croplands at Makhulia Mouja in Dhamrai by Kaizen Limited under Aksir Nagar Land Development Project should not be declared illegal. Officials concerned including land secretary, deputy

commissioner of Dhaka, upazila nirbahi officer of Dhamrai and managing director of Kaizen Limited Touhidul Islam have been made respondents to the rule. The HC bench of Justice Md Mozibur Rahman Miah and Justice Md Kamrul Hossain Mollah issued the rule after hearing a writ petition filed by five villagers of Makhulia,

including Badrul Sarder, challenging the legality of earth filling in agricultural lands by Kaizen Limited under the project in Makhulia. The HC also asked the Dhaka DC to dispose of in 60 days the application submitted by the petitioners on May 24.

ETHICAL CODES FOR NEWSPAPERS

Why it should not be formulated, HC asks govt

The High Court yesterday asked the government to explain why it should not be directed to formulate an ethical code of conduct for newspapers, form a broadcasting commission for electronic media, and stop operation of all unregistered online news portals.

The court sought the explanation from the respondents

through issuing a rule upon them. Information secretary, and chairpersons of Bangladesh Telecommunication Regulatory Commission (BRTC) and Bangladesh Press Council have been made respondents to the rule. They have to respond in a week.

The HC bench of Justice Md Mozibur Rahman Miah and Justice Md Kamrul Hossain Mollah issued the rule, following a writ petition filed by Supreme Court lawyers Rasida Chowdhury Nilu and Zaren Rahman. In the petition, they said the body of a 21-year-old

A team of Rab-4 arrested them from Dhaka and Madaripur after the story of a mother rescuing her trafficked daughter from India went viral on social media.

The gang lured the 17-year-old girl from Dhaka's Mirpur with promises of a job in India. But once there, they sold her off to a brothel in Bihar. All of this took place in January this year.

After her mother came to know of her ordeal, she tried to do everything in her power to get her daughter back, but to no

save her daughter

without disclosing her identity -- asking for a job in India, knowing that she was going to be trafficked like her daughter. She was soon taken to Delhi by the gang, but she was prepared for this and managed to flee their grip. Once free, she made her

way to Bihar and with the help of locals managed to rescue her daughter. During primary interrogation, the

arrestees admitted their crime. They admitted that they used to lure girls from poor families in Dhaka's Mirpur and Gazipur with jobs in beauty parlours in India, Rab's Al Moin told reporters during the briefing.

The gang, having at least 25 members, used to traffic women to India through the Satkhira border. Billal used to coordinate operations at the border, while Sohag used to hand the victims over to mastermind Kalu, he said.

The girls were sold at various brothels in India, the Rab official said. The trafficked victims were kept confined to Billal's safe
