AL feud behind **Barishal violence**

At least 50 hurt, some of them bullet-hit, in Wednesday night's clashes on UNO office premises; AL men including city mayor sued

A political rivalry between two Awami League stalwarts in Barishal city triggered the violence on the premises of sadar UNO's office on Wednesday night, leaving at least 50 people injured.

The incident led to a conflict between the authorities of the city corporation and the local administration, according to several politicians in the district.

Upazila Nirbahi Officer Munibur Rahman and police filed two cases over the incident, naming Barishal City Corporation (BCC) Mayor Serniabat Sadiq Abdullah as the prime accused for instigating the violence. Local AL men were also accused in the cases.

The mayor, however, alleged that Ansar members opened fire on him upon the UNO's directive after he went to the spot to calm the situation. He was unharmed.

Several local politicians told this newspaper that there has been a longstanding rivalry between Serniabat and Zaheed Farooque, state minister for water resources, over establishing supremacy in AL politics in Barishal city. SEE PAGE 2 COL 3

GOVT RECRUITMENT Age limit raised by 21 months STAFF CORRESPONDENT

Considering the impact of the coronavirus pandemic, the age limit for entry into government jobs has been extended by 21 months from the current limit of 30 years. The Ministry of Public Administration yesterday issued an order in this

regard. The letter stated that all government agencies that were unable to issue recruitment notices due to the Covid-19 pandemic are requested to accept applications till the end of this year from job seekers based on applicants' maximum age on Mar 25,

At present the age limit for entering government service is 30 years; 32 for freedom fighters' offspring. However, it will not be applicable for the jobs under BCS.

According to the order, if a job seeker was not 30 years old on March 25 last year would be eligible for upcoming government openings advertised till December this year. As such, people seeking

jobs in the public sector have, effectively, had the age limit raised by 21



17 years on, the road to justice not over yet

Final justice has yet to be delivered over the August 21, 2004 grenade attack on an Awami League rally on the capital's Bangabandhu Avenue, even almost three years after a trial court found 49 people guilty.

A Dhaka court on October 10, 2018 sentenced 19 people, including former state minister for home Lutfozzaman Babar to death. Nineteen others, BNP acting chairman Tarique Rahman included, were given life imprisonment.

RUSSIAN FOREIGN MINISTER SERGEI LAVROV

The Taliban urged unity ahead of Friday prayers and called on all imams in Kabul and the provinces to persuade people not to try to leave the country.

Since seizing Kabul on Sunday, the Taliban have presented a more moderate face, saying they want peace, will not take revenge against old enemies and will respect the rights of women within the framework of Islamic law.

During their previous rule from 1996-2001, they severely restricted women's rights, staged public executions and blew up ancient Buddhist statues. In Asadabad, several people were killed during

This comes at a time when over one crore people, who have registered for getting the vaccine, are waiting for their first dose.

The government has not permitted any private facility to administer Covid-19 vaccines. All eligible people are supposed to get the shots from designated government facilities for free.

The reported vaccine embezzlement and the subsequent availability of those in the black market came after various irregularities marred the special vaccination campaign between August 7 and 12.

Experts say these, however, small in number, are causes for serious concern and put the entire campaign into question.

"It's a small incident but the consequences are huge. The entire vaccine chain management system needs to be re-examined to find the loopholes. Monitoring and supervision should be strengthened from the national level to field level," Be-Nazir Ahmed, National Immunisation Technical Advisory Groups (NITAG), told The Daily Star yesterday.

Be-Nazir, also former director of Directorate General of Health Services (DGHS), said a proper probe was needed. Mechanisms must be devised to prevent such incident since a huge number of people would be vaccinated in the coming days. SEE PAGE 2 COL 3

WORLD MOSQUITO DAY TODAY Lax monitoring led to surge in dengue cases

Experts for year-round surveillance, effective mechanism to keep the mosquito-borne disease in check

The absence of an effective mechanism to check Aedes mosquitoes, including proper and timely surveillance by the city corporations, is mainly to blame for dengue cases spiralling in the capital and elsewhere in the country, experts say.

They say hospitals are dealing with an increasing number of dengue patients every day and it has put an additional burden on the country's healthcare system already stretched by the Covid pandemic.

At least 32 dengue cases were reported in January, when the population of the Aedes mosquito -- vector for the dengue virus -tends to be low.

But it was only in June that the two city corporations in Dhaka started mosquito fogging in areas where hospitalised dengue patients lived. The city corporations took almost four months to swing into action after collecting patients' addresses from hospitals, the experts pointed out.

By that time, the number of dengue patients had already crossed the 250 mark,



shows data from the Directorate General of Health Services (DGHS). The situation has worsened since only then.

"To fight dengue, year-round surveillance Aedes mosquitoes very important," Rahman, an Saifur

entomologist at the Bangladesh National University, told The Daily Star.

He said had the authorities conducted an extensive fogging in and around the patients' houses in January, the dengue situation would have been much better now.

On Tuesday, the country reported 329 dengue cases, the highest daily count this year.

In 24 hours till 8:00am yesterday, 270 dengue patients were admitted to hospitals across the country, shows DGHS data. Of them, 33 were admitted to hospitals outside Dhaka.

Another dengue patient died in those 24 hours, taking the official death toll to 31. All these patients died in July and August. Till yesterday, the total number of SEE PAGE 10 COL 2

10 Absconding Convicts in Aug 21 Case CID moves to seek Interpol red notice

To write to Police HQ for necessary steps

The CID will write to the National Bureau of the Police Central Headquarters to get the Interpol to issue red notices for 10 absconding convicts of the August 21 grenade attack case.

The 10 fugitives are retired Lt Col Saiful Islam Joardar, former DGFI director retired Maj Gen ATM Amin Ahmed, and militants Md Iqbal, Mohibul Muktakin, Anisul Morsalin, Mohammed Khalil, Maulana Liton alias Delwar Hossain alias Zobayer, Jahangir Alam Badar, Mufti Shafiqur Rahman and Mufti Abdul Hai.

Of the 49 convicted of the grenade attack in 2004, 16 are absconding.

Interpol had earlier issued red notices for six of them, but later cancelled the notice for BNP Senior Vice-Chairman Tarique Rahman, who is in the UK, and former BNP lawmaker Kazi Shah Mofazzal Hossain Kaikobad, who is either in the UK or the US. About the other four, the NCB has come to know Mawlana Mohammad Tajuddin Mia is probably in Pakistan, Abul Haris Chowdhury in India or Malaysia, Ratul Ahmed Babu in Italy or South Africa and Mohammad Hanif in Thailand or Malaysia

The International Criminal Police Organisation (Interpol) issues red notices for fugitives wanted either for prosecution or to serve a sentence. A red notice is a request to law enforcement worldwide to locate and provisionally arrest a person pending extradition, surrender, or similar legal action.

Police Headquarters' Central Bureau (NCB) in Dhaka is the focal point for Interpol in Bangladesh. Officers familiar with the proceedings

said the NCB recently asked the

Criminal Investigation Department for its opinion on whether to seek red notices for the 10 convicts.

An officer at the section concerned of the CID said the department was preparing the necessary documents. "We will write to the NCB to communicate with the Interpol about issuing the red notices for the 10 convicts."

Mohiul Islam, assistant inspector general, at the Police Headquarters said Interpol red notices were issued for six of the convicts at different times, but Tarique's red notice was cancelled on January 26, 2016, due to his protective status and Kaikobad's notice got cancelled on May 4, 2018, as it did not comply with the Interpol's constitution.

The grisly attacks on Bangabandhu Avenue in 2004 left 24 people dead and over 300 wounded. AL chief Sheikh Hasina, then opposition leader, narrowly escaped with injuries to her right ear.

Mohiul said at the request of the commissioner of Dhaka Metropolitan Police, the NCB was trying to get the red notice reissued for Tarique in a money laundering case filed with Cantonment Police Station in the capital.

In the grenade attack case, the CID pressed charges against 52 in October 2018. Of them 49 got convicted. The court awarded death penalty to 19, life imprisonment to 19, three years imprisonment and a fine of Tk 50,000 to four and two years imprisonment with a fine of Tk 50,000 to seven.

COVID FIELD HOSPITAL BSMMU slows down expansion as virus infection drops

Bangabandhu Sheikh Mujib Medical University authorities have slowed down the expansion of their Covid-19 field hospital as fewer new cases are being detected in recent days.

Officials yesterday reported 159 deaths of patients confirmed to have Covid-19, the lowest in the past one and a half months.

The BSMMU launched Bangamata Sheikh Fazilatunnesa Muiib Field Hospital with 356 beds on August 7. There are 20 beds at the Intensive Care Unit (ICU) and 20 beds at the High Dependency Unit (HDU) at the facility which has central oxygen supply system

Yesterday, the general bed occupancy declined to 39 percent from 69 percent on July 13. The ICU bed occupancy rate declined to 70 percent from 90 percent on July 30.

"The number of Covid-19 patients has been declining because there were some restrictions before August 11. With everything reopening, there is a risk of another rise," Dr Abu Jamil the Epidemiol member

Serniabat is the general secretary of Barishal city AL while Farooque, lawmaker from Barishal-5, is vicepresident of Barishal AL.

Witnesses said the violence ensued as some BCC staffers -- believed to be followers of the mayor and members of the local AL units -- appeared on the premises of the UNO's office in the city's C&B area around 9:30pm and tried to take down banners put up by Farooque's followers marking the National Mourning Day.

As on-duty Ansar members barred the BCC staffers from removing the banners, the mayor's followers started scolding them. On information, the UNO rushed to the spot from his government residence on the same compound. Mayor's followers misbehaved with him,

60-70 people. They then attacked the UNO's residence, breaking open its gate. At this, the UNO ordered the on-duty

Ansar members to open fire. Additional policemen, who had already arrived there, also swung into

As the incident heated up Barishal's political landscape, the authorities suspended road and river connection between the district and other parts of the country till yesterday noon.

Additional members of police and Rab were deployed at different parts of Barishal city to avoid any further untoward situation.

The C&B Road was blocked by garbage trucks of the city corporation.

Ten platoons of BGB members were also deployed across the city yesterday evening to maintain law and order.

Talking to journalists, Barisal Metropolitan Police (BMP) Additional Commissioner Md Enamul Haque said, "We did whatever was necessary to drive the mob away." Barishal Divisional Commissioner

Saiful Hassan Badal and Barisal Metropolitan Police (BMP) Commissioner Md Shahabuddin Khan visited the spot. Both of them said legal action would be taken against those responsible for the violence.

Two separate cases were filed with BMP's Kotwali Police Station in connection with the incident.

The UNO yesterday sued the mayor, 28 other named and 80 unnamed people over the violence.

 police sub-inspector filed the other case accusing the mayor, 94 other named and 400 unnamed people.

Police arrested 12 people, including Barishal city unit AL Joint Secretary Hasan Mahmud in connection with the incident, said Nurul Islam, officer-incharge of Kotwali Police Station.

Barishal district AL, city unit AL and BCL jointly organised a press conference yesterday and alleged that the UNO unleashed the violence as he was

involved in a conspiracy to tarnish the government's image.

In a statement yesterday, Bangladesh Administrative Services Association said it held an emergency meeting of its executive committee. The Association thinks the incident took place at the instruction of the BCC mayor, the statement said.

The association demanded the mayor's immediate arrest and other legal action against him, added the statement. Talking to The Daily Star, several local politicians said the violence on Wednesday night was the result of a longstanding feud between the mayor and the state minister.

Almost all 30 ward councillors in Barishal City Corporation were loyal to the mayor. But recently, six to seven of them joined hands with the state minister. These councillors in collaboration with the state minister organised different programmes and put up banners on the occasion of the National Mourning Day.

This irked the mayor and that is why his men went to take down banners from the premises of the UNO's office, they said.

The politicians also said Serniabat wants to take absolute control of Barishal city politics while Farooque is trying to increase his political strength in the city.

The two AL leaders did not make any comments regarding their rivalry or their involvement in the incident.

No official comment on the alleged conflict between the BCC and the local administration was also available.

Talking to journalists yesterday, Home Minister Asaduzzaman Khan said action would be taken against those responsible after investigation.

"The probe will reveal the real issue," he said.

JAPANESE WOMAN'S PETITION HC summons father over custody of two daughters

Asks him to bring them to court STAFF CORRESPONDENT

The High Court yesterday directed Bangladesh-born US citizen Imran Sharif to produce his daughters before it on August 31 after his Japanese wife Eriko Nakano, who moved to Bangladesh, filed a writ petition for custody of their children.

The court ordered the officers-incharge of Adabor and Gulshan police stations to ensure that Imran and his sister Amina Jebin produce the children -- Nakano Jasmine Malika, 11, and Nakano Laila Lina, 10, -before the court on that day.

It also ordered Imran not to leave the country with his daughters in the next 30 days.

The HC also issued a rule asking the authorities concerned of the government and Imran and Amina to explain as to why they should not be directed to produce the children before the court to satisfy it that they are not confined illegally.

The HC bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman came up with the order after hearing the writ petition.

Lawyer Mohammad Shishir Munir appeared for the petitioner during the virtual hearing.

Nakano, 46, a doctor based in Tokyo, came to Bangladesh on July 18 this year and filed a writ petition with the HC seeking a directive on Imran, 58, to hand over the children to her custody.

She submitted the petition to the court through lawyer Shishir, saying that Imran, who now lives in Mohammadia Housing Society under Adabor Police Station in Dhaka or in a Gulshan house, may flee Bangladesh with her daughters.

In the petition, Nakano said she and Imran got married on July 11, 2008, in Japan following Japanese and Muslim culture.

Imran submitted a divorce notice to a Japanese court on January 18 this year. However, he did not appear before the court on the scheduled dates for the hearing.

On January 21 this year, Imran picked up the daughters from their school in Tokyo and came to Bangladesh on February 21.

In the petition, Nakano prayed to the HC to order Imran to produce her daughters before the court in three days to demonstrate that they are not

confined illegally. She added that Imran took her daughters and harassed her intentionally by preventing her from seeing or contacting them.

Wounds unhealed

"With all these complications, I am not sure if I will get to see the culprits punished before I die."

During the phone conversation, her voice cracked frequently. In between, she spoke of her tribulations: she feels numb in her left leg and left hand. Just days ago, she slipped and fell from the stairs as her left leg betrayed her and took a misstep.

Her husband, who was a big support for her in this condition, died a few years ago. "For me, living is now hell due to the pain all over the body.

She added: "Despite all these sufferings, it would bring us some solace if we could see implementation of the verdict in our lifetime."

When she was taken to the hospital after the grisly attack 17 years ago, everybody thought she was dead. They even kept her among the dead bodies, she recalled.

She first moved her limbs after three days in a coma, and regained full consciousness after 25 days.

Rashida Akhtar Ruma, another victim bearing over 1,000 splinters in the body, was 24 when she suffered the injuries. Now 41, her pain is unbearable somedays, and it is getting worse with time.

"All that we want is to see the perpetrators and mastermind of the attack, Tarique Rahman, punished in my lifetime," she said.

Execution of the capital punishment

remains pending as the High Court has not yet started hearing on the death references and appeals by the 19 deathrow convicts.

Nasima Ferdushe, now in her 60s, sustained injuries so bad that doctors cannot do an MRI on her because of the 1,500 splinters she still carries, including in her head, lungs, and chest.

A former MP, Nasima said the pain was a constant reminder of the attack. She was only able to walk after five years of treatment and had been bedridden for nine months.

"Many of the grenade attack victims have already died. Many others are waiting for the end like me with untold sufferings," she said, adding that to be able to see the final justice done would take away at least some of the pain.

The attack left 24 people dead and over 300 injured.

Prime Minister and AL chief Sheikh Hasina, then opposition leader, narrowly escaped death with injuries to her right ear. Ivy Rahman, wife of late president Zillur Rahman, was among those killed.

Nazimuddin, 60, carrying around 100 splinters, said pain in different parts of his body was increasing with each passing day.

A vice-president of Dhaka City North Awami League, he said the execution of the verdict, including the death sentence for 19, would bring them some mental peace although it would not ease their physical pain.

Several other survivors shared his sentiment and called for quick completion of the High Court proceedings.

Alarm as vaccines found at pvt clinic

On Wednesday night, police, following a tip-off, arrested Bijoy Krishna Talukder, 37, for selling Moderna Covid-19 vaccines at Sheba Clinic in Chalabon area of Dakkhinkhan, Azizul Huq Mia, officer-in-charge (investigation) of Dakkhinkhan Police Station, told The Daily Star.

Bijoy was supposedly a volunteer in the special vaccination drive at a centre in Uttarkhan in the city.

The law enforces recovered an ampul of the vaccine from Bijoy's room and 20 packets that could hold 10 ampules each. Police later raided his home in Hazipara area and found another ampule in his refrigerator, said the official.

"During primary interrogation, we learnt that Bijoy was vaccinating people for Tk 500 per dose. We traced a couple who have taken the jabs from him. We are trying to get details," said Azizul.

Saiful Islam, deputy commissioner of Uttara division police, told this paper that Bijoy told police that he took the ampules from the vaccination centre.

"We have requested the city corporation [DNCC] to check whether any ampul was missing. We have also asked for details of Bijoy as he claimed to have worked as a volunteer," said Saiful. He said the DGHS was informed and

it was investigating how the shots got out of the vaccine centre. Dhaka North City Corporation Mayor

Atiqul Islam said, "I am yet to receive any letter from the police. We will give full assistance to the police.

He, however, said they would not

investigate the matter themselves.

Health officials have squarely blamed the DNCC authorities for the vaccines ending up in the black market.

They also said the vaccination campaign was going smoothly until the special vaccination campaign was held during which around 55 lakh people got vaccinated.

"The vaccination campaign has been monitored by us. But during the special mass vaccination campaign, some new centres were opened under city corporations and all the anomalies happened in the city corporation areas," said a DGHS official, preferring not to be named.

2 die, 270 hospitalised in a day

Leaving a 40-day-old baby behind, Tabassum Shahirin died of dengue yesterday morning while undergoing treatment at Enam Medical College Hospital.

Tabassum was a former student of Jahangirnagar University's international relations department.

Her husband Miftahul Islam has also been hospitalised with dengue.

"Tabassum was admitted to the hospital in critical condition on Wednesday nightaround 8pm. After her condition deteriorated, she was shifted to the intensive care unit (ICU), where she passed away at 7:25am yesterday morning," the hospital's duty manager Babul Hossain told The Daily Star.

According to Directorate General of Health Services (DGHS), one more dengue patient died, while 270 more were hospitalised in the last 24 hours till 8am yesterday.

With the new cases, the number of dengue patients this year rose to 7,251, according to DGHS. Of the total infected, only 416 are from outside Dhaka.

Meanwhile, 31 people have died of dengue in the country this year -- the fifthhighest total deaths since 2000, when the country first experienced dengue cases. At the time, 93 people died of the virus.

Experts said if the city corporations do not take effective measures to kill adult mosquitoes immediately, the situation will

Although the foreign minister recently said flights with India will resume today, Biman Bangladesh Airlines, US-Bangla and Novoair said they are yet to get any direction from Civil Aviation Authority of Bangladesh (CAAB) in this regard.

CAAB on the other hand said they are yet to get any formal reply from India about resuming flights.

Amid this situation, several hundred Bangladeshis, most of whom went to India for medical purposes, remained in

uncertainty about returning to the country by air. Many Bangladeshis waiting for a long time to go to India for treatment are also in limbo.

Foreign Minister Dr AK Abdul Momen on Tuesday said operation of flights between Bangladesh and India will resume today.

He said India had agreed to resume on Bangladesh's request, considering demands of facilitating movement of passengers and goods

They were supposed go to Fiji to work as agricultural labourers. But after being trafficked to India, and they ended up spending months in seedy hotels.

A Rab-3 unit yesterday arrested a manpower agency who had left dozens of aspiring migrant workers stranded in Delhi, Mumbai, and Nepal for months.

Md Yasin Mollah, a small trader from Madhabdi in Narsingdi had spent as much as Tk 4,50,000 for the elusive agricultural job in Fiji. But instead, he landed in a hotel in India for three months. And after his visa expired, he was forced to cross back to Bangladesh illegally.

The primary school graduate cannot even locate Fiji in a map, and the traffickers took advantage of exactly that.

Twitter launches new tools to report covid misinformation

Twitter announced on Tuesday that it will begin testing a new reporting feature that will allow users to flag tweets that contain potential misinformation, reports The Verge.

Users will be able to report misinformation in the same way that they can report harassment or other harmful content, starting today, via the dropdown menu at the top right of every tweet.

Users will be asked to choose whether the false statement is political, health-related, or belongs to another category.

According to The Verge report, more specific forms of misinformation, such as election-related content, are included in the politics category. Users will be able to flag Covid-19-specific misinformation under the health category.

Users will not receive any updates from the company on what happens to misleading tweets they report for the time being, though this may change in the future.

The new feature will be available to most users in the United States, Australia, and South Korea on Tuesday. Twitter stated that it plans to run this experiment for a few months before expanding it to other markets.

Twitter describes the test as an "experiment," not a fully functional feature. According to a report in

TechCrunch, Twitter will monitor how users interact with the new misinformation reporting tool to see if it can be a useful tool for identifying potentially harmful misleading tweets.

Previously in 2019, the platform added the option to report false election-related tweets to help protect elections in Europe and India.

As the platform continues to test the feature, Twitter stated that not every report will be reviewed. However, the information gathered during the test will aid the company in determining how to expand the feature in the coming weeks. The test could also be used to detect tweets that contain false information and have the potential to go viral.

While the option to identify tweets as misleading is a new feature, the new option will feed reported tweets into Twitter's current enforcement mechanism, which employs a mix of human and algorithmic moderation to enforce Twitter's known policies surrounding health and political misinformation.

This procedure will also prioritise reported tweets for review. Tweets from users with large followings or tweets with unusually high levels of engagement, as well as tweets about elections and Covid-19--Twitter's two areas of focus when it comes to policing misinformation, will be prioritised for review.

According to TechCrunch, the new test is Twitter's newest attempt to rely more on its own community to detect misinformation.

Address challenges of climate FROM PAGE 3 representatives of civil society organisations and other stakeholders. Water resource and climate expert Prof Ainun Nishat said salinity intrusion due to sea-level rise and river erosion are two

major causes behind climate-induced migration and displacement in Bangladesh. People facing such situation have to be provided with sufficient skills training for employment opportunities, he said.

Prof Ainun said the government's action plan on climate change related issues has to be scientific and suggested for undertaking "land reclamation" initiative in the coastal areas to support people's livelihood there. In his keynote presentation, former foreign secretary and migration expert M Shahidul Haque said climate change is an "existential threat for Bangladesh" and "climate migration is a development crisis". Climate change displacement has redefined migration and mobility globally,

he said, adding, due to climate-induced migration, the development ambition of Bangladesh will be challenged. Saying people displaced forcibly due to frequent flooding are "climate-induced

migrants", Shaheen Anam, executive director of Manusher Jonno Foundation, said another example in this regard is river erosion.

She said they have been advocating for long to formulate a "river erosion policy" in the country, adding the new poor has to be the targeted group if the country wants to live up to the goal "leave no one behind". Rezaul Karim Chowdhury, executive director of COAST Foundation, said Bangladesh needs to form a "climate commission" to negotiate climate change related issues in global forums.

Affirming that river erosion is a main reason behind creation of poverty in the country, State Minister for Planning Shamsul Alam said the government is aware of the situation.

Various projects have been undertaken for the development of slum areas, said the state minister, addressing the event as chief guest.

Besides, the government is also trying to reduce the gap between rural and urban areas in terms of ensuring services, he added.

On labour migration, the state minister said, "The 8th Five-Year Plan will make a comprehensive push to expand overseas employment and remittance earnings through government-to-government negotiations by lowering the cost of migration."

Regarding capacity restrictions on flights, CAAB said a maximum of 140 passengers in a narrowbodied (single aisle) aircraft and 200 passengers in wide-bodied (twin aisle) aircraft can be carried.

Apart from Biman, Novo Air and US Bangla, five Indian airlines used to operate flights from Bangladesh on various routes going to India during normal times. The airlines include Air India, Indigo, SpiceJet, Vistara and GoAir.

More than 3,500 Bangladeshis travel to India daily on average. Of them, over 10 percent used to travel for medical purposes.

More than 13.7 million foreigners, including 2.8 million Bangladeshis, took treatment in India between January 2018 and March 2019.

COPING WITH PANDEMIC Locals raise Tk 16 lakh in five days to install central oxygen supply

50-bed Birganj Upazila Health Complex now has an oxygen supply outlet next to each bed Kongkon Karmaker with Firoz A Muzahid

Belongingness, willingness,

compassion and leadership go a long way when it comes to overcoming any difficult situation or task.

The people of Birganj, which means land of the brave, have just proved that they have all it takes to overcome any situation and the naming of their birthplace is iustified.

Thanks to the timely initiative of a local business owner turned politician, a number of warmhearted residents of Birganj upazila in Dinajpur raised necessary funds in five days to install a centralised oxygen supply system for every bed in 50-bed Birganj Upazila Health Complex.

When many high-priority government-run district hospitals are yet to get central oxygen supply system, the authorities of Birganj Upazila Health Complex, with oxygen outlet available for every bed, is now capable of assuring their critical Covid patients of best possible care.

Serving a population of 3 lakh, the health complex had so far been unable to treat critical patients with Covid-19 since the pandemic broke out in the country in March last year.

Zakaria Zaka is a business owner and president of Awami League's Birganj upazila unit. He said after he found out that the health complex was not equipped to cope with the rising number of Covid patients with its existing eight oxygen cylinders, he put his mind to find a solution to the ominous scenario.

On July 19, he met with officials of the health complex to assess what is required to solve the longstanding problem at the hospital. Soon afterwards, he conveyed the assessment to a firm that builds

and delivers central oxygen supply systems to medical facilities.

Following site visit, the firm provided him a Tk 16-lakh estimate for the job and Zakaria formed a committee of 23 members to raise the fund.

Thanks to the generosity of Birganj residents, the entire amount of the required fund was raised by July 31 -- only five days after they started going from door to door in Birganj, Zakaria said.

The firm took five days to install a 360-kg upgradable oxygen reservoir for the centralised system and 50 wall outlets for supplying oxygen to patients in all the 50 beds of the hospital.

The final bill the firm collected

was Tk 14 lakh, said a thankful

Zakaria. Mohammad Mohsin, health and family planning officer at the health complex, hoped that the situation would now improve at the hospital that had been struggling to provide proper oxygen support to critical patients in all its four wards, including its Covid isolation ward.


A 42-year-old Covid patient, who took treatment at the hospital a week ago, said she realised how dangerous it could get if proper oxygen supply is not provided to a patient in time. She hoped that government hospitals in other upazilas would follow the example of Birganj Upazila Health Complex in getting their own centralised oxygen supply

systems.

During the inauguration of the central oxygen supply system at Birganj Upazila Health Complex on August 11, Dinajpur-1 (Birganj and Kaharol) lawmaker Manoranjan Shil Gopal, while speaking as chief guest, said the people have done what the government could not do.

This proves that every problem can be solved if the people want it, the MP added.

According to health officials in Dinajpur, at least 480 people tested positive for Covid-19 in Birganj upazila since March last year and 13 of them, including a staff member of Birganj Upazila Health Complex, died of the disease.

Shihab Uddin Palash of Panchnal village of Yugikhali union in Kalaroa upazila used to work in a school for the disabled people run by an nongovernmental organisation (NGO). The young man also worked as an artisan beside the job.

At one stage, he left the job and trained up the poor women of the area in handicrafts to help them become self-reliant. He formed an organisation called 'Puppet Handicrafts' in 2014.

"We use date palm leaves and straw as raw materials. Our products are being exported to 10 countries including those in Europe after meeting up the orders from the country," Palash said.

Three dead, 50 wounded in blast targeting Shia in Pakistan

At least three people were killed and 50 others wounded when a bomb explosion ripped through a Shia Muslim procession in central Pakistan yesterday, officials said. Security was high as the religious minority marked Ashura during the holy month of Muharram, a flashpoint for sectarian violence in previous years. Social media videos showed bleeding victims lying on a road being assisted by members of the public. Authorities have suspended mobile phone services in major cities as a security measure during Ashura processions. No group claimed responsibility of the blast till filing the report.

Pfizer jab declines faster than AstraZeneca: study

The effectiveness of the Pfizer-BioNTech vaccine against Covid-19 declines faster than that of the AstraZeneca jab, according to a new study published yesterday. "Two doses of Pfizer-BioNTech have greater initial effectiveness against new Covid-19 infections, but this declines faster compared with two doses of Oxford-AstraZeneca," researchers at Oxford University said. The study, which has not been peer reviewed, is based on the results of a survey by Britain's Office for National Statistics that carried out PCR tests from December last year to this month on randomly selected households. Pfizer had "greater initial effectiveness" but saw "faster declines

Sets up thousands of paediatric beds; Biden to get booster jab Agencies

Several Indian states are building facilities with more paediatric beds, plus oxygen, due to concern that children returning to school without being vaccinated will be among the most vulnerable during a third wave of coronavirus infections.

Health administrators have taken heed of trends in the United States, where a record number of children have been hospitalised as the coronavirus Delta variant, first found in India, has surged through unvaccinated populations.

During a second wave of infections in India that peaked in April and May, hundreds of thousands of people died for want of oxygen and medical facilities, and now there are concerns that another third wave will gather during the winter months.

"We don't know how the virus will behave, but we cannot afford to be unprepared this time around, Suhas Prabhu, who heads the Paediatric Task Force in the big western state of Maharashtra, said.

'No mother should have to run around looking for a hospital bed when her child is sick.

The Maharashtra government has stockpiled medicines, and built facilities for additional pediatric beds and oxygen provisions in new centres in Mumbai and Aurangabad.

Built on empty stretches of land or in re-purposed stadiums, the Mumbai facilities have a total of 1,500 pediatric beds, most of them with oxygen.

"We can upgrade this capacity to double if the world have yet to receive a single dose.

needed," Suresh Kakani, a senior official with Mumbai's civic body said.

In neighbouring Gujarat, authorities have set up 15,000 pediatric oxygen beds, health commissioner Jai Prakash Shivahare said.

Meantime, schools in at least 11 of India's 28 states have opened after more than a year of closures, raising worries these could become breeding grounds for transmission of the virus.

As of March 2021, less than 1 pct of India's coronavirus deaths were in the under 15 age group, according to the health ministry, and officials say the severity of the disease in this age group has been minimal so far.

Epidemiologists say there is no evidence to show that the Delta variant or any other mutations affect children more than other parts of the population.

Meanwhile, US President Joe Biden said he and his wife Jill will both be getting a Covid vaccine booster shot, with the extra dose becoming available to all US adults from next month.

Israel began administering third Pfizer doses last month to confront a surge in local infections driven by Delta. Several European countries are also expected to begin offering boosters to the elderly and people with weak immune systems.

The World Health Organization condemned Wednesday the rush by wealthy countries to provide Covid vaccine booster shots, while millions around

TALIBAN FIGHT TRUST DEFICIT WITH PR BLITZ

Smiling and waving at journalists, posing for selfies in the streets and even sitting down for a TV interview with a woman journalist, the Taliban appear to have launched a public relations blitz, telling Afghans -- and the world -- that life under their rule will be different this time. But Taliban 2.0 is a hard sell. Memories of the militants' brutal 1996-2001 regime and the near-two-decade insurgency that killed tens of thousands are etched on Afghan minds -- especially women and religious minorities.

WHAT ARE THE TALIBAN PROMISING?

"On ideology, and beliefs, there is no difference," longtime Taliban spokesman Zabihullah Mujahid said in his first press conference. "(But) based on experience, maturity, and insight, no doubt there are many differences." He ticked off all the boxes -- a full amnesty for all, women would have rights, including to education and work, the media would be independent and free, and an inclusive government would be created in a country where ethnic and sectarian rifts run deep. Taliban have also vowed that Afghan soil will not be used against other nations, and that they want to be a part of the international community. In arguably one of their most astonishing gestures, they sent representatives to a ceremony marking Ashura, one of the most important periods of the year for Shia Muslims -- considered heretics by many hardline Sunnis, such as the Taliban.But all the vows come with a caveat: everything must be in line with the principles of Islam, as they interpret it.

WHY IS THERE SUCH LOW TRUST IN THE TALIBAN?

Much like last week, the Taliban promised general amnesty to their opponents when they first captured Kabul 25 years ago. "We do not believe in any kind of revenge," their leader Mullah Omar told Kabul residents on September 25, 1996. Two days later, the Taliban shot former president Mohammed Najibullah, dragged his bloodied body outside and hung it from a post. While the group is trying to show a moderate, new face



from Kabul and Doha, reports have emerged of their fighters harassing journalists and not letting women enter universities in some parts of the country. Images of women have been covered up or vandalised on storefronts around Kabul. And their enforcers in rural Afghanistan and smaller cities are still reportedly brutalising people. Just over a week before capturing Kabul, the Taliban claimed responsibility for killing the head of the government media centre -- the same place where their spokesman spoke of independent journalism on Tuesday. "They have better PR now," Pashtana Durrani, who runs a women's education charity, told Britain's Channel 4 in an interview. "What they are saying in press conferences and what they are doing on the ground... are two different things," she added. "It's a grave reality that they haven't changed, they're the same people."

DOES WORLD BELIEVE THEIR PROMISES?

Not yet. Despite their months-long campaign of assurances, Afghans are terrified. And the Taliban's promises have yet to win them any diplomatic recognition. Analysts and officials say there is no guarantee Taliban will get the funds it needs to revive its fragile economy unless Western donors are convinced that rights are protected and groups like al-Qaeda no longer find haven in Afghanistan. British Prime Minister Boris Johnson on Wednesday echoed warnings from other governments: "We will judge this regime based on the choices it makes and by its actions rather than by its words."

China marks Tibet anniversarv with call to accept Party rule

China vesterday marked the 70th anniversary of the founding of the Tibet Autonomous Region on the roof of the world, with a call to accept the rule of the Communist Party. Beijing has ruled the remote region since 1951, after its People's Liberation Army marched in and took control in what it calls a "peaceful liberation". "Tibet can only develop and prosper under the party's leadership and socialism," Wang Yang, who heads a national organisation responsible for uniting all races and all parties under the leadership of the Communist Party, said at the event in the region's capital, Lhasa. The celebration, attended by almost 10,000 people, was held at the foot of the iconic Potala Palace, a sacred Buddhist site associated with the Dalai Lamas.

POST-POLLS VIOLENCE IN WEST BENGAL HC orders CBI probe

The Calcutta High Court yesterday ordered a probe by Central Bureau of Investigation (CBI) into allegations of arson, violence and rape in West Bengal soon after assembly elections in which Mamata Banerjee-led Trinamool Congress emerged victorious this year.

A seven-member committee set up by the National Human Rights Commission (NHRC) in compliance with the High Court order had investigated the incidents of post-poll violence and recommended a courtmonitored CBI probe.

The CBI will probe the allegations of murder and rape while a separate Special Investigation Team (SIT) consisting of senior Indian Police Service officers of West Bengal cadre will be set up to investigate the other allegations.

The court observed that there are "definite and proved" allegations that complaints of the victims of violence in the aftermath of polls were not even registered. The High Court has sought probe status report within six weeks and fixed the next hearing on October 4. Both investigations will be monitored by the court.

The BJP had alleged that after TMC's victory, its goons had attacked women members, killed workers, vandalised houses and looted shops and offices belonging to the saffron party members. The Bengal government has said the reports have been greatly exaggerated and most of the incidents of violence that took place around the May 2, the vote counting day, when the state police were under the control of the Election Commission.

Trapped in Kabul's no-man's land

Thousands of Afghans were packed yesterday between Taliban checkpoints and a US-imposed ring of steel around Kabul's main airport, desperate to get aboard any flight out following the return of the hardline Islamist group.

Even more were mobbing foreign embassy compounds in the capital, as rumours spread that visas were up for grabs or safe passage on offer at least as far as the airport.

Unconfirmed reports on social media say several people have been killed as US forces and the Taliban struggle to contain the desperate throngs on their respective sides of an unofficial no-man's land.

"I went to the airport with my kids and family... the Taliban and Americans were shooting," said one man who until recently had worked for a foreign NGO.

"Despite that, people were still moving forward (to get in) because they knew a situation worse than death awaited them outside the airport."

There have been chaotic scenes since the weekend, when the Taliban drove unopposed into the capital



after a two-week lightning offensive that capped a simmering 20-year insurgency

Distressing pictures and video have emerged of people desperately trying to get aboard any flight leaving -- even resorting to climbing on a US military Hercules as it rolled down the runway for take-off

Some semblance of order has been restored, but thousands have been left stranded between the Taliban and US lines -- clinging to an unrealistic hope that they will be let in and evacuated. The Taliban have provided official escorts for some foreign embassies -- taking their nationals as well as Afghans -- and they are being allowed in by the Americans.

But even that journey -- which can take several hours for just a few kilometres (miles) is fraught with heartbreak.

"There were people beating on the windows of the bus, trying to get inside," said a woman who made it through on Wednesday.

"The Taliban with us fired in the air to chase them away."

There was desperation also near the diplomatic enclave yesterday, as thousands clamoured to get the attention of anyone at now largely deserted embassies.

"I was told that if I get my name and my details and my phone on a paper to the French embassy they will take me," said one man.

Hundreds of people sat on pavements begging for scraps of paper or to borrow a pen to do the same.

Washington said Wednesday the Taliban were reneging on pledges to allow Afghans who worked with the United States and its allies out of the country and asked for compliance.



Sabri poisec to become Malaysia PN

Former Malaysian Dep Prime Minister Ismail Sabri Yaakob moved cl yesterday to forming th next government after securing a parliamentar majority from the same coalition that collapsed

earlier this week. Muhviddin Yassin resigned as prime minis on Monday after conceding he had lost support from his alliance, bringing to an end a fraught 17 months in office.

If confirmed, Ismail Sabri's appointment would mark the return of the

Organisation (UMNO) party to leadership, three years after it lost a general election because of

corruption allegations. Muhyiddin yesterday said Sabri has the support.

The support was conditional on Ismail Sabri ensuring that the new

cabinet members were free from graft charges, he said in a statement.

Ismail Sabri, 61, has the support of 114 lawmakers out of the 222seat parliament, UMNO lawmaker Ahmad Maslan said on Twitter.

King Al-Sultan Abdullah, the constitutional monarch who will be appointing a new premier, is scheduled to meet with the country's other senior royals today.

A decision on the new government head is likely to be announced after that.

NURTURING DREAMS Skipping towards Guinness World Records

Skipping is a playground staple for people of all ages. Rasel Islam, a teenager from Thakurgaon, has commandeered the sport with two Guinness World Records to his name. On January 2, 2021, he set new world records by skipping 145 times in 30 seconds on one foot, and another by skipping 258 times in 1 minute. To improve his hand-eye coordination and muscle endurance, the 18-year-old trained for six months before attempting to break the records.

Rasel has been skipping since 2017. "People used to discourage me from skipping, saying it is a 'girl's sport'. Nonetheless, I continued practicing, as I was determined to prove my ambitions," he said.

Rasel looks up to Konok Karmakar, who is currently the highest Guinness World Record holder from Bangladesh, with 15 records to

The young skipper received his official recognition certificates on July 29 this year. "My family was over the moon. People came over to our house to take pictures with me," Rasel added.

This is just the beginning for Rasel as he hopes to break more records in the skipping category, moving forward. He has already signed up for 10 more records. "I plan to participate in the World Jump Rope Championship. I also want to form a team of skippers in Bangladesh, so we can compete on international platforms," concluded Rasel

The Bangladeshi medical student won the Outstanding Young Leader of Asia Award

Rakib Al Hasan from Bangladesh won the Outstanding Young Leader of Asia Award 2021 from the Asian Youth Council for his work in children's and women's rights, education, health, democracy, and peace. Youths around the world are doing important work during the coronavirus pandemic. For the first time, the Asian Youth Council, a well-known youth organisation in Asia, organised this award programme to provide such young leaders with opportunities.

Rakib, a final-year medical student of Shaheed Suhrawardy Medical College Hospital, is a writer and activist. Furthermore, they will have the opportunity to make fully funded tours in 48 countries in Asia, and actively participate in international projects and development activities of the Asian Youth Council.

YOUTH IN ACTION Brihonnola reaches out to 5 prestigious scholarships for **Bangladeshi students** those in need

Pursuing higher education at a foreign university is a dream for many, but the associated costs may be a hurdle. In this case, financial aid and scholarships are helpful. Students often do not apply for scholarships due to lack of knowledge about the opportunities. Let us look into 5 prestigious scholarships for Bangladeshi students.

Fulbright Scholarship

The Fulbright Scholarship provides graduate students and young professionals with opportunities to pursue fully funded master's degrees in the USA. As a prerequisite, applicants must have at least two years of full-time professional experience relevant to their proposed field of study. "This scholarship includes a variety of allowances for potential grantees. It also acts as a good network of scholars from other participating countries," shared Shwe Wai Ching, a Fulbright scholar.

Erasmus Mundus Programme

This programme offers fellowships and scholarships, which cover tuition fees, living costs, insurance, and travelling costs. The amount varies according to the levels of study, duration, and the nationalities of students. The joint master's scholarship is a fully-funded grant sponsored by the European Commission. "The scholarship offers students the opportunity to study in multiple European Union countries," shared Md Shafwan Ul Alam who is set to attend his first two semesters at the University of Lorraine, France.

Commonwealth Scholarship

This scholarship and fellowship is only available for students from Commonwealth countries. The subject areas the scholarship covers are engineering and technology, science, agriculture and humanities, and social sciences. As a part of the application process, students have to scout through the different host universities listed, and jot down the courses that seem fit. "My scholarship is jointly funded by the United Kingdom (UK) Foreign, Commonwealth and Development Office (FCDO) and the UK university I was

Chevening Scholarship

This scholarship, funded by the UK government's FCDO, empowers recipients to pursue a master's degree at a UK university. It is a merit-based scholarship for young professionals from diverse fields who have at least two years of work experience, and have proven exemplary leadership and networking skills. "The Chevening secretariat and local British High Commissions arrange different events for scholars, offering great networking opportunities with people from all over the world," added Chevening scholar Khaled Hasan.

Stipendium Hungaricum Programme

The Stipendium Hungaricum programme aims at providing scholarships and study opportunities on a wide range of courses. It seeks to encourage the globalisation of Hungarian higher education and its continuous growth, to improve academic and research community international relations. It is currently offered to students from close to 80 countries. "This scholarship provides me with tuition-free education, monthly stipend, accommodation and a health benefit scheme," asserted Maisha Maimuna.

Seeking an equal and inclusive society, Brihonnola relentlessly works with the transgender community. The organisation intends to include transgender individuals in the mainstream society, while promoting gender equality in Bangladesh. Sadikul Islam started Brihonnola in 2018, along with an executive team of 15 members, amongst which most were transgender people.

"We disbursed daily necessities and relief funds to the transgender community in the beginning," mentions Sadikul, who received the Joy Bangla Youth Award 2018. "During this pandemic, we initiated various social-awareness campaigns around Dhaka. A team of Brihonnola's transgender members have been volunteering in front of Dhaka Medical College regularly. However, their journey has not been a smooth one. "There is an ill-intending middle man circle at the hospital gates, and we are sometimes mistaken for them," says Sadikul. "On the other hand, some people are still hesitant about getting help from a transgender person because of social stigmas, or family pressures."

Research, cultural, youth networking and relationship development, accessible environ-

ment promotion, and education and skill development are the main departments of Brihonnola. The organisation also has three active executive committees, including the central committee, Chittagong University committee, and Dhaka University committee, with 100 members. Facilitating financial and educational empowerment for the

transgender community, Brihonnola provides counselling, and plans to open a learning centre for transgender people to equip them with necessary skills for var-

Any law on data protection must respect data privacy

Such laws must not be used to infringe on individual rights

HE protection of personal data in the modern world is a complicated and contentious issue, especially when there is increasing evidence not just of spyware and surveillance technology accessing our data in the most insidious ways, but of big tech companies collecting and mining user data and potentially having the power to store more personal information of a country's citizens than their own government. After the 2018 Cambridge Analytica data scandal, there has been a growing debate on how much information is too much, and what governments can do to ensure they are able to protect the personal data of their citizens.

Against this backdrop, it is safe to say that there is a strong logic behind countries playing a more involved role in the protection of data generated within its borders and preserving data sovereignty. However, the best way to go about it is still being debated, and there are still questions of whether this is even realistic—given the nature of big data—and whether it would be ethical for governments to have more control over the personal data of its citizens either.

Now that Bangladesh is drafting a new data protection act, these differing views must be taken into account with the utmost seriousness. According to the minister of post and telecommunication, this law will address three major gaps—it will allow the authorities to take action against social media companies, fulfil the need for a law on data protection, and enable the protection of people's privacy. Given that Bangladesh is one of the 25 countries in the world with no laws on data privacy and protection (according to the United Nations Conference on Trade and Development's tracker), experts have recognised the need for legislation in this area.

However, experts and rights activists have also expressed concerns that the new law will focus less on data protection, and instead be used more as a tool of surveillance on social media. In India, we have already seen the authorities use similar data protection laws to infringe on individual rights—for example, by suspending Twitter accounts of journalists, media outlets, and politicians during the country's farmer protests, and blocking hundreds of pro-farmer tweets that were deemed "controversial" by the government. What safeguards will be in place in Bangladesh to ensure that the same does not occur, especially when the draconian Digital Security Act has already been wielded by the authorities to suppress dissent?

There is definitely a lot of merit in formulating data protection laws, but there is a lot of scope for misinterpretation and misuse as well. Any such laws created in the country must have the ultimate goal of protecting the privacy and data of users from anyone, including state actors. The precedent set so far in this regard is not an encouraging one—according to experts, the existing Data Privacy and Protection Regulation 2019 does not provide enough checks and balances to protect data from state actors. We must remember that personal data of any individual is personal property that cannot be misused by private companies or by the state. Whatever steps Bangladesh takes, our government must guarantee individual rights are not infringed upon, as guaranteed by the Constitution of Bangladesh.

Taliban takeover of Afghanistan: Its meaning and implications

HIRD W ANAM HIRD W HIRD W ISTORY unfolds in ways that may appear to be totally incomprehensible to us. It may not fit into our logic, may appear to be contrary to the facts that are at hand and our own

analysis, which, often guided by our prejudice, may have indicated a different outcome. But as the dust settles and we understand things better, the outcome looks quite inevitable. That is how the Taliban takeover looks as we unearth more and more facts—inevitable. It is up to us now to understand the meaning of their victory, its regional and global significance, its ideological impact on the short term and the long term and what implications it has for us in Bangladesh Two fundamental realities must guide our present thinking: The importance of the Taliban victory and how the US, a superpower, will digest this humiliation and defeat and what course of action it will take. Let me address the second aspect first. Let us not forget that the US is a superpower and in some ways the only one for the moment. For them, it is very hard to live with the fact that a rustic, village-based community, with a backward economy in every sense, with little training in modern-day warfare, with no airpower, no latest weaponry, no tank, no laser-guided missiles, no night-vision equipment, no drones, no helicopters, and wearing only slippers and their traditional dress and carrying powerful automatic rifles-the only signs of modern weaponry-sent the US and NATO armies packing, invoking the memory of the US' ignominious flight from Saigon 46 years ago. It is very hard to digest this reality, especially for a superpower like the US, that lives with a daily diet of "we are the best" slogan. I mention this first because I anticipate that the immediate post-Taliban period will see efforts by the US and its Western allies to make the Taliban takeover look as bad as possible. They will try to highlight every flaw and shortcoming in the Taliban operation, notwithstanding the fact that so far six days of takeover have passed without much violence or law and order issues, which are inevitable in case of a shifting of power of this magnitude. This they will do-the CIA, starting from the 50s, has 70 years of experience in that-to justify their 20-year presence in Afghanistan. The fundamental weakness of the Afghan society is its ethnic divide which every external power tried to exploit over the centuries. Hopefully, the new Taliban regime will be extremely conscious of that vulnerability and act accordingly. From the US perspective, the 20-years narrative of "caring" for the Afghan people and "helping" them to modernise and build a society of freedom and democracy cannot be allowed to just vanish into the thin air. Otherwise, the whole architecture of the "white man's burden" in its modern-day version loses credibility, especially for its, God forbid, future use.

men led by an Egyptian among them yet, the Bush administration decided to invade and occupy Afghanistan because it refused to hand over Osama Bin Laden to the Americans. US and UK military began bombing the country in October, 2001.

It was more like "how dare the US has been attacked"—that too in its mainland, something that had never happened before, and so someone and the country that supports or shelters them have to pay. The man—Osama Bin Laden—was the self-proclaimed perpetrator and the country, Afghanistan, the shelter-giver to Bin Laden, became the recipient of US' wrath and thus the invasion of a country began. Bin Laden escaped to Pakistan and was later killed by the US forces in 2011.

The quick victory over the Taliban and its removal from power gave the Americans a premature feeling of having prevailed. The Taliban withdrew and returned to fight another day and win.


What the Americans would now find

millions of dollars for doing what the regular army was supposed to do, without any of the motivations and institutional disciplines that military institutions usually are known to have.

The vanishing Afghan army speaks more of the American training than of the Afghan soldiers. How can it be that as soldiers in the army under US training they disappear without any fighting and the same Afghans under the Taliban take on the mighty US and fight like lions for 20 years no less? As the US leaders search for an answer for the debacle, they should focus their attention internally, to their very institutions and investigate the US army itself, how it worked in Afghanistan, what were the role of the private companies, who were paid what and how.

Let none of us lose sight of the enormity of this event. After Vietnam, this is the first time that the Americans have been defeated in the battlefield by a guerrilla force. And unlike the Vietnamese, world. Every country, in whatever stage of development, hates foreign domination. Howsoever it be packaged and whatsoever be the narrative of "helping", "assisting", "caring", etc. the presence of foreign troops generates resentment which develops into hatred and finally into a desire to resist, and if compelled, through force. Each time the US air force flew sorties, each time a drone destroyed a house, each time US troops fired at an Afghan, it became a recruitment event for the Taliban.

To give some credit to the Americans, they seem to have understood this reality some time back, and hence started talking to the Taliban, initiating the Doha talks which reached its highest level in 2019 with US special envoy Zalmay Khalilzad and top Taliban leader Mullah Abdul Ghani Baradar leading their respective sides, reaching an "agreement in principle" when former President Trump, quite inexplicably called off the



Migrant workers forced into quandary over flight home

Why the dire lack of coordination between different organs of the state?

A s if migrant workers are not already suffering enough due to unemployment and underpayment/ non-payment of salaries during the pandemic, those in Malaysia have now been put in the middle of a brand new dilemma—that too by the Civil Aviation Authority of Bangladesh (CAAB) and the Bangladesh High Commission in Kuala Lumpur. CAAB, as reported in this daily, had issued a circular on August 16 stating that "Bangladeshi citizens have to be fully vaccinated against the novel coronavirus 14 days before the travel date for their return home by flights." It also said that those who were not fully vaccinated would need special authorisation from the Bangladesh foreign ministry in order to be allowed to fly back home.

Naturally, this caused migrants in Malaysia to crowd the Bangladesh High Commission offices. However, once there, they were reportedly turned away by officials who claimed that the travellers would not need any special approvals to fly back to Bangladesh. Some officials even said that the CAAB circular had been withdrawn. But when Bangladesh's deputy high commissioner in Malaysia was contacted by *The Daily Star*, he contradicted this claim, saying the circular remains effective, and that there must have been some miscommunication about it.

The deputy high commissioner has since assured us that an announcement would be made clarifying that migrant workers will need to be fully vaccinated before they can travel to Bangladesh. However, we must ask why and how the misinformation—about migrants being allowed to substitute a special approval from the foreign ministry for full vaccination—came to be placed in the CAAB's circular.

Do instances such as these not signal to the neglect with which issues of Bangladeshi migrants abroad are handled by the authorities here? Because of this lack of coordination between the CAAB and Bangladesh High Commission in Kuala Lumpur, our migrants in Malaysia, who have been waiting for months to come home (many of whom have lost their jobs or work permits recently, or just come out of jail) are now facing unnecessary hassles. Some are having to expend money on hotel stays as the process of returning to Bangladesh has been made so complicated.

We would urge the authorities at home and in Malaysia to coordinate with each other before issuing such notices, so that migrants do not get caught in the middle of such confusions. We would also ask them to make it easier for Bangladeshis to return home, perhaps by reverting to the previous process of undergoing PCR tests to detect Covid-19 and obtaining a negative certificate and then quarantining for 14 days once they are in Bangladesh.

The decision to invade Afghanistan was taken by George W Bush following the bombings of New York's Twin Tower and Pentagon by Al-Qaeda. Though there was not a single Afghan in the 19-member squad that led to the 9/11 attacks (in September 2001)—there were 15 Saudi harder to digest, more than the Taliban takeover—as that was being discussed in Doha for the last few years—is the manner of the takeover and collapsing of the edifice—the Afghan army—that the US military built over a 20-year period spending nearly a USD 100 billion to train and equip. No country, leave alone a superpower, can take defeat well. The Americans are especially vulnerable in

these situations. "It can't be their fault", and so a scapegoat will have to be found. Questions are being raised about

who the Americans were training, and what level of efficiency, commitment and loyalty they were generating in these soldiers. Though the Americans are now trying to say that the Afghan national army did not want to fight to defend their country and were not committed, the real story is that the US trainers just did not see the writing on the wall. The government that these soldiers were supposed to defend did not enjoy public confidence, and the leaders for whom they were supposed to lay down their lives were corrupt to the core, many holding foreign passports and having their families living abroad. Nothing could depict the bankruptcy of the government leaders more than its head, President Ashraf Ghani, fleeing the country with a helicopter full of foreign currency-which he later denied. I think this one incident says it all.

It had been frequently reported that at the grassroots level, the ordinary soldiers were ill-paid if at all, not regularly given ration, and most often served under corrupt seniors. Didn't the US trainers know that? If not, then how come? And if yes, then what did they do about it. What was the role of the intelligence bodies? Were the trainers from the US army, or were they outsourced to private mercenary groups like the Blackwater who made who were helped by the Russians and the Chinese, the Afghans did not have such generous patrons.

A rustic army comprising of tribal people got together and defeated the mightiest power in the world over a period of 20 years. The US had everything money, power, literally the whole of the Western world behind it, not to speak of the latest technology, the most

sophisticated communication systems, the extensive network of satellites to monitor the Taliban's every move. With the addition of drones, the Americans, to kill the "enemy", had only to press a button, sitting in an air-conditioned room in any part of the world, most probably in the US, and not having to take the trouble of going to the war-zone. This press a button warfare led to indiscriminate killings of Afghan civilians, including women and children, especially when the rules for air strikes were relaxed.

What Vietnam proved 46 years ago to the US—after fighting there from the late fifties till 1975-Afghanistan proved again in 2021, that with all the sophisticated technology and limitless resources in hand, one cannot suppress the human spirit. It was Afghan nationalism, expressed through faith, that prevailed over unthinking arrogance, disdain for a people's way of life, very low impression of another people's culture and tradition. Not that everything about culture needs to be preserved, nor every aspect of tradition to be eulogised, but whatever change that needs to be brought about-and change must come in tune with the process of modernisation-cannot be done through imposition and foreign occupation. All changes must come from within, through a nation's own experiences and thinking.

The Taliban victory also proves, if proof was at all necessary, how the presence of foreign troops is hated everywhere in the peace talks and cancelled a secret meeting at Camp David with Afghan President Ashraf Ghani. In February 2020, a "Path to Peace" agreement was signed and the first peace talks between the Taliban and Afghan government in 20 years was held in Doha. In April 2021, Biden declared complete troops withdrawal by September 2021.

Well, the world didn't have to wait till then. The US's longest war in recent history ended as the Taliban took control of Kabul without any resistance.

The Taliban victory has tremendous significance for our region. It will definitely have Pakistan and India competing intensely for their attention. Here Pakistan may appear to have an edge, but India's considerable presence in infrastructure building in Afghanistan will not be something that the new rulers will ignore. Pakistan will focus on expeditious return of the three million refugees that have been living in Pakistan ever since the Soviet invasion of 1979 when their 10 year occupation began. India will keep a keen eye on how the Kashmir situation is handled by the Taliban, who have declared that they will not let their territory be used to meddle in other countries' affairs. They have assured the Chinese about their total non-interference about the Uyghurs. The Russians have their concerns about the Chechens, and here also, the Taliban appears to have calmed their nerves. It is too early to predict, but so far the dealings have been matured.

As for Bangladesh, we need to observe the situation carefully and move as it unfolds. About recognising them, we should go slow but definitely not close our mind to doing so, especially if they are able to form an inclusive government, taking in the other ethnic groups that inhabit their land. Their internal and external policies will definitely be a strong guiding factor for our actions in Bangladesh.


The thing to remember is that the external factors behind the Taliban coming to power are different this time around than in 1996, especially the part played by Saudi Arabia and its brand of Wahhabi Islam. In fact, Saudi Arabia itself has undergone changes.

The Taliban appears to have learnt a lot in the last 20 years since they were last in power. They are a far more nationalistic force than they were in 1996, and we should expect them to focus more on their own development than meddling in other people's affairs.

What can we do if inflation is back?



W ^{HY} talk about inflation in the midst of the pandemic, one might ask. The answer is simple, if somewhat unpleasant. Inflation may soon be making

There is no question that while defeating the Covid-19 virus and cutting its hydra-like fangs are of utmost urgency, we might soon see a situation where the world is fighting multiple battles on several fronts. Some of the issues that policymakers are currently grappling with are a surge in the Delta variant or some other variant, a sluggish economic recovery compounded by unemployed and underemployed population, lack of skilled workers in developed countries, and inflationary pressures that might complicate the task of the central banks as they pursue expansionary monetary policy and keep interest rates low. To complicate matters, inflation is emerging as a major concern in both G7 and emerging market and

Fahmida Khatun, Executive Director of CPD, in reviewing the country's monetary policy cautioned that the Bangladesh Bank "will have to be vigilant in maintaining the stability of the financial market in such unusual circumstances to avoid any price bubble," (The Daily Star, August 2). Other economists knowledgeable about the Bangladesh economy, including Zahid Hussain and Ahsan H Mansur, are all unanimous that inflationary pressures unleashed by disruptions in the supply chain and the easy money flowing from the government's stimulus programmes are already evident in the price of food and other essential commodities. According to BSS, the average inflation in the justconcluded fiscal year was 5.56 percent, overshooting the government's target of 5.4 percent. June's inflation of 5.64

percent was the highest in eight months. The spectre of inflation has been

on the minds of central bankers and policy analysts in developed countries for some time, and this is reflected in the public discourse as well as in the print and online media. Inflation is also a constant fear in developing countries. For example, in Bangladesh, the total stimulus packages given during this pandemic by the government so far amount to Tk 128,441 crore (4.59 percent of GDP). Prices of almost all the commodities, including rice, pulses, flour, onion, vegetables, fishes and meat, are on the rise. This can be partially attributed to disruptions in the supply chain due to the pandemic, floods and market manipulation. However, inflationary expectations are rising too. "In addition to these, the increased flow of money into market from the stimulus packages has created fears of further inflation," according to Mansur.

I was recently searching for a topic for my next op-ed for The Daily Star. I started with the Wall Street Journal which has over the years been a reliable source of current news as well as emerging business issues. During the last few weeks, US Congress and the financial markets have consistently expressed their worries about the prospects of inflation. The lead stories and the opinions pages have kept on chirping about inflation. Regardless of the constant denials from the Federal Reserve, the central bank of the USA, one can be sure that just as the US and the global economy appear to be bouncing back from last year's slowdown, the fear of inflation will be a dominant theme.

Inflation phobia is obviously the result of our past experience, and theoretical discussions about the effect of increased money supply on inflation. Inflation-or the rate of change in prices over time-is not a simple phenomenon to measure or interpret. In general, a swiftly growing economy, a tightening job market, and continuing supplychain issues seem a ripe environment for prices to keep on rising.

The prognosis is in sharp contrast to

recent low inflation in most countries. Until 2020, inflation has averaged just above 0.5-1 percent over the past decade, well below the US Federal Reserve's target of 2 percent. Low inflation for such an extended stretch is quite unusual if we consider the post-World War II record. "With the current unemployment rate near historic lows, the persistent soft readings on inflation pose a puzzle and challenge for economists, financial market participants, policymakers, and the general public," according to Dan Sichel

of Wellesley College, USA.

Let us now look ahead. The trillions of dollars of stimulus money that have been pumped into the global economy over the last 18 months are bound to trigger inflation. "Too Much Money Portends High Inflation. The Fed should pay attention to Milton Friedman's wisdom", write economists John

Greenwood and Steve H Hanke. According to Milton Friedman, an economist who won the Nobel Prize, the relationship between money supply and price level is captured by a simple equation, known as the Quantity Theory of Money. Friedman's disciples, known

as monetarists, believe that a higher rate of inflation is coming, and inflation will remain high in the coming years.

For Bangladesh, economists caution the government to remain alert in the face of rising commodity prices, including that of daily essentials, "in the face of already existing excess liquidity which has reportedly reached Tk 2.31 trillion." Experts everywhere are somewhat in double minds about the future inflationary trends, though. Central bankers are not sure and forecasters in some instances stand at

these categories are unchanged. Alberto Cavallo of Harvard Business School found that in 10 of the 16 countries, inflation rates during the pandemic were higher than the official rates.

The IMF suggests seven possible measures to curb inflationary surges. In its report "The Impact of Covid-19 on Inflation: Potential Drivers and Dynamics", the IMF suggests international coordination to secure food and medical supplies, especially for low-income and fragile countries, checks on speculative price hikes and hoarding, and "targeted transfers-like food stamp programmes-to address the needs of the most vulnerable populations at the country level.

It is possible that the rise in prices as lockdowns start to be lifted may be "transitory", as many central bankers are hoping. The government can reduce uncertainty and the extent of pentup demand which fuels inflation by announcing a credible plan to open up the economy to mitigate both deflationary pressures due to lack of demand during the containment and the inflationary pressures due to a rebound in demand during the reopening.

Moreover, to avoid creating inflationary pressures, appropriate monetary and fiscal policy after the end of the pandemic should be datadependent and based on the strength of the rebound in supply and demand. This calls for watchful eyes from the policymakers, economists, and statisticians alike.

Equality also refers to inter-generational equality-the current generation should be sensitive to the needs and opportunities of future generations and, in that context, should be mindful of the use of natural resources and their consequences. With equality, there needs to be equity as well. Equality is an absolute

without social unrest and communal riots, and last but not the least, without terrorism. Today, our world is beset with wars and conflicts, characterised by unrest and human oppressions, and human security all around is threatened by terrorist activities here and there. In order to settle differences of opinions or any other conflict, people often resort to force or weapons. There has been an increasing radicalisation or

environment as that would shrink the opportunities and potential of the future generations and would hurt inter-generational equity. As Homo sapiens, we must realise that we can exist and prosper when we are respectful and sensitive to our environment and nature

Debates provide a critical means for the youth to better equip themselves for meaningfully participating in the creation of a better world. For such meaningful participation, debates prepare young people in five distinct ways:

First, debates provide a broader

viewpoints. In a world bedevilled by wars, conflicts and terrorism, one needs sensitivity, tolerance, and mutual respect to end conflicts and to stop terrorism. Such traits would also breed equality, communal harmony, and stability-all critical elements of a better world.

Fourth, debates give debaters confidence—confidence to speak out, to raise their concerns and to demand and seek solutions. All these are needed for effective participation in the process of changing the world. Furthermore, through debates, a sense of collaboration and cooperation develops among the team members. So the debaters do not go for individual celebration, rather a collective approach to get their desired goal. Such a sense of collaboration and cooperation help young people understand the importance of collective actions, which are needed for changing the world. Finally, changing the world is not a static process, rather a dynamic one. In such a process, priorities change, focus is redefined, strategies are revised. The change-makers must adjust to such shifts. Debating is also a dynamic process, which teaches the debaters to shift grounds as arguments and counterarguments evolve. I think at present, debates can contribute to changing the scenario in at least three specific areas—first, in areas of intolerance and conflict by bringing in reasoning, respect for others, and the desire to settle differences; second, by having deliberations on emerging challenges like environmental degradation, migration, and refugees; and third, helping the issue of mental health because of the Covid-19 pandemic.

The ultimate objective of debate is to create sharpened, logical, and creative minds. Debating provides a platform for having discussions on critical issues facing the world and is thus an important means of creating a better world.

What constitutes a better world? In my view, a world that is equal, stable and sustainable is a better world. An equal world stands for human rights, human dignity, equal rights. A series of corollaries emerge from all these-being sensitive to other human beings, respect for other beliefs and views, tolerance, equal treatment of all citizens, remaining secular, and so on. The notion of an equal world is neither a utopia nor a rhetoric, rather a goal which we all can aspire to achieve. Equality implies the equality of capabilities as well as the equality of opportunities. Equality should be seen on different planes—between men and women, along the rural-urban

concept, whereas equity is a relative or proportional one. For example, everyone should be treated equally before the eyes of the law, but should be treated equitably in terms of taxes, where the tax burden should be proportional to the income of the person concerned.

A better world would mean a stable world—a world without wars and conflicts, without human oppression,

weaponisation of society of late, and reasoning and tolerance have taken a back seat as a result. The world would be stable when we can overcome these obstacles.

A better world would also imply a sustainable world, where there is peaceful and respectful coexistence of humans and nature. The present generation should not degrade the picture by exposing the pros and cons of the topic. As a result, the participants get a holistic view of concerns-a view which is needed for a constructive and balanced change in the world. For a changed world, such a broader vision is much-needed.

Second, since debaters are trained to approach issues in a logical manner, they can identify the priorities of societies in a logical manner. Identification of priorities and setting them in a logical manner is needed for any kind of change. Debates also equip young people to be focused and clear in their thoughts and approaches. Again, without a clear and focused approach, changes cannot be brought in. Furthermore, while making their arguments and counter-arguments, debaters depend on evidence. Their deliberations are fact-based. Evidence is also critical while making a case for a change and without facts, a blueprint for change cannot be formulated. Since they know how to use evidence in an objective manner, debaters can also effectively participate in the process of changing the world.

Third, debates teach people to be more sensitive to others, more respectful of others and more tolerant of opposing

Physical activity, during the pandemic, can provide the immune system the required boost to fight the virus in the event one happens to contract it.

The World Health Organization believes all adults over the age of 18 should at least spend 150 minutes in moderate-intensity physical activity throughout the week. In practical terms, that is just a little over 20 minutes of stretching, a light run, a couple of sets of push-ups, or even yoga every day.

Alternatively, you can choose to spend 75 minutes per week doing high-intensity workouts. That will be 25 minutes of muscle workouts, fast cardio, and bodyweight training spread across three days of the week.

In addition to a boosted immune system, one will experience better mood while stuck at home during lockdowns or while working from home. With the recent trends in Covid-19 cases, it seems as good a time as any to work up a sweat.

was rocky. But data gathered by Nasa's Cassini spacecraft, which orbited the ringed planet for 13 years before intentionally plunging into its atmosphere in 2017, suggests a larger core than previously estimated.

Rather than solid rock, Saturn's core is likely what scientists refer to as "fuzzy," or a slushy mix of ice, rock and metallic fluids.

A study on the findings published Monday in the journal Nature Astronomy.

Oscillations occurring within Saturn's interior cause the planet to move, which creates ripples in the planet's stunning system of rings.

"Saturn is always quaking, but it's subtle," said Christopher Mankovich, lead study author and a postdoctoral scholar research associate in planetary science at the California Institute of Technology, in a statement.

"The planet's surface moves about a meter every one to two hours like a slowly rippling lake. Like a seismograph, the rings pick up the gravity disturbances, and the ring particles start to wiggle around."

The frequency of the gravitational ipples measured in the rings suggest that Saturn's deep interior is stable. When the planet was forming, its interior formed stable layers as heavy materials like rock and ice moved toward the planet's center and lighter materials rose above them.

"This is the first time we've been able to seismically probe the structure of a gas giant planet, and the results were pretty surprising," said Jim Fuller, study coauthor and assistant professor of theoretical astrophysics at Caltech, in a statement.

The mosquito-borne viral infection and Covid-19 present similar symptoms such as fever, headache and body ache, which makes diagnosis hard.

And most hospital beds, including those at the Intensive Care Units (ICUs), are occupied by Covid-19 patients, making it difficult for dengue patients to get hospital admissions, said experts.

Saifur went on to term the existing system for eradicating Aedes mosquitoes outdated.

Fogging, which is the government's preferred mode of controlling the Aedes mosquito population, is not good at nipping the nuisance in the bud, according to the entomologist, who did his PhD on medical entomology in Malaysia.

"It [fogging] is the last resort," he said, adding that the Insect Growth Regulators (IGRs) were very useful insecticides against mosquitoes.

The IGRs are insecticides that mimic hormones in young insects and can prevent reproduction, egghatching and moulting from one stage to the next.

"If we can use this kind of insecticides, we need not worry about the Aedes mosquito breeding like we are doing now."

Saifur underscored the need for an integrated vector management unit, which is yet to be formed by the government.

Besides, he lamented that the two Dhaka city corporations lack entomologists, whose presence is crucial for monitoring the Aedes mosquitoes and advising antimosquito operations round the year. The Dhaka North City Corporation (DNCC) has two entomologists, but

the Dhaka South City Corporation (DSCC) does not have a single one.

The entomologist's post in the DSCC has remained vacant since last year, said an official of its health department, preferring not to be named.

"Serosurveillance is very important to know about the type of virus so that the authorities can take necessary measures accordingly," said Manzur Chowdhury, entomologist and former president of the Zoological Society of Bangladesh.

Serosurveillance is a globally used and trusted standard that measures the levels of antibodies against a certain infection and decodes the percentage of the population previously exposed to the virus. It is typically used as an extensive tool to

The Institute of Epidemiology Disease Control and Research (IEDCR) has conducted serosurveillance in July and found serotype-3 active in Bangladesh this year like in 2019, when the country suffered its worstever dengue outbreak with more than one lakh dengue cases and 179 deaths.

The serotype-3 is the most dangerous variant among the four dengue serotypes, he said, adding that the IEDCR could have done it much earlier.

The two city corporations, however, beg to differ.

Contacted, Brig Gen Md Zobaidur Rahman, the chief health officer of DNCC, said they have increased the manpower and equipment to combat dengue after 2019.

An additional 540 workers were recruited after 2019 to take the workforce to about 1,000.

Apart from the anti-mosquito drive, the DNCC is working to build awareness among people since the beginning of the dengue season this year, Zobaidur said.

The insecticide DNCC is using is 100 percent effective in killing mosquitoes, he said, adding that they have tested it in three laboratories before using it.

"We examine every bit of the chemical to check its effectiveness."

Apart from having two permanent entomologists, the DNCC also has an

advisory panel of entomologists. The city corporation is fogging and larviciding at the dengue infected patients' houses and their surrounding areas since May. Zobaidur, however, said there

is a difference between theory and practice.

"Many things can be said theoretically but practically it is very difficult," he added.

The DSCC has also doubled its workforce and logistics accordingly.

"We have increased the workforce from five to almost 14 in each ward to conduct larviciding and adulticiding since 2019," said Abu Nasher, spokesperson for the DSCC.

Abu, however, said that they were facing difficulties in locating the patients' addresses provided by the DGHS.

"As many as 40 percent of the addresses of dengue patients that we received from the DGHS were wrong and now we are trying to collect those directly from the hospitals," he said.

Quizzed about the incorrect addresses, ABM Khurshid Alam, the director-general of the DGHS, said they provided the information to the city corporations after getting it from hospitals.

He said they would be more thorough going forward.

The wicket-keeper batsman duo -- Mushfiqur Rahim and Liton Das returned as predicted, while young legspinner Aminul Islam made the cut as well. The three aforementioned players had to miss out on Bangladesh's recently-completed historic 4-1 series win against Australia for having opted to exit the bio-bubble for personal reasons, following the Zimbabwe tour.

The only player dropped from the previous T20 squad is Mohammad Mithun, who was one of the players from the Tigers' ODI squad for the Zimbabwe tour that the BCB had asked to stay back for the T20Is against the Aussies in order to fill in for the missing players.

The inclusion of technically gifted,

experienced right-handed batsmen like Mushfiqur and Liton is most likely to strengthen the batting line-up, given that the top-order, especially the openers Soumya Sarker and Naim Sheikh, were found wanting against the Aussies and that the batting order is lop-sided by left-handers as well.

As far as Aminul is concerned, having a diverse option of a leggy in the bowling unit could prove to be a vital component behind Bangladesh's success in the upcoming ICC T20 World Cup later this year.

Cup in the UAE and Oman in October-November this year?

The truth is that even if the likes of Kane Williamson, Trent Boult, Kyle Jamieson and Lockie Ferguson toured, Bangladesh would still be the favourites for the upcoming series if they decided to opt for yet another slow, low and gripping Mirpur pitch similar to the surfaces during a historic first-ever bilateral series triumph against the Aussies earlier this month.

Winning ought to boost confidence, but at times winning in favourable conditions only can severely add to a false sense of achievement. That can be far more detrimental to a team than a few losses in challenging conditions, and help them prepare for what is which could actually help a team

The trend for Bangladesh over the past five years goes to show just how a false sense of achievement has

impacted the Tigers' performance. In that period, Bangladesh won 25 of the 40 games played across formats at the Sher-e-Bangla National Stadium in Mirpur, which typically behaved more or less the way it did during the recent tour of Australia. A winning rate of 62.5 per cent should have seen Bangladesh make massive strides in the game, at least going by the logic that counts winning as the only measure of success.

However, while Bangladesh kept bolstering their confidence in Mirpur, the Tigers saw the other side of the coin when playing overseas over the same period, losing 48 of 67 games played across formats

with a winning rate of just 23.88 per cent.

After hammering Australia 4-1 in their last T20I series, Bangladesh are now in high spirits and looking to put up another dominant showing against the Kiwis in the coming month.

But if the team management decides to employ the same tactic against the Kiwis as they did against Australia, it would probably only serve to improve their winning rate on a favourable Mirpur pitch. That would also mean that the quality of cricket during the New Zealand series will also be far from what is required for an ideal preparation ahead of an event as big as a T20 World Cup.

It is true that teams need to utilise home conditions to make the most of them. And like every other home series, the Bangladesh team management must opt to use the home conditions to assist their

cause this time around as well. Only this time, the difference should be that they prepare a true cricketing wicket that will genuinely challenge the Tigers' abilities.

That may see them lose a few T20Is, but will certainly help the players recognise their shortcomings and rectify them before the T20I World Cup, which, in fact, is the true purpose of this series.

Mirpur yesterday.

Saif Sporting Club notched up a 3-1 win over Uttar Baridhara Club, courtesv of a brace from Nigerian John Okoli, in the Bangladesh Premier League (BPL) at the Bangabandhu National Stadium yesterday.

The day's other match witnessed a stoppage-time strike from Mohammad Jewel which guided Bangladesh Police to a single-goal win over Arambagh KS, who have been relegated already, at the Birshreshtha Shaheed Mostafa Kamal Stadium in Kamalapur.

However, both winning sides staved in their previous positions of the 13-team table of BPL, with Saif SC in the sixth position with 38 points from 21 matches while eighth-placed Police raised their tally to 25 points from 22 outings.

Bashundhara Kings roped in Brazil's Robson Da Silva, popularly known as Robinho, on loan from top-tier Fluminense FC, the Bangladesh Premier League champions had his marauding runs down the left flank in mind and hopes their Argentine talisman Hernan Barcos could capitalise on Robson's flawless crosses and decisive passes in the AFC Cup.

However, Barcos left Bashundhara Kings after the expiration of his contract, having played only one match in the abandoned 2020 AFC Cup. He made an undeniable statement in that game, the former Argentine international netting four times in an overwhelming 5-1 win over TC Sports Club in Dhaka.

And while Robson was denied the opportunity to pair up with Barcos in the AFC Cup or domestic competitions, he found a partner in another Argentine, Raul Becerra, and has become the most lethal striker in the league with 19 goals from 20 matches.



The 26-year-old also effectively translated his rich scoring form to the AFC Cup to give Bashundhara Kings a winning start and prove that he was as important as Barcos had proved in the 2020 campaign.

Robson also has a splendid ability with the ball at his feet and he has easily danced past three or four players many times in domestic matches before finding the back of the opponent net or feeding the ball to others. He is undeniably dangerous in the opposition's box, but the top-left

corner of the box seems to be his favourite striking position, as a number of his 19 goals came from that spot during league matches.

So when the Brazilian received the ball in his favourite position in the 10th minute against Maziya S&RC in an AFC Cup match on Wednesday, the Kings held their breath in anticipation. But frustratingly, Robson drove straight into the hands of the Maziya goalkeeper at the near post as he attempted his trademark curler into the top right corner.

Robson grew into the game and began to penetrate, but it was not until the 39th minute that he truly made amends, striking a stunning goal from a bullet-like drive that blazed in at the near post with the goalkeeper motionless.

Despite being the hero of the match, Robson was polite in giving credit to his teammates and management.

"Since I've been with Bashundhara, my confidence has increased. I feel the support of the staff and my teammates as well as the management. I know I need to be one of the players pushing and making plays that make the difference," Robson was quoted as saying on the Asian Football Confederation website after the match.

"The main thing compared to our league was the intensity. It was a high-intensity game. I want to praise the team. All of them were very confident with the plan as we analysed them in detail and we knew that if we stuck to the plan, we would get some points."

Indies aim to seal series

Less than five days after playing one of the most memorable Test matches in recent history, West Indies and

Pakistan will once again take the field on Friday in the second and final game of the series.

West Indies scraped through by the barest of margins to register a thrilling one-wicket win against Pakistan in the first Test of the series as the hosts registered full 12 points on the ICC World Test Championship 2021-23 table.

Since the second Test too will be played at Sabina Park in Jamaica, both teams could opt to go with an all-pace bowling lineup after the spinners went wicketless in the first game.

West Indies captain Kraigg Brathwaite could look to off-spinner Roston Chase to provide some variety and bring in another fast bowler, perhaps Alzarri Joseph, to complete the pace quartet. Pakistan too might ring in a couple of changes if they too want to go with the all-pacers strategy, which would mean Yasir Shah sitting the second match out.

The bowlers might have hogged most of the limelight in the first Test, but it also highlighted how important it is for batters to grind it out in difficult conditions, especially in low-scoring encounters such as these. While several batters on both sides got off to starts, they could not convert it into big scores.

Inter's turbulent summer leaves Serie A crown up for grabs

Inter Milan kick off the new Serie A season on Saturday in the midst of fan protests and money troubles that threaten to derail their title defence before it has even begun.

A dramatic summer for the champions reached its lowest ebb last week when star striker Romelu Lukaku was sold to Chelsea, a transfer that enraged not just supporters but reportedly also CEO Giuseppe Marotta and new coach Simone Inzaghi.

The Gazzetta dello Sport reported that Inter's cash-strapped Chinese owners Suning forced the sale of Belgium forward Lukaku after having already offloaded buccaneering right-back Achraf Hakimi, a key figure in their first Serie A triumph





since 2010, to Paris Saint-Germain.

The club's financial problems were clear well before the league crown was claimed, and last month previous coach Antonio Conte left Inter knowing his team could be dismantled. They are still strong in key areas and have one of Italy's Euro 2020 heroes in Nicolo Barella, but the squad has certainly been downgraded.

Lukaku has been replaced with Edin Dzeko, a capable forward familiar with Serie A, but the Bosnia striker is 35 years old and scored just seven league goals last season. Dutch defender Denzel Dumfries however is an intriguing choice for the vacant spot at right-back after his exciting displays at Euro 2020. How he and Dzeko fare will be key to Inzaghi's chances at Inter

after doing an excellent job on a small budget at Lazio.

Ready to pounce will be Juventus, who have Massimiliano Allegri back at the controls and added Euro star Manuel Locatelli to a midfield which was the Old Lady's weak point under Andrea Pirlo last season. Rumours of Cristiano Ronaldo's desire to leave Juve have not dampened enthusiasm around the team's chances as the chaos that has enveloped Inter and Allegri's return have boosted hopes in Turin of reclaiming the title from their old enemies

Also sniffing to overtake Inter is a new cast of managers led by Jose Mourinho at Roma, who on Tuesday celebrated the arrival of Tammy Abraham from Chelsea

Mourinho was welcomed back to Italy this summer, memories of treble glory at Inter over a decade ago leaving Roma fans hoping the once Special One's star has not definitively waned.

Elsewhere Maurizio Sarri will try to bring his brand of passing football to Lazio while Luciano Spalletti has a chance to get a talent-packed Napoli back in the top four on his return to club management after two years away.

DHAKA-MAWA-BHANGA EXPRESSWAY Korean firm to be tasked with toll collection

The government is set to give Korean Expressway Corporation the responsibility to collect toll from vehicles on the Dhaka-Mawa-Bhanga expressway.

The South Korean company has already been assigned to collect toll on the Padma Bridge.

Apart from toll collection, the company would be appointed to operate an intelligent transport system (ITS) and the operation and maintenance of the country's first ever expressway.

Cabinet Committee on Economic Affairs (CCEA) yesterday gave approval in principle to a proposal in this regard.

No date was fixed to start toll collection on the 55km expressway. However, it may start when the Padma Bridge is open to public next year, officials said.

Finance Minister AHM Mustafa Kamal, who presided over the virtual meeting, briefed reporters about the development.

The company, which will use an automatic toll collection system, will give a detailed proposal, including the financial aspects, for approval by the Cabinet Committee on Government Purchase (CCGP).

The Road Transport and Highways Division has set a toll rate for the expressway but the rate for the Padma Bridge has not yet been finalised. The CCEA in August last year approved a proposal to appoint KEC for maintenance and toll collection once construction of the Padma Bridge is complete.



Yahya discusses trial of Bangabandhu

TRIAL OF BANGABANDHU In a telegram sent today to the US Department of State, Joseph Farland, the US ambassador to Pakistan, provided an interesting detail of his discussion with Pakistan President Yahya Khan about the trial of Bangabandhu Sheikh Mujibur Rahman.

The one-on-one meeting took place on August 19, 1971. Farland told Yahya that as a friend, he felt strongly the military tribunal had been advised that the trial must be conducted with the greatest care, without bias or prejudgment, and that the record must be in full substantiation of whatever verdict was reached.

Yahya further stated that because the charge carried the possibility of a death sentence, it was his plan that if such the verdict be, a request for mercy would be made on Bangabandhu's behalf,
