DMCH Relatives of patient sedated and robbed

Three relatives of a patient were sedated and robbed at Dhaka Medical College Hospital on Saturday night

The victims -- Jahura Khatun (60), her son-in-law Ameer Hossain (35), and granddaughter Sumona Akter (20) -- are receiving treatment at the hospital.

A middle-aged woman, identifying herself as the patient's attendant, started talking to the victims as they were sitting on a mat in the corridor of the Gynecology ward around 10pm, said one of the victims, Ameer.

The three were accompanying a patient from Brahmanbaria, Sumi Akter, who was admitted to the DMCH with gynecological complexities.

"At one stage of our conversation, the woman offered us juice. What we can recall is we drank the juice," Ameer said. SEE PAGE 4 COL 3

44 oxygen cylinders go missing from Barishal hospital Our Correspondent, Barishal

Forty-four oxygen cylinders have gone missing from Barishal Sher-e Bangla Medical College and Hospital's (SBMCH) Covid unit.

The unit was already struggling to cope with oxygen cylinders, as highlighted by a report of The Daily Star published on August 3. With these 44 lost cylinders, hospital authorities are concerned about the unit's functioning until they are found or restocked.

The incident came to light when hospital authorities started to record the number of cylinders at the Covid unit

According to hospital sources, the authorities found the oxygen cylinders missing after store officer Anamika Bhattacharya made a list of oxygen cylinders and flow metre and submitted it.

Following this, ward master Mashiur Alam was transferred instantly, hospital Director Dr SM Saiful Islam

informed this correspondent. The director said an investigation has been launched to

find out the reason behind the incident. "We are worried that the number of missing oxygen cylinders may increase. A three-member probe committee has been formed with the hospital's deputy director Abdur Razzak as chief," he said.

The committee will submit their report by this week and the details will be made public, he said.

According to hospital sources, a total of 612 oxygen cylinders and the same number of oxygen flow metres were supposed to be at the hospital.

OPERATION KILO FLIGHT

A story of valour

Pilots who conducted air strikes during Liberation War recount memories of missions

It was December 3, 1971. An aircraft took off from an abandoned Second World War era airfield in Kailashahar, Manipur of India. Its mission was to bomb Eastern Oil Refinery in Chattogram's Patenga.

On the same day, a helicopter took off from Teliamura of Agartala to bomb the oil depot at Narayanganj's Godnail.

This was the first bombing raid of brave Bangladeshi pilots. They aimed to cripple Pakistan army's fuel supply, as all vehicles and vessels of Pakistan occupation forces were dependent on the fuel depots.

This daring mission was codenamed "Operation Kilo Flight".

The operation had significantly

turned the tide of Bangladesh's Liberation War, as it totally decimated Pakistan army's oil supply and made it impossible for them to continue a prolonged war.

On Saturday, three of the brave pilots who participated in the mission -- Group Captain (retd) Shamsul Alam, Bir Uttam, Squadron Leader (retd) Badrul Alam, Bir Uttam, and Captain Shahabuddin Ahmed, Bir Uttam -recounted the momentous mission at a webinar titled "Kilo Flight: Air Raid by the Freedom Fighters".

The heroes remembered how they improvised the old, ramshackle flying machines for the raid.

A total of 58 freedom fighters contributed to this courageous air raid. And throughout the war, they conducted at least 50 such air raids on Pakistani forces and their supply depots.

According to Shamsul Alam, the Canadian-built otter aircraft, which was actually a civilian aeroplane, was fitted with rocket pods that could fire 14 rockets one by one. The door of the aircraft was removed and a machine gun was placed there.

The main body of the aircraft was modified to be a bomb bay, which could carry 10 bombs. However, as it was not a bomber plane, the bombs could not be dropped automatically; they had to be thrown by hand.

"It was kind of a suicidal mission for us. Maximum speed of the aircraft was only 80 miles per hour. We had to fly at a very low altitude along the coastline. Pakistani gun boats fitted with anti-aircraft guns used to patrol the coastline frequently.

needed. Saifuzzaman emphasised the importance of having a representative of the divisional commissioner concerned with the representative of the ministry during the surprise visits to land offices. Besides, a request letter will be sent to the cabinet division to give the responsibility of inspecting field-level survey offices to the deputy commissioner (collector) and divisional commissioners, he said.

The Roads and Highways Department (RHD) yesterday signed contracts with two companies for upgrading a part of the 190-kilometre Elenga-Rangpur highway to four lanes and an interchange, aiming to improve road communication between the capital and northern districts

Under the contract, Abdul Monem Ltd will upgrade 13.6km of the highway (package-5), from Alenga to the east side of Bangabandhu Bridge, in the next three years at a cost of Tk 601.11 crore.

China Railway Construction Bridge Engineering Bureau Group Co Ltd will develop Hatikamrul, a major transport hub, into a modified cloverleaf interchange (package-13) at a cost of Tk 743.28 crore. Under the contracts, both companies

On Saturday, Metropolitan Magistrate Md Ashek Imam sent her to Women's Jail in Gazipur after Criminal Investigation Department Inspector Kazi Golam Mostafa, who is also the case's investigation officer, produced her on completion of her one-day remand.

The IO appealed to the court to confine her to jail until the investigation is complete.

She was previously placed on a six-day remand in two phases for the same case.

The accused, now behind bars, pleaded not guilty and demanded justice after Dhaka's Additional Chief Metropolitan Magistrate Md Hasibul Haque read out the charges to them, court sources said.

The magistrate also fixed October 13 for starting the trial


