## Families go broke at pvt hospitals

Crisis of ICU beds at public hospitals drives the poor, middle class to despair

When Covid patient Rokeya Sultana was fighting for her life in the ICU of a private hospital last week, her son Mamunur Rashid was found frantically talking over the phone with someone trying to convince that person to buy a piece of land from him.

Approached by The Daily Star, he said his mother, 50, had been in the ICU for four days and doctors could not tell him how long she would have to stay there. The family had brought Tk 1.2 lakh for her treatment and all the money was already gone.

"Half the amount was borrowed from our relatives. Now we're selling two decimals of our courtyard for Tk 1.5 lakh, which is much lower than the market price. We need more money. We are even ready to sell our home," Mamunur said, adding that treatment at the private hospital was extremely expensive

Mamunur and all his brothers are day labourers. Their elderly father is bedridden. Selling the little they have seemed the only way for them to get some cash.

Rokeya, however, died on August 20.

The impoverished family of Rokeya Sultana, 50, had to spend over Tk 4 lakh in treatment cost, which included a hefty bill of Tk 3.20 lakh for her six-day stay in a private hospital in the capital.

Talking to The Daily Star yesterday, Mamunur said after her mother was diagnosed with Covid-19, they took her to a local upazila health complex in Cumilla. She then started complaining of breathing difficulties and was rushed to Cumilla Medical College Hospital.

But finding no bed over there, her family admitted her to a private hospital in Cumilla. She was brought to Dhaka when

## Shut down Savar tannery estate JS body recommends as the industrial zone

lacks adequate waste treatment facilities

A parliamentary body vesterday recommended shutting down the Savar Tannery Industrial Estate in Hemayetpur because the estate treat all liquid waste generated by the tanners it houses.

The parliamentary standing

committee on the Ministry of Environment, Forest and Climate Change made the recommendations at a meeting at the Jatiya Sangsad Bhaban.

"The Tannery Industrial Estate has the capacity to treat around 25,000 cubic metres of liquid waste every day, but the tanners generate around 40,000 cubic metres of liquid waste per day. That means 15,000 cubic metres are dumped into the [Dhaleshwari] river without any treatment, causing severe pollution," Saber Hossain Chowdhury, chief of the parliamentary watchdog, told reporters.

In 2003, the government had taken the initiative to build the Bangladesh Small and Cottage Industry Corporation (BSCIC) Tannery Industrial Estate on 200 acres at Hemayetpur after moving all tanneries from the capital's Hazaribagh in order to prevent environmental pollution and to

### No extension to deadline

Warn Taliban, say no new govt until last US soldier leaves the country

The Taliban said yesterday they would not extend the August 31 deadline for Nato forces to leave Afghanistan, jeopardising hopes of extending the evacuation of thousands of foreign nationals and vulnerable Afghans.

US President Joe Biden said on Sunday night he would consider extending the deadline for all American troops to leave the country amid growing pressure from allies including Britain.

However, the Taliban said no western government or leader had approached them to request an extension and that they would not agree

"If the US or UK were to seek additional time to continue evacuations -the answer is no. Or there would be consequences,'

## It's possible to walk across the Padma now

All 2,917 road slabs in place on Padma bridge

The Padma bridge project yesterday moved one step closer to completion after the authority finished the installation of all road slabs linking both sides of the Padma river through the roadway.

Now it is possible to cross the Padma river by walking across the 6.15 kilometre-long bridge.

The last road slab was installed on the span that linked the pillars 12 and 13 of the Padma bridge at 10:12 am yesterday, said project engineers.

The installation of road and rail slabs began more than two years and five months ago. In June, the rail

slabs were laid and now all 2,917 road slabs are done. "We have reached a new milestone. With this, we have moved one more step forward," Project Director Shafiqul Islam told journalists at the project service area

The long-cherished bridge, whose physical works started in November 2014, is expected to be open for

the public in June next year. Once in service, the double-decker bridge, which has a roadway on the upper side and rail line on the bottom, will connect the capital with 21 southwestern districts and is expected to boost Bangladesh's gross domestic product by 1.2 percent.

## 'Liaqat shot him at Pradeep's directive'

Sinha's sister testifies in court

Major (retd) Sinha Rashed Khan was shot dead by now suspended police inspector Liaqat Ali as per instructions from Pradeep Kumar Das, former officer-in-charge of Teknaf Police Station, said the victim's elder sister.

"I filed a murder case with a court on August 5, 2020, five days after the incident, after talking to eye witnesses and collecting information from them.

Sinha's elder sister, Sharmin Shahriar Ferdous, made the statement while placing her deposition before the Cox's Bazar District and Sessions Judge's Court yesterday.

Judge Md Ismail Hossain yesterday started recording the depositions of witnesses in the Sinha murder case. As the plaintiff, Sharmin was the

first to place her deposition. The recording of her statement

began around 9:45am and continued till around 1:00pm, said the court's Public Prosecutor Advocate Faridul Alam. There are 83 witnesses in this case.

The court summoned 15 of them to place their depositions in the first phase between August 23 and August 25.

recorded only Sharmin's deposition yesterday, said Faridul Alam. Two other witnesses, Md Abdul Hamid and Mohammad Yunus,

who are residents of Teknaf upazila's Shamlapur area, yesterday appeared before the court, which decided to record their statements today.

Earlier, the dates for recording witness statements were fixed for July 26, 27 and 28. But it was not possible as they followed High Court directives given due to the lockdown, said Faridul Alam.

On June 27, the court framed charges against 15 accused.

Of them, 12 are policemen, including suspended OC Pradeep Kumar Das, police inspector Liaqat Ali, sub-inspector Md Shahjahan and assistant sub-inspector Liton

The others accused are suspended police sub-inspector Nandadulal Rakshit, and suspended constables Sagar Deb, Kamal Hossain, Abdullah Al Mamun, Safanur Karim, Rubel Sharma, Md Abdullah and Md Rajib.

The remaining three accused are Nurul Amin, Nezam Uddin and Ayaz Uddin - close aides of the accused policemen.

All the accused are now in jail.

On December 13, the investigators submitted the charge sheet of the case against the 15, about five months after Sinha was killed in police firing at a check post in Cox's Bazar's Teknaf upazila on July 31 last year.

## Top bureaucrats disagree

The development came hours after the local administration, the BCC and leaders of the Awami League at a meeting decided to settle the dispute.

At least 50 people were injured on August 18 in a clash between BCC staffers -- reportedly followers of the BCC mayor and members of local AL units --, and police and Ansar members over removal of banners from UNO's office in Barishal Sadar.

Later, Upazila Nirbahi Officer Munibur Rahman and police filed two cases over the incident, naming BCC Mayor Serniabat Sadiq Abdullah as the prime accused for instigating the violence. Local AL men were also accused in the cases.

On the other hand, two cases were filed against the UNO -- one by Barishal city AL member and Councillor Rafigul Islam Khokon and the other by BCC Revenue Officer Babul Haldar.

The association also said it thinks the incident took place at the behest of the

Asked, Anwarul said, "I don't know what had actually happened. We've asked the mayor, [divisional] commissioner and law enforcement

agencies to sit and find out the reason behind it. Why would such an embarrassing incident take place?

"They've sought time to sort it out... "We're observing the situation closely... In most cases, we find that such untoward incidents occur due to miscommunication.

The Cabinet Division and the LGRD ministry have already instructed the administration, law enforcement agencies and public representatives in Barishal to stay in touch regularly," added the cabinet secretary.

On Sunday night, top officials of Barisal Division administration, the BCC and AL leaders held a meeting and decided to settle the dispute.

Talkingto our Barishal correspondent, Divisional Commissioner Saiful Islam Badol said, "The problem has been resolved in a befitting manner."

In a press release yesterday, the BCC said the unfortunate incident took place due to misunderstanding between the BCC cleaning staffers and

The misunderstanding has been resolved, and the city administration and the district administration will

work unitedly, it mentioned. Contacted, Barishal City AL President AKM Jahangir said the cases would be withdrawn and a settlement over the issue would be reached soon.

## Vaccinate industrial workers

"A special discussion was held over the industrial workers today [in the meeting].... Since Bangladesh would get six crore doses of vaccine from Sinopharm as per an agreement signed by the health ministry, the prime minister gave the instruction to vaccinate the workers quickly bringing them under a separate programme," said the cabinet secretary.

Besides, Hasina said she would herself oversee the matter.

"The prime minister has given instructions to vaccinate not only the workers but also their family members as forerunners," said Anwarul.

Meanwhile, Health Minister Zahid Malegue said there would be no more special campaign for mass Covid-19 vaccination due to the shortage of

Besides, there will be no onthe-spot registration facility to take Covid-19 vaccines.

"No one will get vaccines without registration," the minister said while talking to journalists at the secretariat

He said, "More than three and a half crore people have registered and [of them] more than two crore have been vaccinated. Registration will be based on the amount of vaccine available.

On August 15, the health minister said the government was not able to carry out the special vaccination campaign due to shortage of Covid-19 vaccine shots.

From August 6-11, the government carried out a special vaccination campaign countrywide under which around 34 people were inoculated through on-the-spot registration.



her condition deteriorated further.

"We took her to Dhaka Medical College Hospital, Shaheed Suhrawardy Medical College, Mugda Medical College Hospital and DNCC hospital, but could not find a vacant bed at those hospitals," Mamunur said, adding that they had to pay around Tk 30,000 in ambulance fare for carrying her from Cumilla and looking for beds in different hospitals.

"We eventually got a bed at the DNCC hospital, but we were already financially devastated."

Like Rokeya's, many poor and middle class families of Covid-19 patients are going broke and bankrupt as such patients are forced to take treatment at private hospitals due to the unavailability of beds in the subsidised government hospitals.

These correspondents visited five prominent private hospitals in Dhaka and talked to over a dozen family members of Covid patients. Most of them said they sold their last belongings and fell into a debt trap to fund the treatment.

The family of Monowara Begum, a woman in her 60s, is another family with a similar tale.

Monowara was admitted to the ICU of a private hospital in Mirpur on July 28. She was put on life support a few days later.

She died on August 20. Her family had to spend around Tk 50,000 every day when she was on life

is hardly anyone of their relatives from whom they did not take loans.

Her husband, Jahangir Alam, said, "We completely depended on our only son's income. He is a graphics designer and earns around Tk 25,000 per month. We had to sell all our ancestral land in our village for the treatment.'

An acute shortage of space is also widespread in the private hospitals, which has exacerbated the situation for patients with financial limitations.

Sania Akhter, 23, mother of a five year old son, desperately needed a Covid bed with uninterrupted oxygen supply at the rate of eight litres per minute. However, the woman from Savar could not get any bed in public hospitals. When she was turned away by all

the hospitals, I thought my sister would die in the ambulance. At that time, the ambulance driver took us to an underconstruction hospital in Shyamoli, which had just installed some IĆU beds but did not open its general wards yet," said her brother, a day labourer.

"Since then, I had to pay for all the ICU services. Seeing my helpless situation, the hospital authorities were kind enough to give us a discount of Tk 50,000," said her brother Mohammad Ibrahim.

Nevertheless, he had to pay Tk 2 lakh for her treatment.

"I am happy that we got our sister back. But I am now totally entangled in debt as I had to borrow money with 50,000 every day when she was on life support. They spent the last of their last of their life repay these loans," he said.

The average daily cost is Tk 37,128 for a general bed and Tk 68,885 for an ICU bed in private hospitals, the report

Mainul Ahasan, secretary general, Bangladesh Private Clinics and Diagnostic Owners' Association, said, 'Covid treatment is expensive. We can't give patients much discounts as Covid units have high operating costs." Moreover, the number of non-Covid

patient has reduced drastically. Because of the pandemic, people don't come to hospitals and diagnostic centres unless is an emergency," he said.

'If we give too many discounts to Covid patients, we won't be able to run our facilities.'

Md Nurul Amin, deputy director (deputy secretary) of HEU who led the study, said, "The cost of treating coronavirus patients is comparatively high all over the world due to the high cost of medicines, elevated expenditure relating to manpower and facility maintenance. But that does not mean that these hospitals will be off limits to patients with financial challenges.'

He said that the government can financially assist these people or pay for their treatment if they have to be hospitalised in private clinics.

## Lowest single-day Covid deaths reported in 55 days

Bangladesh logged 117 more Covidrelated deaths in 24 hours till yesterday morning, the lowest in 55 days.

The country last saw 115 coronavirus-related deaths on June 30 and the upward curve of the fatalities reached its peak on August 5 and 10 with 264 deaths.

Besides, 5,717 more people came out positive for the virus after 26,789 samples were tested during the 24-hour period, according to the Directorate General of Health Services. The fresh number pushed the

country's total fatalities to 25,399 while the cases reached 1,467,715. Meanwhile, the daily case positivity

rate rose to 15.54 percent from Sunday's 15.16 percent, said the The recovery rate rose to 93.54 percent, but the case fatality rate

remained unchanged at 1.73 percent compared to the same period. Among the new deaths, 40 died in Dhaka division, 29 in Chattogram, 13 in Sylhet, 11 in Khulna, 10 in Rajshahi,

nine in Rangpur, four in Mymensingh and one in Barishal divisions. Of them, 53 were men and 64

## 5 sent to jail for gang-rape of woman

A Dinajpur court sent five men to jail in a case filed for gang raping a woman after tying her husband to a tree in the district's Bashbaria village on Friday night.

Quoting the couple, police said the victims left their home in Dinajpur's Birampur upazila the same night for their relatives' home in nearby Nawabganj upazila for an emergency reason. As a battery-run three-wheeler carrying them reached Bashbaria village around 9:30pm, the five

accused ambushed them. The accused beat up the driver, tied up the husband to a tree and forcefully took the woman, 30, to a nearby jungle, where they raped her,

said police. The attackers left around 1:00am

on Saturday. Later, the woman managed to call 999 and a team from Birampur Police Station rescued the couple.

The victims were sent to Birampur Upazila Health Complex.

Based on the woman's statement, police later raided different places of the upazila and arrested the accused, said Suman Kumar Mohanta, officer-

in-charge of the police station. The woman filed a case with the police station against the arrestees, he

On Saturday, the accused were produced before a Dinajpur court,

which sent them to jail. The victim underwent medical examination at M Abdur Rahim Medical College Hospital in Dinajpur,

said police. The arrestees are: Sirajul Islam, 35, of Kanikathal village, Abdul Latif, 36, of Bagharpara village, Shuvo Mia, 20, Abu Raihan, 40, and Moinul Islam, 20, of Babaritola village of Dinajpur,

### Two teens die in Banani fire

Two teenagers died and a woman was injured after a fire originated at a residential building in Dhaka's Banani area early yesterday.

The deceased were identified as Mim (16) and Swapna (14). Both used to work as house helps at a duplex flat -- on the fourth and fifth floors -- of a 10-storey building on Road 3 (Block-F) in Banani.

The fire originated around 1:40am on the fourth floor and four firefighting units doused it around 2:40am, said Rasel Sikder, duty officer of Fire Service and Civil Defence Headquarters.

The bodies were recovered from the fourth floor's bathroom, fire officials said.

The owners were on the fifth floor at the time, they added.

Fire officials rescued the three and rushed them to a nearby hospital where doctors declared Mim and Swapna dead, said Rasel.

Injured Rinta (30), who is a relative of the flat owner, took treatment at the hospital.

The cause behind the fire that damaged the living room, kitchen, and furniture of the flat could not be ascertained immediately, said the fire officer.

Amid the rise in dengue cases, the Directorate General of the Health Services (DGHS) yesterday announced six hospitals in Dhaka dedicated to treating the dengue

A notification signed by Dr Mizanur Rahman, DGHS director of Management Information System (MIS), was issued in this regard.

The hospitals are: Sir Salimullah Medical College Hospital, Shaheed Ahsan Ullah Master General Hospital in Tongi; Railway General Hospital at Kamalapur, 20-bed Aminbazar Govt Hospital, Lalkuthi Hospital in Mirpur, and 31-bed Kamrangirchar Hospital.

Meanwhile, one more dengue patient died while at least 276 more dengue patients were hospitalised in the last 24 hours till 8am yesterday. Among the 276 new cases, only 33 are from outside Dhaka.

According to DGHS, dengue fever has claimed 37 lives so far. Of them, 12 people died in July and 25 in August

With the new cases, a total of 5,659 persons were diagnosed during the running month out of the total 8,317 infected. Of them, 511 are from outside Dhaka.

At least 2,286 patients were hospitalised in July, 272 in June while 43 were infected in May, according to DGHS.

Though most of the patients who were hospitalised have so far been released, 1,146 are still undergoing treatment at hospitals in Dhaka, and 87 outside the capital, the DGHS

The Election Commission (EC) is going to hold more than 4,100 elections by December. Narayanganj City Corporation (NCC) mayoral election, and all district council and union parishad (UP) polls are to be held in this period.

Besides, EC has decided to hold by-polls to Sylhet-3 constituency on September 4, EC Secretary Humayun Kabir Khandaker said yesterday, following a commission meeting. Candidates can start their campaigns at 8am on September 1 and run them for 24 hours.

The Sylhet-3 by-polls, which was scheduled to take place on July 28, was postponed by the High Court on July 26 due to the imposed lockdown at that time. The Sylhet-3 constituency fell vacant pariiamentarian Manmud Us Samad Chowdhury died of Covid-19 on March 11.


In the first week of next month, the EC will announce dates of byelection to Cumilla-7 constituency, NCC mayoral election, first phase

polls for 167 UPs, second phase polls for UPs, and elections for nine municipalities, he said. He said the commission will need to hold

elections for more than 4,000 UPs by December. In March, the EC decided that elections to all UPs will be held in several phases. On March 3, the EC announced the schedule for polls to 371 UPs in

the first phase, fixing April 11 as the election day. But it delayed the election due to Covid-19 and fixed the election date to be June 21.

In early June, the commission decided to postpone elections to 163 union parishads in Khulna, Bagerhat, Satkhira, Noakhali, Chattogram and Cox's Bazar due to a surge in Covid-19 cases.



EC officials said elections for 61 district councils will be due by January 2022.

Besides, elections to nine municipalities were postponed due to Covid-19 as well, and the fiveyear tenure of another 20 municipal mayors will be completed soon. The five-year tenure of NCC

mayor will end on February 7, 2022, as the first meeting of the corporation was held on February 8, 2017. The NCC election was held on December 22, 2016. The Local Government (City

Corporation) Act 2009 requires holding city corporation polls 180 days before the tenure of the incumbent mayor ends. The present EC will also

complete it's five-vear tenure on February 14 next year, as the current commissioners assumed office on February 15, 2017.

NID-wing officials at the meeting proposed registering data of people who were born on or before January

1, 2006, aiming to issue National Identity Cards (NIDs) to all citizens aged 16 and above and include them in the voter list when they become

Those interested to get NID will need to go to the Upazila Election Office and apply, or they can register online. Citizens will be given NIDs only after completing biometric registration.

Humayun said a committee under Election Commissioner Brigadier General (retd) Shahadat Hossain Chowdhury usually observes NID activities. "The committee will review the matter and send their recommendation to the commission regarding the proposal."

The resolution, however, did not specify any decisions on whether the old and ecologically important trees will be cut. Environmentalists have been demanding

the government refrain from any further tree felling in the historic Suhrawardy Udyan

the meeting, where several professionals, including professors of Dhaka University and journalists, attended.

Yesterday, the ministry placed a copy of the resolution to the HC through Deputy Attorney General Samarendranath Biswas during hearing of a writ petition over this

The HC bench of Justice Farah Mahbub and Justice SM Maniruzzaman fixed Wednesday for hearing the matter, as writ petitioners' lawyer Syeda Rizwana Hasan said they will make a reply to the resolution after examining it.

According to the resolution, Minister Mozammel told the meeting that he will take an initiative to form a committee to

recommend which species of trees will be planted at Suhrawardy Udyan, and will think about narrowing its pathways.

The minister said they are trying to properly preserve and protect the history of the Liberation War.

He also said a symbolic structure of the stage where Bangabandhu had delivered his historic March 7 speech has been established, according to the resolution. Advocate Minhazul

Chowdhury, another lawyer for petitioners, who went through the resolution, told The Daily Star that there is no decision on whether the old ecologically important trees will be kept intact.

While hearing the petition filed by six rights bodies and an

activist, an HC bench on June 29 sought the resolution of the ministry meeting held on June 24.

The petitioners claimed the ministry is sponsoring a project titled "Suhrawardy Udyane Swadhinata Stomvo Nirman Threetiya Porjay (Construction of Independence Monuments at Suhrawardy Udyan -- Third Phase)", which is being implemented by indiscriminately felling hundreds of old and ecologically important trees. Meanwhile on July 23, Minister Mozammel told this correspondent that cutting trees has already been stopped, and construction work will continue keeping

the trees intact.

## 'Want peace, stability in Afghanistan'

Says Bangladesh permanent representative to OIC

Bangladesh has called for peace in Afghanistan, security of its people, and quick evacuation of foreigners who got stranded following Taliban's takeover on August 15 after the US withdrew troops.

Bangladesh Ambassador to Saudi Arabia and Permanent Representative to the Organization of Islamic Cooperation (OIC), Javed Patwary, said this at an emergency meeting of OIC on Sunday. As a responsible member of the international

community, Bangladesh believes in peaceful coexistence

with neighbouring countries and does not interfere in any country's internal affairs, said Patwary. Bangladesh's policy for South Asia comes from the Father of the Nation Bangabandhu Sheikh Mujibur Rahman's 1972 speech where he said, "We will work together with our neighbours for common development

and prosperity of South Asia." "Bangladesh wants sustainable peace and stability in Afghanistan, and as a bridge between South and Central Asia, Afghanistan should utilise its natural resources and geostrategic position properly."

Afghanistan's political situation normalises, Bangladesh will share its experiences of socio-economic development with the country.

Ambassador Patwary said the international community should continue humanitarian and development assistance for the Afghan people under the current circumstances. The OIC should keenly watch the situation and make necessary recommendations for Afghanistan's peace, security, stability, and development.

## Red Crescent withdraws volunteers over irregularity

Allegations are rife over the mishandling of Covid vaccinations at some centres in the port city. The situation has become so convoluted in fact, that Bangladesh Red Crescent Society has withdrawn their volunteers from two vaccination centres run by Chattogram City Corporation (CCC), protesting irregularities in their vaccine programmes.

Sources said the organisation withdrew its members from CCC General Hospital on Wednesday and from Safa Motaleb Maternity Hospital at Mohara area on Thursday.

Contacted, Iftekher Hossain Imu, chief of Youth Red Crescent, Chattogram, said they withdrew their members after coming across irregularities by a section of CCC staffers in these centres. Imu said they have seen various staffers prioritise vaccine-seekers in exchange of Tk 500 to Tk 1,000 for each person.

The same situation prevailed in CCC General Hospital, said Imu. "It got so bad that vaccine-seekers

besieged the centre one day. All occasions. They said the allegations CCC staffers fled the centre, but our aren't true. It's possible that some volunteers stayed and called 999. Police came in later and brought the situation under control."

"Here's the problem. The people might start associating our volunteers with the irregularities. Why will we take the liability of CCC staffers' misdeeds?" Imu asked.

"We do not have any problem with the centres run by the Directorate General of Health Services (DGHS). Our issues are with the two CCC-run centres," said Imu.

Contacted, Dr Sheikh Fazle Rabbi, civil surgeon of Chattogram, said, "As the two centres are run by CCC, I have passed it on to their health department, which will look into it."

Despite repeated attempts, CCC chief health officer Dr Selim Akter Chowdhury could not be reached for comments over the phone.
Contacted, CCC Mayor Rezaul

Karim Chowdhury said he was not aware of the issue.

It is worth mentioning that CCC formed a probe body on August 10 to investigate into a prior incident of vaccine mishandling on August 9. Although the committee was asked to submit a report within two working days, it is yet to start investigation.

CCC executive magistrate Jahanara Ferdous, also a member of the probe committee, said the probe was delayed due to unavoidable reasons, but are hoping to launch it soon.

CCC did suspend Bishu Dey, health staffer at CCC Mostafa Hakim Maternity, after a case was filed against him over misappropriating vaccines from the centre and administering them outside in exchange for money. Around 600 members of Youth

Red Crescent are volunteering in the "I have asked CCC health officials vaccination centres in the city and

### Embezzling Tk 1,100cr

## E-orange CEO, two former owners on 5-day remand

A Dhaka court yesterday placed three people, including two former owners of e-commerce platform E-orange, on a five-day remand in a case filed over embezzlement of around Tk 1,100 crore.

The accused are former owners of eorange -- Sonia Mehjabin and her husband Masukur Rahman -- and chief executive officer Md Amanullah Chowdhury.

Metropolitan Magistrate Morshed Al Mamun Bhuiyan passed the order after Aminul Islam, inspector of Gulshan Police Station and the case's investigation officer, produced them before the bench with a 10day remand prayer for each.

In the remand prayer, the IO said the accused schemed and misappropriated around Tk 1,100 crore from customers. So the three need to be remanded to find out information on the other accused and to know where they transferred the money.



## Mayor's 'private market' on public property

OUR CORRESPONDENT, Patuakhali

Amid the rising onslaught on private properties, including a place of worship and cemetery belonging to the minorities by land grabbers in Kuakata, the custodian of the town, the mayor himself, has built a kitchen market on public land right next to the Kuakata-Dhaka highway.

Built on Roads and Highways Department (RHD) land, on the southern end of local BTTB office by the highway, the market is built with wood and tin. Out of its 17 stalls, seven were handed over to recipients two months back.

Although Mahmudur Rahman Russell, sub-divisional engineer of RHD in Kuakata, in a notice issued on June 30 asked Mayor Anwar Hossain Hawlader to remove the illegal market, it is still operating at the spot.

During a visit to the market recently, many of the stores at the market -- 120 feet by 30 feet -- were seen selling fresh vegetables while three were selling grocery items.

Only one store in the middle of the market had a sign that read 'Sanju Moni Store -- proprietor: Shakib Hawladar'. Samsul Haque Hawlader, father of the storeowner, said the mayor of Kuakata handed over the stall to them after they paid him Tk 10 thousand.

"We've been selling vegetables here since last couple of months. some money as "construction The monthly rent for the stall has yet to be settled," he also said.

Another shopkeeper, Abdus Salam, said, "I heard that the land belongs to the government."

Although he claimed that the mayor built the market with his "personal funds" to create business opportunities for them, he admitted to have paid the mayor

The market is built with wood and tin, and out of its 17 stalls, seven were handed over to recipients two months back.

Salam, however, refused to say how much he paid to the mayor.

Vegetable seller Yasin also said that the mayor has built the market so they could make a living by conducting their business there.

A resident of the municipality on condition of anonymity said that the Kuakata mayor collected advance payments from locals and built the market illegally by encroaching on government land so he could rent it out for his own benefit.

Contacted, Mayor Anwar Hossain Hawlader said that he spent Tk 7 lakh from his personals funds to build the market for residents of the town, as there was no kitchen market in the municipality. "If the department concerned wants the land back, I will remove the market.

Asked about the notice served by the RHD, he said, "I received the letter and I've been having discussions with them [RHD].'

Mir Mohammad Kamrul Hasan, executive engineer of RHD in Patuakhali, said, "We couldn't take any action so far due to the nationwide lockdown. However, steps are being taken to remove that market soon.'

## 'I am totally lost'

Rising food prices, shuttered banks add to misery for Kabul REUTERS, Kabul

A week after the Taliban's lightning seizure of Kabul, growing numbers of people in the Afghan capital are facing a daily struggle to get by with their jobs gone, banks still shuttered and food prices soaring.

The thousands crowded outside the airport entry points and fighting for seats on flights out of Kabul have provided the starkest image of the turmoil in the city since the Western-backed government collapsed.

But as the days pass, everyday worries about food and rent are adding to the uncertainty in a country whose fragile economy has been crushed by the disappearance of international support.

"I am totally lost, I don't know what should I think about first, my safety and survival or feeding my kids and family," said a former policeman, now in hiding who has lost the \$260 a month salary that used to support his wife and four children.

Like many lower level government employees, who have often gone long periods without being paid, for the past two months he has not even received that.

"I'm living in a rental apartment, I have not paid the owner for past three months,"

## Harris vows 'enduring engagement' in Asia

Reaffirms US commitment to keep South China Sea open

Vice President Kamala Harris vowed "enduring in Asia yesterday, reassurances of Washington's commitment to the region following the United States' withdrawal from Afghanistan and the Taliban takeover.

The hardline Islamists' swift return to power a week ago, and desperate scenes of thousands trying

to flee, have cast a shadow over the United States' status as a global superpower.

But on a visit to Singapore, her first stop on a trip that will also include Vietnam, Harris repeatedly insisted that Washington could be

committed to enduring engagement in Singapore, into Southeast Asia and the Indo-Pacific," Harris told a press conference alongside Singapore's

"The reason I am here is because the United States is a global leader, and we take that role seriously.

But she dodged questions about whether US

credibility had been damaged by the Afghan debacle, saying only her government's focus was on "evacuating American citizens, Afghans who worked with us and vulnerable Afghans, including

Harris is also facing criticism for being tone-deaf in going ahead with a visit to Vietnam as US forces struggle to evacuate tens of thousands of people.

women and children".

US officials insist the trip was planned long before the Afghan crisis and is focused on Washington's broader strategic goals in Asia.

Southeast Asia is seen as critically important at a time China is challenging US political sway and naval dominance in the region.

Washington has repeatedly criticised Beijing's expansive claims to almost the entire flashpoint South China Sea, which overlap with claims of several Southeast Asian states and Taiwan. At yesterday's press conference, Harris reiterated US commitment to "uphold the rules-based international order and freedom of navigation, including in the South China Sea".

## Medical supplies stuck at Kabul airport: WHO

More than 500 tonnes of medical supplies including surgical equipment and severe malnutrition kits due to be delivered to Afghanistan this week are stuck because of Kabul airport restrictions, the World Health Organization said yesterday.

Aid agencies say it is critical that medical and food supplies reach some 300,000 people displaced in Afghanistan over the past two months amid advances by Islamist Taliban insurgents that culminated in their capture of Kabul on August 15.

Nearly 18.5 million people - half the population - rely on aid and the humanitarian needs are expected to grow due to drought. But the closure of Kabul airport to commercial flights has held up deliveries, WHO regional emergency director Dr. Richard Brennan told Reuters.

"While the eyes of the world now are on the people being evacuated and the planes leaving, we need to get supplies in to help those who are left behind," Brennan said in an emailed statement.

He said the WHO was calling for empty planes to divert to its warehouse in Dubai, United Arab Emirates, to collect the supplies on their way to pick up evacuees from Afghanistan.

The United States has enlisted six commercial airlines to help move Afghan evacuees, however Washington and Nato coalition partners have so far indicated that they cannot bring supplies on incoming evacuation planes due to "operational constraints and security concerns", Brennan

"The US is using these commercial airlines only for evacuation," he said, adding that the WHO was exploring various options and reaching out to other governments.

### **ETHNIC DIVERSITY AT THE CENTRE OF CONFLICT**

Afghanistan's ethnic diversity has been at the centre of politics and conflict in the country for more than a century, and these divides are expected to play a role in the Taliban's formation of a new government. No single ethnic group has a decisive majority among Afghanistan's 40 million people, and the fissures have been a perennial challenge to political stability. Here is a brief overview of the major ethnic groups in

The Pashtuns are Afghanistan's biggest ethnic group, making up more than 42 percent of the population. The group -- which is predominantly Sunni Muslim and speaks the Pashto language -- has dominated Afghan politics since the 18th century. Many Pashtun leaders over the years have stressed a "right to rule" Afghanistan, which has angered other ethnic groups. The Taliban, in control of Afghanistan for a second time after their 1996-2001 regime, are a Pashtun-dominated group. Even the two presidents under the previous US-backed governments -- Hamid Karzai and Ashraf Ghani -- were Pashtuns. Traditionally based in the south and east of the country, the dominant position of the Pashtuns has often caused resentment among other groups, especially because of political, economic and cultural marginalisation.

The Tajiks are the second-biggest ethnic group, making up more than a quarter of the Afghan population. The main language among Tajiks is a dialect of Farsi called Dari, also the lingua franca of Afghanistan. The group is mainly distributed in the north and west of the country, with strongholds in the Panjshir Valley, the western city of Herat and some northern provinces. The Panjshir Valley is famed for resisting occupation not only by the Soviet military in the 1980s but also by the first Taliban regime. While not politically dominant, a number of prominent Tajik leaders have emerged in recent decades. The revered



mujahideen leader Ahmad Shah Massoud -- "The Lion of Panjshir" -- who fought the Red Army and the Taliban is at the top of that list among Afghans. Burhanuddin Rabbani, a Tajik from Badakhshan province in the north, served as Afghan president from 1992 to 1996 before Kabul fell to the Taliban. **HAZARA** 

The Hazara, believed to have origins in Central Asian and Turkic peoples, are around 10 percent of the population and are mainly based in central Afghanistan. They speak a Dari dialect and are predominantly Shia Muslim. The group faced violent oppression and discrimination in Afghanistan over both religion and ethnicity for more than a century. They have also suffered massacres across various Afghan governments in recent decades, but especially under the Taliban -- hardline Sunni Muslims who have usually labelled Shias heretics.

Afghan Uzbeks are also around 10 percent of the population, mainly based in the north of the country close to the border with Uzbekistan. A Turkic people, they are mainly Sunni Muslims. The most famous, and notorious, Afghan Uzbek is the warlord Abdul Rashid Dostum, who fought with the Soviets against the mujahideen before changing sides and effectively setting up his own stronghold centred on the northern city of Mazar-i-Sharif. He was a leading figure in the Northern Alliance that helped end Taliban rule after the US invasion of 2001, and later joined the Ghani administration as a first vice-president. He fled to Uzbekistan when Mazar-i-Sharif fell to the Taliban this month.

## 'There is no time to waste'

Aid groups warn water crisis, drought threaten 12m people in Syria, Iraq

and Iraq are losing access to water, food and electricity, 13 aid groups warned in a report as they called for urgent action to combat the severe water crisis.

Rising temperatures, record low levels of rainfall, and drought are depriving people across the region of drinking and agricultural water, said the report, published vesterday. Syria is currently facing its worst drought in 70 years.

Compiled by a group international organisations, including the Norwegian Refugee Council, the Danish Refugee Council, CARE, Action Against Hunger, and Mercy Corps, among others, the report warned higher temperatures caused by climate change increased the risks and severity of droughts in the region.

The changes in the climate also disrupted electricity as dams ran out of water, which in turn impacted the operation of essential infrastructure including health facilities, they said.

"The total collapse of water and

## Israeli attack on Gaza strip 'apparently broke law': HRW

Israeli air raids that demolished four highrise buildings in the besieged Gaza Strip during its assault on the enclave in May apparently violated international laws of war, a leading international human rights group said yesterday, calling on the Israeli military to produce evidence justifying the attacks.

Human Rights Watch (HRW) noted although no one was harmed in the air raids, the attacks damaged neighbouring buildings, left dozens of people homeless, and destroyed scores of businesses.

The apparently unlawful Israeli strikes on four high-rise towers in Gaza City caused serious, lasting harm for countless Palestinians who lived, worked, shopped or benefited from businesses based there," said Richard Weir, crisis and conflict researcher for the New York-based group.

"The Israeli military should publicly produce the evidence that it says it relies on to carry out these attacks.

The Israeli military did not immediately respond to the report. But at the time it accused Hamas - the group that governs the enclave – of using the buildings for military

purposes and turning their occupants into human shields. However, it provided no evidence to back up its claims.

It was HRW's third report on the 11day Israeli offensive, which was marked by its intensity and the targeting of civilian structures.

It previously accused Israel of apparent war crimes for attacks it said had no clear military targets but killed dozens of civilians. Examining the actions of Palestinian groups out of the Gaza Strip, it also said that they fired rockets indiscriminately at Israeli cities, constituting a war crime.

Both sides denied the accusations. The conflict erupted on May 10 after Hamas fired a barrage of rockets towards Israel in support of Palestinian protests against Israel's heavy-handed policing of the Al-Aqsa Mosque and the threatened eviction of dozens of Palestinian families by illegal Jewish settlers in the nearby neighbourhood of Sheikh Jarrah.

The rockets were launched just minutes after the passing of a Hamas-issued ultimatum for Israel to withdraw its forces from the Al-Aqsa Mosque compound as well as Sheikh Jarrah.

### **DEVASTATING FLOODS** 22 dead in US state of Tennessee

Devastating floods after record rainfall in the southern US state of Tennessee have left at least 22 people dead and at least 20 more missing, local officials said Sunday in what they warned was a preliminary toll.

Tennessee Saturday meteorologists called historic storms and flooding, dumping as much as 17 inches of rain.

Rural roads, state highways, bridges and hundreds of homes were washed out and widespread power outages affected thousands of people.

In Humpreys County, the downpour broke a 24hour rainfall record for Tennessee, the National Weather Service said.

# **Business through Internet: A** Quest for Legal Framework

n absence of proper and up-to-date legal framework in place, administrative regulations seem to be governing the digital commerce operations in Bangladesh. Most of the transactions-related rules now in force in the country are derived either from Bangladesh Bank Guidelines or Guidelines of the Ministry of Commerce. On 4 July 2021 the Ministry of Commerce issued the 'The Digital Commerce Operations Guidelines, 2021' (hereinafter referred to as Guidelines, 2021). One of the aims of the Guidelines, 2021 is to ensure transparency and accountability of the mushrooming e-commerce operators. Chapter 3 of the Guidelines, 2021 provides that all the existing concerned laws of the country will apply to the digital commerce operations. As such, it seems that the government has no plans to enact a separate statute any time soon to regulate digital commerce operations. But the existing laws that govern commercial operations in Bangladesh are not sufficient to meet the demand of the current situation.

The Guidelines, 2021 render the responsibility to the marketplace authority to take proper steps against allegation brought by a consumer regarding goods or

Furthermore, Money Laundering Prevention Act, 2012 may be used to curb the swindle of money against transactions made via payment gateways platforms. However, the law is not designed in such a way so that it can be applied against defaulters of e-transaction processes. Section 23 of the Digital Security Act, 2018 allows fake ID related offences to be tried in Cyber Tribunals. The government has raised the number of Cyber Tribunals from 1 to 8 this year to try cyber offences at division level. But the fact is that criminal justice system in Bangladesh is a time-consuming, lengthy and tiresome process which often frustrates the victims of online frauds. This coupled with the difficulty of proving online frauds before court eventually demoralises a victim to file a case against the offender or persuades him to opt in for alternative measures e.g. out-of-court settlement with the offender or defaulter, wherever possible. Therefore, it is vital to find out ways for speedy disposal of disputes arising out of digital commerce

The Guidelines, 2021 made provisions for refund of advance payment made by a consumer in e-commerce in cases of nondelivery of goods or services. However, it is pertinent to mention here that paperless payment system has been in operation in Bangladesh under the Bangladesh Bank approvals. The existing legal framework authorises Bangladesh Bank to issue rules, procedures, guidelines, operating directives or specific permissions to introduce online payment systems. Bangladesh Automated Clearing House (BACH) includes Bangladesh Automated Cheque Processing System (BACPS), and Bangladesh Electronic Fund Transfer Network (BEFTN). These modern payment systems have brought significant change in the interbank fund transfer mechanisms of the country. But it is noticeable that these significant and major changes brought about in the payment systems are made only through issuance of directives and guidelines by the Bangladesh Bank. No statutory law consolidating all the rules, regulations and directives regarding payment systems has so far been passed by the Parliament. Though the government once took an initiative to introduce the Payment System Act, 2015, the proposed bill is yet to see the light of the day.

To sum up, it transpires that administrative guidelines and central bank regulations are the only basis of control and management of digital commerce operations these days in Bangladesh. But scattered guidelines and regulations cannot be an alternative to establishment of a well-planned and comprehensive legal framework by the Parliament to regulate and monitor digital commerce operations in the country. It cannot be gainsaid that we will certainly see further acceleration of digital commerce in the days ahead. The urgency of enactment of a statutory law consolidating all the rules, regulations and directives regarding control and management of digital business operations and online payment systems can hardly be ignored these days.

## Hindu women's right to inheritance

ayabhaga and Mitakshara are two schools of Hindu inheritance law. Hindus in India's West Bengal, Assam, and Bangladesh mainly follow the Dayabhaga school. Non-Bengali society, on the other hand, i.e., Mumbai, Madras, Punjab, Benares, Maharashtra, and other locations, follow the Mitakshara doctrine.

These two schools were established in response to Hindu scriptures and Samhitas that chronicle the practices that Hindus must follow in their personal lives. In imitation of the Hindu inheritance distribution system, daughters are not usually given a share in the father's property while the sons are still alive. Although it is not explicitly mentioned in the commentary, this practice has been going on for ages. As a result of this social norm, women are usually deprived of their father's

However, following the landmark case of Danamma vs. Amar in 2018, India has amended its Hindu Inheritance Act, 1956. The Supreme Court of India ruled in this case that under the reformed Hindu Succession Act, 2005, a daughter has equal property rights with their male counterparts. Again, the Supreme Court of India reiterated their verdict, stating that a woman can now claim an equivalent portion in the family property as a coparcener under Section 6 of the Hindu Inheritance Act, which was reinstated in 2005 to give women equal inheritance

According to Articles 27 and 28 of the Constitution of Bangladesh, all citizens are equal in the eyes of the law. Even though the Indian Hindu inheritance Act of 1956 was modified in 2005 and 2007 to realise women's rights, the Hindu inheritance law in Bangladesh remains unchanged.

Also, Hindus in our country are usually provided with legal recourse under British Law. One of the reasons for this is that Hindu Dayabhaga law is not wellrepresented in our country, and most Hindus are unaware of the Dayabhaga law of Hindu schools, which has less practical implications. Even though Bangladesh has a Hindu Inheritance Act of 1929, it only applies to Mitakshara practitioners, where most people in Bangladesh follow the Dayabhaga school of Law. So, it is regrettable for the policymakers of Bangladesh that they have not yet been able to ensure law which is applicable for the larger Hindu population.

The Law Commission has recommended amendments the Hindu Inheritance Act in order to provide Hindu women in Bangladesh equal rights to their father's property. In 2012, it proposed a new law to revamp the Hindu Inheritance Act which

included nine provisions emphasising equal property rights for women. However, the government was unable to take any further action due to the resistance of some Hindu scholars. The national alliance Hindu Ain Pronoyoney Nagorik Udyog has proposed the Hindu Inheritance Act 2020 containing 17 sections.

Some arguments against reform include the perception that the social system of Bangladesh is not conducive to Hindu law reform because Bangladesh is a predominantly Muslim country. On top of that, scholars argue because neighboring India and Nepal are Hindu-majority countries, Hindu law in these countries has been changed long ago to meet the needs of the time. Moreover, the democratic systems of India and Bangladesh are not analogous, and law reform will exacerbate the complexity of Hindu property distribution. Scholars also contend that if such legislation is enacted, no one will agree to marry a girl who does not own property, and dowry will become more common. Besides this, as is frequently seen in numerous family court cases, such property allotment will increase the level of violence against women.

In general, Hindu women receive Stridhana as a gift from their father during their marriage. Since Hindu marriages do not require registration, when a woman divorces, she is usually unable to file a claim for maintenance and other benefits. As per the Hindu Women's Rights to Property Act, 1937, women did not inherit any property. The 1943 Act later amended it, and after 83 long years, in 2020, the High Court Division ruled in the case of Jyotindranath Mandal vs. Gouri Dasi that Hindu women would get an allotment in their husband's property. Reviewing the history of Hinduism, it is seen that during the Vedic period, women were in a very respectable and high position, but their rights began to erode over time. Later, after the Vedic period, there were many changes in various treatise where women's property rights were utterly abolished. Indisputably, this is not acceptable in today's socioeconomic context because women are now eading worldwide. Women's ınherıtance includes more than simply a property and economic rights. Women's positions in the family, society, and state are strengthened by legacy. In conclusion, there is no alternative to give equal rights to women to build a modern social system. In this context, Hindu scholars and policymakers must come forward to reform the Hindu law so that equal rights for women are established in society.

## Citizenship of the Rohingya in Myanmar: A historical account

**T**hile the international stakeholders and the Government of **V** W Bangladesh have tried for their safe and dignified voluntary return of the Rohingya refugees as per the agreement between Bangladesh and Myanmar, the citizenship issue became one of the crucial contesting conditions. Unfortunately, no government of Myanmar, after the mischievous power-grabbing of the then Burma by the military government led by General Ne Win has responded positively to the citizenship issue of the Rohingya. The present article argues that the citizenship crisis is rooted in the British colonial era that consequently gained momentum through the political demarcation and marginalisation of different ethnicity

including Rohingya. It is believed that, during postcolonial periods, the Rohingya Muslims and the Rakhine/Arakan Buddhists lived harmoniously. After the colonisation by the British and the First Anglo-Burmese War in 1825, there was a paradigm shift in the politics and thus change the notion of the people of these two groups which silently created division and distance. This situation further extended during the Second World War, when the Rohingya declared their loyalty to the British while the Arakanese/ Rakhine sided with the Japanese. In response, the *Rohingya* population was targeted jointly by both the Rakhine

Buddhists and the Burma Independence Army, killing 100,000 Rohingya and exiling a further 50,000 towards the border to the then East Bengal. The situation worsened in 1947 when some Rohingya had been negotiating with West Pakistan about incorporating Maungdaw and Buthidaung of the northern Arakan region into East Pakistan which subsequently failed due to strong objections from Aung San and

The structure of the 1948 Burmese Constitution stands on the foundation of federal polity based on the Panglong Agreement signed by General Aung San, the chief architect of Burma's independence, on behalf of the majority Burmans with Shan, Kachin, and Chin ethnic nationalities who considered Burma as their home. However, the unfortunate assassination of Aung San settled the Burmese Constitution in favor of the Buddhist beliefs repudiating the tolerant integration of different ethnicity including Rohingya Muslims as it became deeply associated with "Burmeseness".

After the independence of Burma from the British in 1948, the 'Constitution of the Union of Burma and the Union Citizenship Act' together deemed as legal document encompasses guidelines for Rohingya towards Burmese citizenship. Harmonious reading of these two documents contended the constitution's intention of making citizenship inclusive rather than limiting access to citizenship rights for both



Buddhists and Muslims. U Nu, the longestserving civilian Prime minister of Burma, declared Rohingya as one of the ethnic races and acknowledged nationality of Rohingya with Kachin, Kayah, Karen, Mon, Rakhine and Shan. Burma's first president, Sao Shwe Thaike, and independent Burma's second prime minister, U Ba Swe, reiterated similar attitudes about the Rohingya's equal status of nationality.

Unfortunately, after the coup d'état in 1962, all the process of implementing citizenship rights of Rohingya have been deferred, even the government rejected official documents that had recognised Rohingya citizenship – effectively making them stateless. The five decades that

followed saw the military in continual conflict with the country's ethnic minorities and these ongoing domestic conflicts have been labeled the world's longestrunning civil war. In Ne Win's regime, the citizenship standing of the military government was practiced differently, especially by denying citizenship rights, forced official exercise, and silent changes in the contemporary domestic understandings about Taingyintha or "sons of the soil" ideology of ethnicity.

In the 1974 Burmese Constitution, which has been adopted based on a socialist manifesto by the military-led government, the ethnic groups had lost their special recognition. In 1978 the first military

campaign, codenamed "Dragon King", was carried out forcing about 200,000 Rohingya to cross the border into Bangladesh refuting Rohingya as a citizen of Burma. However, the government of Myanmar took back the Rohingya under pressure from UNHCR and Muslim countries in 1979

With the enactment of the Citizenship Law in 1982, the Rohingya were denied all forms of citizenship i.e., full, associate, and naturalised though they had strong proof of their existence in Burma before 1823.

From 1978 to 2017, there were several expulsions of Rohingya in different consecutive years. There was a nationwide campaign in April 2013 carried out by Buddhist monks that demanded anti-Muslim legislation. However, the 2008 constitution was very delicate in denying the Rohingya citizenship by drastically narrowing down the grounds of acquiring citizenship by the Rohingya. Moreover, the Thein Sein government repetitively address Rohingya as "illegal migrants of Bangladesh" and Suu Kyi-led government stands on the same footing make the situation worse. Therefore, all these systematic incidents in these years could be narrowed down to one arguable conclusion - structuring the denial mechanism of Rohingya citizenship by making the Rohingya stateless in their own country.

## Let's take the fight to Aedes

After 19 hotspots identified in Dhaka, authorities must ramp up dengue response

T is heartening to know that the Directorate General of Health Services (DGHS) has recently identified 19 Aedes hotspots in Dhaka—areas that are extremely vulnerable to dengue due to the widespread presence of Aedes mosquito, the carrier of the virus. Of them, 10 are in Dhaka North City Corporation (DNCC) and nine in Dhaka South City Corporation (DSCC). The survey, conducted from July 29 to August 7 in 100 areas of 98 wards of the two city corporations, is the first known quantitative risk assessment of this year's dengue season in the capital, where most of the dengue cases have been reported. If followed with quick and coordinated interventions, it will be quite helpful in containing the spread of the virus. It can help narrow down the focus in our fight against an "enemy" which, until recently, was largely ignored because of its significantly more infectious and dangerous counterpart—the coronavirus.

According to the survey, Basabo and Goran are at the top of the list of risky areas in DSCC with 73.3 points on the Breteau Index, whereas in DNCC, Moghbazar and New Eskaton are the riskiest areas with 56.7 points. The Breteau Index reflects the number of containers with Aedes larvae per 100 houses inspected. As well as the 19 hotspots, there are 26 other areas in DNCC and 30 in DSCC that got 20 points, meaning those are at risk as well. There are more insights to be drawn from this survey: in the areas identified as risky, the highest 18.5 percent of Aedes larvae was found on flooded floors, 12.1 percent in plastic drums, 9.4 percent in plastic buckets, 7.5 percent in flower tubs, 6.9 percent in discarded tyres and 3.2 percent in pots.

While there can be still places having escaped the radar of the DGHS team—who visited about 3,000 houses as part of the survey—what we have now should give the authorities of two city corporations ample ammunition to take the fight to dengue, rather than groping in the dark for a solution, passing the buck for failure on to each other, or the public in general, or randomly spraying larvicides/insecticides without a plan

The latest revelations come at a time when the dengue situation shows no signs of abetting. At least 291 dengue patients were hospitalised in 24 hours till Sunday morning. Of them, only 32 are from outside Dhaka. This takes the total number of infected since January 2021 to at least 8,041 people, of whom 5,383 got infected in the last 22 days. Twelve people died last month and 24 in the previous 22 days. The rising trend is a serious cause for concern, coming as it does against a backdrop of still-very-high coronavirus infections, overwhelming the entire healthcare system. We can't handle another major crisis lurking in our backyard. The authorities must ramp up their efforts to tackle the dengue crisis by undertaking an inclusive, well-coordinated response plan, not just in Dhaka but across the country.

## Remove all confusion regarding flights to India

Focus on getting them started


TATEMENTS made by the foreign minister and Biman on August 17 and 22, respectively, have led to another bout of confusion for air passengers wishing to travel to India from Bangladesh and vice versa. On August 17, the foreign minister said that flight operations to India will resume from August 20, but later he said his statement was not definitive, and what he meant to say was that flights between the two countries might resume at that time. However, following his earlier statement, Biman issued a press release saying that flights to Delhi and Kolkata will resume on August 22.

Despite these statements and the issuance of the press release, air travel between the two countries are still to start and, according to a report published by this newspaper on Monday, the Civil Aviation Authority, Bangladesh (CAAB) is yet to receive a response from India about resuming flights after they, on August 4, sent a letter to the Directorate General of Civil Aviation of India, seeking its approval for flight resumptions under the air bubble agreement. This means that all the previous statements were issued without the approval of the CAAB. After Biman's announcement, many passengers bought their tickets to India and those currently in India bought their tickets to return home. And these passengers are now stuck in limbo.

It is extremely unprofessional of Biman to have issued such a press release without verifying through official channels whether flights between India and Bangladesh were to resume and when. Just because the foreign minister issued a public statement does not give Biman a legitimate excuse for not following up with the CAAB for approval before going ahead and announcing its flight schedule to the public. This is the second time within a span of two weeks that Biman has placed its passengers in a difficult position. Earlier on August 10, a row between Biman and its online ticket sales partner led to all Biman ticket sales online being suspended. That led to untold sufferings for the public, who had to physically go and collect their tickets, risking themselves unnecessarily during a time of pandemic.

We expect much better from our national flag carrier. Such mismanagement on the part of Biman officials is nothing but humiliating. Biman should immediately offer an apology to all its passengers and, more importantly, try to help them sort out the inconvenience that it has caused. In the meantime, what is also essential for the authorities to do is to remove all confusion regarding the matter and focus on taking the necessary steps to resume flights.

## Tea workers routinely ignored during the Covid-19 pandemic



38, a tea of Rampur Tea Garden in Bahubal upazila (Habiganj district), died of Covid-19 on July 6. Rampur Tea Garden is a furi (division) of Rashidpur Tea

Estate, owned by Finlay Tea Co. Ltd. Paban had fever from June 27. On July 1, he started having difficulties in breathing. The following day, he developed severe breathing problems and was taken to Bahubal Upazila Health Complex. According to Paban's family, the upazila health complex could not treat him. It referred him to Habiganj district hospital. However, the Sheikh Hasina Medical College in Habiganj also failed to treat him. He was then admitted to MAG Osmani Medical College in Sylhet the same day (July 2). He got a bed in the general ward. On July 3, he was moved to

Paban was treated at ICU up to July 6—his condition turned critical and he died at 3:22 pm. His Covid-19 test sample was collected as soon as he was admitted to Osmani. At 4:30 pm on the day he died, it was confirmed that he was Covid positive. A healthy man without any known underlying conditions, Paban Paul is known to be the first reported casualty of Covid-19 in the tea gardens in Habiganj district.

After Paban's death, his family members got tested for Covid-19 too, but none of them were positive. According to Ajoy Singh (24), a nephew of Paban's who accompanied him to hospitals, he checked with the tea garden dispensary regarding Covid-19 tests, but he was told that he should make his own arrangements. The only immediate step taken by the garden management was to offer firewood for Paban's cremation and the funeral meal on August 5 for the family and a few others. The next thing the management is likely to do is recruit Paban's wife, mostly likely as a tea leaf picker in his place. And period! The company has done its duty to Paban's

Is it really so simple? Nripen Paul, joint general secretary of Bangladesh Cha Sramik Union (BCSU), the only trade union for around 100,000 registered workers in Sylhet and Chattogram divisions, believes tea gardens must do more. According to the Bangladesh Labour Rules 2015, the owner of tea gardens must provide "indoor" and "outdoor" treatment to its workers

and their family members. Purabi Paul, wife of Paban, reports the family spent Tk 85,000 (including a bribe of Tk 30,000 to secure a ICU bed) for his treatment. Will the owner refund, in full or part, the cost of his treatment? "We do not know how to approach the owner for this," says Purabi, who is now the only breadwinner of the four-member family.

Their ordeal demonstrates just how helpless tea workers are when infected with Covid-19. Most tea workers will testify that the management in any tea garden is least interested in carrying out Covid-19 tests of their workers. Why? According to different sources, owners fear that if tests are carried out, many cases

and upazila health complexes."

Covid-19 tests in government facilities may not sound expensive. At a district or upazila health complex booth, it costs Tk 100. But for a tea worker whose daily cash pay is Tk 120, this is expensive. Also, getting these tests requires travel costs and at least a day off work. Then, if one tests positive, the resulting treatment cost can be far too high for a tea worker to bear.

As a result, those in the tea gardens testing on their own and testing positive are having a very hard time. Hari Das (60) of Rajnagar Tea Estate in Rajnagar upazila (Moulvibazar district) is one such worker, who was a registered worker for 10 years and a casual worker for five years

implemented by the government to control the spread of the coronavirus, the tea gardens have continued operations throughout, including during the current wave of Covid-19 and the most recent lockdown. With a week off for Eid, a strict lockdown began on July 23, when all industries, including garments factories, remained closed. However, the tea gardens were the only exception. The Bangladesh Tea Board in a circular classified tea as "foodstuff", and its production and sale was exempted from the lockdown. During this period, many started

to believe that the tea gardens are a safe haven from the coronavirus. They have been proven wrong. There are allegations that tea workers have been wilfully exposed to Covid-19, given that tea gardens remained fully operational even though safety equipment for tea workers are miserably short in supply and Covid-19 tests for workers and their families are just inadequate. On the one hand, the owners are reluctant about providing tests, and on the other, the workers have a tendency to hide illness unless the symptoms become too explicit due to a fear of losing their daily wages.

We are yet to get a clear picture of the pandemic in the tea gardens, which remain largely isolated. The fear is that the Delta variant has spread into the communities in labour lines. The tea gardens in Assam, close to Sylhet, became a hotbed for Covid-19 related deaths during the second wave of the virus. According to a report in Northeast Today, 105 deaths were reported between April 1 and June 28, 2021 from the tea estates. In the first wave of Covid-19 last year, deaths in the tea gardens of both Assam and Bangladesh were few. However, in the current wave, Covid-19 deaths have dramatically increased.

Against this backdrop, the tea workers and their communities require urgent attention from the state and owners of tea gardens. Massive awareness campaigns, garden level tests for coronavirus, distribution of mask and sanitiser in adequate quantities and proper physical distancing at all stages of tea leaf picking, depositing and processing are some urgent needs in the tea gardens. Tea workers have brought huge profit and comfort to their owners, which includes state agencies that own 17 tea gardens. Now, at this time of crisis, they should treat the tea workers as a priority group for tests and vaccination.

According to Rambhajan Kairi, an executive adviser of BCSU, the management has, on the other hand, shown interest in vaccination, and in helping workers and their families to register for it. However, on the issue of testing for Covid-19 in the tea gardens, the civil surgeon of Sylhet district, Dr Chowdhury Jalal Uddin Murshed, said, "I wanted to initiate testing booths in the tea gardens, but the expert committee in Dhaka advised me not to do so, because there is a risk that Covid-19 will spread when collecting samples. Like others, the tea workers have to come to sample collection booths at district sadar hospital

at the manager's bungalow. His family took him to Moulvibazar Sadar Hospital with breathing problems, and he tested positive on July 7. However, because he is no longer a registered worker, he had to face even greater struggles, since he lost his wages for every day he was absent

## We must urgently prioritise adaptation to address the climate emergency

**¬**HE recently-published report of Working Group-I of the Intergovernmental Panel on Climate Change (IPCC) is a renewed wakeup call on the urgency of taking action at the global level to address climate change. It has, with more accuracy and confidence, confirmed that at least one degree Celsius of temperature rise compared to pre-industrial level can be attributed to human activities. The recent climate events in North America, Europe and Asia, such as heat stress, wildfires and floods, are ample evidence of runaway climate change.

Against this, what is urgently needed is exponentially enhanced adaptation actions, particularly in the most vulnerable low-income countries. Obviously, COP26 to be held in Glasgow in just three months is expected to negotiate an ambitious programme on adaptation. The July ministerial meeting held in London reached an understanding on putting adaptation on a higher political plane while moving forward. It may be mentioned that for the last few years, framing of adaptation has been expanded by multidisciplinary thinking from the national to global levels, requiring global cooperation and multistakeholder engagement. Accordingly, this norm of globalising responsibility for adaptation is recognised in the Paris Agreement, as a "global goal" and a "global challenge" (Articles 7.1 and 7.2).

Although six years have passed since the adoption of the Agreement, not much progress has been made in operationalising the Global Center on Adaptation (GGA), nor is there any concrete roadmap to address this challenge. So, COP26 is expected to establish a clear process of defining the GGA going forward. Some agencies, including the Green Climate Fund, adopted the potential of transformational adaptation as a criteria for approving projects/programmes for funding. The challenge is how to achieve the transformational adaptation under the existing global socioeconomic order.

Transformational adaptation is often contrasted with incremental adaptation, as a continuum, beginning with reactive, coping strategies. The former calls for a system-wide change, a restructuring

of human and ecological systems as an integrated whole, with a focus on sustainability of natural resources and man-made artefacts. This grounds human actions in spaces/places in the natural world and questions the effectiveness of existing systems, social injustices and power imbalances. But incremental adaptation happens within the existing socioeconomic structure, which works with the dominant actors without conflicts with prevailing interests and values. The proponents of this model argue for a slow process to effect change while working within the system, as the national or global dynamics do not support a radical change in the system, which is founded on the neoliberal paradigm that values market justice more than procedural and distributive justice.

Therefore, it can be argued that as a pragmatic approach, incremental

adaptation can be a vehicle for transformational adaptation (despite being a slow process), but only if it proceeds as part of a well-planned, long term strategy under current and future climate change. However, the process must be dynamic, without being locked into the inertia against change. For this to happen, there must be a few fundamental elements

The first is locally-led adaptation (LLA). We may recall that the now-defunct Global Commission on Adaptation had suggested embracing the LLA track for all the right reasons. A rich body of evidence already establishes the efficacy of LLA beyond contestation, as adaptation is inherently local or regional, because climate impacts differ spatially, across regions and across socioeconomic groups in any country. So, adaptation actions

must remain bottom-up, with national governments providing for a facilitative policy-institutional framework.

In fact, LLA can be regarded as a shift in adaptation paradigm, meaning a shift in fundamental approaches and assumptions in existing practices. If we really mean it as a paradigm shift, we must ask upfront the questions of Who, What, How, etc. in adaptation policy domain. It may be mentioned that adaptation is viewed often from a "technocratic" perspective, for investment decisions, to build climateproof resilient infrastructure. But this view does not address power and political dynamics, which is needed for a holistic perspective of adaptation that addresses the underlying causes of vulnerability, such as poverty, marginalisation, structural inequalities, economic, political and social disempowerment, etc. This latter lens is about transformational adaptation. However, available literature shows that even now, overwhelming practices in adaptation are driven not by local actors, but by those living far away from the locales or places increasingly pounded by extreme climate events as part of the new normal. Without a fundamental shift from hitherto centralised approaches to LLA, even incremental adaptation cannot be achieved sustainably.

In this effort, adequate funding for gradual implementation of LLA can make a difference. However, only three percent of the least developed countries' (LDCs) adaptation finance needs are now met with global support. Therefore, the following need to be agreed upon at COP26: First, scaling-up of adaptation funding to 50 percent of climate finance from the current level of only 20 percent globally. This had been pledged more than a decade ago by the developed countries and global funding agencies. Second, as pledged by the LDC Vision 2050, at least 70 percent of climate finance needs to be delivered to local communities, as opposed to the less than 10 percent that is currently reaching them. Third, COP26 must agree on a programme to improve access to adaptation finance, particularly for low-income nations, which includes reducing procedural complexities. Fourth, poor communities must get adaptation funding only on a grant basis, against the increasing trend of loan provision. Fifth, COP26 must agree that the five

percent share of funds generated from market mechanism activities under Article 6 of the Paris Agreement is channeled to the Adaptation Fund. Finally, the expedited direct access modalities (EDA) initiated earlier by the Adaptation Fund and now the Green Climate Fund must scale devolution of funding to subnational and local community levels so that programmes can be designed and implemented directly by local actors, with resources under their direct control. This internationally-supported funding must be complemented by national and local resources

The successful implementation of LLA requires a change in capacity building at all levels, focusing particularly on local actors including elected local representatives, local government officials, local entrepreneurs and community leaders. There should also be a focus on building local youth and women leadership. We may recall that earlier, supply-driven, short-term project-based, foreign consultancy-led capacity building under donor-supported Technical Assistance programmes did not work well. So, we must shift towards a demanddriven mode in capacity building. What we really need is a transformative capacity building model for transformational adaptation. This is the collective local agency to initiate social and economic transformation that gradually moves away from unsustainable and disempowering trajectories, towards a new socialecological trajectory that grounds adaptation actions within the assimilative and regenerative capacities of both manmade and natural capital.

Finally, as experience in adaption interventions is relatively new, a learningby-doing approach has to be taken. This is where action research is extremely important, which integrates local/ indigenous and scientific knowledge and methods. In this process, big data will not do, as national and global aggregate data mask spatial, socioeconomic and gender differentiation. The use of sub-national and local level data for measuring the process of monitoring, evaluation and learning would be the most appropriate when it comes to locally-led adaptation.

## School closures have wreaked havoc on children. We must bounce back.



wreaking havoc in Bangladesh, like in the rest of the world, for the last 18 months. There was always a concern that the pandemic would disproportionately affect poorer countries. That is how it is in

fragility of public institutions becomes more evident, and their shortcomings are laid bare. Amidst the grim struggle between lives and livelihoods, one group in the country has practically fallen off the policy radar: schoolchildren. While public health and hunger are rightfully the most urgent concerns during a pandemic, the current state of education is causing irreversible harm to our country's human capital, damage that will take decades to bounce back from—a ticking bomb, in other words.

All educational institutions have been closed since March of last year. This means, in a few months, children will pass two full grades without having attended a day of school. Of course, school closures do not automatically mean a complete break in learning. Parents and students together have found ways to cope with the crisis, as one would expect. Common alternatives to school learning adopted by families have ranged from the somewhat effective private tutoring and distance learning tools, to the more dubious unsupervised self-studying and help from family members.

A number of problems leap out. First, despite said coping measures, the substantial reduction in time spent on learning activities and the attempt to study outside the learning environment provided by schools are unlikely to compensate for lost school time. Second, all the above mentioned methods mean additional cost burdens for families, be it out-of-pocket costs for distance learning and private tutoring, or the opportunity cost of time spent by parents in teaching. With

mouths to feed during a raging pandemic, poorer families will understandably prioritise earning activities over children's education.

The third issue is the most obvious, and one that we should have foreseen. The notion that alternatives like distance learning tools would miraculously replace mainstream schooling is a pipe dream. Even before the Covid-19 crisis, one in five children of school-going age were out of school. The quality of education the rest were receiving was discouraging. Over half of children aged seven to 14 years did not demonstrate foundational reading skills before the pandemic, and almost three-fourths were found similarly lacking in numeracy skills, according to a 2019 survey conducted by the Bangladesh Bureau of Statistics (BBS) in collaboration with UNICEF Bangladesh. The ongoing school closure has only compounded the problem: at least one in four children are at risk of serious learning losses due to the prolonged disruption in education, as found by a recent study by the BRAC Institute of Governance and Development (BIGD).

The government appeared to be concerned

about the potential catastrophe. Immediately after the school closure, the authorities started broadcasting classes for primary and secondary students on national television—a commendable initiative on the surface. The problem, however, was the obvious absence of groundwork needed to properly execute such a measure. Over a third of rural families did not have access to a television. But even among those who had access, very few took those classes, and many who did found the content boring or difficult to follow. As a result, only two and three percent of primary and secondary school students, respectively, were reportedly using the medium.

Thus far, the multiple studies on education in Bangladesh carried out by BIGD over the course of the pandemic indicate three major consequences of school closures: worsening of the existing learning crisis, increasing outof-pocket costs, and the very real possibility of widening social and economic inequality

in the country. What can we do about it? To draw attention to this silent learning crisis and to nudge public discourse towards effective, feasible interventions, BIGD brought together some leading international experts in a workshop in July this year. The task at hand was to find satisfactory answers to the following: how do we deliver catchup education to recoup learning losses? How do we ensure last-mile delivery of education without further exacerbating inequality? And finally, how do we minimise dropouts and also provide life opportunities to children who may drop out due to the economic

fallout of the pandemic? First, the government and NGOs alike must consider the stark digital divide when designing technology-based education interventions. To reach the greatest number of children, both advanced and simple technologies are necessary. It might be prerecorded or live classes over the internet

in some cases; in others, it might be as rudimentary as a text message that delivers and follows up on homework and math

Second, since learning losses are unavoidable during school closure, we should, at the least, be able to identify and measure the learning gaps, so that when children return to school, we can tailor instructions to their appropriate learning level. Third, it is time we delinked learning from schooling. Remedial education during school hours will be unhelpful; students may fall back in their current grade. Thus, afterschool remedial classes will be necessary to help students catch up and be on track. The challenge is to make the supplementary content engaging-and not overwhelmingfor children. We also need to find creative solutions by exploring all possible delivery methods and by involving the entire education ecosystem, for example, by engaging community volunteers to provide supplementary education.

Finally, there is the looming danger of pandemic-induced dropouts among primary and secondary schoolchildren. Any and all measures that encourage children to stay in school—and parents to send their kids to school—should be explored. This includes incentives like free school meal plans and nutrition programmes. Also, the role of peers in promoting positive learning behaviour among students cannot be overstated. Interventions that emphasise the communal aspect of schools and promote cooperation and help-seeking behaviour among children have been proven effective against rising dropouts.

Rather than being proactive, policies and interventions in poorer countries have historically been reactive. But the Covid-19 crisis has exposed the pitfalls of this approach. Maybe this time, the pandemic will serve as the necessary impetus towards building more resilient institutions for the future.

## Afghan debacle potentially puts UAE on the spot

is showing the United Arab Emirates the downside of being a haven for deposed leaders and exiled politicians whose wealth is reportedly parked without question in Emirati financial institutions.

The latest arrival in the UAE, former Afghan president Ashraf Ghani, denied allegations by Afghanistan's ambassador to Tajikistan, Zahir Aghbar, that he had stolen USD 169 million from state coffers, and an assertion by the Russian embassy in Kabul that he had fled with four cars and a helicopter full of cash. There was no independent confirmation of the allegations.

Ashraf Ghani said that after the UAE announced that it was hosting him for "humanitarian" reasons, he had left his country "with one set of traditional clothes, a vest and the sandals" he was wearing. "I was expelled from Afghanistan in such a way that I didn't even get the chance to take my slippers off my feet and pull on my boots." Ghani, a former World Bank official who co-authored a book titled Fixing Failed States, said he arrived in the UAE "empty-handed." He was reported to have first gone to Tajikistan before landing in the UAE. Aghbar has denounced the Taliban takeover and pledged allegiance to Ghani's first vice president, Amrullah Saleh. Saleh insists that he remains in office as the legitimate caretaker president and has criticised Ghani for abandoning Afghanistan.

Ashraf Ghani joined a long list of highprofile figures who have sought refuge in the UAE over the years after having either headed governments that were perceived to be corrupt and/or faced charges of corruption themselves. They include siblings Thaksin Shinawatra and Yingluck Shinawatra, who both served as Thai prime ministers until they were toppled by the military, former Pakistani

president Pervez Musharraf, former Spanish King Juan Carlos, ex-Palestinian security chief Mohammed Dahlan and Ahmed Ali Abdullah Saleh, the eldest son of a longtime Yemeni leader who was toppled in the 2011 popular Arab revolts and assassinated several years

"For almost two decades now, billions of dollars in corruption proceeds have been funnelled from Afghanistan, a country devastated by four decades of conflict, to Dubai. These outflows have played a part in stunting Afghanistan's economic and political development, facilitating the resurgence of the Taliban, and exacerbating regional

candidate, Ahmad Wali Massoud, whose brother was reported to have flown to the UAE with more than USD 50 million in cash; a senior intelligence official, Adib Ahmad Fahim, whose father was implicated in involvement with the transfer of large sums of money from Afghanistan, and various members of parliament. Fahim's uncle, Haseen, and Karzai's brother were shareholders in Kabul Bank, which was at the centre of a billion-dollar fraud in 2010, much of which was parked in Dubai banks.

The Bureau was careful to emphasise that ownership did not constitute evidence of corruption. The Bureau noted, however, that

raise red flags and needs to be investigated by the authorities," she said.

While in office, Ghani ordered an investigation into allegations of embezzlement by Ghulam Farooq Wardak, when he was education minister. Wardak was identified by the Bureau as owning, together with his wife, two luxury properties in Dubai. The investigation, conducted by the US Special Inspector General for Afghanistan Reconstruction (SIGAR), reportedly found evidence of embezzlement and inaccurate data records on the number of schools that enabled diversion of donor funds. Wardak denied the allegations.

Of all the exiles in the UAE, Ashraf Ghani most represents the risks of facilitating the movement of funds that potentially may have been acquired through corruption. Massive corruption in Afghanistan is what partly returned the Taliban to power. If so, looking the other way at the influx of corrupt funds has helped empower the kind of group against which the UAE has been on the warpath for more than a decade: Islamists who reject a separation of politics and religion.

"Terrorist groups may use (Afghanistan) as a base if global powers cannot negotiate with the Taliban on (the transition of power) quickly," warned columnist Yousef al-Sharif in the UAE's Al Bayan newspaper. To be sure, the Taliban have never sought

to export their vision of an Islamic state but their victory encourages militants who do, many of which, like Al Qaeda and the Islamic State, are present in Afghanistan.

In addition to the fact that the Afghanistan debacle highlights the need for stricter implementation of anti-money laundering laws, the UAE may feel the need to review its policies as Western nations consider tightening their approach towards aid and cooperation with Middle Eastern, African and Asian countries in the wake of the return of the Taliban.

"The governments and populations we support need to assume ownership and responsibility for the well-being of their country. We need to apply conditionality much more than we have done in the past... If a host government does not play ball—if it is not ready to build strong independent institutions, promote democracy, fight corruption, and respect national and international law-in future, German leaders and their allies should think twice about entering into massive engagements," said Christoph Heusgen, chairman of the Munich Security Conference Foundation Circle. He was Germany's ambassador to the United Nations until June of this year.

Heusgen, as well as Jean-Marie Guéhenno, a member of a board that advises UN Secretary-General António Guterres on mediation, have suggested that Europe should review its involvement in other conflict zones such as the Central African Republic, Mali and Somalia.

The UAE has focused on Somalia and the breakaway republic of Somaliland with the creation of military bases and management of ports as part of its bid to project influence in the Horn of Africa and counter Turkey, Iran, Qatar and Saudi Arabia.



been vaccinated has been discussed, with most experts of the view they are not prone to severe infections though it can pass the virus to others. Other estimates have said the third wave, seen to be the result of renewed mobility, may prove to be less severe than the second.

reported a record 18,332 Covid-19 infections yesterday and for the first time acknowledged community transmission of the highly contagious Delta variant of the virus in its capital region.

The region, an urban sprawl containing the capital, Manila, and 16 cities home to more than 13 million people, had been subject to strict lockdown measures which were relaxed for 10 days from August 21 to allow more businesses to operate, reports Reuters.

Israel said yesterday it would offer Covid-19 vaccinations to students on school grounds as it announced the school year would open on time next week, despite surging coronavirus

"Pupils... will be vaccinated on school grounds during school hours, subject to parental approval," government statement said, confirming classes would begin on September 1.

China reported no new domestic coronavirus cases yesterday, and Beijing appears poised to bring to heel the pandemic's most serious resurgence in months -- driven by the highly contagious Delta variant -- with mass testing and targeted lockdowns.

The latest outbreak, which began in mid-July when cleaners at a Nanjing airport tested positive, is the most severe since Covid-19 first surfaced in the central city of Wuhan.

In Australia, police yesterday criticised a Sydney church for flouting the city's Covid-19 lockdown by holding a service for 60 people in a pandemic hotspot.

The church is part of Christ Embassy, an international religious group headquartered in Lagos, Nigeria, which has a record of spreading Covid-19 conspiracy theories.

After being tipped off by residents yesterday, police moved in on the Christ Embassy Sydney church, issuing a fine of 5,000 Australian dollars (\$3,600) to the organisation and Aus\$1,000 fines to 30 parishioners.

But if you are not going outdoors, or don't have a cycle, home breathing exercises are a good start. There are many tutorials on YouTube that can help you out. The breathe-store-exhale three times a day is a good idea.

The drill is to breathe in through the nose, and let the air sit inside your lungs for 5-10 seconds. Then exhale

with ease. Repeating this exercise a few times a day can help clear your nasal pathways. To take this exercise a bit further, you might consider lying face down on your bed, with a pillow pressed against your diaphragm. This way, your lungs can accommodate the most amount of oxygen and that strengthens the capacity to pump in, store, and pump out the air.

Breathing exercises will not prevent Covid-19 transmission, but these can provide the body a fighting chance. And in these trying times, any fighting chance is worth considering.

## Ukraine blocks access to popular Russian news sites

Ukraine yesterday blocked the websites of several prominent Russian media outlets in its latest round of sanctions against neighbouring Russia which it has accused of spreading propaganda.

Ties between the ex-Soviet countries have deteriorated sharply since Russia annexed the Crimean peninsula in 2014 and threw its weight behind armed separatists in eastern Ukraine.

Ukraine and its Western allies have accused the Kremlin of sending troops and weapons to reinforce the separatists and also say Russia is leveraging media as

a propaganda tool to stoke the conflict. A decree from President Volodymyr Zelensky published Sunday ordered the websites of 12 Russian media

organisations to be blocked in Ukraine. include the Vedomosti They business daily, which was recently taken over by Kremlin-friendly editors, and the Moskovsky Komsomolets

newspaper, among others. The decree also ordered the organisations' local bank accounts to

The Kremlin criticised the move, describing Ukraine as being on a path towards "strangling freedom of speech" and limiting "unwanted and uncomfortable" information.

Vladimir Soloviev, the head of the Russian Union of Journalists, described the move as the "final cleansing" of Russian media in Ukraine.

'Today is a big day for Delhi in its fight for clean air against pollution," Chief Minister Arvind Kejriwal said after the inauguration near the busy shopping area of Connaught Place.

The installation "is being looked at in an experimental way. We will analyse the data and if it's effective, more towers will be built across Delhi," Kejriwal added.

The tower cost \$2 million and critics say erecting a sufficient number to clean the air substantially across the city would cost huge amounts of public money, and that efforts would be better directed at the sources of the smog.

These include vehicle exhaust, heavy and small-scale industry, construction activity, the combustion of waste and fuel, and in winter the burning of crops in neighbouring

"Let's just be clear that this is futile, an absolute waste," Karthik Ganesan from the Council on Energy, Environment and Water told AFP.

"Now that taxpayers' money has been spent, let Delhi be the test case for all other Indian cities... to ensure no other city spends on such ideas which we can't afford," he added.

India has 14 of the world's 15 most polluted cities, according to the World Health Organization.

A 2020 study in the Lancet found there were 1.67 million deaths in the country attributable to air pollution in 2019 including almost 17,500 in

In 2018 China built a much larger 60-metre smog tower in the polluted city of Xian, but the experiment has not spread to other cities so far.

Earlier Finn Allen and Colin de Grandhomme, after participating in The Hundred, arrived in Dhaka from England on August 20, four days ahead of the scheduled arrival of the Kiwis and

## Victims still stranded in India

Police want to visit there to bring them back; some remain traceless

Some of the girls trafficked to India and forced into prostitution by a transnational racket are still stranded in the neighbouring country, while a few, including a minor, are yet to be traced.

A police team now wants to visit India to rescue and bring back the Bangladeshi victims, and interrogate those arrested in connection with the trafficking.

At least 10 victims, mostly TikTok users, were trafficked by the racket recently, according to police.

The Daily Star learnt names of the six victims, including a minor, who are still stranded or untraceable in India.

Md Shohidullah, deputy commissioner of Tejgaon Division, wrote a letter to the inspector general of police,

seeking permission to send a three-member investigation team to India. Speaking to The Daily Star yesterday, the Tejgaon DC said the matter is still under process.

After a video clip of a 22-year-old woman being tortured and sexually assaulted went viral on social media, Indian police, in May, arrested Rifadul Islam Ridoy, 26, along with five other Bangladeshis from Bengaluru.

## Bodies of 398 migrants sent home from Jeddah

At least 398 bodies of Bangladeshi migrants were sent from Saudi Arabia's Jeddah region in the 2020-2021 fiscal year following efforts taken by the Bangladesh Consulate General in Jeddah.

Employers of 391 of the workers paid for the expenditure of sending the bodies, which saved almost Tk 9 crore, the consulate general said in a recent letter to the expatriates'

welfare ministry.

The seven other bodies were flown home with the expenditures borne by the Bangladesh government.

Talking to this correspondent on a messaging app, Aminul Islam, labour counsellor at the Bangladesh Consulate General in Jeddah, yesterday said in the 2019-2020 fiscal year, 591 bodies of Bangladeshi expatriates arrived in the country.

## 3rd Covid wave imminent

Warns India's home ministry panel, seeks better medical preparedness for children

A committee of experts constituted under the National Institute of Disaster Management (NIDM) of India's home ministry has warned of an imminent third wave of Covid that could peak around October.

It also sought better medical preparedness for children who might be at similar risk as adults.

The report of the committee has noted that "paediatric facilities — doctors, staff, equipment like ventilators, ambulances, etc are nowhere close to what may be required in case a large number of children become infected".

It has called for prioritising vaccination among children with co-morbidities and a special focus on those with disability. The report has been submitted to the PMO.

Even with "strict interventions", the peak of the third wave is expected to arrive by late October, the experts have concurred with earlier assessments of different institutions. Several studies have spoken of the likelihood of a third wave but these are estimates.

# New Delhi opens first 'smog tower'

India's capital New Delhi opened its first "smog tower" yesterday aimed at reducing the air pollution blamed for thousands of premature deaths every year, but experts were sceptical.

Concentrations of tiny deadly particles in Delhi's air regularly exceed safe limits by up to 20 times, particularly in winter when its 20 million people are enveloped in a noxious grey blanket of smog.

Forty giant fans on the 25-metre (82-foot) tower will pump 1,000 cubic metres of air per second through filters that halve the amount of harmful particulates in a radius of one square kilometre (0.4 square miles), according to engineers.

# Accused asks for death by firing squad

Court sets Aug 31 for verdict delivery

An accused in the Xulhaz-Tonoy murder case told a judge that he would prefer death by the firing squad in public, if the court was to give him the death penalty.

At the end of yesterday's closing arguments of the proceeding, Arafat Rahman Siam, member of militant outfit Ansar al Islam, said, "Sir, if I get the death penalty in the case as a militant, please order for my execution by the firing squad."

Siam was given the death penalty in another case in February.

He repeated the sentence twice before Judge Majibur Rahman of the Anti-Terrorism Special Tribunal set August 31 to deliver the verdict in the case.

Siam is one of the eight members of Ansar al Islam accused in the case.
