# A principal mired in corruption

Edn ministry probe finds Mirpur college principal embezzled funds, appointed teachers violating rules

With each passing day, his irregularities became more unbridled and brazen.

From preparing fake bills to disbursing money without vouchers, from paying hefty repair bills for furniture bought barely a year ago to spending unacceptable amounts of money in the name of rally and education tours, from collecting different fees from students without providing a receipt to appointing as many as 38 teachers violating rules and regulations, Md. Gholam Wadud, the former principal of Mirpur College, has indulged in all.

So unbridled did his misdeeds become that a few teachers of the college lodged a complaint against him to the authorities, which prompted an investigation by the Department of Inspection and Audit (DIA) of the education ministry and led to his suspension.

The investigation unearthed a case of unbridled use of influence to enrich oneself. The report was submitted to the ministry on June 30.

On August 21, the college governing body suspended Wadud. A few days earlier, the Directorate of Secondary and Higher Education (DSHE) had suspended Wadud's

#### **Rolling Stones** drummer Charlie Watts dies

Rolling drummer Charlie widely



regarded as one of the coolest men in rock, a jazz enthusiast and snappy dresser during nearly 60 years with the band, has died, his spokesperson told Reuters yesterday.

He was 80 years old. "It is with immense sadness that we announce the death of our beloved Charlie Watts. He passed away peacefully in a London hospital earlier today surrounded by his family," the spokesperson

"Charlie was a cherished husband, father and grandfather and also as a member of The Rolling Stones one of the greatest drummers of his generation."

### Probe reports to be submitted in 45 days

CID says

The CID yesterday said the investigation reports of the 15 cases filed against different people, including actor Pori Moni, model Piasha, producer Nazrul Islam Raj and expelled Awami League leader Helena Jahangir, would be submitted in a month and a half.

CID chief Mahbubur Rahman, also additional inspector general of police, came up with the disclosure at the Criminal Investigation Department Headquarters while speaking to reporters.

Although he said they are at the final stages of the probes, other officials involved in the investigation said they had no clue about how the accused collected the liquor and why they had stocked it.

Asked about the narcotics cases, the CID chief said they are collecting evidence.

"Some of them [the arrestees] are saying they have brought it [liquor] from abroad while some are saying they bought it from the airport."

#### Venomous sea snakes confusing divers for mates



Highly venomous olive sea snakes may "attack" scuba divers as part of misplaced courtship behaviors, according to a new study.

Divers regularly report sea snake interactions involving chasing and biting, the reasons for which were previously unclear.

Now a study published in journal the Scientific Reports suggests that male sea snakes may think divers are potential rivals or mates, while female snakes think they are possible hiding places.

The study uses data collected by co-author Tim Lynch describing encounters with olive sea snakes in the Great Barrier Reef, Australia, from 1994-95. In 74 of 158 encounters sea snakes approached SEE PAGE 10 COL 1

## Homegrown mRNA Covid shot safe

Says India after early trial

Indian pharmaceutical firm Gennova Biopharmaceuticals' Covid-19 vaccine, the first homegrown mRNA-based shot, was found to be safe and effective in an earlystage study, the government said yesterday.

Government authorities have also approved further studies to test the vaccine's

efficacy in a larger population. Gennova plans to conduct a mid-stage study at about 10 to 15 sites and a late-stage trial at 22 to 27 sites in India.

The country has authorised emergency use for two domestically developed Covid-19 shots, made by Bharat Biotech and Zydus Cadila, but does not have mRNA-
