METRO DREAM closer to reality

Uttara-Agargaon section to open by Dec 22 at the latest: Quader

Bangladesh's first ever metro rail service will launch in December next year, Road Transport and Bridges Minister Obaidul Quader said vesterday, raising the city dwellers' hope of daily commutes free of tailbacks.

At least, the service between Uttara and Agargaon, a distance of 11.73km, will be operational by the end of 2022, Quader said while inaugurating the beginning of a series of test runs of the metro train on viaduct yesterday.

Uttara-Agargaon is part of the 20.10km route to Motijheel. The Mass Rapid Transit Line-6 or MRT-6, the country's first metro rail service, is being built at a cost of Tk 21,985 crore.

"We hope the prime minister will be able to inaugurate... the metro rail, Padma bridge and Bangabandhu tunnel next year," he said.

Padma bridge will be inaugurated in June. The second mega project to be inaugurated will be the Bangabandhu Tunnel under the Karnaphuli SEE PAGE 2 COL 6

ENFORCED DISAPPEARANCES

Days in custody unaccounted for

Cops showing victims arrested even weeks after actual detentions

There is a kind of enforced disappearance where a person is picked up or abducted, vanishes into thin air and is never heard from again.

There is another kind where the person returns but after many months or years.

Then there is a more common form of enforced disappearance.

These are the cases where a person is picked up and kept at a certain location for a few days before being produced before a court as arrested. This leaves a certain number of hours, days, or weeks in custody unaccounted for.

According to the Code of Criminal Procedure (Section 167) an arrestee must be produced before the court within 24 hours of arrest. But as law enforcement agencies, journalists and rights activists know, this stipulation is often flouted.

Rights organisations are rarely able to collect data on this. The phenomenon only recently came under media scrutiny when cartoonist Ahmed Kishore filed a case alleging that he was kept in an unknown location for several days and tortured.

In recent times, she said Hong Kong, Singapore and Bangkok gained importance while Dubai is currently getting the greater attention. "I can say Cox's Bazar will be

Use of antibiotics rampant, careless

Finds study on 10 Covid and non-Covid hospitals

A study has revealed that costly antibiotics are being prescribed injudiciously for treating Covid patients at hospitals, which could lessen effectiveness of the lifesaving drugs in killing bacteria.

Such irrational use of antibiotics is also putting unnecessary financial burden on patients, said researchers involved in the

The Institute of Epidemiology, Disease Control and Research (IEDCR) and the American Society for Microbiology (ASM) jointly conducted the study at five Covid and five non-Covid hospitals in the capital, Chattogram, Rajshahi and Sylhet. Of the hospitals, five are state-run and five private.

Data was collected from May 1 to July 30 this year for the study titled "Antibiotic Usage and Antimicrobial Resistance in Tertiary Care Hospitals of Bangladesh".

Bacteria-fighting drugs known as antibiotics have been helping control and destroy many of the harmful organisms that can make one sick.

But in recent times, overuse and misuse of antibiotics led some strains of bacteria



to make small changes in their DNA and become antibiotic-resistant "superbugs", according to health experts.

This happens mainly due to injudicious use of antibiotic drugs, they said.

As per the AWaRe (Access, Watch and Reserve) classification, antibiotics are classified into three groups -- "Access Group" used for a wide range of primary level infection, "Watch Group" used against higher resistance bacteria, and 'Reserve Group" only to be used when all

alternatives fail. AWaRe classification is a method to classify all antibiotics adopted by the World Health Organization in 2019.

OUT OF KABUL A dozen Bangladeshis now in Qatar

The 12 Bangladeshis and 160 Afghan students evacuated from Afghanistan to Qatar on Saturday have been under quarantine at a US base in Doha.

Their quarantine period will be determined by their health status following the RT-PCR test, a source familiar with the evacuation process told The Daily Star yesterday.

They will be brought to Bangladesh following the quarantine period, he said.

The Bangladeshis and the female Afghan students of the Asian University for Women in Chattogram were evacuated with the help of the US and the United Nations from

Their flights were cancelled initially after the Taliban's seizing control of Afghanistan on August 15 as thousands of foreigners and Afghans rushed to flee the country in fear of Taliban rule.

Blast rocks Kabul again

Rocket lands in a neighbourhood near airport; US strikes at IS militants

A huge explosion was reported near Kabul airport yesterday after a rocket had hit a neighbourhood, hours after US President Joe Biden warned of another terror attack.

An Afghan police chief said the rocket struck a house in an area to the northern side of the airport amid US evacuation. Television footage showed black smoke was rising into the sky. However, no casualty was reported and no group immediately claimed the attack.

US President Joe Biden on Saturday warned of more attacks from the ISIS-K group. "The situation on the ground continues to be extremely dangerous, and the threat of terrorist attacks on the airport remains high," Biden said.

'Our commanders informed me that an attack is highly likely in the next 24-36 hours."

Meanwhile, the US carried out a drone strike on Islamic State militants in Kabul yesterday, US officials said, as its forces at the capital's airport worked to complete a withdrawal that will end two decades of involvement in

The officials, speaking on condition of anonymity, told Reuters the strike targeted suspected ISIS-K militants, a group that is an enemy of both the West and the Taliban and was responsible for a suicide bomb attack outside the airport gates on Thursday.

The attack by ISIS-K, a branch of Islamic State, killed at least 90 Afghans and 13 American troops as a huge evacuation operation was underway following the Taliban's seizure of Kabul on Aug. 15.

Fishermen not getting their aid

Says agriculture minister; points to corruption in distribution

Explaining the hurdles that fishermen have to face, Agriculture Minister Dr Muhammad Abdur Razzaque said on top of other miseries, they do not even get the aid meant for them during fishing bans.

"I've information. Please don't mind. Fishermen do not get the 40-kg rice properly. Anomalies take place," he said at the inaugural session of

"National Fish Week 2021" yesterday. The National Fish Week 2021 began on Saturday and will continue till September 3.

Speaking to SM Rezaul Karim, minister of the Ministry of Fisheries and Livestock (MoFL), who was present at the programme, Razzaque requested a special programme and monitor so that aid reaches actual

In three phases, the MoFL provided VGF rice to fishermen. A total of 16,721 tonnes of rice were distributed to 2,98,595 fishermen during the 65day ban on catching fish in the sea.

About 56,228 tonnes of rice was distributed among 3,73,996 fishermen during the ban on catching Jatka (fish fry) and about 10,566 tonnes to 5,28,342 fishermen during the 22-day ban on catching brood Hilsa.

Razzaque called upon the MoFL to increase the amount of aid.

"We have to feel the struggles and [consider the] conditions of fishermen who live in remote areas of Barguna and Patuakhali. Their living standard is declining due to the rise in sea levels and many other reasons... It is our duty to look after them. As a part of the government, I'll help you in this regard."

Contacted, Zia Haider Chowdhury, project director (Hilsa) of the Department of Fisheries (DoF), said local administrations and public representatives are involved in aid distribution.

"We have to strengthen our monitoring this year to ensure that the aid reaches actual beneficiaries,' he said

Sangsad Speaker Shirin Chaudhury Sharmin programme said the government has taken comprehensive measures to develop the fish sector of the country.

"Meeting nutrition demands, building a meritorious nation, the unemployment problem, in other words, the overall socio-economic development of the country is related to the fish sector. That is why the government is giving emphasis on it," she said.

Fisheries Minister Rezaul Karim said Bangladesh was internationally recognised for its success in fish production. The country came in third in catching fish from inland water bodies and fifth in fish farming in closed water bodies.

Bangladesh ranked first in the production of Hilsa and fourth in Tilapia, he said, adding that they have successfully revived 31 native fish.

Underscoring the need to catch fish from the sea in a well-planned manner, he said if fish is caught following scientific methods, marine life will not go extinct.

Twenty-one individual organisations were handed gold and bronze medals for their outstanding contribution in the fish sector.

Dhirendra Debnath Shambhu, president, parliamentary standing committee on fisheries and livestock, Rawnak Mahmud, secretary at the MoFL, and Quazi Shams Afroz, director general of DoF were present, among others.

Use of antibiotics rampant, careless

The IEDCR study found that physicians prescribed the Watch Group drugs in around 70 percent cases, followed by Access Group drugs (28 percent), Reserve Group drugs (0.8 percent), and drugs not recommended by the WHO (0.4 percent).

"Physicians should be cautious while using Watch Group antibiotics as these drugs have the potential to give rise to resistant bacteria," said Dr Zakir Hossain Habib, head of microbiology and principal scientific officer at the IEDCR, who led the

The study listed top 10 antibiotics based on their use among patients at the Covid-19 wards and ICUs.

It showed Ceftriaxone physicians' first choice for majority of the patients at four of the five Coviddedicated hospitals.

For example, Ceftriaxone was the first choice for treating 62.8 percent of the Covid patients at Bangladesh Institute of Tropical and Infectious Diseases in Chattogram, followed by a combination of Amoxicillin and Clavulanic Acid (24.8 percent).

Similarly, Ceftriaxone was the doctors' top choice for treating 55.8 percent of the patients at Rajshahi Medical College Hospital, 53.6 percent at Shahid Shamsuddin Hospital in Sylhet, 30.7 percent at Chattogram Medical College Hospital and 27.9 percent at Uttara Adhunik Medical

College Hospital in the capital. According to a 2017 IEDCR study, the widely-prescribed ceftriaxone was ineffective in combating E-coli, proteus spp, non-typhoidal salmonella and Acinetobacter complex and other bacteria in many cases.

The latest study said Meropenem -a Watch Group drug -- was also among the top 10 antibiotics used at these five hospitals. This was widely used for the patients in intensive care units.

"Covid-19 is a viral infection and antibiotics are not effective in treating it. Antibiotics should not be used unless there is possibility of secondary bacterial infection... Physicians should be judicious in selecting antibiotics," Dr Zakir told this newspaper yesterday.

"This [use of antibiotics] also puts unnecessary financial burdens on patients."

Ceftriaxone is a costly and overrated drug. It should not be used without proper judgement, he observed.

Voicing concern over widespread use of very effective antibiotic Meropenem for Covid patients, he said doctors should be more careful about using this drug and try to avoid it whenever possible.

According to experts, Culture and Sensitivity Test of a patient's specimen is a mechanism to see what kind of medicine, such as an antibiotic, will work best to treat a particular disease or infection.

Worryingly, this practice was found in case of drug selection for just 6 percent patients at private hospitals and only 3.44 percent patients at public hospitals.

The researchers involved in the study recommended prescribing antibiotics based on the results of Culture and Sensitivity Test.

They also said ceftriaxone should be used judiciously.

Ain o Salish Kendra yesterday issued a statement demanding that the government of Bangladesh ratify an international treaty by the United Nations titled International Convention for the Protection of All Persons from Enforced Disappearance.

It also demanded that the government initiate an investigation of enforced into all cases disappearances.

Furthermore, it stated that a specific law must be crafted to recognise enforced disappearance as a crime, instead of simplifying it as abduction.

Top officials of Dhaka Mass Transit Company Ltd (DMTCL), the implementing agency of the project, over 100 journalists, many engineers and workers gathered at the workshop at the depot in the capital's Diabari yesterday morning.

Around 11:00am, MAN Siddique, he MD of DMTCL, briefed reporters about the programme.

Apart from a train operator from the Japanese company, a resident engineer, and Project Manager ABM Arifur Rahman were inside the train. It was operated at 25km per hour on

the main tracks while 5km per hour at the station, Arifur said. The train was operated between Uttara North, Uttara Centre, Uttara South, and Pallabi.

The electric train can reach up to

"We successfully completed today's test run. It was a good start," Arifur told The Daily Star, adding that he and the experts did several technical checks during the test run.

When the train reached Pallabi station, hundreds of people were seen watching it from the streets and rooftops.

Munna Islam, a resident of Mirpur-12, went to the roof of a sixstory building to see the train.

"It will be really helpful to us. We heard it would take 20 to 25 minutes to reach Motijheel from Mirpur once the service begins," he told this correspondent.

Quader said construction of 19.02km, out of 20.10km viaducts, have already been done. Apart from the depot, the tracks have been installed on 17.24km

Wiring on 17.44km of overhead catenary system has also been done. Four of the 24 trains have reached Dhaka from Japan. The rest will reach gradually, he said.

Testing of the train inside the depot started on May 11, he said.

The overall performance tests may take six months and the integrity tests may continue for three months, he

After that, five months of trial runs without passengers will be carried out before starting commercial service, he added.

"Metro rail is no longer a dream, it is now a reality.'

The original implementation period for the fast-track project was from July 2012 to June 2024. But Prime Minister Sheik Hasina inaugurated the physical work in June, 2016.

She later directed that the metro services from Uttara-Agargaon be operational by 2019, and from Agargaon-Motijheel by 2020.

Failing to meet the deadline, the authorities in May 2019 said the services would be launched on December 16 this year to coincide with the golden jubilee of Bangladesh's independence. But construction work lost pace amid the pandemic, forcing the authorities to extend the deadline again, officials said.

The overall progress of the project was 44.12 percent in March last year, when the first cases of coronavirus were detected in the country. As of July this year, the project made 68.49 percent progress, falling short of what was anticipated at the outset.

Finance Minister AHM Mustafa Kamal, in his budget speech in June and MAN Siddique at a programme on July 30 hinted that partial operation of the metro rail service was likely to start in December next year.

There will be 16 stations between Uttara and Motijheel. Around 60,000 people will be able to commute every hour between Uttara and Motijheel in just about 40 minutes. The journey now takes about two hours on a regular

SURGE IN DENGUE CASES

'DSCC must take responsibility'

A group of Old Dhaka residents staged a demonstration in front of the Nagar Bhaban yesterday, calling out the Dhaka South City Corporation for failing to control Aedes mosquitoes in the area.

Under the banner of "Old Dhaka Residents", around 20 people formed a human chain around noon, holding a jar in hand that contained Aedes larvae.

Bangshal resident Alauddin, one of the organisers, said, "We're here to draw DSCC's attention because nothing else

When asked about the larvae in the jar, he told this correspondent they were collected from Kamrangirchar area.

"The city corporation is not taking experts' opinions regarding dengue-control seriously," said Mizanur Rahman, a resident of Jurain.

He said Jurain is particularly hard-hit by the mosquito-borne disease, as nine people from the area have died of dengue this month alone. "But there's still no effective initiative to destroy Aedes mosquitoes by SEE PAGE 4 COL 2

Nine rights orgs condemn repeated violence against Garo, Khasia communities

Nine rights organisations yesterday condemned and expressed concern over repeated incidents of violence on Garo and Khasia communities to evict them from their land in Moulvibazar's Kulaura upazila. Sammilito Samajik

Andolon, Nijera Manusher Ionno Bangladesh Foundation. Legal Aid and Services Trust (BLAST), Bangladesh Environment Association (Bela), for Association Land Reforms and Development (ALRD), Nagorik Uddog, Bangladesh Adivasi Forum and Bangladesh Paribesh Andolon (Bapa) raised the concern at a virtual press conference.

In a joint statement, they raised concern over the "vicious effort" to grab jhum and betel trees of the communities in the name of social forestry, which put the forest department's role into question

They also mentioned separate incidents on August 27, where three people from the Khasia community were attacked on their way back home, and five of the same community were assaulted.

On August 24, around 28,000 betel trees

Media's proactive role a must: speakers

Speakers at a dialogue yesterday stressed the need for media's proactive role in addressing different challenges in the country's labour migration sector.

Besides, they stressed the need for interministerial coordination as well as publicprivate partnership in different areas of labour migration to overcome the existing challenges.

Bangladesh Parliamentarians' Caucus on Migration and Development (BPCMD) and WARBE Development Foundation, with support from British Council's project "Prokas" and Swiss Agency for Development and Cooperation, organised the participatory dialogue between the caucus and media professionals at a city

The dialogue was addressed by present and former parliamentarians, media

professionals and migrant rights activists. Highlighting parliamentarians' role and BPCMD's activities for migration sector development, WARBE chairman Syed Saiful Haque said there is a need for promoting such activities in media to ensure migrant workers' rights.

He said recommendations generated from the dialogue could be helpful for the caucus for future activities.

In her keynote presentation, BPCMD secretary general Mahjabeen Khaled said advocacy and building awareness are among the major activities of the caucus.

Since its inception, the caucus has been working nationally, regionally and internationally with participation in global forums to uphold migrant workers' rights,

She stressed for future collaboration between the caucus and media professionals for migrants' wellbeing.

Mahjabeen also said a "one-stop service centre" under public-private partnership should be created in the country for providing all kinds of support to migrant

Reaz Ahmad, executive editor of Englishlanguage daily Dhaka Tribune, said human trafficking posed a big challenge to the migration sector whereas the caucus can play effective role in eliminating trafficking

BPCMD member and former lawmaker Newaz stressed the need for categorising recruiting agencies based on their performances to ensure safe migration.

Lawmaker and BPCMD member Ahsan Adelur Rahman said proper skills certification of Bangladeshi migrant workers, especially in the caregiving sector, can create job opportunities for them in the North American and European countries.

BPCMD member and reserved seat lawmaker Adiba Anjum Mita said arranging separate accommodation for female migrant workers in the host countries could prevent them from being exploited by their

Income of AL fell by 51pc in 2020

Says its report submitted to EC

The income of ruling Awami League in 2020 was about Tk 10.33 crore, 51 percent down from that of 2019, according to its audited financial statement submitted to the Election Commission yesterday.

However, AL's expenditures increased by Tk 1.73 crore last year, compared to that of the previous year, reports UNB. The party's total income was Tk 10,33,43,33 in 2020, which was over Tk 21 crore in 2019.

An AL team, led by its publicity and publication secretary Dr Abdus Sobhan Golap, MP, handed over the financial statement of the 2020 calendar year to EC Secretary Md Humayun Kabir Khandaker at Nirbachan Bhaban in the city.

Later, Golap told reporters that their party's income largely came from the subscriptions of its members, sale of nomination forms and donations from various individuals and organisations. In 2020, the income declined as it earned less from the sale of nomination forms, and there was no income from the triennial council of the party in 2019.

AL spent Tk 9,94,49,931 in the calendar year, Tk 1,73,48,356 more than it spent in 2019. The expenditures went up for conducting relief activities amid the Covid-19 pandemic, providing donations to party-nominated candidates in different elections and the rise in the expenses against different publications.

On Thursday, BNP submitted its 2020 financial statement before the EC. The party's income was Tk 1.23 crore and expenditure was Tk 1.75 crore in 2020. The additional expenditure was met from its previous fund.

As per the law, each registered political party is obliged to submit its financial statement of the previous calendar year by July 31. But this time, EC has extended the time till August 31 due to Covid-19.

Pori Moni's bail hearing tomorrow

The HC issued the rule following a criminal revision petition filed by Pori Moni, challenging the lower court's order. It also fixed September 1 for hearing on the rule.



Two major rivers devour more fresh areas in Manikganj, Tangail

STAR COUNTRY DESK

Erosion has taken a serious turn in Manikganj and Tangail as flood water continues increasing in the Padma and Jamuna rivers, devouring more fresh

Water level in the Jamuna, Dhaleshwari and Jhenai rivers was flowing above the danger level in Tangail.

Meanwhile, a government primary school and Azimnagar Union Health Centre in Harirampur upazila of Manikganj devoured in the river Padma.

Despite repeated reminder, Water Development Board (WDB) authorities said they could not stop the erosion due to strong current in the Padma, our Manikganj correspondent reports.

Azimnagar Union Parishad (UP) Chairman Billal Hossain said more than 70 percent of the health centre building was washed away by the strong current of the river around 11:00pm on Saturday and the remaining rest part went into the river womb yesterday morning.

The health centre was established in 2014 at a cost of Tk 81 lakh, the chairman said.

He said last year, when it was only 150 yards away from the river he wrote a letter to the higher authorities and also informed the Harirampur Upazila Nirbahi Officer (UNO) about the

"The UNO told me that he had informed the WDB authorities. But WDB authorities did not took any immediate initiative to protect the health centre from erosion," the UP chairman further

In the second week of this month, the Padma river washed away Sutalari Ramchandrapur Government Primary School in the upazila.

Moreover, over a hundred houses and vast croplands have already been devoured in the river, while many other institutions in the upazila are still facing serious erosion threat, locals said.

Manikganj WDB Executive Engineer Md Main Uddin said, "Due to strong currents in the river nothing can be done at present to prevent the erosion. Attempts have been made by dumping sand-filled geo-bags in some areas in the past, but we did not succeed."

A mosque is also on the verge of collapse and villagers were trying to save it by dumping soil bags, he said.

Ramjan Ali of Alipur village in Kalihati upazila said he is taking preparation to shift his dwelling house at other place once again.

OC of the PS Rajib Kumar said they arrested a man and were trying to arrest the main culprit.



Fodder crisis deepens in flood-hit Sirajganj

Two lakh animals affected in floodwater, 154 acres of grazing land submerged

Fodder crisis have become a double blow for the flood affected people of Sirajganj, one of the major dairy hubs in the country. The people who have become stranded due to the flood are worried over feeding their domestic animals as 154 acres of grazing land have submerged in the flood in the district.

Sural Jowardar, a poor farmer of village Bonni Dorota in Sadar upazila, has two cows, but flood waters entered his homestead couple of weeks ago, causing food crisis for his family and the animals.

"We can live without food or minimum food a day but we must feed our domestic animals. All the grazing land in the shoal has become submerged, and we have no money to buy fodder. So, I have shifted the cows to Berabari, another point of the shoal," Sural said.

"The water is increasing very fast and it is just a matter of time until Berbari point gets submerged as well, so I am worried to feed my animals," he added. Visiting Berabari area last week, this correspondent

found that many people were cutting grass in the shoal and a number of cows were grazing. People were coming from long distance in the part of the shoal to collect cattle feed. "Due to river erosion, we have lost our house and we

have taken shelter in the flood protection embankment along with three cows. I have been coming here every morning on my boat for collecting grass over the last couple of weeks." Sujon Miah of Berabari area said. Sujon will have nowhere else to go another if it (Berabari

shoal) gets submerged in flood water. Like them, most of the flood-hit people can hardly

manage fodder for their animals. According to Sirajganj District Livestock Officer (DLO) Dr Gourango Kumar Talukdar, Sirajganj is one of the major dairy hubs in the country having over 8.78 lakh cows, 3.5 lakh goats and over 1 lakh lambs.

Fodder crisis and crises of shelter are making animal farming costlier and immensely difficult due to the flood,

According to the DLO, around 1.08 lakh cows, 79 thousand goats and 20 thousand lambs have been affected by the flood in the last couple of weeks in Sadar, Chowhali, Kazipur and Shahzadpur upazila.

Around 154 acres of grazing land have also submerged in the four upazilas deepening fodder crisis, the DLO said, adding that the flood situation is worsening and more animals are likely to be affected in the district.

Flood-hit cattle farmers, however, said in addition to the fodder crisis, various animal diseases have also broken out. "We have already started vaccination to the cattle in the flood-hit areas for preventing diseases. We will take initiative to give fodder support to the affected farmers," The DLO added

Singapore now the most vaccinated country against Covid

Singapore has fully inoculated 80 percent of its 5.7 million people against COVID-19, according to officials, becoming the world's most vaccinated country and setting the stage for further easing of curbs. "We have crossed another milestone, where 80% of our population has received their full regimen of two doses," Singapore's Health Minister Ong Ye Kung said in a Facebook post yesterday. That gives the tiny city-state the world's highest rate of complete vaccinations, according to a tracker by the Reuters news agency. Other countries that have high vaccination rates include the United Arab Emirates, Uruguay and Chile, which have fully inoculated more than 70 percent of their populations.

Hurricane Ida grows to Category 4 storm

Hurricane Ida was upgraded to a Category 4 storm as it stayed on course to hit New Orleans with maximum sustained winds reaching 225 kilometers per hour, the US National Hurricane Center said yesterday. Ida was due to make landfall later yesterday, 16 years to the day Hurricane Katrina devastated the southern US city, flooding 80 percent of New Orleans, and leaving behind 1,800 casualties and billions of dollars in damage. Shops were boarded up and evacuations were underway Saturday, with officials warning residents to leave immediately or hunker down to ride out the storm.

Japan detects more Moderna vaccine contamination

Two Japanese regions yesterday suspended use of some Moderna Covid-19 shots after more cases of contamination were spotted, the local governments said. The move came a day after the Japanese health ministry said it was investigating the death of two men who received doses from other tainted Moderna batches -- though the cause of death is unknown. Okinawa prefecture said it had suspended use of Moderna shots at a major vaccination centre in the city of Naha, while Gunma prefecture, north of Tokyo, also said it had paused use of contaminated lots. The contamination in Okinawa and Gunma follows the suspension of 1.63 million doses across Japan on Thursday after the deaths of two men aged 30 and 38 in August following their second Moderna doses.

Israel strikes Gaza after fire balloons, border clashes

The Israeli air force attacked two Hamas sites in Gaza yesterday, the army said, after Gazans clashed with forces on the border and launched incendiary balloons into southern Israel. The latest escalation came as Israel and Egypt continued to relax restrictions on commerce and travel imposed on the Gaza Strip, largely cut off by both countries since the Islamist movement Hamas seized the Palestinian enclave in 2007. There were no reports from the Gaza Strip of any casualties caused by the Israeli strikes. Hamas and Israel then fought a devastating 11-day conflict in May, the worst between the two sides in years, which ended with an informal truce.

France, UK to push for Kabul safe zone

Says Macron ahead of today's UN meet, slams US for shifting focus and for abandoning allies

France and Britain will submit a resolution to an emergency United Nations meeting due today proposing a safe zone in Kabul to try and protect people trying to leave Afghanistan, French President Emmanuel Macron

"Our resolution proposal aims to define a safe zone in Kabul, under UN control, which would allow humanitarian operations to continue," Macron told French newspaper Le Journal du Dimanche (JDD) in an

"What we are trying to do is to be able to organise targeted humanitarian operations for evacuations that will not take place through the military airport in Kabul," he said.

threatened Afghans and getting them out of the country in the coming days or weeks. We will see if this can be done through the capital's civilian airport or through neighbouring countries".

He said such a deal would be a prerequisite for constructing a future western relationship with the Taliban.

Journal du Dimanche cited Macron as saying the UK backed the resolution, although London has not spoken publicly on any such efforts. A Whitehall source played down the French president's comments, saying the plans outlined in the interview were

It is not yet clear if Russia or China will accept the resolution, or see it as an incursion into Afghan sovereignty.

Turkey had been negotiating with the Taliban and the US to take military responsibility for the airport, but abandoned the plan after the Taliban said they would not accept Turkish troops remaining on its soil.

Macron made no attempt to hide

that the evacuation operation was incomplete. "We still have on our lists several thousand Afghans who we want to protect, who are at risk because of their commitments - magistrates, artists, intellectuals - but also many other people who have been reported by relatives and who we are told are at risk," he said.

The French president made a succession of pointed remarks towards had yet to accept many refugees from

Afghanistan on to American soil but was instead sending them to processing centres in countries as far afield as Uganda and Albania.

France, he said, "had fought for the last few years to avoid too brutal disengagement of the Americans or other allies in the region", adding that the withdrawal from Afghanistan could have a negative impact on Iraq and

TALIBAN TAKEOVER IN AFGHANISTAN

A 'blow' to Indian interests

The Taliban's return to power two weeks ago has caused a major diplomatic setback for India, with the South Asian giant now one of the region's "most disadvantaged" players, analysts say.

The sudden collapse of the Western-backed government in Kabul on August 15 precipitated an unprecedented exodus of diplomats, foreign aid workers and Afghans who worked for Western countries and feared reprisals from the Taliban.

India was among the nations that closed their missions in Afghanistan and brought back their staff and citizens. It is still trying to evacuate some citizens left behind amid chaotic conditions at the

New Delhi invested \$3b in development projects, offered scholarships to Afghan students, and helped construct the parliament building at a cost of \$90m, earning huge goodwill in the country of 38 million.

Last year, during the 2020 Afghanistan Conference, India's External Affairs Minister Subrahmanyam Jaishankar said no part of Afghanistan was "untouched" by the "400-plus projects" that India had undertaken in all 34 provinces of the country.

Bilateral trade between the two countries had also increased significantly over the years and reached \$1.5bn in 2019-2020.

India, which sees the Taliban as a proxy of its archrival Pakistan, had maintained close ties with the Northern Alliance, which defeated the Afghan armed group in 2001 with the help of the US-led Nato forces.

"India has gone from being Kabul's closest regional partner to one of the region's most disadvantaged players in an Afghanistan context," said Michael Kugelman, deputy director of the Asia programme at the US-based Wilson Center.

Echoing similar sentiments, Happymon Jacob from New Delhi's Jawaharlal Nehru University, said: "I think India seems to be out of the game in Afghanistan."

Some foreign policy mandarins have pointed out India was too late in reaching out to the Taliban to secure its interests, as reports emerged that Indian officials met the Taliban in the Qatari capital, Doha, in June. The Taliban established a political office in Doha in 2013.

Kugelman said two factors went against New Delhi: "India's reluctance to reach out to the Taliban until it was too late, and an ill-fated Afghan reconciliation process with a deep Pakistani footprint, owing to its ties to the Taliban.

"One deprived India of potential leverage, and the other put New Delhi at a geopolitical disadvantage," Kugelman told Al Jazeera.

"Afghanistan will now have a pro-Pakistan government, and this will give Pakistan and India's other key rival, China – Pakistan's close friend – an opportunity to play more of a role in Afghanistan,

Yemen biggest airbase kills 30

Strikes on Yemen's largest airbase yesterday killed at least 30 pro-government troops and wounded t least 56 more, said medical and loyalist sources who blamed Iran-backed Huthi rebels for the attack.

The strikes were carried out on Al-Anad airbase, some 60 kilometres north of Yemen's second city Aden in the south of the conflict-riven country.

The airbase served as the headquarters for US troops overseeing a long-running drone war against al-Qaeda until they pulled out in March 2015, shortly before the Huthis overran the area. An armed forces

spokesman accused Yemen's Shia Huthi rebels of carrying out missile and drone strikes on the facility.

'Asleep on watch'

UK govt slammed over Afghan exit as hundreds left behind

Prime Minister Boris Johnson defended Britain's airlift from Kabul yesterday following growing criticism that ministers had been "asleep on watch", potentially leaving thousands of eligible Afghans behind in the country. Britain, like the United States, has been criticised for

failing to predict how quickly the Afghan government would fall, meaning it had not made sufficient preparation for the chaos that would follow when the Taliban seized power. Britain's last military flight left Kabul late yesterday, ending

a chaotic two weeks in which soldiers helped to evacuate more than 15,000 people from the crowds who descended on the capital's airport, desperate to flee the country. Richard Dannatt, former chief of staff of the British

army, said the government now needed an inquiry to establish why it had been so ill-prepared for the rapid turn of events. "It is unfathomable why it would appear that the government was asleep on watch," he told Times Radio. "We've had this chaotic extraction, we should have done better, we could have done better.

The Observer newspaper said thousands of emails sent to the Foreign Office by lawmakers and charities, detailing cases of Afghan citizens who needed help to leave, had not been read.

A Foreign Office spokesperson said it had worked tirelessly to evacuate people but it had always cautioned that it would not be able to help everyone.

Britain's defence minister, Ben Wallace, predicted last week that time had run out to evacuate around 1,000 Afghans who were eligible to come to Britain, including former staff to the UK.

Johnson said however that while Britain would not have wished to leave Afghanistan in the way it did, the armed forces should still be proud of their achievements. Speaking to the 150,000 men and women who

completed a tour of Afghanistan, and the families of the 457 who died there, Johnson said they had succeeded in keeping Britain safe and in improving the livelihoods for Afghan locals.

Early Barristers from East Bengal

The failed Indian rebellion of 1857 also led to the 'demise' of the rapacious East India Company (EIC) in 1858, when political power was transferred to the crown-in-parliament in England with the founding of 'The British Empire in India' (1858-1947), popularly known today as the British Raj. A deceptive calm settled over the restive land, following savage Company (EIC) reprisals with the fall of rebel held Mughal Delhi, Lucknow and elsewhere in upper India. As colonial India gradually came under the firm vice-grip of the inglorious British Raj, Queen Victoria (reign: 1837-1901) was proclaimed as 'Kaiser-i-Hind' or Empress of India in 1877, in the plains of Delhi in a grand durbar held under the aegis of the Earl of Lytton, the Viceroy and Governor-General of British India.

Meanwhile, as life returned to normal, educational institutions at the college and university level in the Bengal Presidency, experienced an efflorescence of academic excellence achieved by Indian students profoundly impacted by the Bengal Renaissance, necessitating further advanced education in the fields of the sciences, liberal arts and law through enrollment in institutions of higher learning in Britain. In the meantime, the opportune opening of the Suez Canal in 1869 considerably reduced the distance, time and cost of travelling between India and Britain. Also, the rapid modernization of steamship navigation via the high seas, encouraged more aspiring Indian students to travel in relative comfort to attend prestigious colleges and universities in Britain, thereby obtaining higher degrees to qualify in the professions of law, civil service (ICS), medical science, engineering, financial management and in other areas of human endeavor. Thus, the Indian Barristers in particular, started to return to India adequately 'armed' with newly acquired legal skills, determined to face the forbidding challenges of a colonial society with boldness, hitherto unknown. Gradually, a new era of political consciousness and nationalism dawned in British India in which the Indian Barristers played a leading role, many of whom entered politics as ardent nationalists, devout revolutionaries and prominent politicians to challenge the British Raj as formidable opponents. The rest is history.

This essay is dedicated to the early Barristers from East Bengal, the 'Bhumiputra' or 'son of the soil' who qualified for the prestigious legal profession in those difficult days by becoming successful trailblazers for future generations of aspiring Barristers, as they followed in their footsteps during the colonial era. The period covered here is from 1866 to 1920. It began when Monomohan Ghose (1844-1896) from historic Bikrampur of Dhaka, was called to the Bar in London in 1866. While Gnanedramohan Tagore (1826-1890) from the Pathuriaghata branch of the Tagore family in Calcutta was the first Indian and Asian to qualify as a Barrister in 1862, Monomohan Ghose became the first 'practicing' Indian Barrister by joining the Calcutta High Court in 1886.

The following is a list of early Indian Barristers presumably from the Bengal presidency, who were mandatorily required to belong to one of the four learned Societies, that is, the 'Inns of Court' namely: Lincoln's Inn, Gray's Inn, Inner Temple and Middle Temple in London, England to qualify at the Bar. Provided against the names for most of the following Barristers are the dates, when they were called to the Bar. Only the identifiable Barristers from East Bengal are shown within the parentheses of (EB): Monomohan Ghose - 6 June, 1866 (EB); Michael Madhushudan Dutt- 17 Nov, 1866 (EB); Womesh Chandra Bonnerjee (also Umesh Chandra Banerjee) - 11 June, 1867; Syed Ahmed Ali - 26 Jan, 1869; Tarokanath Palit-10 June, 1870; Romesh Chandra Dutt -6 June, 1871; Biharilal Gupta- 6 June, 1871; Rajnarain Mitra- 6 June, 1872; Syed Asghar Ali Khan-11 Jan, 1873; Syed Ameer Ali – 27 Jan, 1873; Krishnamohan Chatterjee- 27 Jan, 1873; Lalmohan Ghose 7 June, 1873; Charu Chandra Dutt-24 Jan, 1874; R. Bengal, some Barristers with Hindu
Bengali names as mentioned above from the
Bengal presidency may have hailed from West
Bengal, too. It was not possible to come by
detailed information on them. Moreover, it is
very intriguing to note that in the year 1880
alone nine Indians qualified as Barristers, a
record number for a particular year of whom
curiously seven were Muslims and only two
Hindus. This is rather unique for the times
and need further research to learn as to how
so many Indian Muslims managed to qualify
at the Bar in 1880, during the heyday of the
Victorian era?

Now a brief mention of the identifiable early Barristers from East Bengal (EB) for the stated period. Monomohan Ghose, was born in historic Bikrampur in Bangladesh. He joined Lincoln's Inn and was called to the Bar in 1866. As already mentioned, he was the first 'practicing' Indian Barrister of the Calcutta High Court. Michael Madusudan Dutt hailed from the zamindar family of Sagarderi, in Jessore district. Although, a non-practicing Barrister for most of his active life, he is better remembered as a great poet, writer and playwright/dramatist of the Bengali literary heritage. A.F.M. Abdur Rahman was the eldest son of the eminent Nawab Abdul Latif of Boalmari, Fardipur. He practiced at the Calcutta High Court and was later invested with the title of Nawab. Deshbandhu C. R. Das needs no introduction, particularly in Bengal. He hailed from Bikrampur, Dhaka. He remains a larger than life illustrious figure as an ardent Indian nationalistrevolutionary, politician and a formidable lawyer. Abdul/Abdur Rasul hailed from the village of Guniauk formerly in Comilla now in the Brahmanbaria district. He was a highprofile secular Indian nationalist lawyer of the Calcutta High Court who vehemently opposed Curzon's Partition of Bengal in 1905. He had a distinguished academic record from England. He had an English wife. Syed Motahar Hossain, was born in the Shaistabad zamindar family of Barisal. Very little is known about him beyond the fact that he was a Barrister and the son of Nawab Syed Moazzem Hossain (1810-1909) of Shaistabad, Barisal. He died at a relatively young age. A.S.M. Latifur Rahman was the son of the Calcutta based Barrister Nawab A. F.M. Abdur Rahman of Boalmari , Faridpur. He was a judge at the 'Court of Small Causes' in Calcutta. Ashraf Ali Khan Chowdhury hailed from a notable zamindar family known as the 'Khan Chowdhurys' of Natore, Rajshahi. He practiced at the Calcutta High Court. Deshpriya Jatindra Mohan Sengupta of village Barama, Chittagong, was a Cambridge educated Barrister and a devout Indian nationalist revolutionary and a lawyer-politician in British India. He along with his devoted English wife, Nellie Sengupta, also a politician became household names in Bengal for their diehard nationalist activities. Jatindra died in a British jail in Ranchi due to serious health problems as a result of frequent incarcerations, for his relentless political activism against British rule. Sir Khawaja M. Nazimuddin was a member of the Dhaka Nawab family. He attended Cambridge University and was called to the Bar from

Middle Temple in 1920. He became a notable

politician and held important public offices in

Bengal during the British Raj and more so, after the partition of 1947, in Pakistan.

I take this opportunity to highlight the story of a remarkable zamindar family from Haripur, now in the Chatmohar Upazila, in the district of Pabna, Bangladesh. This particular family was not only noteworthy for being prominent landholders, but more so because of their meritorious scholastic achievements and contribution in the fields of law, Bengali literature and cultural heritage. They were closely associated by marriage and cultural ties to the fabled Tagore's of Jorashanko, Calcutta. We begin with Durgadas Chaudhuri, a notable Brahmin zamindar of Pabna and father of the illustrious 'Chaudhuri brothers.' He married Sukumari Debi a sister of Rabindranath. It is alleged that Dugadas once paid a courtesy

themselves by producing 'five brothers' (siblings) of the same family who became contemporary Barristers between the years 1886-1904 in the Bengal presidency, but also held that enviable distinction in entire British India during that period! We should take note of this exemplary feat of achievement and take legitimate pride in it as Bangladeshis.

Barrister Sir Ashutosh Chaudhuri (1859-1924) of Pabna, East Bengal, was a lawyer of the Calcutta High Court from 1912-1920. He is readily confused with his namesake, Sir Ashutosh Mukherjee (1864-1924) of Hooghly, West Bengal, another stalwart of Bengal who although not a Barrister was nonetheless, a famous lawyer of the Calcutta High Court and Vice Chancellor of Calcutta University. Incidentally, both the Ashutoshes died in

call on the English Collector of Pabna, who thought he had come to petition him for a job for his son. Thus, humiliated Durgadas resolved to send his older sons to England to become Barristers. It was the only elite profession in British India where an Indian Barrister could enjoy professional autonomy while in service, and one that did not require an Indian to kowtow to the colonial administration like in the other services, including the prestigious Imperial/Indian Civil Service (ICS). Durgadas and Sukumari had seven sons, five of whom eventually became barristers. They were: Barrister Sir Ashutosh Chaudhuri (1859-1924); Barrister Jogesh Chandra Chaudhuri; Barrister Kumudnath Chaudhuri (1862-1933), Barrister Pramathanath Chaudhuri (1868-1946), Capt. Manamatha Nath Chaudhuri, Dr. Suhrid Nath Chaudhuri and Barrister Amiya Nath Chaudhuri (1868-1946). The illustrious Chaudhuri's of Pabna from East Bengal (Bangladesh), not only distinguished

1924, adding to the prevailing confusion. Sir Ashutosh Chaudhuri, was educated at the Presidency College, Calcutta and at St. John's College, Cambridge, England from where he took his Tripos in 1885, and was called to the Bar in 1886. He married Probita Debi, daughter of Hemendranath Tagore the brother of Rabindranath. Sir Ashutosh was knighted in 1920. He was the Founder Secretary, of the Bengal Landholder's Association a formidable guild during the Raj. For a while he was also a member of the Bengal Legislative Association, the deputy chair of the Bangiya Sahitya Parishad and president of the Calcutta Club in 1915. His younger brother, Barrister Kumudnath Chaudhuri (1862-1933), was a renowned big game hunter who lost his life to a fatal tiger attack during a hunt in the forest of central India. Another younger brother of Sir Ashutosh was Barrister Jogesh Chandra Chaudhuri who graduated from Oxford and qualified at the Bar in 1895. He married Sarasibala the daughter

of the famous Indian nationalist, founding member of the Indian National Congress and a leading politician Sir Surendranath Bannerjee (1848-1925). Another sibling of Sir Ashutosh was Barrister Pramathanath Chaudhuri (1868-1946), popularly known as Pramatha Chaudhuri whose nom-de-plume was 'Birbal'. He was a major influential writer of Bengali literature of the 20th century, and a nephew of Rabindranath who was his maternal uncle. Pramatha was married to Indira Debi daughter of Satyendranath Tagore (1842-1923), the first Indian ICS (1863) and elder brother of Rabindranath. He received his MA in English from the Presidency College, Calcutta and stood first class first. He was called to the Bar from Inner Temple, London, in 1896. As a Barrister, he practiced at the Calcutta High Court. However, he did not take the legal profession seriously, since he was more inclined towards the pursuit of Bengali literature which was of foremost interest to him and his actual forte. His devotion and excellence as an eminent Bengali litterateur made him a renowned figure during the last forty years of his literary life.

The last of the distinguished Chaudhuri brothers to become a Barrister was, Amiya Nath Chaudhuri, popularly known as A. N. Chaudhuri. He received a law degree from Cambridge and was called to the Bar in 1904. While his eldest brother, Sir Ashutosh Chaudhuri, the well-known Barrister was a staunch nationalist, Amiya on the other hand was an inveterate Anglophile who along with his westernized spouse loved the excitement and gaiety of high life. They were very popular socialites of the early 20th century glitterati society of colonial Calcutta, thereby belonging to those exclusive social circles where European businessmen and British officials dominated. Amiya was married to Millie, daughter of the eminent Barrister Sir Womesh Chandra Bonnerjee (1844-1906), who was the first president of the Indian National Congress. Millie Chaudhuri (nee Bonnerjee) had the rare distinction in Calcutta of her time for being educated at the Sorbonne in Paris. Their son, Jayanto Nath Chaudhuri (1908-1982), passed out from the renowned Royal Military Academy at Sandhurst, England, where Ayub Khan (1907-1974) later on president of Pakistan was his batchmate. Both Jayanto and Ayub, became King's Commissioned Indian Officers (KCIOs) in 1928, and joined the British Indian Army. Later on, Jayanto alias 'Mucchu' went on to become the first Bengali and the sixth Indian C-in-C of the Indian Army (1963-1966) in independent India. It is somewhat ironic that both former Sandhurst graduates who had served together in the British Indian army, finally fought against each other to a standstill in the Indo-Pak war of 1965, Ayub Khan as the Pakistani president and thus the C-in-C of his armed forces and General Jayanto Nath Chaudhuri OBE, as the C-in-C of the Indian Army.

It should also be recalled here, that there were two other extraordinary families from East Bengal (Bangladesh) in British India, who had the enviable distinction for having produced three brothers from each family, who became contemporary barristers. They were the sons of Durga Mohan Das who hailed from a wellknown Baidya family of Bikrampur, Dhaka. His Barrister sons were: Satyaranjan, Satishranjan and Sudhiranjan. Likewise, three sons of Durga Mohan's younger brother Bhuban Mohan Das, who also became Barristers were: Chittaranian (Deshbandhu), Prafularanjan and Basanta Kumar. Barrister Atul Prasad Sen (1871-1934) the phenomenal Bengali composer, lyricist, singer and litterateur also hailed from Bikrampur. Born in old Dhaka, he was closely related to the Das family and was called to the Bar in England in 1895.

This article should be read in the context of the times. It is explicitly written with our younger generation in mind for dissemination of information regarding a long-forgotten chapter in the early days of higher education particularly in law, studied in England by adventurous Indian students during the mid-19th and early 20th centuries. I hope that this modest effort will imbue future researchers to delve into newer sources of information on this subject and write more substantially, by way of documentation and historical narration. So much remains to be known about the difficult path traversed by the early pioneering Barristers from East Bengal, who qualified by sheer dint of merit against all odds to become valued members of a once exclusive guild and coveted legal profession. It should be recalled here with gratitude that in an all India basis, it was ultimately the Bengali Barristers who played a pivotal role in humbling the British Raj, thereby bringing it down!

Through this essay, I would like to make a fervent appeal to the Department of Archeology, Ministry of Cultural Affairs (Bangladesh), the District Council of Pabna and the Pabna Bar Association to take urgent steps to preserve the remnants of the historic Chaudhuri zamindar house in Haripur, Pabna, by initiating a wellcoordinated action plan to reclaim the lost property. A complete survey should also be undertaken forthwith to demarcate the property and renovate the zamindar house with the assistance of the Department of Archeology. A befitting museum and library should also be set up in the memory of a great son of the soil, the outstanding Bengali litterateur Pramatha Chaudhuri. It will be a laudable step towards the preservation of our cultural heritage and, thereby facilitate tourism.

Stimulus package disbursers demanding bribes

A leopard never changes its spots

T is a pity that when the government is working under tremendous economic strain caused by the pandemic, with an economic downturn becoming an inevitability, its incentive programme—to rescue various business enterprises in the service and manufacturing sectors with loans on easy terms—is being hampered by the disbursers asking for bribes.

Apart from the serious impact of the pandemic on the health sector, it has had the most deleterious consequences on the county's economy. For its part, the government has taken up a scheme of Tk 1,28,000 crores worth of stimulus packages to salvage firms affected by the pandemic. But a survey of around 500 such firms has now revealed that a good percentage of those cannot obtain loan without greasing the palm of the people entrusted with distributing the loans. The survey, done by the South Asian Network on Economic Modeling (SANEM), shows that paying bribes (not "reports") has become like a precondition for getting the application processed and receiving the money. And this involves bank employees and various public agencies assigned with the task of processing and disbursing the loans.

The pandemic, unfortunately, has brought a windfall situation to certain people who are exploiting the situation to mint money. And that includes a section of corrupt local leaders who defalcated funds and misappropriated relief goods allotted by the government. The same culture we see now in case of providing relief in the form of monetary incentives, where 12 percent of firms surveyed complained of bribery and even 29 percent of firms who did not get the incentives complained of the same. It is a sad reflection of the character of the society, where the bribe culture induces certain people to exploit the plight of the public. The small and medium firms and non-exporting enterprises have no other alternatives but to succumb to the demands of the immoral public servants, to keep their nose above water.

The long and short of it is that, if the current trend continues, and the affected business enterprises have to cough up money to get a slice of the incentive package, a good part of the stimulus packages would go into the pockets of the corrupt officials. Consequently, not all those targeted for the package will get the funds, and a very well-intentioned programme of the government will be ultimately put paid to. SANEM research found that 67 percent of the firms had not received stimulus funds. A good many of them may have to close down if they don't receive the funds soon, which cannot be good at all for our economic recovery.

Here is a situation where an important government plan, to aid the floundering business enterprises, runs the risk of being scuttled by unscrupulous people. Only strict monitoring, transparency, and investigation and punishment for corrupt people associated with the process of disbursement, can see the programme through

Poor showing of a project on waterway accidents

Project managers, suppliers must be held accountable


T is disappointing to know the dismal rate of progress of a Bangladesh Fire Service and Civil Defence project that, if implemented properly, would have expanded its diving unit. As per the findings of the Implementation Monitoring and Evaluation Division (IMED) of the ministry of planning, although the project deadline of three years has passed this year, it has seen only 15 percent progress since its initiation in 2018. The goal of the Tk 165.19 crore project was to equip and train divers with modern rescue equipment in a bid to reduce the country's high rate of deaths by drowning (around 18,000 per year). But not only have the majority of the equipment not been acquired, but those that are there are also sitting idle in the project director's office, with their

warranties nearing expiration. Moreover, due to the "availability" of some of the equipment (such as tugboats, jetties, and pontoons), 68 percent of the estimated Development Project Proposal (DPP) was excluded while "only 19.97 percent of purchase packages were placed for tender" until June of this year. According to our report, there are only 50 divers countrywide. On top of that, the project director claims that the finance ministry refused their proposal to appoint six divers in each district, so they are planning on downsizing their ask to at least three divers per district and resubmitting the proposal. Reportedly, though the revised DPP stood at Tk 63.4 crore after the exclusions, and only 16 percent of the expected capital expenditure was fulfilled, the allocated budget for transportation and office equipment was already spent.

So, we are left to wonder why such major irregularities and delays of large-scale government projects are allowed, unopposed and unpunished. Frankly, the way this vital, life-saving project has been handled from the start leaves a lot to be desired. The excuse of pandemic-induced disruptions in regular activities is unacceptable when it comes to projects and initiatives that have a direct bearing on matters of life and death. The divers are a vital part of any rescue effort in case of waterway accidents, and the authorities must ensure there are enough of them in case of an accident and that they are equipped properly to do their job. Even this past Friday, at least 22 people (including nine children) died in a boat capsizing incident in Brahmanbaria's Laishka Beel, which shows, once again, the importance of reinforcing the diving unit.

If the proposal to extend the project duration by a year is approved by the planning ministry, we would urge the fire service and project managers to use the time effectively by not only recruiting and training an appropriate number of divers, but also to use any existing or to-be-acquired equipment to improve their response time when waterway accidents occur.

Obligations, indifference and accountability

birthday of Mahfuzur Rahman's—a Chhatra Dal leader of Bangshal—son. Mahfuz promised his son that he would bring him flowers on the

occasion and went out to buy flowers in Shahbagh. Since then Mahfuz has not returned. Subsequently, his family learned that he was picked up from the floral market by a group of men in plain clothes. Mahfuz remains traceless to this day. Every year Mahfuz's two children ioin their mother Nilufa in commemoration of the International Day of the Victims of Enforced Disappearance on August 30.

On this day, scores of families of the victims of enforced disappearances get together to share their grief, but also their concerns at the indifference of the State. They exchange experiences of dealing with the state agencies. They raise their voice in unison demanding the return of their loved ones and for a credible investigation into every case of enforced disappearance, justice for the gross wrongdoings and punishment for the perpetrators. They draw support and strength from each other and from those who join them in solidarity.

The demands articulated by the families of the victims are not frivolous or outlandish. They should not be deemed as clamouring for favour or special treatment. The claims and assertions by the families are supported by the supreme law of the land—the Constitutionand by the plethora of international instruments that Bangladesh is a state

The right to life and liberty tops the list of basic human rights. In addition, everyone has the right to an effective remedy by the competent national tribunals for acts violating the fundamental rights granted by the Constitution or by law.

Article 31 of the Constitution unequivocally stipulates: "To enjoy the protection of the law, and to be treated in accordance with law, and only in accordance with law, is the inalienable right of every citizen". It states: "in particular no action detrimental to the life, liberty, body, reputation or property of any person shall be taken except in accordance with law" (emphasis added). This position is reinforced by Article 32: "No person shall be deprived of life or personal liberty save in accordance with law." Article 33 (1) specifies that no one shall be detained in custody without being informed, as soon as may be, of the grounds for such arrest and nor shall he be denied access to legal counsel of his choice. The sub-para (2) further states that a person "arrested and detained in custody shall be produced before the nearest magistrate within a period of twenty-four hours of such arrest" and that "no person shall be detained in custody beyond the said period without the authority of a magistrate." These constitutional provisions ensuring protection of a person have been further augmented by Bangladesh ratifying a number of international instruments.

The right to life is often claimed to be the most important of all human rights because life is the precondition for the exercise of any other right. It is enshrined in Article 3 of the Universal Declaration of Human Rights (1948) and in all major general human rights conventions. Article 6 of the International Covenant on Civil and Political Rights recognises the inherent right of every person to life, adding that this right "shall be protected by law" and that "no one shall be arbitrarily deprived of life".

Moreover, Bangladesh ratified the Convention Against Torture (CAT) over 20 years ago but it refrained from submitting yearly reports for 19 years without any explanation. Enforced disappearance coupled with torture have been a common feature in almost all cases. Physical and mental torture leaves an enduring effect on the victims for the rest of their lives and most who go through them never speak up and reveal what happened to them. A common story tied with ransom flies in the air.

A close scrutiny of the experiences of alleged enforced disappearances and state responses to those amply reveal that state authorities have time and again

Procedure amended by the High Court division in 2003, later affirmed by the Appellate Division in April 2016. Fifteenpoint directives were issued by the apex court in that judgment, which are the most ignored provisions of the law as far as it relates to the personal liberty of a citizen. In addition, in some cases, family members of the victims have claimed they were arbitrarily arrested by some agencies which do not even have the authority to arrest a civilian in any circumstances.

In some cases, deeply distraught family members were assured that their loved ones were being taken for questioning only to be returned shortly. The promise remained unfulfilled and the families' wait became perennial. Some were even threatened with dire consequences if they speak to the press about it. In almost all cases, distressed families are shocked when local police stations and detention. Most fail to secure any information even after running from post to pillar.



not lived upto the above cited Articles of the Constitution. There is a great degree of commonality in the narratives of the families of victims. Most are relatively young active citizens with interest in politics, many belonged to opposition parties or their student, labour or youth wings, while others are trade unionists, journalists or social mobilisers and influencers. Most participated in political or civic actions and are committed to bringing about change as per their own ideological and political moorings.

Only a handful of them have prior police records; others are free from the "blemish". Most were picked up either from their homes (often in the wee hours of the day) or from public places by persons claiming to be members of law enforcement agencies. In some instances, they were in plainclothes; in others, they were in uniforms or donning jackets clearly identifying a particular branch of law enforcement, carrying walkie talkies. While some were taken in vehicles bearing the insignia of law enforcement agencies, in most cases, they were ferried away in white microbuses with tinted glasses. No single case was reported in which the captors produced any warrant

It is presumed that if a law enforcing agency is making an arrest, then they would be doing it under the provisions of Section 54 of the Code of Criminal

They are surprised at the reticence of law enforcement officials to register a General Diary, an otherwise routine practice. Those with social capital also have little success. Their friends and family members with access to the corridors of power can bring them little help. Days, weeks, months, and years pass by, they receive no update on the complaints they had registered. In some instances, family members are discouraged, even threatened, for demanding updated information.

In the meantime, in the absence of the only earning member, some families plunge into deep poverty, more so as the sources of loans dry up. Their children's education suffers and girl children are married off early. Young wives pass months and years without the company of their partners and often have to live in hardship at the mercy of extended families. The absence of documentation about the status of the disappeared makes it difficult for them to claim dues and entitlements from employers, banks, and insurance companies and settle family property issues.

In a few instances, after days, weeks or months, they are either released or their corpses with marks of injury are found in ditches or by the roadside, floating in canals or rivers. In other cases, they are found wandering in unlikely places such as border areas in distraught or

disoriented conditions. In quite a few instances, they are shown arrested and produced before the court without anyone accounting for their whereabouts in the interim. A handful of those who are lucky to return maintain total silence about the experience they endured in captivity.

For more than a decade, the government of Bangladesh has been summarily dismissive of the claims of enforced disappearances made by the families, the media, rights groups and international organisations, and even by the National Human Rights Commission. In 2019 in a reaction to an OMCT-Odhikar report, the Home Minister claimed that "not even a single case" of enforced disappearance had occurred. Other senior functionaries viewed it as a "smear campaign" by vested quarters. The government says the so-called disappeared actually go into hiding of their own accord to "avoid arrest" or detection "after committing irregularities in business or engaging in extra-marital affairs". Thus, there is an absolute denial on the part of the Bangladeshi state.

The government argues that many of those who disappeared were later "shown arrested" or eventually "reappeared", claiming that these nullify the claims of enforced disappearance. However, the eventual release, "shown arrested" or reappearance of individuals in no way negate the fact that the period of their detention or abduction by the state or other actors constitutes enforced disappearance. There is no time limit, no matter how short, for an enforced disappearance to occur.

Enforced disappearance is an anathema to the rule of law. The Bangladesh state's position on enforced disappearance is belied by the lived experiences of hundreds of families of the disappeared. Such denial is an affront to the deceased whom the state had failed to protect as required under the law. If indeed the victims are hiding to cover their misdeeds, is it not incumbent on the state to trace them as per the law? Also, isn't the onus on the authorities to find out or explain where those individuals were during the period when they were reported involuntarily disappeared and their "reappearance" or being "shown arrested" by the police?

The reticence of the authorities to register complaints and their dogged refusal to investigate only reinforce the perception in some quarters about the state's indifference to the practice. While it may be unfair to suggest enforced disappearance is state-sanctioned, denial and refusal to hold anyone to account only encourage the rogue elements to further perpetuate the practice, thereby corroding people's trust in law enforcement. Perhaps the time has come for the institutions to protect citizens' constitutionally guaranteed rights (such as the civil administration and the higher judiciary), robustly safeguard their mandated tasks and resist and rid extra-constitutional encroachment in their domains. The sooner that is done and the sooner the policymakers acknowledge this, the better it is for upholding the dignity of those institutions to ensure good governance and the rule of law and also for the much-touted image of the country.

The Afghan government and its future



sudden collapse of the US-backed Ghani regime in Afghanistan and the scenes of the evacuation of American citizens at Kabul Airport brought back some

deep-buried memories of mine from another era. When Saigon fell and the last of the American troops withdrew from Vietnam on April 31, 1975, I was a Masters' student at Dhaka University watching the developing scenario in Southeast Asia with strongly-held convictions. We were celebrating the collapse of the puppet government in South Vietnam. Last week, after more than 46 years, Americans were once again faced with another defeat in Kabul, and the chaos at the airport was for many of us a "deja vu" moment.

I was joyful in 1975, but I cannot say the same this time. The scenes at Kabul Airport have been a painful reminder to the Americans that military power shifts with the winds and that the costs of armed conflicts are borne by ordinary people. In this particular instance, American taxpayers and the poor ordinary Afghanis will both bear the price for years to come.

Columbia University, discusses in detail the financial cost, i.e. the dollar cost for the US Treasury, and the real cost, the time, money, and lives lost during the two decades of NATO adventure in Afghanistan. In his article, "Blood in the Sand", Sachs is very critical of the American mindset which triggered the

invasion of Afghanistan and the policy decisions made in Washington that kept US forces there for over two decades.

According to a recent report by the Special Inspector General for Afghanistan Reconstruction (SIGAR), the US invested roughly USD 946 billion between 2001 and 2021. While SIGAR is a non-partisan watchdog created by Congress, this number provided in the report is an underestimate by all accounts. That's not the point. It is a mystery why Sachs considers the USD 1 trillion that was poured into Afghanistan an "investment", but more on that later. He must nonetheless be given credit for deconstructing the numbers and reporting that only USD 21 billion was utilised for "economic support". However, much of that money was pocketed by the corrupt officials and the warlords in Afghanistan and not spent for development on the ground, because the programmes were meant to "support counterterrorism; bolster national economies; and assist in the development of effective, accessible, and independent legal systems."

I have taken a very personal interest in the comings and goings in Kabul since I was a child growing up in East Pakistan. In an op-ed for this newspaper earlier this year, I wrote about the dangers that might bedevil the American withdrawal from Afghanistan which was planned for August 31 ("What path lies ahead for Afghanistan?" The Daily Star, March 21, 2021). Like many observers who were in the same boat as me, who had their anxieties about the shape of things to come after the US withdrawal, I harboured misgivings, and mixed feelings of hope and frustration at the uncertainty looming ahead for the Afghan people. Since the Soviet invasion in 1979, this peace-loving nation had seen nothing but conflicts and were manipulated to be the stage for the "endless wars" mentioned by President Biden. "Unfortunately, the proud nation of Afghanistan suffered and paid a hefty price for this tug of war between powerful nations and their surrogates," as I said earlier

Now that Afghanistan is in the hands of the Taliban, who were in power before, until 2001, the work of nationbuilding can start. Fortunately, the city of Kabul and other regional urban centres appear to have been spared

the ravages that befell many other population centres in Syria, Libya, and Yemen. Unfortunately, the country is losing its intelligentsia and technocrats who are understandably trying to get out before things get worse for those who worked with the US-led coalition the last two decades. Even the previous governor of the central bank, Ajmal Ahmady, left with a crowd at the back of a C-17 transport aircraft.

The central administration has collapsed and most ministers have escaped Kabul. Because banks and money exchanges remain closed, the bazaars and the economy have slowly ground to a halt. ATMs have reduced the daily withdrawal limits. To compound the problems, prices of basic commodities such as flour, cooking oil, and petrol have risen by as much as 50 percent.

As of now, the Taliban government cannot access almost all of the Afghanistan central bank's USD 9 billion on Monday, to replace Ahmady at the

rival political forces, and form a national government. A former finance minister, Omar Zakhilwal, who recently returned to Kabul, is reported to be working with the Taliban on a power-sharing arrangement. "We are working in tandem with the Taliban to bring a normal face to Kabul again: reopening of banks, of the offices, of the ministries.

In the interim, Zakhilwal has suggested that the Taliban would do well to promote existing civil servants to replace senior officials who fled the country. This would be more "helpful than bringing in new people who don't know, and whom the international community doesn't know". It is not known if the Taliban will listen. One of its key appointments announced

central bank, has been criticised by financial analysts. While it had the choice of picking a senior-level civil servant for the position, the Taliban appointed Hajji Mohammad Idris, a senior member of the group, as the new governor of Da Afghanistan Bank, the central bank.

There is some speculation whether the USA will fall back into a scorched earth policy after the evacuation from Kabul airport is completed. US money transfer services have suspended payments into Afghanistan, and American banks are more closely scrutinising transactions with Afghan counterparts, as they await clarity on whether US sanctions against the Taliban apply to the new government. Remittances that average over USD 800 million annually have played a major role over the last five years.

All this will cause a major short-term crisis for the Taliban-led government. If the sanctions that are in force against the Taliban are applied more broadly to all business dealings with the new government, Afghanistan could join North Korea and Iran as pariahs in the international financial system.

In the longer term, the new government will need to address widespread corruption and reduce its dependence on foreign aid. Currently, half of the USD 20 billion economy comprises of foreign aid. According to a World Bank study released before the Taliban takeover, the country would need USD 8.5 billion annually until 2024 to keep its government afloat. A large part of the economy is also dependent on the opium trade which also funded the Taliban's war effort.

Many in the west have suggested a Marshall Plan type initiative to help the new government. The Marshall Plan for Western Europe helped war-ravaged countries repair themselves quickly after World War II. It typically provided USD 100-200 per inhabitant per annum over a period of several years, making for a cumulative total that often approached USD 1,000 per person in the end. Using USD 100 as a benchmark, Afghanistan will need close to USD 4 billion in official aid.

On the issue of renewable energy, however, I sense a real opportunity for Bangladesh—and it is one I believe our industry and government must grasp with both hands.

Look at the world's leading apparel brands and all of them have commitments to reduce their carbon footprint. Many of these commitments relate to 2050 but some are more ambitious, with 2040 and even 2030 now being considered.

way it can have a real impact on its carbon footprint is via its suppliers. Yet, installing solar energy at stores and other initiatives are easy to implement for fashion brands. The real challenge comes when it comes to getting to grips with suppliers.

This past week, Swiss outdoor apparel company Mammut has pledged to switch to 100 percent renewable energy at all of its suppliers by 2030. This is a hugely ambitious move and the industry should sit up and take notice. I expect other apparel retailers to take similar decisions moving forward.

Why is it so significant? Well, the

Be in no doubt—sustainability teams at the world's leading fashion brands and retailers will have been taking notice of this report. And each of them, I truly believe, will have been thinking about their own projections as far as the climate is concerned. In short, can they rely on making projections for decades in the future when the IPCC is talking about key temperature "red flags" being hit this

decade? I expect many will be asking the question, can they be more ambitious? Can they bring 2050 forwards to 2040 or 2030? I expect they may have no choice as they will be placed under increasing pressure by their investors, regulators and NGOs. The IPCC report is a seminal moment where climate is concerned.

All of this comes back to us as RMG suppliers and how we can use the requirements of brands to slash

to identify gaps and understand where investment is required.

To reiterate, all of this represents an opportunity rather than a threat for our industry. We have shown already that, when we work together, collaborate and put aside competitive differences, we can achieve great things. For example, look at how we improved safety across the industry in the wake of the Rana Plaza.







It said the gun was in "very good" condition with "well worn grips."

Garrett used the .44-caliber gun to shoot Billy the Kid -- who was born Henry McCarty but also went by William Bonney -- in the chest on July 14, 1881 in New Mexico. The gunfighter died at the age of 21.

The previous record for a firearm was \$1.98 million, set by Christie's in 2002 for a pair of flintlock saddle pistols carried by George Washington during the Revolutionary War, Bonhams said. They were gifts from his friend and ally the Marquis de Lafayette.

The sale Friday was the highlight of an auction of Old West firearms, manuscripts, photos and other memorabilia amassed by Texas-based collectors and college professors Jim and Theresa Earle.

Also sold was a Whitney doublebarrel hammer shotgun that Billy the Kid took from a sheriff's deputy and used to kill him as he escaped from jail in April 1881.

It fetched nearly \$980,000 at Friday's auction, well above estimates of \$200,000 to \$300,000.

Biman pilot

said yesterday, "His [pilot] condition is the same as before," reports our Delhi correspondent.

The pilot's condition is still serious and he remained on ventilation support as he suffered brain hemorrhage and bled profusely, said the officials.

A medical board has been formed to treat the pilot. The team includes Subhrajjit Dasgupta, director medical services, Ranjan Barokar, critical care physician, and Virender Belekar, critical care physician.

Initially, Capt Nawshad suffered a cardiac arrest in flight and later a CT scan revealed his brain hemorrhage.

On Saturday, Roshan Fulbandhe, assistant general manager of Kingsway Hospital, said, "Capt Nawshad's condition is severe ... he is surviving with full ventilation support ... he suffered brain hemorrhage and bleeding profusely... he remains unconscious.

He said initially the pilot suffered a cardiac arrest onboard the flight and after that he was taken to the emergency ward of the hospital with "unresponsive and unconscious" condition.

Roshan said an angiogram was done which brought out 60-70 percent blockage in his two arteries. As per the cardiac arrest protocol, the patient was then put on ventilator.

Asked, Biman Managing Director and CEO Abu Saleh Mostafa Kamal told The Daily Star that two sisters of the pilot reached Kingsway Hospital yesterday.

Our Delhi correspondent reports that wife of Capt Nawshad was supposed to reach the hospital last night.

Different media in Dhaka yesterday reported that Capt Nawshad died.

Capt Mahbubur Rahman, president of Bangladesh Airlines' Pilot Association, a platform of pilots of Biman Bangladesh Airlines, said the news on the demise of Capt Nawshad was a rumor.

Since these samples were taken, Delta has surged and now accounts for more than 98 percent of new Covid-19 cases in Britain, the authors said.

Multiple studies have shown that full vaccination prevents infection with symptoms and hospitalisation for both Alpha and Delta variants.

"We already know that vaccination offers excellent protection against Delta," said Gavin Dabrera, another lead author and consultant epidemiologist at the National Infection Service, Public Health England.

"It is vital that those who have not received two doses of vaccine do so as soon as possible. An earlier study from Scotland also

reported a doubling in hospitalisation risk with Delta over Alpha, suggesting that Delta causes more severe disease.

The coronavirus has killed at least 4,492,854 people since the outbreak emerged in China in December 2019, according to an AFP compilation of official data yesterday.



us open Serbian top seed Novak Djokovic will be the centre of attention when the final Grand Slam of the 2021 calendar, US Open, showdown begins today on the hardcourts at Flushing Meadows


Djokovic will try to complete the first calendar-year men's singles Grand Slam in 52 years and become the all-time men's leader in Slam titles by capturing the US Open.

After winning this year's Australian Open, French Open and Wimbledon, a fourth victory for Djokovic at Flushing Meadows will enable him to enter an exclusive club.

Only five players have previously won all four majors in the same year, with Australian great Rod Laver the only man to have achieved the feat in the

Five past champions won't be in the field when the showdown begins Monday on the hardcourts at Flushing Meadows, with Roger Federer, Rafael Nadal, Stan Wawrinka, Juan Martin del Potro and 2020 winner Dominic Thiem absent due to injuries.

That leaves the main obstacles in Djokovic's path to a 21st career Slam crown as a set of rising 20-something talents trying to build their trophy hauls -- Russia's second-ranked Daniil Medvedev, Greece's third-ranked Stefanos Tsitsipas and fourth-ranked Olympic champion Alexander Zverev of Germany.

Novak Djokovic will attempt to complete a rare calendar sweep of the Grand Slams and go past Roger Federer and Rafael Nadal in terms of major titles.

This will be the first Grand Slam tournament since the 1997 Australian Open not to feature Federer, Nadal, Serena Williams, or Venus Williams in the main singles draw.

The tournament will be the first Grand Slam since the coronavirus pandemic started to be allowed a 100% capacity throughout.

Australia's world number one Ashleigh Barty is widely considered as the player to beat in the women's singles, although Japan's defending champion Naomi Osaka is aiming to lift the title for the third time in four years. With an all-court game that has yielded five titles so far this year, 25-year-old Barty has cemented her place as the world number one and goes into the US Open as the favourite.

After lifting the Cincinnati title last week, Wimbledon champion Barty has notched a tour-high of match wins (40) in 2021 and a 14-1 winning record against top-20 opponents.

Meanwhile, players' mental health is also in focus after four-time Grand Slam winner Naomi Osaka led the charge for her fellow athletes this year.

The 23-year-old withdrew from the French Open after being fined and threatened with expulsion for refusing to attend media conferences, which she said had an adverse impact on her mental health, and disclosed she had suffered from depression for years.

The incident led Roland-Garros organisers to concede that the sport's governing bodies needed to do better and the United States Tennis Association (USTA) this week announced a mental health initiative for players in partnership with the Mount Sinai Health System.



Khulna farmer develops 6 varieties

After chasing his dream for over decade, 46-year-old Aruni Sarkar, a farmer from remote Gangarampur village of Khulna's Batiaghata upazila, succeeded in developing highyielding and climate-adaptable varieties of Aman paddy.

He claims that his varieties would change the fate of povertyhit farmers in southern coastal region where saline water



The new varieties have been made through hybridisation of multiple traditional varieties of paddy. The main features of these paddy are their salinity tolerance, high yield and the ability to ripen faster, said Aruni.

The traditional Aman paddy can survive around one week under saline water. But the new variants can survive over two weeks, he claimed.

Even, the traditional Aman paddy can tolerate 1 dS/m (deciSiemens per metre) -- a unit used to measure the degree of salinity in land. But the new ones can tolerate up to 3 dS/m, claimed Aruni.

BSF shoots 2 Bangladeshis dead


Indian Border Security Force personnel early yesterday shot two Bangladeshi men on the border in Patgram, Lalmonirhat, and kept their bodies.

Yunus Ali, a resident of Burimari area of Patgram, and Sagor Chandra, of Jaldhaka area in Nilphamari, were gunned down on Bandermatha border around 4:30am, according to Camp Commander Billal Hossain of 61 Border Guard Bangladesh and Officer-incharge Omar Farooque of Patgram Police Station.

Yunus and Sagor and about eight others were smuggling in Indian cattle from Changrabandha area in Cooch Behar district of West Bengal when the patrolling BSF men opened fired on them

The duo died at the scene while the others managed to flee. BSF men then took away bodies.

Camp Commander Billal said a letter was sent to the BSF asking for the bodies to be returned,

Delta doubles hospital risk

Says UK study

The Delta variant of the coronavirus that causes Covid-19 doubles the risk of hospitalisation compared with the Alpha variant it has supplanted as the dominant strain worldwide, researchers reported in The Lancet on Saturday.
Only 1.8 percent of the more than 43,000 Covid-19

cases assessed in comparing the two variants were in patients who had been fully vaccinated. Three-quarters were completely unvaccinated, and 24 percent had received only one jab of a two-dose vaccine.

The results from this study therefore primarily tell us about the risk of hospital admission for those who are unvaccinated or partially vaccinated," said co-lead author Anne Presanis, a senior statistician at the University of Cambridge's MRC Biostatistics Unit.

Researchers analysed healthcare data from 43,338 Covid-19 cases in England from March 29 to May 23 of this year, including vaccination status, emergency care, hospital admission and other patient information.

All virus samples underwent whole genome sequencing, the surest way to confirm which variant had caused the infection. Just below 80 percent of the cases were identified as the Alpha variant, and the rest were Delta.

About one in 50 patients were admitted to hospital within 14 days of their first positive Covid-19 test.

After accounting for factors that are known to affect susceptibility to severe illness - including age, ethnicity, and vaccination status - the researchers found the risk of being admitted to hospital was more than double with the
