Based on the Saudi CP, the BERC also revised the autogas price at Tk 50.56 instead of Tk 48.71 per litre.

The BERC chairman announced the new LPG price at a virtual briefing. Other members of the commission were present.

Usually, Armaco, the largest company of Saudi Arabia, announces its CP for bulk LPG at the fag end of each month for the next month's transactions.

Most Bangladeshi private companies import their bulk LPG from the Middle East on the basis of Saudi CP and market it locally.

The BERC for the first time fixed the retail LPG price on April 12 after holding a public hearing to comply with a High Court order.

### Brazil bank robbers strap hostages to cars during deadly raid

AFP, Sao Paulo

Heavily armed gangsters strapped hostages to their getaway cars after robbing two banks in Brazil, in a rampage that left three people dead, police and reports said Monday.

Using explosives, drones and heavy weapons, the assailants took over downtown streets in the southeastern city of Aracatuba, home to some 200,000 people.

After robbing two banks, they made their escape by strapping hostages to the roofs and hoods of moving cars, according to shocking images broadcast by local news channels.

Two civilians and one of the bank robbers were killed during the assault, which left at least six injured, according to police.

The assailants placed explosives in different parts of the city and surrounded some police stations to

delay the arrival of reinforcements. They wore "bulletproof vests, rifles and helmets," and looked like

soldiers, a witness who asked not to be identified told Globo TV. "The scenes of terror experienced

by the population of Aracatuba will not go unpunished," vowed Sao Paulo governor Joao Doria, who ordered a task force of 380 police officers to hunt the gang down.

"Two criminals were captured and a third died when confronting the police," he said.

Brazil has seen other such robberies in recent years, marked by a high degree of planning and heavy weapons, and carried out in medium-sized cities to ensure an escape route and a significant cash haul from the banks.

## 2 CID men 'framed trader for murder'

"I fell sick from torture on June 12. They took me to Rajarbagh Police Hospital by an ambulance and I was treated there

'SI Dolon demanded Tk 10 lakh from me... My brother later gave him Tk 2 lakh so that I'm spared from torture and hassles," Yakub alleged. Following the allegations, Serious

Crime Investigation Unit of the CID was recently tasked with carrying out the probe in the case.

On June 20 last year, a 20-yearold man named Khairul Islam died from electrocution after falling from the third floor of a building where he had gone to meet a girl in the capital's Badda area, said locals.

His father Abdul Quddus Sikder on July 1 last year filed a murder case with Badda Police Station.

According to the case statement, Khairul had a relationshipwith the girl for five years, which her father didn't approve of. When Khairul went to her house on June 20 last year, four to five unidentified persons, including the girl's father, beat him up and pushed him down to the tin-roof of an adjacent house. And Khairul got

electrocuted.

Inquest and autopsy reports of the deceased said Khairul died from electrocution, suffering severe electrical burns.

The post-mortem report, prepared by Sohel Mahmud, the then head of forensic medicine at Dhaka Medical College, on June 23 last year, said Khairul suffered 60 percent burns on his body from electrocution.

"The CID officers, however, are now saying that I brought kerosene and gave it to the girl's father who set Khairul alight. After I was taken to the CID Headquarters on June 10, they said the girl's father contacted me over mobile phone on the day of the incident and asked me to get kerosene...

"I told them I knew nothing about it and had no contact with the girl's father. But they handcuffed me, blindfolded me, and took me to another room. There they tortured me," Yakub alleged.

He also said the CID officers could not show the call records of the mobile phone through which, according to them, the girl's father contacted him.

On July 27 last year, the girl gave a statement in which she didn't

mention Yakub's involvement in the incident. She said Khairul slipped off the roof and got electrocuted

However, around 11 months after the incident, the girl's mother gave a statement under Section-164 on June 12, saying her husband caught Khairul when he came to meet their daughter and beat him up on June 20 last year. The girl's father then called his friend

Yakub over phone to bring kerosene and then poured it on Khairul. To save his life, Khairul jumped off the roof and got electrocuted.

But on June 27, the girl and her mother submitted separate affidavits to a Metropolitan Magistrate's Court, saying the IO asked them and three of their family members to go to the CID headquarters on June 10 and they did so.

The CID officers there confined them for three days and later forced the girl's mother to give a statement against Yakub, according to the

Talking to this newspaper, SI Dolon claimed that the allegations brought by Yakub and others are false.

## Every city dweller loses 7.7 years

In 2020, Bangladesh's air quality was the worst in the world, while its capital Dhaka was the second most air polluted city, it said.

The most polluted areas of the country are the divisions of Khulna and Rajshahi, where the average resident is exposed to pollution that is more than seven times the WHO guideline -- reducing life expectancy by more than six years, according to

The PM 2.5 concentration is high in Narayanganj, Jessore, Rajshahi, Khulna, Pabna, Dhaka and Gazipur,

found the study. Air pollution causes lots of diseases like ischemic heart disease, stroke, obstructive chronic pulmonary

disease, lung cancer and acute lower respiratory infections in children, said Lelin Chowdhury, a public health expert.

"That's why it is related to life expectancy. Our life expectancy increased but how much quality improved, it should be a research topic. In a lifetime, how many days one has to be in hospitals? That should count, too.'

Fossil fuel is one of the most important elements of air pollution, said Chowdhury, also the joint Poribesh Bachao secretary of Andolon, a voluntary social organisation promoting Bangladesh's environmental protection.

"The brickfields are the most dangerous, but those are decreasing. But the use of fossil fuels is increasing day by day. If we develop our public transportation only then would private transportation would reduce along with using fossil fuel," he added. The average person is losing

2.2 years of life expectancy due to particulate pollution exceeding the WHO guideline of 10 mcg/m3, according to AQLI. And permanently reducing air pollution according to the WHO guideline could increase the global

population could gain 17 billion life-

vears. impact of particulate pollution is greater than the effect of devastating communicable diseases

like tuberculosis and HIV/AIDS, behavioural killers like cigarette smoking and even war.

As a comparison, first-hand cigarette smoke reduces the global average life expectancy by about 1.8 years, alcohol, unsafe water and sanitation by seven months, HIV/AIDS by four months, malaria by three months and conflict and terrorism by 18 days.

Strong clean air policies can reduce fossil fuel emissions and help reign in climate change, which can also average life expectancy from 72 to increase life expectancies, the study 74 years, and in total, the world's

Researchers exemplified China as the air pollution concentrations have declined there since 2011 and improved the average life expectancy by roughly 2.6 years.
