US seen funding humanitarian aid for Afghanistan, but not its govt

The U.S. Congress is likely to finance U.N. and other agencies providing humanitarian assistance for Afghanistan but there is virtually no chance it will directly fund a new Taliban-led government, congressional aides said on Friday.

The United States has been a massive funder of Afghanistan since its 2001 invasion to topple the Taliban, setting aside roughly \$130 billion for security, governance and development and humanitarian needs.

Aides to the Democrats who control both houses of Congress and to Republicans said lawmakers were nearly certain to provide humanitarian aid for internally displaced Afghans and refugees but not to the government itself, at least

"It would be difficult to convince members of Congress to do anything that would appear to be supporting the Taliban government," said a senior Senate Democratic aide, citing the absence of oversight and a reluctance "to support a government that is anathema to us.'

A senior Senate Republican aide concurred

"Republicans would absolutely not support giving money to the Taliban," the Republican aide said, saying they do not want to provide any money until Americans and Afghans who worked with the United States can leave Afghanistan.

While aides said there was an understanding that agencies such as the World Food Program and the U.N. High Commissioner for Refugees would need funds, the Republican said lawmakers would want strict conditions on how it is

Illegal weapons sneak in on credit

DB police arrested Akul and the four others on Thursday after they came to Dhaka to deliver an arms consignment. The four are Ilias Hossain, Abdul Azim, Faruk Hossain, and Fazlur Rahman. The arrestees are now on three-day remand each, said DB officials.

Detectives said Akul mainly used to sell three types of firearms -- 9mm, 7.65mm 5-inch barrel and 7.65mm 3-inch barrel.

"Indian smugglers charged 61,000 Rupees for a 9mm, 51,000 for a 7.65mm 5-inch barrel and 41,000 for a 7.65mm 3-inch barrel. Akul used to sell those for Tk 1.20 lakh, Tk 90 thousand and Tk 80,000 respectively," a top official of DB police, requesting anonymity, told The Daily Star yesterday.

In primary interrogation, Akul admitted that Indian smugglers used to make the firearms and bullets in factories in India. Those would then make their way to Kolkata and finally to Bangladesh.

The Daily Star has obtained a video clip of a conversation between of Akul and and an Indian arms smuggler.

In the clip, Akul is heard asking

the Indian smuggler for 20 pieces of 7.65mm pistols. The Indian smuggler replies that he has only three in his hand, but he will be able to deliver the full consignment on September 6.

As Akul asks about the price, the Indian smuggler replies that it will be 1,000 Rupees for each firearm.

During the conversation, Akul and the Indian smuggler is heard using code words like Khabar (food) for bullets. For a consignment of 400 to 500 bullets, the Indian smugglers demands 800 Rupees for each. Rahman,

US Covid-19 booster shot campaign to start with only Pfizer: source

A White House plan to offer COVID-19 booster shots will most likely start this month only with the vaccine made by Pfizer Inc and BioNTech, a narrower initiative than anticipated, a source familiar with the matter said on Friday.

President Joe Biden had expected to launch a campaign to administer 100 million booster shots on Sept. 20. But U.S. vaccine makers other than Pfizer

have lagged in seeking authorization of an additional dose.

only Moderna Inc started submitting data for regulatory approval of a booster shot on Wednesday and said on Friday it had completed its submission.

A panel of experts that advises the Food and Drug Administration (FDA) on vaccines plans to meet on Sept. 17 to discuss additional doses of Pfizer's shot. Dr. Anthony Fauci, Biden's chief medical adviser, told MSNBC in an interview on Friday that it did not appear the information needed for Moderna would be available in time for a Sept. 20 rollout.

"It may be a delay for a few weeks. We don't know," Fauci said.

Johnson & Johnson has not yet asked regulators to approve a booster for its one-dose shot, and last week said it was in discussions with the FDA on the subject.

Earlier, the New York Times reported that the officials told the White House on Thursday to scale back a plan to offer the booster shots to the general public later this month.

As infections from the Delta variant rise, the Biden administration is concerned that COVID infections among people who are fully vaccinated are a sign that vaccine protection is waning. It has pushed boosters as a way to rebuild immunity.

Chinese woman

China claimed to have gone 40 years without any sleep, a feat confirmed by her husband and their neighbors, some of whom actually put her to the test, only to fall asleep themselves. Li last remembered getting some sleep when she was five or six, but now in her mid-40s, sleep is nothing but an old memory.

A resident of a village in Zhongmou County, Henan Province, Li is somewhat of a local celebrity in her community, because of her alleged ability to stay up all through the day and the night.

Li's husband, Liu Suoquin, also confirmed that his wife didn't seem to need any sleep at all. Ever since they got married, he noticed that she stayed awake night and day, doing chores around the house even in the dead of night. She kept telling him that she couldn't sleep, so he blamed it on insomnia and bought her some sleeping pills. That didn't work on her

According to Bastille Post, Li Zhanying sought medical help for her condition many times, but doctors never found anything suspicious. However, after recently visiting a medical center in Beijing, the mystery of her decades-old lack of sleep was finally solved. A team of doctors used advanced sensors to monitor the woman for 48 hours, and discovered that she did in fact sleep, just not the way most of us do.

Data gathered during the 48-hour brainwave monitoring showed that Li did get light and moderate sleep like ordinary people, only not while laying down in bed with her eyes closed, but while conversing with her husband. Doctors described this phenomenon as "sleep when awake," a state similar to sleepwalking, where some of Li Zhanying's nerves and organs are still active.

Doctors said that Li was actually deceived by her own brain. When she was resting, part of her body had already entered dormancy, but she didn't have to close her yes to do so. For example, when talking to her husband, Li Zhanying sometimes had slow eyeballs and hollow eyes, which indicated that she was resting during those mmoments.

Because of her unusual way of resting her body and brain, Li continues to believe that she has not slept in 40 years. She doesn't spend more than 10 minutes with her eyes closed every day, so she's technically right.

Police officers working in the Gulshan Division confirmed that the man arrested by the BSF is indeed Sohel Rana. He is allegedly involved with

regarding withdrawing Tk 2.5 crore from the company at different times. Aminul Islam, investigation) of Gulshan Police

Station, said when they asked Sonia about it, she told the investigators that Sohel withdrew the money on her request, adding that e-orange's ownership was recently transferred to Bithi Akter.

Earlier, VAT intelligence filed another case against the company on charge of tax evasion.
