He asked to monitor social media regularly so that no citizen becomes a victim of cybercrime. He also asked for monitoring markets to check price hikes.

Benazir said the use of illegal weapons and illegal use of legal weapons must be stopped.

Mentioning about ongoing mega projects at different parts of Bangladesh where many foreign nationals are working, the IGP asked for ensuring their security.

registered for the vaccination. Of them, about 4.5 lakh students received the first dose and 90,000 got both doses, a top UGC official, who attended the meeting yesterday, told The Daily Star.

Some 1.31 lakh residential students of public universities have registered for the vaccine. Of them, 1.18 lakh took the first dose and 81,000 got both the shots.

About 90 to 95 percent of about 15,300 public university teachers have received both doses, said UGC officials.

Asked how all students would be vaccinated before October 15 given the current rate of registration, Prof Alamgir said the condition that all students need to be inoculated before that date was no longer in effect after the meeting.

"Now the universities can reopen after completing the registration of all their students before September 27 upon approval of their academic councils and syndicates," he said.

"We don't think vaccination of all students will be a challenge as health officials informed us that there are enough vaccines in their stock," he added.

However, there have been frequent hiccups in the country's regular mass inoculation campaigns mostly because of shortage of doses. About 4.14 crore people have registered and 2.03 crore of them are yet to get the first dose, according to data from the Directorate General of Health Services

At present, there are about 1.5 MONI

vaccine doses in government stock, the data shows. THE MEETING

At the meeting, several VCs said many of their students could not register for not having NID cards.

An UGC member estimated that about 15 to 20 percent of all university students do not have the identification document.

At the meeting, there was also discussion on setting up vaccination booths at the medical centres of public universities to speed up the inoculation.

After yesterday's meeting, Dipu Moni urged all university students to complete their registration by September 27.

"Students completing their registration will get the vaccine on a priority basis," she said.

While talking to reporters after another meeting yesterday, the education minister said the government could not fix any reopening date for universities since they are autonomous bodies.

"We hope that the academic councils and syndicates of the universities will make a final decision keeping in mind the state of student's vaccination and the infection rate,"

The government on August 26 decided that students of all public and private universities will be inoculated against Covid-19 by September and the universities could start in-person classes in phases from October 15.

But on September 5 a discussion on reopening the universities surfaced again. That day, Education Minister Dipu Moni announced in-person classes in schools and colleges would resume in phases on September 12 and universities could reopen ahead of the scheduled date upon approval from their academic councils and syndicates.

The universities were closed on March 17 last year to curb the spread of Covid-19.

About 1.5 lakh students of medical, dental colleges and other health institutions went back to the classroom on Monday after taking both doses of the Covid vaccine.

Couriers in use to smuggle out forex

By that time, some cartons of the consignment had already passed through the scanner machine.

Hasan Ali, a cargo supervisor of Best Kargo Kare, who came with consignment for formalities, was interrogated and handed over to customs officials along with the currencies for the next step of action.

Hossain Mohammad Ershad, assistant revenue officer of Dhaka Customs House, filed a case with the Airport Police Station yesterday.

In the first information report, the custom mentioned that the Star Express line in their declaration gave the names of 23 individuals as senders

The Daily Star tried to communicate with the Star Express Line but all the phone numbers were found invalid. Even the company website does not contain any valid information and is full of spam links.

Rubel Albert, customer manager at Network International Courier Service, the receiver of the consignment in Singapore, told The Daily Star that they receive consignments from Star Express Line regularly.

He declined to give details of the contents of the consignments to the correspondent. He recommended communicating with Network International Courier Service through the law enforcement agencies for details.

GOVT SERVICES No plan to raise age limit now

The authorities have no plan to increase the age limit for entering government services at the moment, said Farhad Hossain, state minister for public administration, yesterday.

responding to a question from BNP lawmaker Mosharraf Hossain at the parliament.

He made the statement while

At present the age limit for entering a government job is 30 years; 32 for freedom fighters' offspring.

Although there was a significant session jam at educational institutions, including universities, in the past, there's no considerable session jam now, the state minister said.

Students generally sit for SSC at the age of 16 and HSC at 18, and they graduate at 23-24. Jobseekers get six to seven years to apply for government jobs after graduation, as the age limit for entering civil service is 30 years at present, he said.

"Moreover, we don't count the extra time from applying for a job to joining, which is required for almost 2-3 years,"

Jobseekers in the country have long been demanding to raise the age limit for entering government jobs to 35

Farhad Hossain said they raised the age limit of retirement to 59 from 57 which decreased the number of vacant posts in government jobs. If they raise the age limit for entering in this circumstance, the number of jobseekers will increase at a massive rate.

"That would bring more competition among the jobseekers and create frustration among under-30 jobseekers, that's why we have no plan to raise the age limit," he added.

Responding to a question from the government-leaning MP Ali Azam, the state minister said Bangladesh Public Service Commission had recommended recruiting 35,603 cadres since 2010. In this period, PSC recommended 5,143 first-class non-cadre employees and 5,743 second-class employees.

The question-answer was tabled by Speaker Shirin Sharmin Choudhury.

In August, the public administration ministry proposed to the prime minister to relax the age limit by 21 months due to prolonged academic life caused by Covid-19 restrictions.

The Daily Star could not reach the minister over the phone as it was switched off.

Tough talks begin to form new Norway govt

A day after winning Norway's general election, left-wing parties yesterday kicked off what are expected to be weeks of tough negotiations to form a government replacing the centre-right in power for eight years.

The Labour Party and its leader Jonas Gahr Store, in all likelihood the next prime minister, and his two preferred allies, the Centre and Socialist Left, won an absolute majority with 89 of 169 seats in parliament, according to preliminary election results.

Outgoing Conservative Prime Minister Erna Solberg acknowledged late Monday that her centre-right coalition had been defeated.

"In the next few days, I will invite the leaders of all the parties who want a new government to talks,' Store, who campaigned against social inequalities, said in his victory speech late Monday.

In addition to the Centre and Socialist Left, Store said he plans to meet with two other members of the current opposition, the Greens and the communist Red Party, who won three and eight seats respectively,
