## Time for action is now

Drowning still a dominant reason of child deaths; experts call for joint intervention by govt, NGOs

On July 11, three under-five children drowned in two unions of Netrakona's Kalmakanda upazila. The incident, however, was not highlighted in the media, as child drowning still remains one of the neglected and underreported issues in Bangladesh.

deceased were one-year-old Mostaqim, son of Sabbir Hossain of Rangchhati union, five-year-old Tasfia, daughter of Khairul Islam of the same union, and one and a half-year-old Jahidul Islam, the only son of Arshad Mia of Nazirpur union.

Each of them died when their family members, especially mothers, were busy with household chores, and the children were exposed to nearby ditches and ponds.

According to a recent media monitoring report on drowning deaths, conducted by SoMaSHTe, a media development and communication focused organisation with support from Global Health Advocacy Incubator (GHAI), of the 1,402 people

who died in the past 18 months due to drowning, 83 percent were children.

What is more alarming is that Netrakona had the highest death record (66) in this

Even though the data is alarming data, upazilas of Netrakona do not seem to have taken any visible interventions to prevent these avoidable deaths and no awareness campaigns have been conducted by the district administration.

For example, Tahera Begum, union parishad chairperson of Rangchhati, and Abdus Kuddus Babul, UP chairman of Nazirpur union, said they are unaware of the death of the three under-five children of their unions and currently, there are no such directions on conducting awareness campaigns regarding drowning in those

Netrakona civil surgeon Dr Md Selim Miah also said as per his knowledge, the district administration of Netrakona has no such programmes or initiative in preventing child drowning, even though there are at

# Govt approves 200-bed Covid Field Hospital

The government has approved a project to build a 200-bed Covid Field Hospital at Bangamata Sheikh Fazilatunnesa Mujib Convention Center under Bangabandhu Sheikh Mujib Medical University.

The approval was given at a meeting of the Cabinet Committee on Economic Affairs yesterday with Finance Minister AHM Mustafa Kamal in the chair.

The decision came when the hospital has already been in operation since August 7.

Primarily, the hospital, named as Bangamata Sheikh Fazilatunnesa Mujib Covid-19 Field Hospital, has been launched with 356 beds, including 20 beds at the Intensive Care Unit and 20 beds at the High Dependency Unit.

Health officials said there will be a total of 1,000 beds at the hospital.

At yesterday's meeting, the construction of a 200-bed Covid Field Hospital was approved in the first phase, the finance minister told reporters in a virtual briefing following the meeting.

He said that it would cost an estimated Tk 10.28 crore. Meanwhile, the Cabinet Committee on Economic Affairs at the same meeting sent back a proposal to hire a Chinese contractor for the maintenance and toll collection after the Bangabandhu Sheikh Mujibur Rahman Tunnel under the Karnaphuli river in Chattogram comes into

Bangladesh Bridge Authority has selected China Communications Construction Company Limited, which is now building the tunnel, for the maintenance and toll collection work under direct procurement method for five years after the tunnel is completed.

But the cabinet committee at its virtual meeting with the minister in the chair yesterday sent back the proposal. During post meeting press briefing, he, however, declined to reveal reason behind their decision.

### Case Against SK Sinha Court to deliver verdict Oct 5

A Dhaka court yesterday fixed October 5 for delivering the judgment of a case filed over Tk 4 crore money laundering against former Chief Justice Surendra Kumar Sinha

Judge Shaikh Nazmul Alam of the Special Judge's Court-4 of Dhaka set the date on completion of closing arguments in the case.

The 10 other accused are AKM Shamim, Gazi Salahuddin, Swapan Kumar Roy, Md Lutful Haque, Md Shahjahan, Niranjan Chandra Saha, Shafiuddin Askary Ahmed, Ranjit Chandra Saha, Santri Roy and Mahbubul Haque Chisty alias Babul

A total of 21 prosecution witnesses gave their deposition in the case before the court, said the state lawyer.

During yesterday's closing arguments, Shamim, Salahuddin, Swapan, Lutful, Shahjahan and Niranjan, who are now on bail, were present at the court. Only Mahbubul, who is now behind bars, was produced before the court from the jail.

Meanwhile, Mahbubul fell sick on the dock of the courtroom around 11:50am when the prosecution was presenting their arguments before the court yesterday.

After the judge directed the court police to take him to a hospital, Mahbubul was rushed to nearby Dhaka National Medical

#### CID presses charges against Piyasha's aide

Criminal Investigation Department (CID) of police has pressed charges against Sharful Hasan alias Mishu Hasan, a close associate of model and former TV presenter Faria Mahbub Piyasha, in an arms case filed with Bhatara Police Station.

IO Mohammad Rahat Khan, also an CID Inspector, submitted the charge sheet on September 13 to the Chief Metropolitan Magistrate's Court of Dhaka, showing 12 people as prosecution witnesses.

On August 3, Rab rrested Mishu and Masudul Hasan alias Jisan, another associate of Piyasha, from Bashundhara residential area. Later, Rab recovered a firearm, 1,600 yaba pills, a Ferrari car, fake Indian currency and some pornography ĆDs from their possession.

Rab filed five cases against them, of which four were with Bhatara and one with Khilkhet police under the Arms Act, Narcotics Control Act, Special Powers SEE PAGE 4 : Act and Pornography Act.

Tk 88.98 Lakh Graft Case Former E-orange owner, CEO

Two people, including Masukur Rahman, former owner of e-commerce platform E-orange, were shown arrested yesterday in a case filed with Gulshan Police Station for embezzling around Tk 88.94 lakh.

The other accused is Aman Ullah Chowdhury, CEO of E-orange.

Metropolitan Magistrate Rajesh Chowdhury passed the order after Aminul Islam, inspector (investigation) of Gulshan Police Station and also the case's investigation officer, submitted an application seeking permission for showing them arrested in the case.

Masukur, brother-in-law of suspended Inspector Sheikh Sohel Rana of Banani Police Station, was sent to jail on August 17 after surrender before another Dhaka court in connection with a different case filed with the same police station over embezzlement of around Tk 11,00 crore the capital. from customers. Sohel Rana was detained by India's Border Security Force on September 3. Aman Ullah was arrested in connection with the same case.

On September 1, Masukur and Aman Ullah were shown arrested in a case filed with Kotwali Police Station over misappropriating Tk 23.25 lakh from investors. They were also placed on a twoday remand each in the case that day.



### Three more die of dengue

more patients have died while 288 more were hospitalised in the last 24 hours till 8am yesterday.

A total of 57 people have died of dengue infection in the country this year, all of whom died in July, August, and September.

Twelve people died in July, 34 have died in August, and 11 have died in September so far.

According Directorate General of Health Services (DGHS), with the new cases, a total of 14,509 were hospitalised this year, of whom 1,538 are from outside Dhaka.

Among the 288 new cases, 56 are from outside

With the new cases, a total of 4,153 were diagnosed during running month. At least 7,698 were

diagnosed in August, 2,286 patients were hospitalised in July, 272 in June, while 43 were infected in May, according to the DGHS.

#### Assaulting JU Student Four Ansar members sacked

Four Ansar members were sacked yesterday for assaulting a Jahangirnagar University (JU) student at National Martyrs' Memorial in Savar. Nur Hossain (22), was assaulted on Monday for protesting against

"irregularities" of Ansar members in charge of the memorial, said students. The sacked Ansar members are Omar Faruk, Sarowar, Nazrul, and Romzan. Ansar and VDP office Dhaka District Commandant, Afzal Hossain, said, "The accused Ansar members have already been sacked. They have also been

blacklisted, meaning they won't be able to work anywhere else in future.'

'We will pay medical expenses of the injured student," he added Acting Proctor of JU, SM Firoz-ul-Hasan said, "After the unfortunate incident, we spoke with police and memorial authorities and requested that they take

Meanwhile, JU students staged a human chain in the morning to protest against the assault. The event started at 11:30am, blocking the Dhaka-Aricha highway. After about half an hour, on assurance of Ashulia police and the proctor, the students left the road.

Nur Hossain is undergoing treatment at Enam Medical College Hospital in Savar for injuries to his head, mouth, backbone, hands, and legs, said neurologist Dr B Karim.

Medical technologists postpone demo

Authorities assured them of publishing results STAFF CORRESPONDENT

Following assurance from high-ups, hundreds of medical technologists, who were demanding immediate publication of their viva results, postponed their demonstration yesterday.

On February 22, a selection board for appointing 1,200 medical technologists took viva voce of candidates who passed in the written exam. The health ministry, however, postponed publication of results, as a

newspaper reported of bribery centring the appointment. The ministry also formed a three-member committee to investigate the issue. Since then, the final result for the recruitment remains pending.

A section of technologists staged a sit-in in front of the headquarters of Directorate General of Health Services (DGHS), as part of their protest. "We have been assured that we will get the viva result very soon. We have postponed our demonstration for the next two weeks," Uttam Kumar, chief coordinator of the protesters, told The Daily Star yesterday.

"If authorities don't publish results by that time, we will wage a tougher movement, which will include blocking the way to the health minister's

## Migrant workers withdrew hunger strike

Expat welfare minister assures them of setting up RT-PCR lab at airport

After assurance from the authorities, the stranded Bangladeshis who works in the United Arab Emirates withdrew their fast unto death sit-in in front of the expatriates' welfare ministry in Dhaka yesterday.

As part of their month-long demonstration, they started the sit-in in the morning, demanding a RT-PCR lab at Hazrat Shahjalal International Airport (HSIA) immediately.

Around 3pm, Expatriates' Welfare Minister Imran Ahmad sat in a meeting

with a delegation of the demonstrators. "The minister has assured that he will inform us by tomorrow (today) morning that exactly from when we would be able to get RT-PCR test service at the airport. Based on his assurance, we have postponed our demonstration," said Md Salahuddin, a representative of the demonstrators.

He said, "We expect the minister will declare a logical deadline. Otherwise, we will take to the street again. Because, we have been suffering a lot for this."
