Prime Minister Sheikh Hasina yesterday in parliament said efforts were underway to vaccinate students aged 12 and above as she spoke about a government plan to gradually inoculate 80 percent of the country's population against Covid-19

The government wants to jab 50 percent of the population by December and it is taking measures in this regard following the World Health Organization guidelines, she said.

The population of Bangladesh is estimated to be over 16.5 crore. Hasina, also the leader of the House, detailed the vaccination target while replying to a question from Rustum Ali Faraji, Jatiya Party lawmaker SEE PAGE 2 COL 1

Pori Moni Remand HC expresses discontent at explanation of 2 judges

The High Court yesterday expressed discontent at the explanations of two lower court judges, who placed actor Pori Moni on remand for the second and third time in a narcotics case. saying that the judges had "undermined" the HC.

"The metropolitan magistrates [lower court judges] in their explanations said they granted the prayers for remands [of Pori Moni], considering the whole situation. They requested for pardon if they have made any unintended mistake or fault in passing the remand orders," the HC said.

The HC said it seems, from their explanations, that they don't believe that they have done any wrong. "They have undermined us by giving such

Infights, economic crisis stalk Taliban

A month after seizing Kabul, the Taliban face daunting problems, economic infightings, as they seek to convert their lightning military victory into a durable peacetime government.

After four decades of war and the deaths of tens of thousands of people, security has largely improved, but Afghanistan's economy is in ruins despite hundreds of billions of dollars in development spending over the past 20 years.

Drought and famine are driving thousands from the country to the cities, and the World Food Programme fears food could run out by the end of the month, pushing up to 14 million people to



the brink of starvation.

While much attention in the West has focused on whether the new Taliban government will keep its promises to protect women's rights or offer shelter to militant groups like al Qaeda, for many Afghans the main priority is simple survival.

Country to get 24cr jabs by Apr: Momen

Expressing optimism about collecting Covid-19 vaccine jabs, Foreign Minister AK Abdul Momen has said Bangladesh is on track to get 24 crore shots either by March or April next

"Vaccine doses are ming under the coming facility, as gifts and from other sources," the minister reporters on the sidelines of the International Conference on Inclusive Business".

He said half of Bangladesh's 16

crore people are young, while 2.22 crore have already been vaccinated.

"Despite significant vaccination in Bangladesh, the United Kingdom kept Bangladesh on the red list which is very unfortunate."

Momen Earlier, reiterated call to remove the Bangladesh's

country from the red list, terming the British government's decision "unfair and discriminatory".

He said this while speaking to a small group of journalists at his office on Monday. Referring

Open DU halls from Oct 5

Provost committee recommends

Dhaka University's provost committee vesterday recommended reopening residential halls for master's and finalyear honours students from October 5.

The decision was taken at a meeting of the provost committee held at the vice-chancellor's residence in the evening, Prof Saiful Islam, provost of Sir AF Rahman Hall, told The Daily

The meeting was chaired by DU VC Prof Aktheruzzaman.

Students who have the certificate to prove they have received at least one dose of Covid-19 vaccine will be allowed to enter their residential halls, said Saiful.

The recommendation to reopen halls on October 5 will be placed before the university's syndicate meeting, likely to be held next week,

"First, students of master's and honours final year will be allowed into the halls. Once their examinations are done, they will leave the halls. Later, students of other sessions will be allowed into the halls gradually," he

provost committee also suggested reopening the central library of the university on September 26, he

The students who have received Covid vaccine will be able to enter the library, said the professor.

The PM said the age bar for receiving the jabs was lowered to 18 for university students and the government now plans to vaccinate all citizens above that age.

"Arrangements have already been made to collect more than 24.65 crore vaccine doses. Steps have been taken to get more than one crore doses every month," she added.

In the scripted answer, Hasina said her government prepared the National Deployment and Vaccination Plan (NDVP) and the plan has already been approved by the global Covax facility.

Initially, people aged 55 and above as well as front-line health workers and other professionals were given the vaccine on a priority basis. Now the government looks to gradually vaccinate 80 percent of the population

under the NDVP, she said. The PM said how many of every 100 people have to be vaccinated to develop herd immunity against the virus was still not clear. The matter is still under study and that is why the government currently plans to vaccinate all Bangladeshi citizens

above the age of 18, she said. In this connection, Hasina said the government is continuing its efforts to collect vaccines from different sources.

According to the WHO, at least 80 percent of the population has to be inoculated to contain the spread of

Hasina also mentioned that people with disabilities would also be able to take the shots using their social safety cards. The cards were handed to the ministries concerned.

Workers will be vaccinated on a priority basis as well, she added. 96.54 LAKH SHOTS IN STOCK

The PM told the House that six crore Sinopharm vaccine doses would arrive -- two crore each month -- from China between October and December.

Among the over 24.65 crore shots the government is supposed to get,

more than 4.4 crore have already from Pirojpur-3, during a question- arrived in the country as gift or answer session chaired by Speaker under different bilateral purchase

agreements till September 12. Till that date, the government had more than 96.54 lakh doses in stock, she said.

She also said people were given over 3.47 crore shots till September 12. Of the people, 2.09 crore received their first doses while 1.38 crore got both the doses.

Hasina said the government was using 673 vaccination centres across the country to take the ongoing vaccine campaign to the doorstep of people in the divisional, district and upazila headquarters.

She hoped that the government would be able to successfully overcome the pandemic with cooperation from

Hasina reiterated her call to the people to follow the health protocols and take the vaccine.

The country reported the first Covid cases in March last year. The government closed all educational institutions across the country the same month to curb the spread of the

The schools resumed in-person classes on this Sunday (September 12), after around 18 months of closure, as the infection rate came

down significantly. Recently, 1.5 lakh students of medical, dental colleges and other health institutions returned to the classroom after taking both doses of the vaccine.

Mass inoculation against Covid-19 had remained suspended for over two months due to a shortage of doses. Bangladesh suspended administering the first dose of the vaccine on April 26. Registration of people for vaccination was suspended nine days later.

A poor initial feasibility study, which led to a major change in the bridge's design, long delay in land acquisition, a lengthy tender process and, more recently, problems caused by the Covid-19 pandemic have kept tens of thousands of people waiting for years.

Although the project was approved in May 2012, the physical work of the bridge started only in July 2016, just five months before the originally scheduled date of completion.

An RHD engineer, who is aware of project developments and preferred not to be named, said although there was a feasibility study before the approval, it was poorly done.

When the consultants prepared the detailed design, they had to change the initial design significantly, resulting in cost escalation, the engineer said.

After the detail design, prepared consultants documents and as a foreign-funded project, the implementing authority has to take concurrence at every stage of the bidding process, causing further delays to start of construction, he added.

Besides, the project authority faced complexities over land acquisition and were able to acquire the entirety of the land only last year, he added.

PD Abdul Halim said at the preliminary stage, the cost of the project was estimated on the basis of a tentative design but actual construction cost was finalised following the detailed design.

"So, the cost had risen after the detailed design," he added.

The declining trend of coronavirus transmission may be harder to maintain if health guidelines are not properly followed, said health directorate officials. In an online briefing yesterday,

Directorate General of Health Services (DGHS), said the positivity rate declined to 6.46 percent on Tuesday. "But there is no room for complacency because maintaining this [low rate] would be tougher if we

28,615 tests. Meanwhile, 51 people died with the virus across the country. Of them, 32 were male and 19 female.

The highest 20 of them were in Dhaka division, followed by 11 in Chattogram, five each in Khulna and Sylhet, four in Rajshahi, and three each in Barishal and Sylhet divisions.

With the latest count, the total number of confirmed cases rose to 1,536,341 and the total number of deaths to 27,058.

The death rate was 1.76 percent of all cases detected since the first cases were reported on March 8 last year.



With backlogs of pending cases piling up due to crisis of judges, the government does not seem to have any specific plan to appoint new judges to the Appellate and High Court divisions of the Supreme Court any time soon to increase the rate of case disposal.

Asked, Law Minister Anisul Huq told The Daily Star recently, "Of course, judges will be appointed to the Appellate and High Court divisions. It's a continuous process. When the posts of judges fall vacant, new judges are appointed.

He, however, did not say when and how many judges will be appointed.

Crisis of judges increased the case backlogs at the courts of the country in the last few years and Covid-19 pandemic restrictions turned the situation graver, causing immense sufferings to the justice seekers.

As of July 30, there are five judges including the chief justice in the Appellate Division (AD) and 91 in the High Court Division.

The chief justice will retire on December 31 this year.

But the number of cases pending with the AD is 15,225 while it was 4,52,963 with the HC till December 31 last year, according to a study report of Law Lab, a law-chamber that conducts research on legal and constitutional issues.

In 1974, the AD had five judges and the number of the HC judges was 12. The pending cases in the AD and HC at that time were 4,094 and 28,186 respectively.

The Law Lab collected the data from the reports published by the SC and from the

parliamentary proceedings. Across the country, the number of pending cases at different courts till December 31 last

year was abysmally high -- 39,33,186.

Ruet authorities felling 50 old trees for construction projects

To make space for new administrative and academic buildings, authorities Rajshahi University Engineering Technology (Ruet) have felled around 50 trees recently, most of which are over half a century old.

This was done without taking mandatory approval from the Forest Department, divisional forest officer Ahmed Niamur Rahman told The Daily Star. "The Ruet authorities have not even informed the forest department about the tree-felling,

Talking to The Daily Star, environmentalists said the felling of these old trees, including litchi, mahogany, and koroi -- all of which grew inside the campus since the university's inception in 1964 -- will leave a bad impact on the area's ecosystem.

During a visit to the campus yesterday, this correspondent saw labourers felling tree one after another. Till yesterday, the felling of at least 15 Krishnachura and Minjiri trees were almost complete.

Contacted, Ruet registrar Prof Md Selim Hossain said the project is being supervised by the offices of planning and development, and the superintending engineer of Ruet.

He said the campus has not undertaken any development works since the 1980s, but recently the government approved nearly Tk 600 crore worth of development projects

The felled trees will give way to ten multi-storied buildings, with the site in front of the Civil Engineering Faculty housing the administrative

for little.

Contacted, both superintending engineer Amit Roy Chowdhury and planning and development affairs director Zaglul Sadat refused to state anything on the matter.

Meanwhile, authorities were also found to have compensate for the felling of old sold the felled trees at a lower than trees," as it takes time for a new tree market rates.

Abdus Samad, a local timber trader, said he estimates each of them to go for Tk 50,000.

However, the campus authorities sold all the 15 felled trees for only Tk 1.27 lakh, this correspondent found. Md Jalal Uddin, senior assistant

Contacted, Prof AHM Mahbubur Rahman of Rajshahi University's Department of Botany said, "Planting new trees does not to fulfil the function of a much older

"Ruet and RU campuses are proud to have these trees. Other than providing oxygen for us, they play critical roles in the area's ecosystem," he said.

Mahbub Tunku, general secretary of Poribesh Andolon Oikya Parishad, said they have been noticing a "mad rush" for tree-felling in Rajshahi for development activities.

"We're not sure whether we need development of this kind, but we're sure we need these old trees," he said, adding that the authorities should plan development activities the campus in the last one year to without harming the environment.

307 more hospitalised with dengue

At least 307 dengue patients were hospitalised in the last 24 hours till 8am yesterday.

Among the new cases, 63 are from outside the

With the new cases, a total of 14,831 persons were hospitalised this year of whom 1,601 are from outside Dhaka, according to the Directorate General of Health Services (DGHS).

A total of 4,475 were diagnosed during the running month.

According to the Directorate General of Health Services, 57 people have died of dengue infection in the country this year. Twelve people have died in July while 34 have died in August and 11 in September so far.

Of the deaths, 53 have died in Dhaka division, two in Chattogram and one each in Rajshahi and Khulna divisions.

At least 7,698 persons were diagnosed with dengue in August, 2,286 were hospitalised in July, 272 in June while 43 were infected in May.

Though most of the patients who were hospitalised have so far been released, 1,291 are still undergoing treatment at hospitals in Dhaka, and 199 outside the capital.

Amid the rise in dengue cases, DGHS on August 23 announced six hospitals in Dhaka dedicated to treating dengue patients.

Four separate bills, including Bangladesh Shishu Hospital and Institute Bill, were passed in parliament yesterday. Three of the passed bills -- Bangladesh Shishu Hospital

and Institute Bill, The Medical Degrees (Repeal) Bill, and The Medical Colleges (Governing Bodies) (Repeal) Bill -were placed by Health Minister Zahid Maleque.

Another passed bill, titled "Kurigram Agricultural University Bill", was placed by Education Minister Dipu Besides, a bill titled "The Quick Enhancement of

Electricity and Energy Supply (Special Provision) Act 2021" was placed in parliament, aiming to extend the tenure of the law for another five years (till 2026). Bangladesh Shishu Hospital and Institute Bill, which

was passed by voice vote, aims to improve healthcare services for children. It was designed in line with Dhaka Shishu Hospital

Ordinance, 2008, which was promulgated during the caretaker government's tenure. The draft law aims to merge Dhaka Shishu (Children) Hospital and Bangladesh Institute of Child Health to

ensure better healthcare services for children. At present, Bangladesh Institute of Child Health is the academic wing of Dhaka Shishu Hospital. Some 54 ordinances, out of 122, promulgated during

Amassing over Tk 12cr in 6 years

Within six years of joining Bangladesh Road Transport Authority (BRTA), the bank balance of an assistant director swelled to about Tk 12.84 crore.

Anti-Corruption Commission (ACC) deputy director Rafiquzzaman yesterday filed a case against the official in question, Farhanul Islam, and his brother Raihanul Islam over amassing around Tk 12.84 crore illegally.

As per the case statement, Farhanul joined BRTA's Noakhali circle in September 2012.

He maintains 10 accounts across three private banks, a public bank, and financial institutions.

He came to the spotlight after suddenly closing six of his accounts in 2019, which alerted the central bank and prompted an investigation, sources said. The inquiry was later transferred to ACC.

Meanwhile, on Tuesday evening, ACC filed five cases against Keya Group chairperson Abdul Khaleq Pathan, his wife, and three children for amassing about Tk 183.84 crore illegally and concealing wealth worth around Tk 96 crore.

In August 2017, ACC had arrested Pathan over swindling Tk 111.14 crore from Bangladesh Krishi Bank.

'It seems purposive'

Journalist organisations condemn BFIU move of seeking bank details of 11 journo leaders

Jatiya Press Club and Dhaka Reporters Unity have condemned and protested the move of Bangladesh Financial Intelligence Unit (BFIU) that sought statements of bank accounts of elected members of different journalists' associations.

In an urgent meeting of the management committee of the press club, they said investigation can be launched on allegations against anyone under the existing act. "But launching a probe only against the elected leaders

of the organisations of a profession seems purposive," the committee said in a press release.

BFIU this week sent letters to banks seeking statements of 11 journalist leaders. The list included 11 names from the six most important

organisations representing journalists. They have been directly elected by thousands of journalists from all over the country, including Dhaka. This unprecedented act has tarnished image of journalist society and Jatiya Press Club, read the press release.

Saying that it has belittled social dignity and defamed journalist leaders publicly, they demanded immediate withdrawal of the decision.

In its press release, DRU executive committee termed the BFIU's move a threat against independent journalism. "It would be logical, if the bank statements of the leaders of all organisations of professionals would have been summoned," it said.

The executive committee of DRU suspected involvement of corrupt bureaucrats behind it.

"It needs to be investigated whether there is an ill motive or Bangladesh Financial Intelligence Unit took up the matter upon the instigation of some quarter," they opined. SEE PAGE 4 COL 3

Where did the money go?

Savar police arrest drug peddler, but don't mention anything about 'recovered money'

A case document centring two people, who were arrested over drug peddling, has raised questions, due to the discrepancy between accounts of police officials and

in Bashundhara area of Savar's Kaundia union held one Mohammed Foysal with three packets of heroin.

On information, a police team of Kaundia police outpost, led by the outpost's in-charge Sub-inspector Shah Alam, went to the spot, and the locals handed Foysal over to police.

They told police that Foysal was addicted to drugs and gets his supply from one Mohammad Hasibul Islam alias Sohel of the same area.

Later, police raided Sohel's rented room and seized materials for taking drugs and around Tk 20,000. They also detained Shohel's wife, as he was not found during the raid.

Later that day, Sohel surrendered to police and admitted to his involvement with drug peddling. Police released his wife afterwards. On August 14, Mohammad Ibrahim

Samaddar, assistant sub-inspector of the outpost, filed a case with Savar Model Police Station.

However, police did not mention anything about the seized money in the case document, although witnesses claimed to have seen officers taking the money.

Sohel was shown arrested with 75 packets of heroin and Faisal with 25 packets in the documents.

The Daily Star spoke with two witnesses of the case about this issue.

Police source Md Khorshed, main witness of the case, told The Daily Star that Faisal was detained with three packets of heroin. When asked about the cash, he advised this correspondent to talk to SI Shah Alam.

Son of Sohel's house owner Sabui Khan, who was made second witness, said, "Although I was not there from the start, when I entered the house, I saw police seizing around Tk 15,000 to 20,000.

Another local, Mainuddin, who was present at the time of the incident, provided similar information.

He said three packets of heroin were seized from Faisal's back pocket, and when going through Sohel's house, police only found materials for taking drugs.

Asked about the claims, SI Shah Alam said no money was recovered during the

Kazi Mainul Islam, officer-in-charge of Savar Model Police Station, said everything recovered is mentioned in the case report, implying that no money was recovered.

Asked about the reported discrepancy in the number of packets seized, SI Alam refused to comment.

Meanwhile, The Daily Star tried to contact Sohel's wife and other family members, but could not trace them, as they left the area after the incident.

Rape case filed against govt official

A woman yesterday filed a rape case against a deputy secretary, accusing him of engaging in sexual relationship by promising to marry her.

The woman, a 30-yearold schoolteacher, filed the case with Women and Children Repression Prevention Tribunal-2 of Dhaka, said Special Public Prosecutor Md Ali Akbar.

After a hearing, Judge Md Habibur Rahman Siddique took the case into cognisance and recorded the complainant's statements.

The judge directed PBI to investigate the case and submit a report before it by September 30.

According to the case documents, the official established sexual relations with her several times, promising to marry her, but he later refused to do so.

They met through social media on December 21 of 2018. The accused also threatened her when she sent a legal notice to him through her lawyer about the matter on June 8. Asked, the official said he knew the woman but had no relation with her.

4 bills passed

the caretaker government's tenure were approved in parliament, following recommendations of the 9th parliament's special committee. But Dhaka Shishu Hospital Ordinance was not endorsed at that time.

Dhaka Shishu Hospital, established in 1977, became an autonomous institute under the 2008 ordinance. The Bangladesh Institute of Child Health was established in 1983 as an academic wing of Dhaka Shishu Hospital.

Currently, there is no complete law or ordinance on regulation and supervision of Dhaka Shishu Hospital's activities. At least 30 beds would be reserved for child patients of poor families, he mentioned, referring to a provision of the bill. The Medical Degrees (Repeal) Bill was passed by voice vote. The proposed law, once enacted, will abolish Medical Degrees Act 1916, as the enactment of Bangladesh Medical and Dental Council (BMDC) Act 2010

made the old law unnecessary. Medical Degrees Act 1916 used to determine everything regarding medical degrees and their standards. But all of its

provisions were incorporated into BMDC Act 2010. The Medical Colleges (Governing Bodies) (Repeal), Bill was also passed by voice vote. The new law will abolish Medical Colleges (Governing Bodies) Ordinance 1961. The old ordinance is not necessary anymore, as some other

laws were enacted for medical education in the country. Kurigram Agricultural University Bill aims to establish a new university in Kurigram, which will help develop agriculture in northern districts through research. Currently, there are 153 universities -- 46 public and 107

private -- in the country. State Minister for Power Nasrul Hamid placed The Quick Enhancement of Electricity and Energy Supply (Special Provision) Act 2021 in parliament.

Since the tenure of the existing law is going to expire in 2021, the proposed law was brought to extend it till 2026. The cabinet on September 6 gave final approval for the bill's draft to ensure uninterrupted supply of electricity and

The tenure of the special provision, enacted in 2010, was extended on several occasions in the past, but no changes other than extensions were made to the proposed law.

It seems purposive

Earlier, executive councils of Bangladesh Federal Union of Journalists (BFUJ) and Dhaka Union of Journalists (DUJ)

expressed grave concerns over the issue. "If there is any specific information about unusual transactions or money laundering against any particular journalist, legal action can be taken against him/her after

proper investigation," read a joint statement. 'Question arises as to whether seeking bank account details of those elected to the top positions of the organisations is meant to humiliate such institutions and their leadership," the statement added.

Courts hamstrung

In one year from January 1 till December 31 that year, 7,39,563 cases were resolved in these courts, said the report. The SC administration does not have statistics on the numbers of cases filed and disposed of last year and this year due to the Covid-19 pandemic, said SC spokesperson Mohammad Saifur Rahman.

Advocate Mohammad Shishir Manir, who leads the Law Lab, said if the case backlog continues to go up, the fundamental rights of the citizens to have speedy trial under article 35(5) of the constitution will be nugatory.

"It is high time to take immediate steps to ensure best use of the existing resources, increase their efficiency and remove procedural complexities to get rid of the pending cases," he said. He stressed on digitalisation of the case management system for faster case disposal.

According to the Law Lab report, each judge of the AD is burdened with more than 3,045 cases on an average as the number of its judges came down to five from 11 in 2009 after appointments and retirements of some judges.

The situation is worse in the HC as each of its 91 judges is burdened with 4,923.51 cases on an average. Three of the HC judges are not being allowed to conduct bench as an inquiry is going on about them since August 22, 2019. Besides, three HC judges are conducting the International Crimes Tribunal-1 for disposing of the 1971 war crimes related cases, SC sources said.

The judges at the lower courts are also burdened with a huge backlog of cases as there are only 1,700 judges to deal with 34.65 lakh cases filed in courts across the country. This means each of the judges will have to dispose of 2,038

cases on an average, the report said. In 2014, Bangladesh Law Commission recommended the government recruit 3,000 judges at lower courts for quick disposal of pending cases and reducing sufferings of justice seekers.

Contacted, Muhammad Yusuf Hossain Humayun, vice chairman of Bangladesh Bar Council, said there is an urgent need for appointing some judges at the AD as it is facing a severe shortage of judges.

EROSION OF PADMA, MODHUMOTI

7 pry schools under threat in Faridpur

OUR CORRESPONDENT, Faridpur

Existence of seven government primary schools is under threat in three upazilas of Faridpur as banks of the Padma and the Modhumoti rivers continue to be eroded fast.

The Modhumoti river in Alphadanga upazila is closing in on three such schools -- Poshchim Narandia Government Primary School, Pachuria Government School and Government Primary School.


In Charbhadrasan upazila, the Padma river is getting alarmingly close to Baliadangi Government Primary School and Sobulla Sikdarer Dangi Government Primary School. Nuruddin Sardar Government School and Kotikandi Government Primary School in Sadarpur upazila are also under threat of erosion by the mighty river.

Headteacher Joynab Begum of Poshchim Narandia Government Primary School, in Alphadanga upazila, said, "The Modhumoti river has reached within eight feet of our school. The tin structure of the school may go into the river any

Established in 1980, the institution also has a singlestorey building on its 30-decimal compound. The school has 110 enrolled students and four teachers, she said, adding that their future would be shrouded in uncertainty if the school is lost to the river.

With the Modhumoti river only six feet away from the school building now, they have been considering relocating to a new site, said Farida Parvin, headteacher of Bazra Government Primary School in the same upazila.

Baliadangi Government Primary

School in Charbhadrasan was established in 1988. The institution had to be moved to the current location after its original campus was eroded by the Padma in 1998. Now the river is eroding its bank about 40 feet away from the school.

The river is once again getting close to the two-storey building of the school, said headteacher Lutfar

In Sadarpur upazila, Kotikandi Government Primary School is facing erosion threat of the Padma, as the river has gotten close to 80 yards of the school's tin structure.

Sharif Hossain, headteacher of the school, said another corrugated

iron building of the school had to be abandoned a year ago, but the way the Padma has been eroding its bank, the existing building of the school will go into it soon.

The higher authorities concerned have been informed of the present situation, he also said.

Asked, Faridpur District Primary Education Officer Touhidul Islam said they already informed the deputy commissioner of Faridpur and Water Development Board (WDB) about the seven endangered government primary schools in Faridpur.

He also said that he advised

upazila education officers and headteachers concerned to take necessary measures if a school building can be saved by relocating.

Explaining various measures taken in this regard, WDB's executive engineer in Faridpur Partha Prothim Saha said they asked Poshchim Narandia Government Primary School authorities to move the school's tin structure to a safer location.

They had been dumping geotextile bags at erosion sites of the rivers to save Bazra Government Primary School and other schools, he added.

Farmers make profit growing watermelon on unused lands of fish enclosures

Farmers of Beel Khukshiya regions in Keshabpur upazila of Jashore have found enviable success in cultivating watermelon during its off-season. They have cultivated watermelon on bamboo platforms near fish enclosures bringing a marked change in their fate. Watermelons were seen hanging like pumpkins on bamboo platforms and the farmers have wrapped those with net bags for their weight management.

As the weather condition is favourable, farmers are making a good profit as the yield has been quite good. Watermelon, usually cultivated during dry season, has been cultivated for the first time in this

Watermelons produced here are being transported to different parts of the country including Dhaka. Many farmers are turning to watermelon cultivation as it is profitable.

Upazila agriculture extension officials have visited the watermelon cultivation and assured the farmers of all sorts of

Bill Khukshiya is located on the banks of the river Srihari in Suflakati union, some 18 km away from Keshabpur upazila headquarters.

Due to 18-year-long waterlogging in the beel, the farmers could not grow any crops in the beel. Later, Tidal River Management (TRM) approach was implemented by the Water Development Board to solve the waterlogging problem. At the end of the project, the farmers started cultivating fish in enclosures. Now, the farmers have seen the face of success by cultivating watermelon on bamboo platforms at the edge of the enclosures. Farmer Mohsin Uddin said, he planted around 1,400 watermelon saplings around his 13-bigha fish enclosure and got a yield of 275 maunds. He sold per maund of watermelon at Tk 1,200. The biggest of his produce weighed 14 kg.

Abdul Halim Khan, another farmer in the area, has sold watermelons worth TK

Farmer Abdul Quddus has cultivated

watermelon in his six-bigha fish enclosure. The watermelons that he produced were also quite large.

The Department of Agriculture Extension has become overjoyed to see watermelon cultivation in the beel area.

Chairman of Suflakati Union Parishad Abdus Samad said, the beel remained waterlogged for 18 years and the farmers could not harvest any crop there. The TRM approach was implemented in the beel in 2005. Now, the farmers are getting the

This year, the farmers have got a huge yield of watermelon in the beel areas.

Besides paddy and fish cultivation, watermelon cultivation has brought back smiles on the faces of the farmers, he added.

Keshabpur Upazila Agriculture Officer Rituraj Sarkar said, watermelon has been cultivated in 254 bighas of land in Beel Khukshiya, which is making the farmers of the area financially solvent.

Watermelons of Asian-1, Pakija Super, Black King, Black Queen varieties have been cultivated here as per the advice of the agriculture department.

Furious Padma devours over 20 homesteads in Harirampur

Over 20 families have lost their homesteads and vast areas of cropland as the erosion of Padma has taken a serious turn in two-kilometrelong stretch on the riverside area of Kanchanpur in Manikganj's Harirampur upazila in the last three weeks.

Of the 20 affected families, 13 are in Kushiar Char village, four are in Kotkandi village and the rest are in Mohammadpur village.

On a recent visit to the affected areas, the trail of devastation left by a furious Padma was seen.

The villagers besieged a boat carrying the WDB official and local AL leaders and demanded that the authorities construct a permanent dam there to save them.

They said, "We don't want relief, we want a permanent dam.

Gazi Bani Islam of Kutirhat village said that "Many houses and vast areas of croplands are going into the riverbed every year. Some GEO bags are dumped now under threat of being devoured

UN urges moratorium on Al tech that threatens rights

The UN yesterday called for a moratorium on artificial intelligence systems like facial recognition technology that threaten human rights until "guardrails" are in place against violations. UN High Commissioner for Human Rights Michelle Bachelet called for assessments of how great a risk various Al technologies pose to things like rights to privacy and freedom of movement and of expression. She said countries should ban or heavily regulate the ones that pose the greatest threats. But while such assessments are under way, she said that "states should place moratoriums on the use of potentially high-risk technology".



US gen secretly called China doubting Trump's sanity: book

The top US general was so worried in early January that Donald Trump was out of control that he took secret action to prevent the outgoing president from sparking a war with China, according to a new book. Joint Chiefs Chair General Mark Milley ordered aides to not act immediately on any move by Trump to use US nuclear forces, and he called a Chinese general to reassure Beijing, presidential chronicler Bob Woodward and co-author Robert Costa wrote in their soon-to-bereleased book "Peril". Milley called Chinese counterpart General Li Zuocheng twice, on October 30 just before Trump's election defeat, and on January 8, two days after Trump supporters attacked the US Capitol, to reassure him that the Republican president's anti-China rhetoric could not translate into military action. "Peril" will go on sale on September 21.

Californians vote to keep **Democratic governor**

Californians voted overwhelmingly to keep their Democratic governor Tuesday, roundly rejecting a Republican attempt to unseat him in a special recall vote spurred by mask mandates and Covid lockdowns. Gavin Newsom handily survived a confidence vote that could have seen him replaced by a Republican with only minority support in one of the most liberal parts of the United States. With more than 60 percent of the votes tallied, NBC, CNN and Fox News said Newsom was set to prevail, with two thirds voting against the effort. Newsom acted quickly as the pandemic took hold of California, ordering people to stay home and shuttering schools, in moves praised by scientists. But entrepreneurs blamed him for suffocating their businesses.

Sri Lanka prison minister quits after gun-toting claims

Sri Lanka's prisons minister stepped down yesterday over allegations he tried to force a confession from a Tamil inmate at gunpoint, and drunkenly threatened to execute others. The controversy raged as the UN Human Rights Council (UNHRC) in Geneva urged Sri Lanka to either prosecute or release 78 Tamils incarcerated for decades without being charged -- some of whom were involved in the incidents. Ratwatte allegedly made the threats at Anurdhapura prison, north of Colombo, on Sunday. Pro-government outlet Derana TV reported the junir minister took eight inmates out of their cell and made them kneel before him and then he placed his pistol on an inmate's head thrice and threatened him.

Time for Europe to step up to the next level' EU chief lays out plan to make bloc more

independent, announces defence summit

The European Union's chief executive yesterday set out plans to make the 27-nation bloc more independent in areas from defence to global trade, and urged other countries to join it in accelerating the fight against climate change.

Europe will seek to boost its own military capacity after the collapse of the US-backed government in Afghanistan, Ursula von der Leyen said yesterday, announcing a defence summit.

"It is time for Europe to step up to the next level," von der Leyen told the European Parliament, in her annual State of the European Union address.

France's President Emmanuel Macron will convene the "summit on European defence" during France's six-month presidency of the bloc, starting at the New Year, she said.

Paris has been leading the push for the 27-nation union to develop more autonomous military capacities alongside the Western alliance, which is traditionally led by the US.

One month after the Taliban took control in Afghanistan, von der Leyen called on EU states to build forces that can intervene militarily abroad without US support.

"What has held us back until now is not just shortfalls of capacity, it is a lack of political will," said the former German defence minister, whose country has been reluctant to deploy troops into combat around the world.

In the short term, the EU chief pledged an additional 100 million euros (\$118 million) in humanitarian aid to Afghanistan as the bloc grapples with the immediate fall-out of the Taliban's takeover.

While US-led Nato has long shouldered the military burden in Europe, China's rise, a more aggressive Russia and U.S. calls for Europe to do more for its own security are pushing the EU to develop a more forceful foreign policy.

Echoing calls by predecessor Jean-Claude Juncker, von der Leyen said the EU needed a "defence union" that would cement joint military action, going beyond its traditional soft power as the world's largest trading bloc.

She proposed waiving value-added tax on weapons developed and sold in the bloc by EU governments, establishing a joint situational awareness centre to improve intelligence-sharing, and better defences against cyber attacks.

She also pledged to increase financial support

to help poorer countries fight climate change and adapt to its impacts by an additional 4 billion euros (\$4.73 billion) until 2027.

Warning against "a pandemic of the unvaccinated", she said the pace of Covid-19 vaccination must be quickened. She announced a donation of 200 million vaccine doses for third countries by mid-2022, on top of a previous commitment for 250 million shots.

Von der Leyen, during her speech, also said the EU is looking to impose an import ban on products made from forced labour, in a move seen aimed at China over its treatment of its Uyghur population.

The stance underlined a hardening Western approach to China, which has become an economic powerhouse that competes with the US and EU while eschewing their democratic and social values

She also said the European Commission is to ropose a law to fight violence against womer before the end of the year after a rise in cases during the Covid-19 pandemic.

"Women must be able to live freely and selfdeterminedly again," she told the European Parliament in her annual State of the European Union address in Strasbourg.

During the pandemic, too many women were deprived of this freedom" to express themselves, live their identity and to "love who you want," she said.

UK CABINET RESHUFFLE

PM Johnson rejigs his top team

British Prime Minister Boris Johnson yesterday demoted his foreign secretary in a major reshuffle, removing his more under-fire colleagues to refocus the government on raising living standards after covid-19.

After months of criticism of several of his top team for missteps and gaffes, Johnson finally started a process some say he wanted to do many weeks earlier, to make the changes he feels he needs to press on with his "levelling up" agenda.

Johnson has made tackling regional inequality a priority, part of an agenda set in 2019 when he won the biggest Conservative Party parliamentary majority since Margaret Thatcher but which has been eclipsed by the Covid-19 pandemic.

Dominic Raab, who has faced calls to resign since he went on holiday in Crete as the Taliban advanced on the Afghan capital,

Dominic Raab Kabul, lost one of the so-called great offices of state in the foreign office to become justice minister. To soften the blow, Raab was also appointed deputy

prime minister, a role he played in all but name when he

stepped in to lead government when Johnson was fighting for his life in hospital with Covid last year. Liz Truss was promoted from trade to the foreign office, becoming only the second woman to hold the position in Britain. Michael Gove, seen as a key player in the Johnson government, was moved to housing from his position in the cabinet office, a department at the centre of government

which drives the implementation of policy. Raab's and Gove's moves followed the sackings of three others: Gavin Williamson as education minister, Robert Buckland as justice minister and Robert Jenrick as the housing minister.

Critics accused Johnson of choosing Wednesday to overshadow the opposition Labour Party's planned vote in parliament on the government's decision to scrap extra support for low-income families. But some Conservative lawmakers said it had been simply long overdue.

Koreas conduct duelling missile tests

Both North Korea and South Korea test fired ballistic missiles yesterday, the latest volley in an arms race that has seen both countries develop increasingly sophisticated weapons while efforts to get talks going on defusing tension prove fruitless.

South Korea tested a submarine-launched ballistic missile (SLBM), becoming the first country without nuclear weapons to develop such a system.

South Korea President Moon was attending that test firing when word came of the North Korean launches, its first ballistic missile tests since March. North Korea fired a pair of ballistic missiles that landed in the sea off its east coast, according to officials in South Korea and Japan, just days after it tested a cruise missile that is believed to have

North Korea has been steadily developing its weapons systems amid a standoff over talks aimed at dismantling its nuclear and ballistic missile arsenals in return for US sanctions relief. The negotiations, initiated between former US president Donald Trump and North Korean leader Kim Jong Un in 2018, have stalled since 2019.

The US military's Indo-Pacific Command said North Korea's missile launches did not pose an immediate threat to U.S. personnel, territory, or allies, but highlight the destabilising impact of its illicit weapons programme.

Japanese Prime Minister Yoshihide Suga called the missile launch "outrageous" and strongly condemned it as a threat to peace and security in the region.

China's foreign ministry spokesman Zhao Lijian told a daily briefing that China hoped "relevant parties" would "exercise restraint".



BOOK REVIEW: FICTION

Patriarchy is a labyrinth that defies time

I am convinced that while writing her book, The Begum and the Dastan (Westland Publications, 2021), Tarana Husain Khan's aim was to leave her readers in a literary stupor, dizzy and yearning for more. A nested tale of love, inheritance, social conflicts, and survival, the novel boasts both real and fantastical themes. The book oscillates between three narratives: the story of the spirited Feroza Begum set in 19th century British India; the story of present-day Ameera, Feroza's great-granddaughter; and that of Mirza Kallan, a dastango (storyteller) who sips opium at the bazaar chowk and weaves tales so magical that the ambits of fantasy and reality become blurred to him and readers alike.

Wilful and fierce of spirit, Feroza Begum is the beautiful daughter of a wealthy Rohilla Pathan in the princely state of Sherpur during the British Raj. Her keen, inquisitive mind—admired by her husband and siblings but disapproved in a society so patriarchal—becomes the reason for her downfall. Happily married and loved by her family, young Feroza defies her father's wishes to visit the celebrations taking place at the Nawab of Sherpur's palace. At the event, Nawab Shams Ali Khan is enamoured by Feroza's fire and beauty and wants her for himself, as another gem in his glittering harem full of women. The Nawab confines her within walls against

her will, forced to divorce her husband and abandoned by her family. Feroza prays for deliverance but she does what she has to for survival-she marries the Nawab and is swept away in the confusing whirlpool of emotions, the grandeur and squalor that make up the life of a reluctant queen.

In the present day, Ameera, the greatgranddaughter of Feroza Begum, listens with rapt attention to her Dadi recounting Feroza's life story as a cautionary tale about female recklessness. Amidst these overlapping narratives, Mirza Kallan charms his audience with the story of a tyrant sorcerer in his magical city where women are tied with chains and tacit rules.

The lives of Feroza and the other women in the Nawab's harem are a stark contrast to his depraved, lavish life. The wives lead a life of puritanical obedience while the Nawab exercises despotism by punishing people who dare to defy him, usurping property of dissenters and capturing women he desires with or without their consent. As Feroza navigates this maze of 19th century court life thrust upon her, and as Ameera absorbs Dadi's account of Feroza's story, both women, despite the century of time between them, realise with grim clarity the cruel, unspoken rules that govern the lives of women regardless of age.

Both women cautiously tread a fine line between propriety and what society has labeled as female vulgarity. Dreams, aspirations and goals become secondary to gendered expectations. Misinterpreted religious texts and archaic tradition govern their lives.

Tarana Husain Khan is a master of imagery; her writing is imbued with elaborate descriptions of resplendent soirees, gloomy dungeons, and busy bazaars, that sweep you into the glamour and delusion of court life. Just as quickly, she will steer you through time and bring you face-to-face with the subversion of women's empowerment in present times.

The pilgrimages of survival across the pages of The Begum and the Dastan have not yet come to an end. Written in invisible ink, Feroza's story continues on in contemporary women as we try to navigate the toiling maze of age-old patriarchy. Turning the last page of this book does not constitute its ending; it is but a pause. A pause to breathe, to reflect, and to perhaps rethink our choices as individuals and a society.

A much-needed Bangla text on the history of Sufism


Sufibad O Sufider Shorup Shondhaney ('In search of the nature of Sufism and Sufis'), written by Syed Rezaul Karim and published in 2020 by Bangla Academy, is a welcome addition to the meager collection of books written in Bangla on Sufism. It is well known that Bangladesh is a predominantly Muslim country because of Sufi influences in its early history, yet books in Bangla on this subject are hard to find. Syed Rezaul Karim's is a product of research not by practitioners of Sufism or Islamic clerics but by a writer who has devoted two decades of his life studying and seeking to understand the concept and connotations of Sufism and the contours of the Sufi path of illumination.

In order to understand Sufism better, the author visited some of the places where celebrated Sufis were born, where they lived and walked the 'Sufi path of consecration'. In his search he travelled to Bistam, deep in Iran, where one of the early Sufi dervishes, Hazrat Abu Yazid al-Bistami (804-875 AD), was born and lies buried. Karim also visited the cradle of the Khorasani school of Sufism from the 10th to the 13th century in Nishapur, Iran. His quest to see and "feel" the Sufi path took him to Konya in Turkey where the great Sufi poet, Mowlana Jalaluddin Rumi, lived and practiced Sufism.

Karim draws up a kaleidoscopic picture of Sufism based on his research, such as the study of some of the earliest books written by Sufis themselves, including the 10th century's Tasaruuf by Kalabadi, and the 11th century's Risala by Abu'l Qasim Abd al-Karim bin Hawazin al-Qushayri and Kashf al-mahjub by Ali Ibn Uthman al-Hujwiri. Rumi's Mathnawi and Divan and Fariduddin Attar's Conference of Birds are frequently quoted to explain and enlighten the different dimensions of Sufism. The picture that emerges has some reflective characteristics. Sufism emanates from Islam and its esoteric knowledge. A Sufi is endowed with great moral character, a pure heart, and a life clad and concealed in material and spiritual poverty. The outward patched garment of a Sufi is symbolic: they walk on the twin path of self annihilation and of abandoning the material world. The goal is to attain Marifa—knowledge of God. A Sufi's constant companion is Zikr, which is "remembrance of God for

the love of God".

The book under review is divided into 16 chapters including such titles as "Sufism—a pen picture",
"Identity of a Sufi", "Pillars of spiritual
transformation", "Marifa", etc. There is a chapter on Sharia, Tariga, and Haqiga delineating the relationship between the three systems of the religious path. It also narrates the historical development of Sufism from the early period of Islam and its spread and influence in Bengal. One of the fascinating Sufi characters that is dealt with in the book is the enigmatic and spirited Mansur al-Hallaj (born 858 AD), whose ecstatic and wild utterances led to his death on gallows on charges of blasphemy by conservative rulers. Yet another chapter comments



on Sufi music exemplified in Mowlana Rumi's Sema, the whirling dance; another chapter looks into the role of women in Sufism.

The profuse use of poetry by Rumi, Attar, and other Sufi poets has made the reading of the book a pleasure. Anyone interested in Sufism and on Sufi masters will find it a rewarding experience.

The book is available at Bangla Academy Library.

Jointly edited by Ahasan Hydar and Snigdhadip Chakraborty, Ek Ashchorjo Phul Binoy Majumdar (Ashroy Prokashon, 2021) is a valuable book on the life and work of Bengali poet Binoy Majumdar, who was born on September

The book is composed of analyses by eminent and emerging poets as well as essayists from both sides of the Bengal border. In the book, friends and colleagues of Majumdar reminisce about the walks they took along College Street together, the lively discussions at coffee houses, and intimate talks at Binodini Kuthi at Shimulpur. The 824-page volume contains discussions on Majumdar's poetry, screenplays, and paintings from the likes of Gayatri

Chakravorty Spivak, Shamsur Rahman, Al Mahmud, Ahmed Sofa, and Ritwik Ghatak, among others. Ek Ashchorjo Phul also comes with a collection of published and unpublished stories, poems, and drawings by the revered Hungry Generation poet himself. At the beginning of every chapter are portraits of Majumdar drawn by different artists.

Editor Ahasan Hydar notes, "This book is the result of a five years-long effort. Readers can learn about the world of Binoy's poetry in a novel way through this book. Binoy was also a great mathematician. His thoughts on society [and] poetry, and the choice of diction in his poems, can charm everybody".

'The Green Knight' adaptation subverts the tenets of chivalric romance

Green Knight (2021), was initially just that for me: a riddle. It was one of those films where I felt like my experience of watching it would be more rewarding if I had some idea of the actual story it was based on. As I read through Sir Gawain and the Green Knight—an alliterative poem, written circa the 14th century, in a Middle English dialect by an anonymous poet—I realised it was the kind of endeavour that neither my very short attention span nor my patience was ready for;

Nope, couldn't let that blot my escutcheon. The poem starts with Britain's bloody and make-believe history. The poet then proceeds to tell of a tale he had heard about King Arthur and Sir Gawain, Arthur's nephew and the youngest of the Knights of the Round Table.

yet I already felt challenged. Being a folklore

junkie and not coming across an epic about

King Arthur's nephew and heir apparent?

During one Christmas celebration at the court, King Arthur demands to hear a marvellous story before he can feast. As if on cue, a giant knight rides into his court in emerald green attire. Not only his clothes, even his skin and his horse are green. This being lays down a challenge for whoever is brave and quick: he declares that a man from the court should strike him with his own axe, which he shall endure without fighting back. The catch, however, is that in a year and a day, he will strike the same blow to the contender in return.

Acclaimed director David Lowery's film opens with Gawain (played by Dev Patel) romancing Essel (Alicia Vikander), a commoner, in a brothel; only he isn't a knight—yet. The muted tones in this first scene, the heavy stone architecture, and the pale makeup of the characters along with velveteen, ornate costumes of greens and browns capture the rotting ambience of the medieval era. In Dev Patel's flawless rendition, Gawain becomes a gullible and befuddled youth, his naivety and youthful impulses offering a solid ground for the plot to rest upon. However, commoners and people of the court glorify this rather unseasoned knight-in-making because he is

Set up RT-PCR lab at Dhaka airport urgently

The long delay in doing this is totally unacceptable

T is absolutely unacceptable that migrant workers had to stage a fast-unto-death sit-in in front of the expatriates' welfare ministry on Tuesday to receive an assurance from the minister that an RT-PCR test service would be installed at Hazrat Shahjalal International Airport (HSIA) in Dhaka. The workers have been staging such protests for the past one month, leading to the prime minister, on September 6, directing the relevant authorities to set up an RT-PCR lab at the airport. Why hasn't one been set up even then? More importantly, why hasn't one been set up over the past year and a half of Covid-19, knowing how essential such facilities are for pandemic-time travel?

The fact that we don't have any Covid-19 testing facilities at our largest international airport yet is a disgrace. It shows just how indifferent the relevant authorities are to the plight of the people—and the migrant workers in particular. Even the prime minister's express directive couldn't nudge them into doing what they should have done of their own accord long ago. While this lack of compliance raises serious questions about administrative accountability, it is because of this kind of negligence that Bangladeshi migrant workers have been suffering immensely—and unnecessarily. Around 50,000 Bangladeshis working in the UAE have been stranded in Bangladesh for months now, unable to return to their workplaces as the UAE government has imposed a condition for migrant workers from different countries, including Bangladesh, that they must carry Covid-19 negative certificates based on RT-PCR test within six hours of boarding a plane. In response to that, if India and Pakistan could set up RT-PCR labs at their airports to aid their migrant workers, why couldn't we? The only logical answer is apathy on part of our authorities.

But why should such apathy towards the plight of migrant workers be acceptable? The government often boasts about the economic progress of the country riding on the backs of these migrant workers. But when it comes to providing vital, pro-migrant services, the government mostly seems either silent or reluctant, acting only when prodded into.

This attitude has to change. The authorities need to prioritise the needs of our migrant workers. Throughout this entire pandemic period, migrant workers have suffered more than most other groups. And during their times of urgency, the government has failed to lend them the needed support. We expect the expatriates' welfare ministry to do much better in supporting our migrant workers. And the government in general needs to do a better job. Setting up an RT-PCR lab urgently at Dhaka airport will be a positive step towards that goal.

Not enough time for students to register for vaccine

Authorities must conduct vaccination of university students in a more organised way

E are sceptical about the recent government decision that any university can resume inperson classes if all of its students complete online registration to get the Covid-19 vaccine by September 27. Earlier, the deadline for reopening the universities was set at October 15.

According to a report by *The Daily Star*, 60 percent of the country's university students are yet to register for the vaccine. Currently, students over the age of 18 years can register using their national ID cards. But for those who do not have NID cards, the University Grants Commission (UGC) has said it will create a link on its website, through which students can register using their birth certificates. The list of students will be forwarded to the health authorities, and students will then be able to register using the Surokkha platform. Once registered, they will be vaccinated on a priority basis, as decided in a meeting between the education ministry officials, the UGC, vice-chancellors of the public universities, and health officials on Tuesday.

However, the mishandling, miscalculations and chaos that we witnessed during the special mass vaccination drives in August and earlier this month (conducted by the city corporations) give us pause as the drives for registration/inoculation of all university students may very well face a similarly chaotic situation.

Even if all students, regardless of their NID status, register for the vaccine by September 27 and begin to attend classes, how does this address the threat of virus transmission in the classrooms in the short term? After all, even if the registration plan goes as expected, the students will only be registered for vaccination at the time of reopening; it may take them weeks to get their schedule for the first dose, and at least a month to get their second dose. There are real concerns about what might happen if the 44.34 lakh or so university students across the country start in-person classes without being fully vaccinated. Will it lead to a surge in Covid-19 infections? When the time for their vaccination comes, will we again see the pandemonium that marked the two special mass vaccination drives? Most importantly, are there enough vaccine doses to inoculate all university students alongside the 2.03 crore citizens who have reportedly registered but have yet to get their first dose?

While we would, of course, like to see the university students return to their classrooms, we hope this will not happen in a haphazard manner, giving way to another wave of Covid-19 infections. We hope the health officials are right about having enough vaccine doses in stock, but we urge the authorities concerned to conduct the vaccination of university students in a more planned and disciplined manner. Otherwise, this much-needed action may cause more chaos than relief.

Here comes the flood

A 'wobble' in the moon's orbit working in tandem with rising sea levels will create record floods in the near future

effect on our surroundings. Today, our fingerprints on the environment can be found everywhere—the atmosphere, the oceans, and the Earth's surface. Not to be outdone, there is now another player, up in the sky—the moon, whose periodic "wobble" together with rising sea levels on Earth will make high tides even higher in the near future, eventually leading to devastating floods around the world.

the tidal bulge ahead of the moon's orbit, while the moon's gravitational attraction tries to pull it backward. The Earth, therefore, feels a drag force known as tidal friction, which has slowed down its rotational period from five hours almost four billion years ago to 23 hours 56 minutes today.

The moon takes the same time—27.3 days—to rotate once on its axis as it takes to orbit the Earth. This is called synchronous rotation. In other words, the moon is tidally locked with Earth, which means we always see the same side of the moon, irrespective of where the moon is in its orbit.

Additionally, there is an apparent wobbling and nodding of the moon, collectively called "libration." The wobbling is similar to the back-and-forth motion of a simple pendulum. It is an effect of the moon's non-uniform speed

tilted by 1.5 degrees. Furthermore, moon's orbital plane is inclined to Earth's orbital plane by about five degrees. The net effect of these inclinations is an up-and-down wobbling, or nodding, in a north-south

Alongside global warming, lunar wobbling can either exacerbate the severity of tides or counteract them. During one half of the 18.6-year wobbling cycle, high tides are lower than normal and low tides are higher than normal, so the difference between the two is rather small. As a result, it negates the effect of rising seas to some extent. During the other half of the cycle, high tides get bigger and low tides get lower, thereupon increasing the range between the highest and lowest tides. This cycle boosts the effects on the sea level rise.

The moon is now in the tideamplification cycle, but the sea level The study is the first to take into account all known oceanic and astronomical causes for floods. According to the study, these floods will exceed flooding thresholds in the coastal countries more often—as frequently as every day or every other day. They may even occur in clusters and can last as long as a month or more, depending on the positions of the moon, the Earth and the Sun. "It's the accumulated effect over time that will have an impact," the study warns. However, it also notes that the prediction does not apply uniformly to every coastline everywhere.

Climate change has already increased the frequency and severity of hurricanes, floods and other extreme weather events around the world. This impending threat on the horizon could wreak additional havoc, thereby worsening the already grim predictions of climate change for people living along the coastlines. Some of the biggest cities on the US Atlantic and Gulf coasts, including New York City, Miami and New Orleans, will be hard hit. Osaka in Japan is also a major-risk city; climate models show it could "disappear" with rising tides. Other high-risk cities are Alexandria in Egypt, Rio de Janeiro in Brazil and Shanghai in China.

It took Noah years to build an ark to save him and his family from a godless society that God was going to destroy by sending a catastrophic flood. Unlike Noah, we have 15 years, more or less, to build the ark of mitigation and adaptation necessary to save us from the calamitous effects of climate change. It is thus a race against time, because the flood is coming faster than many once thought. Keeping this in mind, Nasa's Sea Level Change Team is providing crucial information so that we can "plan, protect, and prevent damage to the environment and people's livelihoods affected by flooding." Unfortunately, if poor low-lying countries like Bangladesh become the victims of high tides caused by lunar wobbling, they will suffer immensely because they may not have the technology and/or sufficient fund to implement Nasa's recommendations.

Finally, our moon, until now the quiescent mystical object majestically shining in the sky, has been "faithful to its nature and its power is never diminished." One of the powers it always flexed (albeit unnoticed by us) and will flex again approximately 15 years from now—but this time working in tandem with climate change—is its ability to create record floods. The floods will perhaps give our leaders, who are not doing enough to combat climate change, an alibi to throw in the towel by blaming the wobbling moon.

Bangladesh is among the countries that are at a high risk of flooding likely to be caused by the combined effects of rising sea levels and lunar wobbling.

High tides are caused mostly by the gravitational pull exerted by the moon on Earth. But because our planet's lone natural satellite wobbles ever so slowly over a predictable 18.6-year cycle, the power of the pull varies from year to year. Nevertheless, the result is two simultaneous high tides: one on the side of Earth facing the moon, and the other on the opposite side.

Earth rotates on its axis much faster than the moon revolves around it. Our planet's rapid rotation coupled with higher orbital speed about the Sun drags

along its elliptic orbit around Earth. The orbital speed increases as the moon approaches the perigee, which is the point closest to the Earth. It decreases as it recedes from the perigee and approaches the apogee, the point farthest from the Earth. This gradual increase and decrease in the orbital speed causes the moon to wobble back and forth—at least to our eyes—by roughly seven degrees in the east-west direction.

The wobbling motion also arises from the fact that the moon's rotational axis is not perpendicular to its orbital plane; it is has not risen enough yet due to climate change for the effect to be pronounced. However, a new study by scientists from Nasa and the University of Hawaii published in the peer-reviewed scientific journal *Nature Climate Change*, only days before the recent destructive flood in Western Europe, warns that Earth may experience record flooding in the mid-2030s, when the moon's next tideamplification cycle is set to happen. By then, global sea levels will have risen enough to make the already elevated high tides especially troublesome.

Financing a Sustainable Global Food System

HE global food system is unsustainable. While it is worth approximately USD 8 trillion annually, its negative impact is valued at roughly USD 12 trillion.

And this is not the system's only contradiction. Around the world, food systems are both affected by climate change (owing to disruptive weather and rising temperatures) and make significant contributions to it (through greenhouse-gas emissions and biodiversity destruction). The millions of jobs they provide are often low-quality and poorly paid. And, most significantly, they fail in their ultimate purpose of

delivering affordable, healthy food to all.

Because the global food system is fundamentally unviable, change is inevitable. But the radical reforms needed to create an inclusive, sustainable sector that produces nourishing food for the world's population may have devastating short-term consequences. If we take the wrong approach, incorporating the true costs of production into food systems could trigger widespread bankruptcy, devastate rural unemployment, drive up prices, and increase poverty.

The best way to achieve a rapid, fair, and safe transition to a sustainable global food system that can deliver affordable, healthy food for all is, however, a matter of heated debate. This is reflected in the strident and largely unproductive discussions taking place in the run-up to the United Nations Food Systems Summit, to be held on September 23 during the UN General Assembly.

From a production standpoint, advocates of regenerative farming vehemently oppose a new generation of soilless food production, such as lab-grown "alternate protein" and vertical farming. But it is tough to scale regenerative farming rapidly. Soilless systems must be a major part of the

solution, given their dramatically reduced carbon footprint and water use, minimal impact on biodiversity, and potential for rapidly delivering cheap, healthy food at scale

The role of finance in this transition is no less controversial.

There is some merit to complaints about the undue influence of a limited number of private players on decisions that impact the entire global food system. Financialisation—the drive to maximise risk-adjusted financial returns—is increasing across the global food system, and market concentration is growing. For example, just ten companies control half of the world's seed market, and four agribusiness firms account for 90 percent of the global grain trade. Just one percent of agricultural firms own 65 percent of the available farmland.

Financialisation reinforces the unequal distribution of economic returns, squeezing the incomes of small farmers and communities, while supporting business models that under-supply healthy, affordable food, and over-supply foods containing high levels of salt, sugar, fat, and carbohydrates. Moreover, financialisation amplifies corporate lobbying that externalises public health costs, maintains perverse agricultural subsidies, and ensures that the costs to the climate and nature do not adversely affect financial bottom lines.

But private capital is absolutely necessary for financing the global food system's transition. We need to harness the massive financial resources managed on our collective behalf by pension funds, banks, and private equity while mitigating the dangers of financialisation.

In a recent report, Making Finance Work for Food: Financing the Transition to a Sustainable Food System, the Finance for Biodiversity Initiative maps out the role global finance can play in the needed transition. The report, prepared in association with the Food System Economics Commission, describes four ways financial tools can be used to shape future food systems.

For starters, financial policies and

regulation, reinforced by shareholder and public activism, must drive investors' internalisation of the costs to nature and climate in their financing decisions. This change would strand dirty assets, accelerate green-friendly investments, and trigger a shift towards more nutritious food production.

Second, financial innovations, including blended public and private solutions, are needed to accelerate

soilless forms of food production.

Finally, we need to create opportunities to empower citizens, especially by harnessing the power of digitalisation.

As consumers, they can make an impact by adopting improved, sustainable diets. As investors, pension policy holders, and taxpayers, they can advocate for better uses of their money.

investment in healthy food produced by climate- and nature-friendly forms of farming, thereby driving down costs. Such innovations could involve scalable instruments equivalent to the feed-in tariffs that have been used to great effect in catalysing investment in renewable

Third, policies and public finance are needed to protect and retrain those whose livelihoods are eroded during the transition. The goal should be to provide technology, skill development, and capital to enable them to own and operate commercially viable regenerative and

We need to overcome the resistance not only of those who profit from today's systems but also of those who seek to protect the vulnerable. Resetting global finance and harnessing its benefits is necessary to fund a rapid, sustainable, and equitable transition.

Where logic ends, our power development begins

Crores of taka are wasted due to overcapacity, yet prices go up



VER a decade supply in Bangladesh was inadequate and production was virtually nonexistent. Increasing power production was a dire necessity then. The last caretaker government

initiated efforts to that end; those efforts gained momentum when the Awami League government took office in 2009.

As soon as they came to power, the Awami League government started propelling the development of oil- and gas-based rental and quick rental power plants as a part of their overall effort to increase power production in the country. Several ruling party leaders, lawmakers, and businessmen were given approval to set up quick rental and rental power plants—even those with no prior knowledge or experience in the area. The process raised many questions then, as it had several loopholes: there was no mechanism to check the expertise of the producer; the prices were too high; and the producers were able to bill the government for "capacity charge" despite zero production of power.

Because of these loopholes and the lack of transparency in the entire power production process, the government faced a lot of criticism. Yet, it stayed firm on its decision. In order to avoid possible legal actions in the future—as well as to smoothen the process of opening up these power plants—the government formulated a law named the Quick Enhancement of Electricity and Energy Supply (Special Provisions) Act, passed in parliament in 2010.

Despite all these issues, the power sector in Bangladesh began to see higher output, and people started getting electricity supply per demand. There were still concerns regarding the alleged corruption in the sector and the price hike, yet the general populace started to experience a sense of relief. Residences, commercial establishments and factories started to get uninterrupted power supply. It seemed the curse of "load shedding" was finally being lifted from the country.

But those issues still exist, and have become causes for concern. According to experts, there are some major shortcomings in the overall "development philosophy" of the power sector in Bangladesh. Before, there was a severe lack of supply, but now we have ample amount of power. There is no clear answer to some vital questions, such as how much power the country needs, to what extent does the production capacity need to be enhanced, etc.

In 2008-09, our electricity output was around 3,800MW against a demand of around 7,000MW, which means there was a shortage of more than 3,000MW. At present, the total demand for electricity ranges between 9,000MW and 12,000MW. But the country's power generation capacity is more or less 22,000MW. As yet, the daily power production has topped at 13,000MW. The average daily production now is 9,000MW. The daily demand for power rarely exceeds that amount, which means we are operating at less than half

of our power generation capacity.

Despite this situation, because of the conditions set in the agreements, the government is forced to pay the producers the capacity charge for about 12,000MW of power that is not even produced. That capacity charge amounts to a whopping Tk 9,000 crore.

In 2020, the Centre for Policy Dialogue (CPD), a Dhaka-based think tank, said about 60 percent of the power plants in Bangladesh were sitting idle and earning money in the form of capacity charges. According to last year's data provided by US-based research firm the International Energy and Environment Foundation (IEEF), about 57 percent of the

grid has not been set up yet. There is no other way to connect the output of the power plant to the national grid, which means it is not operating at its full capacity.

We are being forced to pay Tk 100 crore as capacity charge for the Payra power plant as

The organisation that was appointed to build the transmission line failed to meet the deadline. The contractor was fired and replaced with a company named China National Machinery Import & Export Corporation. line, there has been no scope for testing the full capacity of the two units [of Payra power plant]. But the power plant has been approved to go ahead with commercial production," he

"As the government has to bear the cost of idle capacity charge for the power plant, the cost of per unit power generated there has gone up to Tk 10. This is the opposite of what the aim of such a large-scale power plant was-cheap electricity. In this case, the country's greater interest has been ignored to favour the power plant's benefits," he added.

Saying that the electricity generated at Payra coal-fired power plant would not be usable

idle power plants is causing a huge loss." He also said transmission lines should be installed keeping in line with the construction of the power plants.

The Payra coal-fired power plant is importing coal at a price of USD 100 per tonne to fuel the production. The Barapukuria coal-fired power plant is buying coal extracted from the local mines at a price of USD 150 per tonne. A Chinese company is mining the coal from Barapukuria and selling it to the Bangladesh Coal Mining Company Ltd (BCMCL). The BCMCL is paying an extra USD 50 per tonne in order to buy locally mined coal, compared to the price paid for imported coal. As there is a scarcity of locally mined coal, the Barapukuria power plant is running at 50 percent capacity. Still, the cost of producing each unit of electricity is Tk 6.5 at Barapukuria, whereas the same costs Tk 10 at Payra. This leads to the question: Is the "impunity law" being exploited to build exorbitantly expensive power plants?

There are a few other big power plants under construction in Bangladesh. In Rampal, Bangladesh and India are jointly building a 1,320MW power plant. Japan is financing the construction of a 1,200MW power plant at Matarbari in Moheshkhali, Cox's Bazar. In Pabna's Rooppur, a 2,400MW nuclear power plant is being constructed. There are plans to supply electricity to the national grid from this two-unit power plant in 2023.

The government contracts with the rental and quick rental power plants will be expired by the end of this year. The Bangladesh Power Development Board (PDB) has sent a proposal to Bangladesh Energy Regulatory Commission (BERC) to renew contracts with five gas-fired rental and quick rental power

Bangladesh is also importing electricity from India. As per the contract, we have an arrangement to procure 1,200MW of power from India on a daily basis. From India, Bangladesh is buying coal-fuelled and gasfuelled electricity at a price of Tk 6 and 7 per unit, respectively.

Bangladesh will also buy hydroelectricity from Nepal, where India will act as the third party. It is not confirmed as to what amount of electricity will be procured, but the price per unit will be nearly Tk 8.

Before, there was no electricity; now, there is. This has become the guiding philosophy behind power generation in Bangladesh. But there is a disconnect between this philosophy and a science-based working plan. We have big power plants, and coal-fired plants that are extremely harmful to the environment are already in production—yet, the prices of electricity are not going down, nor is there any such possibility on the horizon. Crores of taka from the state coffers is getting squandered away in the name of capacity charge. Some producers are making money without generating any power, while the consumers are being forced to pay high tariffs.

power plants in Bangladesh are sitting idle. According to a source, a recent utility report from the power sector—which has not been made public—shows that in 2023-24, the country's power overcapacity will be as much as 66 percent, which means the burden of capacity charge will grow even bigger.

After building some small rental and quick rental power plants, the Bangladesh government proceeded to make big investments in big, coal-based power plants. But how these plants will be connected to the national grid, where the electricity generated from these plants will be used, and whether there is a demand for that power still remain unclear. A key benefit of having large-scale power plants is that the production costs go down, but the opposite is happening in Bangladesh.

The two-unit Payra thermal power plant, with 1,320MW power generation capacity, officially went into production last year. But the 400kV transmission line required to supply the generated power to the national

said: "We hope the work for the transmission line will be complete by next year. The work was interrupted due to a spike in coronavirus infections.

He further said: "As long as we are not being able to utilise the produced electricity [from Payra power plant], we will be forced to continue paying the capacity charge.

Even if the transmission line is established within the deadline specified by the state minister, we will be forced to pay a monthly capacity charge of Tk 100 crore for nearly a year and a half. It is also not certain whether we will be able to use the electricity generated at Payra plant even if the transmission line is

Energy expert Prof M Shamsul Alam also voiced his concerns regarding the transmission line and the issue of commercial production at Payra power plant.

"The approval for commercial production can be given only when full-capacity production is confirmed by running tests. Since there is no functional transmission

even when the transmission line is in place, Prof Shamsul Alam added: "The issue of the transmission line is being used as an excuse. Even if the transmission line is installed and fully functional, the 1,320MW of power generated at Payra plant cannot be used in full. Moreover, the second phase of Payra power plant has been initiated, which will see the construction of another plant with an additional 1,320MW generation capacity, set to be completed by 2024. There is a complete lack of transparency regarding the usage of that power. A big sum of money is being spent, in a non-transparent manner, in order to construct unnecessary power production facilities. Because of these coal-fired plants, not only is the biodiversity of the area +facing a threat, but money is being wasted as well.'

Prof M Tamim, former adviser to the caretaker government and an energy expert, said: "Although it is claimed that Bangladesh's overall power generation capacity is 22,000MW, in reality it is about 15,000-16,000MW. But paying for capacity charges for



Petrobangla then organised a meeting with Bangladesh CNG Filling Station and Conversion Workshop Owners' Association, and others in this regard.

Farhan Noor, secretary general of Bangladesh CNG Filling Station and Conversion Workshop Owners Association, told The Daily Star they urged reducing the closing time from six hours to three hours.

"We have the lowest amount of gas with the highest price. It would not be a wise decision to keep filling stations closed. But they requested us and we agreed to keep them closed for four hours."

The decision came after a virtual meeting about producing low, middle and long-term plans on the demand and supply in gas-based power plants on July 19.

About two-thirds

have attained their expected returns from investments.

The industrial sector was badly hit by the pandemic as all the distribution channels were disrupted, he said.

Even then, the industrial units tried to continue production.

He went on to acknowledge that such an increase in industrial default loans is not good for the economy.

The real crisis of default loans has reached an alarming stage, said Muinul Islam, a former professor of the department of economics of the University of Chittagong.

"Since the flow of our remittance is still on, the banks are not facing any deposit crisis. This is why we are not realising how big the problem of default loan is," he added.

Meanwhile, the disbursement of industrial loans also dropped during the pandemic, Kamal said.

In the first quarter of last year, industrial loans amounting to Tk 91,662 crore were disbursed. In the following quarter, it was Tk 74,257 crore. Loan disbursement picked up

in the latter half of 2020 as the pandemic flames were brought under control: in the December quarter, it was Tk 100,533 crore, Kamal said. At the end of the first quarter of

2021, industrial loan disbursement stood at Tk 90,966 crore. The finance minister also disclosed

that the per capita foreign debt of Bangladesh is Tk 24,890.

In reply to a question, the minister said the current foreign debt stood at \$49,458 million.

FROM PAGE 12 Researchers plan to do this by taking skin cells from Asian elephants, which are threatened with extinction, and putting them into stem cells with frozen mammoth DNA to create an embryo.

These embryos will then be carried to full term by a surrogate mother or in an artificial womb in a laboratory.

The team hopes to have its first set of calves within the next six years if all goes to plan.

Dr Church and Lamm believe the elephant-mammoth hybrid could help slow climate change by stomping out thin, low-oxygen trees and exposing healthy, carbon-trapping grasses to restore the Arctic tundra.

"Our goal is to make a coldresistant elephant, but it is going to look and behave like a mammoth,"

Dr Church told the Guardian. He added: "Not because we are trying to trick anybody, but because we want something that is functionally equivalent to the mammoth, that will enjoy its time at -40C, and do all the things that elephants and mammoths do, in particular knocking down trees."

mid-October, he added.

"We hope [the number of] dengue [cases] will start coming down within this month in Dhaka, but it does not mean it [the infection] will totally stop [spreading], rather it will remain on a smaller scale... Still, there is scope to control dengue outside Dhaka as the number is still low.'

City

Residents outside Dhaka will have to use mosquito nets and make their children wear full-sleeved clothes and long pants to keep them safe from dengue. They will also have to use mosquito repellents to kill Aedes mosquitoes at least twice a day, he

It will not be convenient to conduct anti-mosquito drives throughout whole cities, rather they will have to carry it out in focused areas, he said.

Entomologist Kabirul Bashar said all the areas outside Dhaka where dengue cases are being found will have to be considered hotspots.

"Authorities concerned will have to conduct fogging and larviciding in the areas, including the homes and workplaces of the patients... If they [any hotspots] are in cities, then the city corporation or municipality will have to take measures and if they of

parishad or union parishad concerned will have to do it.

Keeping every patient under a mosquito net is also very important, Monzur said.

Saifur Rahman, another entomologist, said effective measures to kill Aedes mosquitoes are lacking in areas outside Dhaka. Fogging is crucial as without it

killing infected mosquitoes is not possible, he said. He said the mistake done in Dhaka

should not be repeated outside Dhaka.

"So, wherever cases are found, intense fogging should be done there.' Moreover, he said, the DCC should take special care and conduct fogging operations in and around major bus

stands like Gabtoli, Sayedabad and

Mohakhali to stop the movement of infected mosquitoes in public transports from Dhaka. "Owners and the authorities concerned will have to spray insect

repellents in their transports.

An adult mosquito can survive from 15 days to 61 days and, on average, 21 days. If not killed, it can infect people multiple times, said Saifur.

He said there are many areas where dengue patients are found every other year. "The authorities will have to identify those areas and will have the village level, then the upazila to conduct extensive anti-mosquito

drives there."

LGRD Minister Md Tazul Islam said different authorities concerned of the government are doing their jobs to control Aedes mosquitoes even outside Dhaka, but everyone will have to come forward and help, otherwise it will not be possible.

He said most of the patients outside Dhaka contracted the infection while they were in the capital.

He emphasised the need for patients to stay under mosquito nets. 'If they don't, the mosquitoes in rural areas will also begin carrying the virus."

Abu Ali Md Sazzad Hossain, deputy commissioner of Pirojpur, said the number of dengue cases in their district is low at the moment and separate committees have been formed up to the union parishad level to monitor the situation and take apt measures in this regard.

He added that regular cleaning activities are going on there and public representatives, including those from different organisations, are also involved. Fogging and other anti-mosquito drives are also being conducted in and around patients'

"There are separate dengue units in hospitals and they provide immediate treatment to the patients."

'Liton can be a top 10 batsman in the world'

Bangladesh batting consultant Ashwell Prince, who has been with the Tigers since their series against Zimbabwe in July this year, spoke to The Daily Star's Ekush Tapader in an exclusive interview, discussing the Tigers' consistency problems in the opening positions and their overall plans going into the T20 World Cup in Oman and the UAE next month. The excerpts are given below:



(DS): Bangladesh won the series against Australia and New Zealand

comfortably but the batsmen struggled to score runs. Do you think there are concerns in the batting department going into the T20 World Cup?

Ashwell Prince (AP): World-class batsmen with a lot of experience in franchise T20 tournaments and international matches from all three teams (Australia, New Zealand and Bangladesh) struggled to score runs fluently during those series. Those pitches were very tough to bat on for everyone.

DS: There was a lot of discussion about the wicket prepared for the past two series. Do you think the Mirpur surface helped in terms of World Cup preparation?

AP: The Mirpur pitches were really difficult. They were very slow and spun a lot. It was obviously really difficult for the groundstaff to get them much firmer during the rainy season. Having said that, the IPL is about to restart in the UAE and by the time the WC starts, those pitches might also be a little tired and start spinning. If things turn out that way, one could argue that these matches versus Australia and New Zealand could be very good preparation. Having said that, if the pitches are better, I think it's easier for batters to adapt to conditions where the ball comes on better and spin less.

DS: What should the batsmen's main focus be in the Oman camp ahead of the World Cup?

AP: Their main focus will be to find their rhythm and have clear game plans going into camp in Oman. It was very hard for the batters to find rhythm in Bangladesh.

Considering inconsistency in the opening position, especially in the T20 format, what sort of approach do you want to see from the two openers at the T20 World Cup?

AP: As coaching staff, we know what our openers are capable of. They showed glimpses of it on those tough conditions. I'm confident we'll see the best of them on better surfaces.

DS: Liton Das has been

AP: We had a couple of AP: The one thing I'd like to see conversations and we identified terms of his batting. We worked on it extensively during the New Zealand series while he wasn't playing. He feels much better now.

DS: Naim Sheikh got some runs but struggled to rotate the strike, sometimes spiking the number of dot balls in some crucial situations. How can he improve his game and

AP: Once again, the number of dot balls were high for all batters. However, for any young batsman making their way into the international game, whether T20 or 50-over cricket, it makes life a lot easier if you can reduce dot balls. It makes life a lot easier. He might just need a little clarity in his game plan in terms of his best options to keep the scoreboard ticking over.

DS: How should Bangladesh best take advantage of their depth in the lower middle order at the T20 World Cup?

AP: I don't want to give away too many secrets (smiles).

DS: How crucial is the number three spot in T20? What are the team's demands from a number three in this format?

AP: Every batting position from 1-8 is important because these are the guys ultimately responsible for getting the runs. If we're depending on No. 9,10, or 11, then we're in a bit of trouble. In terms of roles, the top four obviously require more adaptability because you may come to the crease in a range of different scenarios. 5-8 generally have to come in and be aggressive almost immediately.

DS: Despite Shakib's success at the number three position in ODIs, he has not always featured at that position in T20s? Do you feel Shakib needs a fixed position at the T20 World Cup?

AP: With his all-around skills, Shakib will always be a very important player for Bangladesh and I'm sure he will play a massive role with bat and ball at the T20 World Cup. However, for me there always has to be flexibility in the line-up. Hypothetically speaking, if we have a left-right opening partnership and the right-handed batsman is out first, do we want two lefties at the crease or do we want to continue with left-right? These are minor details that go into planning where the flexibility of the group comes in.

DS: Do you see Afif coming in to bat earlier in T20Is?

AP: Introducing the right guys into the match at the right time is always a balancing act. Afif will play a massive role at this tournament. He is still young, but another that I think can become a big player on the international stage.

Lower-tier leagues set to begin in November

The lower-tier cricketers of Bangladesh receive some good news at last, long after the coronavirus outbreak last year, as the Bangladesh

Cricket Board (BCB) director and the Cricket Committee of Dhaka Metropolis (CCDM) chairman Kazi Inam Ahmed informed the lower-division leagues are set to begin in November this year.

Although the top-level cricket involving the national team returned

gradually alongside the Dhaka Premier League, however, the lower-division cricket was kept to a standstill, where the players had spent anxious time over the past two years.

The financial struggle has even forced many cricketers to seek alternate means of livelihood and thus, the announcement will arrive

as a huge source of relief to the lower-tier cricketers of Bangladesh.

"We [CCDM] have been able to complete the Dhaka Premier League successfully and at this moment it has become important for us to get the lower-division leagues back to the field. We already had a discussion on this issue and at the moment, we're working on coordinating so that we can start the 1st, 2nd, and 3rd division cricket in November-December this year.

"We've already planned to sit with all the clubs of all the divisions soon, like we do every year. We need to set the dates to play the tournament within the cricket season, which is November, December, January, and February," Inam told the media at Sher-e-Bangla National Stadium yesterday.

Inam informed that the authorities will follow the Covid-19 guidelines set by the government and as per suggestions of the board and CCDM.

"Now the country is slowly resuming normality. There is no lockdown and every

sector is open, including even schools and colleges. But there is a guideline given by the government so we'll see and follow those in the lowerdivision leagues and also take suggestions from the BCB and CCDM," added Inam.

The CCDM chairman further added that they are willing to return to the usual 50-over format of the Dhaka

Premier League for the upcoming season, set to begin in March-April.

"Last year we had a tiny window in which we had to complete the tournament by resorting to the T20 format. Since Dhaka Premier League, one of the most popular leagues of the country, is an A-list tournament and one-day international being our strongest format, the Dhaka League will be played in its traditional 50over format," Inam concluded.

Though the spread of dengue outside Dhaka started comparatively late, the growing number of cases shows that the situation may soon take a turn for the worse if

necessary measures are not taken immediately to curb further spread, experts entomologists.

According to the Directorate General of Health 14,831 dengue cases were reported around

the country starting from January till 8:00am yesterday. 1,601 of those were outside Dhaka and 13,230 were in

In 2019, the total number of cases was 1,01,354, of which 49,544 were outside Dhaka -- the highest since 2000, according to DGHS data.

Monzur A Chowdhury, entomologist and former president of the Zoological Society of Bangladesh, said the rate of dengue outside Dhaka will continue to rise this year if proper steps are not taken. The dengue infection started in the capital earlier than it did outside Dhaka, for which it is likely to keep increasing there (outside the capital) till SEE PAGE 10 COL 2

POWER RATIONING **CNG** stations to stay shut 6-10pm from September 19

The government has decided to keep CNG filling stations closed from 6:00pm to 10:00pm -- the peak hours of electricity supply -- every day for power rationing.

The decision will be applicable from September 19, Mir Mohammad Aslam Uddin, public relations officer of the power, energy and mineral resources ministry told The Daily Star last night.

"The decision was taken to ensure uninterrupted gas supply to power plants," he said.

It could not be known exactly how long the rationing would continue. However, an official said it could be for three months or until further notice.

Earlier, the ministry had decided to apply decision from September 15 but then called for a meeting with the authorities concerned on Tuesday and changed the date.

As of March, total default loans stood at Tk 95,085 crore, which is 8.07 per cent or the total outstanding loans, according to data from the Bangladesh Bank.

Kamal acknowledged that the amount of classified loans increased slightly in the

first quarter of the year. According to the Bank Company Act, no bank or financial institution has the opportunity to provide loans in favour of a

bad client or defaulting borrower.

EVACUATED FROM KABUL

6 Bangladeshis back home from Spain

Six Bangladeshis who were recently evacuated from Afghanistan and flown to Spain were repatriated from the European country yesterday.

The names and identities of the Bangladeshis could not be known immediately.

A Turkish Airways flight carrying them landed at Hazrat Shahjalal International Airport in the capital around noon, said an official at the airport's immigration department.

The foreign ministry on its official Facebook page yesterday announced that the six Bangladeshis started their homeward journey from Spain's Malaga Airport on

The Bangladeshis were evacuated from Afghanistan by the US army and initially taken to Saudi Arabian capital Riyadh on August 28. They were then flown to Rota military base in Spain in a

US military plane on August 30, reads the foreign ministry The Bangladeshis were staying at the base under the US

army's supervision, the Facebook post said. After they sought support from the Bangladesh embassy in Madrid, the foreign ministry directed the embassy to

take necessary measures for their repatriation. The Bangladesh embassy immediately established communications with the Bangladeshis and also successfully established communications with the Spanish foreign ministry, US embassy and US officials at the Rota base.
