They want to 'approve' new entrants

Asks BERC to make membership of their association mandatory for new licences

LP gas importers, distributors and CNG filling stations owners want a new clause in BERC License Regulations requiring their certificates for any new entries in this sector.

In a written proposal to the Bangladesh Regulatory Energy Commission (BERC), CNG Filling Station and Conversion Workshop Associations yesterday Owners' requested to include membership certificates of the association among other documents required to be a new

BERC organised a public hearing at their head office, after the proposal was placed before them, to make necessary reforms in it's Licence Regulations 2003, where the owners of different CNG and LP gas companies demanded the new clause.

They attached a commerce ministry gazette dated June 22, 2017, saying that all authorised CNG stations must get the membership of the CNG Filling Station and Conversion Workshop Owners' Association.

After their proposal, Zakaria Jalal, executive director of Basundhara LPG, demanded a similar clause for LPG

In the liquified petroleum gas sector, LPG Operators' Association of Bangladesh (LOAB) is controlling the market along with new entries, claimed the concerns. They said BERC set prices for LPG but couldn't implement them for this reason.

Experts, however, said if the BERC caves in to these demands, it will legalise the "syndicate" that currently controls the sector.

"This kind of proposal and practice are conflicting with the BERC's act," said Prof Shamsul Alam, energy adviser of Consumers' Association of Bangladesh.

Contacted, High Court lawyer Barrister Tureen Afroz told the Daily Star that such proposals constitute conflict of interest.

"The Commission is the absolute authority to issue a licence. Here, if I say it's mandatory to join an association to get a license, it means the associations would be the regulating authority here. There will be a syndicate who will decide whom to include or not."

According to clause 15 of the Competition Act, 2012, no person shall, directly or indirectly, enter into any agreement or collusion, in respect of production, supply, distribution, storage or acquisition of any goods or services, which causes or is likely to cause an adverse effect on competition or creates monopoly or oligopoly in

BERC Chairman Md Abdul Jalil and member (gas) Md Maqbul-E-Elahi Chowdhury said such a clause could be a contradiction with the Competition Act, 2012, and so they will talk to the authorities concerned.

At first BERC member (Admin, Finance and Law) Mohammad Abu Faruge presented the background of this public hearing. He said they have changed some of the clauses of the BERC regulations 2003 in 2016 "mistakenly" without the law ministry's permission and published a gazette in this regard without the ministry's vetting.

After that, they started the process of rectifying the mistake in 2017.

The process slowed down during the pandemic, but they are now following every step of reforming the regulations, including pre-publishing, public hearing and sending it to the law ministry for their vetting for a Statutory Regulatory Orders (SRO) number, he said.

The 2016 Regulations had no SRO

During the public hearing yesterday, the representatives of different electricity, gas or petroleum companies placed their demands to reduce the license fees or renewals.

Some of them wanted the renewal of licenses after at least three to five years instead of existing one year. Some demanded changing their licensing categories, while some wanted the reduction the penalty.

The Draft Regulations have a clause 15 (B) -- where they mentioned the Commission could change the fees from time to time.

Two of the attendees demanded the withdrawal of the clause or the inclusion of a line that the commission could change the fees after a notification issued within a specific period and speaking to those concerned.

Chairman Abdul Jalil said that they will notify before any change.

Evaly couple in cuffs

individuals involved with the company's financial management of embezzlement in a case filed with Gulshan Police Station.

The complaint mentioned that different media reported that Evaly embezzled Tk 700-800 crore from consumers like him through scams orchestrated in the name of selling goods.

e-commerce company disrupted Bangladesh's e-commerce landscape since its entry on December 16,2018 with its incredulous discounts.It began to face investigations amid allegations of delayed delivery of goods after receiving the payments.

Khandaker Al Moin, Rab's Legal and Media Wing director, told reporters at a briefing in the evening that the raid was conducted after a case was filed against the accused over misappropriation and deception.

The e-commerce company has been in discussion for some time amid the allegations as disgruntled customers demonstrated against the company.

On September 14, a governmentformed panel on e-commerce recommended that the commerce ministry hand over the matter of Evaly

to the home ministry for taking legal action for anomalies in its business.

The move came after Evaly, in response to the Commerce ministry's directive to explain the whereabouts of around Tk 338 crore that it owed the customers and merchants, submitted that its total liabilities were Tk 543 crore, including Tk 311 crore to more than 2 lakh customers and Tk 206 crore to merchants as of July 15.

It did not disclose the number of vendors it owes money nor clearly mention when the dues will be cleared.

In its submission, Evaly said its tangible asset was worth Tk 105 crore and intangible asset Tk 438 crore, including a brand value of Tk 422 crore, a claim that raised questions as the company carried out the asset valuation, including that of the brand value, on its own.

If the brand value is taken out, the value dips to Tk 122 crore. Evaly's equity was Tk 1 crore, according to the submission.

For months, Evaly offered incredible discounts on products. In some instances, it offered cashback as high as 120 percent. As of the middle of March this

year, according to a Bangladesh Bank inspection, Evaly's liability to customers was nearly Tk 214 crore and nearly Tk 190 crore to merchant suppliers. Following the findings, the commerce ministry on July 19 asked

Evaly to explain the whereabouts of Tk 338 crore that the e-commerce site owed customers and merchants. In its desperate revival efforts, Evaly

Group's interest in investing in the

Jamuna on September 7 said it scrapped its plan regarding an investment in Evaly.

Meanwhile, thousands of victims face uncertainties as to whether they would ever get back their money. Customers and merchant suppliers of e-commerce platforms E-orange and Dhamaka are also in a similar situation.

Between May 29 and June 19, the complainant paid Tk 3,10,597 through online banking at different

The company promised a full refund if it failed to deliver the products in 7 to 45 working days.

As the delivery was not made, he contacted the Evaly customer care representative. He said he made the last call on September 5, but failed to get the product. Every time they were contacted, they made false promises, said the complaint.

Complainant Arif alleged that on September 9, he along with Abul Kashedm and Abdullah Omar Haq went to Evaly's office on Road No. 14 in Dhanmondi. As they tried to meet with Rassel, they were obstructed.

A day later, he along with his two friends went to the office to talk to the company's representatives about the products, but they were yelled at. At one point, Rassel came out of his office and intimidated them and refused to provide them the products by the end of July, disclosed Jamuna or refund the money, reads the case statement.

"At one stage Russell also threatened to kill us," Arif Baker mentioned in the statement. He also alleged that the company chairman who was present there also refused to give the products and the money. She also misbehaved and intimidated them, he added.

BNP MP Rumeen Farhana yesterday told parliament that due to the negligence of the government, companies like Evaly and E-Orange have looted thousands of crores of take in the name of business.

Speaking on a point of order, she demanded that the government refund the money to those who were cheated from the government fund and later collect money from those institutions.

BANGABANDHU KILLING PM says Zia

was involved, no doubt

Prime Minister Sheikh Hasina yesterday told parliament that she wanted to make Ziaur Rahman an accused in the Bangabandhu murder case because there was no doubt in her mind that Zia was involved in the killing.

She also said Zia, a former president and founder of the opposition BNP, did not become a sector commander but rather worked as an "Odhinayak" during the country's Liberation War of

Hasina made these remarks while delivering her valedictory speech in the 14th session of the 11th parliament.

The leader of the House also said she does not run the country based on what the media says.

"There is no doubt that he [Ziaur Rahman] was involved in the 1975 massacre [of Bangabandhu and most of his family members]. I wanted to put his name as an accused [in the Bangabandhu murder case], but the then home secretary Rezaul Hayat told me that dead persons could not be made accused. But the name [of Zia] should have been [included] as

accused [in the case]," Hasina said. Hasina, also president of the ruling Awami League, said Bangabandhu's killers Faroog and Rashid in interviews with the BBC said Zia had been involved in the conspiracy. Besides, it was stated in the books of Anthony Mascarenhas and Lawrence Lifschultz.

"So, how can they [BNP] deny it?" she asked. **DEBATE ON ZIA'S BODY**

Referring to the ongoing debate on Zia's grave at the city's Chandrima Udyan, Hasina said a box was brought from Chattogram which was claimed to contain his body.

She also said freedom fighter Mir Shawkat and the late army chief and former president Hussein Muhammad Ershad had admitted that the box did not contain Ziaur Rahman's body.

The prime minister said discussion s going on about the grave of Ziaur Rahman and whether his body is indeed there, but said that she did not want to say anything more about it.

She said Zia's body was not found after his death in May 1981.

The education ministry sent the letter to the UGC on September 9 citing decisions of a September 2 meeting of the National Committee on Security Affairs (NCSA).

The Daily Star has obtained a copy of the letter.

Following a meeting between the education ministry, the UGC and public university VCs, the government on Tuesday decided that any university can resume in-person classes if all its students completed online registration for Covid-19 vaccination by September

The universities can reopen upon approval of their academic councils and syndicates.

The government on August 26 decided that students of all public and private universities will be inoculated against Covid by September and the institutions could start in-person classes from October 15 in phases.

The following day, Awami League General Secretary Obaidul Quader, also the road transport and bridges minister, alleged that conspirators were preparing to create unrest in the country centring the universities with a target to oust the government of Prime Minister Sheikh

He called upon the Chhatra League men to remain alert and not to get involved in internal wrangling over trivial matters, reported BSS.

Several VCs told yesterday's meeting that the situation was still under control. "They [VCs] do not see any major chance of creating an anarchic situation after the resumption of inperson classes," said a UGC member.

The VCs also said they were on alert against any kind of "militant activities" on the campuses.

"But as precaution, the meeting decided that universities will contact intelligence agencies and set up CCTV cameras at the main entrances and other sensitive places," the UGC member added.

The meeting also decided that if any university faced any problem in installing CCTV cameras, the UGC vould assist it.

The authorities should also consider that CCTV surveillance does not hamper personal activities of the students on the campuses, the meeting observed.

It further decided that VCs will keep close contact with local politicians and teachers' associations to avert any untoward incidents on the campus.

Speaking to The Daily Star, UGC member Prof Sazzad Hossain said the meeting discussed running universities after their reopening.

Asked whether it was held to discuss possible "anarchy" and "spread of militant propaganda" on the campuses, he said: "I don't see any concern about anarchy.

Chairman Prof Kazi Shahidullah said he did not attend the meeting as he was busy with family affairs.
