# HC tells lawyers to settle dispute

The High Court yesterday gave the responsibility to lawyers concerned for an amicable settlement to the domestic disputes between Bangladesh-born US citizen Imran Sharif and his wife Japanese national Eriko Nakano, as they could not reach any solution.

Imran Sharif's senior lawyer Rokanuddin Mahmud and Eriko Nakano's lawyer Mohammad Shishir Manir have been asked to meet and discuss for an agreeable solution to the issue through mutual understanding and compromise by September 28.

During hearing a writ petition, the HC also ruled that Eriko and Imran will stay with their daughters -- Nakano Jasmine Malika (11) and Nakano Laila Lina (10) -- at the Gulshan residence in Dhaka, where they are now staying.

Eriko will stay with the children from 8am on September 17 till 8am on September 18 and Imran will stay with the children from 8am on September 18 for the next 24 hours.

They will stay with their daughters this way, alternatively, till September 28, the HC bench of Justice M Enavetur Rahim and Justice Md Mostafizur Rahman said.

### Man dies while trying to prevent mugging

A man died and another was injured after miscreants stabbed them when they were trying to prevent a mugging in Dhaka's Kotwali area early yesterday.

The deceased is Alamgir Hossain (40), a day labourer, and the injured Anwar Hossain (38).

The incident took place around 4am when the victims along with others were working at a scrap material shop at Balurghat.

A man rushed to them and sought help, saying muggers took his money and travel documents. As they chased the muggers and tried to catch one, miscreants stabbed the duo -- leaving them injured.

Alamgir was rushed to DMCH with stab injuries in his chest, neck and hands. He died at 1pm, said Bachchu Mia, in-charge of DMCH Police Outpost.

#### SCC announces Tk 839.20cr budget

Sylhet City Corporation (SCC) has declared its budget of Tk 839.20 crore for fiscal 2021-2022.

Mayor Ariful Haque Chowdhury announced the budget at a press conference held at a convention centre at the city's Arambagh yesterday.

In the budget, the corporation has shown a total income of Tk 82.23 crore. The corporation realised Tk 44.92 crore from holding tax and Tk 8.60 crore from tax on transfer of immovable property. These taxes were its significant income sources. SCCs significant

expenditures include Tk 90 crore for infrastructural development; Tk 130 crore for projects to remove waterlogging, clean water supply and related infrastructure construction and Tk 28.72 crore for reconstruction of roaddrain-culvert damaged by the 2018 flood.

The mayor said, "The city area was only 26.50 sa km, which recently expanded to 59.50 sq km. Extra work for the newly added area is a new challenge.

The proposed law was sent to the parliamentary standing committee of the respective ministry for scrutiny. The committee was asked to submit its report within 45 days.

The old law, which was enacted in 1974, has to be amended amid evolving situations.

The bill proposes a maximum three years' imprisonment or fine of minimum Tk 2 crore and maximum Tk 5 crore for maritime pollution.

The punishment was one year's imprisonment and Tk 5,000 fine in the old law.

## Three more dolphin carcasses found off Chattogram coast

Three more dolphins were found dead off the coast of Sitakunda in Chattogram on Wednesday.

Mohammad Kamal Hossain, range officer of Sitakunda coastal forest department, said locals in Mandaritola spotted the carcasses of the dolphins in the sea and alerted the forest department.

An official of Sitakunda fisheries and livestock department, Md Shamim Ahmed, said, "It is still not clear what caused their deaths. The dolphins could have died after getting stuck in fishing nets."

On August 20, locals found a dead dolphin off the coast of Bagachtar in the same upazila.
