Landslides endanger Habiganj Tripura village

An indigenous village of the Tripuras, located on hillocks in Chunarughat upazila of Habiganj, is facing decimation due to landslides.

The Satchhari Tripura village, now inhabited by 24 families, has been in existence alongside a creek inside present-day Satchhari National Park since 1947.

But indiscriminate lifting of sand from the creek about 25 years ago has led to erosion of the banks of the creek and that ultimately has been causing recurring landslides of the hillocks every year, especially during the monsoon, said Chitta Ranjan Debbarma, a resident of the village.

At least five houses were destroyed ever since and three more will face the same fate unless an embankment is made along the creek before the next monsoon.

The Tripura village about to disappear, but their repeated requests of building an embankment along the stream fell on deaf ears, he alleged.

According to Chunarughat upazila administration, they so far relocated five of the families whose houses were at the risk of collapse.

"My house might tumble down any time. Where would I go then?" said villager Nirmal Devbarma, 58.

A 92-year-old villager, Shri Ram Devbarma, said only the prime minister can save the indigenous community as the local public representatives including the upazila nirbahi officers (UNO) over the past ten years had given them nothing but assurances.

The villagers said they witnessed a massive landslide following a few days of incessant rain last year and Habiganj unit, said illegal sand lifting recently, said he informed they were wary of a catastrophe

Potholes rule roads in Kalapara town

Around 4 Kilometres of road in Kalapara municipality is in a dilapidated condition due to absence of proper drainage network and routine maintenance.

The condition of the pothole-riddled roads worsened further due to accumulation of rainwater during this monsoon season. The roads have become impassable for all sorts of vehicles, let alone for pedestrians.

Orphanage Road resident Abu Musa said most of the roads in the municipality are now unfit for movement of vehicular or pedestrian traffic.

The roads get muddy or submerged in ankle-deep rainwater even after a short spell of rain, making those extremely difficult for vehicles or pedestrians to pass.

Although the municipal authorities are repairing some of the roads, but that is still not enough, considering the overall situation, he also said.

Urging the authorities to relieve the townspeople of sufferings by repairing the roads urgently, Rahmatpur resident Abdur Rashid Khan said people walking through these roads cannot reach their destinations

without having their clothes tainted with mud or dirty water.

Auto-rickshaw driver Abdur Rahim said at least four kilometres of roads in different parts of the town are full of potholes, leading to traffic congestion and frequent

During a visit to the area recently, innumerable mud and water-filled potholes were found in various roads including the road between Old Ferry Terminal and College, Rahmatpur Road via Orphanage, Thana Road, Upazila Road, Animal Resources Road and both roads beside the radar station.

Especially the Sadar Road, Thana Road and Rahmatpur Road were not even safe for pedestrians to walk through.

Locals alleged that the roads turned for the worse as those did not undergo any repair work in a long time.

Contacted, Bipul Haldar, the mayor of Kalapara, admitted that the state of some of the roads in the town has worsened.

However, work was underway to repair some of the roads and the townspeople would get relief from the sufferings once all the roads are repaired after the monsoon.
