Probe if Pir has links to militancy

HC asks CTTC

The High Court yesterday directed the Counter Terrorism and Transitional Crime (CTTC) Unit of Dhaka Metropolitan Police to find out if Rajarbag Darbar Shareef Pir Dillur Rahman had any connections with militancy.

The court also ordered the Anti-Corruption Commission (ACC) to enquire into the assets of Pir Dillur Rahman and his disciples. Both the CTTC and ACC were asked to submit reports in 60 working days.

Meanwhile, Pir Dillur Rahman and his followers allegedly filed false cases against the writ petitioner for harassing and humiliating them.

Thus, the court directed the Criminal Investigation Department (CID) to identify those who filed false cases against the writ petitioner and submit its report in 60 working days.

At the same time, the HC asked the inspector general of police to provide proper security to the victim writ petitioners.

Besides, the court issued a rule asking the authorities to explain in have a connection with the militants.

Customers, sellers seek legal recourse from home. be taken against Evaly and other

On Friday, a seller sued Evaly CEO Rassel, his wife and Chairman Shamima, and 12 officials of the company with Dhanmondi Police Station on charges of embezzlement and threatening the plaintiff.

Dhanmondi police then filed a praver with a Dhaka court to place Rassel and Shamina on a seven-day remand each.

In the case statement, seller Kamrul Islam Chakdar, who has four businesses in the capital's Paltan, alleged that he supplied goods worth around Tk 35 lakh but Evaly did not pay him since January.

It gave him a post-date bank cheque in May, but it bounced twice as the company didn't have enough money in their account in June, added the case statement.

"Evaly had signed an agreement that it would pay the money within 30 days of delivering products. But it didn't abide by that even after I filed a general diary in January in this regard," he wrote in the complaint.

Hours after filing of the case, Evaly authorities shut down its head office in Dhanmondi until further notice and said that its employees will work

"The office will reopen with permission following the completion of investigation by authorities," read a notice hung at the entrance of the Evaly headquarters on Dhanmondi road 14.

Earlier, a customer named Arif Baker filed a case against Rassel and Shamima for not delivering products worth Tk 3.10 lakh.

Following the case, Rapid Action Battalion arrested the duo at their Mohammadpur residence Thursday.

They are now on a three-day remand each.

Meanwhile yesterday evening, a group of sellers and customers staged a protest in front of the Evaly office, demanding release of the Evaly CEO and the chairman.

They urged the government to release Rassel and his wife so that Evaly can run the business and pay back the money.

Khaleda's physicians said she was suffering from rheumatoid arthritis, diabetes, ophthalmological and dental complications.

Her family has long been seeking permission from the government to allow her to go abroad for treatment.

However, Law Minister Anisul Huq on September 12 said she has to return to jail first to submit a new application seeking release on condition and permission to go abroad.

On March 25, the government stended the imprisonment extended suspension of Khaleda for six months.

The 76-year-old BNP chief was released from jail on September 25 last year for six months upon an executive order considering her age and humanitarian grounds, following an application by her family.

On February 8, 2018, Khaleda was sent to the Old Dhaka Central Jail after a lower court had sentenced her to five years' imprisonment in the Zia Orphanage Trust corruption case.

The High Court later doubled her iail sentence.

She was found guilty in another corruption case the same year. Her party, however, claims both the cases are politically motivated.

Information of each individual's family members, employment, health, economic status, nationality, citizenship, and residence would also be stored in the NPR.

Biometric information will include prints of 10 fingers and data needed for IRIS and face recognition.

Shahadat told The Daily Star that the project was still being conceptualised and opinions of the stakeholders were being collected at yesterday's event.

Once the NPR is developed, there will be no need for a population survey every 10 years, he said, adding that it will integrate databases of the NID, passport and driving licence.

The NPR would accumulate all sorts of data in one place to be monitored by the government, he said.

Former Algerian president Abdelaziz Bouteflika, ousted in 2019 after mass protests, was given a state funeral on Sunday attended by senior officials but received little of the attention

given to such occasions in the past. Bouteflika died on Friday, aged 84. An armoured vehicle decked with flowers pulled his coffin, covered with the national flag, on a gun carriage from his home in Zeralda, west of the capital, to the el-Alia cemetery in Algiers where five of his predecessors are buried.

Bouteflika was first elected in 1999, and is widely credited with a national reconciliation policy that restored peace after a war with armed Islamists in the 1990s killed an estimated 200,000 people.
