FIRST PHASE UP POLLS

Three killed as violence rules the day

At least three people were killed and dozens others injured in clashes between supporters of ruling Awami League's chairman candidates and party rebels during the final part of the first phase of union parishad polls yesterday.

Postponed due to the Covid-19 pandemic, the election to 160 union parishads and nine municipalities featured some of the prominent features of the 2018 national polls and recent local government elections: boycott by candidates and ballot stuffing at places.

The election lacked festivity and enthusiasm and the absence of candidates from the BNP apparently made it one-sided. Most clashes took place between supporters of chairman candidates from the AL and those of party rebels.


Unofficial results in 134 of the 160 unions were available until 12:30am today. AL candidates secured victory in chairman election in 103 unions. Independents, including AL rebel, won in the other 31 unions, reported our district correspondents citing returning officers.

Two people died in Maheshkhali and Kutubdia upazilas of Cox's Bazar yesterday and one died in Bagerhat's Mongla upazila the previous night, reported our correspondents in

Clashes also took place in Bagherhat's Morelganj, Sharankhola upazilas and Khulna's Dighalia upazila

At least 10 candidates boycotted the elections and voting was postponed in five centres.

Eighty-five girl students out of 345 of Baravita Girls High School in Kurigram's Phulbari upazila have been married off during the closure of the school amid the pandemic. Aged between 12 and 16, they were students of classes

Of the 85 child marriage victims, two were in class VI, 10 in class VII, 17 in class VIII, 29 in class IX, 14 in class X

After the reopening of the school on September 12, the attendance of students came down to about 40 to 45 percent. Before the closure in March last year, the

No RT-PCR labs at airports only obstacle for migrants ready to fly to UAE

A group of UAE-based expatriates, who got stranded at home amid the pandemic, yesterday gathered at the Hazrat Shahjalal International Airport's multistorey car park to demand speedy installation of RT-PCR labs there.

The building has been selected for setting up the RT-PCR facilities as the UAE government last month set a condition that foreigners must have rapid PCR tests for Covid-19 maximum six hours before boarding the flights to the Gulf country.

Civil Aviation Authority of Bangladesh (CAAB) Chairman Air Vice Marshal M Mafidur Rahman said seven healthcare facilities have been selected for setting up RT-PCR labs at HSIA.

Six of them have submitted standard operating procedures (SOP), which have been sent to the UAE. Installing

gets 30 years in HC blasts govt for delayed action

Writ petition filed for an e-commerce watchdog

The High Court yesterday pilloried the government for its failure to take action in good time against companies that embezzled people's money.

"The government is taking action. But when? After I have become penniless," said the HC bench of Justice Abu Taher Md Saifur Rahman and Justice Md Zakir Hossain during the hearing of a writ petition.

The comment came on the day Supreme Court lawyer Md Anwarul Islam Badhon

filed a writ petition with the HC seeking its directive for forming an e-commerce regulatory authority for oversight on the fast-growing industry. The petition was made as public interest litigation: the National Digital Commerce Policy 2018 has a mandate to establish an e-commerce watchdog but the government has not taken any steps to that end.

In the petition, Badhon prayed to the HC to issue a rule asking the authorities concerned with the government to explain why their failure to form an e-commerce regulatory authority should not be declared illegal. The development comes as hundreds of thousands of customers of

rogue e-commerce platforms like Evaly and Dhamaka Shopping are left in limbo over their orders for which they had made payment months ago. SEE PAGE 2 COL 3

Lowest daily Covid deaths in 4 months

Twenty-six Covid-19 patients died in the 24 hours till 8:00am yesterday -- the lowest single-day death in nearly four months.

The last time fewer than 26 single-day deaths were recorded by the Directorate General of Health Services (DGHS) was on May 27, when there were 22 Covid-19 deaths.

The overall death count due to the highly transmissible viral diséase now stands at 27,251.

The death rate is 1.76 percent of all cases detected so far. In the same 24-hour

period, the DGHS also reported 1,555 new cases after testing 27,431 samples, according to a DGHS press release. The daily positivity rate is 5.67 percent.
The total number of

cases recorded now stands at 15,44,238. The overall positivity rate is 16.32 percent.

On March 8 last year, the DGHS reported the first three novel coronavirus cases in the country.

Strictly implement Paris accord

Hasina asks global leaders at UN Headquarters

Renewing her call for strict implementation of the Paris Agreement, Prime Minister Sheikh Hasina has asked global leaders to take stronger steps urgently to address the planetary emergency of climate change.

She also placed six-point proposal before the global leaders as the COP-26 is just a few months away, reports

The PM was addressing a closeddoor leaders' meeting on Climate Change, arranged for a small group of heads of state and governments, at the UN Headquarters yesterday.

The proposal includes strict implementation of the Paris Agreement to keep the global temperature rise below 1.5 degrees Celsius, realisation of annual \$100 billion climate fund from the developed countries, 50 percent of this fund should go to adaptation and resilience, especially to climate vulnerable countries.

The other proposals are: Forging new financial mechanisms and transfer of green technology to developing countries, addressing loss-and-damage issue, and displacement of large-scale population due to climate change and capacity building of CVF countries to tackle the double jeopardy of pandemic and disaster, particularly with the increased frequency of climate-induced disasters.

"Finally, we need a 'whole-of-theworld' approach to leave a sustainable future for our next generations," she

In the petition, he also requested the HC to issue a rule asking the respondents to show causes as to why the failure and inaction of the respondents to prevent informal moneylenders from lending money in the excessive interest rate should not be declared illegal.

Citing the petition, Suman told The Daily Star that high-interest informal moneylending businesses are going on at every village across the country in the name of co-operatives.

Many people also individually running such businesses even though they have no registration.

They provide loans on a high interest rate and collect weekly and monthly instalments, he said, adding that poor people are being hostage to the moneylenders and are becoming destitute.

A borrower reportedly has to give Tk 500 to Tk 1,000 as interest every week for a loan of Tk 10,000 and a moneylender collects Tk 2,000 to 2,500 per month against a loan of Tk 10,000, Suman said.

'Such moneylending business is running illegally before the local administrations in many places -- they need to be banned."

When experts are advocating for a planned public transport system to ease traffic congestion and ensure road safety, the number of buses and minibuses are actually declining in

Their numbers saw a sharp decline in Dhaka as well as other parts of the country in the last one and half years, intensifying people's suffering amid the pandemic.

Although the number of private

cars and micro-buses have gradually Research Institute at Bangladesh declined over the last three years, the number of such vehicles operating on roads is still too high, said experts.

In fact, their numbers increased again this year, according to Bangladesh Road Transport Authority (BRTA) data.

"When developed countries are moving for public transport-oriented development, we are moving towards more private cars and motorcycles due to lack of proper planning," said Prof Hadiuzzaman, director of Accident

University of Engineering and Technology (Buet).

It is amid this paradoxical situation that the country is going to observe World Car Free Day tomorrow -- a day which aims to discourage the use of private cars and encourage cycling, walking or using public transport instead.

The day has been observed in Europe since the 1970s and in Bangladesh since 2006.

47pc children in port city resistant to antibiotics, finds study

The medicines we are selfprescribing in our efforts to fight off illnesses are actually creating stronger and deadlier germs.

A recent research confirms that overuse and misuse of antibiotics are causing antibiotic resistance in people and creating uncertainties regarding the effectiveness of future treatments.

As many as 47 percent of newborns and children in Chattogram have been infected by at least three types of antibiotic-resistant microorganisms, pathogens that cannot be fought off by drugs, said researchers.



47pc of newborns, children infected by at least 3 types of antibiotic-resistant germs

40pc of those aged 15 and above resistant to at least 3 antibiotics 70pc of people resistant to at least 1 antibiotic

They conducted a study on 1,000 patients in two hospitals in Chattogram over a period of two years -- from 2018 to 2020 -- and found increasing ineffectiveness of antibiotics

"Among the patients monitored in the research, around 50 percent were children. Of them, more than 40 percent were antibiotic resistant," said one of the researchers, Dr Wazir Ahmed, head of neonatal ICU at Chattogram Maa-O-Shishu Hospital.

At least 275 patients were hospitalised in the last 24 hours till 8am yesterday. Of them, 64 are from outside Dhaka.

According to Directorate General of Health Services (DGHS), with the new cases, 5,345 have been diagnosed during the current month, out of 15,976 infected this year. Of the 15,976 infected, 1,842 are from outside Dhaka. At least 7,698 were diagnosed in August, 2,286 patients

were hospitalised in July, 272 in June, while 43 were infected in May, according to DGHS. As per DGHS data, 59 people have died of dengue this year. All of them succumbed to the disease in July, August and September. Twelve people died in July, 34 in August,

and 13 in September so far. Among the deaths, 54 have died in Dhaka division, two each in Chattogram and Khulna, and one in Rajshahi

From cultural activists to Covid volunteers

Bibarton Jashore steps up amid the pandemic

When the Covid-19 pandemic began, some cultural activists could not bear the thought of staying back home as everyone else suffered.

Confronting their own fears of the deadly virus, they came forward and tried to help out those in distress in anyway they could.

From going door-to-door on a 24/7 on-demand oxygen service, to arranging food, masks, and sanitisers, they dedicated themselves to the service of others. They did all of this despite most of them being unemployed and having no way to earn their own living. They belong to an organisation called "Bibarton Jashore".

With 55 cylinders at their disposal, they provide oxygen to over 500 patients across the district, Chopol said. In addition, they also run a vaccination registration booth to assist people enroll their names into the government website.

REGENT HOSPITAL SCAM DGHS ex-DG named in charge sheet

The Anti-Corruption Commission (ACC) yesterday approved a charge sheet against the former Director-General of Directorate General of Health Services, Abul Kalam Azad, and five others in the Regent Hospital scam case.

According to ACC sources, the charge sheet will be submitted to the court within this week.

Azad was implicated in the case during probe. Earlier, five people, including Shahed Karim, were accused in the case.

On July 7 last year, a case was filed against Shahed and 15 others over issuing fake Covid-19 test reports and charging people unfairly for testing and treatment. He was arrested in Satkhira on July 15 last year. He was sentenced to life imprisonment in an arms case last year.

Sheikh Hasina univ of science, tech gets approval

The government has approved of another private university, named Sheikh Hasina University of Science & Technology.

The Ministry of Education has issued an order in this regard, with a temporary approval to install and operate the university in Banshgari village of Kishoreganj's Bhairab upazila, said a press

Earlier on Thursday, the Directorate of Secondary and Higher Education (DSHE) sent a letter to university founder Dr HBM Iqbal, providing temporary approval to run the institution.

With this, the number of private universities in the country stands at 108, according to the press release.

The approval was given under the Private University Act 2010, subject to fulfilment of 24 conditions, the press release said. Dr Iqbal -- a former lawmaker from the

ruling party and current chairperson of Premier Bank Limited -- is already working on improving education in the area, establishing the "Dr. Iqbal Education City" in Banshgari. Spread over 100 acres of land, it will

host a multitude of establishments for higher education such as the university, a medical college, a polytechnic institute, a nursing school and more.

HC seeks info

Attorney General AM Amin Uddin opposed the petition saying that death-row convicts are kept in condemned cells to ensure their security.

Facilities in condemned cells have improved, he argued Three death-row convicts, including Zillur Rahman, filed the petition with the HC in September. They urged the HC to order prison authorities to transfer them to normal cells. Around 2,055 death-row convicts are currently in condemned cells, Shishir Manir told The Daily Star.



Summer bean farming brings solvency to Jhenidah farmers

Our Correspondent, Jhenidah

Cultivation of IPSHA, an early variety bean, has appeared to be a profitable venture for many farmers in Jhenidah, an area famous for growing the popular winter vegetable.

Farmers have got fair price of their yield as the variety matures early when the supply of other variety beans in the market is not sufficient.

Jhenidah Department of Agriculture Extension (DAE) sources said, in 2021/22 season IPSHA variety has been cultivated in 20 hectares of land in four upazilas of

Notably, beans were cultivated on 18 hectares of land in 2020/21 season in the

According to the DAE sources, the variety has been cultivated in nine hectares in Kaliganj upazila, four hectares in Kotchandpur upazila, three hectares in Shailakupa upazila and four hectares in Moheshpur upazila.

Farmers said that they do not get good prices of their produce in winter as the crop is cultivated on a largescale at that time. But by cultivating the IPSHA variety, they have seen the face of success as this variety can be brought to the market early.

Bapparaj Hossain of Subidpur village under Kaliganj upazila said, "We planted the seeds on the first week of June and after 20/25 days the plants bore flowers. Just after one and a half month into flowering, harvesting started. It costs Tk 18,00 to 20,000 (33 decimals) to cultivate beans on per bigha land, which includes fertilizer, insecticide and bamboo platforms.

He added that he has cultivated beans on one bigha of land this year and selling the produce at Tk 125 per Kg.

He expects that he will get a profit of Tk one lakh if the weather condition remains favourable.

Another farmer Imran Hossain of the village told that he has cultivated 15 decimals at the cost of Tk 14,000.

> According to Jhenidah DAE IPSHA variety has been cultivated on 20 hectares of land in 4 upazilas of the district in 2021-22 season.

He has already sold 5 Kgs at Tk 120 per Kg. He added that its demand is very high in the market as there is no other varieties of beans available in the market now.

Rafi Uddin, Abdus Sattar, Harun-or-Rashid of the village echoed the same.

Vegetable vendor Mobarak Ali said that summer beans are not available in the market. So, its demand is very

"We cannot meet the demand of the buyers as the supply is inadequate," he

Asgar Ali, deputy director of Jhenidah DAE, said that the farmers are getting good profit by selling the off-season



RUSSIA PARLIAMENTARY POLLS

Pro-Putin party wins big majority

Opposition claims mass fraud

REUTERS, Moscou

Russia's ruling United Russia party, which supports President Vladimir Putin, won an emphatic parliamentary majority after its most vociferous critics were prevented from contesting an election that opponents said was marred by large-scale fraud.

With 98% of ballots counted yesterday, the Central Election Commission said United Russia had won nearly 50% of the vote, with its nearest rival, the Communist Party, at just under 20%. United Russia won 54% in 2016, the last time a vote was held.

The scale of the victory means United Russia will have more than two-thirds of deputies in the 450-seat State Duma lower house of parliament. This will enable it to continue to push through laws without having to rely on

The Kremlin hailed the result, saying United Russia, which Putin helped found, had confirmed its role as the leading party. It said the election had been competitive, open and honest. Kremlin critics alleged large-scale vote rigging. They said the election was a sham and that a newlyintroduced electronic voting system had been used to deprive opponents of United Russia of victory in Moscow.

Some Moscow-based Communists who felt cheated called for a protest in the Russian capital yesterday evening. The central square they named as the venue was sealed off by police yesterday afternoon.

SHADOW GOVT'S CALL FOR WAR AGAINST JUNTA

Myanmar's Suu Kyi has 'no comment': lawyer

Toppled Myanmar leader Aung San Suu Kyi has "no comment" on a declaration of war against the junta by a shadow government dominated by lawmakers from her party, her lawyer said yesterday.

Myanmar has been in turmoil since the military ousted Suu Kyi's National League for Democracy government in a February coup, sparking huge democracy protests which have triggered a bloody crackdown from

NLD lawmakers make up the majority of a "National Unity Government" which is working to overturn the military regime and declared a "people's defensive war" earlier this month urging citizens to attack junta assets.

Following the declaration, clashes between local "people's defence forces" and the military have increased, and over a dozen army-owned communications towers have been attacked, according to anti-junta

Suu Kyi had "no comment" when asked by her lawyers about the NUG's declaration of war, her lawyer Khin Maung Zaw said, and would comment only after discussions with others in the NLD leadership.

"She said she never turns against the wishes of the people," he added. Suu Kyi, 76, appeared at a special court in the capital Naypyidaw yesterday for the latest hearing over allegedly importing walkie-talkies illegally and flouting coronavirus restrictions during elections last year that her party won by a landslide.

Avoid new Cold War

Guterres urges US, China ahead of UNGA gathering of world leaders

United Nations Secretary-General Antonio Guterres has warned of a potential new cold war between China and the United States, and implored the two major powers to repair their "completely dysfunctional" relationship. "We need to avoid at all cost a

cold war that would be different from the past one, and probably more dangerous and more difficult to manage," Guterres said ahead of the annual UN General Assembly gathering of world leaders - a convening blemished by Covid, climate concerns and contentiousness across the planet.

Guterres said the world's two major economic powers should be cooperating on climate and negotiating more robustly on trade and technology even given persisting political fissures about human rights, economics, online security and sovereignty in the South China Sea.

"Unfortunately, today we only have confrontation," Guterres said on Saturday in an interview with the Associated Press



functional relationship between the two powers," he said, adding that it is "essential to address the problems of vaccination, the problems of climate change and many other global challenges that cannot be solved without constructive relations within the international community and mainly among the superpowers".

Two years ago, Guterres warned global leaders of the risk of the world splitting into two camps, with the US

and China creating rival internets, currency, trade, financial rules "and their own zero-sum geopolitical and military strategies". He reiterated that warning in the

AP interview, adding that two rival geopolitical and military strategies would pose "dangers" and divide the world. Thus, he said, the foundering relationship must be repaired - and The so-called Cold War between

the Soviet Union and its allies and the US and its Western allies began immediately after World War II and ended with the breakup of the Soviet Union in 1991

The UN chief said a new cold war could be more perilous because the Soviet-US antipathy created clear rules, and both sides were conscious of the risk of nuclear destruction. That resulted in back channels and forums "to guarantee that things would not get out of control," he

Italy inmate shoots at rivals with 'drone-delivered' gun

An Italian prisoner shot at fellow inmates through the bars of their cell with a weapon believed to have been smuggled in by drone, a prison union said yesterday. The 28-year old, who has links to the Neapolitan mafia, fired three shots Sunday at prisoners he had argued with, but without injuring them, Donato Capece, head of the Sappe prison union, told AFP. The man had got permission to leave his cell to have a shower, and once the door was open he pulled out the gun and pointed it at a guard, forcing him to hand over his keys to the other cells, Capece said. Unable to open the cells of his enemies, the inmate shot through the bars instead, he said.

Trudeau future on the line as **Canadians vote in election** Voting kicked off in Canadian elections

yesterday that are headed for a photo finish, with liberal Prime Minister Justin Trudeau seeking a third term but threatened by a strong challenge from rookie conservative leader Erin O'Toole. 'Hotel Rwanda' hero convicted on terror charges

Paul Rusesabagina, the "Hotel Rwanda" hero who became a fiercely outspoken government critic, was found guilty of terror charges yesterday after what his supporters labelled a politically motivated show trial. He was convicted by a high court in Kigali of forming a rebel group blamed for deadly gun, grenade and arson attacks in Rwanda in 2018 and 2019. "He founded a terrorist

organisation that attacked Rwanda, he financially contributed to terrorist activities," Justice Beatrice Mukamurenzi said at the end of a seven-month trial. Rwandan prosecutors have sought a life sentence for Rusesabagina, the 67-year-old former hotelier credited with saving over 1,200 lives during the country's 1994 genocide, and whose actions inspired the Hollywood film.

US risks nuke arms race

N Korea warns over Aukus pact; France pulls out of UK defence talks amid row

North Korea yesterday warned that the United States risked a dangerous nuclear arms race by providing submarine technology to Australia, criticising its "double standards" and vowing counter-

Last week, the United States clinched Aukus pact, a new trilateral security partnership involving Britain, to provide technological aid to Australia to build at least eight nuclear-powered submarines.

North Korea joined China in decrying the US decision as an "irresponsible one" that destroys regional peace and stability and global non-proliferation efforts.

"These are extremely undesirable and dangerous acts which will upset the strategic balance in the Asia-Pacific region and trigger off a chain of nuclear arms race," the North's foreign ministry said in a comment carried by the official KCNA

The North criticised Washington's not be immediately reached. The British "double-dealing attitude," singling out defence ministry declined comment. White House spokeswoman Jen Psaki's

remarks that it does not seek conflict with AFP, Moscow China but the decision was to shore up regional security.

Her comment "amounts to a stand that any country can spread nuclear technology if it is in its interests, and this shows that the US is the chief culprit toppling the international nuclear non-proliferation system," the ministry said.

"We are closely looking into the background of the US decision and will certainly take a corresponding counteraction in case it has even a little adverse impact on the security of our country."

Afghan women outraged by Taliban restrictions on work

AFP, Kabul

Fears were mounting in Afghanistan vesterday as the Taliban tightened their grip on women's rights, slashing access to work and denying girls the right to secondary school education.

After pledging a softer version of their brutal and repressive regime of the 1990s, the Islamic fundamentalists have been stripping away at freedoms one month after seizing power.

"I may as well be dead," said one woman, who was sacked from her senior role at the foreign ministry.

"I was in charge of a whole department and there were many women working with me... now we have all lost our jobs," she told AFP, insisting she not be identified for fear of reprisals.

The acting mayor of the capital Kabul has said any municipal jobs currently held by women would be filled by men.

While the country's new rulers have not issued a formal policy outright banning women from working, directives by individual officials have amounted to their exclusion from the workplace.

Many Afghan women fear they will

never find meaningful employment. Since returning to power on August 15, the Taliban have shown no inclination to honour rights of women.

When pressed, Taliban officials say women have been told to stay at home for their own security but will be allowed to work once proper segregation can be implemented.

"When will that be?" a woman teacher said yesterday. "This happened last time. They kept saying they would allow us to return to work, but it never happened."

Women in the capital remain deeply suspicious. "The Taliban told us not to come to work and to wait for their second announcement.

But it seems like they don't want women to work again," a lawyer in the capital's high court told AFP. A colleague fears that because of her past role prosecuting Taliban fighters, she

will not be allowed to work again, but has

noticed some changes in the regime.

"They are not like before but we don't know if it will last. Before we had to be accompanied by a man, today we can come alone," she added.

Former UK PM Gordon Brown calls for urgent action to avert wasting stockpiled Covid vaccines

A vaccine summit being hosted by US President Joe Biden must come up with a plan this week to transfer 100 million stockpiled Covid-19 poorer vaccines to countries before they

reach their expiry date, former British Prime Minister Gordon Brown said.

Biden is due to convene a virtual Covid-19 summit on Wednesday on the margins of the UN General Assembly, aimed at boosting vaccinations worldwide with the goal of ending the pandemic by the end of 2022.

Brown said he had sent Biden and fellow G7 leaders research by Airfinity, a scientific information and analytics company, which found 100 million Covid-19 vaccines stockpiled in rich countries in the northern hemisphere would expire by December without being used.

Out of 5.7 billion doses of coronavirus vaccines administered around the world, only 2% have been in Africa.

"We need a plan to distribute vaccines



quickly," Brown, Britain's finance minister for a decade before serving as prime minister from 2007 to 2010, said in a statement "It will be a profound

and collective political tragedy if this summit misses the opportunity to

act with doses transferred immediately to poorer countries," he said. The Airfinity data predicts that, without

a speed-up in the vaccine roll-out, there will be 100 million more Covid-19 cases by next summer and one million more deaths from lack of ventilators and oxygen.
"It is unthinkable and unconscionable

that 100 million vaccines will have to be thrown away from the stockpiles of the rich countries whilst the populations of the world's poorest countries will pay for our vaccine waste in lives lost," Brown said.

Brown called on the leaders to decide whether countries should swap delivery contracts, how regulatory barriers to exports could be overcome and who would underwrite costs of using stockpiled

Concerns over the proposed personal data protection bill

It has come to light through print and electronic media that the Government of Bangladesh has recently prepared a draft bill on the matter of personal data protection. Some very pertinent issues regarding the bill are set out below.

Section 2 of the proposed bill includes definitions of several key terms, including data, anonymised data, personal data, the data subject, data controller, data processor, processing, etc., but many of the definitions are not comprehensive and exhaustive. For example, under the proposed bill, anonymised data refers to 'any data that has undergone the process of anonymisation', but there is no explanation regarding the anonymisation process. Again, there should have been clues about the personal data that can be used to identify a person. Generally, personal data means and includes some identification indicators, such as the name, ID number, location data, or any specific physical, physiological, genetic or mental condition, etc. The definition of personal data as laid down

in the said bill does not include any of these identification indicators, and this turns the definition clause into a problematic one.

Moreover, the proposed bill did not define many other important terms, generally used in data protection laws, including but not limited to - international transfer/cross border processing, profiling, pseudonymisation, consent, data breach, health data, biometric data, establishment, etc.

Since data processing activities are becoming increasingly complex in the digital age, there must be entities to be in place to act as watchdogs for the protection of the rights of the individuals.



Therefore, most international, regional, and national data protection frameworks, specially the Convention 108 of the Council of Europe 1981, the General Data Protection Regulation (GDPR), and 90% of countries having data protection laws have opted to establish an independent supervisory authority.

Whereas under section 28, the proposed bill incorporates provisions for the establishment of a data protection office (DPO) under the direct control and administration of the Digital Security Agency constituted under the Digital Security Act, 2018 (DSA). The DPO will be equipped with officers and other employees as required and headed by the Director-General of the Digital Security Agency established by section 5 of the DSA. Experts in the field opine that the DPO under the proposed bill should be independent of the Digital Security Agency. One should bear in mind that privacy is not an option but one of the most valued rights for the growth of democracy in the digital age.

Under section 43 of the proposed bill, there are provisions for the transfer of personal data outside Bangladesh, subject to the notification of the government published in the Official Gazette. This will be a lengthy process. The cross-border data transfer can be made more simplistic by incorporating specific provisions like transfers subject to appropriate safeguards, binding corporate rules, derogations/exemptions, or

international cooperation mechanisms. Despite that section 43(3) specifies seven circumstances of cross-border data transfer without government's intervention such as consent, performance of a contract, vital interests of the data subject, public interest, etc., these provisions lack at least two other important provisions such as transfers subject to appropriate safeguards and international cooperation for the protection of personal data.

Data breach notification is being incorporated as one of the most exhaustive provisions in modern data protection instruments. Under section 29 of the proposed personal data protection bill, the controller will share the data breach with the Director-General and the processor will notify the controller without undue delay. But there is no specific timeframe for the notice of data breach, and eventually, the said provision could hardly protect the irreparable data losses of the individuals. Moreover, there is no notification requirement to the victim concerned. In that case, the data controller and all other responsible persons should notify about the data breach without undue delay, but no later than 72 hours. Furthermore, if the data breach appears likely to cause a high risk to the rights and freedoms of the individuals, the controller should inform the concerned persons without further delay.

The combined reading of sections 60 and 65 of

the proposed bill reveals that no legal action can be taken against the Director-General, authorised officer, an employee of the DOP in respect of any act or omission done or omitted by any of them in good faith in such capacity. Similarly, under section 57 of the said bill, a company along with other responsible persons may get exemption from being punished for the commission of an offence under the bill if they can prove that the offence was committed without their knowledge, or they had exercised all due diligence to prevent the commission of such offence. Let us not forget that too much blanket powers of exemptions as evidenced in the bill will certainly destroy its purposes while making the law meaningless.

It is good to see that under section 46, the proposed data protection bill incorporates the provisions of compensation for the victim from the data controller, data processor or data collector for their failure to comply with the provision of this law. There is neither any provision for filing civil litigation nor any fixed administrative fine under the proposed bill. Due to the lack of specific provisions for civil litigation, fixed administrative fines, etc., the proposed bill may turn into a powerless tool. Considering the profound importance of privacy, the data protection laws of many countries such as Singapore, Switzerland, USA, UAE, Portugal, South Africa, Malta, Macau, Chile, Lesotho, Cape Verde, Bahrain and Uzbekistan have incorporated provisions for filing civil suits against data breach incidents.

Last but not least, an effective data protection law does not intend to stop the processing of personal data rather allows processing within the legal bounds. A carefully designed data protection regime promotes business, eases trans-border data transfers, encourages research and innovations, pays due attention to public interests, and protects the privacy rights of individuals. Hence, the principal aim of an effective data protection regime is to strike the balance of the competing interests among all stakeholders, namely the State, businesses, and data subjects. Though the primary duty of ensuring privacy lies on the government, all relevant stakeholders such as civil society, the legal community, judiciary and other legal institutions, national human rights institutions, ministries and legislative bodies, industry and technology community, and media should have some roles to make a new law purposeful.

Procedural waiver in writ jurisdiction: Should *Tayeeb* case be followed as general standard?

Enforcement of fundamental rights is itself a fundamental right within the constitutional scheme of Bangladesh, the basis of which is found in Articles 44 and 102(1) of the Constitution. The words used in Article 44 need no further explanation as the words are devoid of ambiguity and posit the rights to be 'guaranteed'. However, the articulation of words in Article 102(1) possesses linguistic uniqueness which is certainly capable of inviting a wide range of interpretation. A textual reading reveals 'an application' must be submitted to set the case in motion, therefore making it a pre-requisite to the judicial enforcement of fundamental rights.

The essence of submitting an application is to draw the Court's attention to a particular case of violation along with other aspects of maintaining a case, such as certainty of contesting parties, aggrieved person's locus standi, etc. Apparently, the liberalisation of 'locus standi' in the famous case Mohiuddin Farooque v Bangladesh (Writ Petition No. 998 of 1994) could not remove the procedural hurdle in toto in writ jurisdiction of the High Court Division. Traditional legal scholarship would interpret the requirement of submitting 'an application' from an aggrieved person as an absolute procedural requirement. This was the prevailing attitude until the premise met with challenge in Mohammad Tayeeb v Bangladesh (Civil Appeal No. 593-594 of 2001). In this case, fatwa given by the local community forced the victim to go through another marriage against her will before she could return to her actual husband after an alleged divorce from the latter. The High Court Division initiated a suo moto case considering the newspaper report as 'an application' after reading it in the same. Later, it was challenged in the Appellate Division which expounded the case in favour of victim. The Court had to deal with, among others, the question of procedural requirement of submitting an application. It interpreted the requirement in the light of 'knowledge' of the judge which was the ultimate purpose of 'application' moving away from the conventional understanding of an 'application' to be a well-written document



disclosing the grievances and accounts of violation of rights. So, in case of grave violation of human rights where the victim cannot pursue the court to set forth the case by reason of any procedural hurdle, including, but not limited to, submitting an application, the judge can exercise *suo moto* jurisdiction if it comes to his knowledge. This premise is also known as epistolary jurisdiction of the Court that connotes the relaxation of procedural rules to meet the justice.

Epistolary jurisdiction was introduced in India as part of judicial activism in Sunil Batra v Delhi Administration (AIR 149 SC 1982) where the Supreme Court, upon receiving a letter from a prisoner stating the Jail Authority's inhumane treatment to the prisoners, took cognizance of the said letter and treated it as a petition. The Tayeeb case seems to be a reiteration of Indian precedent in Bangladesh, though the text of the judgment does not mention the same. One might find it an extreme instance of judicial activism that wins justice for the downtrodden. Dispensing justice for the people not capable to access justice due to their social or economic misfortune by exercising the Court's epistolary jurisdiction is indeed applaudable. But this epistemic or knowledge based 'discretionary' power is coupled with dilemmas, such as when any such event which satisfies a judge to intervene into the matter by initiating a case, it places him in a representative capacity. Furthermore, when the same judge renders rulings or deals with the same that

he himself initiated, it then makes him the judge of his own interest. It is important to note that Tayeeb case did not establish a general standard of maintainability of a writ petition, rather merely provided waiver of application requirement in exceptional cases. Drawing reference to this case in every matter at hand despite the merit of the case would thus be a wrong application of epistolary jurisdiction bypassing the actual text of the Constitution. However, the Supreme Court of Bangladesh is showing great interest in suo moto rulings in recent days by introducing procedural amendment to facilitate suo moto rulings based on news report, letters, etc.

In a society where violation of human rights is prevalent, where social structure systematically bars the poor from accessing justice, where transparency and good governance is subjected to political consideration, an inevitable outcome would be victims becoming unable to reach the Court with their grievances. In such cases, Court cannot sit idle. In a grave case of violation or a case involving environmental matter which requires immediate attention, epistolary jurisdiction should be exercised as a timely weapon to address the cause and in such a case it should be seen not as a Court's being overenthusiastic but being active in fulfilling its constitutional

Government should heed the UN's concerns

Review DSA, address growing inequality and violence against women

HE UN has expressed its concerns over shrinking civic space, growing inequality and violence against women in Bangladesh. During a recently held discussion at the Foreign Service Academy, UN Resident Coordinator Mia Seppo mentioned how the pandemic had led to growing inequality and violence against women not only in Bangladesh, but across the world, and said that action on both national and global levels was needed to address these issues. Most importantly, she called on the government to make the Digital Security Act (DSA) compliant with international human rights standards.

Undoubtedly, the shrinking of civic space is a major concern in the country right now. Freedom of expression and opinion is under severe threat as people's voices are being suppressed using laws such as the DSA. Cases of enforced disappearances have created fear among the citizens. Poverty has increased in society, while violence against women and children have become major issues of concern.

It is time for the government to seriously reconsider dropping some of the more controversial provisions of the DSA that have repeatedly been used against the citizens. The Editors' Council and the TIB called for review of this law several times in the past. As the Universal Periodic Review (UPR) has looked into the DSA and made some recommendations, we now hope that the law ministry will take steps to implement them. Needless to say, the DSA should be made compliant with the international standards. If Bangladesh wants to work as a functioning democracy, it needs to get rid of such repressive laws and work to protect civic space. We also need to ratify the convention on enforced disappearances, which the UN advised us to do.

Moreover, as Bangladesh is going to graduate from the LDC status, it should now focus more on eliminating inequality from society. There are several steps that the government can take in this regard, such as expanding its social safety net programmes and addressing corruption—which ultimately leads to increased poverty and inequality. At the same time, the government should make sincere efforts to stop violence against women and children in the country, which is also a major barrier to the country's development.

An excellent decision by JS watchdog

The government project on an ECA in Cox's Bazar must be scrapped

T E wholeheartedly support a parliamentary body's decision to strongly oppose the public administration ministry's plan to build a civil service academy in Cox's Bazar on 700 acres of land that has been declared as a protected forest and ecologically critical area (ECA). According to the chairman of the parliamentary watchdog, it would be unacceptable for a government department to take the reserved forest land at a time when the government is trying to reclaim forest land that has been grabbed by different individuals and organisations. We, too, have previously mentioned in this column how this would set a dangerous precedent, and could open doors for private entities to follow suit.

In 2018, the Cox's Bazar district administration sought clearance from the Department of Environment (DoE) for the construction of the Bangabandhu Academy of Public Administration on the 700 acres of land adjacent to the Cox's Bazar-Teknaf Marine Drive. According to some sources, the name of Bangabandu was used in the proposed name so that the project could jump through bureaucratic hoops with ease. As distasteful as that move was, it seemed to have worked somewhat, as the DoE cleared the project.

Nevertheless, according to the parliamentary watchdog, the respective government department and the Prime Minister's Office were not properly informed about the type of land that the public administration ministry wanted to use. Otherwise, the construction of the training centre would never have been approved. Having been informed that the land has 100 acres of orchards created through social afforestation under the afforestation project in the coastal areas to address the adverse effects of climate change—and it's a hilly area that is a habitat to different species of flora and fauna—the parliamentary standing committee has recommended that the government take steps to stop the

project and relocate it to somewhere else. It is clear that the environment and ecology of the area would be severely damaged if the project is set up there. Given that the area is already under serious pressure from the influx of the Rohingyas, which has resulted in the razing of some 6,000 acres of forestland in southern Cox's Bazar, further destruction of forest areas is not something we can afford. Therefore, we second the parliamentary body's call to the DoE to withdraw its clearance for the project. We also ask the land ministry to reclaim the plot from the public administration ministry. The move to set up the training centre on the ECA is unconstitutional, and we hope that it is stopped and that no such initiatives are pursued in the future.

Are we headed towards another dengue crisis?

The experience of 2019 outbreak should have been enough for the authorities to prepare better this year



odds (read: existent movement restrictions and the maintenance of health safety guidelines almost becoming a practice-as-youplease thing), it seems the rate

of Covid-19 infections in Bangladesh is finally going down, and hopefully nearing the "safe" and much-desired mark of five percent or less. This is, without a doubt, a welcome development, given the phased reopening of schools and, soon, of universities. Lest we rest easy, though, the seasonal dengue menace has been making itself known in the country for the last

15,701, with 5,345 people diagnosed this month alone.

Dengue has caused 59 deaths in the country so far this year, according to the Directorate General of Health Services (DGHS). While most of the cases of infections have been reported in Dhaka, dengue—as any other virus—has started spreading outwards. For instance, of the 307 cases reported between September 14 and 15, about 20.52 percent were cases reported outside the capital. This is significant when we consider the fact that, of all the dengue cases this year until September 15, only around 10.79 percent were detected outside Dhaka.

However, the question now is not how we can combat this dengue surge, but why we did not anticipate this situation in the first place. Did the 2020 outbreak of Covid-19 pandemic wash away all the memories of the horrid dengue crisis that the DGHS. While the monsoon months typically see bouts of dengue infections anyway, the current dengue situation could also have been handled better, with preparations based on the experts' observation that dengue outbreaks seem to be worse every other year.

So, what can we learn from the errors made in 2019 in order to save our citizens, and our already exhausted healthcare system, from the burden of another dengue epidemic?

One of the major ways in which city corporations attempt to kill Aedes mosquitoes (carriers of the dengue virus) and prevent their breeding is by fogging—that is, the spraying of mosquito repellents in public spaces using fogging machines. However, in 2019, a study by the International Centre for Diarrhoeal Disease Research, Bangladesh (icddr,b) found that the insecticides sprayed by

would have given the authorities enough time to buck up and use insecticides containing malathion and deltamethrin instead of permethrin, as recommended by the researchers. Or to start their dengue awareness campaign earlier on. But it was not until July 15, 2019 that the Dhaka North City Corporation (DNCC) held a meeting and decided to look into the effectiveness of its adulticides. Alas, the dengue epidemic of 2019 still happened.

When it comes to diseases like dengue, authorities such as the city corporations tend to put a lot of emphasis on the citizens' own responsibility to save themselves from being infected. But there comes a point where it stops being awareness-building and starts becoming blame-shifting. No doubt, the public must take up preventive measures, such as wearing clothes that cover most of their bodies, spraying insecticides in their own homes, and get rid of stagnant water so Aedes larvae don't get the chance to breed there. But it cannot be denied that the majority of places where mosquitoes can breed freely and undisturbed are public spaces, making them the responsibility of the authorities.

Conducting mobile drives and imposing fines on people whose private properties have been found to have Aedes larvae are all well and good. But equal vigilance is required to encourage people to keep their homes clean and to raise awareness about how dangerous the dengue virus—specifically the serotype-3 variant—can be. Additionally, bulking up our healthcare sector to deal with the increasing number of dengue patients, amid the still-dangerous Covid-19 situation, is also crucial. Back in July, when the Covid-19 numbers were at their worst, two of the dengue wards of Shaheed Suhrawardy Medical College Hospital in Dhaka had to be re-assigned to accommodate coronavirus patients.

It is important to remember, no matter what the disease, that prevention is more desirable—and certainly a more intelligent option—than cure. Viruses will likely never disappear and will only mutate and exist among us as different, more dangerous variants. While dengue is seasonal, it is not as discriminative as Covid-19, in that it can infect people of all ages—including children. We must all work together—the state and the people, to the best of our respective abilities—in order to prevent a situation as bad as what we experienced in 2019, in this year and in the coming ones.

Will the BRICS ever grow up?



created the BRIC acronym to capture the collective potential of Brazil, Russia, India, and China to influence the world economy, I now must ask a rather awkward question:

When is that influence going to show up? Given today's global challenges and the enormous issues facing the BRICS (which subsequently became a real-world entity and was expanded in 2010 to include South Africa), the bloc's ongoing failure to develop substantive policies through its annual summitry has become increasingly glaring.

This November will mark the 20th anniversary of the BRIC acronym, which I first used in a 2001 Goldman Sachs paper titled "Building Better Global Economic BRICs." At that time, I offered four scenarios for how each country could develop over the next decade, and made the case for why global governance needed to become more representative and include these four rising powers.

That paper was followed by a series of others, starting in 2003, which showed how China's economy could become as large as the US economy (in nominal dollar terms) by 2040; how India could surpass Japan to become the thirdlargest economy soon thereafter; and how the BRIC economies together could grow larger than the G6 (the G7 minus Canada).

But the bloc's economic trajectory since 2001 has been a mixed bag. While the first decade was a roaring success for all four countries, with each surpassing all four scenarios that I had originally outlined, the second decade was less kind to Brazil and Russia, whose respective shares of global GDP have now fallen back to where they were 20 years ago.

If it weren't for China—and India, to some degree—there wouldn't be much of a BRIC story to tell. Yet, notwithstanding the difficulties the BRICs have faced, China's growth alone is on track to lift the technical aggregate of all four economies

to match the size of the G6.

In terms of global governance, the only notable shift over the past two decades has been the rise of the G20 since it took centre stage in response to the 2008 global financial crisis. Representing the world's 20 largest economies, the organisation seemed immensely powerful at the time, and it managed to implement policies of potentially lasting importance. But since then, it has generally been

of the attention this year has been on security and terrorism. After all, recent developments in Afghanistan will have serious, direct implications for Russia, India, and China. But this singular focus is disappointing, because it highlights the group's limited joint ambitions.

Modi would seem to agree, saying: "We need to ensure that the BRICS are more productive in the next 15 years." Beyond creating the BRICS Development Bank,

a disappointment, saying much but achieving very little.

For their part, the BRICs held their first annual meeting as a political club in 2009, in Russia (the first to include South Africa took place in China in 2011). And this year, Indian Prime Minister Narendra Modi hosted the BRICS leadersvirtually—for their 13th summit. Every leader made bold statements about what they had supposedly achieved together, and all discussed avenues for future cooperation. Yet, they have accomplished very little; lofty statements are usually accompanied by only scant policy moves.

Nothing in the bloc's latest joint declaration suggests that anything has changed. Perhaps, not surprisingly, most now known as the New Development Bank, it is difficult to see what the group has done other than holding meetings annually.

Following the bloc's rather dismal second decade, there are many things that BRICS leaders could do collectively to help revive the kind of economic gains made in the first decade, all of which would be good for the rest of the world as well. In doing so, they could create a much stronger impression of their usefulness alongside the G20, strengthening the case for more substantive reforms to global governance.

For starters, the BRICS need to strengthen trade between themselves. China and India could both gain

enormously from a more open and ambitious trading relationship, which would redound to the benefit of the rest of the region, the other BRICS members, and the world. In fact, more India-China trade alone would visibly boost global trade. Moreover, while the BRICS have little

in common other than having large populations, they also share a significant exposure to infectious diseases. The Review on Antimicrobial Resistance that I led in 2014-16 showed that all of the BRICS were worryingly vulnerable to drug-resistant tuberculosis. And as Covid-19 has shown, most have healthcare systems that are poorly equipped to deal with pandemics. Unless they treat global infectious diseases more seriously, they will never be able to reach their economic potential.

Since the fall of 2020, I have had the privilege of serving on the World Health Organization's independent Pan-European Commission on Health and Sustainable Development, which is chaired by former Italian Prime Minister Mario Monti. One crucial proposal from our initial call to action this past spring, now outlined in detail in our final report, is to establish a Global Health and Finance Board under the auspices of the G20. The reasoning is simple: unless we place global health challenges at the heart of regular economic and financial dialogues, we will remain ill-prepared for them. And as the pandemic has shown, global health challenges are also economic and political challenges.

This proposal already has the support of several key governments—notably those of the United Kingdom, the United States, France, Italy, and the European Union. Yet, for reasons I fail to understand, the BRICS, especially China, seem to be opposed to it. Such resistance makes no sense and will have dire consequences for the rest of the world. It gives me and other long-time champions even more reason to doubt the group's collective potential.

A by-poll like no other

Trinamool Congress is pulling out all the stops to prepare for the by-election in Bhabanipur

is the better part of valour, but not quite when it comes to West Bengal Chief Minister Mamata Banerjee. She has a penchant for rushing into political terrains where not many would dare to tread—a trait that has

characterised her political career. Who else, for instance, would have been brave enough to take on senior Marxist leader Somnath Chatterjee and pull off the giant-killing feat in the Lok Sabha poll in 1984, when Mamata was a young feisty leader from the Congress party, contesting from Jadavpur constituency?

Fast forward to September 2021: Mamata is no longer young, but remains as feisty and fleet-footed as ever, and has often defied conventional political wisdom. That is why when she chose Nandigram as her assembly constituency in the state assembly elections this year, she knew she was taking a calculated risk by moving out of her safe bastion of Bhabanipur in south Kolkata, her home and a cosmopolitan constituency from where she had won twice in the 2011 and 2016 elections. Many would say that Mamata had chosen Nandigram because her agitation in 2007-08 against land acquisition for industries by then Left Front government had catapulted her to power for the first time in 2011. But a decade is too long a time in politics for things to

Nandigram disappointed Mamata by giving the victory to aide-turned-adversary Suvendu Adhikari of the Bharatiya Janata Party (BJP) on the latter's home turf this year. But she knew she always had the option of winning a by-poll within the six-month mandatory timeframe provided under Article 164 (4) of the constitution, and retain her chief ministerial chair. But things did not turn out as smoothly as she might have thought about the by-election since her defeat in Nandigram on May 2. Mamata is, no doubt, a charismatic mass leader, and has been keen on getting elected as a member of the legislative assembly to shed the tag of an unelected chief minister.

It required several meetings between the Mamata-led Trinamool Congress (TMC) and the Election Commission, as well as her own pleas with the poll body, to ensure that the Bhabanipur by-poll would be held before the six-month deadline expires in early November. Tension had been building up within the TMC as to when the Election Commission would announce the by-poll. When the schedule was announced with the polling to be held on September 30 and the of EVMs without an iota of evidence. In fact, the Election Commission allowed the Bhabanipur by-poll even as it continued to postpone by-elections in three Lok Sabha and 31 other assembly constituencies across India, including four others in West Bengal itself, in view of the pandemic and flood situation there. Obviously, keeping Mamata in mind, West Bengal Chief Secretary HK Dwivedi had written to the commission seeking an early by-poll in Bhabanipur on the grounds of

poll, has decided not to field a candidate against Mamata in Bhabanipur. While Priyanka is not new to electoral politics as she had unsuccessfully contested the recent assembly elections from Entally constituency in Kolkata, Srijib is set to make his debut in elections. Priyanka's claim to fame is that she is among the petitioners on whose pleading the Calcutta High Court ordered a comprehensive investigation into the post-poll violence, an exercise that was stonewalled by the TMC.

The TMC is leaving nothing to chance in Bhabanipur. The party's campaign is spearheaded by Mamata, and it has pressed into service its entire organisational machinery, deploying three senior ministers-Subrata Mukherjee, Firhad Hakim and Partha Chatterjee, Kolkata Municipal Corporation Administrator Debasish Kumar, Mamata's brother Kartick, and activists of the party's student front in different parts of the constituency. The BJP, on the other hand, has lined up a motley collection of its Bengal leaders led by state unit President Dilip Ghosh and at least three federal ministers to woo the voters of Bhabanipur.

In the last assembly polls in March-April this year, Bhabanipur gave victory to Sobhandeb Chattopadhyay by a margin of 28,000 votes against BJP nominee Rudranil Ghosh. Soon after Mamata's defeat in Nandigram, Sobhandeb vacated the Bhabanipur seat so that Mamata could contest the by-poll from there.

Although dominated by the Bangalee middle class, a sizable chunk of the 206,389-electorate in Bhabanipur consists of Muslims in Ekbalpur, Khidderpore and Mominpur areas, as well as Marwaris, Punjabis and Gujratis, who will be a key factor in tilting the scale. Almost three-fourths of Sobhandeb's victory margin of 28,000 votes in the last assembly poll came from the Muslim-majority areas, while the TMC did not do that well in areas of non-Bangalee

The TMC was first off the bloc as far as publicity blitz is concerned in Bhabanipurwith banners, festoons, posters, and graffiti—all of which describe Mamata as "Bhabanipurer meye (Bhabanipur's daughter)," a hyper-local version of the slogan "Bangla taar meyekey chai (Bangla wants its daughter)' in the run-up to the state assembly election earlier this year. Considering that Bhabanipur has a significant number of non-Bangalee voters, the TMC has so far refrained from playing up the Bengal subnationalism card, which it had successfully done in the assembly elections. The religious symbolism in Mamata's campaign was quite evident as she herself visited a temple, a mosque and a gurudwara in Bhabanipur.

In the cut-throat world of competitive politics, at times, past performance in an election counts little for the future. Therefore, Mamata rightly told the TMC workers not to take her victory in Bhabanipur for granted. She has raised the stakes in the outcome of Bhabanipur by-poll by telling them that the election result will have an impact on the forthcoming civic body polls across West Bengal and set the tone for the 2024 general elections. Whether this strategy pays off or not will be known on October 3, when the final vote counts of the by-poll are out. But for Mamata's presence, the Bhabanipur by-poll would pass off as just another routine democratic exercise.

China's strategic interests in post-US Afghanistan

FTER the withdrawal of the United States and North Atlantic Treaty Organization (NATO) forces from Afghanistan last month, the Taliban took over the country for the second time.

Although the Talibanled government has yet to be recognised by any country, China is one of the few that has expressed interest in developing friendly relations with the Taliban.

China has reiterated its stand for noninterference in Afghanistan's internal affairs and firm support for the country's sovereignty, independence and territorial integrity. While the US and its NATO allies have evacuated their embassy staff from Afghanistan, the Chinese embassy is still functioning normally in the country. China's State Councillor and Foreign Minister Wang Yi hosted a Taliban delegation led by Mullah Abdul Ghani Baradar, head of the Afghan Taliban Political Commission, on July 28, in the northeastern Chinese port city of Tianjin. China has given a clear indication that it wants to make contact and establish effective communication with the Taliban.

As per the policy, during an informal meeting in Dushanbe, Tajikistan on September 16, China along with Russia, Pakistan and Iran agreed to strengthen communication and coordination, exert positive influence and play constructive role in order to stabilise the situation in Afghanistan. China has also announced USD 31 million worth of emergency aid to Afghanistan, which includes food supplies, medicines, and coronavirus vaccines. These developments imply that China has increased engagement with Afghanistan moderately

under the Taliban rule.

It is important to note that China never established an official relationship with the Taliban when the group was previously in power in Afghanistan from 1996 to 2001. Then what is the reason behind China's remarkable policy shift towards the Taliban in post-US Afghanistan?

Protecting its national interests is one of the key reasons why China is willing to build good relations with the Taliban. The Chinese government perceives the East Turkestan Islamic Movement (ETIM)—referring to the alleged Uyghur extremist group—as a direct threat to the country's national security and territorial integrity. According to Chinese news agency Xinhua, there are currently 200-300 ETIM members in Afghanistan. The fact of the matter is that the Wakhan Corridor, a narrow strip of territory in Afghanistan, borders China's Xinjiang province. Given that China is concerned about the possible connection between the Taliban and the ETIM, and a potential rise of terror attacks within its borders, the country seeks clear assurance from the newly empowered Taliban to break ties with all kinds of international terrorist forces. According to a press statement on the China-Taliban meeting issued by the Chinese foreign ministry, Foreign Minister Wang Yi remarked: "We hope the Afghan Taliban will make a clean break with all terrorist organisations, including the ETIM, and resolutely and effectively combat them to remove obstacles, play a positive role, and create enabling conditions for security, stability, development and cooperation in the

China has gained assurance from the Taliban that it will not allow any forces to use Afghanistan's land to endanger other countries—including China. The country has urged the new Taliban government to take effective measures to crack down on terrorism within its territory. Neil Thomas, analyst on

China and Northeast Asia at Eurasia Group, said: "Chinese authorities may also be trying to protect their country from terror attacks by building a relationship with the Taliban." Thus, the Taliban attaches a great deal of significance to China to ensure an ETIM-free

Afghanistan. China is also willing to develop good relations with the newly formed Taliban government to pursue its economic interests through economic diplomacy. As Afghanistan has been facing daunting challenges and uncertainties, China is considered to have emerged as the best partner in Afghanistan's reconstruction process, according to the

Global Times, a mouthpiece for the Chinese Communist Party. Chinese companies seek investment opportunities in Afghanistan's severely damaged infrastructures. It attempts not only to expand Chinese business through establishing a long-term industrial platform in Afghanistan, but also to facilitate the development of economic corridors across the region, under the framework of China's most ambitious Belt and Road Initiative (BRI) project. Whereas building cross-border infrastructure connectivity remains the prime agenda of BRI, such investment opportunities can accelerate China's infrastructure projects in war-torn Afghanistan. It also opens the

door for the potential expansion of China-Pakistan Economic Corridor (CPEC), the flagship and fastest growing project of the BRI, into Afghanistan. The Taliban has already expressed its desire to join the CPEC to protect overseas investment.

Enhancing economic engagement with Afghanistan in sectors such as utilities and mining has been of significant interest for China for years. For instance, the China Metallurgical Group Corporation (MCC Group), a state-owned Chinese company, won the right to develop a large copper deposit and extract high-quality copper from the Aynak copper field near Kabul in November 2007. The China National Petroleum Corporation (CNPC) signed a 25-year deal with Afghanistan in December 2011, to explore three fields in the basin containing about 87 million barrels of oil. These projects have been stalled due to the instability and security concerns in Afghanistan. Amid the dramatic power shift with the Taliban takeover, Chinese firms are eying a resumption of these projects. China also seeks to start new projects to extract rare earth metals and minerals in Afghanistan. In this regard, China plans to boost cooperation in the energy sector with the mineral-rich

It is apparent that China's gradual engagement with the Taliban has both geostrategic and geo-economic implications. Being one of the neighbouring countries of China, it is crucial to restore long-term peace and stability in Afghanistan in order to ensure China's territorial integrity and national security. Hence there is a huge possibility of expanding China's BRI project to Afghanistan, which would, of course, depend on China's successful diplomacy with the Taliban.

India had supplied 6.6 crore doses to nearly 100 countries before halting the vaccine export.

The announcement by the Indian health minister came a day before Prime Minister Narendra Modi travels to the US to attend the maiden in-person Quad summit where the vaccine issue will be come up prominently.

The summit will be attended by President Joe Biden of the US, Australian PM Scott Morrison and Japanese PM Yoshihide Suga.

Modi is also likely to hold a bilateral meeting with Bangladesh PM Sheikh Hasina on the margins of the UN General Assembly session in New York, reports our New Delhi correspondent.

India wants to vaccinate all its 944 million adults by December and has so far given at least one dose to 64% of them and two doses to 22%

India's inoculations have jumped since last month, especially as the world's biggest vaccine maker, the Serum Institute of India, has more than trebled its output of the AstraZeneca shot to 200 million doses a month from April levels, reports Reuters.

Indian companies have set up the capacity to produce nearly 3 billion Covid vaccine doses a year.

US to end travel bans for vaccinated passengers early Nov

United States announced yesterday it will lift Covid travel bans on all air passengers in November if they are fully vaccinated and undergo testing and contact tracing.

Jeffrey Zients, coronavirus response coordinator for President Joe Biden, told reporters the new "consistent approach" would take effect "early November.

The easing of travel restrictions, imposed 18 months ago by Donald Trump as the Covid-19 pandemic first erupted, marks a significant shift by Biden and answers a major demand from European allies at a time of strained diplomatic relations.

Numerous safeguards will remain in place to suppress the spread of the virus, which has already killed more than 670,000 Americans and is resurgent after what many had hoped was a lasting dip earlier this year.

importantly, nationals flying to the US will be required to be fully vaccinated,' Zients said.

It wasn't immediately clear if the new rule only applied to US-approved vaccines or if other brands, such as those produced in China or Russia would also qualify. Zients said that would be determined by the US Centers for Disease Control.

Restrictions on vehicle movement from Canada and Mexico will remain in place. "We do not have any updates on the land border policies," Zients said.

Zients said passengers will need to show they were fully vaccinated before boarding planes to the United States, as well as providing proof of a negative Covid-19 test taken within three days.





Robber accused of stealing RMG goods from trucks gets arrested

A man, who has stolen ready-made garment products from thousands of trucks in the last two and a half decades, was arrested with 10 of his gang members, detectives told a press conference yesterday.

Since 1998, Shahed, known in his circles as Sylheti Sayeed, has stolen garment products from over 5,000 trucks and lorries.

The gang pulled off the robberies with the help of lorry drivers of shipping companies who received a cut.

Around 24 cases were filed against him over the

years, said AKM Hafiz Akter, additional commissioner of Detective Branch of police.

Last year, Shahed got arrested and was in jail for eight

months in six cases filed in Chattogram. But he returned to the world of crime soon after he was released on bail, said Hafiz.

Shahed owns a two-story building, a brick kiln and several trucks in Moulvibazar, the officer said, adding that

Covid VACCINE India to start exports in October

Says its health minister; neighbouring countries to get priority

India will resume exports of surplus Covid-19 vaccines from next month, prioritising the global vaccine-sharing platform Covax and neighbouring countries first as supplies rise, the country's health minister said yesterday.

"We will help other countries and also fulfil our responsibility towards Covax... Neighbouring (countries) first," Minister Mansukh Mandaviya told reporters in New Delhi, adding that only the excess supplies would be exported.

India, the world's biggest maker of vaccines, stopped exports of Covid shots in April to focus on inoculating its own population as infections exploded.

The country's monthly vaccine output has since more than doubled and

Says info minister; home boss says 11 journos' reputation undermined

The government can seek bank account details of anybody for any reason, Information Minister Hasan Mahmud said vesterday.

He added that the fact that their bank details were sought were not supposed to be published in newspapers.

Innovation Index Bangladesh still at 116th

Bangladesh's ranking in the Global Innovation Index has remained unchanged at 116th out of 132 countries.

The country's score stood at 20.2, according to the ranking prepared by the World Intellectual Property Organisation (WIPO).

The 14th edition of the Global Innovation Index (GII), which was released yesterday, captures the innovation ecosystem performance of the economies and tracks the most recent global innovation trends.

In South Asia, India improved its ranking by two places to 46th. Sri Lanka moved up six notches to 95th, and Pakistan advanced eight spots to 99th. Nepal slipped 16 spots to 111th.

Switzerland topped the list. Sweden came second, the US third, the UK fourth, and South Korea fifth

Scientists transform fruit leftovers into bandages

Scientists at Nanyang Technological University (NTU) in Singapore are tackling food waste by turning discarded durian husks into antibacterial gel bandages.

The process extracts cellulose powder from the fruit's husks after they are sliced and freeze-dried, then mixes it with glycerol. This mixture becomes soft hydrogel, which is then cut into bandage strips.

"In Singapore, we consume about 12 million durians a year, so besides the flesh, we can't do much about the husk and the seeds and this cause SEE PAGE 10 COL 6
