Special vaccine campaign to mark PM's birthday

The government will run a special campaign tomorrow to inoculate 80 lakh people with the first dose of Covid-19 vaccines and mark the birthday of Prime Minister Sheikh Hasina, Health Minister Zahid Maleque said yesterday.

"Those who have been waiting to get vaccines after registration will get priority in the campaign. Only the first dose, mainly the Sinopharm vaccines, will be administered on that day," he said while announcing the programme in an online

HC questions legality of prior permission

The High Court yesterday questioned the legality of the provision in a law that requires police to take the authorities' permission before arresting civil service officials on charges relating to their jobs.

According to section 41 of the Government Service Act, 2018, until a court accepts the charges against a civil servant, law enforcers cannot arrest the individual without the approval from the ministry concerned.

Turnout in class dropping off

The number of students in classrooms of secondary schools has been dropping since September 12, when the schools reopened after over one and a half years.

According to Directorate of Secondary and Higher Education (DSHE) data, absenteeism has been growing in secondary schools for the last two weeks.

On September 12, 67 percent of the 43.31 lakh students of 14,817 schools attended classes. On September 18, 48.01 lakh students of 16,690 schools attended classes, and on Saturday, 56 percent of 42.33 lakh students of 15,860 attended classes. The number of schools vary because not all the schools report to the DSHE every week.

Educationists attributed the growing absenteeism to families needing the children to work, parents unwilling to SEE PAGE 2 COL 1





ERRORS IN TEXTBOOKS

HC summons NCTB chairman

The High Court yesterday expressed utter dismay about the errors regarding the history of the country's Liberation War in some textbooks of secondary and higher secondary levels, saying such mistakes in the books are unfortunate.

The court also summoned the chairman and member concerned of the National Curriculum and Textbook Board (NCTB) directing them to appear before it on November 10 for hearing their explanations about the errors.

The HC bench of Justice M Enayetur Rahim and Justice Md Mostafizur Rahman passed the order in response to a writ petition filed by Md Alamgir Alam, guardian of a student of Viqarunnisa Noon School and College, containing the errors in the books.

At the same time, the bench issued a rule asking the authorities concerned of the government to explain in four weeks why they should not be directed to take steps to amend the mistakes in

Petitioner's lawyer Ali Mustafa Khan told The Daily Star that his client has found more than 100 errors about the history of Bangladesh's Liberation War in some textbooks of secondary and higher secondary levels.

"As a result, hotels, motels and restaurants of the Bangladesh Parjatan Corporation were almost without customers or guests, and the agency made huge losses," reads the letter.

It incurred losses of around Tk 40 crore in 2019-20 and 2020-21 fiscal years due to the pandemic, it mentioned in the letter.

In 2018-19, it earned Tk 113.47 crore and Tk 97.34 crore in 2019-20, show BPC documents.

Because of the huge losses, a serious crisis arose with regards to paying salaries to staffers and pensions to retirees," he wrote.

Following his letter, the civil aviation and tourism ministry wrote to the cabinet division on August 17 seeking the division's directive to all ministries and divisions to procure BPC services. The cabinet division on August 19

wrote to all secretaries to take necessary steps regarding the request of the BPC. Different ministries, including the road transport and bridges ministry, have already issued the same directives to its

Contacted, Hannan Mia said they have spent Tk 20 crore from their savings to meet the necessary expenditures.

We have sought Tk 10 crore from the government to meet our threemonth expenses, but the money may not be required as the government has opened tourist spots," he told The Daily Star on Saturday.

Starting from 9:00am, the campaign availability and our capacity. We will will be conducted in 16,153 centres set up in around 4,600 unions, 1,054 municipalities and 433 wards in the city corporation areas across the country.

Males aged 50 and above, females above 25 and students 18 and above will get priority.

Mothers-to-be and lactating mothers will not be vaccinated during this campaign.

To receive vaccines, people have to carry registration cards or National Identity cards.

Around 80,000 health workers and volunteers will be deployed to conduct the vaccination programme, the minister said.

The minister, however, did not mention whether people who registered would get text messages for

getting the shots. In reply to a query, he said, "People will be able to know in time.

Asked, Prof Meerjady Sabrina Flora, additional director general (planning and development) of the health directorate, told The Daily Star, "One who has registered for a certain centre, like upazila health complex, will go to nearby centres in his or her union."

"Due to technical barriers, it may not be possible to mention the name of centre in text messages. But there will be an announcement through loudspeakers," Prof Flora said.

On August 7-12, the government vaccinated around 34 lakh people in a similar special campaign which was marked by chaos and shortage of vaccines.

Since then, the government did not hold any special campaigns due to the shortage of vaccines.

In the last one month, the health officials often said the government will inoculate two crore people each month and 10 crore by December in total.

Asked about this target, the minister fourth day in a row.

said, "It will depend on vaccine try to administer two-three crore jabs each month. We will try.'

"We have received around five crore vaccine shots so far. Of those, we have administered four crore. We hope we will get enough vaccine doses by December and January," the minister added.

About the chaos in the vaccination centres last time, Maleque said, "You know we have thousands of vaccination centres. This was positive that people came en masse. In the past, people were not interested in taking vaccines, now they are ... We have had experiences. Now there will be no problem.'

For the second dose, a similar campaign will be held a month later, the minister added.

The country has received a total of 4,94,29,940 doses of Covid vaccines. Of those, around 4.02 crore jabs were administered as the first and second doses as of Saturday.

The government has also signed a contract to buy six more crore doses of Sinopharm vaccine which, according to officials, will start to arrive by this month.

Besides, the government has

been trying to buy 10 crore vaccine jabs through the World Health Organization. Despite this, the uncertainty over vaccine supply is not over and it would

Fear of illegal occupancy looms

DU students worry ahead of dorm reopening; no more 'gono' rooms, say authorities

The Dhaka University (DU) administration has decided to end the crammed "gono room culture" at its dormitories, shifting students who were staying there before the pandemic to regular dorm rooms amid concerns over health safety.

The university authorities said they would first vacate seats occupied for long by former students and gradually allot those rooms to students housed in the gono (mass)

However, students fear that if the administration cannot prevent the stay of "illegal" former students at the dormitories, it will create uncertainty for those living in the

Wishing anonymity, a first-year student said if the administration fails to vacate seats occupied by former students on time and close the gono room, he may have to stay outside the campus to pursue his education.

The student, who is from Sylhet, said he had stayed at such a room in Shaheed Sergeant Zahurul Haque Hall for three months before the pandemic, as the hall authorities did not allot a regular room to him.

The 18 DU dormitories for students, including five for female students, were closed in March last year amid the surge in Covid-19 positive cases in the country. Besides, DU has an international dormitory for foreign students. The DU administration is preparing to reopen the 18

dorms in a limited scale on October 5 ahead of resumption At DU, a gono room is a makeshift accommodation,

usually a four-bed room, where 30 to 35 students, mostly freshers, live in crammed conditions. There are allegations that students who are involved

in ruling party politics "control" those rooms. They take advantage of regular students by allowing them to stay

First day of library reopening descends into chaos

After 18 months, Dhaka University authorities (DU) reopened its central, departmental, and institutional libraries for honours final and masters students yesterday, as per a previous decision.

However, what was supposed to be a festive occasion soon turned sour during a teacher's group's visit -- lead by DU proctor Prof AKM Golam Rabbani -- at the science faculty library around 10am, as a confrontation threatened to turn into a

As the library gates opened around the same time, this correspondent saw staffers prepared at the entrance with hand sanitisers, masks, and temperature measuring instruments.

But this was for nought as students started pouring in as soon as the gates opened, cramming into the library almost by force, said a science faculty library

During their visit, the teachers -- also consisting of DU librarian Nasiruddin Munshi; general secretary of Teachers' Association Nizamul Haque Bhuiyan; and assistant proctor Liton Kumar Saha -- asked students about their neglect of the health guidelines and asked them to produce vaccination certificates.

The situation became tense once the assistant proctor attempted to slap a student due to misconduct.

Other students soon came to their fellow's aid and surrounded the assistant proctor. During the chaos, agitated students also harassed two campus reporters who were trying to capture photos and videos of the incident.

A fraudster in many guises

CTTC arrests man who amassed crores illegally

Sometimes he introduced himself as an officer at the land office, sometimes as an officer in the deputy commissioner's office and at other times as an influential person in a government office.

In the last eight years, 48-yearold Abul Kalam Azad, a resident of Nabinagar area of Brahmanbaria district, played many roles to deceive people.

During this period, he embezzled at least Tk 20 crore to Tk 25 crore in name of settling property dispute and giving jobs. With the money, he now owns two buildings, a flat in Mohammadpur and multiple

times. One of his wives is now working as a police sub-inspector at

Dhaka Metropolitan Police (DMP). He also used a part of the embezzled money to take part in the UP chairman election.

Azad contested for the chairman post from the Laur Fatehpur Union Parishad of Brahmanbaria in 2011 and 2016 from Jatiya Party. In the latest polls this year, he was campaigning to take part in the UP election for the chairman post, but this time from BNP.

He took around Tk 1 crore from developer company by forging documents of state agencies. The developer company -- Happy Homes Limited -- then filed a case

with Shahbagh Police Station. While investigating the case,

Counter Terrorism and Transnational Crime unit arrested Azad and two of his associates -- Mobarak and Nur Hossain - from Dhaka on Wednesday.

Confirming the development, Tohidul Islam, additional deputy commissioner of CTTC unit, told The Daily Star on Friday that Azad has four to five members in his

Azad is the ringleader, he said. There were also four to five cases filed against him and the other arrestees, added Tohidul.

A victim of Azad's scam, Sharif Hossain Chowdhury, managing He also used one of his fake director of Happy Homes Limited, said they had built a building at 25-27 Kazi Nazrul Islam Avenue in Dhaka on a 54-katha land.

In 2005, the district commissioner's office issued a district notice for compensation as some land was acquired for a road extension project. But the developer company faced indefinite delay in collecting the money, Sharif said in the complaint.

Later, the High Court ordered that Tk 17.52 crore be paid as compensation for the land. However, the developer company has not received money even after 13 years, the complaint reads.

Azad appeared at the scene to solve the problem.

Dengue claims two more lives

At least two more dengue patients died while 242 were hospitalised in the last 24 hours till 8am yesterday, according to the Directorate General of Health Services (DGHS).

Of them, only 57 patients are from outside Dhaka.

With the new cases, a total of 7,001 patients were diagnosed during the running month out of a total 17,357 infected. Of the total infected, 2,126 are from outside Dhaka.

At least 7,698 persons were diagnosed in August, 2,286 were hospitalised in July, 272 in June while 43 were infected in May, according to the DGHS.

According to the DGHS, till now 61 people have died of dengue infection in the country this year. Twelve people died in July, 34 in August and 15 in September.

Among the deceased, 56 have died in Dhaka division, two in Chattogram and Khulna and one in Rajshahi division.

Though most of the patients who were hospitalised have so far been released, 1,043 are still undergoing treatment at hospitals in Dhaka, and 229 in other divisions of the country, the DGHS data showed.

But the works remained incomplete till 2019, when the authorities redesigned the flyover into a double-lane one and planned the road into four lanes.

According to the State Acquisition and Tenancy (Amendment) Act, 2004, the government is supposed to form the tribunal headed by an HC judge in order to hear and dispose of the appeals arising out of the judgment, decree or order of the Land Survey Tribunals.

The HC on July 25, 2019 in a verdict directed the land ministry to form the tribunal in 90 days in line with the law. The full text of the HC verdict was released on October 13 last year.

He met with the developer company and demanded Tk 8 crore to solve the problem, according to the victim and police. Azad even showed the developers pay orders, checks and exemption orders from the DC office - all of which were forged.

He allegedly collected around Tk 1.12 crore between June 2019 and March 2021 and then stopped all communication with the developer. Whenever the company wanted to meet him, he would threaten them, said victim and police.

ADC Tohidul said during primary interrogation, Azad admitted to taking Tk 92 lakh. "We have produced him before the court seeking a 10-day remand. The court has fixed next week for the hearing," he said.

Local and police sources said, Azad left his village home Nabinagar in 2000 after his HSC exams and moved to Dhaka to start a transport business. In the beginning, he forged documents from Nilkhet and used the names of various government and non-government organisations to commit fraud activities, said investigators.

Locals claimed that they knew Azad as a businessman and an influential person. In the last couple of years, Azad also took money from local youths promising he would give them jobs, but afterwards, he would stop all communications with them.

In the locality, Azad has allegedly sold one piece of land to multiple persons and collected money by forging documents.

OC Aminur Rashid of Nabinagar Police Station, said that there are three fraud cases and one warrant issued against Azad.

Talking to the correspondent, Lau Fotehpur village inhabitant Jewel Chowdhury, said Azad took money from many people, promising them jobs. His cousin gave Azad Tk 6 lakh in this regard, he claimed.



Sources at the university said a proposal to end the "gono room culture" was made at a meeting of the university's Provost Standing Committee with Vice Chancellor Prof M Akhtaruzzaman as chair last month.

On September 18, the DU Syndicate, the highest governing body of the university, approved the proposal.

The DU authorities took a similar decision to vacate seats occupied by former students several times in the past but failed to implement it allegedly due to influence of the ruling party's student wing.

However, considering the Covid-19 situation, this time the university administration is taking a hardline to implement the decision which is pivotal to ensuring social distancing, said authorities.

Prof Abdul Bashir, provost of Bijoy Ekattor Hall, said they have already identified rooms occupied by former students. Besides, the hall authorities have prepared a draft list of first- and second-year students. The vacant seats will be allotted to them, he said.

Prof Saiful Islam Khan, provost of Sir AF Rahman Hall, said they have also prepared a list of "illegal" students who have occupied dormitory seats for a long time.

As per the university's decision, after reopening of dormitories, students currently pursuing their master's degree and those who are in honours final year will be allowed in the dormitories first.

Nilphamari primary schools see dwindling attendance

The attendance of primary students in Nilphamari has seen a decrease of 13pc to 16pc after reopening of school following a long hiatus, which guardians and teachers say may be the result of the end of the school feeding programme.

The project tenure expired in June this year having an impact on students' attendance, they said.

After the reopening of schools following a long pause due to pandemic, the attendance of students was as high as 95pc to 98pc which has dropped within a few days as the average attendance rate now stands at 82pc, according to data of primary education offices in different upazilas.

According to the primary education department, it could be learnt that the government introduced the school feeding programme in primary schools in 2001 to make students of low-income families interested in attending schools and the programme garnered positive

Under the programme, students were provided with a packet of nutritious biscuits in tiffin time so that learners of poor families who come to school halffed or unfed do not leave classes because of hunger and can concentrate on their

The programme continued even in the pandemic time during the long closure of schools when teachers handed over the packets of biscuits to students going door to door at the directive of higher authorities.

District primary education office informed that there is a total of 1,084 primary schools in six upazilas of the district where around 2.4 lakh students

mostly from low-income families read as kids of solvent families are usually sent to read in specialised schools like

Guardians and teachers said that the reason for the sudden decrease in attendance may be caused by the discontinuation of the feeding programme as the students are not being provided biscuits after attending classes.

GirizaProsonna president of district unit of primary teachers' association, said "Government programmes to provide textbooks for free and school feeding programme were epoch-making in popularising primary education and it should be continued."

Shandha Rani and Sumon, students of Uttar Ramnagar Government Primary School, said that they feel hungry during school time and can't pay attention to

Delwar Hossain, a guardian from Gayabari village of Dimla upazila, said that her daughter reading in class four in a local primary school now insists on giving her Tk 10 before going to school daily to buy snacks from the grocery shop as she is not getting the biscuits from the school

Ashraful Islam, headmaster, of DoluaDogasi Government Primary School in Sadar upazila, said that they were going to the doorsteps of the students assuring them that the progrmme will resume soon in a bid to increase the attendance

Assistant District Primary Education Officer MdTazul Islam Mondal said, "The government has not officially stopped the school feeding programme and there is every possibility for its revival as it is an

The 300-foot-long wooden walk bridge built recently by volunteers of two villages on Amlabhanga canal in Waiting 15 years, they build 2nd bridge OUR CORRESPONDENT, Patuakhali Secondary School and Kachiabunia open for all during the second week

Instead of accepting to be hamstrung by bureaucratic red tape, residents of two villages in Rangabali upazila once again built their own walk bridge over Amlabhanga canal.

This time the villagers of South Kazir Hawla and Kachhiabunia villages built a two-foot by 300-foot wood bridge to replace a bamboo bridge that broke down about two months ago. The bamboo bridge they built in 2006 had been in a terrible state for the last several years and they had been urging the authorities to build a proper bridge for them on

A bridge on Amlabhanga canal is crucial for the inhabitants of both villages as they depend on it for reaching a number of educational institutions, Rangabali Union Health and Family Welfare Centre and Rangabali Union Parishad office.

The educational institutions on both sides of Amlabhanga canal are: Dakshin Kazir Hawla Government Primary School, Rangabali Dakhil Madrasa, Rangabali Government College, Kachiabunia Government Government Primary School.

Around 2,000 people from the two villages and four other nearby villages need to cross the canal every

Locals said they had been repairing the bamboo bridge since it turned wobbly in recent years, but it continued to turn increasingly risky to cross, especially for children, the elderly and women.

There had been many occasions when villagers including young students fell off the bridge, they also said, alleging that despite the fact, their petition with the Local Government Engineering Department (LGED), requesting a bridge on the canal, went unheeded.

Finally, when the rickety bridge collapsed about a couple of months back, villagers on both sides of the canal were mobilised to build a wooden walk bridge. The initiative was taken by Nazmul Masud, a lecturer at Rangabali Government College, and Mosharraf Mollah, a resident of South Kazir Hawla.

While visiting the site recently, people were seen walking down the wooden platform of the bridge, erected on logs driven into the canal

Nazmul Masud said, "The bamboo bridge was risky for crossing the canal. And that's why the villagers responded positively to [our] call for building a wood bridge. The government offices we approached only gave assurance, but didn't deliver.

After the villagers in a petition to the chairman of Rangabali Upazila Parishad sought funds for the purpose, he allocated Tk 80,000 from government funds, he said, adding that they spent total Tk 2.8 lakh on the new bridge.

Contacted, Engineer Mizanul Kabir of LGED in Rangabali upazila, said they have plans to build an iron bridge over the canal and they already sent a proposal in this regard to the higher authorities.

Construction of the iron bridge It took the villagers about a month will begin once the proposal is

Cyclone Gulab makes landfall in

eastern India

A cyclone packing strong winds and rains barrelled into India's east coast late yesterday, as tens of thousands of people in three states were evacuated to shelters. Cyclones are a regular menace in the northern Indian Ocean but many scientists say they are becoming more frequent and severe as climate change warms sea temperatures. Cyclone Gulab made landfall between the coastal states of Odisha and Andhra Pradesh just after 6:00 pm local time, bearing gusts of up to 95 kilometres per hour, India Meteorological Department said. The storm system from the Bay of Bengal would bring "strong winds and very heavy (and) extremely heavy rainfall", the weather bureau added in an advisory yesterday.

Inter-Korean summit possible with 'respect': Kim's sister

The influential sister of North Korea's leader said in a statement on Saturday that an inter-Korean summit could take place, but only if mutual "respect" and "impartiality" are guaranteed. It was the second statement in two days by Kim Jong Un's sister and key advisor Kim Yo Jong. She had on Friday urged Seoul to end its "hostile policies" towards Pyongyang after South Korea's president called for declaring an official end to the

state of war with the North. The 1950-53 war between the two Koreas ended in a truce, not a peace treaty, leaving Seoul and Pyongyang technically at war for over half a century. An inter-Korean summit between her brother and the South's Moon Jae-in could be held "only when impartiality and the attitude of respecting each other" are guaranteed, Kim said in a statement carried by Pyongyang's official KCNA news agency.



Taliban urge int'l airlines to resume Afghan flights

The Taliban yesterday urged international airlines to resume flights to Kabul, saying all technical issues at the country's main airport have been resolved. Facilities at Kabul airport were badly damaged in the chaotic evacuation of more than 120,000 people that ended August 30 with the withdrawal of the last US troops. Since then only charter flights

have been operating, although Pakistan International Airlines (PIA), Iran's Mahan Air and Afghanistan's Kam Air have run a limited number of special flights. The international community is keen to hold the Taliban to their word that they will allow anyone to leave the country once commercial flights resume. At present airlines such as PIA and Kam Air are charging more than \$1,200 for a one-way, 40-minute flight from Kabul to Islamabad.

Russian Foreign Minister Sergey Lavrov called Saturday on the United States to take a more active approach to help resume stalled talks aimed at reviving the Iran nuclear deal.

"It seems evident they should be more active" in "resolving all issues related" to the accord, Lavrov told reporters at the United Nations in New York.

Lavrov added that he hoped negotiations in Vienna among Iran, Russia, China, France, Britain and Germany would resume "as soon as possible."

The talks, brokered by the Europeans, seek the return of the United States to the 2015 agreement trashed by former president Donald Trump -- as well as Iran's return to full

Trump pulled America out in 2018, reinstating sanctions on Iran that Washington had lifted as part of the agreement. Since then, Tehran has also retreated from many of its

commitments. Lavrov said Iran no longer meets elements of the agreement "simply because the United States has left it." He added that sanctions reimposed on Iran also affected

countries who "trade legally" with Tehran. "These sanctions should be lifted as part of the restoration of the nuclear deal," he said, adding that Iran's

"should not suffer from unilateral US measures." Lavrov also said that international recognition of the

Taliban was not currently under consideration. "The question of international recognition of the Taliban at the present juncture is not on the table," Lavrov told a news conference.

Myanmar's junta has denied suspending the internet in conflict-wracked regions, blaming a recent spate of data blackouts on anti-coup protesters who had destroyed military-owned communications towers.

The Southeast Asian country has been in chaos since the military toppled Aung San Suu Kyi's government in February, triggering huge democracy protests that security forces have sought to quell in bloodý crackdowns.

Some in the anti-coup movement formed local "people's defence forces" in their townships to fight back, and in recent weeks destroyed several communications towers belonging to military-owned Mytel in western Chin state.

Reports of an internet and data blackout -particularly in regions where local defence forces and the military are locked in conflict emerged soon after.

Anti-coup fighters told AFP that telecommunications services in Pinlebu, Kawlin and Wuntho townships in northern Sagaing region -- where clashes with the military have been fierce -- were down since the early hours of the day.

The junta's foreign ministry on Saturday denied that the State Administration Council -- as the military regime dubs itself - was responsible.

"In fact, the recent internet connections were disrupted due to the terrorist acts such as destroying of communication towers by terrorist groups," the ministry said in a statement.

"The Ministry urged some foreign missions in Yangon to thoroughly verify information before making statements."

Mamata's swipe after Indian govt's 'no' to Rome meeting

West Bengal Chief Minister Mamata Banerjee on Saturday accused the centre of jealousy after the Ministry of External Affairs refused permission for her to travel to Italy for an all-faith peace meeting organised by the Community of Sant'Egidio, a Romebased Catholic foundation.

Banerjee said the centre had told her the event is "not commensurate at your level".

Outgoing German Chancellor Angela Merkel, Italian Prime Minister Mario Draghi and Pope Francis are among nearly 500 religious and political leaders invited to the two-day peace conference.

"There was a meeting on world peace in Rome, where I was invited. German Chancellor, Pope (Francis) are also supposed to attend. Italy had given special permission for me to attend... yet centre denied clearance, saying it wasn't right for Chief Minister," Banerjee said Saturday.

"You will not be able to stop me. I am not eager to visit foreign countries... but this was about the respect of the nation. You (PM Modi) keep talking about Hindus... I am also a Hindu woman. Why did you not allow me? You are totally jealous," she

The Trinamool leader - who faces a critical by poll in Bengal's Bhabhinpur on Thursday, which she must win

to become an MLA and remain Chief Minister - also hit out at the 'Talibani' BJP.

"We have to protect our freedom. 'Talibani' BJP cannot run in India... Trinamool alone is enough to defeat BJP. Games will start from Bhabanipur and will finish after we win in the entire nation," she said at a public meeting.

Ahead of the Bhabinipur by poll Banerjee has been relentless in her attacks on the BJP, which has fielded lawyer Priyanka Tibrewal from that seat. Last week she called the BJP a "jumla party" and said she would not let the centre "divide the country" and "make India like Taliban".

The results of the Bhabinipur by poll are expected October 3.

ICELAND'S NEW PARLIAMENT

Women hold more than half of the seats

In a first in Europe, women hold more than half of the seats in Iceland's new parliament, final election results showed vesterday.

Of the 63 seats in the Althing, 33 were won by women, or 52 percent, according to projections based on the final No other European country has had more than 50

percent women lawmakers, with Sweden coming closest at 47 percent, according to data compiled by the World Bank. Five other countries in the world currently have parliaments where women hold at least half the seats, according to the Inter-Parliamentary Union: Rwanda (61 percent), Cuba (53 percent), Nicaragua (51 percent) and

Mexico and the United Arab Emirates (50 percent). Unlike some other countries, Iceland does not have legal quotas on female representation in parliament, though some parties do require a minimum number of candidates be women. Iceland has long been a pioneer in gender equality and women's rights, and has topped the World Economic Forum's ranking of most egalitarian countries for the past 12 years.

It offers the same parental leave to both men and women, and its first law on equal pay for men and women dates back to 1961.

Legacy of the Kumar of BHAWAL


Prior to the abolition of Zamindari in East Bengal (Bangladesh) in accordance with the 'East Bengal State Acquisition and Tenancy Act of 1950', the Bhawal zamindar estate was the second largest feudal landholding in the Dhaka district. In terms of size (area), revenue and prestige it was second only to the Dhaka Nawab estate of the Khawja family. In fact, its enormous landholdings within Dhaka city began right from today's Bangla Motor, embracing much of Tejgaon, going all the way up to Savar and beyond. Most of the land to the north of the city fell under the Bhawal estate. In the early 1960s, on our way to school in the Dhaka cantonment area, we had to regularly pass by an attractive period building with a large pond where stork, heron, kingfisher, kite, duck and geese frolicked. The attractive old building stood on the opposite side of the former Dhaka airport at Tejgaon. This unique historic edifice looked somewhat incongruous

in its setting, ensconced as it was amidst a picturesque setting redolent in luxuriant foliage, thereby attracting my attention and curiosity. There was no other comparable, large and impressive colonial era mansion like it anywhere around, unless one went all the way to the Ramna area of Dhaka city. One day, I asked my driver to stop by this old two-storied building ringed by huge old banyan, neem and rain trees of crowning glory for a good look. This eye-catching mansion was once the Baganbari or pleasurevilla of the Bhawal zamindar. Built in 1933, it is called the Nymph which was built by Kumar Ram Narayan Roy on a sprawling twenty bighas of land. I had never heard of this Kumar of Bhawal before. The information was given to me by a Hindu gardener of the horticulture department who was then working at the site. His forefathers had all been malis (gardners) of the Bhawal zamindars. As I wandered around in the vast pristine compound of the Nymph, a gentle spring breeze swayed the branches, boughs and rustled the leaves of the ancient trees. The blissful quietude of the sylvan surroundings seemed to cast a entrancing spell, as I savored the languorous ambience of the place. Little did I known then that come nightfall this peaceful place, was said to be occasionally haunted by the ghost of a young woman clad in a diaphanous white sari. The most macabre part of the story was that the ghost carried her severed head in her own hands!

My subsequent visits later on to the Nymph left me a bit baffled regarding its hybrid architectural styles and antecedents. Therefore, I sought the wise counsel of a distinguished veteran architect Abu H. Imamuddin, requesting him to take a look at some photographs of the Nymph, I had passed on to him and enlighten us by describing its salient architectural features. He most graciously obliged and wrote, "Just by observing the building without any knowledge of its original plan, makes it difficult to provide an accurate architectural assessment of it. However, in brief here is a general impression of the

building. It seems that the building underwent a number of alterations and modifications over time, corresponding to the changes of ownership and the need for functional usage. The weak relationship of the inner and the outer façade is distinctly visible. The inner façade resembles the architecture of the British colonial era that flourished in Dhaka after the partition of Bengal. There are massive corner columns with decorative arches. However, the outer façade looks like a latter addition having eclectic architectural characteristics. The repetitive motifs on the railings in the outer verandah may have been adapted from the Bungalow design, atypical of the mansions of the local landlords of that period. On the roof, the dwarf towers with a dome on top represent two different religious references: Christian and Islamic. The parapets around the roof having a regular undulating pattern with projected pillars topped by spherical heads, represents a common recurring feature in the design of the colonial bungalow. The curious screen wall shown having a vertical slab built with pinwheel designed blocks, may have been placed much later for some specific functional need. The pattern of the design suggests that it is of a latter addition to the building. The overall complex architectural taxonomy of the building makes it hard to classify it into any specific category".

Now a brief on the Bhawal Raj, the second Kumar, the Sannyasi, and the most celebrated judicial court case in the history of the British Raj in colonial India. The zamindar Raja Bahadur Rajendra Narayan Roy Chaudhuri of Bhawal died in 1901, leaving behind his widow, Rani Bilashmani Devi, and six children—three daughters: Indumayi, Jyotirmayi and Tarinmavi and three sons: Ranendra alias baro (eldest) Kumar, Ramendra alias mejho (second) Kumar and Rabindra alias sejho (youngest) Kumar. In 1904, citing gross mismanagement, the Bhawal estate was taken over by the Court of Wards. Meanwhile, the nationalist quarters and the vernacular print media in Bengal raised a big 'hue and cry' at the forcible takeover of one of the premier *zamindar* estates of East Bengal. Meanwhile, a great

tragedy descended upon the Bhawal Raj family. Rani Bilasmani died in 1907, of illness. In 1909, the second Kumar suddenly died in Darjeeling, amongst conflicting reports that he was both cremated and also that his dead body had mysteriously vanished from the cremation grounds during a sudden thunder shower, before being consigned to the flames. The matter would have ended there. But soon there arose unsubstantiated charges of a palace conspiracy and dark nefarious family politics were hinted at. It was further alleged that the

Kumar was poisoned by his own wife, Srimati Bibhabati Devi, in connivance with her secret paramour the family doctor. Soon strange news of a wandering Sannyasi resembling the lost Kumar also started to emanate from various parts of India, complicating the already fluid situation. To make matters worse, the eldest Kumar also died in 1910, probably as a consequence of his excessive drinking habit, followed by the death of the youngest Kumar in 1913. All three Kumar's had died childless. The Bhawal Rai was now bereft of any legitimate male heir to the zamindari. In 1915, the Court of Wards under the Board of Revenue, went into action again and took over the management of the estate. Thus, the stage was set for a confrontation which would increasingly take on a fervently patriotic, nationalistic and anti-colonial overtone against the British Raj in support of the beleaguered Bhawal Raj.

However, powerful factions within

the Bhawal Raj family coalesced to reverse the situation in their own favor. In this the widow of the youngest deceased Kumar, Srimati Ananda Kumari Devi, played a pivotal role. She adopted a boy, Ram Narayan Roy, as the new Kumar of Bhawal. Surprisingly, contrary to their negative policy against the Bhawal zami estate, this move was endorsed by the British Raj as evidenced from a rare photograph where the Earl of Ronaldshay, Governor of Bengal on his visit to Dhaka in 1919, had himself 'anointed' the boy-Kumar's eventual assumption to the 'guddi'(throne) of Bhawal as the heir-apparent and possibly later as the Raja. However, all this would dramatically change the scenario with the miraculous appearance of a strange Sannyasi, naked except for a loincloth, smeared in ash and long matted hair, on the Buckland Bund near the Ruplal House in Dhaka in 1921. He bore a striking resemblance to the missing second Kumar of Bhawal. For months he refused to identify himself. In the meantime, his advent had aroused great curiosity and speculation. Later on, during his subsequent visits to the Bhawal Rajbari, the Sannyasi was hugely welcomed and recognized by the tenant-farmers as their second Kumar. The tenants thronged in record numbers to the palace premises and started paying him his share of the rent, even before he was lawfully declared as the lost Kumar. Thereafter, supported by a powerful faction of the Bhawal raj family, thousands of tenant-farmers, sympathetic public and media, the Sannyasi finally changed his stance. He claimed that he was indeed the lost Kumar of Bhawal who being poisoned by his own family, was saved by a group of Naga Sadhus who had nursed him back to health. In the meantime, he had wandered all these years throughout India with the Sadhus having lost his memory, until his arrival in Dhaka. Through all this unfolding high drama the widow of the second Kumar, Srimati Bibhabati Debi, adamantly refused to meet the Sannyasi declaring him as an interloper. However, the biggest loser from this sensational development would be, Srimati Ananda Kumari Debi, the widow of Rabindra the youngest of the deceased Kumar's, her adopted son Kumar Ram Narayan Roy who was the 'heir-apparent' to the Guddi of the Bhawal zamindari, and the palace coterie that had staunchly supported them.

At last, on April 24, 1930, lawyers working for the claimant (Sannyasi), supported by the sisters and elder sisterin-law of the Kumar, filed a declaratory lawsuit in the court of the first subjudge of Dhaka district, claiming

the name and property of Ramendra Narayan Roy against his widow Bibhabati Debi and other shareholders who were represented by the Court of Wards. The trial began on November 30, 1933. Both sides summoned an over abundance of witnesses (literally hundreds), whose statements were often contradictory. However, judgment was delivered on behalf of the plaintiff the Sannyasi in 1936.

On October 5, 1936, the government filed an appeal against the judgment of the lower court in the Calcutta High Court, again in the name of the wards of the Court of Wards. The hearing began on August 14, 1939. On November 25, 1940, the Calcutta High Court upheld the verdict and the appeal was dismissed. In 1943, the colonial government in consultation with the lawyers representing Rani Bibhabati then filed for a leave to appeal against the judgment of the Calcutta High Court in the Privy Council in London seeking redress. However, the war and the German blitz in London delayed the hearing which finally began in 1945. After a prolonged hearing, the Privy Council in London also dismissed the appeal in its judgment in favor of the Sannyasi, on July 30, 1946.The next evening the claimant (Sannyasi) finally declared lawfully as the second Kumar of Bhawal went to offer puja at a Kali temple in Calcutta, where he suffered a stroke and died two days later. His funeral rites were preformed on August 13, 1946. Divine retribution for an imposter? That is exactly what Srimati Bibhabati Devi and those of her ilk concluded.

Through this protracted Bhawal Sannyasi case, the deprived and frustrated Kumar Ram Narayan Roy grew into manhood as a tall, heavyset, fair and handsome young man, devoted wholesale to a life of indolence and pleasure. As a privileged feudal in those days, he became

personnel and their families. And, as for the mysterious lady ghost at the Nymph, only a few air force personnel during both the Pakistani and Bangladeshi periods had ever claimed that they had indeed seen it. But for those overwhelming majority of people who only heard of it, but never saw nor believed in it, conclude with a 'wink and a chuckle' that it was fabricated by someone in a fit of drunken stupor at the bar, whose fervid imagination had given currency to it. However, the story persists to this day. The Nymph is the only remnant of a zamindar era Baganbari (garden-house) from the colonial days in Dhaka city. It has miraculously survived the vicissitudes of time and escaped the greed of men due to its fortuitous location in the cantonment area, thereby remaining well preserved. However, regretfully nobody knows what really happened to all those expensive chandelier, candelabra, furniture, rich Persian carpet/rug, monogrammed cutlery pieces and decorative artifact that had once graced the interior of the many roomed Nymph! We, therefore, urge the concerned authorities of the Bangladesh Air Force to take moral responsibility and ensure that this wonderful heritage building remains unaltered. The Nymph will soon turn a 100 years old in 2033, besides being an unique historical mansion with a story to tell. It should be declared a heritage building to be preserved for posterity. Meanwhile, it remains one of

In 2004, I was told an interesting story by a prominent member of the erstwhile Dhaka Nawab family. She narrated that as a young school girl in the early 1950s, she had once espied with wide-eyed wonderment from an upper floor window of her house in Dhaka, the fairytale visage of a beautiful stately carriage (Brougham) driven by two handsome horses, as it

drawn to a hedonistic lifestyle of shikar, musical soiree, cavorting with dancing girls (baijee/tawaif), given to binge drinking and spending endless nights of sensual pleasure with his companions. To give proper vent to his amorous proclivities, he built an exclusive pleasure villa in 1933, called the Nymph at Tejgaon away from the prying eyes of his family and the din and bustle of the Bhawal palace at Joydebpur. However, it is not known if Kumar Ram Narayan eventually regained his short-lived rights as the sole heir to the Bhawal zamindari until its abolition in 1950, on the sudden death of the Sannyasi in 1946, declared as the rightful second Kumar of Bhawal. After the abolition of zamindari in 1950, following the partition of British India in 1947, the huge landed property including the Nymph of the Bhawal zamindars was taken over by the Dhaka Cantonment Board, and handed over first to the Pakistan Air Force and after 1971, to the Bangladesh Air Force (BAF) to be used as their Officers Club and mess. At present it is used as the BAF Ladies Club. Sadly, the beautiful large pond which once lent so much glamour to the adjacent Nymph, has now been mindlessly filled up and turned into a big lush green airy field for recreational purpose for the BAF

slowly came up the driveway to her house. She had run down bubbling with excitement to welcome the august visitor. The carriage door was emblazoned with a gorgeous family crest. Soon an imposing figure - a large, fair, immaculately attired aristocratic gentleman emerged from the carriage. Hugely impressed and in awe, she welcomed him with courteous regard, introduced herself and politely ushered the guest into the living room. With an affectionate pat on her head the visitor said in a rich baritone voice,"go tell your father that his friend Ram Narayan Roy is here to see him". It was the same little Kumar of Bhawal shown here in the picture. The storyteller, now a distinguished elderly lady further added wistfully that her father and the Kumar of Bhawal, had been childhood friends and were of the same age.

Only a non-partisan body can engender trust in the people of the country

ESPITE our much-vaunted march of democracy since its resurrection from the bonds of the khaki, our democratic institutions have fared badly because of the characteristic propensity of the political party in power to fill vital institutions with "our men," or "our women" for that matter. Unfortunately, the worst sufferer of such a biased attitude has been the Election Commission (EC). With every successive government, the commission has been made more blatantly partisan. It is no wonder that one of the reasons for the decay of democracy in Bangladesh is the loss of people's trust in the electoral system. With every election, fewer and fewer people have exercised their right to choose their representatives, knowing that their votes matter little, the result being a foregone conclusion. The turnout in local elections—the most recent of them held only a few days ago—testifies to our views. And this ominous state has been acknowledged even by some serving members of parliament.

Can a nation that suffered unimaginable losses in terms of human lives—to establish the right and freedom to choose their own representatives and have them run their own affairs, and not by those who defile and distort the system to "get elected"—countenance such a state of affairs? We certainly do not want a repetition of the 2018 general election, nor the dozens of local elections held

Through our columns, we have been calling for enactment of appropriate laws to govern the formation of the Election Commission. We, therefore, endorse and strongly reiterate the call of those who have been demanding such a law, including that of 53 eminent personalities who recently also called for reforms, so that the civil administration and the law enforcement agencies are made resistant to all extraneous pressures

We wonder at the reluctance of the party in power to do so. After all, our constitution mandates such a law. However, while we are calling for enactment of a law for Election Commission formation, we are aware that any law can be circumvented—as we have seen happen many times before. But a law in place would at least restrict the ruling party's ability to ride roughshod over the provisions indiscriminately.

Only a credible institution can retrieve the faith of voters in the electoral system which, as of now, stands severely sapped. Also, it is in the interest of the ruling party that elections are not only claimed free and fair, but are actually so. Only a free, transparent and unencumbered Election Commission can ensure that. We also believe that, despite the process of selection of the commission members, everything depends on the quality of the individuals holding the posts, the strength of their moral fibre, and their obligation to the people and their conscience. In a democracy, it is not the verdict of the court but of the people that renders validity to an election, and to the people elected

Why construct a market inside Dhupkhola field?

It indicates a lack of appreciation for history on the part of authorities

N a city already devoid of enough playgrounds, the decision by the Dhaka South City Corporation (DSCC) to build a market inside the Dhupkhola field is disconcerting, to say the least. The Dhupkhola field is not just a playground where people play different sports—it is a place where residents from nearby neighbourhoods come together to hang out and spend time with their friends and families. Therefore, constructing a market inside the field will most certainly change the entire characteristic of the field.

The Dhupkhola field also has a rich history of producing athletes who have gone on to represent Bangladesh at the highest levels of their respective sports The first Test centurion of Bangladesh, Aminul Islam Bulbul, is just one cricketer of note who trained in the field. Mohammad Rafique, considered one of the best spinners Bangladesh has ever produced, is another. Former national team footballers such as Ataur and Mamun Babu also trained in Dhupkhola field. There are currently three cricket academies based in the Dhupkhola field, where around 500 cricketers practise on a regular basis. Who is to say that the next great Bangladeshi cricketer will not emerge from there? And what will happen to the fate of these 500 athletes once the market eats up a significant chunk of the field?

According to the DSCC plan, the authorities will construct a five-storey market to house the 394 shops set up around the fields, which will take up 0.62 acres of the field area. The city corporation is also going to construct walkways, seating arrangements, parking spaces, and a cafeteria, which will further reduce the field's space. All these will bring down the total size of the field to 4.01 acres from 7.47 acres. Right now, the 7.47 acres of the field area is split into three parts: Jagannath University field, East End Club playground, and an open field for everyone to use. The construction of the market, by significantly reducing the total field size, will affect everyone who wishes to use it.

Research by the Bangladesh Institute of Planners (BIP) shows that the city's fields barely meet 10 percent of the public demand. When open playgrounds are already in such short supply, why is the DSCC taking up a project that will reduce them even further? There seems to be no logical explanation to this. The director of the Dhupkhola Math (field) Development Project justified the decision by saying that the facilities were being built because of "space constraints." But what about the lack of playing fields in Dhaka? How will the authorities make up for that? We urge the authorities to seriously reconsider their decision and find an alternative site for the market's construction.

Building a healthy e-commerce sector needs strong actions



¬HE recent crisis that has been created in e-commerce sector of Bangladesh is another example of financial fraudulence in There have been

complaints, for quite some time, about malpractices by a number of e-commerce companies. But those complaints fell on deaf ears, and the companies continued their business right under the nose of the relevant authorities. However, the problem could not be ignored for long as it became too big and unavoidable. The owners of e-commerce platform Evaly have been arrested for fraud, and cases have been filed against them under the existing law of the land. If they are proven guilty, they may have to stay behind bars for three to seven years, according to legal experts.

But will it help those who have lost their money? This is the most important question in the whole Evaly episode right now. Judging by our previous experience, getting back the customers' stolen money is a distant reality. Though the measures taken by the authorities are a positive move, it will not solve the problems faced by the affected people. Recovery of the money by confiscating the assets of Evaly seems to give a little hope. It has been reported that the value of Evaly's assets seems to be much less than the amount customers have paid the company to purchase products. The legal battle is a long process, and the affected people may not get their money back. Indeed, there have been similar cases before where the affected customers were not fully compensated. One may recall the misappropriation of customers' deposits by the sponsor of the Oriental Bank Ltd in 2007, and the collapse of the bank. Till today, many clients of the bank have not gotten their money back. Not too long ago, people were also cheated by multilevel marketing companies that allured innocent people with the promise of higher returns on their deposits. The deceit of those businesses was unearthed a few years into their operations, and the culprits were put behind bars. But the cheated customers did not get their money back. Several low-income people lost their lifelong savings.

Will the customers of Evaly get their money back? When and how? As discussion on the solutions to the Evaly problem continues, there have been demands for compensation from the government. This is, indeed, a dangerous proposition. Government money is taxpayers' money, and that money is for the development of the country and to support the poor. We are still in the middle of the Covid-19 pandemic; a good number going on for several months. Why these of people in the country—who lost their jobs during the pandemic—are yet to get their jobs back and earn their living like they used to before Covid hit the country. Public money is to support people during such difficult times, generate jobs, and create opportunities for the people. Why would the hard-earned money of our taxpayers be used to compensate for a crime committed by two greedy individuals? This will only encourage malpractice in this sector as well as in others. The government's objective should not be encouraging bad practices, but to root out the greed of deceitful businesses like Evaly.

E-commerce is a new but potential sector for Bangladesh. It is a source of employment for the youth. In Bangladesh, the capacity of the job market to absorb all of the aspiring young population is limited. This sector creates opportunities for them. But this prospect is not for the unemployed youth only; many smart and promising young citizens, who could easily find good jobs but do not want to work for others, have started their own businesses with innovative ideas. They have created jobs for others; they have set examples of ethical business. Several successful e-commerce businesses are also attracting foreign investment because of their reputation. Having a large population, Bangladesh is an attractive destination for the e-commerce industry. As our per capita income is increasing, consumerism is also expanding. It will continue to do so as the country is expected to do better in the

coming days. But unethical practices of a few e-commerce companies have damaged the customers' confidence. If this is not remedied, it will not only have a negative impact on youth employment, but also on the overall economy. So, policymakers must address customers' concerns without

With the unveiling of fraudulent practices of a few e-commerce companies, the role of regulatory bodies has come into question. The Ministry of Commerce and the Bangladesh Bank have critical roles to oversee and monitor such businesses. These malpractices have been

were not tracked and stopped by the responsible departments are questions that must be answered. Going forward, there is a need for coordination between these and other relevant bodies, such as law enforcement agencies, e-commerce associations, the financial organisations which facilitate payments, and a consumer rights protection department, for a healthy e-commerce sector. Following the Evaly debacle, the Ministry of Commerce has launched Digital Commerce Operation Guidelines, 2021. It has instructions on product delivery, payment, information

misappropriating customers' money through their unchecked greed. In the process of their financial accumulation via cheating customers, they were also involved in other unethical practices, such as sponsoring various organisations, giving gifts to important people, etc. On the other hand, some customers wanted to make money by buying products at discounted prices and reselling them to others at higher prices. There are also small customers who ordered goods for their own use, but never received their products, nor was their money refunded Both types of customers were naïve: they

to customers, etc. It also mentions that if companies fail to comply with the guidelines, the government can shut them down. Also, consumers can lodge complaints with the Directorate of National Consumer Rights Protection and relevant courts. There are demands from some groups that these guidelines should be more comprehensive and stringent. There are also suggestions for new laws. However, e-commerce companies do not want a separate regulatory body. They want facilitation, not regulation. Legal experts suggest that the existing laws can be amended to take measures against the fraudulent companies. But having good laws is not the solution to the problem proper implementation of the law is the

did not realise that such discounted rates are impossible, and businesses cannot sustain through such irrational practices. This cannot be a business model. This is a cheating model.

Given the importance of the issue, it may continue to be the topic of discussion for some time—perhaps before another, more serious incident happens! However, this issue is important not only because customers have lost over Tk 1,000 crore to Evaly; the problem is much bigger than that. It is about this whole practice of becoming rich overnight through malpractices and corruption, and yet receiving acceptance and even accolades from our society. They occupy the cover pages of magazines, they are projected as role models and are discussed in the media and elsewhere, and they take the centre stage of programmes attended by powerful people. They would shamelessly show off their wealth, while others would admire them. At times, the power of their money is stronger than the power of policymakers. Hence they stay above the law. They get away with crimes. The Evaly scam is yet another test case for the policymakers to prove its commitment to the common people of the country.

In fashion, 'sustainability as usual' may no longer be enough



decouple business climate impacts? This is the thorny question that no politician wants to answer right now, and it is easy to understand why. On the one hand, all our leaders

recognise that "business as usual" is no longer an option on a planet where we are already seeing evidence of global change on a daily basis. The latest report by the Intergovernmental Panel on Climate Change (IPCC), the United Nations body for assessing the science related to climate change, states that many of the changes observed in global climate are unprecedented in thousands—if not hundreds of thousands—of years. It says that the changes are widespread, and that the role of human influence on climate is undisputed.

At the same time, if one considers the above argument in light of Bangladesh's most successful export industry, it is evident that we may have a problem. Fashion creates millions of jobs in lesser developed countries, such as Bangladesh. If the "fast fashion" tap were to be switched off—in the name of protecting the environment—many of these jobs would be gone, and the societal impact would be huge.

Our leaders recognise this conundrum—this balancing act between societal and environmental impacts. It is for this reason that the idea of decoupling economic growth from climate impacts is so appealing. Such a decoupling would mean that economic growth would become a sustainable goal for all of

Is this even possible? Until relatively recently, decoupling of this nature has been viewed as a fanciful notion. This is because the majority of historical data and projections illustrate the intrinsic link between material and energy use and

the consequent carbon emissions/climate impacts.

As a consequence, many people have difficulty reconciling the sustainability goals of a business model—fashion, in this case—which is dependent upon selling more and more business units. In short, they say we can't have our cake and

I personally have one foot in this camp, and believe that the idea of "sustainability as usual" may no longer solution where we can separate traditional GDP growth from climate impacts. Within the textile industry, this is via recycling and the circular economy. I have written about this issue before, but I believe it deserves growing scrutiny in countries like ours, which are so heavily dependent upon labourintensive manufacturing industries, such as clothing production. It is in our own interest to embrace solutions that can separate growth from the impacts of

remanufacturing; and useful application of materials such as repurposing, recycling, and material recovery. While not all of these ideas will be

easy to apply in the RMG manufacturing space, many of them could extend the useful life of garments. For example, textile materials can be repaired and refurbished, and alternative markets can be found for them. Is our garment

industry ready to explore these ideas? If all of this sounds quite radical, that's the intention. I said sustainability as usual might not be an option moving forward, and as manufacturers we need to think about what this new landscape might entail if we are to remain relevant to our fashion buyers. Be in no doubt: our buyers are looking for solutions in these areas. When they talk about "going circular," it is us, their manufacturers, that they are relying on to enable them to achieve their goals.

What can we do now to prepare for a less resource-intensive, circular environment, where GDP growth is decoupled from carbon emissions?

Most experts agree that several steps will be required for textile manufacturers. One is to phase out the use of unsafe materials and the discharge of microfibres (another huge issue for our customers). This will require more innovative garment design and smarter production processes.

The second is changing the way clothes are designed, a step to be taken in collaboration with our buyers Step three is designing products

keeping recycling in mind, so that the products are recoverable at the end of their "life."

Taken together, these actions would initiate a major step for our RMG sector. At some point, we may need to think very differently about our business models as part of a broader societal shift away from a linear business model. These are difficult questions, but now is the time to think about their answers.

Feminist icon, educator, and author Kamla Bhasin passed away on September 25, 2021, at the age of 75. The Daily Star pays tribute to her rich legacy by reprinting an interview first published in 2016.

like getting a booster shot of energy and optimism. Her vivacity and enthusiasm will catch you unawares and force you out of whatever cynicism is afflicting you. And cynicism in a world so full of injustice

and superficiality is a comfort that is hard to let go of. But Kamla has given feminism a much-needed sanguine spin. She is kind of a brand ambassador for "South-South cooperation," bringing together men and women from South Asia to learn from each other's experiences, in the hope of bringing greater understanding and camaraderie in a region so divided by political, economic, and

For the last 40 years, she has been coming to Bangladesh speaking on uncomfortable things like patriarchy, gender inequality, and sexual violence. Kamla talks about such sensitive issues with simplicity, wit and clarity, making her one of the most compelling speakers one could have the privilege of listening to. I remember one such lecture—perhaps a good 10 to 15 years ago that had left me riveted. Hence my elation at the prospect of interviewing her a few days

Clad in her newly acquired Grameen check kurta—"for my birthday," as she puts it (she was born on April 24, 1946)—Kamla looks very much the "development feminist" she calls herself. She is still the silver-haired champion of the marginalised, with piercing eyes and that straightforward eloquence that makes her the perfect interviewee.

I know my time with her is limited, yet cannot resist from asking her to begin from the beginning.

It was 1975. Kamla, then a twentysomething young woman, was working for FAO and was assigned to identify innovative development work in Asian countries and create networks between people across countries. "At that time, none of us, not a single NGO, knew anyone across the border," Kamla explains. "Indians didn't know Bangladeshis, Bangladeshis didn't know Indians, Nepalis didn't know Pakistanis there was NO contact. So, the purpose was what later became known as South-South cooperation at the people level."

But Kamla persistently pursued the idea and eventually managed to hold a South Asian workshop in Dhaka attended by women from all these countries. It was for the first time that Bangladeshis realised that "not everyone in Pakistan was responsible for the atrocities, that there were people there who were actually against those policies, that governments don't represent our people, and that we need to start to rebuild those bridges—at least among our civil society

It was also when Kamla met Dr Zafrullah Chowdhury and was completely wowed by what he had achieved with Gonoshasthaya Kendra. "If anyone has thought 'out of the box' in South Asia, it was this man. The way he started training women paramedics, drivers, security guards, was amazing. In our jargon, we call this 'gender transformating'when you change the definition of a woman or a man, you transform gender. Now gender is a social definition—of a man or a woman. Think of a girl who can drive a car, ride a bicycle. So when this man gave them jobs as

paramedics, the first thing he told them is that you have to ride a bicycle and that was, for me, a revolution for Bangladesh."

Thus, for Kamla, such development miracles also organically became lessons in gender politics. There was also a kind of awakening in the world in general. In '75, the first global conference on women had taken place (in Mexico) and NGOs in the field, says Kamla, were realising two things: Firstly, development from the top was not reaching the poor—it was reaching the elite of the villages of our countries. Secondly, they realised that development was not reaching women, and these kinds of insights were

coming from Africa, Latin America and Asia based on the work of the NGOs that were working with people, not governments.

She was invited by development activists from all over South Asia to hold gender training workshops. She challenged patriarchy and even the language of patriarchy: "The word 'swami' (husband), for example, means malik or owner. But the constitution says that Bangladeshi women cannot have an owner or master—they can have a partner—so swami is anti-Bangladesh Constitution as far as I'm concerned; similarly, 'pati' is against the Indian Constitution. No Indian citizen can have a pati controlling her. Even the word 'husband' is sick—it comes from animal husbandry; to husband is to control or domesticate.

Kamla's deep understanding of gender issues at the grassroots level comes from her own experience growing up in the villages of India—her father, a medical doctor, was posted at various villages where she attended school up until matriculation. She went to a government university and got her bachelors and master's degrees "with second divisionso had a bad education but learnt a lot of common sense." Later, she went on to study sociology of development at the Muenster University in Germany with a fellowship.

In 2002, she resigned from the UN and gave all her time to the feminist network

she had helped to set up, called Sangat, an informal network of which anyone can be a member.

western concept. From a development worker, she also became a feminist development worker, and therefore, at the conscious level, a feminist. This is the story of many others, says Kamla. "We didn't become feminists by reading

Kamla rejects the notion that feminism is a

western feminist theories," she adds. "We became feminists by looking at the realities of women in the villages—e.g. what was dowry doing to women, about domestic violence, how women were being treated at home and in society...

But feminist theory in the formal sense was also important, and Kamla and her fellow activists started inviting to their workshops academics—social scientists, political scientists, and economists who were feminists and working on feminist theories. The marriage between theory and action was

Kamla also started writing about these issues in courses, which became very important resource material—booklets on understanding patriarchy, gender. They were also translated into 25 to 30 languages. The movement that Kamla and her fellow activists started, moreover, got rid of binary divisions: "One of my slogans is: 'I am not a wall that

divides, I am a crack in that wall.' So all these walls of nationalities—Bangladeshi, Pakistani, Indian—we become cracks in these walls and we go across borders and make friends. Pakistani women were the first to apologise for the genocide here—Pakistani feminists."

Cultural expression was the most effective tool to reach the messages of equality. From the very beginning, music, dance, and posters have been part of Kamla's work, especially in reaching an audience that was mostly illiterate. She wrote a hundred songs and compiled them into CDs and had posters with slogans such as "Zero tolerance for violence against women," "Men of quality are not afraid of equality," "Honour killing no honour in killing," etc translated in the

But despite such dedication and innovative feminist efforts, we are in a world where violence against women is alive and kicking, and objectification of women is at its zenith. When I ask why, Kamla's answer is simple: "Capitalist patriarchy" along with religious and cultural patriarchy. She cites the pornography industry which is a billiondollar industry that reduces women (and children) into objects of sex. The cosmetics industry, says Kamla, promotes the idea that a woman is just a body, and unless she decorates herself in this way, she is nothing. Women have been reduced to being just bodies-perfected through surgeries and procedures. "So once you are a body, what's the harm in raping you or groping you?" Kamla asks. In a capitalist patriarchy, she says, everything saleable is sold and profit predominates over people.

Patriarchy, says Kamla, is equally damaging for men because it dehumanises and brutalises them.

"One other thing," she adds, "our struggle for gender equality is not a fight between men and women. It is a fight between two ideologies—two ways of thinking. One ideology is that patriarchy is better, that men are superior. The other says, no, equality is better, men and women are different and equal, and equality is good for all. And that men must realise that unless women are free, men cannot be free."

With that provocative comment, my interview with this innovative, compassionate development feminist comes to an end. I still have so many questions, but reluctantly I relent, remembering that she has a birthday to celebrate.

But mitigation and adaptation do not exhaust all the options. Carbon removal specifically breaks the second link in the chain—from emissions to concentrations. Technically, emissions could stay the same, while removal sucks enough carbon out of the atmosphere to decrease concentrations, lessening the net effect and giving rise to many a "net-zero" climate

That sounds like a win-win. But it turns out to be a rather expensive proposition, especially when looking beyond trees and other "nature-based" solutions. While they remove carbon from the atmosphere, they retain it in the biosphere and are

carbon removal technologies? Moreover, why should big polluters be let off the

That second question goes to the heart of many political debates around climate and economic policy more broadly. Is climate change caused by too much pollution, or is it a problem of economic growth itself? Those who believe it is the latter argue for a full-scale reining in—or rechannelling—of economic activity and market forces; some even call for "degrowth" and other more sweeping societal transformations. Given these associations, it is easy to see why those on the left would be suspicious of carbon removal, and why those on the right might be eager to embrace it.

The political dynamics driving the carbon removal debate are even stronger

in the discussions of solar geoengineering. By reflecting more of the Sun's radiation, this potential intervention aims to break the link between atmospheric CO2 and rising temperatures. It would not address ocean acidification and other problems directly tied to higher atmospheric concentrations, but it could have its own advantages. Chief among these is that the effects could be virtually immediate, reducing temperatures within months and years, rather than decades and centuries.

Serious discussions of solar geoengineering have long since moved on from the Johnson White House's ideas about brightening the world's oceans. The most-discussed method today envisions the seeding of small reflective particles into the lower stratosphere to mimic the global cooling effects of large volcanic eruptions.

Some describe this scale of geoengineering as a "last ditch" option that should be reserved only for a planetary emergency. Others emphasise that it should be viewed only as a potential complement to serious emissions reductions and other interventions—from adaptation to carbon removal—with each addressing climate risks differently.

But again, those who merely argue for more research into solar geoengineering usually meet with strident "moral hazard" objections, as if simply studying the issue will distract from emissions cuts. We must move beyond that argument. Remember, adaptation measures used to be viewed the same way.

Regardless of whether one believes that solar geoengineering is inherently dangerous, potentially useful, or both, one should support more careful, open, and transparent research into the matter. We are not in a position where we can peremptorily reject potential solutions to the climate crisis. If nothing else, geoengineering research could help to educate those who are still dragging their feet on emission reduction.

After all, by failing to break the other links in the climate chain, we are making it more likely that either carbon removal or solar geoengineering will become a key element in the 21st century climate policy portfolio—whether one likes it or not.



In the Mymensingh-Sylhet sector, Mukti Bahini today ambushed a Pakistani patrol near Gafargaon in Mymensingh district and killed two Pakistani soldiers. On the night of September 27, Mukti Bahini raided Pakistani troops guarding the bridge near Rahimpur, killing one enemy soldier. In another operation, Mukti Bahini attacked Pakistani troops near Baotali and killed three Pakistani

In the Dhaka-Cumilla-Chattogram sector, Mukti Bahini raided the Pakistani position at Kaimpur, killing eight enemy soldiers and injuring seven. Two enemy boats were destroyed in the area. On the same day, Mukti Bahini raided Pakistani positions at Sripur and Ajnapur areas and killed 11 Pakistani soldiers. In another operation, Mukti Bahini ambushed Pakistani troops near Monoharpur and Koteswar, killing four of the enemy.

was constructed around 150 feet inside the demarcation pillar. Now, construction works for large jetties are ongoing on the north side of the landing station. Besides, a two-storied government

building has been constructed by the Department of Agricultural Marketing in the space between the landing station and the under-construction

Paribesh Bachao Contacted, Andolan Chairman Abu Naser Khan said large concrete structures like jetty would obstruct the natural water flow and public movement, he claimed.

There is a High Court directive that imposes a ban on the construction of any structure obstructing the natural flow of river water. Besides, such construction on the riverbank would encourage further encroachment, he added.

"In the case of road communication, we can see that parking spaces are being constructed by widening roads. Similarly, jetties should be constructed by widening rivers instead of filling it," Khan said. Contacted, Bangladesh Poribesh

Manchester United slumped to a first Premier League defeat that paved the way for Liverpool to go top later, although Juergen Klopp's side had to be settle for a point as Brentford secured a 3-3 draw in a thriller.

Liverpool have 14 points from six games with City, Chelsea, United and Everton all on 13 points. Brighton & Hove Albion could go top with 15 points if they beat Crystal Palace on Monday.

Bangladesh's focus has been on the shortest format of cricket with the T20 World Cup looming, but the selectors showed a willingness to prepare for the

longest version of the game as well, with the stage set for the start of a fresh season of the National Cricket League from next month.

The first-class competition was initially postponed and later cancelled earlier this year due to the Covid-19 pandemic. However, after having already announced 20-member squads for participating teams, the country's premier first-class competition is now tentatively slated to begin from mid-October.

That means members of Bangladesh's T20 World Cup squad will not be able to participate from the start of the tournament since they are scheduled to travel to the middle-east in the first week of October.

Selector Habibul Bashar nevertheless opined that the NCL would be good preparation for players ahead against Pakistan in November a two-match Test series.

"We have a few Test matches right after the World Cup. It's a good opportunity to prepare players. We didn't get much of a chance to play Tests. Obviously, there is a difference between a practice match and a competitive match. I think the NCL will be adequate preparation for the Pakistan series," Bashar told media yesterday.

The former Bangladesh captain expressed hope that it would be a competitive competition considering the amount of time the players have to prepare.

"This time we are starting the NCL with enough time on hand. Teams will get sufficient time, around a month, to prepare. The players will undergo a fitness test on October 1 and are expected to start skills training by October 5. As the pitches will also get plenty of rest, we are hoping to have a competitive league this time around," he added.

The Tigers fared horribly in the previous World Test Championship cycle, failing to register a single win. But Bashar is confident of a better showing in the second cycle, starting with the series against Pakistan.

Despite the fact that a majority of players will be engaged in the T20 World Cup, the upcoming NCL will help prepare redball only cricketers, including the likes of Test skipper Mominul Haque, Saif Hasan, Shadman Islam, Najmul Hossain Shanto, Abu Javed and Ebadot Hossain.

"I think the NCL is going to be very good preparation for us ahead of the Pakistan series. We also had two four-day practice matches between the A team and High Performance squad and I think that was also very fruitful," Test opener Shadman Islam told The Daily Star yesterday.



BIWTA filling up the Turag again

Experts say it's building multiple jetties violating HC order

Bangladesh Inland Water Transport Authority (BIWTA) has taken an initiative to build permanent structures in the capital's Gabtoli, Amin Bazar, and Diabari areas by filling

The government body has come up with the initiative as part of its plan to construct large concrete jetties on the riverbanks.

In 2005, the same authorities constructed landing stations in the same areas by filling the riverbanks as the government introduced a water taxi service to facilitate

Despite spending a huge amount of money, the government failed to popularise the service that has been remaining shut for many years.

The landing stations have remained abandoned since then with the suspension of the service.

During a recent visit to the areas, this correspondent noticed that multiple private and government structures were set up adjacent to the landing stations by illegally filling the river.

The newly-planned large jetties will be constructed near these landing stations.

Contacted, environmentalists said that construction of such illegal structures by filling the river violates a directive of the High Court.
