Special vaccination drive today marking PM's birthday

The government begins a special daylong drive at 9:00am today to administer the first dose of the Covid vaccine to 75 lakh people marking the 75th birthday of Prime Minister Sheikh Hasina.

"Only those who have already registered and been waiting for vaccines will be jabbed," Prof Abul Bashar Mohammad Khurshid Alam, director general of the health directorate, said in an online briefing yesterday afternoon.

In the first two hours, males aged 50 and above, females, and differently abled people will get vaccines on a priority basis, Khurshid said.


Expecting and lactating mothers will not be vaccinated during this campaign.

Everyone must carry the Covid vaccine registration card and the national identity card to the vaccination centres to get vaccines, according to a public notice published in the Facebook page of the Directorate General of Health Services (DGHS) yesterday.

Each centre at unions and municipalities has a target to jab 500 people throughout the day while the target figure is 1,000 for each centre in the city corporation areas, according to the DGHS DG.

Bangabandhu Sheikh Mujibur Rahman devoted his life to making one dream come true: establish a democratic, peaceful and disparity-free society called "Sonar Bangla". Braving myriad hurdles, he was striving to take the nation to that promised land.

SSC exams to start Nov 14, HSC on Dec 2

This year's SSC and its equivalent examinations will begin on November 14 while HSC and equivalent exams on December 2. The examinees will

have to take the tests only in three optional subjects with a shortened syllabus and the exams will carry fewer marks.

They will not have to sit for tests in compulsory subjects like Bangla, English and Mathematics.

Usually the Secondary School Certificate (SSC) and its equivalent

examinations take place in February while the Higher Secondary Certificate (HSC) and its equivalent tests in April.

But the Covid-19 pandemic has delayed the exams this year, severely disrupting the academic life of students.

The routines published yesterday show the SSC exams will conclude on November 23 and HSC on December 30.

The exam duration for each paper will be one and a half hours and there will be no break between MCQ

Although the government said any university or its affiliated colleges could resume in-person classes if all their students completed the Covid-19 vaccine registration by yesterday, more than half the tertiary-level pupils across the country failed to do so within the deadline.

Most students do not have their national identification (NID) card, which is mandatory for vaccine registration through the government's Surokkha app

The University Grants Commission (UGC) opened a weblink for such students to enable them to use their birth certificates to register. But a large number of them have not used the link yet, several top UGC officials told The Daily Star yesterday.

UGC Chairman Prof Kazi Shahidullah, however, thinks resuming in-person classes at universities and their affiliated colleges will not be a big challenge.

"The Covid-19 infection rate has come down significantly. It is now under five percent. If universities can ensure health guidelines properly, they can resume classes upon approval of their academic councils and syndicates," he said.

UGC Member Prof Muhammed Alamgir hoped that a huge number of students would get their first dose of the vaccine as the government today conducts a special daylong campaign aiming to inoculate 75 lakh people. SEE PAGE 2 COL 3



LENDING AT HIGH INTEREST RATE

Shut them down, take legal action

HC asks govt about financial and microcredit institutions, cooperatives

The High Court yesterday directed the government to immediately shut down the offices of unauthorised financial and microcredit institutions and cooperative societies and to take appropriate legal actions against them for lending at high interest rates.

In response to a writ petition, the court also ordered the finance secretary and Bangladesh Bank to form a committee to look into the activities of such unauthorised institutions and cooperative societies and submit a report to the court in 45 days from formally receiving the order.

Moreover, the HC asked the microcredit regulatory authority to make a list of names of local money lenders that have no licence and give the list to the court in 45 days.

At the same time, the court issued a rule asking the respondents to show causes as to why their failure to monitor and supervise the activities of unauthorised institutions and cooperative societies should not be declared illegal.

Secretaries at the ministries of finance and social welfare, governor of Bangladesh Bank and microcredit regulatory authority's chairman are the respondents to the rule.

The HC bench of Justice Abu Taher Md Saifur Rahman and Justice Md Zakir Hossain issued the order and rule after hearing a writ petition seeking an order to ban informal money lending businesses.

During the hearing, lawyer Syed HC bench on September 20 that unauthorised financial institutions

have embezzled crores of Tk from the people in the name of money lending. Jubok, which had misappropriated

Tk 2,600 crore in 2006, had no licence to as a lender, he said. Syed Sayedul Haque Suman, on

September 7, submitted the petition as a public interest litigation to the HC -- also challenging the failure and inaction of the respondents regarding informal moneylenders from lending money with exorbitant interest rates. The petitioner also sought

a directive from the HC on the respondents to identify the unauthorised moneylenders across the country.

Informal money lending businesses are present at every village across the country in the name of cooperative societies, the petition mentioned.

Many people also individually run money lending businesses and take high interest rates, it said. Such individuals collect weekly and monthly instalments from borrowers even though they have no registration to do this. Poor borrowers often become hostage to the lenders and end up being destitute.

A borrower reportedly has to give Tk 500 to Tk 1000 in interest every week for a loan of Tk 10,000, Sayedul Haque Suman said in the petition, adding that such money lending businesses are illegally functioning in broad daylight and need to be banned.

He also requested the HC to issue a rule asking the respondents to show causes as to why the failure and inaction of the respondents to prevent Sayedul Haque Suman told the informal money lenders from lending money at high interest rates should not be declared illegal.

Unusual UN meet to close without Taliban, Myanmar speeches

The UN General Assembly in New York was set to end yesterday but without speeches by those in power in Afghanistan and Myanmar, one of many quirks at this year's diplomatic marathon that saw 100 leaders defy coronavirus fears to meet in person.

The UN representative of Afghanistan's former regime was expected to defy the Taliban with an address yesterday after the group requested its new foreign minister be allowed to speak instead. The Taliban wrote a letter to UN Secretary-General Antonio Guterres last Monday requesting that Amir Khan Muttagi be allowed to "participate." The letter noted that Ghulam Isaczai, Afghanistan's UN envoy under Ashraf Ghani, who was ousted last month, "no longer represents" Afghanistan at the United Nations. The plea was due to be considered by a committee that included the United States, Russia and China, but a UN official told AFP the meeting didn't take place. A diplomat said the Taliban sent their request "too late," paving the way for Isaczai, whom the UN still recognizes Afghanistan's representative, to speak. If he does take the opportunity, he could demand a strengthening of sanctions against the Taliban, as he did during a Security Council meeting on September 9.

Once dubbed as a "bottomless basket" by former US secretary of state Henry Kissinger, Bangladesh is now among the most vibrant economies in the world. It is now considered a 'role model" for the strides it made in various sectors including education, health, agriculture, and empowerment of women.

And for that to happen, she was unwavering in the face of numerous odds.

Of all she has done, infrastructure development might be one of her brightest legacies.

Aware of the challenges of globalisation in the 21st century, she placed a roadmap in her party's manifesto "Charter for Change -Vision 2021" before the 2008 election. After having made good on many of her pledges from Vision-2021, she placed in 2014 "Vision 2041" to help Bangladesh graduate to a developed country. The longest-serving prime minister

of Bangladesh, Hasina turns 75 today. The eldest among the five children of Sheikh Mujibur Rahman and Sheikh Fazilatunnesa Mujib, she was born at Tungipara in Gopalganj on

She spent her childhood at Tungipara and started her schooling there. When Bangabandhu was elected a legislator, his family moved to Dhaka in 1954.

Hasina got into student politics while in college and was elected the vice-president of the students' union at Government Intermediate College (now Begum Badrunnesa Government Girls' College) for the 1966-67 term. As a student leader, she took part in

the Six-Point Movement of 1966 and the student movement of 1969, which saw off the Ayub Khan regime . In 1968, Hasina got married to

nuclear scientist Dr Wazed Miah. She and her younger sister Rehana survived the August 15 bloodbath as they were in the then West Germany.

After a long exile, she returned to the country from India in 1981.

Since then, she has survived at least 19 attempts on her life, the worst being on August 21, 2004, when grenades were hurled at an Awami League rally.

In 1981, while in exile in India, Hasina was elected the president of the Awami League, one of the oldest political parties in the country. She has been leading the AL since then

During her term as head of the government, Hasina initiated war crimes trials, setting up two special tribunals. Several notorious war criminals were executed after completion of the trial proceedings. Also, under her watch, the trial of Bangabandhu murder case was completed after the scrapping of the infamous indemnity ordinance.

Since being elected the prime minister in 2009, Hasina has indeed been steering the country towards development.

However, like any other leader, Hasina has her share of controversies. There are allegations that under her tenure the country has witnessed some backsliding with regard to public trust in the electoral system and the rule of law; it has also seen weakening of institutions, shrinking of space for media and freedom of expression. And a functional parliament remains a far cry.

Prime minister for three times on the trot and only two years away from the next general election, Hasina now faces a stiff challenge: a seal of people's approval.

Masud Al Mahdi alias Apu, 27, completed his masters in Mass Communication and Journalism in 2018

He had participated in different movements on the campus and was part of the Ducsu polls, his friends said.

His roommate Al Imran said three people, including Apu, used to live in a room on the seventh floor of an eightstorey building. The top five floors of the building are used as "mess" where nearly 200 students live.

"When I came to the room to have lunch, I found the door locked from inside. Then through the window, I saw him hanging from the ceiling fan. We broke open the door and informed police about it," he said.

On information, police rushed there and sent the body to Dhaka Medical College morgue in the evening for autopsy.

His friends and juniors at the journalism department suspect he was murdered.

Jasim Uddin Molla, deputy commissioner of Lalbagh Division Police, said the roommates of the victim said he died by suicide.

Police recover body in building in Chattogram

Police recovered a body from an under-construction building in Khulshi's Jalalabad area in the port city yesterday.

The dead was identified as Md Nezam Pasha, 65, the owner of the sixstorey under-construction building where his body was found.

Md Shahinuzzaman, officer-incharge of Khulshi Police Station, said

said the government set the target to inoculate 80 lakh people today.

He also mentioned that students aged 18 and above who have registered would also be vaccinated.

However, there was no mention of students in the DG's briefing as well as in the DGHS circular yesterday.

Around 80,000 health staffers and volunteers will work in 16,153 vaccination booths during the campaign.

"The local health officials and other stakeholders, however, can increase the number of vaccination target and booths, if needed," Khurshid said.

For today's special campaign, the government will mainly use the Sinopharm vaccines.

There will be sitting arrangements in each centre for people to wait for half an hour to check any health issues after being vaccinated. A special team will also be present at each centres to tackle any side effects.

"Whatever the situation may be rain, cyclone, or anything else -there is no way to stop the vaccination campaign," Khurshid said, adding that the EPI programme (regular

vaccination) must continue. The DGHS runs different vaccination programmes round the year under Expanded Programme the on Immunisation (EPI).

The health DG said they have already held coordination and advocacy meetings with local public representatives and civil society members to carry out the special campaign.

Meanwhile, 25 people died from Covid-19 in 24 hours preceding 8:00am yesterday, said a DGHS press release.

A total of 1,212 people tested positive for the virus during the period.

With the latest counts, the total number of Covid deaths in the country rose to 27,439 and the number of cases went up to 15,52,563.

The death rate stands at 1.77 percent. Against a total of 27,787 samples tested during the 24-hour period, the positivity rate was 4.36 percent. The rate remains below five percent for five days in a row.

Of the 25 deceased, 13 were males and 12 females.

Half yet not registered

UGC officials said about 24.34 lakh students -- around 54 percent of the total 44.34 lakh studying in universities and their affiliated colleges did not register with Surokkha or the UGC weblink until yesterday.

Most of those students are from colleges under the National University. So, reopening those colleges would be a challenge, said a UGC member, adding that the registration rates among public and private university students were comparatively better.

On August 26, a meeting attended by officials of the two education ministries and other stakeholders had decided that in-person classes at universities and their affiliated colleges would resume from mid-October after vaccinating all students by September.

The government later moved away from the stance. On September 14, it said any university can resume in-person classes if all its students complete the online registration by September 27.

REGISTRATION

One-hundred and seven private universities, 50 public universities and their affiliated colleges have 44.34 lakh students in total, according to the latest UGC annual report.

There are about 3 lakh students at public universities, excluding the National University, the Open University, Islamic Arabic and medical universities.

The private universities have some 3.50 lakh students and colleges affiliated with universities including National University have 37.84 lakh students.

About 90 to 95 percent of about 15,300 public university teachers have received both doses of the vaccine, said UGC officials.

UGC acting secretary Ferdous Zaman yesterday afternoon said about 18 lakh students have so far registered for the vaccination with the government app.

Of them, about 5 lakh students received the first dose and 1.5 lakh got both doses, he said.

60pc returnee female workers unemployed

Says BILS report

Sixty percent of 323 female returnee migrant workers in 12 upazilas under three districts are currently unemployed, according to a new report of Bangladesh Institute of Labour Studies (BILS).

The report states that one in three female returnees have lower socio-economic status than before.

Highest 22.6 percent of the female migrants returned home within 12 months of their migration and lowest 3.4 percent stayed abroad for 10 years or more, the report adds.

BILS disclosed findings of the report "Social and Economic Reintegration of the Returnee Female Migrant Workers: Success and Sorrows" at a programme at its auditorium yesterday.

In a broad sense, the reasons behind female migrant workers' return home include low wage and forced labour in the host countries, said the report's lead researcher Manirul Islam.

He said official data on returnee female migrant workers is not available, but in their estimate, on an average, 200 to 300 such workers return home each month.

Manirul, deputy director (research) of BILS, said at least a dozen ministries are responsible for returnee reintegration but a coordination gap in this regard among them was evident.

The report says 55 percent returns of the female migrants was either unexpected or forced.

The research was conducted in four upazilas each of Jashore, Faridpur and Chattogram districts between July and December 2020.

Most of the female migrants returned from the Middle East -- Saudi Arabia, Lebanon, the United Arb Emirates, Oman and Jordan. Of them, 5.6 percent are aged between 18-25 years and 81.3 percent between 26-49 years.

Also, 24.5 percent female returnees are either divorced, widowed or were abandoned by their husbands, and 3.1 percent are unmarried.

Some 54.5 percent female returnees have no institutional education, and another 29.8 percent studied up to grade-V.

The report says 61 percent female returnees have debt burden of Tk 76,736 on an average. Thirty-eight percent respondents alleged they were abused physically in the destination countries, 52 percent were victims of forced labour, and 61 percent often suffered from lack of food and water while abroad, it says.

Besides, 10 percent of the female returnees were imprisoned abroad, it adds. Fifty-two percent female returnees thought "a change of social attitude"

Killing an innocent woman to frame rival in polls

PBI arrests Mongla UP election candidate, two others

A member candidate of a union parishad election got a woman killed, all to frame his rival so that he can't win.

None of them won eventually, but an innocent woman, with no connection to the politicians, lost her life.

The Police Bureau of Investigation (PBI) investigated the incident for over a week and arrested three people in connection with the murder.

Although the feud started centring the UP member election of Chila union in Mongla, the killing took place in Baktarpur area in Savar, on the outskirts of the capital.

After murdering the woman, the killer left a photocopy of the

rival UP member candidate to frame him.

At a press briefing at its headquarters in Dhaka yesterday, PBI Chief Banaj Kumar Majumder said they arrested the mastermind, UP member candidate Halim Hawlader (52), the killer, Jamal Hawlader (50) and their associate, Moshiur Rahman Milon Kabiraj, a tailor by profession, from Bagerhat's Mongla, and Dhaka's Lalbagh

and Mirpur areas. At the press conference, Banaj Kumar said, Halim wanted to frame opposition member candidate Billal Sardar in a case so that he gets arrested and can not come out of jail. The PBI got a record of a

National Identity Card of the phone call where Halim was heard saying: "If Billal is not arrested, first a rickshaw-puller will die. If that does not work, then a woman will die.'

Banaj said the election was scheduled to be held on September 20. According to the plan, Halim hired a man from Dhaka -- Jamal -- to kill someone in exchange of Tk 30,000 in late August.

Halim collected Billal's NID copy and handed it over to Jamal, said the PBI Chief.

"The killer did not know whom to kill. The victim did not know why she was killed. They killed an innocent person only to gain influence...," said Banaj Kumar.

WATERLOGGED FOR 70 DAYS Khulna's Bastuhara colony an island now

It started around 70 days ago. Due to heavy rainfall, almost a third of Khulna city went underwater, including the low-lying Bastuhara colony area. But The Daily Star how unbearable it has while the rest of the city has since become to live there, not just because of

public representatives, no initiative has been taken to resolve the issue, they alleged.

Abdur Rob, a stationery shopkeeper and resident of the colony, described to

Incurring huge losses in his sanitary business during the pandemic, Shawkat Ali bought a motorbike two months ago to use it for ridesharing services.

But ever since he got it down to the street, he kept getting bludgeoned with fines for violating traffic rules.

Yesterday, right as the 46-year-old was about to be charged for a similar violation, the frustration inside him finally came out.

In broad daylight, Shawkat pulled out the bike's fuel pipe, lit a fire, and torched the bike then and there. He even obstructed people who tried to douse the flame.

A video of the incident soon went viral on social media. In the footage, Shawkat could be heard shouting in exasperation.

When The Daily Star contacted him over cellphone, he said, "I set it on fire myself. I cannot bear it anymore. Last week, traffic police filed a case against me, and another was

filed today [yesterday]."

For Shawkat, the last straw was when a traffic sergeant stopped him at the capital's Badda Link Road around 9:30am. Debpriyo Barua, the sergeant, took away his documents and started filing a case on charge of obstructing traffic.

Following the incident, police took Shawkat to Badda Police Station around noon, said Officer-in-Charge Abul Kalam Azad.

Contacted around 7pm, Shawkat said he

was still in the office of deputy commissioner and not in a position to talk "You understand I and not in a position to talk. "You understand I cannot talk," he said when this correspondent wanted to meet him.

OC Azad said, "He [Shawkat] was severely affected financially and was going through some psychological issues. He is burdened with debt after incurring around Tk 9 lakh in

losses at his shop." Narrating the incident, eyewitness Azam Khan said he, Shakhwat, and several other ride service providers stopped their bikes at the left turning point of the road for passengers, when the sergeant approached them.

While everyone else managed to drive away, Shawkat stood there bargaining with a passenger. The sergeant proceeded to catch up to him and asked for documents to penalise him Tk 5,000.

"Shawkat begged repeatedly not to penalise him, but to no avail," Azam said. Zakir Hossain, additional deputy

Free Kirtankhola of illegal occupation

Residents, activists demand at World Rivers Day event **OUR CORRESPONDENT,** Barishal

On the occasion of World Rivers Day, citizens of Barishal have demanded a Kirtankhola river free from pollution and illegal occupation. Prominent citizens and activists of Barishal made the demands while speaking at a programme yesterday morning.

The programme, titled "Nadi Kathan", was organised by the city-based rivers day celebration committee "Sammilito Udjapon Parshad" on the banks of Kirtankhola, where Deputy Commissioner Jasim Uddin Haider was present as chief guest.

Speakers said Kirtankhola is not safe anymore. Industrial pollution from various factories has spread throughout the river. Although all industrial establishments are required to have Effluent Treatment Plants to reduce pollution, only one out of seven such establishments in the city has one, they said.

The deputy commissioner said they have undertaken an initiative to evict illegal occupants from the seven canals connected to the river.

During his speech, environmental activist Anwar Zahid said it is a matter of concern that the water of Kirtankhola river has lost salinity.

Meanwhile, Rafiqul Alam, divisional coordinator of Bangladesh Paribesh Andolon, said although there are 4,000 illegal occupants in the area, authorities have taken action against only 60 organisations.

Among others, Bangladesh Environmental Lawyers Association executive director Rizwana Hasan, eminent citizen Sharmin Murshid, and LRD executive director Shamsul Huda attended the programme virtually.

bioresearch and coastal fisheries resources after setting up the research centre. Financed by the Bangladesh Fisheries Research Institute, scientists were able to devise the technology to farm soft shell crab and green oyster.

The research centre has taken all preparation to produce coral pry in hatcheries using salty water of Bay of Bengal. Once it goes into production which will use Malaysian technology, it will bring about a revolutionary change in the fisheries sector.

This research centre will also contribute to determine the strategy to deal with the impacts of climate change on coastal areas and its environment.

CVASU is the only university that arranges a six months internship programme out of twelve universities that confer fisheries degree. When other universities could not start classes physically or hold exams, our students taking vaccines have been staying in the research centre. Fifty-seven students (28 female and 20 male students) from the fisheries science department are doing their internship.

Besides that foreign students too come and stay in the research centre to research on coastal environment and climate change. Ten students from Malaysian university Terengganu did their internship staying in the research centre over a period of one month in 2017. Another batch has been pursuing. Instead, the report said how comprising 12 students from Putra University of

Malaysia stayed in the centre for one week and agreement that clearly says the university could completed their research.

It is not feasible for the students to perform Multiple researches kicked off on marine research by staying in hotels and motels in worldclass tourist site like Cox's Bazar. In such a reality, the five-storey building was built to facilitate the accommodation for researchers and students.

It is saddening to see responsible daily newspapers like The Daily Star run a fictitious and motivated report at a time when the research centre is moving forward with its various research activities and earned reputation for its contribution to the socio-economy of the country. The information of hill razing destroying the forest in the report is completely unfounded. false and not compatible with reality. No such devastation of hill cutting and forest clearing took place there. Rather the research on coastal biodiversity and marine research is being praised in every quarter. The university authority deems the report was done intentionally to tarnish the reputation of the university.

OUR REPLY

In the rejoinder, the university authorities did not specifically point out the reason it found the news report "fictitious" and "motivated". The rejoinder mainly detailed the "research centre", the internship it arranged, how many students stayed at the centre and how it was going to help the fisheries sector in bringing positive changes.

Our report did not say anything about who is residing in the dormitory; neither did we raise any question about the research the university the CVASU violated the condition of the lease

only build a research institute there.

The university authorities did not build any research centre that the rejoinder claimed. The CVASU constructed a dormitory in the protected forest. The five acres of forestland, which was leased out to CVASU, got the status of protected forest in 1935. The university authority took the lease on condition that they would build a full-fledged "Institute for Coastal Biodiversity, Marine Fisheries and Wildlife Research", which they did not. This is a clear violation of the lease condition.

Although the rejoinder claimed that no incident of hill razing happened, a forest department survey found the university authorities cut hills and destroyed forest even beyond the leased area. The Department of Environment filed a case against the CVASU vice-chancellor for cutting hills. The case is under trial in the environment court.

The Department of Environment, in a report prepared after a field visit on October 24, 2016 in the area, found the hills were levelled by five to six feet. The Daily Star obtained a copy of the report, which instructed the university authorities to stop it.

At that time, the razed area amounted to 165 decimals (five bighas). The field report said the way the hill was razed, it bifurcated the hills and uninterrupted forest, causing danger for wildlife. An elephant was found dead inside the razed area on June 10, 2017, which locals alleged died by falling from the hills. We stand by our report.

said Anjuman Ara Lucky a resident, of the colony's Road No 5.

"The floor inside my house has remained flooded since July 15. We are forced to keep all our perishable valuables, including our stove, on the bed," she said. "Our two children can't even go outside to play or walk."

Yunus Ali, a resident of Road-11, told The Daily Star, "It's inhuman that no one from any government agency or Khulna City Corporation are taking any action to remedy the situation. Small traders and hawkers of the area cannot store their belongings at home, as the floors have been underwater for months."

Contacted, Md Mahafuzur Rahman, councillor of Ward-9, said the colony is situated in a low-lying area, where sewers are narrow. Rainwater moves towards the colony from adjacent areas, he added.

"The city corporation is trying to drain out water to clean drains," he added.

Khulna City Corporation, said they have assigned cleaning staffers of the corporation to drain the water after any downpour, but due to its location being in a low-lying area, this proves to be a difficult task.

He also shifted part of the blame on to the residents.

Only 15 percent returnees have some sort of investment and 15 percent female returnees are satisfied with their present occupation.

economic reintegration. Shakil said, during their migration abroad, female migrant workers are not being provided with proper information and training.

As a result, they often experience a gap between their expectations and what they are being offered in the host countries, he

60pc returnee Killing an innocent Jamal contacted his friend Moshiur, who gave him a target -- one Parul Begum, who used to make children's clothes and sell them by herself. "Parul, a divorcee, used to live alone in Dhaka as her

daughter lived in village. She also needed support. Jamal pretended to be in love with Parul and convinced her to rent a house in Nama Bazar area of Savar on September 7 posing as a couple," Banaj said. "Once they moved in, on the first night, Jamal strangled

her to death with a scarf. Later, he left a copy of Billal Sardar's NID card next to the body," said the PBI official.

"After recovering the NID copy, we investigated and confirmed that Billal was not involved in the murder. Then we contacted him to know whether he has any enemies. He named a few people, including rival member candidate Halim," the PBI Chief added.

"Our investigation found frequent contact between Halim and Jamal. After arresting Jamal, we took him to Savar and the caretaker of the house he and Parul rented identified him," he added.

Banaj said among the arrestees, Jamal and Moshiur gave confessional statement before a Dhaka court.

However, talking to The Daily Star, Gazi Akbar Hossain, chairman of Chila union, said Halim was framed in the incident following a feud with his rival Billal Sarder.

"Halim was a two-time UP member at one of the remotest unions of the country. He went to Dhaka only once and does not know his way around there. How can he hire a man in Dhaka and plan the killing?" asked the union chairman.

Feed prices worry Mymensingh fish farmers

Just when Mymensingh's 1.12 lakh fish farmers were looking forward to turn the corner and start recovering from losses they incurred during Covid-19 restrictions, the rising prices of fish feed are eating away their profits.

aquaculture The industry in Mymensingh -- one of the largest fish producing hubs in the country -- suffered Tk 400 crore in losses, mostly due to unavailability of transport during lockdowns.

Abu Raihan, a commercial fish farmer in Dhanikhola village of Trishal upazila, said fish feed prices rose significantly in recent months.

Price of one kilogram of feed has gone up by Tk 4 to 5 over the last three months, raising the cost of production close to the sale price, sometimes even higher. "For example, per kg Pangas is being sold for Tk 82 to 84 while the production cost is around Tk 90," said Raihan.

Ataur Rahman Khan, another fish farmer from Boilor village in the same upazila, said he suffered losses during the pandemic months and he might lose another Tk 4 lakh this year due to the rising prices of fish feed.

Contacted, Dilip Kumar Saha, district fisheries officer in Mymensingh, said dealers of fish feed might be involved in raising its prices, as he found production at different fish feed factories going on in full swing during his recent visit at some of the factories in the district where a few of the factory owners had faced a supply shortage of ingredients.

Against an annual demand of 1.26 lakh tonnes of fish in Mymensingh, around 1,12,000 fish farmers in the district have been producing nearly 4 lakh tonnes of fish each year, he also said.

Tofail Ahmed, senior fisheries officer in Trishal, said around 7,500 fish farmers in the upazila incurred losses due to the pandemic and now the hike in fish feed prices is likely to deal another blow to the industry on which around seven lakh people depend in Mymensingh.

Khaled Masud Sujon, who works as a fisheries executive at Quality Feeds Ltd in Mymensingh, said the prices of fish feed has gone up by Tk 4 to per kg in the last seven months, as prices of ingredients including soyabean, rice bran, oil cake and maize also went up.

The prices of fish feed are not likely to fall any time soon, as the prices of ingredients continue to rise, he added.

US warns Iran as IAEA inspectors blocked from nuclear site

Iran must stop denying the UN nuclear watchdog access to a workshop making centrifuge parts as agreed two weeks ago or face diplomatic retaliation at the agency's Board of Governors within days, the United States said yesterday.

The workshop at the TESA Karaj complex makes components for centrifuges, machines that enrich uranium, and was hit by apparent sabotage in June in which one of four International Atomic Energy Agency cameras there was destroyed. Iran removed them and the destroyed camera's footage is missing.

TESA Karaj was one of several sites to which Iran agreed to grant IAEA inspectors access to service IAEA monitoring equipment and replace memory cards just as they were due to fill up with data such as camera footage. The September 12 accord helped avoid a diplomatic escalation between Iran and the West

"We are deeply troubled by Iran's refusal to provide the IAEA with the needed access to service its monitoring equipment..." a US statement yesterday said.

Iran's envoy to the IAEA, Kazem Gharibabadi, said that before the deal, Iran indicated that monitoring equipment at Karaj was "not included for servicing" because of ongoing investigations and Sunday's report "goes beyond the agreed terms of the JS (Joint Statement)".

CLASHES WITH ANTI-COUP DISSIDENTS IN MYANMAR Military launches air strikes

Myanmar's military launched air strikes at the weekend after clashes with fighters opposed to the junta in the Sagaing region, according to media and a militia member, as phone lines and the internet were also severed in some districts.

The Southeast Asian country has been in crisis since the army seized power on February 1, ending a decade of tentative steps towards democracy and triggering outrage at home and abroad and the setting up of People's Defence Forces (PDFs) to take on the military.

The DVB news portal reported the air strikes occurred as the army staged an offensive in the Pinlebu area of Sagaing in northwest Myanmar, citing residents who heard aircraft and explosions on Saturday night before phone lines and the internet went down.

A member of the Pinlebu PDF, speaking from outside the area, also confirmed by telephone that air strikes had taken place, but said there had been no casualties amongst his group.

"We cannot contact them due

to the internet and phone lines uprising on September 7 and called to be identified, said of his opposition colleagues.

Reuters could not independently verify any of the claims and a spokesman for the military did not answer calls seeking comment.

Covid cuts life expectancy by most since WW2: study

The Covid-19 pandemic reduced life expectancy in 2020 by the largest amount since World War Two, according to a study published yesterday by Oxford University, with the life expectancy of American men dropping by more than two years.

Data from most of the 29 countries - spanning most of Europe, the US and Chile - that were analysed by scientists recorded reductions in life expectancy last year and at a scale that wiped out years of progress.

Life expectancy fell by more than six months compared with 2019 in 22 of the 29 countries analysed in the study.

The university said most life expectancy reductions across different countries could be linked to official Covid-19 deaths. There have been nearly 5 million reported deaths caused by the new coronavirus so far, a Reuters tally shows.

"The fact that our results highlight such a large impact that is directly attributable to Covid-19 shows how devastating a shock it has been for many countries," said Dr Ridhi Kashyap, co-lead author of the paper, published in the International Journal of Epidemiology.

There were greater drops in life expectancy for men than women in most countries, with the largest decline in American men, who saw life expectancy drop by 2.2 years relative to 2019.

Overall, men had more than a year shaved off in 15 countries, compared to women in 11 countries. That wiped out the progress on mortality that had been made in the previous 5.6 years.

In the United States, the rise in mortality was mainly among those of working age and those under 60, while in Europe, deaths among people aged over 60 contributed more significantly to the increase in mortality.

Kashyap appealed to more countries, including low- and middleincome nations, to make mortality data available for further studies.

S Korea's President Moon raises dog meat ban

South Korea's President Moon Jae-in raised banning the eating of dogs in the country yesterday, his office said, a traditional practice that is becoming an international embarrassment. The meat has long been a part of South Korean cuisine with about one million dogs believed to be eaten annually, but consumption has declined as more people embrace dogs as companions rather than livestock. The practice is now something of a taboo among younger generations and pressure from animal rights activists has also been mounting. "Hasn't the time come to prudently consider prohibiting dog meat consumption?" Moon told Prime Minister Kim Boo-kyum during a weekly meeting, according

to the presidential spokeswoman.

Encrypted messaging app Signal hit by brief outage

Encrypted instant messaging app Signal was hit by a brief outage late Sunday that interrupted services on the platform at the same time as localised interruptions on other social media services. Signal blamed hosting issues for the disruption, which internet outage monitor DownDetector said began at 11:05 pm Eastern Standard Time (0305 GMT), citing user reports. The site logged reports of interrupted service in the United States, Europe, Hong Kong and other parts of the world. Service had largely returned to normal by 3:00 am (0700 GMT), according to Signal's developers.



India exam cheats caught with **Bluetooth flip-flops**

Ten people have been arrested in India for planning to cheat in fiercely competitive teaching exams using Bluetooth devices concealed in their flip-flops, police said. Cribbing has long been a problem in India and, for Sunday's government exams in Rajasthan state, police had permission to snap mobile internet access while the tests lasted. But one group planned to get around this with devices hidden in the soles of their flip-flops that could receive ordinary

calls which would be transmitted wirelessly to tiny receivers hidden in their ears. The plan was for accomplices outside to call the hidden contraptions and dictate the correct answers to the exams. But the group of would-be teachers were arrested acting suspiciously outside the examination hall before the exams and the devices in their footwear were discovered.

World's crisis manager steps down

German Chancellor Angela Merkel endured as others came and went over the past 15 years

It's a lesson many politicians -mostly male -- have learned the hard way over the past 15 years: never underestimate Angela Merkel.

The German Chancellor is preparing to step down later this year, having long ago cemented her position as one of the world's most successful political leaders.

In her time in office, she has dealt with five UK prime ministers, four French presidents and seven Italian prime ministers. When President-elect Joe Biden takes office on Wednesday, he'll be the fourth American commander-inchief she's worked with.

Yet despite her track record, Merkel, the leader of the world's fourth-biggest economy, has spent much of her political career having to prove herself.

Her counterparts have tried to Vladimir Putin once brought a Labrador dog into his meeting with



the Chancellor who is famously afraid of dogs. Donald Trump told her she was stupid. Silvio Berlusconi once left her waiting for 15 minutes while he chatted on the phone.

When she became the first woman to take Germany's top job in 2005, many deemed her too inexperienced and uncharismatic to last.

Bild, Germany's most-read newspaper, marked the occasion East Germany has deeply influenced with a front-page photo and a headline reading "Miss Germany!" Even within her own party, she in quantum chemistry, she often overpower or even humiliate her. was referred to as "das Mädchen," German for "the girl."

But while other leaders have

come and gone over the intervening years, Merkel has endured, enjoying an unparalleled popularity. "Das Mädchen" became nicknamed "die Mutti," a mother figure and symbol of stability.

Political scientist Joyce Mushaben, said Merkel was seen as a "temporary" leader when she first rose through the ranks of the Christian Democratic Union (CDU) party.

Mushaben, a Merkel biographer and professor of University of Missouri-St. Louis, said the key to Merkel's success lay in the unique mix of her background and her abilities.

Her experience of growing up as a pastor's daughter in Communist her political decision-making, and as a former scientist with a doctorate approaches problems in the same way as complex calculations, Mushaben said.

'Convenient scapegoat'

PM Imran Khan says Pakistan should not be blamed for Afghan war's outcome

Prime Minister Imran Khan has said that Pakistan must not be blamed for the outcome of the war in Afghanistan and for the losses of the United States, stressing on setting eyes on the future to avoid another conflict instead of continuing with a blame game.

"Today, with Afghanistan at another crossroads, we must look to the future to prevent another violent conflict in that country rather than perpetuating the blame game of the past," he wrote in an op-ed for

The Washington Post today. The premier emphasised that Pakistan "surely" could not be blamed for the fact that "300,000-plus well-trained and equipped Afghan security forces saw no reason to fight the lightly armed Taliban".

The underlying problem, he said, was an Afghan government structure lacking legitimacy in the eyes of the average Afghan.




He also expressed "surprise" over the recent Congressional hearings on Afghanistan, where "no mention was made of Pakistan's sacrifices as a US ally in the war on terror for over two decades".

"Instead, we were blamed for America's loss," he added.

Prime Minister Imran recalled that since 2001, he had repeatedly warned that the Afghan war was "unwinnable" and pointed out that given their history, the Afghans would never accept a protracted foreign military presence.


Even an outsider including Pakistan could not change this reality, he said.

"Tragically, instead of facing this reality, the Afghan and Western governments created a convenient scapegoat by blaming Pakistan, wrongly accusing us of providing safe havens to the Taliban and allowing their free movement across our border," the prime minister said.

১৯৬৫ সালে পাক ভারত যুদ্ধে পূর্ব পাকিস্তানের অসহায় অবস্থা তিনি প্রত্যক্ষ করেছেন। শেখ সাহেব যখন এই অবস্থার অবসানের জন্য ছয় দফা দাবি উত্থাপন করেন, পাকিস্তানি শাসকদের এক নম্বর দুশমনে পরিণত হন এবং আগরতলা যড়যন্ত্র মামলায় এক নম্বর আসামিরপে বিচারাধীন, তখন হাসিনা ঢাকা বিশ্ববিদ্যালয়ে বাংলা বিভাগের অনার্সের ছাত্রী। আগরতলা ষড়যন্ত্র মামলা নিয়ে যখন দেশব্যাপী প্রচণ্ড গণ-আন্দোলন গড়ে ওঠে তখন শেখ হাসিনা ঢাকা বিশ্ববিদ্যালয়ে আগরতলা আন্দোলনের অন্যতম নেত্রী। ইতোমধ্যে তিনি ছাত্রী অবস্থাতেই সংসারী হন, ছাত্রী জীবনও চলতে থাকে কিন্তু ১৯৭১ সালে মুক্তিযুদ্ধের সময় যখন বঙ্গবন্ধু পাকিস্তানে কারাগারে বন্দি তখন শেখ হাসিনা ঢাকায় বন্দিদশাতেই লাভ করলেন তাঁর প্রথম সন্তান 'জয়'কে। মুক্তিযুদ্ধের পর তিনি সংসার ও ছাত্রীজীবন এক সঙ্গে চালাতে লাগলেন। কিন্তু এই সময় ১৯৭৫ সালে তিনি এবং রেহানা এম.এ ওয়াজেদ মিয়ার সঙ্গে জার্মানিতে বেড়াতে গিয়ে তাঁদের জীবনের সবচেয়ে বড়ো ট্র্যাজেডির সম্মুখীন হলেন। দেশে বাবা-মা-ভাইদের এবং দু'জন ভ্রাতৃবধুদের হারালেন পাকিস্তানের দালাল বাংলাদেশি ঘাতকদের হাতে। শুরু হলো হাসিনা ও রেহানার নির্বাসন জীবন। এইভাবে চললো কয়েক বছর।



Why is BIWTA filling up the Turag again?

Officials of the government body must be held accountable

THE latest initiative of Bangladesh Inland Water Transport Authority (BIWTA) to build permanent

structures in Dhaka's Gabtoli, Amin Bazar, and Diabari areas by filling the Turag River is shocking. In 2005, the BIWTA constructed landing stations in the same areas by filling up the riverbanks for a government water taxi service. Despite pouring a huge amount of money into launching the service, the project was an utter failure as the landing stations remained abandoned since the suspension of the service.

The latest plan to construct large concrete jetties on the banks of Turag River indicates that the BIWTA has learned nothing from its previous failure. As this daily reported on Monday, multiple private and government structures have also been set up bordering the landing stations by illegally filling the river. According to experts, the construction of these illegal structures violates a High Court directive, as one of the landing stations has been constructed around 150 feet inside the river's boundary demarcation pillars, and the BIWTA has kept filling up the riverbank near the landing station. Moreover, large jetties are being constructed near the landing station's south portion, around 100 feet inside the river's boundary demarcation pillar nos. 210, 211 and 212. Similar construction works were being done near other demarcation pillars as well.

We fail to understand why the BIWTA would choose to ignore an express directive of the High Court imposing a ban on the construction of any structure obstructing the natural water flow of a river. Environmentalists have pointed out that such action may encourage others to also encroach upon the river. And they have also asked whether all this was being done for the interest of any vested quarter, and to legitimise other riverbank grabbers. We believe this is a legitimate question.

In this connection, the comments made by the chairman of the National River Conservation Commission are pertinent. At a recent webinar, he admitted that rivers were becoming "victims of greed" of influential and vested quarters. This newspaper has also, time and again, reported on the continuing river encroachment by influential individuals and groups, and the lack of government action to hold them accountable. This trend must change, and the culture of impunity that is fuelling such illegal activities must be eradicated. But how can that be done, we wonder, when the government bodies themselves are guilty of such encroachment?

We call upon the authorities concerned to immediately look into the matter and ask the BIWTA high-ups to explain why they have taken up this initiative, despite the obvious environmental concerns and a High Court order, risking the life of the Turag River. Additionally, we call on the government to immediately halt said construction work and to clear the riverbank of all such obstructing structures-government or private.

World News Day In Defence of the Messenger

The practice of ethical journalism has become difficult in the present climate

ODAY, September 28, is observed globally as World News Day. This is not your usual "industry celebration" day, but one to highlight the importance of the institution of news media and the critical

role that journalists play in gathering, presenting and interpreting facts, in unearthing the background of events, in exposing corruption and abuse of power, in holding the state and non-state actors accountable and-through all these processes-in augmenting democracy. It is a day to sensitise the wider society about the challenges that the journalist community faces in performing their duties. At the same time, it is also a day of reiteration of what constitutes ethical journalism, the hallmark of this noble profession. Coincidentally, the day is also marked as the International Day for Universal Access to Information (designated by Unesco).

Journalism as a trade has experienced massive transformation in this age of communication technology, augmented by digitalisation. The centuries-old paper-based news industry now faces a serious challenge from its online counterparts. The local newspaper industry, even in the Global North, faces threats from Facebook, Google, and other sites that "siphon off" the bulk of the revenue. While some in the industry have successfully adapted to the new reality, others have had to pull down the shutters. In addition, social media has emerged as an alternative source of information. Unfortunately, such systemic transformations have not necessarily been accompanied by the growth of responsible and credible journalism practices, promoting, celebrating and facilitating professional excellence. Therefore, the need for gathering, presenting, and interpreting trustworthy news and information has become ever more important. An essential prerequisite to attain such lofty goals is protecting the right of the journalists to perform their tasks freely and without fear.

One may recall that in the long-drawn struggle for democracy during Pakistani days, ethical journalism played a critical role. On the one hand, it challenged and exposed the authoritarian practices of those at the helm of the state; on the other, it conveyed the alternatives (such as that of the theory of two economies) offered by the opposition platforms that helped galvanise the people to rally, and protest, and demand change. Unfortunately, instead of further

facilitating press freedom, successive governments in independent Bangladesh have adopted laws and administrative practices that act as barriers to that aspired principle. Included among the laws are provisions of the Special Powers Act, the Printing Press and Publication Act, the Information and Communication Technology Act, the sedition and defamation clauses of the Code of Criminal Procedure and, no less importantly, the Digital Security Act. Needless to say, these laws, particularly the DSA, have been applied to stem dissent on a number of occasions, and it is the journalist community who

The rampant application of the DSA severely restricts freedom of expression. Stating that 14 of the listed 19 offences under the law are non-bailable, the president of the Editors' Council noted, "Even if the law is not invoked, its sheer existence is enough to destroy journalistic initiatives." This may entail that an accused may have to spend months behind the bars before the trial process even begins. It also takes a toll on his/ her reputation and social standing. The law also extends enormous power to the police to conduct searches on the premises of news establishments or seize computers and other equipment on "mere suspicion."

The defamation provision is another legal instrument to intimidate journalists. While in most countries, defamation

is treated as a civil offence, under Bangladeshi law, it is a criminal offence. The law explicitly stipulates that the plaintiff has to be an aggrieved party, but in practice, defamation cases filed by individuals, who had no locus standi to file them, were admitted by the magistrate.

While the state retains a plethora of legal provisions to clamp down on the media if it so decides, thus far there is no law for the protection of the media from arbitrary intrusion and closure, and from arrest or questioning of journalists and the whistleblowers. This works as a great impediment to freedom of the press, and curtails journalists' ability to effectively

There have been occasions where journalists had to endure physical assault, illegal detention, and harassment from the state functionaries for performing their professional tasks. In mid-March 2020, Ariful Islam's reports on the irregularities of Kurigram district administration resulted in 30 to 40 people, including a senior official of civil administration, raiding his house in the

middle of the night and detaining him. Arif was taken to the DC's office, where he was tortured blindfolded and threatened with an "encounter." He was then sent to iail for a year on charges of "possessing alcohol and marijuana" by an illegal mobile court sanctioned by the deputy commissioner.

The non-state actors also constitute a threat to journalists. On umpteen numbers of occasions, particularly during mass protests such as the road safety or quota movements, along with the protesters, reporters (carrying visible identity documents) were attacked and their equipment and vehicles vandalised by the supporters or members of the affiliated organisations of the ruling establishment, inflicting bodily harm on journalists. There is little evidence that effective actions were taken against the attackers for violating the law.

Likewise, reporters are also subjected to attacks and intimidation for publishing news and posting opinions on social media platforms, triggering displeasure of the powerful quarters. Golam Sarwar's case provides a classic example. This Chattogram-based journalist was involuntarily disappeared last November, and he reappeared after three days. While in illegal custody, Sarwar was

asked to surrender his freedom to pursue his chosen vocation in exchange for "freedom" from harassment and torture. He claims that a politically influential family in Chattogram filed two defamation cases against him. In one instance, Tk 100 crore compensation was sought. So far, he failed to secure any redress from the law enforcement authorities.

The prevailing adverse regulatory framework, coupled with arbitrary administrative practices and highhandedness of the politically and financially powerful connected with the corridors of power, have created an environment of self-censorship. This has led to a situation in which it is not only the veracity of facts that concerns news editors and chief reporters, but also if the facts being dealt with are "DSA proof."

Over time, journalism has also been adversely affected by changes in the pattern of the ownership of media houses due to corporatisation, which are increasingly guided by overtly pecuniary, business, and other interests. Gone are the days when there was little meddling of owners with contents of the news and opinions expressed, and the editors enjoyed full discretion in running affairs of the media. However, over time, there has been gradual erosion in the authority of professional editors as the corporate houses increasingly began to interfere on such matters. Instead of letting the media perform its professed goal of serving the nation by disseminating credible facts and information, news outlets have become a handy tool for corporate houses to pursue their business and political interests, often resorting to publishing or running fake news to malign their business and other rivals. Such "predatory corporate control" has increasingly become stark in the Bangladeshi context, eroding the ethical foundation of media in general.

Such a development not only dampens ethical journalism, but it also does a disservice to the people and weakens democracy. As the nation marches forward in the economic terrain, the need for accountability and transparency of various branches of the government and state institutions has become all the more important. Therefore, the onus lies on the state and other stakeholders to ensure that freedom of expression and ethical journalism can flourish-as real news, truth, objectivity, balance, and fairness do indeed matter.



'gono' rooms closed commendable

The authorities must see this through and ensure compliance with health guidelines before reopening

S the Dhaka University authorities are preparing to reopen its 18 dormitories on a limited scale on Ctober 5, ahead of resuming in-person classes, students who were staying in the 'gono' rooms before the pandemic are naturally worried about whether they will be able to get any regular seats in the dorms. Although students currently pursuing their master's degrees and those who are in honours final year are supposed to return to the dormitories first, students of other academic sessions will be allowed into the dorms gradually. However, how the university authorities will provide seats to these 'gono' room residents as they have decided to end the 'gono' room culture-to maintain the Covid-19 safety guidelines—has become a big question.

Reportedly, the university authorities have decided to vacate seats occupied by former students in the dorms and allot them to the 'gono' room students. To ensure this, they have made a list of the former students who have been staying in the dorms illegally for a long time, and another list of first- and second-year students to whom these seats will be allotted. Although the hall authorities have said that they will ensure the allotment, we don't know how they plan to do it. As far as we know, the university authorities took such initiatives in the past as well, but could not implement them allegedly due to the influence of the ruling party's student wing. And students of 'gono' rooms fear that if the administration cannot prevent the stay of "illegal" former students at the dormitories, they may have to live outside the campus, further spiralling into uncertainty.

Besides, it also remains to be seen how the authorities ensure that only honours final-year and master's students will stay in the dorms at the beginning. In a sign of things (troubles) to come when the university finally reopens, we have already seen the chaos that was created in the university libraries on Sunday, when students entering the libraries after the long closure hardly maintained health guidelines and got into a scuffle with the proctor. The incident raises alarm as to what will happen when the university dorms reopen and the classes resume.

We hope the Dhaka University authorities will remain alert and take all the necessary preparations so that such incidents do not recur. Maintaining health safety guidelines and social distancing should be a priority for the university authorities as they reopen. We hope other universities will learn from DU's experience in phased reopening, and reopen their own doors only after taking proper measures to avoid untoward incidents.

There's still time to save Gazipur

The city corporation needs to be developed in a planned manner



seen a fast population growth over the last two decades. The city's present population is estimated to be more than four million. With an area of 329.53sq-km, it

is bigger than Dhaka North and Dhaka South combined. The GCC was established in January 2013. The city is one of our main centres of employment, industries, business, and entertainment partly as a result of its proximity to the capital city, which contributes about one-third of the country's total GDP and has about 30 percent of the country's total urban population.

Due to a wide range of economic and social activities, and a fast-growing job market, Gazipur city has attracted people from adjacent districts—especially from the rural areas. Therefore, in-migration is a major factor behind the growth of the city population. With the population growth, the demand for public utilities and services has grown manifold, but the city's infrastructure and services have failed to keep pace with that demand, resulting in a great deal of suffering for the residents.

About one-third of the ready-made exportoriented garment factories of the country are located in Gazipur. There are many other industries in the city as well: aluminium, textiles, leather, pharmaceuticals, cosmetics, ceramics, packaging, and others. The garment factories are employing hundreds of thousands of people-mainly women. Two export processing zones and the Tongi industrial area are located in the GCC area. A number of important public offices and facilities-including Bangladesh Agricultural Research Institute (BARI), Bangladesh Rice Research Institute (BRRI), Dhaka University of Engineering and Technology, Bangabandhu Sheikh Mujibur Rahman Agricultural

THE Gazipur City University, National University, Islamic University of Technology, Bangabandhu Safari Park, Bangladesh Machine Tools Factory, and Bangladesh Ordnance Factoryare also situated there.

There is a large number of brick kilns on both sides of Turag and Bangshi rivers, and in the western and southern parts of Gazipur city, which are polluting the environment severely. Illegal encroachment of rivers, canals, and wetlands is also rampant there.

Millions of garment workers, rickshaw pullers and other low-income workers and their families live on the outskirts of the city, which are very crowded and have limited access to services and facilities. Besides, thousands of people who commute to the city on a daily basis face a tremendous traffic problem. Thousands of air- and waterpolluting factories, workshops, vehicle repair shops and brick fields are located in and around these places, posing a risk to public health.

The GCC authorities, in recent years, have been putting in increased efforts to improve the condition of the city roads and drains. But the challenges of maintaining domestic water supply, street lights, sewerage, and garbage

collection and disposal are enormous. There is also a lack of hospitals, schools, community centres, parks and shopping facilities. The city corporation's total budget was Tk 5,007 crore in 2020-2021 fiscal year, which has gone up four times to Tk 20,986 crore in 2021-2022.

To provide quality public services, first and foremost, a proper plan for land use is required, based on which the development of transportation network, civic services, appropriate environmental protection, and more healthy living options-such as greener surroundings, educational institutions, healthcare facilities, economic zone, parks and playgrounds, etc-should be undertaken. Since there is no master plan, the city's development along with its services and

facilities is taking place in a haphazard manner. Most of the internal roads are very narrow and not maintained properly, and drains are mostly open. Many residents of the city travel to Dhaka to obtain basic services, such as medical treatment, shopping, schooling of their children, etc. In a city where it is difficult to move around due to traffic congestion, people waste inordinate amounts of time on the road to meet their day-to-day service requirements.

Some parts of the city have densely developed residential and commercial areas. Many land owners found it quite lucrative to build multi-storey buildings with the help of real estate developers. The vertical growth of the city, on the one hand, made it possible to house the upper middle-class

families with affordable accommodation in developed areas; on the other hand, it exerted severe pressure on the existing infrastructure and services. The number of private vehicles, trucks and buses on Gazipur's roads increased manifold over the years, adding to the traffic gridlocks in the city.

Four national highways and six regional highways pass through Gazipur city, providing a crucial transportation network to connect to other parts of the country. The existence of a good road system has been the main attraction for investors in Gazipur. However, the transportation network needs further improvement to cater to the growing needs of people, and to transport products throughout the country. The work on the planned metro rail and elevated expressway projects should be expedited.

The GCC has recently taken an initiative to prepare an urban development plan that will take into account land use, drainage, and environmental management, traffic and transportation management, and industrial and recreational facilities. This plan should be comprehensive and drawn up to build a healthy city. A team of town planners, transport engineers, urban economists, geologists, hydrologists, water and sanitation engineers, environmentalists, agriculturists, waste management experts, civil engineers, architects, and sociologists should contribute to developing this plan.

The city still has a large geographical area under agriculture and forest coverage, which is highly likely to be transformed for other uses in line with the growth of population and establishment of new industries and businesses in the future. But the forest lands and water bodies should be preserved at all costs to keep Gazipur as an environmentally balanced city. If properly planned, there is a good prospect of developing Gazipur city in an aesthetically beautiful manner.

Ghosts in the classroom

As schools reopen, are we paying enough attention to the culture of bullying?



times, it was the worst of times," wrote Charles Dickens at the beginning of "A Tale of Two Cities." No other quote in the literary canon captures my experience in the Bangladeshi education

as Dickens'. School changed my life for the better, but it also nearly took it away.


I titled this piece "Ghosts in the classroom" because, in fourth grade, that's what I thought

T was the best of of my father, my religious identity, and the poverty in which we lived. Then, in the fifth grade, my class teacher kept me back during lunch to ask if anything was bothering me, and immediately I broke down in tears as all the pain inside my heart welled up and escaped my lips. Her presence made the classroom feel safe.

On the other hand, my classmates threw my stationary, which I could barely afford, out the window. Additionally, a barrage of comments

a single woman in our society possibly do to afford to send her daughter to a private school? My classmates found a particularly unflattering photo of me taken after a dance performance. In an anonymous Facebook group, that image was posted over the name of a male student in my class.

Looking back, what surprises me the most is that no mature adult in the school intervened. No one ever confronted my abusers. I suppose a scholarship student who

In 2017, I joined Minerva University in San Francisco, where I pursued a dual undergraduate degree in computer science and politics on yet another full scholarship. As a college student, I had the opportunity to travel worldwide, and I worked in different sectors, including education, public policy, and computational social science, at some of the world's preeminent institutions. In October, I will begin my graduate degree in development studies at the University of Cambridge on a fully funded scholarship. It's not been easy, but these accomplishments would not have been possible were I stopped in my tracks in the seventh grade. every time my stationary went missing and the contents of my pencil box were scattered outside my classroom window. Spooky! I couldn't even consider the possibility that the "ghosts" were my classmates who began to bully me and damage my possessions to punish me for my strong academic performance in our class.

Apart from my academic strengths, multiple axes of my identity set me apart. I am from Dhaka. In Dhaka, I grew up in a single-parent household as a child of a Hindu-Muslim couple. After my father left, my mother and I struggled to make ends meet, with no assurance about how we would afford next month's rent and school fees. Yet, my mother insisted that I have the best possible education available in town. Due to her efforts. I was eventually admitted to one of the premier English medium educational institutions in the country. Let's call it "School Y."

I received an excellent primary education at School Y. I studied in an interdisciplinary curriculum, which placed self-inquiry and social action at the centre of my learning. In class, I explored ancient civilisations, the solar system, different religious customs around the world, human migration, the environment-the list goes on. Every day was an adventure. However, I felt weighed down by a pile of secrets, such as the whereabouts

circulated in the classroom about my weight. During report card days, my mother, who felt defeated at every other aspect of her life, proudly entered the school grounds to learn once again that I had topped the class. After classes resumed, the bullying got worse.

When I cut my hair short (described in Dhaka as a "boy cut"), the comments became more hurtful. My classmates called me a "hijra." During the winter, I wore a sweater made out of jute (once a dominant industry in our country), and they called me "bosta" (sack). Rumours went around about the exact nature of my mother's profession; what could paid half price wasn't worth the trouble of angering students and parents who paid the full price. After all, School Y often suspended me for weeks on end when my mother couldn't pay tuition fees.

My mental health deteriorated. I became a Unicef statistic: one in three children globally experience bullying (including leaving children out of activities, making inappropriate sexual remarks, and cyberbullying). Subsequently, I developed an obsessive desire to lose as much weight as quickly as possible. Over three months, I went from 67 kilograms to 45. But I wasn't ready to stop dieting or exercising. I

anorexia nervosa. As a result of my condition, I was hospitalised and force-fed, because the psychiatrists didn't know how to treat me.

When I returned to school, the taunting continued. Then, the head of our school threatened to expel me because I reflected poorly on the school's reputation! School Y was no longer a safe haven.

We know about Samin, a 10th grader who was bullied about his weight, who wanted to die from the humiliation, and who developed anorexia, like myself, but unlike me, who passed away.

Who is responsible for Samin's death, for my painful childhood experiences? The bullies? The families that fostered a sense of unhealthy competition and judgemental attitude about weight? The teachers and school authorities who failed (or refused) to intervene? The school board for not enacting responsible policies to deal with bullving incidents, and prioritising profits before students' lives? The country which is yet to develop the legal framework to create and implement effective anti-bullying laws in schools? Or a world where violence and domination reign and the weak suffer?

Notwithstanding my difficult childhood experiences, things worked out fine. After changing schools, I received numerous awards in my high school years, including a US Department of State-funded exchange

It is not certain how long the Covid-19 virus survives on surfaces. Its survival time depends on a number of factors, including the type of surface, temperature, relative humidity and specific strain of the virus.

Under three LoC funds, the BR took 17 projects, out of which nine have already been completed. Six other

projects are now being implemented. The six projects are: construction of the Khulna-Mongla Port rail line; construction of the third and fourth dual gauge lines in the Dhaka-Tongi section and dual gauge double line in Dhaka-Joydebpur section; rehabilitation of the Kulaura-Shahbazpur section; conversion of the meter gauge into a dual gauge line from Parbatipur to the Kaunia section; construction of double line in the Khulna-Darshana section; and construction of dual gauge line from Bogura to Sirajganj.

The physical work of three projects have started and have already witnessed several revisions. But the physical work of three others are yet to start, despite being approved around three years ago. The Khulna-Mongla Port rail line project taken to construct 64.75-kilometre-long rail line in December 2010 was supposed to be completed within three years of its

approval. But the project's physical work did not kick off even six years after approval. In the meantime, the cost of the project rose to Tk 3,801 crore -- 120 percent higher than the original estimate.

The delays did not end here.

The project authorities sought another Tk 633.4 crore and a one-anda-half-year extension of the project's last deadline in June this year. As of August, the project witnessed 86. 72 percent progress.

The deadline was extended up to December 2022 while the cost revision proposal is now pending with the Planning Commission, sources said.

The Ecnec had approved the project for building the third and fourth dual gauge railway tracks on the Dhaka-Tongi route and doubling the dual gauge track on the Tongi-Joydevpur route in November 2012. The cost of the project was Tk 849 crore and the deadline was June 2015.

After several revisions, the cost rose to Tk 1,106 crore and deadline was set to June 2023. But the project witnessed only 51.40 percent progress till August this year.

The project for the rehabilitation of the Kulaura-Shahbazpur section, taken up in 2011, went through similar processes. It witnessed 24.40 percent progress till August, even though the revised deadline is December next year. The project for Parbatipur-Kaunia

section was taken up in February 2018 while the Khulna-Darshana project in May 2018 and the Bogura-Sirajganj project in October 2018. The physical works of none of

these have started yet, although the Bogura-Sirajganj project is well ahead. The project authority hoped to start physical works by mid-2023.

While fossils of armoured, herbivorous dinosaurs, such as the famous Stegosaurus, have been widely uncovered from the northern continents, the researchers say this is the first time the remains of one have been found from Africa.

Over the years, several armoured dinosaurs have been unearthed, some with rows of bony plates embedded into their skin, and those which grew spikes from these bony plates, and others with a large bony club at the end of their tails.

However, the newly discovered dinosaur stands out.

Palaeontologists say the protective spikes in this ankylosaur is particularly peculiar since the feature, which would have lined the sides of this animal, are actually fused to the rib bones themselves.



Messi, Guardiola meet again

On a night when Shakhtar Donetsk host Inter, Liverpool travel to Porto, Real Madrid welcome FC Sheriff and AC Milan play Atletico Madrid,

the focus will still be on the game between Paris Saint-Germain and Manchester City at the Parc des Princes as PSG's Lionel Messi reunites with City coach Pep Guardiola. There was a time when a reunion

between Messi and Guardiola looked distinctly possible, but on Tuesday they will be on opposite sides.

However, PSG are yet to reveal whether the six-time Ballon d'Or winner will form part of their plans for a heavyweight continental clash, but Messi has been pictured in full training.

As it turns out, things could have been very different if certain series of events took place a bit differently.

City announced the £100 million (\$139m) signing of Grealish from Aston Villa on August 5, the same day Barcelona revealed Messi would not be staying at the Camp Nou.

A year ago, when Messi tried to force his departure from Catalonia, City appeared the most likely destination.

In the end Barcelona prevented the



six-time Ballon d'Or winner from leaving then and 12 months later, Messi was prepared to stay put until it became clear the financial mess at the Camp Nou meant he could not

If City had anticipated Messi becoming available, they might have moved for him. But instead they focused their sights on Grealish and were trying to sign Harry Kane, a move that ultimately didn't happen.

Meanwhile, certain members of the City squad may be hoping that Messi loses his race to be fit enough for Champions League duty on Tuesday, but Ruben Dias is not one of them as the Portuguese defender is desperate to test himself against the best.

Messi has been nursing a knee problem of late, but Dias is hoping to see the Argentine shake off that ailment and line up alongside fellow superstar forwards Neymar and Kylian Mbappe when the Premier League title holders pay a visit to the French capital.

"Whether it's Messi, Mbappe, Neymar or [Mauro] Icardi, PSG have amazing strength in depth and no matter who it is we face, it'll be a tough test. Everyone is looking forward to this game for exactly that reason," Dias said ahead of the game.

"Messi is a phenomenal player and as a professional, you want to play against all those sorts of names," Dias added.

Messi has played just three games for his new club and is vet to score. He has sat out PSG's last two matches with a knee problem but the feeling is that Mauricio Pochettino has been saving him for City.

After being held 1-1 by Club Brugge in their opening game, PSG need a positive result against City to stop their rivals taking control of their Champions League group.

Bhuiyan Captain Jamal believes Bangladesh can pull off something special in the upcoming SAFF Championship as the national football team depart for Maldives this

afternoon to take part in the regional football extravaganza, starting from October 1 at the National Football Stadium in Male.

"I think we are strong and confident as a group from playing together for so long," said Jamal Bhuiyan at a press conference arranged to address the preparation of the men in Red and Green ahead of the 13th edition of the regional tournament yesterday.

"We've been working hard in the last few practice sessions to perform our best in the tournament. Of course, our goal is to reach the final and become champions but we've to take one match at a time," said Jamal, who also led his side in the last edition of the SAFF tournament where Bangladesh were ousted from the group stage due to goal difference despite having equal six points with Pakistan and Nepal.

Ahead of the SAFF Championship, Bangladesh Football Federation (BFF) released the long-serving British coach Jamie Day and appointed Bashundhara Kings' Spanish coach Oscar Bruzon as the interim coach, who also stated the objective of playing the final by displaying an entertaining and attacking brand of football, in contrast to his predecessor.

"We're working to show that we are playing and understanding the new set of principles of attack and defense of the team while working on the set-pieces. The most important thing is that the players and coaches have good understanding to make things happen.

but I can assure you that the boys have already started implementing new ideas. We want Bangladesh football to progress to greater heights and for that, we need to prove that we can beat all teams of the subcontinent region," said the 44-year-old coach.

Jamal and his teammates only had four days training under Bruzon and are due for two more sessions ahead of the first match against Sri Lanka.

"On day one, the coach had let us know what style he wants to play. What formation he wants to implement is familiar with most players at the club level, so I think we'll adapt easily before the first game against Sri Lanka," Jamal expressed his optimism.

Bruzon echoed Jamal's optimism and seemed pleased with the progress of his charges so far. "The confidence of everybody is very, very high. The group, focused on the process, is getting clear ideas with each daily practice and convinced that we can click this time," said the Spaniard, further adding that they are now only focused on the crucial opening match.

"Right now, all analysis is revolving around Sri Lanka. If we can beat them, then we're going to play a half-final against India in the next match. Otherwise, we're going to face difficulty in getting points because the next rivals are tougher.

BCB awaits ICC's instructions on WC protocols

All participating 72.2 boards, including the Bangladesh Cricket (BCB), Board are expected to receive a clear guideline regarding the health security measures for the upcoming World Cup from ICC.

"In the next few days, all the boards are expected to get specific instructions regarding health safety protocols, traveling guidelines and quarantine protocols for the upcoming T20 World Cup to be held in Oman and the UAE," informed BCB's chief physician Debashish Chowdhury told the media yesterday.

Bangladesh are all set to travel to Oman on October 3 to take part in a

ICC T20 World Cup. The cricketers will undergo coronavirus tests on October and will remain in a strict home quarantine before leaving for Muscat.

The Tigers will also spend a day in room quarantine in Muscat before starting their training.

"Members of the world cup squad will undergo coronavirus tests on October 2 and will leave for Oman the next day. We will begin our training after completing one day quarantine in the hotel," added Debashish.

Meanwhile, according to the ICC's regulations, all the teams will have to stay for a mandatory six-day quarantine before the Super 12 stage in the UAE.

Bangladesh will travel to Dubai on October 21 after completing the qualifier stage. And if the Tigers require

preparation camp for the upcoming to follow ICC's mandatory six-day quarantine rule upon arrival in the UAE, then Bangladesh could even miss their first Super 12 match scheduled on October 25.

Even if ICC sticks to its quarantine protocol, the BCB, however, has planned for an alternative way that will see the Tigers stay in bio-bubble in Oman and travel to Dubai via private transportation.

Bangladesh will start their training camp on October 5 in Oman. The Tigers will then travel to Dubai to take part in two official practice games on October 12 and 14 respectively.

Mahmudullah Riyad and his troop will then return to Oman to participate in the qualifier stage and will face Scotland in the first qualifier game on October 17.

'Magical moment' as Hamilton hits 100 wins

Lewis Hamilton described becoming the first driver to win 100 Formula One races as "magical" on Sunday while his Mercedes team boss Toto Wolff hailed the landmark as "mind-blowing". The 36-year-old Briton reached his century by winning the rain-lashed Russian Grand Prix at Sochi. Seven-time world champion Hamilton also moved back to the top of the drivers standings by two points from Max Verstappen, who finished second in a Red Bull. "It's a magical moment," said Hamilton. Hamilton won his first F1 race in Canada in 2007 as a 22-year-old and behind the wheel of a McLaren. He was also the sport's first black race winner. His 99th victory came on home ground at Silverstone in July this year but it was achieved in controversial circumstances.

Moeen announces retirement from Tests

England all-rounder Moeen Ali has announced his retirement from test cricket, the country's cricket board said on Monday. Moeen, who made his test debut in 2014, scored 2,914 runs in 64 Tests at an average of 28.29 and picked up 195 wickets with his off-spin. "I've enjoyed test cricket but that intensity can be too much sometimes and I feel like I've done enough of it and I'm happy and content with how I've done," Moeen said. Having played little test cricket since the 2019 Ashes, Moeen was recalled for the home summer series against India and played in three matches.

Railways Minister Nurul Islam Sujan yesterday sought India's cooperation for the quick release of funds for the projects which are being implemented under the Indian Line of Credit (LoC), in order to maintain deadlines.

The minister made the request as six railway projects under the Indian LoC fund are running behind the schedule, while several of them already saw a huge cost escalation.

Sujan was speaking at a contract-signing ceremony in relation to an Indian-funded project at Rail Bhaban where Indian High Commissioner to Bangladesh Vikram K Doraiswami was present as a guest of honour.

The Bangladesh Railway (BR) yesterday signed a contract with an Indian joint venture firm for consultancy services for a project to construct a direct rail line from Sirajganj to Bogura.

Under the Tk 97.56 crore contract, RITES Ltd and Aarvee Associates Architects Engineers and Consultants Pvt Ltd of India will work for updating the project's feasibility study, detailed design, and preparing tender documents.

They will also provide construction subversion services when the physical work of the project will start, expectedly by mid-2023.

Project Director Abu Zafor Miah and Sanjay Agarwal, executive director (regional projects) of RITES signed the contract on behalf of their respective organisations.



Dinosaur fossil with 'bizarre' spikes found in Africa

Seeks three-way alliance to replace Merkel-led coalition

German Social Democrat Olaf Scholz vowed yesterday to strengthen the European Union and keep up the transatlantic partnership in a three-way coalition government he hopes to form by Christmas to take over from Angela Merkel's conservatives.

Scholz's Social Democrats (SPD) came first in Sunday's national election, just ahead of the conservatives, and aim to lead a government for the first time since 2005 in a coalition with the Greens and the liberal Free Democrats (FDP).

Scholz, 63, projected a sense of calm assurance when asked whether the close election result and the prospect of prolonged coalition negotiations sent a message of instability in Germany to its European partners.

'Germany always has coalition governments and it was always stable," he said in fluent English, standing beside a statue of Willy Brandt, a Cold War-era SPD chancellor awarded the Nobel Peace Prize for fostering dialogue between East and West.

The SPD, Germany's oldest party, won 25.7% of the vote, up five percentage points from the 2017 federal election, ahead of Merkel's CDU/CSU conservative bloc on 24.1%, provisional results showed. The Greens came in with 14.8% and the FDP won 11.5%.

The SPD's recovery marks a tentative revival for centreleft parties in parts of Europe, following the election of Democrat Joe Biden as US president in 2020. Norway's centre-left opposition party also won an election earlier SEE PAGE 10 COL 1
