came up with the directives after holding a hearing on three separate writ petitions that sought its directives for protecting the interest of consumers of e-commerce platforms including Evaly and Eorange and oversight of their activities.

The bench fixed November 8 for further hearing and passing orders on the petitions.

Lawyers Mohammad Shishir Manir, Mohammad Humayun Kabir Pallob and Md Anwarul Islam Badhon placed arguments for the writ petitioners while Deputy Attorney General Bepul Bagmar opposed the petitions at the hearing.

Manir recently filed a writ petition on behalf of 33 aggrieved consumers of Eorange to the HC challenging the failure and inaction of the authorities concerned to take necessary actions or preventive measures to protect their rights.

In the petition, they requested the HC to issue a rule asking the authorities to explain why their failure and inaction should not be declared illegal and why they should not be directed to take necessary steps to compensate the victims of the e-commerce platforms including the petitioners.

They also urged the HC to order the government to constitute a committee of experts to prepare specific proposals of customers.

for the protection of rights and interests of consumers of e-commerce platforms and submit a report before this court.

On September 20, Supreme Court lawyer Md Anwarul Islam Badhon submitted another writ petition as public interest litigation to the HC seeking its directive on the government to form an e-commerce regulatory authority to control the online commerce in the country.

In the petition, he said the National Digital Commerce Policy, 2018 has a mandate to establish an e-commerce regulatory authority, but the government is yet to comply with the mandate.

On September 22, SC lawvers Mohammad Humayun Kabir Pallob and Mohammad Kawser filed a writ petition with the HC to form a judicial committee to inquire into the alleged embezzlement of money, money laundering and fraudulence by problematic e-commerce platforms including Evaly, Alesha Mart, E-orange, Dhamaka, Qcom, Aladiner Prodip and Dalal Plus.

They submitted the petition as public interest litigation to the HC requesting it to form the committee to ascertain the persons or the government authorities whose negligence or failure caused serious financial loss and damage to millions

family members to pay bribes for his release, but they did not agree.

"At last, I found my husband's body at the Cox's Bazar Sadar Hospital morgue on July 17, 2019. The [then] OC killed my husband by staging a drama in the name of "crossfire" as we refused to pay bribes," said Chenwara, a witness in the Sinha murder case.

Judge Mohammad Ismail of Cox's Bazar District and Sessions Judge's Court recorded her testimony, said court sources.

Later, another witnesses Mohammad Ham Jalal, a former member of Teknaf union parishad, testified in the court.

He said a police team, led by Pradeep, detained his younger brother Yusuf Jalal Bahadur and him in December 2018. Pradeep demanded Tk 6 lakh for releasing them.

As they refused to comply, Ham Jalal was implicated in a Yaba case and Yusuf was killed in the name of a "gunfight", the witness told the court.

The court recorded the statement of witnesses Ali Azgar, a resident of Teknaf's Nhila union. His testimony could not be completed as the court proceedings ended around 5:30pm.

The judge began recording witnesses' statements in the fourth phase yesterday and it will continue todav

All 15 accused in the case were present in the court yesterday. Among them are 12 police personnel, including Pradeep.

Sinha, 36, was killed in police firing at a checkpoint of Armed Police Battalion (APBn) in Teknaf's Shamlapur area on July 31 last year.

He had been in Cox's Bazar to make travel documentaries for a YouTube channel named "Just Go". The firing took place when he was returning to Cox's Bazar from Teknaf.

Investigators submitted the charge sheet to the court on December 13 last year. According to the charge sheet, 83 people are witnesses to the incident. On June 27 this year, the court framed charges against the accused. The court began the trial on August 23 through recording the statement of Sinha's elder sister Sharmin Shahriar Ferdous, also the complainant of the case

The murder case was filed against the BNP chief and others after seven people died and 25-26 others were injured when a bus was torched in Cumilla's Chouddagram during an anti-government agitation by the

BNP-led 20-party alliance on February 3, 2015. Lawyers Kayser Kamal and AHM Kamruzzaman Mamun appeared for Khaleda

Lawyer Kamruzzaman told The Daily Star that Khaleda stands accused in 36 criminal cases and she is now on bail in 34 cases.

The BNP chief has been convicted and sentenced to imprisonment for 17 years, in total, in Zia Orphanage Trust and Zia Charitable Trust corruption cases by the trial court and HC.

She was released from jail on March 25 last year following an executive order of the government suspending her jail sentences.

On December 21, 2015, Khaleda at a discussion at the Institution of Engineers, Bangladesh, raised questions about the actual number of Liberation War martyrs, saying, "There are controversies over how many were martyred in the Liberation War. There are also many books and documents on the controversies.'

Reacting to Khaleda's remarks, a defamation case was filed in Narail and three others were lodged in Dhaka.

# Venezuelan migrants in Chile

UN condemns 'xenophobia' against

The United Nations has condemned the violence and "xenophobia" targeting mainly Venezuelan undocumented migrants in Chile over the weekend, carried out by locals fed up with their presence in the country.

About 3,000 protesters took to the streets of the northern port city of Iquique on Saturday, some burning the belongings of rough-sleeping migrants who had been occupying a public square for months.

In a tweet, the UN mission in Chile on Monday urged the "authorities and the population to act within the framework of respect for human rights and international humanitarian rights.

The world body expressed its willingness to provide technical assistance and to "collaborate in the efforts of national and local

The leftist leader indicated that he had activated the "Return to the Homeland" program -- launched in August 2018 to facilitate the voluntary return of migrants -- for those wishing to go home.

The demonstration took place a day after police evacuated a migrant camp that had existed for a year on the town square. Most of the migrants, poor and undocumented, are surviving on odd jobs and sleeping in tents.

### Philippines approves Covid jabs for kids as young as 12

The Philippines has approved Covid-19 jabs for children as young as 12, an aide to President Rodrigo Duterte said yesterday, as the country battles surging infections fuelled by the hyper-contagious Delta variant.

Duterte's government has been skewered over the glacial rollout of vaccines, with just over a quarter of the adult population fully vaccinated nearly seven months after the first doses were delivered.

# Swiss court reopens probe into Iran opposition figure's killing

#### AFP, Geneva

A Swiss investigation into the 1990 killing of Iranian opposition figure Kazem Rajavi must reopen, after a court ordered genocide and crimes against humanity charges added to the probe.

Prosecutors in the Vaud canton had wanted to close the case on the April

24, 1990 killing of Radjavi outside Geneva, as it had passed the 30-year statute of limitations.

But "the killing in question may have been committed in relation to intended genocide or perpetration of crimes against humanity," the Federal Criminal Court said in a judgement issued on September 23 and seen by AFP late Monday.
