TEACHER APPOINTMENT, TRANSFER, MPO

Riddled with graft

Finds TIB study on secondary education sector

The secondary education sector is mired by various forms of corruption and irregularities including illegal financial transactions for the appointment of head teachers and officials in other roles.

A study even found instances where aspiring head teachers or assistant head teachers had to pay between Tk 3.5 lakh and Tk 15 lakh to get the appointments in schools.

transactions have also taken place for

the transfer of teachers, their inclusion to the Monthly Pay Order (MPO) benefits, during schools' academic approval, school inspections, etc., Transparency International Bangladesh (TlB) said in thestudy on secondary education made public yesterday.

The study tilted "Secondary education programme: Governance challenges and way out" was unveiled during a webinar.

The study also found that while there is an online process for non-government teachers to apply for MPO benefits, they still "had to pay money" at four stages.

Under the MPO scheme, the government pays teachers of non-government schools

100 percent of their basic salaries. teachers The also get small monthly payments as allowance through MPO. Many government school teachers and upazila

education officers have been working at the same place for over 10 years using their influence and money. Many officials of Directorate of Inspection and Audit (DIA) are also working at the same station for long as they have scope to "earn money" in those stations.

However, there is a provision that a person cannot stay at the same station for more than three years.

The study also shows that supervision of secondary schools is facing hurdles in the absence of sufficient manpower at field level

The study, quoting the Directorate of Inspection and Audit, said 1,577 teachers were recruited as assistant teachers using fake teacher registration certificates, certificates showing computer expertise and other academic certificates between 2013 and February 2020.

How many must die before they wake up?

When open sewers in the port city have become a death trap claiming at least four lives in the span of just three months, the authorities concerned stay in a deep slumber instead of taking measures to prevent such deaths.

The latest victim of their sheer negligence is Sehrin Mahbub Sadia, a first-year computer science student of International Islamic University Chittagong. The 19-year-old died after falling into an open drain in Agrabad Badamtali area around 10:00pm on Monday. She slipped into the drain while walking towards her car along with her grandfather and an uncle. Firefighters recovered her body five hours later after removing a few tonnes of waste.

The street along which the drain is has lately been narrowed down for the construction of an elevated expressway by Chattogram Development Authority

Also, the area was dark as street lights have been out of order for months. Making sure a street is adequately lit is

among the key responsibilities of any

Sadia's death has touched off outrage in Chattogram and beyond, but apparently failed to hammer any concern and sensitivity into CDA and Chattogram City Corporation (CCC).

DHAMAKA SHOPPING

Embezzlement planned from onset

Dhamaka Shopping came to the market with a singular plan: take hold of as much cash as possible from unsuspecting customers by offering them dizzying discounts for deferred delivery and run for safety as soon as a certain amount had accrued.

Which is why, it did not bother getting a trade licence or a business account with a bank. It used its sister concern Invariant Telecom's account to receive Tk 803.5 crore from customers.

The exit was always scheduled for April and it even gave a clue: the validity of its 'Signature Card', which provided 20-30 percent discounts, was until April.

And the activities of the e-commerce platform, founded just five months earlier fashioned on the infamous Evaly, also

became erratic from then onwards. At that point, only 20 percent of the products were delivered to the customers, Khandaker Al Moin, director of Rapid Action Battalion's legal and media wing, told a press briefing at its media centre in Karwan Bazar yesterday after the arrest of three top officials of the disgraced e-commerce

The platform -- which sold mobile phones, TVs, refrigerators, motorcycles, household goods and furniture -- began to issue refund cheques to customers while moving the money from the bank account. Not just that, it has stopped paying rent for its office in the capital's

Mohakhali and delivery hub at the Battala intersection in Tejgaon. Its employees too are not getting paid since June. "All the activities of the company have been suspended since July after its money was moved elsewhere in April this year. A huge amount of

money has been siphoned off," Moin said. Now, only Tk 1 lakh is left in the accounts whereas it owes about Tk 400 crore to customers and sellers.

Rohingya leader Mohibullah shot dead

Unidentified criminals Rohingya rights activist and leader Mohibullah dead at his office in Kutupalong under Cox's Bazar's Ukhia upazila last



Rohingyas in camps of Kutupalong are tensed with police and local administration issuing an alert across the district to avert further violence. Residents of the camps questioned how

the criminals entered, shot Mohibullah and then fled despite the presence of law enforcement personnel inside the camp.

Police said Mohibullah came to his Forcibly Displaced Myanmar Nationals (FDMN) camp-1 east office after offering Esha prayers around 8:30pm. Three armed men then entered and fired five bullets.

Additional Deputy Inspector General (DIG) (crime) of Chattogram Range Police Jakir Hossain Khan told The Daily Star, "Three bullets hit his [Mohibullah's] chest, leaving him critically injured. The criminals fled the scene immediately afterwards.

"He was taken to Kutupalong MSF Hospital where doctors declared him dead," said the DIG.
