Mamata faces test in by-polls today

The stage is set for today's assembly by-polls in south Kolkata's high-profile Bhabanipur constituency where West Bengal Chief Minister Mamata Banerjee is seeking the people's mandate to enter the state legislature in order to retain her post.

Mamata, who took charge as Chief Minister for the third time after the Trinamool Congress's mega victory in the state election, needs to win the by-polls as an MLA to retain the top post.

According to the Constitution, a person has to get elected to the legislature within six months of taking oath as a minister.

Mamata, the Trinamool Congress (TMC) supremo, will be pitted against BJP's Priyanka Tibrewal and Left Front's Srijib Biswas. The result will be declared on October 3.

By-polls to Bhabanipur seat, earlier represented by Mamata in 2011 and 2016, was necessitated following the resignation of TMC MLA Sovandeb Chattopadhyay to help party supremo's election to the assembly.

On directions of the Election Commission, Kolkata police imposed restrictions under Section 144 of CrPC in the 200-metre radius of polling stations in Bhabanipur Assembly constituency from Tuesday evening.

The restrictions will be imposed till the conclusion of voting for the bypolls on September 30.

This came after a delegation of the Bharatiya Janata Party (BJP) comprising Union ministers Bhupender Yadav, Mukhtar Abbas Naqvi, Anurag Thakur and BJP leader Om Pathak met the Election Commission of India (ECI) over violence and issues related to West Bengal byelections on Tuesday.

Stop violating airspace

Taliban warn US after drones enter Afghanistan territory

The Taliban yesterday warned of consequences if the United States did not stop flying drones over Afghan airspace.

"The US has violated all international rights and laws as well as its commitments made to the Taliban in Doha, Qatar, with the operation of these drones in Afghanistan," the Taliban said in a statement on Twitter.

"We call on all countries, especially United States, to treat Afghanistan in light of international rights, laws and commitments ... in order to prevent any negative consequences."

US officials were not immediately available to comment. The Taliban Islamist militia swept back into power in Afghanistan last month after most US and other Western troops left, ending a military and diplomatic mission that began soon after the September 11, 2001 attacks on the >> Taliban call for upholding commitments made in Doha

Meanwhile, United States Secretary of Defense Lloyd Austin and Joint Chiefs of Staff Chairman General Mark Milley, appearing before Congress on Tuesday, have acknowledged a series of failures that led to the chaotic withdrawal of US troops from

"It is clear and obvious that the war in Afghanistan did not end on the terms we wanted with the Taliban now in power in Kabul," General

Milley told the Senate Armed Services Committee, warning that Afghanistan today appears headed towards civil

"The fact that the Afghan army we and our partners trained simply melted away - in many cases without firing a shot - took us all by surprise," Austin, a former four-star general who served in Afghanistan, told the Senate Armed Services Committee.

"It would be dishonest to claim otherwise."

"My analysis was that an accelerated withdrawal, without meeting specific and necessary conditions, risks losing the substantial gains made in Afghanistan, damaging US worldwide credibility and could precipitate a general collapse of the NSF and the Afghan government, resulting in a complete Taliban takeover, or general civil war," Milley said. He called it a "strategic failure".

COP26 'won't be easy'

UN climate chief admits as world faces frequent droughts, flooding, storm surges

The forthcoming COP26 summit -- which could determine the viability of the Paris Agreement -- will "not be easy" but an outcome matching the urgency of the crisis is an "absolute necessity", the UN's climate chief said yesterday.

As the world faces stronger and more frequent droughts, wildfires, flooding and storm surges made worse as the planet warms, the COP26 summit in Glasgow is being billed by organisers as a key milestone for keeping the Paris goals within reach.

The point is decisions need to be taken now, that is why Glasgow is so important," UN climate chief Patricia Espinosa told AFP

Struck to international fanfare in 2015, the accord commits nations to limit global temperature rises to "well below" 2 degrees Celsius above those before the onset of the Industrial Revolution.

It also saw countries promise to stick to a safer warming cap of 1.5C through sweeping emissions cuts. Yet, 6 years on, atmospheric levels of planet-warming CO2 have risen steadily and are now at their highest concentrations in roughly three million years. The latest round of country-by-country emission-cutting pledges --

baked into the Paris deal's "rachet" mechanism of ever-increasing ambition put Earth on course to warm a "catastrophic" 2.7C this century.

COP26, delayed a year due to the pandemic, will provide another chance for states to agree key outstanding elements of the Paris rulebook, or how the aspirational goals outlined in the deal function in practice.

Russia threatens to block YouTube

Russia yesterday threatened to block YouTube and take other retaliatory measures, after the US video-sharing platform blocked the German-language channels of state broadcaster RT. Moscow has recently been ramping up pressure on foreign tech giants as it seeks greater control over content available online to its domestic audience. At the same time, it has launched a series of efforts to broaden its influence abroad, especially with RT which operates broadcasters and websites in multiple languages. YouTube on Tuesday told German media that it had issued a warning to RT for violating its coronavirus disinformation guidelines and then shuttered two channels for breaching user terms.

Japan ruling party elects Fumio Kishida leader, next PM

Japan's ruling party elected former foreign minister Fumio Kishida its new leader yesterday, setting him on course to become the next prime minister of the world's thirdlargest economy. The soft-spoken centrist defeated popular vaccine chief Taro Kono in an unusually close race to succeed Prime Minister Yoshihide Suga, who is stepping down after just a year in office. Kishida, 64, will be confirmed as the new premier in a vote in parliament on October 4 and will then lead the Liberal Democratic Party (LDP) into general elections that must happen by November. Speaking after his win, he called on members to "show the public that the LDP has been reborn, and appeal for their support."



Indian caught with kilo of gold paste in rectum

A smuggler who stashed nearly one kilo of gold paste in his rectum to get the precious metal past Indian customs has been arrested, officials said yesterday. India is the world's second-largest gold consumer and experts say smuggling has increased in recent years, including by converting the precious metal into paste form. The mule was detained on Monday after a security official noticed the "presence of metal in body cavity" at Imphal airport in the northeastern state of Manipur. The man, who was bound for New Delhi, was taken for questioning but "could not reply satisfactorily", the Central Industrial Security Force said in a news release. Officials then took him to the medical examination room where an X-ray of his lower body revealed four capsules filled with gold paste weighing over 900 grams (1.98 pounds).
