

EVALY DEBT Only a part peeled The e-commerce firm owes at least

Tk 408cr to 1,026 sellers

Evaly owes at least Tk 408 crore to 1,026 sellers, according to its own data obtained by The Daily Star.

This amount is nearly double what Evaly disclosed on September 5, when the e-commerce platform told the commerce ministry that it owes Tk 205.86 crore to its merchants.

The actual figure may be much higher as there may be more databases that this newspaper could not get. The daily was given access to several of the payment-tracking datasheets maintained by the beleaguered

company, by sources within. meticulous details, separate bill and invoice numbers, the dates of the invoices, the total amount due to each merchant, and whether or not the merchant was paid (through online or bank

transfer or cheques). Evaly owes Artisan approximately Tk 32 crore, according to Evaly data.

Operations Manager Aupo Hasan said they cannot confirm the exact figure, but it would be something like that.

Zeal for repatriation cost him his life

Say people close to slain Rohingya leader MOHAMMAD AL-MASUM MOLLA AND MOHAMMAD ALI JINNAT

About four months before his assasination, Rohingya leader Mohib Ullah's organisation took an initiative to form repatriation committees in every refugee camp to facilitate the return of the refugees.

His Arakan Rohingya Society for Peace and Human Rights was forming these committees to make Rohingyas aware why they should go back home. The initiative angered different Rohingya groups that maintain that

refugees should return only after the Arakan state is liberated. 'As Mohib formed the committees, he started receiving threats. But

Mohib had an unwavering determination," said a close aide of Mohib who was assassinated on Wednesday night.

Mohib and his followers formed several committees in the Lombashia camp and were about to expand it gradually to other camps.

Mohib, a leading voice for the Rohingya cause, was among the 700,000 refugees who came to Bangladesh in 2017 fleeing a violent military crackdown in Myanmar.

RingID embezzled Tk 212cr in 3 months

Had no authorisation to collect money from customers; CID arrests director

After Evaly, Dhamaka Shopping and Eorange, the jig seems to be over for another unscrupulous company, the social networking platform RingID, after one of its directors was arrested yesterday.

The police arrested Saiful Islam from the capital's Gulshan following a case filed on September 30 by an aggrieved user of RingID at the Bhatara Police Station under the Digital Security Act and Multi-Level Marketing Control Act.

Saiful is the brother of Shariful Islam,

the managing director of RingID, which was established in July 2015 as a social networking platform with a dizzying range of features including live broadcasting, voice and video calls, instant messaging, stickers, media cloud, newsfeed, secret chat, multimedia sharing, online wallet.

Shriful's wife, Ayrin Islam, is the cofounder and chief executive officer of Ring ID, which had sponsored cricket tournaments a few years ago, like Evaly.

Ayrin and Shariful were arrested earlier on December 28, 2016 following a case SEE PAGE 2 COL 1

433 in jail under DSA

Amnesty gives UN figures until July 11

Bangladesh had at least 433 prisoners under the Digital Security Act as of July 11 this year, Amnesty International told the United Nations' Human Rights Council (HRC) yesterday.

The figure was 358 exactly a year ago (July 11, 2020), said the rights body during the Council's 48th session.

"The longest serving prisoner detained at least until 11 July 2021 under the law has been detained since December 24, 2018," said Saad Hammadi, the South Asia Campaigner for Amnesty International, briefing the Council.

Amnesty reviewed the recommendations made during Bangladesh's Universal Periodic Review (UPR) to see which ones have been implemented so far.

Every four years, the HRC reviews Bangladesh's human rights situation as part of its UPR. The last time Bangladesh went through the process was in 2018.

Bangladesh was reviewed and it agreed to implement 178 of the suggestions to improve the human rights situation in the country.

Switzerland, Poland, Latvia, Slovakia, New Zealand, Canada and some other countries had recommended that Bangladesh take measures to ensure freedom of press, freedom of assembly, and freedom of political association. SEE PAGE 5 COL 1

Around 80 villages have been flooded in at least six upazilas of Jashore and Khulna districts due to incessant rain last month.

Many villages in Abhaynagar, Monirampur and Keshabpur upazilas of Jashore and Dumuria upazila of Khulna have been inundated, said Ranajit Bawali, convener of Bhabadah Pani Nishkason Shangram Committee.

These villages fall under the Bhabadah waterlogged region, which has been a lifelong woe for hundreds and thousands of inhabitants of at least six upazilas in Jashore, Khulna and Satkhira, he said.

Locals are fearing that the muchtalked Bhabadah water logging problem may reappear in region as the water has been stagnant and hasn't receded in the past week.

Meanwhile. Water Jashore Development Board has been trying to pump out the stagnant water to solve the problem from the beginning of the year.

Ranajit, however, said there is no option to solve the problem except for using tidal river management (TRM) system.

Shibapada Biswas, a resident and high school teacher of Dumurtola village in Jashore's Abhaynagar upazila, said, "A road that goes through either side of marshland is the only stretch of land that hasn't yet gone underwater. The rest of the village has been under the knee to waist-deep water since mid-

September. Incessant rain for the last several days caused the flooding, which resulted in countless sufferings for us."

He and other locals said the Water Development Board's (WDB) initiative of pumping out water and sealing the Hori river at Bhabadah Sluice gate point in "impractical".

The Met office recorded 334 mm rainfall in Jashore during September.

Jashore WDB Executive Engineer Tauhidul Islam said the inundation happened due to the nonstop rain within a short period since the beginning of September.

The pumps that were installed are not capable of pumping out such huge quantities of water, he said.

"I heard around 80 villages have gone underwater but we don't have our statistics in this regard.'

The engineer said it might take longer for the water to recede from the villages. If more powerful pumps are installed, the problem may be solved, he hoped.

After already spending almost Tk 2.5 crore on the pumping project -- including setting up the pumps, paying electricity bills, and doing some river excavation work -- the WDB has proposed another water-pumping project at an estimated cost of Tk 50 crore.

However, locals rejected WDB's proposal at a meeting in Jashore on September 25 attended by Azadur Rahman Mallick, joint secretary of the Water Resources Ministry.

"We have decided that we will not be making any comments on Evaly," he said.

In November last year, Evaly and Artisan signed a memorandum of understanding according to which customers could purchase gift cards of the clothing brand from Evaly at up to 60 percent discount, to be used across the country.

Of the 1,026 merchants this newspaper tracked, most are owed between Tk 5 lakh and Tk 30 lakh each. Around 70 sellers are owed over Tk 1 crore and over 10 sellers over Tk 5 crore each.

This includes the mega chain Sabbir Hasan Shwapno. Nasir, executive director of ACI (Logistics) Ltd (Shwapno), confirmed that the figure owed by Evaly to them is Tk 5.6 crore. Evaly owes Tk 5.8 crore to Partex

Mum drinking water and RC Cola.

Partex Beverage Ltd, confirmed that the amount would be in that region. "If Evaly shuts down, it will ultimately be us who would suffer and not be able to get our money back," he said, adding that they had been in business with Evaly for a year.

Highly-placed sources in the police, who are investigating Evaly, said they were looking money-laundering trails and whether Rasel siphoned off the company's money to personal coffers.

On the other hand, a presentation made to new recruits on June 15 showed the hundreds of crores of taka of monthly sales by Evaly.

It showed that Evaly's gross merchandise value (GMV) in May this year was Tk 800 crore.

Gross merchandise volume is a term in e-commerce that shows the total sales value for merchandise sold through a marketplace over a specific timeframe. It is calculated by taking the sale price per item charged to the customer and multiplying this by the number of items sold.

Between January and April 2021, Evaly's gross merchandise value ranged between Tk 500 crore and Tk 600 crore.

This was a meteoric rise from September 2020, when the company's GMV stood at less than Tk 50 crore.

With monthly sales worth several hundreds of crores of taka but almost nothing in the banks arises the question: where has all this money gone?

Iftekharuzzaman, executive director of Transparency International, Bangladesh, told The Daily Star in an interview published last week: "Now, the Bangladesh Financial Intelligence Unit should look into the money laundering aspect of it, to trace the money of the customers who have paid Evaly for

undelivered products. If the money is as they failed to air advertisement-free not in the bank, then where is it?" programmes or clean feed. Battle for abortion rights hits America's streets

The abortion rights battle was set to take to the streets across America yesterday, with hundreds of demonstrations planned as part of a new "Women's March" aimed at countering an unprecedented conservative offensive to restrict the termination of pregnancies.

The fight has become even more intense since Texas adopted a law on September 1 banning almost all abortions, unleashing a veritable legal guerrilla warfare and a counterattack in Congress, but with few public demonstrations until now.

Two days before the US Supreme Court, which will have the final say on the contentious issue, is due to reconvene, nearly 200 organizations have finally called on abortion rights defenders to make their voices heard from coast to coast.

In the last quarter of 2020, RingID pivoted into a business model that exploited the affiliate marketing programme, which is rather popular globally to drive sales and generate significant online revenue.

Affiliate marketing is a process by which an affiliate earns a commission for marketing another person's or company's products. Typically, the affiliate promotes a product and earns a piece of the profit from each sale made.

Often, directing people to a company's site is enough to get the affiliate the commission.

RingID posed as an affiliate and to maximise its commission from companies, it dipped into its sizeable

year of its operation a decade ago. Besides, like e-commerce sites, RingID was also conducting transactions through e-wallets in the name of selling various products at

unusual discounts, the CID said. In the primary interrogation, Saiful, who was placed in a two-day remand yesterday, admitted that RingID did not have the authorisation to collect such deposits from users, the CID said.

In the time of the pandemic, many were thinking of making easy money, which is why they fell for RingID's offer, according to Rezaul Masud, special superintendent of the CID's Cyber Intelligence and Risk Management cell.

"We just got the amount for three months. If we look into the amount they collected for the full year, the amount will be four times higher," he told The Daily Star yesterday.

About one lakh purchased RingID's membership.

"If someone gets Tk 7,000 a month from investing Tk 12,000, why would people not jump in? Their business has a kind of multi-level marketing model with fraudulence," Masud added.

For Gold membership, one has to pay Tk 22,000. He/she can then earn up to Tk 15,000 a month by watching about 100 advertisements per day.

Between May and July, RingID collected a total of Tk 212.3 crore by selling such memberships, said a press release from the Criminal Investigation Department (CID) of the police, which made the arrest.

If the existing members brought in newer ones, they were rewarded too, giving RingID the vestige of notorious multilevel marketing companies like UniPay2U, which had collected more

with the police led to Saiful's arrest, and her family had put in upwards of Tk 20 lakh in RingID.

They are yet to see any returns on their investments.

Two more cases have since been filed against RingID with Jashore's Kotwali Police Station, said Tajul Islam, officerin-charge of the police station.

The Bangladesh Bank has already been requested to freeze RingID's bank accounts to curb money laundering.

An inquiry team of CID is also working in this regard.

"The 'Brand Promoter Model' is like the Affiliate Marketing Programme that in fact very popular worldwide."

The company started its business with Evaly in April/May 2020. Evaly sometimes deposited 10 percent or 20 percent money against the total orders and then bought goods from the company.

The rest was supposed to be paid as per an agreement.

The company has not provided any mobile phone to Evaly since May this year, and consumer electric products were delivered the last time in July.

The source said, "Whenever they [Evaly] said they would take goods but wouldn't deposit money, Fair Electronics stopped supplying them products.

The source added, "If Evaly is declared bankrupt, they will sue them. And then, they will file a case on charges of extortion.

"Fair Electronics learnt from various government sources that the authorities are considering auctioning and selling Evaly's assets. If something like this happens, the arrears will be calculated and distributed. That's good too."

Out of 1,143 unique merchants' data checked by this newspaper, only 17 percent had no money due from the e-commerce firm.

However, this newspaper has incomplete data on liabilities, since the company itself claims it has over 35 thousand registered merchants.

As many as 552 small traders -- each owed Tk 10 lakh and less -- are still waiting for their payments.

a bill of Tk 1.3 lakh. The Bosila-based water purifier seller's bill has been stuck since February, said its proprietor Mohaimen Islam Shamim.

"I stopped giving them [Evaly] products about 4-5 months ago because I used to continuously get calls from customers, who had paid for the products but did not get the delivery. Evaly would sell the products, but would not forward me the invoices. So, I never knew whether a product was shipped or not." said Shamim. He said used to sell around 30-40 filters every month.

Evaly had told the commerce ministry late last August that it owed its customers Tk 311 crore, and that it had 207,741 customers.

It is unclear how the money will be repaid by Evaly. Commerce Minister Tipu Munshi said last week, "I don't think Evaly has any money -- there is not much scope to recover any money from them."

In June, a Bangladesh Bank inspection found that Evaly only had Tk 65 crore in assets, a fraction of what it owes to its sellers and buyers.

In addition, the Rapid Action Battalion, which is quizzing Evaly's CEO Mohammad Rassel and his wife Shamima Nasrin, chairperson of the e-commerce platform, also informed the media that Evaly had only Tk 30 lakh in its bank accounts.

This is alarming because sales data of just two dates -- July 31 and August 7, 2021 -- shows that the e-commerce firm owes Tk 32 lakh in advance payments made by about 4,000 customers. This

e-commerce firm used to take money from new customers to clear debt owed to old customers.

The dramatic rise in Evaly's gross merchandise value came during a time when it was being investigated by a whole host of government agencies for financial irregularities.

In late August, the BFIU informed the public that it would freeze Evaly's assets for investigation. Later in September, the National Board of Revenue and the Anti-Corruption Commission joined the frav.

In February this year, by the time the central bank jumped on the bandwagon, the beleaguered company's GMV had shot up from Tk 50 crore to Tk 500 crore.

Fahmida Khatun, executive director of Centre for Policy Dialogue (CPD), wrote in The Daily Star recently, "The commerce ministry and the Bangladesh Bank have critical roles in overseeing and monitoring such businesses. These malpractices have been going on for several months. Why these were not tracked and stopped by the responsible departments are questions that must be answered.

Contacted over the phone, Evaly Executive Director Ehsan Sarwar Chowdhury told this correspondent to send queries via WhatsApp.

The questions were sent via the messaging app, but The Daily Star was yet to get the reply till 10:45pm yesterday.

This was the minister's first remarks after the global condemnation of the Rohingya leader's murder.

Police on Thursday night registered a murder case in this regard, a day after the killing took place at Ukhiya camp in Cox's Bazar.

The FIR was filed with Ukhiya Police Station against unidentified people following a complaint from Mohib Ullah's brother Habib Ullah, OC Sanjur Morshed of the police station said.

Unidentified assailants opened fire on the 44-year-old Rohingya leader on Wednesday night. He was first rushed to a local medical facility and later shifted to Cox's Bazar Sadar Hospital, where doctors declared him dead on arrival.

Mohib Ullah was buried in Ukhiya's Lambashia camp-1 on Thursday afternoon after a namaz-e-janaza, which was attended by a large number of Rohingya refugees from camps in Ukhiya and Teknaf upazilas.Formerly a teacher in Myanmar, the slain human rights activist was popularly known as Master Mohib Ullah among the Rohingyas. He was the head of Arakan Rohingya Society for Peace and Human Rights at Kutupalong camp.

December 31, 1954, Bablu completed his HSC from Notre Dame College in

Dhaka. He also obtained Bachelor's in Arts, Master's in English Literature and another Bachelor's in Law from Dhaka **University**

Active in student politics from a young age, he served as the general secretary of DU's English Departmental Association from 1974 to 1975.

From 1979 to 1983, he was a member of the Dhaka University Senate. From 1981 to 1983, he was the General Secretary of Bangladesh Chhatra League (Bangladesher Samajtantrik Dal).

During that time, he also served as the general secretary of Dhaka University Central Students Union (DUCSU).

From 1988 to 1990, Bablu was the cabinet minister of power and energy during the Ershad regime.

As he was known as a JP leader who sympathised with Awami League, he also served as an advisor to Prime Minister Sheikh Hasina from 2013 to 2014 with the rank and status of a cabinet minister.

Bablu was first elected a member of parliament in 1988 from the Chittagong-7 constituency and was later elected MP from Chittagong-9 in 2014.

He was also appointed special assistant to late Jatiya Party chairman HM Ershad.

His namaz-e-janaza was held at the Gulshan Azad mosque after Esha praver. He was laid to rest at the Mirpur martyred intellectual grave.

Meanwhile, police on Friday night arrested Abdus Salam, 30, of ombashia camp and Ziaur Rahman, 32, of Kutupalong camp during raids on the camps, said Armed Police Battalion (APBn) officers.

188 hospitalised with dengue STAFF CORRESPONDENT

At least 188 patients were hospitalised in the last 24 hours till 8am yesterday of which 30 are from outside Dhaka, according to the Directorate General of Health Services (DGHS).

This year, 7,841 dengue patients were hospitalised across the country in September which is the highest in a single month. At least 7,698 were diagnosed in August, 2,286 were hospitalised in July, 272 in June, 43 in May and the rest from January to April.

With the new cases, a total of 18,550 people were hospitalised this year. Of the total infected, 2,367 are from outside Dhaka.

According to the DGHS, 68 people have died of dengue infection in the country this year. Twelve people have died in July, 34 in August and 22 in September. Among the deaths, 63

have died in Dhaka SEE PAGE 4 COL 4



Abul Mansur Ahmad has explained the world in his own way. He thought and wrote about the world in all its complexities -- exploring politics, economics and literature - and envisioned how to create changes for the better, observed Professor Emeritus Serajul Islam Choudhury of Dhaka University.

He must be remembered for his unique contribution to history, Prof Serajul noted during a prize giving ceremony for an essay competition on the eminent writer-historian organised by the Abul Mansur Ahmad Smriti Parishad at The Daily Star Centre in the capital vesterday.

"Abul Mansur Áhmad was involved in every major movement in some form, including the peasant movement, language movement,



Rabindra University students call off protest

"But we will continue the Law Minister peaceful sit-in programme in front of the academic building," Shamim Anisul Huq yesterday added.

Hours after Rabindra University was declared closed for an indefinite period, the administration issued a notice on Friday confirming that the university will not remain closed. However, exams will remain suspended till further notice.

The aggrieved students have been demonstrating, seeking permanent expulsion of Farhana.

On September 26, the teacher asked university employees to trim male students' hair before allowing them to enter the examination hall.

Farhana, herself, trimmed hair for many other students, alleged the agitators.

Unable to bear the humiliation, one of the students tried to die by suicide, sparking protests.

Child marriage on the rise in Cox's Bazar: study

A recent study on the impact of Covid-19 on child marriage in Cox's Bazar has showed a rising trend in the number of child marriages in the district since March 2021.

Notably, the highest increase -- 82 percent -- came from Eidgaon upazila, while Ukhiya upazila was second with a 75 percent increase, the study found.

Carried out by COAST Foundation, the study surveyed 32 union parishads and three municipalities across the nine upazilas of the district.

Jahangir Alam, assistant director of COAST, presented the findings at a virtual press conference yesterday.

Md Mujibul Haque Munir, joint director

of the organisation, said child marriage eats up nine percent of women's income and one percent of the total national income.

"Preventing child marriage by 2030 could save 11 percent of our educational budget," he added.

The study was conducted from August 4 to September 26 this year. It covered 384 families who had a member or a close relative marry off their underage daughter during 2020 and 2021.

Around 63 percent respondents said child marriage rates increased due to the pandemic -- and its economic fallout --, while 47 percent cited school closure as the main reason behind the spike in the rate.

The conference was moderated by Rezaul Karim Chowdhury, executive director of COAST Foundation.

Ami Probashi app is a digital platform operated by the expatriates' welfare ministry. The app provides various support services to Bangladeshi nationals seeking job opportunities abroad.

As per government decision, migrant workers have to first register with BMET, by paying a fee, to be eligible for Covid-19 vaccine registration on Surokkha site/app. One way to register with BMET is through Ami Probashi app.

Addressing the programme, the BMET

DG said authorities are planning to add a new condition for recruiting agents to obtain a recruitment licence: agencies have to arrange a job fair at least once a year at TTC to recruit workers.

Addressing the programme as chief guest, Expatriates' Welfare Ministry Secretary Ahmed Munirus Saleheen said due to the service of Ami Probashi app, migrant workers could overcome a crisis period and ensure Covid-19 vaccination.

In terms of per capita remittance, the secretary said, Bangladesh's position is "frustrating" when compared to what other labour-sending countries such as India and the Philippines earn.

"Our per capita remittance, when compared to international standard, is very low," he said, adding that to improve the remittance situation, focus has to be given on quality migration, and the government has taken various steps to ensure that.



The Kuakata municipality mayor, who illegally built a kitchen market on public land several months ago, has demolished a 100-foot section of a boundary wall that demarcated a piece of land belonging to Bangladesh Water Development Board (BWDB) in the town.

Mayor Anwar Hossain Hawladar was physically present at the spot around 11:00am on September 25 when about a dozen of workers and municipality employees used a bulldozer to dismantle the wall of BWDB's 'Dhansiri inspection bungalow' on Kuakata-Patuakhali highway, said Arif Hossain, executive engineer of BWDB in Kalapara.

All the bricks, iron rods and rubble of the five-foot-high wall were removed by the workers in front of the mayor, he also said.

BWDB bungalow employee Masum Mia said he tried in vain to stop the demolition work as the workers carried out the task at the directive of the mayor.

By the time WDB's Sub-Divisional Engineer Shawkat Iqbal Mehraj, Assistant Revenue Officer Tariqul Islam and Branch Officer Syed Tariqur Rahman arrived at the scene, the dismantling of the wall was already complete.

Faridpur General Hospital limps for shortage of doctors, staffs

Medical services for 1.913 million people (2011 census) in Faridpur district is limping amid an acute shortage of doctors and staff at Faridpur General Hospital, one of the frequently sought after medical destinations.

City

The hospital was established in 1917 with 20-bed and later it was upgraded to 50-bed in 1985 and finally, it was upgraded to 100bed in 2002 without arranging adequate manpower, said the hospital sources.

There are only 14 doctors against 37 posts, no sub-service superintendent against one, three pharmacists against four, 14 office assistants against 20, two cooks against six, one ward master against one and eight sweepers against 16 at the hospital, added the sources.

At present, there is no senior consultant at surgery, skin, ENT and orthopaedic departments and no junior consultant at the ophthalmology, cardiology, radiology and pathology departments. The posts have been lying vacant for long. Besides the posts of anaesthetist,

pathologist, radiologist, two sub-registrars at gynaecology department, two subregistrars at surgery, a sub-registrar at ENT, two sub-registrars at medicine department, two posts of EMO, a medical officer, one blood bank officer and one medical officer (herbal) are also lying vacant.

The current employees also do not perform their duties properly, the patients alleged.

Patients crowd in front of the doctors' chambers while the doctors idle away their time on different excuses, they claimed.

Emergency patients who come to the hospital in the afternoon or at night are often deprived of services.

During a visit to the hospital recently, this correspondent saw at least 120 patients at different wards and many outdoor patients waiting in front of the doctors' chambers.

Some patients and their attendants claimed that medical representatives often visit doctors during duty hours.

Hamidur Rahman Khan, 50, from Manan Mondal Dangi village said, "I have been suffering from fever for two days. So, I came here to visit a doctor and have been waiting in the queue for two hours."

Md Lablu Kabiraj, 40, a resident of Luxmipur area who came to the hospital with his ailing son, said "There are a good number of patients in this hospital. So, we have to wait for long. If the number of doctors was higher, we would not need to wait for longer.

Ganesh Agarwala, residential medical officer (RMO) at Faripdur General Hospital said, "At least 600 patients take treatment outdoor at our hospital daily as Bangabandhu Sheikh Mujib Medical College Hospital was declared Covid-19 dedicated hospital. But we have not enough

doctors to extend treatment and handle such a greater number of patients daily."

"Additionally, I would like to add that the hospital quarter was declared abandoned 12 years ago. The consultants do not stay at their quarters at the hospital compound," he added.

Enamul Haque, Civil Surgeon in Faridpur said, "We are suffering a lot for the shortage of doctors and other staffers. We have sent our demand to the higher authorities no steps have been taken yet."

'Bullying acts' Taiwan rebukes China over

record fighter jet incursion

Taiwan yesterday accused Beijing of bullying and damaging regional peace after Chinese fighter jets and bombers made their largest ever incursion into the island's air defence zone.

Beijing marked its National Day on Friday with its biggest aerial show of force against Taiwan to date, buzzing the self-ruled democratic island with 38 warplanes, including nuclear-capable H-6 bombers.

Democratic Taiwan's 23 million people live under the constant threat of invasion by China which views the island as its territory and has vowed to one day seize it, by force if necessary.

Under President Xi Jinping, Chinese warplanes are crossing into Taiwan's air defence identification zone (ADIZ) on a near daily basis. Xi has described Taiwan becoming part of the mainland as "inevitable"

But Friday's incursion sparked a particularly sharp rebuke from Taipei.

"China has been bellicose and damaging regional peace while engaging in many bullying acts," Premier Su Tsengchang told reporters yesterday.

Friday's show of force came the same week Beijing accused Britain of "evil attentions" after it sent a frigate to sail through the Taiwan Strait.

China claims the strait as its own waterway, along with most of the disputed South China Sea. Most other nations view them as international waters open to all.

Beijing has ramped up pressure on Taipei since the 2016 election of President Tsai Ing-wen, who views the island as "already independent" and not part of a "one China"

Last year, Chinese military jets made a record 380 incursions into Taiwan's defence zone, and the number of breaches for the first nine months of this year has already exceeded 500.

Global Covid deaths hit 5m

US death toll crosses 700,000; Delta variant sweeps the world REUTERS

Worldwide deaths related to Covid-19 surpassed 5 million on Friday, according to a Reuters tally, with unvaccinated people particularly exposed to the virulent Delta strain.

The variant has exposed the wide disparities in vaccination rates between rich and poor nations, and the upshot of vaccine hesitancy in some western nations.

More than half of all global deaths reported on a seven-day average were in the United States, Russia, Brazil, Mexico and India.

While it took just over a year for the Covid-19 death to hit 2.5 million, the next 2.5 million deaths were recorded in just under eight months, according to a Reuters analysis.

An average of 8,000 deaths were reported daily across the world over the last week, or around five deaths every minute. However, the global death rate has been slowing in recent weeks.



More than half of the world has yet to receive at least one dose of a Covid-19 vaccine, according to Our World in Data.

The United States, which has been battling vaccine misinformation that has caused about one-third of the population to avoid inoculations, surpassed 700,000 deaths on Friday, the highest toll of any country.

US cases and hospitalizations have been trending lower, but health officials are bracing for a possible resurgence as cooler weather forces more activities indoors.

Russia reported 887 coronavirusrelated deaths on Friday, the largest singleday death toll it has recorded since the pandemic began and the fourth day in a row it has set that record. Only 33% of Russia's eligible population has received a first vaccine dose.

As a region, South America has the highest death toll in the world accounting for 21% of all reported deaths, followed by North America and Eastern Europe contributing more than 14% of all fatalities each, according to Reuters analysis.

However, India, one of the first countries ravaged by the Delta variant, has gone from an average of 4,000 deaths a day to less than 300 as its vaccination campaign is rolled out.

About 47% of India's eligible population has received a first shot, with officials administering around 7,896,950 doses per day over the past week, a Reuters analysis of Our World in Data showed.

The Delta variant is now the dominant strain around the globe and has been reported in 187 out of 194 World Health Organization member countries.

NORTH KOREA'S RECENT MISSILE TESTS UNSC fails to agree on joint statement

The UN Security Council held an emergency meeting Friday on North Korea's recent missile tests but failed to agree on a joint statement, diplomats said.

The closed door meeting lasted just over an hour. It was requested by the United States, France and Britain.

The goal was to examine North Korea's launch early this week of what it called a hypersonic gliding vehicle. On Friday North Korean state media said the country has tested a new anti-aircraft missile.

"France wanted a public statement but Russia and China said that this was not the time, that they needed more time to analyze the situation," a diplomat from a country that is part of the Security Council told AFP.

In 2017 at the behest of the Trump administration, the Security Council imposed tough economic sanctions against North Korea three times after it staged a nuclear test and several involving conventional missiles. The council passed them unanimously each time. But since then the council has failed to reach a common stance on North Korea.

Several times China -- Pyongyang's key ally -- and Russia have requested in vain the partial lifting of sanctions against North Korea.

UK army to deliver petrol from Monday amid fuel crisis

The British army will begin delivering petrol to fuel stations tomorrow after fears over tanker driver shortages led to panic buying and forced the government to offer visa waivers to foreign truckers to plug the shortfall. "Almost 200 military tanker personnel, 100 of which are drivers, will be deployed from Monday to provide temporary support as part of the government's wider action to further relieve pressure on petrol stations and address the shortage of HGV drivers," the government said in a news release issued Friday. Motorists queued at fuel pumps across Britain at the beginning of the week, draining tanks and fraying tempers. Business minister Kwasi Kwarteng said the situation is improving and emphasized that there was no national

shortage of fuel in the UK.

US official calls for Pakistan action on militants before visit

A top US official called Friday for Pakistan to take action against all extremist groups ahead of a visit to Islamabad, which has sought reconciliation with militants both at home and in Afghanistan. Deputy Secretary of State Wendy Sherman will meet on October 7-8 with officials in Pakistan, which has long faced US accusations of playing a double game in Afghanistan where the Taliban swept back to power in August. "We seek a strong partnership expect sustained action against all militant and terrorist groups without distinction," Sherman told reporters. Pakistani Prime Minister Imran Khan said in an interview aired Friday that his government had opened talks with Pakistani Taliban about laying down their arms. Sherman

'stretch to do more'

Says Kerry ahead of crucial COP26

The world's major economies must "stretch to do more" at next month's UN climate talks to show they are serious about wanting to tackle global warming, US Climate Envoy John Kerry said yesterday.

The COP26 conference in Glasgow aims to secure more ambitious climate action from the nearly 200 countries that signed the 2015 Paris Agreement to limit global warming to well below 2.0 degrees Celsius - and to 1.5 degrees preferably - above pre-industrial levels.

"We now have about 55% of global GDP (gross domestic product) committed to undertake tracks that will hold the temperature to 1.5 degrees. There are other countries now sharpening their pencils," Kerry said during a pre-COP26 meeting in Milan, Italy.

"Well below 2.0 degrees Celsius means well below ... the common sense meaning of that is not 1.9, 1.8 or 1.7 (degrees)," he added.

New energy and funding pledges from the United States and China have raised negotiators' hopes, but many G20 countries - including major polluters such as China and India - have yet to announce updates of their short-term climate action plans.

Climate activists have called for a transparent climate finance system and more grants to help the people most exposed to the impact of climate change. Wealthy nations that pledged a decade ago to mobilize \$100 billion a year to help vulnerable countries adapt and transition to cleaner energy are still short of their 2020 goal.

Kerry said he expected donors to fulfil the \$100 billion pledge, but added that a post-2025 finance plan "with an emphasis not just on billions, but on trillions" would be required.

Trump asks US judge to force Twitter to restart his account

Former US president Donald Trump asked a federal judge in Florida on Friday to ask Twitter to restore his account, which the company removed in January citing a risk of incitement of violence. Trump filed a request for preliminary injunction against Twitter in the US District Court for the Southern District of Florida, arguing the social media company was "coerced" by members of the US Congress to suspend his account. Twitter and several other social media platforms banned Trump from their services after a mob of his supporters attacked the US Capitol in a deadly riot on Jan. 6. That assault followed a speech by Trump in which he reiterated false claims that his election loss in November was because of widespread fraud. Before he was blocked, Trump had more than 88 million followers on Twitter and used it

as his social media megaphone.

Duterte to retire

Philippine President Rodrigo Duterte yesterday said he will not run for vice president in 2022 and will retire from politics, potentially paving the way for his daughter to contest the country's highest office.

Duterte, who polls show remains almost as popular as when he was swept to victory in 2016 on a promise to rid the country of drugs, is constitutionally barred from seeking a second term as leader.

"The overwhelming... sentiment of the Filipinos is that I am not qualified and it would be a violation of the constitution to circumvent the law, the spirit of the constitution" to run for the vice presidency, Duterte, 76, said.

"Today I announce my retirement from politics."

Duterte made the surprise announcement at the venue where he was expected to register his candidacy. He did not specify when he would leave politics. His close aide, Senator Christopher Lawrence "Bong" Go, registered for the vice presidency instead.

The tough-talking leader has not yet announced his preferred successor, but many expect it will be his daughter, Sara, who has been the front runner in recent polls.

Yesterday, Sara registered to run for her third term as Davao mayor, state media reported. But she has until November 15 to make a late entry into the presidential race -- as her father did in 2015.

The election season kicked off Friday with candidates vying for thousands of posts from president to town councillor.

Report says Afghan interpreters summoned by Taliban

Afghan interpreters who worked for the Netherlands have been summoned to appear in court by the Taliban who have threatened their families, Dutch public television NOS reported on Friday.

The interpreters are in hiding but their family members will be held responsible if they fail to show up in court "and severely punished to teach other traitors a lesson," said a letter from the Taliban, which was aired by the broadcaster.

NOS said the recipient, who worked for the EU's policing agency Europol in Afghanistan, was accused of taking "dishonourable and forbidden money" from foreigners.

"We will take revenge. If we are not able to get hold of you, we will settle scores with your near ones," said another letter to an interpreter whom the Taliban accused of being responsible for the deaths of some of their fighters.

Just after taking power, the Taliban declared a general amnesty for Afghan government and military officials. But despite their pledges not to avenge themselves, a confidential United Nations report said the Taliban were tracking down people who worked with foreign forces.

Man marries rice cooker

An Indonesian man named Khoirul Anam has created a stir on social media by 'marrying' his rice cooker. Khoirul Anam shared a series of pictures last week that show him dressed up in fancy wedding finery for the ceremony. The white-



coloured rice cooker he 'married' was also decked up for the occasion - it appeared alongside Anam in a sheer white veil.

Photos that he shared on Facebook show them sitting side-by-side as the marriage was solemnised. One of the photos shows him kissing the cooker. In another, the appliance is placed next to him as he signs their marriage papers.

In a short caption accompanying the post, Anam said he decided to marry his rice cooker as it was "Fair, obedient, loving and good at cooking."

The photos sparked much amusement on Facebook, collecting nearly 10,000 'likes' and over 1200 comments.

Bizarre as it may sound, the story only got stranger when, four days later, Anam 'divorced' the kitchen appliance, citing that it could only cook rice. The Indonesian man announced the divorce on Facebook.

Of course, the whole wedding and the subsequent divorce was nothing more than a social media stunt for entertainment. Local news websites report that Anam is a well-known celebrity in Indonesia who participates in outlandish stunts for the entertainment of his followers.

The sixth session of the Bangladesh National Youth Conference on Family Planning (BNYCFP) ended on ecently in Dhaka in hybrid format with two days of sessions.

The conference host SERAC-Bangladesh was joined by its partners including Foreign, Commonwealth and Development Office, USAID, Bangladesh Youth Health Action Network (BYHAN), Coalition of Youth Organisations in Bangladesh (CYOB), Jhpiego, Population Action International (PAI), Marie Stopes Bangladesh, Population Reference Bureau (PRB), Pathfinder International and UNFPA Bangladesh in organizing this largest youth gathering in the country on reproductive health and family planning.

More than five hundred youths joined the event with the theme "Commit and Act For Youth", where policymakers, high-level government officials, international and national experts on health and family planning spoke and shared experiences.

The conference opening plenary was chaired by Dr Mohammed Sharif, Director (MCH-Services); Line Director (MC-RAH), MCH-Services Unit



of Directorate General of Family Planning, whereas attended by the former Director-General of Family Planning Quazi AKM Mohiul Islam, UNFPA-Bangladesh, Chief of Health Dr Vibhavendra Raghuyamshi, Senior Country Director of Pathfinder International Bangladesh, Ms Caroline Crosbie, Senior Program Officer of Advance Family Planning and youth speaker, Mr Mervyn Christian, MPH and young city champion, UN-Habitat-Botnar, Md Nazmul Hasan. On the first day, 500 young

people actively joined in multiple sessions conducted by Pathfinder International, Population

Reference Bureau, Population Action International, IYAFP and other potential partners.

On the second and final day, the conference secretarygeneral and SERAC-Bangladesh's Executive Director SM Shaikat moderated the closing session chaired by Director General of Family Planning Shahan Ara Banu, NDC, and the Minister of Health and Family Welfare Zahid Maleque, MP joined as the chief guest. Speakers and special guests included UNFPA Country Representative Dr Asa Torkelsson, Health Advisor of the Foreign, Commonwealth, and Development Office (FCDO) Dr Shehlina Ahmed, and a youth

representative Khadija Kalam. SM Shaikat, Executive Director of SERAC-Bangladesh in his speech highlighted, the standard and scopes of the adolescentfriendly health services need expansion with more allocation of budget and increasing numbers of service providers, which is an area government and non-government actors have roles to play. Health Minister Zahid

Health Minister Zahid Maleque said that, adolescents are the futures of the country. The government is trying its best to ensure health services at all levels in the country. The service facilities are equipped with information and services on family planning, sexualreproductive health. He emphasised that the vision of the Father of the Nation, Bangabandhu Sheikh Mujibur Rahman was to secure primary healthcare for everyone and freedom from hunger and poverty. This vision needs to focus more on the health and well-being of the young population.

DGFP chief Shahan Ara Banu confirmed her departments' commitments for youth and adolescents family planning services and information from national and grassroots levels. She reiterated that the National Adolescent Health Strategy 2017-2030 has been in operation to support the 1,103 centres for adolescents service. Brain magnetic stimulation can enhance memory performance

Memories of past events and experiences are what define us as who we are. Yet, the ability to form these episodic memories declines with age, certain dementias, and brain injury. A study by the University of Glasgow, United Kingdom, shows low-frequency repetitive transcranial magnetic stimulation or rTMS stimulation can improve memory performance by reducing the power of low-frequency brain waves as memories form.

Based on current knowledge of the brain and the effects of rTMS, the researcher's hypothesised that they could improve episodic memory, and in the process, generate targets for future memoryrelated therapies.

The researchers first analysed past data from 40 college students who had been asked to memorise lists of words. Half of the students received slow rTMS over the left dorsolateral prefrontal cortex while memorising the words, and the other half received rTMS over a control region of the brain. Then, in a new experiment, researchers collected data from 24 college students who each performed a similar memory task under both rTMS conditions.

Analysis of both datasets revealed that the slow rTMS applied to the prefrontal region led to the reduced power of low-frequency (beta) waves in the parietal region of the brain, which is known to be involved in attention and perception.

The electrophysiological results suggest that frontal stimulation affects a broader network and improves memory formation by inhibiting parietal areas. These are complex but exciting effects that require further experiments to better understand their neural basis.

Can AI foresee the next virus transmission from animals to human?

Most emerging infectious diseases of humans (like COVID-19) are zoonotic – caused by viruses originating from other animal species. Identifying high-risk viruses earlier can improve research and surveillance priorities. A recent study at the University of Glasgow, United Kingdom, suggests that machine learning using viral genomes may predict the likelihood that any animal-infecting virus will infect humans, given biologically relevant exposure.

Identifying zoonotic diseases before emergence is a major challenge because only a tiny minority of the estimated 1.67 million animal viruses can infect humans.

The researchers are using viral genome sequences to develop machine learning models. They found that viral genomes may have generalisable features independent of virus taxonomic relationships and may preadapt viruses to infect humans. They were able to develop machine learning models capable of identifying candidate zoonoses using viral genomes.

These models have limitations, as computer models are only a preliminary step of identifying zoonotic viruses that can potentially infect humans. These models predict that viruses might infect humans; the ability to infect is just one part of the broader zoonotic risk, ability to transmit between humans, and the ecological conditions at the time of human exposure.

You do not store it right

The mask is easily thrown upon the dashboard or seat. Meantime, your mask needs a clean home. Put it in a dry paper or mesh bag if it is not damp or dirty. Put it in a clean pocket or handbag if you are out to dine but not on the table. Next, wash your hands, then reapply.

You reuse disposable masks Disposable masks are one-time use. With a reusable one, check it leaves no side gaps. The blue side should be facing out. After using a disposable mask, put it into a garbage bin. If you remove your mask to eat, replace it afterwards.

You don't tweak your mask to fit If your mask is too big, don't cross the ear loops. Instead, knot each one to shorten it. Put the knots behind your ears to keep the mask from cinching. A hijab can be worn over the mask and secured with a safety pin or paper clip.

You use a coffee filter

A filter on your mask does improve protection. Look for PM 2.5

should be worn loosely enough to allow you to breathe freely and move your mouth freely.

You wear your mask below your nose Make your nosepiece if your glasses fog up. Join a few wire twist ties. Make a tiny incision in the upper band of your mask and insert the twist ties.

You wear your mask above your chin Your mask should cover your chin and the bottom portion of your face. This is because viruses can enter via your chin and reach your mouth, nose, and eyes.

You don't baby your face Wash your face with a mild cleanser to prevent breakouts and rashes. Then, apply moisturiser for additional protection. Your dermatologist can advise you on the finest components for your skin. It is also recommended to remove your mask every 4 hours for 15 minutes.

DSA cases kept in limbo

Unlawful detainment without trial under the DSA is a breach of constitutional rights

RIDAY, October 1, marked three years since the → Digital Security Act (DSA) came into force in Bangladesh. From its very inception, we have warned against the indiscriminate use of this draconian law which, instead of protecting online spaces and making them safer, has been used to clamp down on freedom of speech and target independent journalism. Recent research from the Centre for Governance Studies (CGS) now verifies that our claims of the DSA being used as a tool to harass and silence certain individuals are not unjustified.

According to the think tank, which tracked details of 668 out of more than 1,500 cases filed under the Act in the last 20 months or so, only two cases have been disposed of so far. However, scores of DSA cases against journalists, teachers, politicians, students and others remain pending.

CGS data revealed that from 1,543 individuals accused, charges were pressed against only 1.17 percent, despite the fact that the law stipulates an investigation report must be submitted within 60 days of filing the case. This wanton disregard of the existing provisions of the law, which has led to the unlawful detainment without trial of those accused under the DSA, is a serious breach of the fundamental rights that a Bangladeshi citizen is accorded under the country's Constitution. We cannot forget that writer Mushtaq Ahmed was locked up under the DSA for over nine months and denied bail six times before he died-receiving the worst punishment even before being given a trial. Yet, there has been no serious inquiry into why it took nine months to complete the investigation.

We are also gravely concerned to note that 13 children (under the age of 18) have been prosecuted under the DSA, including a ninth-grader who was sent to a juvenile correction centre for allegedly insulting the prime minister on Facebook. But an overwhelming majority of these cases are not filed by aggrieved persons-in 507 of the 577 cases logged by CGS, those filing the cases were not the direct victims of the incidents. Only 76 cases were filed by law enforcement; 85 percent of the accusers were ruling party activists. The sheer folly of being allowed to lodge a DSA case against just about anyone, without even being affected by their alleged "crime", should not be lost on anyone, especially when it leads to situations like that of farmer Abu Zaman, who despite not even owning a smartphone or having internet access, was on the run in March this year after being accused under the DSA

This reckless use of the controversial law has shrunk civic spaces and created a culture of fear in the country. We call upon the government to immediately remove this threat to freedom of expression and democracy, and rescind the DSA before more innocent citizens fall victim to it.

threats for a week, when the Tatmadaw unleashed their scorched-earth campaign to wipe out the existence of the Rohingya from Myanmar in 2017.

Once in Bangladesh, Mohib and his family might have heaved a sigh of relief at having escaped the Myanmar military crackdown. Unfortunately, the sense of relief was not meant to last long. Mohib was brutally murdered in the Rohingya camp in Kutupalong, Cox's Bazar, on the evening of September 29, 2021. Assassins shot at Mohib at close range as he spoke

to highlight the cause of the Rohingya refugees

Mohib also established the Arakan Rohingya Society for Peace and Human Rights (ARSPH), a rights group, which unearthed and documented the sufferings of the Rohingya refugees at the hands of the Myanmar military.

However, it was Mohib's unfailing commitment towards a peaceful resolution to the Rohingya refugee crisis that might have made him a potential target for the ARSA. The Arakan Rohingya Salvation Army is known for its ruthless terrorist activities. Fortify Rights earlier suspected the militant group to be behind the abduction and torture of at least five Rohingya refugees. And Mohib's resolve to take a peaceful path to promote the Rohingya cause angered the ARSA who threatened him even earlier this month. Nur Khan Liton, a Rohingya rights activist told the AFP, "His [Mohib's] peaceful activism angered ARSA." ARSA might as well have acted on their threats.

Mohib's family suspect the Arakan Rohingya Salvation Army (ARSA) for his murder. Mohib's brother informed the media that he had received multiple death threats recently-from many unknown phone numbers—and he suspects that ARSA committed this atrocious act. But what made Mohib a target for ARSA?

Mohib was a leader who had played a proactive role to promote the cause of his community. Over the last few years, he emerged....one of the few from the Rohingya refugee community-to have boldly raised the concerns of the Rohingya community and worked towards ensuring a safer and respectable life for them. Mohib spoke on international platforms, including the UN Human Rights meeting in Geneva, and met the US president,

However, Mohib was a threat to many more. Mohib was also known for his activism against any kind of repatriation of Rohingya refugees to Myanmar, until a conducive environment for their return was ensured. Mohib led a peaceful protest in 2019 when a repatriation process was announced. This also made him an enemy of the quarters-even within the Rohingya community-who were and still are pushing for a so-called repatriation of the refugees.

And there are many other players in the Rohingya camps who could have been behind Mohib's murder. Violence is a common scenario in the Rohingya camps. One might remember the October 2020 gang violence that erupted in the Rohingya camps as different factions tried to establish their dominance in drug

trafficking that led to the killing of seven people and left many families without shelter. There are also speculations that people within Mohib's own organisation might have been behind this, due to differing opinions. Or even the other factions who felt threatened by Mohib's rising popularity and greater acceptability among the refugees.

Police have arrested a suspect—a man named Mohammad Selim alias Lomba Selim, was arrested from Ukhiya on October 2. "They fired five rounds" of bullets and fled immediately. Our search mission is on to arrest the killers," deputy police chief in Cox's Bazar, Rafiqul Islam, was quoted by Reuters. However, the killing of Mohib has raised multiple questions about the security situation in the Rohingya camps. If ARSA indeed has committed this crime, that too in full public view, then the possibility of their active presence and operations in the camps cannot be ruled out. If this turns out to be the case, then it is high time the government revisit its security strategy in the Rohingya camps in Cox's Bazar. ARSA's presence in the Rohingya camps is not just a threat to the security of the Rohingya, it is a security threat for the country and the region.

Even if any other quarter has carried out the assassination attack on Mohib, this incident has nonetheless exposed the security lapse in the camps. How can murderers just kill a man in public and get away with it?

As of writing this column, the police informed the media that they were investigating the murder. The bullet shells are being scrutinised to trace them back to the killers. Witnesses are being interviewed. The police initially suggested that the witnesses saw four to five men shooting at Mohib before fleeing the scene. Given the tight security that is supposed to be in place at the Rohingya camps, how could this have happened?

The current state of security affairs in the Rohingya camps reflects poorly on the living conditions in the camps. While human trafficking, drug trafficking and sex trafficking have remained constant threats in the Rohingya camps, the murders of various individuals at the camps over the years have exposed the security loopholes in the area. Unfortunately, not much has been done it seems to rectify the situation. As a result, an honest man, a father of nine, an activist, died for supporting the right cause. According to a Reuters report, in view of the threats, Mohib had earlier sought security support from the Bangladesh authorities and the United Nations. But he was provided with none it seems. Why?

Rafiqul Islam suggested that Mohib did not file any official complaint. "If he did, we could have considered that," Islam was quoted as saying by Reuters.

In the Rohingya refugee crisis,

Myanmar looks after its own interests and thus they are unwilling to take the refugees back. While Bangladesh is trying its best to accommodate the refugees, it cannot continue to host them in Cox's Bazar for long. And even if the refugees are shifted to Bhashan Char, this will not be a sustainable solution. Unfortunately, Bangladesh has not been able to secure international support to force Myanmar into taking back its people amidst peaceful conditions. And the international community-due to the various economic and political interests in Myanmar of many influential countries-are not helping the cause of the Rohingya refugees either. For them, economic and political gains perhaps come before human rights.

So, the refugees are caught in a limbo. They have nowhere to go, and they do not have a voice of their own. As Mohib was once quoted by The Guardian as saying, "Imagine you have no identity, no ethnicity, no country. Nobody wants you. How would you feel? This is how we feel today as Rohingya." Today the Rohingya are an unwanted people, and their only voice was Mohib. And now that voice has been taken away from them.

Who will now speak for the Rohingya refugees? Who will be their voice?

Mohib was more than just another Rohingya refugee. Mohib was an influencer and he could have played a constructive role in aligning and promoting the concerns of the Rohingya in the coming years as well. He could have also played an instrumental role in the safe repatriation of the refugees.

"For decades we faced a systematic genocide in Myanmar. They took our citizenship. They took our land. They destroyed our mosques. No travel, no higher education, no healthcare, no jobs... We are not stateless. Stop calling us that. We have a state. It is Myanmar," Mohib had said. And at the end of the day he wanted to go back to his state, provided the conditions were right for his people.

The killing of Mohib is not just a major loss for the Rohingya community, but also for the Bangladesh government as it lost the one person who could have been helpful in mobilising support for safe Rohingya repatriation. While Mohib's assassination has left a void in the leadership space for the Rohingya, it has also sent ... a very alarming message to those who are working to support the cause of the refugees through peaceful means.

While the void cannot be filled so easily, the killers of Mohib should be immediately apprehended and brought to justice. The security situation in the camps needs to be reassessed. Further bloodshed at the Rohingya camps must be avoided at all costs.

What are the authorities doing to save the Buriganga?

Stop illegal occupiers, excavate the riverbank to restore its natural flow

S grabbing of our rivers goes on across the country without any break despite the High Court's order to save them at all costs and despite it terming them as "living" entities, we have come to know about yet another incident of encroachment of the riverbank of Buriganga. According to a report published by this newspaper on Saturday, in the capital's Kamrangirchar area, local syndicates are again encroaching upon the banks of the river setting up truck stands, businesses of construction materials, motor workshops, etc. While visiting the site recently, our reporter found dozens of trucks, pickups and small vehicles parked on the filled-up riverbank while trading of wood, sand, brick and stone was also going on at different spots. Moreover, household waste was also being dumped on the site.

What we do not understand is what the authorities responsible for looking after the river are doing when its banks are constantly being filled up and used for illegal purposes. Although the Bangladesh Inland Water Transport Authority (BIWTA) conducted some drives recently, they could not evict all the occupiers. And the BIWTA's plan to construct walkways and plant trees on the banks of the Buriganga may seem harmless, but it is, in fact, a violation of the High Court's directive, as the court strictly prohibited such initiatives. Moreover, according to Bangladesh Paribesh Andolon (BAPA), the way the demarcation pillars were set up on the banks of the Buriganga was faulty.

Therefore, what the authorities must do now to save the Buriganga, the lifeline of Dhaka, is re-demarcate the riverbank boundaries and excavate the filled-up stretches of the riverbank on an urgent basis. The BIWTA can build walkways later, after proper demarcation is done. The authorities should take whatever steps are necessary to ensure the natural flow of the river. In addition, all the illegal businesses set up there must be evicted without further delay. Action must also be taken against the river grabbers as per our laws. Needless to say, the National River Conservation Commission (NRCC), the guardian of the country's rivers, has an important role to play here. The government must strengthen the commission and give them enough power so it can really work to protect our rivers.

medicines and vaccines for decades, not all can produce the novel mRNA vaccines without access to new technical knowledge and materials. Yet, MSF has identified "mRNA vaccine-capable" manufacturers in developing countries, including four in Africa alone.

MSF estimates such manufacturers can establish the capacity to produce up to 100 million doses annually within ten months for between USD 127-270 million. But they would still need access to mRNA vaccine technology and reliable supplies.

But Pfizer and Moderna have both refused to share the needed. Now, instead of transferring technology or increasing

vaccine supplies to developing countries, they have only contracted to supply vaccine ingredients to companies in rich countries and China.

State-subsidised super-profits

Despite benefiting from taxpayer funds, legally enforced patent monopolies and low taxes, People's Vaccine Alliance research shows the three have used their mRNA vaccine duopoly to secure super profits. Their vaccines sell for USD 41 billion over production costs estimated at USD 1.20 per dose.

As a charity has noted, "Instead of partnering... to make sure that we have

Moderna, Pfizer and their scientific personnel can thus be induced to help rapidly scale up production internationally to vaccinate the world. Also, the waiver proposal must be swiftly approved by the WTO to quickly enough vaccine doses for everyone, these

enable more affordable access to tests, treatments, equipment and other materials urgently needed to better fight the pandemic until it can be ended altogether.

At his summit, Biden vowed to expand vaccine output in Africa and Asia. He can still do the right thing. This could well open a new era of multilateral cooperation instead of the dog-eat-dog new Cold War we are lurching towards. Perhaps there is still hope.

Creating research-capable institutions in Bangladesh

Is it possible for Bangladesh to create research-capable institutions similar to ones that are already playing a key role in other Asian countries, driving rapid economic development in the knowledge-intensive era of the fourth industrial revolution?

Today, knowledge is the new currency. East Asia and Southeast Asia are being increasingly recognised as knowledge centres producing high quality research. Although their journey in research is relatively recent, they have fared well, driven by a knowledge seeking culture, in vying with the world's elite research institutions and rising to research prominence.

In contrast, while research in South Asia suggests that it is growing, doubling in quantity every six years, it appears rather lacklustre from a global perspective where, over the last 50 years, viewed in 10-year blocks, the South Asia region published 1.08 percent, 1.54 percent, 1.82 percent, 2.31 percent and 3.94 percent of total global knowledge. production. In this uninspiring record of research, India alone published the lion's share (84 percent) compared to 6.4 percent by Pakistan and 3.2 percent by Bangladesh.

These numbers corroborate articles, public discourse, and recent commentaries on the poor state of research in our higher education institutions (HEIs), depicting their lethargic and unimaginative knowledge production capabilities. Different quarters often rue when our universities, especially elite universities such as University of Dhaka (now in existence for a 100 years) and Bangladesh University of Engineering and Technology (Buet), both well-regarded within the country, fail to figure prominently in the global rankings published annually. This is not to say that such rankings are flawless; but where is the alternative?

Scholars from the advanced West, e.g., Willem Van Schendel, agree with the assessment made by some of us who are from Bangladesh but know intimately the Western, as well as the advanced Asian research


systems. Putting it baldly, Bangladesh lacks substantially in research capability in spite of its incredible human resource base and institution building potential. Consequently, research related to development of Bangladesh by even recognised local scholars remains nearly invisible abroad and often remain unutilised locally for policy purposes.

The dearth of research in Bangladesh's HEIs has been attributed to many factors. Most prominent among these, in our view, are the following:

Funding is probably the most immediate factor. Neither the public sector nor the private sector provides a level of funding that can enable our universities to play in the same league as the Southeast Asian success stories. Another factor is the brain drain phenomenon which has many reasons; but the lack of funding in Bangladesh reinforces other reasons for not returning such as poor administrative support, promotion of undeserving faculty, lack of opportunities to pursue research (in industry and the government), political uncertainties, and a lack of social demand for knowledge.

We have heard, experienced, and reported many complaints regarding the heavy burden of teaching loads. From personal experiences and formal research, we have verified, especially among the private universities, that driving up revenues trumps other loftier goals. While a part of the revenues is used for development of physical infrastructure, the academic administrators do not prioritise research over teaching. If there's no research, what is one teaching?

These and other related factors culminate in what we term "a serious lack of vision for and appropriate incentives" to engage in research. Unsurprisingly, faculty members ask, "Why should I do research?" The payoffs are better for teaching in multiple institutions or for engaging in parochial academic politics that is more conducive to advancement and benefits. Thus, poor "layered" management systems, from the policy level to university administration, are further skewed by rational political and economic calculations that stifle



research which, in turn, fails to serve our national interest.

If Bangladesh wishes to turn around this dismal situation and join the other Asian developing countries, poised to benefit from the fourth industrial revolution, we must ask some hard questions. Key among these urgent questions are:

1. Why have resources not been mobilised or once mobilised not efficiently allocated to promote research?

2. Why have we failed to create an effective research promoting and talent gathering institution like the National Science Foundation in the US and similar entities in Europe, Japan, China, Singapore, Thailand, etc.?

3. What is the correct strategy from here onwards? Building specialised research institutes or modern comprehensive

universities run by competent people with clear goals and little bureaucratic interference? What incentives need to be in place to attract and retain a pool of talented researchers?

4. What are some priority areas (biotechnology, artificial intelligence, mechanisation in agriculture, conflict resolution, trust in government, etc.) in which focused research is to be launched for local impact?

5. How will we know that good research is being conducted and relevant outcomes being produced for the nation's benefit?

A pragmatic approach may be a pilot project in founding a Research Oriented University of Science and Technology (ROUST) with relevant social sciences and humanities disciplines as a part of a comprehensive 21st century research

university programme. The curriculum for such a ROUST may be based on benchmarking with successful universities we wish to emulate. Which models should we follow: specialised versus comprehensive institutions? Why are we not debating these questions?

We might reflect on the fact that up until the founding of two research-oriented universities in the US in the late 19th century-based on the German research university model—the traditional US universities were quite weak in scientifictechnical research except perhaps in agriculture. But that changed quickly with the founding of research universities which were replicated throughout the US; after WW2 American research universities became models for the rest of the world. Today, the exemplary success of small Asian countries like Singapore shows that given the political will, resource mobilisation, and a solid brand of governance, Bangladesh can follow the ROUST approach with careful planning and resource allocation.

Both of us have done theoretical, as well as relevant empirical research on developing tertiary education with research as a strategic component. Our findings point to the urgent need for Bangladesh to formulate a comprehensive public-private partnership within at least a medium-term strategic science and technology development plan.

Once we have such a plan, we must be prepared to implement it and learn by doing. To this end, the sooner a high-level working group is comprised of the leading thinkers, both within Bangladesh and from among the expatriates with solid track records and international reputation, and activated to take the research agenda forward, the better. Many other Asian developing countries have already stolen the limelight and are leagues ahead of us. Do we have the luxury of losing more precious time?

Congress Party lurching from crisis to crisis



 \dashv and mutual recrimination among leaders in public, either at state or national level, are nothing new to India's main opposition party-Congress Party. In fact, they are as old as the party itself. But

in recent weeks, the turmoil triggered by internecine quarrels have taken a different dimension because it once again underlined the political ineptitude and continued drift in the party's top leadership. The crisis in the Congress' unit in Punjab and the unceremonious ousting of one of its most prominent state leaders Amarinder Singh after the party high command engineered a revolt against him-led by cricketer-turned-politician Navjot Singh Sidhu, who defected from the Bharatiya Janata Party four years ago—is the latest illustration of the ills plaguing the country's oldest party once known as the natural outfit for governing an ethnically, religious and linguistically diverse country like India. Spurred by the party's predicament in Punjab and elsewhere in the country in the wake of steady desertions in its rank and file, a clutch of its senior leaders spearheaded by Kapil Sibal has questioned the top leadership (read interim party President Sonia Gandhi and her children Rahul and Priyanka,) for allowing the party to be rudderless. Sibal could not perhaps be more scathing of the Gandhi family. Without naming them, he told the media on September 30 that there was no knowing who were taking decisions in the party. Sibal was backed by many of the group of 23 senior leaders of the Congress who have been demanding organisational elections and a course correction in the party. Within hours of Sibal's criticism of the party high command, he had to face the music as



However, the dissident group had gone silent since then and failed to be vocal when needed most after the Congress' dismal performance in the assembly elections in Assam, West Bengal, Kerala and Puducherry in May this year, raising question marks over its efficacy as a pressure bloc.

With just four months remaining for the assembly poll in Punjab, the Congress is struggling to set its house in order in the agrarian state where the raging farmers' unrest against the three farm laws piloted by the federal government last year had put the party on a strong wicket. What was the need for a leadership change in Punjab so close to the electoral battle? One of the reasons that reportedly prompted the high command to show Amarinder the door is to blunt the antiincumbency The biggest advantage for the Congress in Punjab is that its main political rival in Punjab Shiromani Akali Dal, a former ally of the BJP, is yet to shake off the negative fall-out of its long association with the saffron party even after nearly a year of parting of ways over the farm laws issue. The sudden removal of Amarinder as Chief Minister and anointment of Charanjit Singh Channi last week and Sidhu as state Congress chief a couple of months ago were initially considered by some analysts as a "master stroke." That is because Channi, a Dalit Sikh in a state where Dalits formed a very sizable chunk of the electorate, fitted into the Congress high command's political messaging of identity politics for not just Punjab, but for the rest of the country ahead of state assembly polls in six states, including the most crucial one of Uttar Pradesh. But much of the effect of "master stroke" fizzled out as Sidhu resigned as state Congress chief, living up to his reputation as a mercurial person, a trait that first came to the fore during his cricketing career when he walked out of India's tour of England in 1996 following a spat with the then team captain Md Azharuddin. Sidhu has now acquired the tag of a "habitual quitter". He had resigned

from the BJP in 2016 and after a brief dalliance with the Aam Aadmi Party joined the Congress.

But the "master stroke" seemed to have boomeranged when Sidhu resigned as state Congress President as he is reportedly sulking at not getting the chief ministership and resenting Channi's choice of portfolios for his ministerial colleagues and some key bureaucratic appointments. The entire drama in Punjab Congress has shown how deeply divided the party is.

What has particularly aroused anger in the Congress is a meeting Amarinder had with senior BJP leader and Indian Home Minister

would be political harakiri if he was seen to be hobnobbing with the BJP in Punjab where there is widespread resentment against the farm laws

It is not just in Punjab the Congress is facing factionalism. The party is beset with the same problems in two more states-Chhattisgarh and Rajasthan-it rules with a section of Congressmen demanding change of guard. It required a lot of fire-fighting by the party high command to deal with this internecine war.

Questions are being raised once again about the functioning of the Congress high command and about the correctness of the decisions taken by it. The party has been without a regular president for more than two years now after Rahul Gandhi quit from the post in May 2019, taking responsibility for the party's debacle in the 2019 Lok Sabha polls, after which his mother was installed as interim president. The removal of Amarinder and choice of Sidhu and Channi are being seen as the handiwork of Rahul and Priyanka, as much as their recent induction into the party-fold of young leader Kanhaiya Kumar of the Communist Party of India is. Ironically, Kanhaiya Kumar has, as a former firebrand leader of the CPI's student front in Delhi's Jawaharlal Nehru University, was highly critical of the Congress and the BJP in the same breath. He had alleged that the Congress alone was enough to destroy India. Kanhaiya should know the difference between politics in the confines of JNU and a party's electoral politics. He had hoped to cash in on his image as a student leader in the Lok Sabha poll as a CPI candidate in 2019 but ended up losing to a BJP rival in his home state of Bihar. It is the difference between politics in a well and in an ocean.

Amit Shah on September 29, sparking speculations about his joining India's ruling party and drawing a sharp reaction from the Congress. But a day later, Amarinder tamped down the speculations but made it clear he was not going to join the BJP after being "humiliated" by the Congress high command. This too set the tongues wagging on whether the former army officer was preparing to float a new party and jump into the upcoming state assembly elections in Punjab and hurt the Congress party. The Congress' retort to the Shah-Amarinder meeting stood in sharp contrast to the same when other leaders like Jyotiraditya Scindia, Jitin Prasada, Sushmita Dev, Luizinho Falerio and some in Tripura left the party and joined either the BJP or the Trinamool Congress. In fact, the Congress had maintained a studied silence When the TMC poached the former's leaders in Tripura, Assam and Goa, raising the question if the weakened pan-India party, buffeted by defeat in two successive general elections in 2014 and 2019, was succumbing to regional parties.

Amarinder is too astute a politician. Emerging from the meeting with Shah, the former chief minister went on record as saying that he discussed the farm laws issue with the home minister and pressed for repeal of the laws. Amarinder knows farmers are central to politics in Punjab and that it





start in the SAFF Championship and the charges of interim coach Oscar Bruzon did it after switching to a brand of possession-based football from a

defensive one. It is not that the footballers are new to possession-based football rather they once adapted well to such playing style under Dutch coach Lodewijk De Kruif before they switched to a counter-attacking version while prioritising a solid back-line under British coach Jamie Day.

Nevertheless, the boys in red and green did look a bit nervous initially against Sri Lanka, who are ranked 205th and 16 places behind Bangladesh in FIFA ranking but the charges of Bruzon gained control of the midfield as the match progressed.

Even though Bangladesh had 58 percent of ball possession, during which they strung 15 to 20 short passes on several occasions, they couldn't destabilise the Sri Lankan backline, unlike how Maldives treated Nepal in the second game of the tournament.

Now, the question is how far can Bangladesh progress in the tournament with such an approach – possession without penetration -- against comparatively stronger sides like India, Maldives and Nepal.

"Sri Lanka played a highdefence, so it was really tough to penetrate them in their half to create scoring opportunities," said match-winner Tapu Barman, who yesterday had a full rest at the Turf Ground due to a minor ankle problem.

"Look, in the second half, we played better football compared to the first," said the centre-back. Midfielder Mohammad Ibrahim believes the players need some time to adjust with the playing style.

"The players who have already worked with Bruzon, have good understanding with the coach but the rest of the players need some time," said Ibrahim. "It's not that only forwards

will score in total football. You will see some time that the midfielders and wingers also score goals but to be honest, the coach hasn't gotten much time to work on the finishing aspect." The Bashundhara winger

wants to continue playing the same way in the upcoming matches.

"We've proved yesterday that we can play possession football but we have to improve it day by day. I think we have to increase communication among the forwards, and then the next matches will be easier for us," believes Ibrahim, who played in the midfield instead of his usual wing position.

Ibrahim seemed optimistic about solving the scoring issue. "You saw how many chances

we created against Sri Lanka which we never did in the past matches. As we have started playing open football, the scoring problem will be gradually solved, I believe."

Regardless of what Ibrahim believes about the solution of the scoring problem upfront, Bangladesh are definitely going to face an uphill task while attempting to penetrate the backlines of India, Maldives and Nepal, as all three opponents are superior to Bangladesh in terms of skill, technique and tactics and, of course, FIFA ranking.

Moments after Yeasin's joke, one of the Bangladeshi expatriates who were watching the training session from outside the main gate, shouted towards the players, "Just beat India, we won't mind even if you don't win the title."

There is huge enthusiasm among the expatriates regarding Monday's match against seven-time champions India, who last December beat Bangladesh 2-0 in a World Cup qualifying fixture and are taking this championship as part of their preparation for next year's Asian Cup Qualifiers. India have always been a hurdle for Bangladesh in SAFF Championships as the Blue Tigers beat the men in red and green twice in final and two more times in semifinal stage.

However, Bangladesh, except for the last meeting, had managed to hold India to draws in previous three meetings and midfielder Mohammad Ibrahim is seeking inspiration from those matches.

Careful what you click

Cops tell how 3 suspects made phishing links to blackmail over 200 social media users

They have no degrees. Some of them have not even completed primary education. Yet, they learnt how to trick Facebook users into giving them their social media IDs and passwords.

Watching YouTube videos, they learnt to make "phishing links". They send the links to unsuspecting users making it appear as though it was sent by a friend.

The links usually look like invitations to contests and when one clicks on them, a pop-up appears asking the user to login again. The moment the user does that, their data has gone to the hackers.

The hackers, now in control of the users' social media account, blackmail them and extort money from them.

Cyber and Special Crime Division of police's Detective Branch (DB) has disclosed the technique following the arrest of three suspects from Shibchar, Madaripur on September 29.

The arrestees are Obaidur Rahman Nobel, 20, Shamim Sarder, 21, and Saiib Khalifa, 21

Nobel is a seller of women's purse. He studied up to SSC. Shamim is an electrician and he has studied up to class-IV. Sajib is a tailor and he studied up to class-III, said police.

Over the last two years, the three managed to hack around 2,000 Facebook users, Junaed Alam Sharker, additional deputy commissioner of cyber and special crime division of DB, told The Daily Star.

The ADC said that after taking control of an account, the hackers go through messages and personal address book details. They exploit their victims using personal pictures or videos found in their accounts. SEE PAGE 5 COL 4

Fire on Farmers 4 held over Thursday's incident

Police yesterday arrested four men for their alleged involvement in injuring seven farmers with gunshots at Tulatoli village in Satkania upazila of Chattogram on Thursday.

The arrestees got engaged in an altercation with the farmers over putting dredging materials on agricultural land by the Sangu. The attackers were a Water Development Board (WDB) contractor's men, said complainants.

Anwar Hossain, officerin-charge of Satkania Police Station, said they arrested the accused during raids in different areas of the upazila yesterday.

COVID HOSPITALISATIONS Merck's pill cuts it by half

US pharmaceutical company Merck said it will seek authorization of its oral drug molnupiravir for Covid-19 after a trial showed that the drug can reduce hospitalization by 50 percent.

A simple pill to treat the coronavirus has been sought since the start of the pandemic and Friday's announcement was hailed as a major step towards that goal.

Anthony Fauci, chief medical advisor to President Joe Biden, told reporters: "The data are impressive," and he highlighted that the trial results showed there were no deaths among patients who received the drug compared to eight deaths in the placebo group.

The US has procured 1.7 million courses of molnupiravir should it be greenlighted, with the option to buy more, and global health agency Unitaid said it was working with a partnership called ACT-Accelerator to secure supply for low- and middle-income countries.

Until now, Covid therapeutics such as monoclonal antibodies and Gilead's remdesivir have been administered intravenously.

"It's very exciting to have more options that are easy to deploy," Natalie Dean, a biostatistician at Emory University who specializes in infectious diseases, told AFP.

"You can have something that's similarly effective, but if one is much easier to use, that's going to have a bigger population-level impact."

But experts also stressed that if approved the drug is not a miracle cure and should complement highly effective vaccines, rather than replace them.

In a late stage clinical trial, Merck and its partner Ridgeback Therapeutics evaluated data from around 770 SEE PAGE 5 COL 1
