However, Alfai's family denied his involvement and dismissed the accusation, saying they are too poor to even afford a domestic worker in the first place.

In the case, the woman stated Alfai attempted to rape her on two separate occasions in August. She also accused Alfai's father Tajul Islam and mother Gulnahar Begum.

But Alfai's uncle Elias Hossain told this correspondent a different tale. "The family has never had a domestic help. Alfai's father has a small tea-stall in the village. I doubt he earns more than Tk 10,000 to 15,000 per month. They have a two-room house and an outdoor kitchen."

"It doesn't make sense why a woman from the city would come to a village some forty kilometres away to work as a domestic help. We do not even know her, he said.

Talking to this correspondent, Sitakunda Police Station Officer-in-Charge Abul Kalam Azad said they arrested Alfai and his parents after receiving an arrest warrant issued by the court.

Meanwhile, following two days in police custody, Alfai was granted bail by judicial magistrate Md Mainul Hasan of Chattogram's Women and Children Repression Prevention Tribunal-6 yesterday.

# 'A minimum wage that doesn't ensure minimum dignity'

Wage board recommendation for tea workers woefully inadequate, say speakers

The minimum wage board for tea workers, a government-led tripartite body, have continued the 170-year-long "tradition" of depriving workers by recommending an unfair wage structure that conflict with existing laws, said speakers at a virtual dialogue yesterday.

minimum recommended for tea workers is the lowest among the country's major sectors, and woefully insufficient for maintaining a basic standard of living, they highlighted.

Speakers expressed their concern over the recommendation at a dialogue titled "Tea Workers' Wage: Present structure and challenges".

"The wage structure for tea workers is way too low considering the upper poverty line of 2016, minimum wage of other sectors like garment or leather and living wage in the country.'

Professor Dr MM Akash of department of economics in Dhaka University, said, "The workers and the owners set Tk 120 daily wage for the year 2019-2020 while negotiating. Considering Association and Bangladesh Cha a 5 per cent inflation rate each year, the wage should have been increased by 15 per cent for 2022

and onwards. If this factor is taken into account, the recommended wage is lower than the previous

He further argued that the profit margins of the tea garden owners should be made public.

Uttam Kumar Das, a Supreme Court lawyer, said, "The labour law clearly stated that allowances do not constitute wages. There is no scope legally for the minimum wage board to contradict the existing labour laws of Bangladesh. There have also been multiple High Court orders which state that allowances and benefits cannot replace wages.

It is discriminatory that while all workers are granted service benefits as per section-28 of the Labour Law of 2006, tea workers were stripped of the benefit in the 2018 amendment of the law, he

"Besides, there is no casual leave for tea workers, which is discriminatory. Every women worker is exempted by law from working eight weeks prior to childbirth, except the women tea workers.'

"The wage structure declared by the wage board is an injustice to the workers and clearly benefits the owners by not considering workers' rightful demand," said Tapan Datta, a labour leader.

Among others, Rambhajan Kairi, executive advisor of BCSU, and Nripen Paul, acting general secretary of BCSU, spoke in the dialogue.

### Protect ancestral land of Khasi people

Urge 13 eminent citizens in letter to Sylhet divisional commissioner

Thirteen environmentalists, rights activists and prominent citizens have issued a letter to Sylhet divisional commissioner, demanding protection of the ancestral and customary land of the Khasi people living in Daluchhara and Belkuma Khasiapunji, located in the Kulaura upazila of Moulvibazar.

They issued the letter on Saturday upon receiving news that the so-called "beneficiaries" of Kulaura Upazila administration, police, forest department and social forestry of Moulvibazar will "forcibly" implement the plantation of trees on the land of Daluchhara Khasia Punji

The signatories said the forest department implementing a flawed project such as this one in the name of social forestry raises serious questions, and requested the administration not to undertake any such project that destroys natural forests.

The Khasis have been living in their ancestral lands for ages. Various international charters, including the United Nations, have recognised the indigenous culture of preserving ancestral lands, and the Bangabandhu regime also ratified the ILO Convention 107 in 1972, recognising the ancestral land rights of the indigenous people, the

The letter also highlighted that the forest department unilaterally listed the beneficiaries without any discussion with the Khasis and ignored the social forestry policy as well, creating several issues and complications between the beneficiaries and the Khasis.

Some miscreants have already destroyed the betel nut jum/garden owned by the Khasis and attacked them, claimed the signatories in the letter. The media has shed light on this issue very recently, prompting a meeting between the Khasi ledearship and the forest and environment minister to solve the issues.

Besides, the Moulvibazar court has imposed a ban on this land too, according to the issued letter.

Iativatabadi Ulema Dal arranged the programme at Jatiya Press Club, marking its 42nd founding anniversary. Fakhrul said Bangladesh

was liberated with a dream of establishing democracy and a free society, but Awami League has established a "oneparty rule". "Now there's no democracy, election, accountability and law and order in the country. We didn't want such a country.

He said 11-12 companies, including Evaly, took away hundreds of crores of taka from people in the name of e-commerce, but the government could not take any step in advance to check such fraudulence.
