### **Rangpur Medical College: ACC sues** ex-principal for embezzling Tk 1.75cr

ACC has sued two persons, including a former principal of Rangpur Medical College (RMC), for allegedly misappropriating Tk 1.75 crore in purchasing medical equipment during 2012-2013.

The accused are Dr Abdul Rouf, the then RMC principal; and Moksedul Islam, owner of Three-Eye Merchandiser, a supplier.

ACC filed the case on Tuesday, confirmed Muhammad Arif Sadek, ACC public relations officer in Rangpur.

According to case statement, RMC authorities decided to purchase five dental chairs during 2012-13 fiscal year. But the administration did not take any performance security (bank guarantee) from supplier. Later, ACC found the chairs were purchased when Rauf was principal and the price was shown higher than the actual market price.

### Sust to reopen halls from Oct 25

#### UNB, Sylhet

After nearly 18 months, Shahjalal University of Science and Technology will reopen its halls to students in phases from October 25.

Sust Vice-Chancellor Prof Farid Uddin Ahmed announced the date on Tuesday after the 167th Academic Council meeting on October 5.

### Four held for raping widow in Khulna

Police have arrested four members of a robbery gang -- in a case filed over raping a widow during robbing her house in Paikgachha upazila of Khulna.

The arrestees are Ferdous Dhali (51), Sheikh Wahidul Islam (28), Rakibul Islam (28) and Sheikh Monayem Hossain (24) -- all from Paikgachha.

They were arrested from different parts of Paikgachha and Kovra upazilas on Tuesday and yesterday, said Md Ezaz Shafi, officer-in-charge of Paikgachha Police Station, yesterday.

During primary interrogation, the arrestees admitted to raping the victim, he said.

They were produced before the Senior Judicial Magistrate Court in Paikgachha, added the OC.

According to the case statement, the four stormed into the house of a widow in a village in Paikgachha upazila in the early hours of September 2 and looted some gold jewellery, two mobile phone sets and Tk 40,000 in cash.They also raped the woman during the robbery, the case statement said.

The OC also said the victim filed a rape case against four unidentified people with Paikgachha Police Station the same day.

Among the deaths, 68 have died in Dhaka division, two each in Chattogram and Khulna and one in Rajshahi division.

Though most of the patients who were hospitalised have so far been released, 863 are still undergoing treatment at hospitals in Dhaka, and 143 outside the capital, the Directorate General of Health Services data shows.
