### Foreign minister on official visit to Romania, Serbia

UNB, Dhaka

Foreign Minister Dr AK Abdul Momen left Dhaka yesterday for a two-nation official visit to attend bilateral meetings in Romania and Serbia.

Momen left Dhaka for Romania -- at the invitation of his Romanian counterpart Bogdan Aurescu -- at the early hours of the day. He will attend a bilateral meeting with the Romanian Foreign Minister during his visit.

Meanwhile, Serbia will organise a commemorative event in Belgrade on October 11-12 to mark the 60th anniversary of the first NAM Conference. Momen will attend the function, alongside his bilateral engagements with Serbian Foreign Minister Nikola Selakovic.

Momen is scheduled to return home on October 14.

### 208 more hospitalised with Dengue

At least 208 patients were hospitalised in the last 24 hours till 8am yesterday, of which 35 are from outside Dhaka, according to the Directorate General of Health Services. With the new cases, a total of 1,347 were diagnosed during the running month out of a total 19,544 infected.

According to DGHS, 12 people died in July, 34 in August, 23 in September and four in October so far.

### DRU, Nagad to jointly give best reporting award

Children Charity Bangladesh Foundation sent the notice requesting the commission to file a petition with the HC in 15 days seeking direction on the government to provide the compensation to Khadija (12).

### Ties with Bangladesh to grow, says **Nepalese foreign minister**

### Locals in fear after threats from AL leader

Many people in Gobindapur union of Rajshahi's Bagmara upazila are in panic, five days after an Awami League leader made threats against them on video over casting votes.

During an internal meeting of the oarty's Gobindapur unit on October 2, Golam Sarwar, general secretary of AL's ipazila unit, threatened the union's Hindu community to vote for the party in the next Union Parishad election.

The video footage of his 14-minute speech, which was shared on Facebook, went viral in different social media groups.

Contacted, Gobindapur Union Chairperson Bijon Sarker said, members of the Hindu community have been coming to me to get an idea about the situation. "They are in fear," said Bijon, also

president of Hindu Bouddha Christian Oikya Parishad's upazila unit.

Bijon, who is president of Communist Party of Bangladesh's upazila unit, won the last UP elections, where the AL candidate secured fourth place.

In his speech, Golam also said AL gets

### Lighter vessel capsizes in Bay of Bengal

A lighter vessel carrying around 1,000 tonnes of scrap metal capsized at the outer anchorage of Chattogram port yesterday afternoon.

All 14 crew members aboard the vessel were rescued by local boatmen.

Nabi Alam, vice president of Lighter Vessel Workers Union, said the vessel Titu-7 was on its way to Banglabazar Ghat on the river Karnaphuli after loading the scrap from a mother vessel anchored at the outer anchorage.

Around noon, the anchor of an oil tanker near Patenga Sea Beach hit the hull of Titu-7 and caused it to tilt to one side, he said quoting crew members.

Eventually, the vessel capsized, he said.

Chittagong Port Authority (CPA) Secretary Md Omar Faruk said there was no disruption in vessel movement on the Karnaphuli channel due to the accident.

CPA will issue a letter to the capsized vessel's owning firm Abul Khair Group to salvage it, he said.

# Rape victim's house set on fire 'by accused'

A rape victim's house was set on fire allegedly by the accused in Dhamrai upazila of Dhaka on Wednesday.

The 24-year-old's family alleged that the accused -- who was recently released on bail -- set the fire to kill them as they refused to withdraw the rape case.

Rahman, officer-in-Atiqur charge of Dhamrai Police Station, confirmed to The Daily Star yesterday morning that the house was torched.

He said the matter was being investigated as the woman's father filed a written complaint with Kawlipara Police Outpost on Wednesday evening.

Sumon Hossain, his brothers Shamim Hossain, Amjad Hossain, Selim Hossain and their brotherin-law Jahangir Hossain -- from Dhamrai -- were made accused in the complaint, said the OC.

According to the complaint, Sumon raped the woman two months ago after promising to marry her. Two days later on August 8, she filed a rape case with Dhamrai Police Station against

Sumon and his three brothers--Shamim, Amjad and Selim.

Afterwards, police arrested Sumon's three brothers who received bail on August 31 and kept pressuring the woman's family to withdraw the case.

On September 11, the woman's father filed a GD with Dhamrai Police Station. Since then, the accused have been threatening the family, they said.

On Wednesday around 2am, Jahangir entered the house and locked the collapsible gate. They then set fire to the two tin-shed

houses and left the scene. Later, neighbours doused the blaze and rescued the family members. By that time, valuables worth around Tk 2.5 lakh were

burnt, the complaint stated. Accused Hossain Shamim claimed that the allegation against them over the fire is false.

Dhamrai Police Station Subinspector Arafat Uddin, who is investigating the complaint, said legal actions will be taken after investigation.

Sumon is on the run, the SI added.

### Two found dead

Two people were found dead in a house at Satanipara in Gazipur's Kaliganj upazila on Wednesday night.

The deceased are Hridoy Gomez (25) -- an NGO worker -- and Evana Rozario (22), of Bandakhola village. The young woman was a nursing student. Police suspect Hridoy killed Evana over some issue and stabbed himself to death afterwards.

Quoting Evana's father Shopon Rozario, SI of Kaliganj Police Station, Saiful Islam, said Evana and Hridoy were in a relationship. She went to Hridoy's house at his request on the day. He was alone at the time.

When Hridoy's mother returned home, she found the main door and windows of the house locked from inside. She also heard loud music blaring from inside, the SI said. Getting no response, she, along with neighbours, broke into the house through a window and found the two dead.

On information, police rushed to the spot and sent the podies to a local hospital morgue, said the SI. There was strangulation mark around Evana's neck and the body also had several injury marks, he added.

said Gopal Chandra Das, a young instrument maker from the city's Boro Kalibari area.

"It is our ancestral profession. We also continued the venture on a small scale during the pandemic as these instruments are used in various religious performances of the Hindus," said Gopal.

"As both charges and orders have increased this year, we

hope for a better income this season," said Ujjol Kumar Das of Nobab & Co at the city's Boro Bazar area. A worker can earn around Tk 30,000 preparing for the occasion of Durga Puja, said Rezaul Karim Aslam, proprietor

of Nobab & Co. However, the making and repairing charges haven't changed compared to the previous years, according to Sandu Das of Samir & Co of Boro Bazar. Currently, a dhak is being sold at Tk 6,500 to Tk 10,000 a khol at Tk 2,000 to Tk 5,000 and a dholok at Tk 2,200 to

Tk 4,500. Meanwhile, the price of a khol (mridanga) ranges

between Tk 3,200 and Tk 4,000, and a Bangla dhol between Tk 4,500 and Tk 7,000, depending on size and quality. An 83-year-old Narayan Chandra Das shared that he came to Mymensingh with his parents as a little boy

from Manikganj and has been continuing this ancestral profession of making instruments to this day. Though the business faced a serious blow amid the pandemic, Narayan sees a bright prospect for this profession, as more people are getting interested in the roots of the country's traditions and culture and

contributing to its expansion. Some 784 mandaps of the district are ready to celebrate Durga Puja this year, and the local administration has taken necessary security measures for the premises, said Shankar Saha, organising secretary of the district's Puja Utjapon Parishad.
