India to reopen for tourists from Oct 15

India will reopen for tourists from October 15 after being closed for more than a year due to the coronavirus pandemic, the government said

"After considering various inputs, the MHA (home ministry) has decided to begin granting fresh Tourist Visas for foreigners coming to India through chartered flights with effect from October 15, 2021," the home ministry said in a statement.

"Foreign tourists entering into India by flights other than chartered aircraft would be able to do so only with effect from November 15, 2021 on fresh Tourist Visas," it added.

India suspended all visas for foreigners in March 2020 when the pandemic took off as the government imposed a strict lockdown.

Restrictions on some categories of foreigners such as diplomats and businesspeople were later lifted but tourists remained barred.

Earlier this year India was hit by a severe wave of coronavirus infections with about 400,000 cases and 4,000 deaths every day.

But cases in the country of 1.3 billion people have since slowed sharply to around 20,000 new daily infections and 200 to 300 deaths.

At the same time restrictions on most activities have been lifted.

It's causing infectious

September to October has increased by 43mm.

The report further said, according to the survey done on 15,000 people, sickness among the people rises by 26 percent during monsoon. Respiratory infections also increase during the season with the rise in temperature and humidity.

More cases of depression are reported during cold and dry seasons compared to the rainy season, the report says. However, anxiety disorders can become more prominent with an increase in temperature and humidity during monsoon.

The reports further said erratic weather conditions played a key role in the 2019 dengue outbreak in Dhaka city, where 77 percent of the country's

total dengue-related deaths occurred. The report linked higher rainfall and humidity with dengue. It said that in 2019 Dhaka recorded more than three times the average rainfall in February, followed by higher temperature and humidity between March and July.

With further climate change

predicted, more physical and mental

health issues are likely to emerge. The report further suggests that by strengthening healthcare systems, Bangladesh can deal with outbreaks of infectious and other climate-sensitive diseases.

Hossain Chowdhury chairman of the parliamentary standing committee on forest, environment and climate change ministry, said it is a study of immense value. It is giving a message to the world that the climate change has another dimension - that of physical and mental health.

It is not only about land degradation, rising sea levels or melting glaciers. The whole issue has to be seen from a public health perspective and we must act accordingly, he said.

Saleemul Haq, leading climate researcher, said, "We are entering an era of loss and damage due to humaninduced climate change. The future is going to be worse unless we prevent it. Every day will be worse than the last. Rich or poor, every one will face it, so we need to prepare ourselves."

Going forward, Bangladesh can better track the evolution of climatesensitive diseases by ensuring stronger data collection, said Iffat Mahmud, World Bank Senior Operations Officer and co-author of the report.

The silent killer

The court then fixed November 2 to decide whether to accept the charge sheet or not.

They embezzled over Tk 1.37 crore through collections and testing samples of Covid-19 patients in a government-run lab Nipsom, the statement said.

Moscow invites Taliban to Afghanistan talks on Oct. 20

2.23 crore was transferred to the joint account from Sinha's account at Sonali Bank's Supreme Court branch. Later, Tk 78 lakh was transferred to Shangkhajeet's personal account at the EPZ branch of Dhaka Bank.

Shangkhajeet told investigators in writing that upon Sinha's instructions, he opened two FDRs with Tk 60 lakh and kept the remaining Tk 18 lakh in his account.

The accounts containing the money were later frozen upon a court order in 2019, reads the FIR.

One Sujon Kumar Singha, who is an architect, was appointed to supervise the construction of the building along with Shangkhajeet Shingha.

Both Sujon and Shangkhajeet told

investigators that the former chief justice and his wife paid construction expenditure in cash.

Sinha's brother Narendra was not involved in the construction, reads the case statement.

Pinaki Das, tax lawyer of the former chief justice, told investigators that Sinha had once requested him to prepare his brother Narendra's tax documents. Pinaki then prepared tax files for five years from 2011-12 to 2017-18 for Narendra.

Pinaki submitted this information in writing to the ACC.

Narendra showed construction building in this tax file.

As sources of the funds for construction, he showed an advance of Tk 4.4 crore as flat booking from one Khaleda Chowdhury, Tk 1.49 crore from selling a flat to his brother Surendra Kumar Sinha, Tk 74.53 lakh as loan from Sinha's daughter Suchana Sinha, and Tk 89.81 lakh as bank loan. According to Pinaki's statement

before investigators, Sinha sent necessary documents through his representatives and the tax lawyer prepared the tax files without

On the other hand, Khaleda Chowdhury said she booked flats in the building but paid only Tk 70 lakh from January 2018 through his son Atiqul Islam Chowdhury.

Atiqul showed the transaction in his tax file.

"Therefore, getting Tk 4.4 crore from Khaleda as booking money is not true," reads the FIR. Narendra told investigators that he

did not receive any advance money "Actually, his brother Surendra

Kumar Sinha included the information in the tax file. He [Narendra] is not aware of it," an ACC official told The Daily Star yesterday.

According to the report of an independent architect, about Tk 6.31 crore was spent on the construction of the building.
About Tk 75 lakh was spent to buy

the plot, Khaleda Chowhdury gave an advance of Tk 70 lakh and about Tk 78 lakh remain frozen in banks, according to the case statement.

Pluto's atmosphere

the dwarf planet and revealing its small, nitrogen rich atmosphere.

Their observations suggest that as Pluto moves further from the Sun in its long orbit, it is getting colder and its nitrogen is refreezing to the surface.

Pluto was discovered in 1930 and is just over a third of the way around the Sun. The small world is currently moving further from the star, meaning it is getting colder over time.

It is currently 3.7 billion miles from the Sun, and will not complete its first full orbit of our star since its discovery until March 23, 2178.

The astronomers used a technique known as occultation to determine the impact the distance was having on its thin and tenuous atmosphere.

This technique relies on a dark object being backlit by a distant light to reveal previously hidden details.

This includes showing atmosphere density for a distant world like Pluto. The occultation took about two minutes, during which time the star faded from view as Pluto passed in front of it.

The rate at which the star disappeared and reappeared determined the density profile of Pluto's atmosphere, the researchers explained.

Scientists have used occultations to monitor changes in Pluto's atmosphere since 1988," said Dr Eliot Young, a senior author on this new research.

"The New Horizons mission obtained an excellent density profile from its 2015 flyby," he added. These findings were consistent with

Pluto's bulk atmosphere doubling every decade. However, the 2018 observations by the team behind the new study "do

not show that trend continuing from

2015." The data will help atmospheric improve modellers understanding of Pluto's subsurface particularly regarding compositions that are compatible with the observed limits on heat transfer.

The findings were presented at the American Astronomical Society Division for Planetary Sciences Annual Meeting on October 4.

Turkey parliament ratifies Paris climate agreement

Turkey's parliament on Wednesday unanimously ratified the Paris Agreement on climate change, more than five years after Ankara first signed the landmark deal on cutting emissions

that contribute to global warming. The vote followed President Recep Tayyip Erdogan's announcement at the UN General Assembly in September that Turkey would implement the accord in time for next month's UN Climate Change Conference in Glasgow.
