former students occupy the seats, as far as we know, so actual students are being deprived of accommodation."

Rakibul Rony, general secretary of JU Chhatra Union, underscored the need for proper medical facilities.

Provost Committee President Prof Muzibur Rahman acknowledged that abolishing gono rooms at once will not be possible, but authorities will take steps gradually.

Meanwhile, JU will launch a vaccination drive for students on campus from today at the institute's Wazed Miah Science Research Center. The vaccination drive will run from 10am to 1:30pm every day.

However, justice is a far cry for these victims, especially those who have intellectual, speech, hearing and psychosocial disabilities, even though they endure abuse and sexual violence, at rates much higher than other girls and women, said rights activists.

Although there is no data available on conviction rates in rape cases concerning girls with disabilities, activists said such convictions are rare, if not completely unheard of.

BARRIERS IN ACCESSING JUSTICE

In the country's legal system, since the burden of proof entirely falls on the victims, it becomes difficult for the girls and women with disabilities to prove the incident beyond any reasonable doubt due to their circumstances, argued experts.

There is a severe lack of sensitivity and understanding in dealing with survivors with disabilities, they added.

"For example, a survivor with speech and hearing impairment cannot give her testimony to the court directly because there are no lawyers or judges in Bangladesh who know sign language. Courts

require interpreters in such cases, but there are only around 10 of them in the country and most are based in Dhaka," said Supreme Court lawyer Rezaul Karim Siddiqui, also former research fellow at BLAST.

Besides, if an interpreter agrees to take on a case, s/he becomes witnesses and are required to travel whenever needed for hearings, which many consider a hassle.

Ariful Islam, a sign language news presenter of BTV, who has served as an interpreter in more than 20 rape cases, said many judges outside Dhaka are not aware of interpreters and usually ask the disability focal person of Department of Social Welfare, or teachers of local deaf schools, who may lack the skills or the sensitivity to engage properly with survivors.

"In addition, although the court order mentioned providing transport allowance to interpreters, in reality they do not get any, which discourages many from assisting in cases outside Dhaka. But if the government creates a database of interpreters, assigns them a specific number of cases in a selected area, and provide a minimal transport allowance, the situation could

be improved," he opined.

Even when interpreters are available, testimonies of people with disabilities are often considered not credible, especially of those with intellectual disabilities.

Moreover, in case of survivors with psychosocial disability, the police are not even willing to document such cases because the survivors cannot prove the incident, while those who have multi-sensory impairment are completely unable to give testimony, he added.

Ashrafun Nahar Misti, executive director, Women with Disabilities Development Foundation, an organisation providing non-legal support to women with disabilities, highlighted that Persons with Disabilities Rights and Protection Act 2013 does not specify how a girl child or woman will get remedies if they're raped.

"Rather, they too are dealt under the Women and Children Repression Prevention (Amendment) Act 2020, but it would have been better if there was a separate chapter on how these particular cases could be tried and remedies provided."

"Now, we are totally

dependent on the discretion of judges and lawyers, but if they are not sensitive, there is no hope," she said.

"Another important factor is that since most survivors with disabilities mostly come poor families, they cannot afford the protracted legal battle without the assistance from NGOs. Although the public persecutors are appointed by the state, they do not give enough attention to these victims as such cases do not benefit them financially."

Advocate Siddiqui however suggested that if the burden of proof could be shifted to the perpetrator from the victim in such cases, justice could be easier to mete out.

Besides, law enforcement and implementing agencies must ensure that laws related to rape and disability rights must be disseminated to the victims in accessible formats (through braille, sign language).

Contacted, Law Minister Anisul Huq told this correspondent yesterday that he will surely look into the issue and try to address it.

a commission and allocate fund so that socio-economic development of indigenous people can be ensured," he said.

He also criticised the declaration of indigenous people as ethnic minorities.

Afsana Binte Amin from NETZ Bangladesh presented the concept paper in the seminar.

Sanjeeb Drong, general secretary of Bangladesh Adivasi Forum, said a state cannot change the name of any ethnic group. "Indigenous people lost their ethnic identity and got deprived of their land rights in the process of building a modern state. When the world is talking about the conservation of biodiversity, it is the indigenous people who conserve 80 percent of the world's biodiversity," he said.

Rokeya Kabir, executive director of Bangladesh Nari Pragati Sangha; Shamim Ara Begum, executive director of Pallisri, and Jakir Hossen, chief executive of Nagorik Uddog, spoke at the seminar which was moderated by Shahidul Islam, director of NETZ Bangladesh.

In Cox's Bazar, Bangladesh, WFP provides assistance to displaced Rohingya through national retail. The payment modality is via WFP Food Assistance Cards. With these cards, beneficiaries receive an entitlement that they can use to purchase a variety of perishable and non-perishable food and non-food items (bathing and laundry soap etc.) from the WFP-established Electronic-Voucher outlets.

Retail partners will be responsible for:

- Procurement of food (and some non-food items). WFP contracted retailers will be encouraged to procure fresh and perishable items from local producers in the Cox's Bazar district to support the local economy.
- Implementation of a full logistics plan to transport the commodities to the Cox's Bazar district (Ukhya & Teknaf)
- Running the distribution points (Electronic-Voucher shops) in line with the humanitarian principles/code of conduct. Strict food quality and safety standards must be implemented and maintained at all stages of the supply chain.

Ashek-e-Elahi, ASI Hasan Uddin, Constable Harunur Rashid, Constable Titu Chandra Das, and Abdullah Al Noman. All except Noman are in jail.

On September 30, Sylhet's Additional Chief Metropolitan Magistrate accepted the charge-sheet, framed charges and issued an arrest warrant against the fugitive.

Marking one year of the murder, family members and well-wishers of Rayhan organised a human chain in front of Sylhet Central Saheed Minar yesterday afternoon.

Rayhan's mother Salma Begum said, "It took a whole year to frame charges, so we

don't know how long it'll take to conclude the trial."

PRIME ACCUSED TRIES TO MEDIATE

After charge framing, prime accused Sub-inspector Akbar tried to mediate the matter by convincing Rayhan's family.

Salma Begum said, "While we went to the jail gate for witness deposition, Rayhan's uncle was taken to a room with Akbar, where Akbar and Ashek-e-Elahi begged for forgiveness. They said they tortured Rayhan to death on wrong information."

A few weeks earlier, Akbar's parents came to Sylhet and proposed for mediation, but we refused their proposal, she said.

Pandemic reversed work

achievement in creating a child marriage free village has been reversed in the pandemic, as more and more parents were marrying off their underage daughters due to school closure and financial instability.

"Due to Covid-19, we could not work properly as there was restriction of movement, and now, the number of child marriages has increased again in our village, which is very disappointing for us," she said.

Nasima Akter Jolly, secretary, National Girl Child Advocacy Forum Bangladesh, highlighted that during the first eight months of 2021, a total of 813 girl children were subjected to rape, while 193 girl children were killed in this period, due to rape, sexual harassment and family feud, and 157 girl children died by suicide.

"We have to address the mental health issues of the girls, and families should take necessary steps in this regard," she said.

Besides, in order to stop sexual harassment and torture of girl children, a separate and comprehensive law regarding the sexual harassment prevention and remedy should be enacted, she added.

Rawnak Jahan, representative of Girls Not Brides Bangladesh, the Bangladesh alliance to end child marriage, said they were unable to visit the community during the pandemic, and could not continue their social mobilisation activities and advocacy for legal reforms.

However, the Girls Not Brides, a network of 29 organisations, will continue its work on the pressing issue, by sharing learnings and challenges with each other, she assured.

ActionAid Bangladesh country director Farah Kabir; Solika Akter of Activista Dhaka-YFF Network; Syeda Samara Mortada, regional movement, supporter, SheDecides; Priodarshine Auvi, programme analyst, climate change programme, UN Women; Halima Akter, manager, policy and advocacy, Educo Bangladesh, among others, spoke at the event.

It was moderated by Morium Nesa, manager- Women Rights and Gender Equity, ActionAid Bangladesh.

returned to his workplace after surviving Covid-19 last year. However, he was completely bedridden for the past six months. He left behind his wife, two sons and a daughter and many well-wishers to mourn his death.

He was the initiator of a children's page called "Chander Hat", published in the daily Purbodhes, from where he got the title of "Dadubhai".

He served as the executive editor of Dainik Rupali, Dainik Janata, and worked in several important positions in Dainik Azad, Dainik Lal Sabuj, The Bangladesh Observer and his last workplace, the daily Jugantor during his distinguished career.

From 1976 until 1983, he was the acting editor of Kishore Bangla, the Indian subcontinent's only weekly newspaper dedicated to children.

He received the Bangla Academy Award and the Bangladesh Children's Academy Award in 2019 for his contributions to Bangla children's literature.

He received numerous prizes throughout his lifetime.

In a condolence message, Prime Minister Sheikh Hasina expressed profound shock and sorrow at the death of Dadubhai. She prayed for the salvation of the departed soul and expressed deep sympathy to the bereaved family members.
